(57) **CLAIM**

I claim the ornamental design for a snap-on license plate emblems kit, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a snap-on license plate emblems kit showing a football portion of my new design;

FIG. 2 is a rear, top and right side perspective view of the football portion thereof;

FIG. 3 is a front elevational view of the football portion thereof;

FIG. 4 is a rear elevational view of the football portion thereof;

FIG. 5 is a top plan view of the football portion thereof, the bottom plan view thereof being a mirror image thereof;

FIG. 6 is a right side elevational view of the football portion thereof, the left side elevational view thereof being a mirror image thereof;

FIG. 7 is a cross-sectional view thereof taken along line 7—7 of FIG. 5;

FIG. 8 is a reduced perspective view showing the snap-on license plate emblems kit in use; the broken lines depict environmental structure for illustrative purposes only and form no part of the claimed design;

FIG. 9 is a front, top and right side perspective view of a basketball portion thereof;

FIG. 10 is a front elevational view of the basketball portion thereof;

FIG. 11 is a right side elevational view of the basketball, soccerball and baseball portions thereof, the top plan view and bottom plan view thereof being identical thereto, and the left side elevational view being a mirror image thereof;

FIG. 12 is a rear elevational view of the basketball, soccerball and baseball portions thereof;

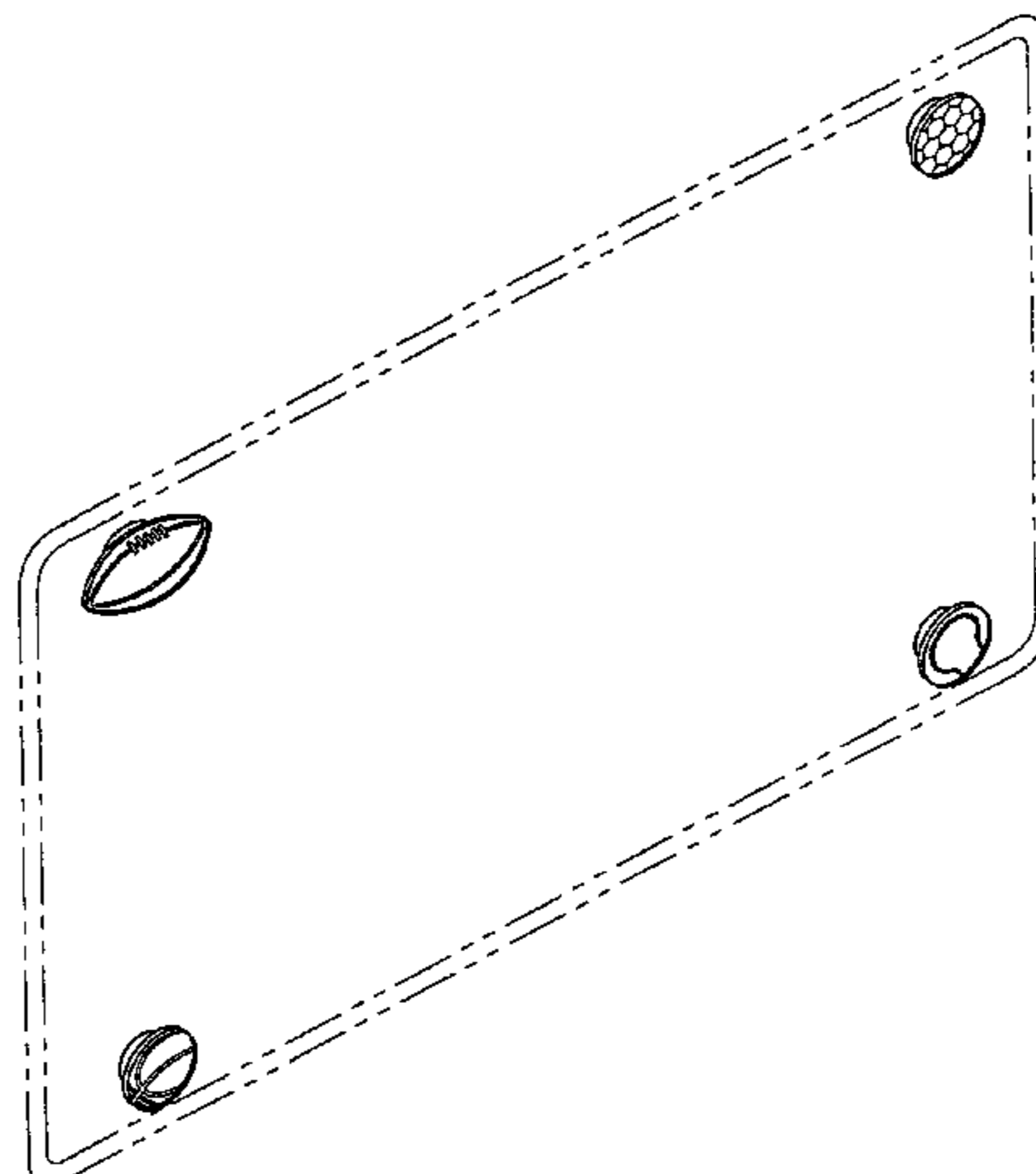
FIG. 13 is a front, top and right side perspective view of the soccerball portion thereof;

FIG. 14 is a front elevational view of the soccerball portion thereof;

FIG. 15 is a front, top and right side perspective view of the baseball portion thereof; and,

FIG. 16 is a front elevational view of the baseball portion thereof.

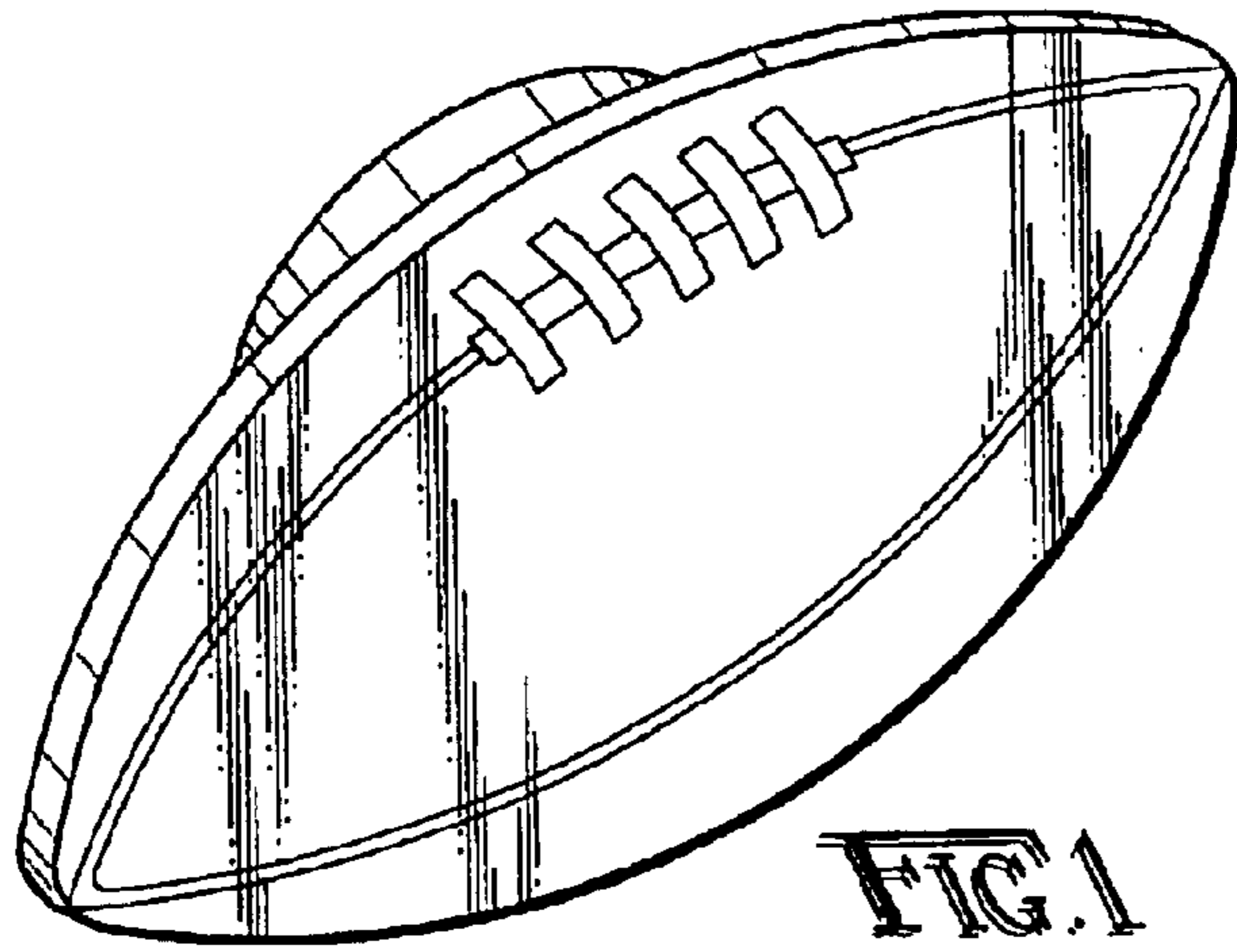

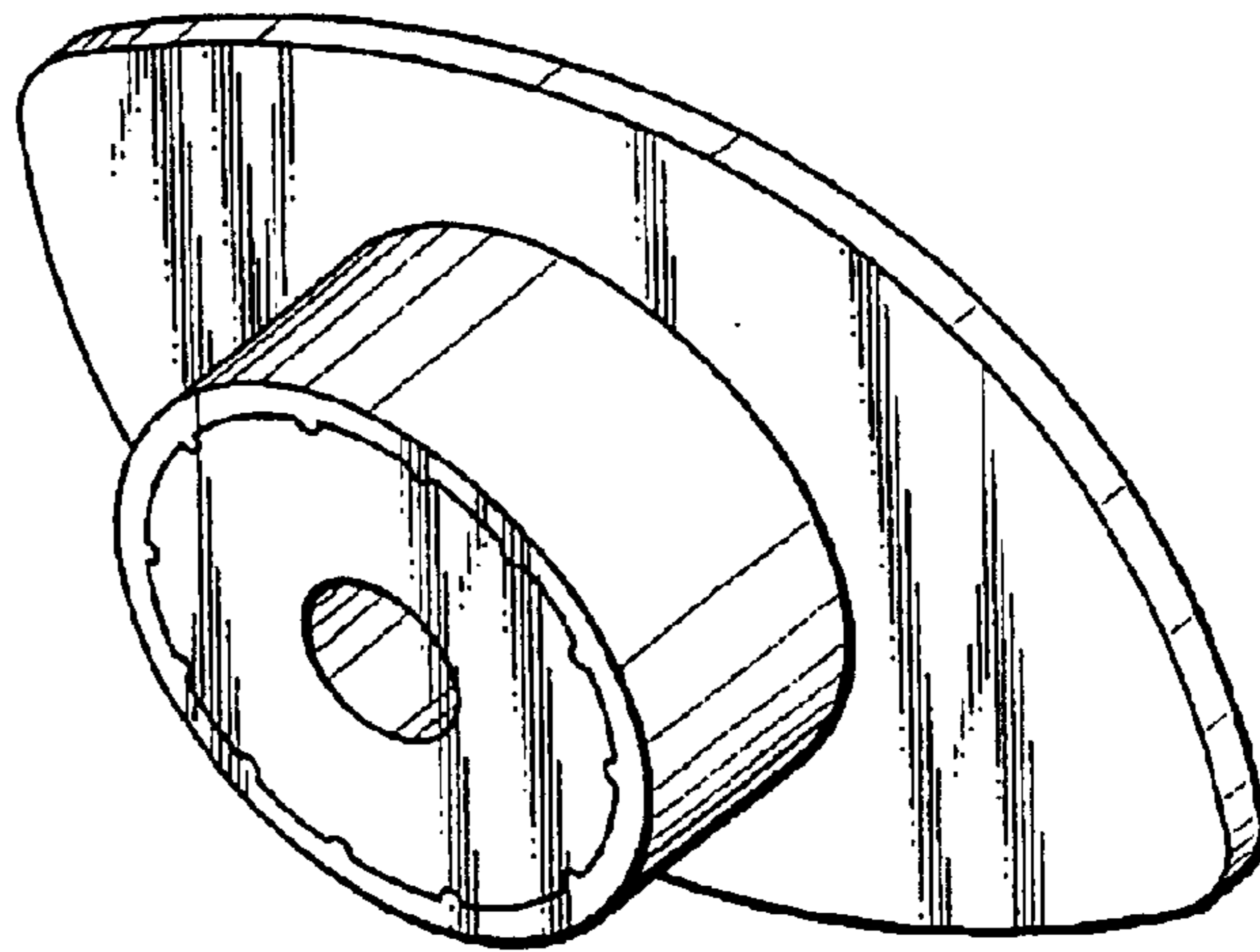

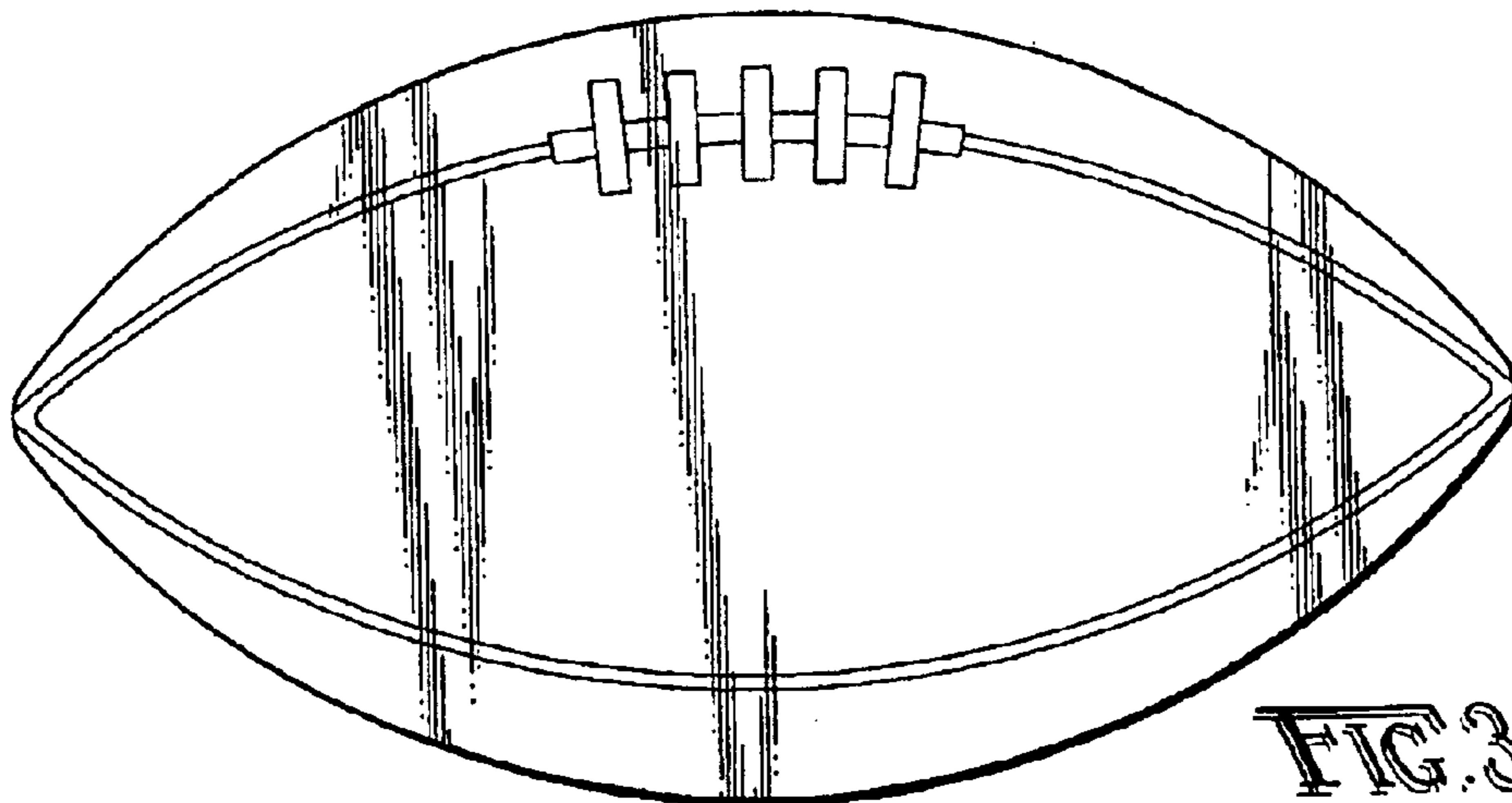
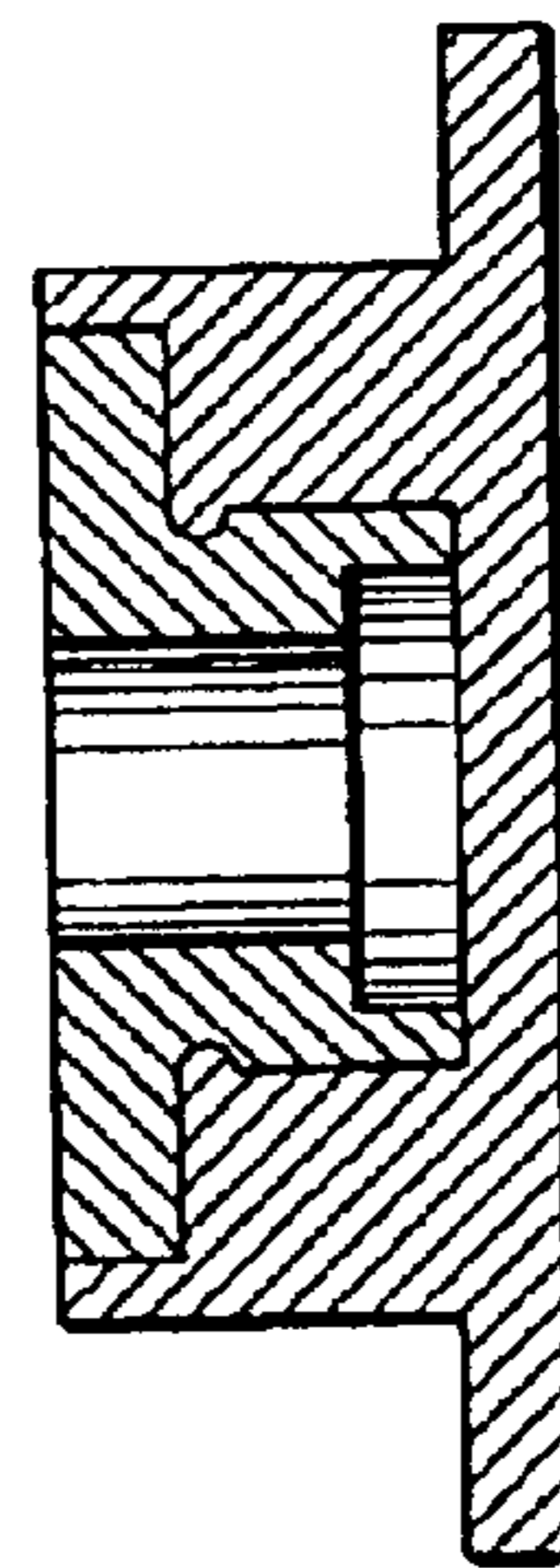
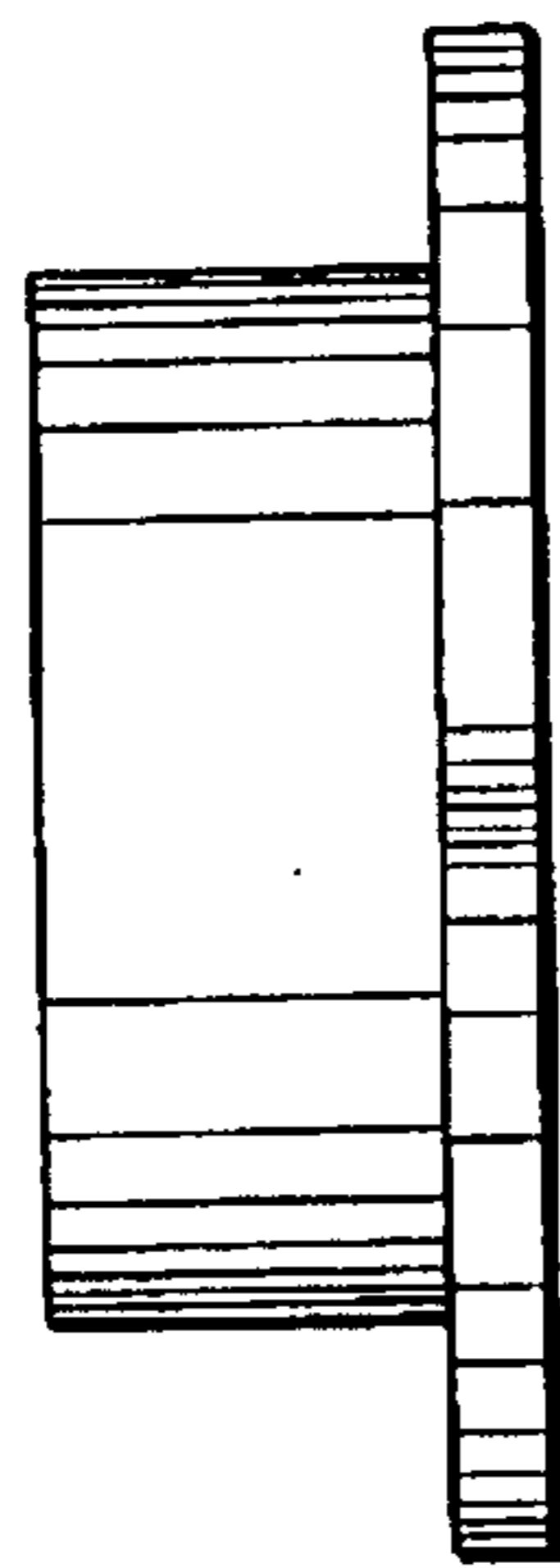
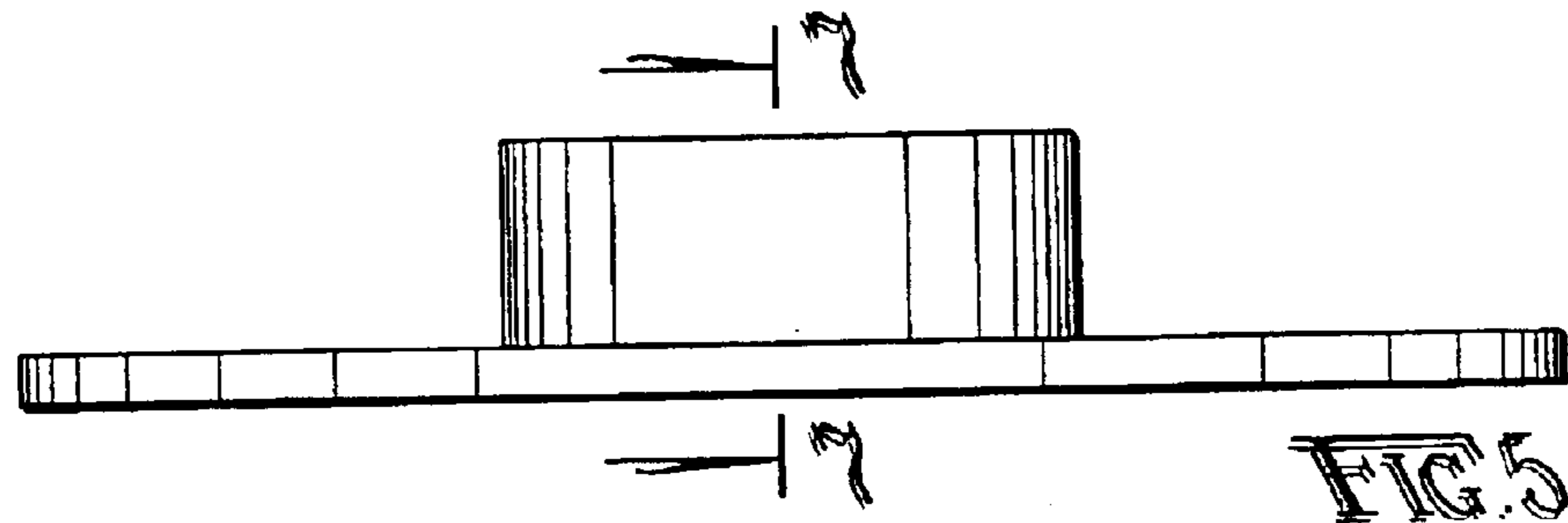
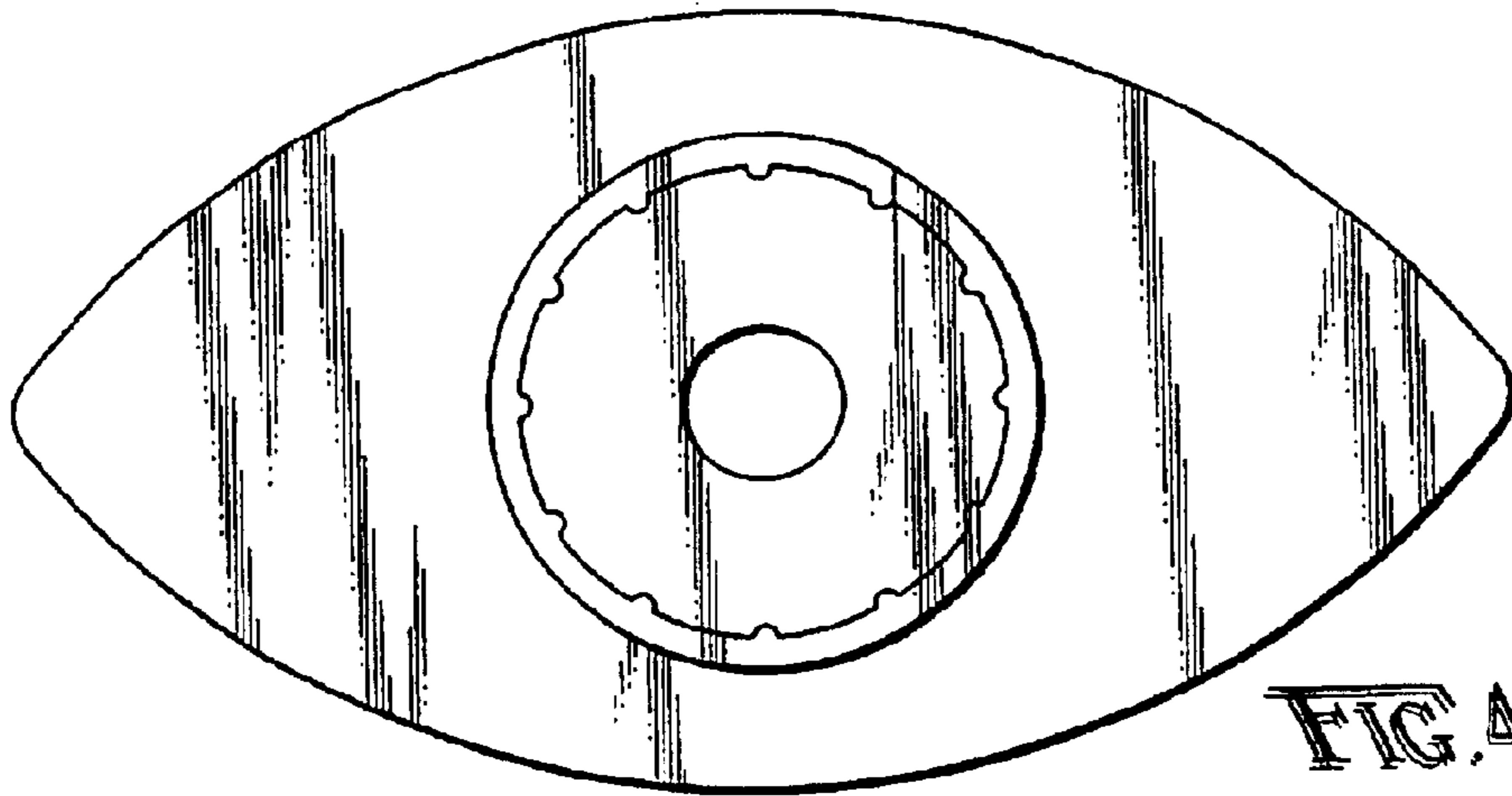

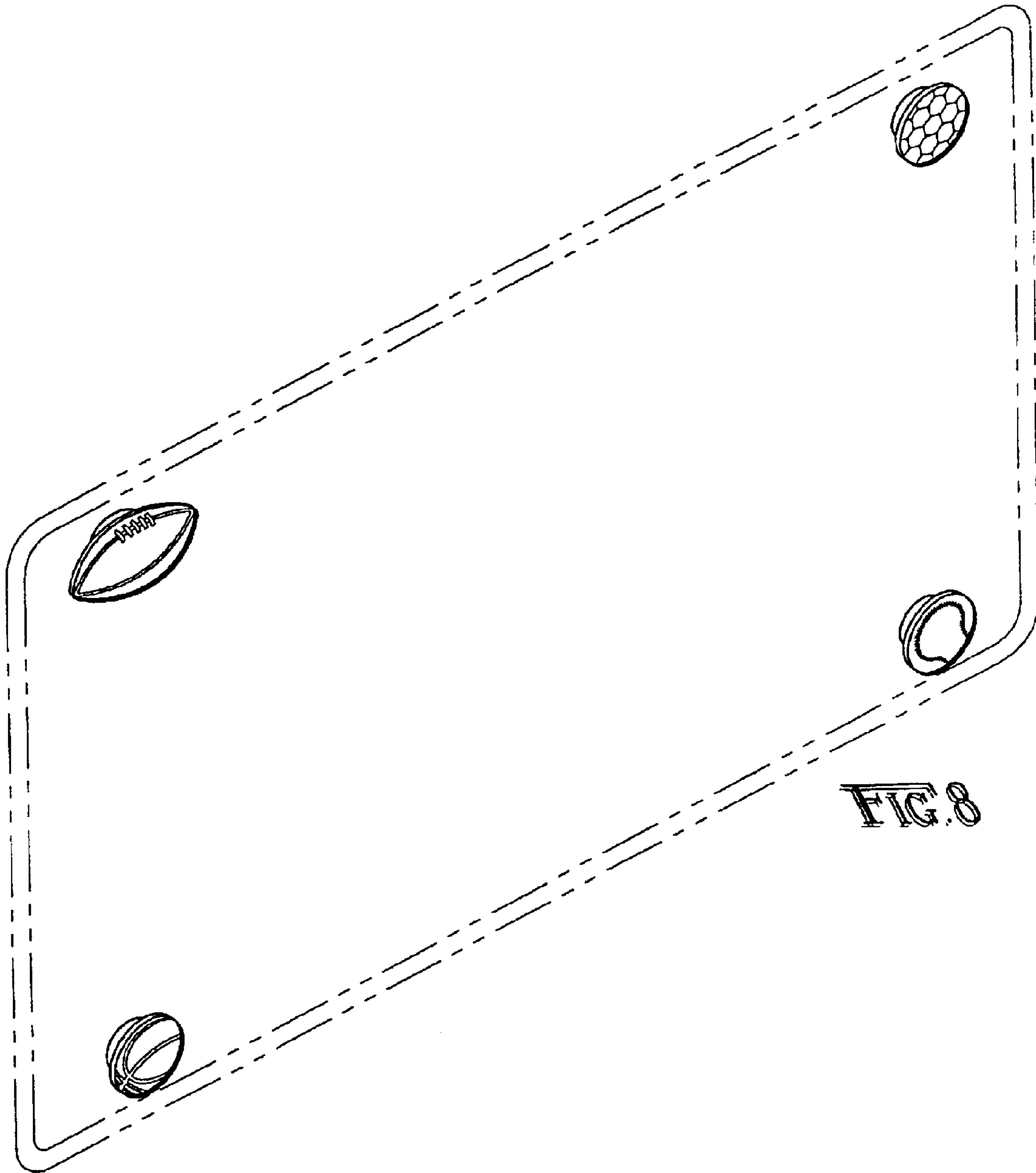

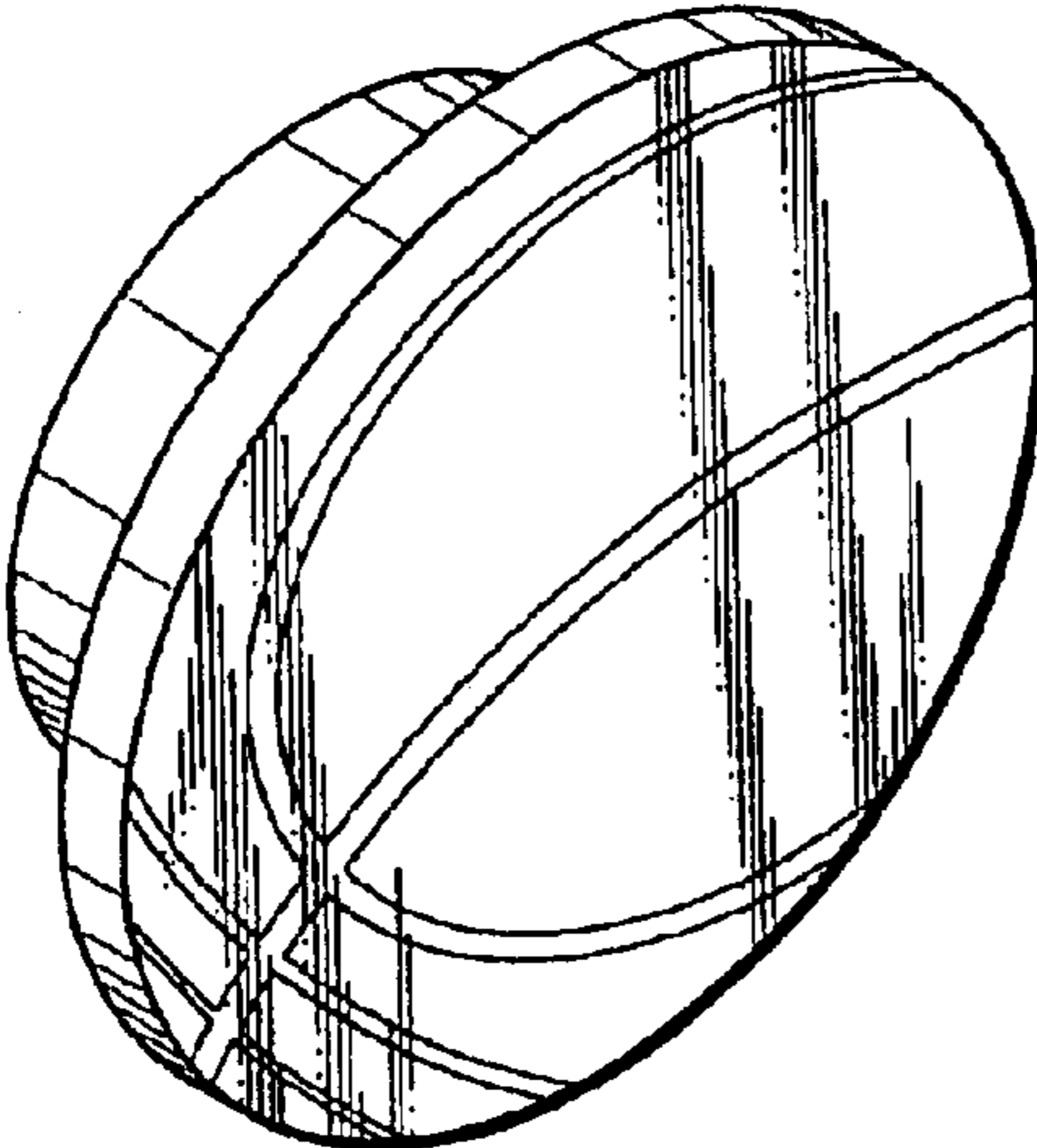

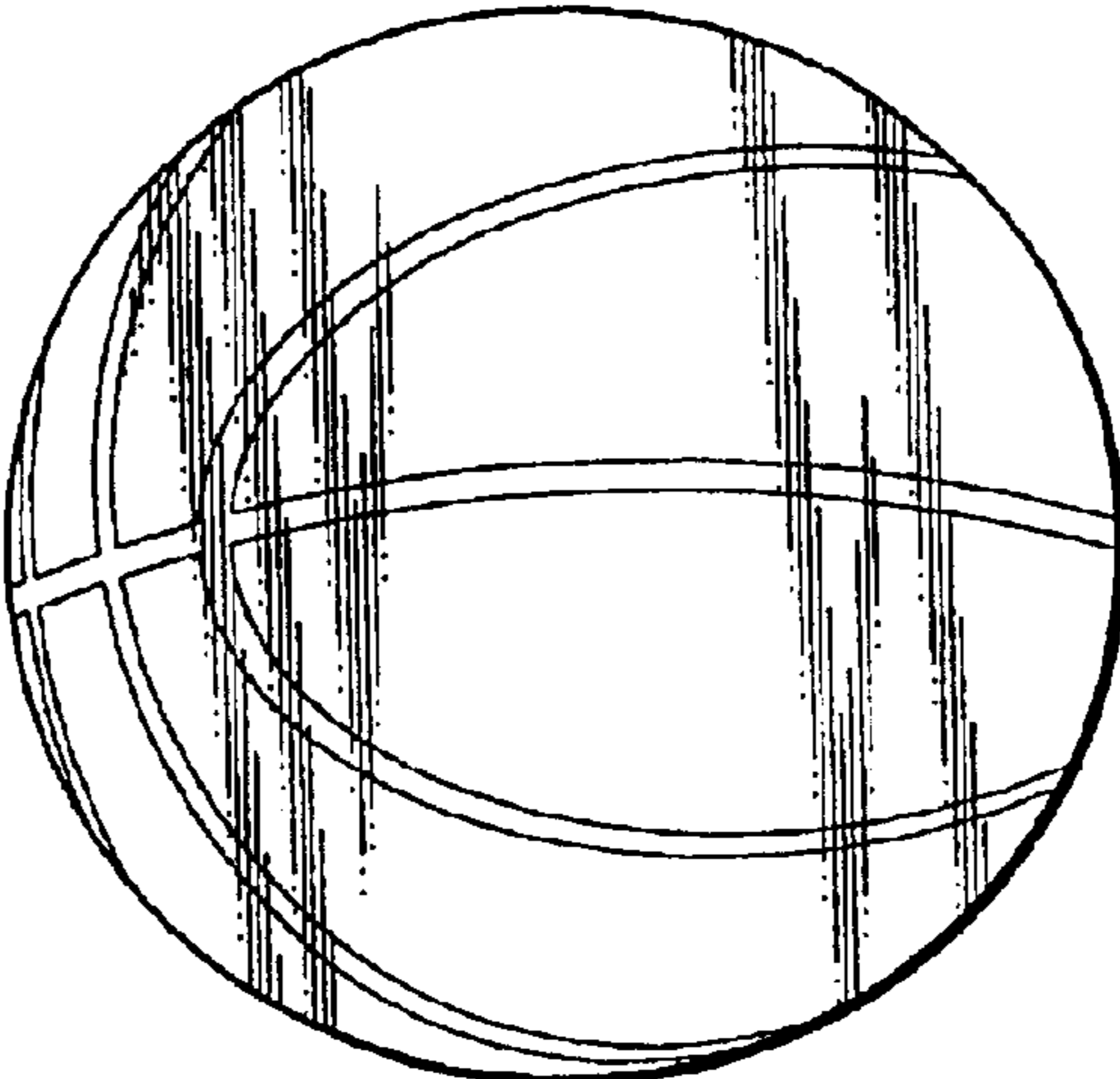

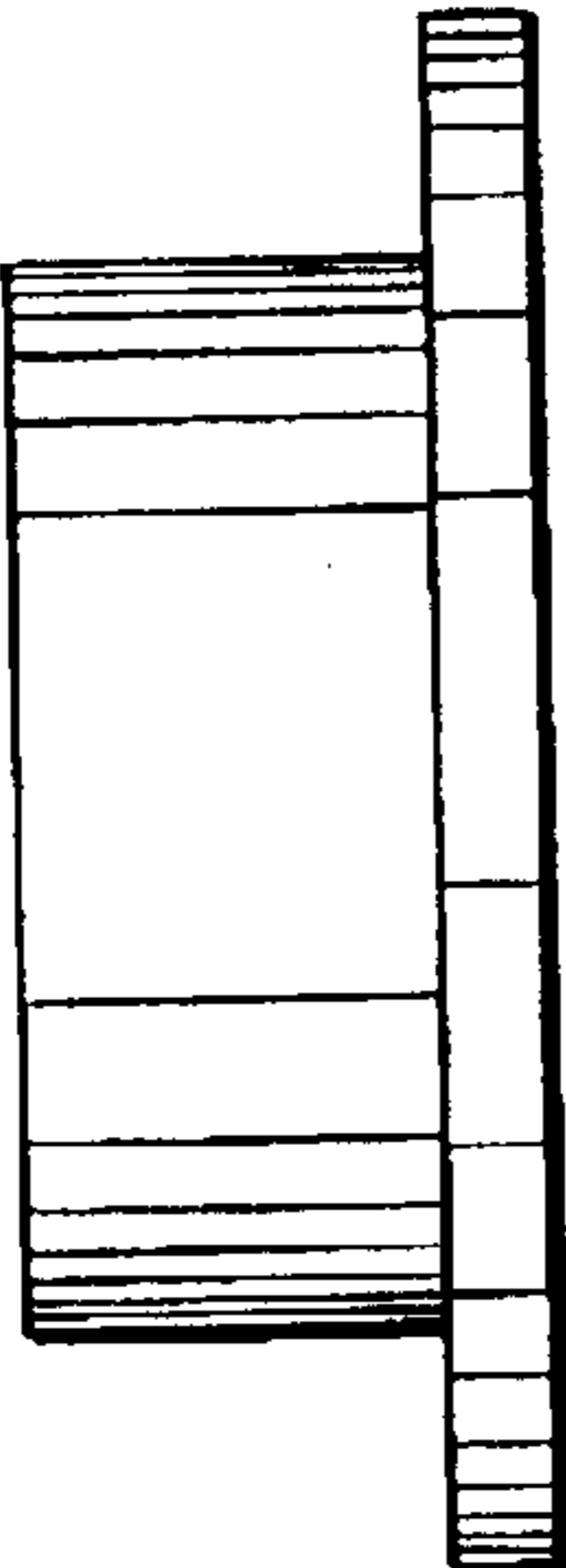

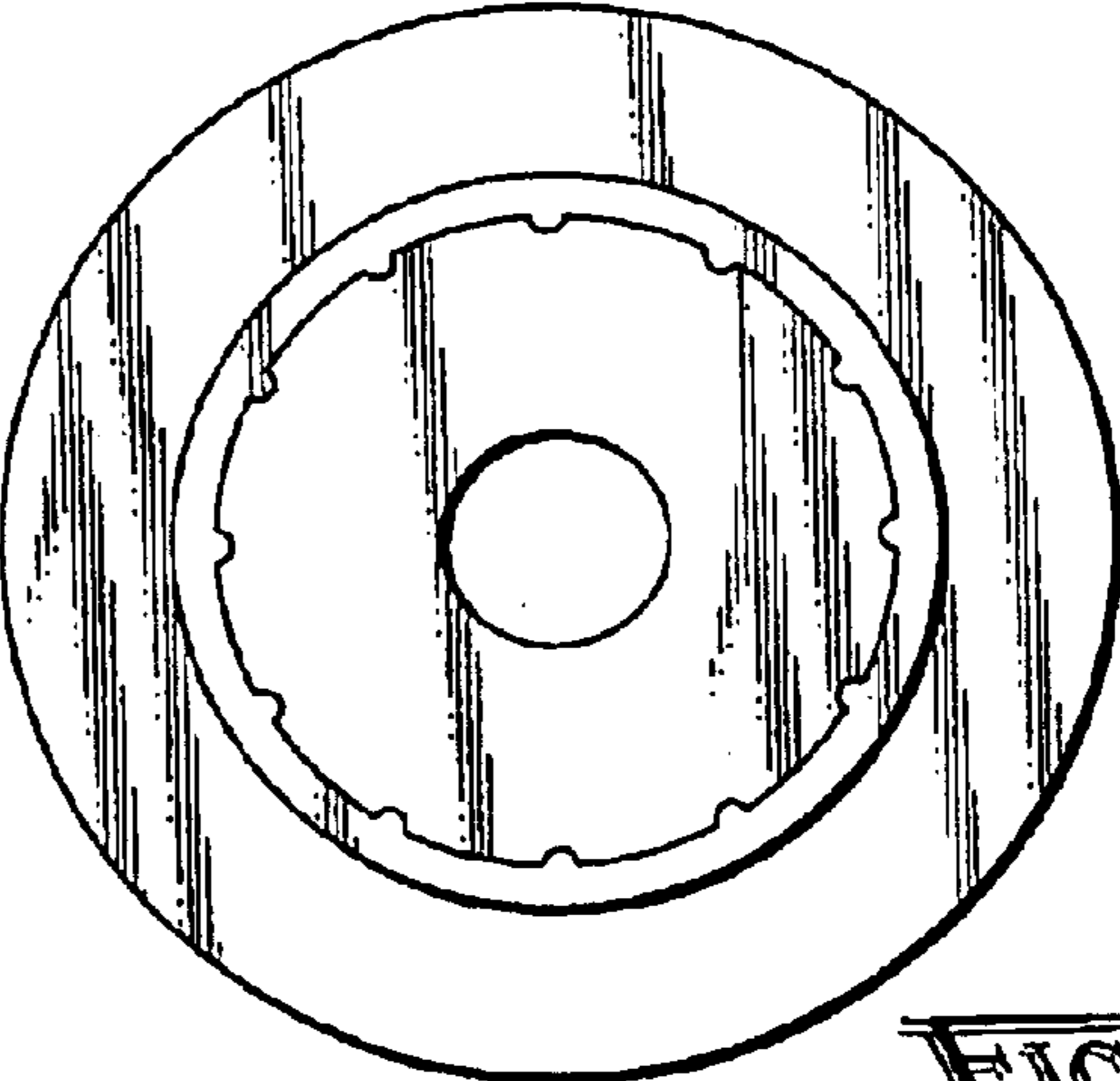

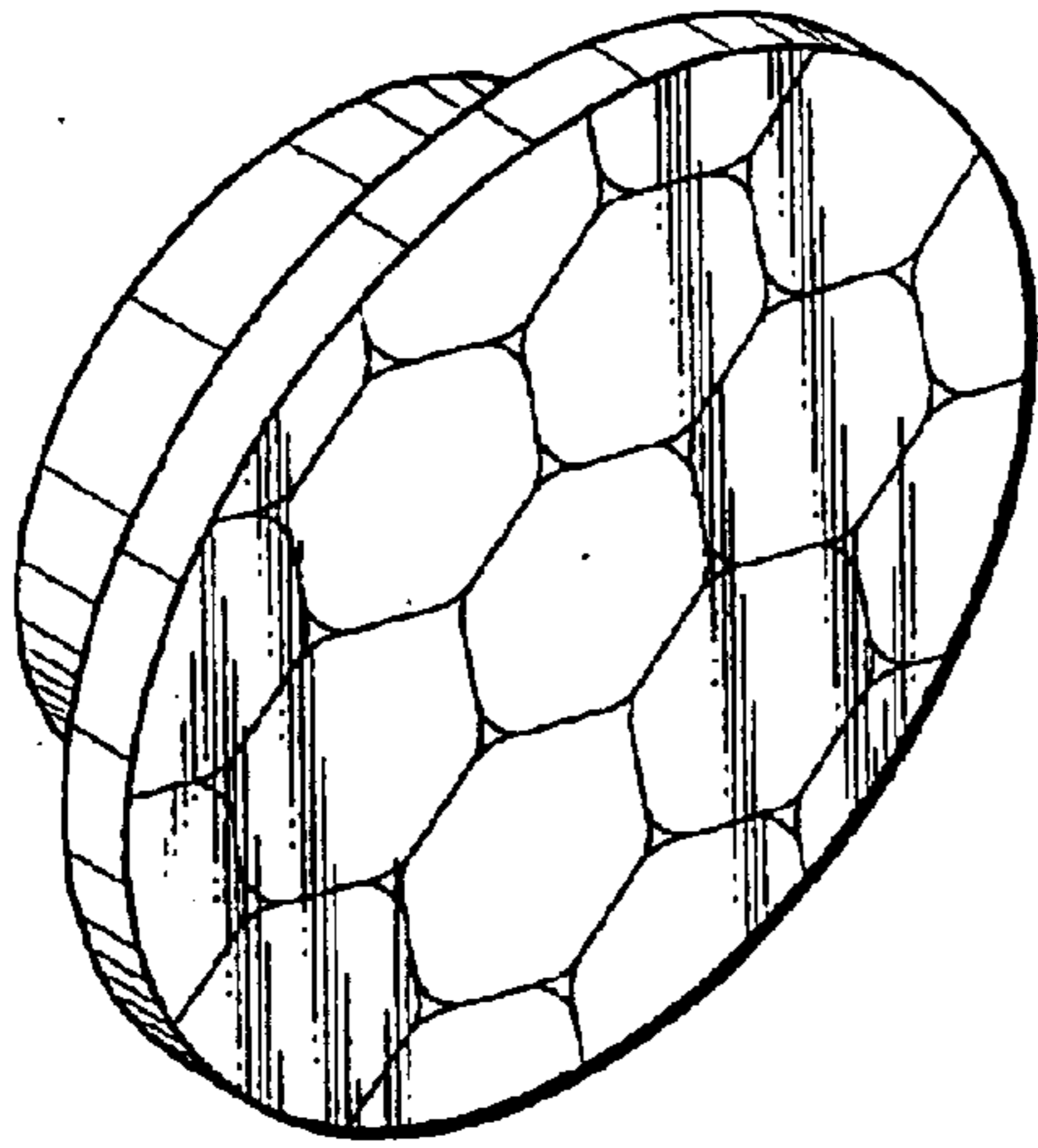

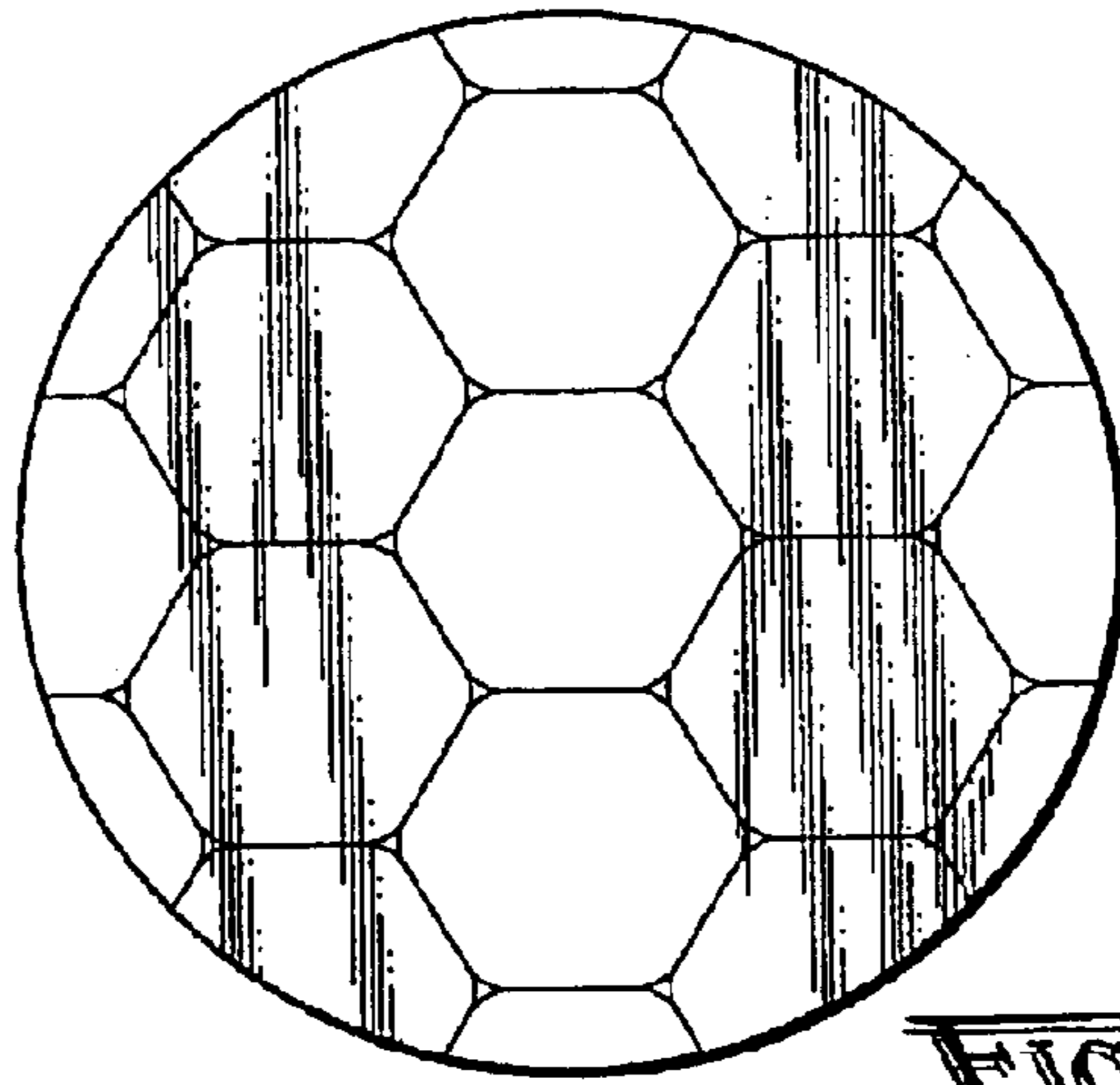

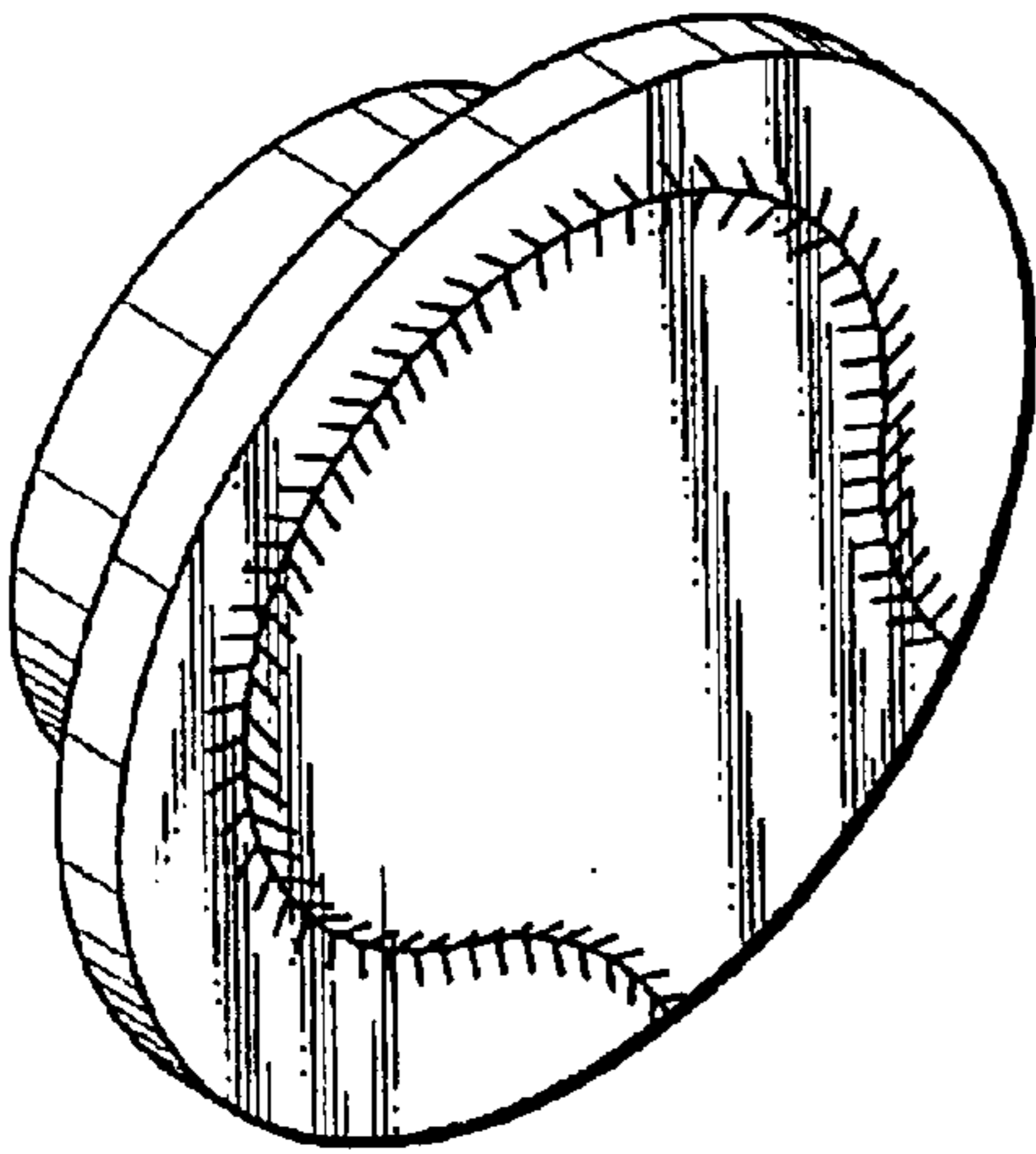

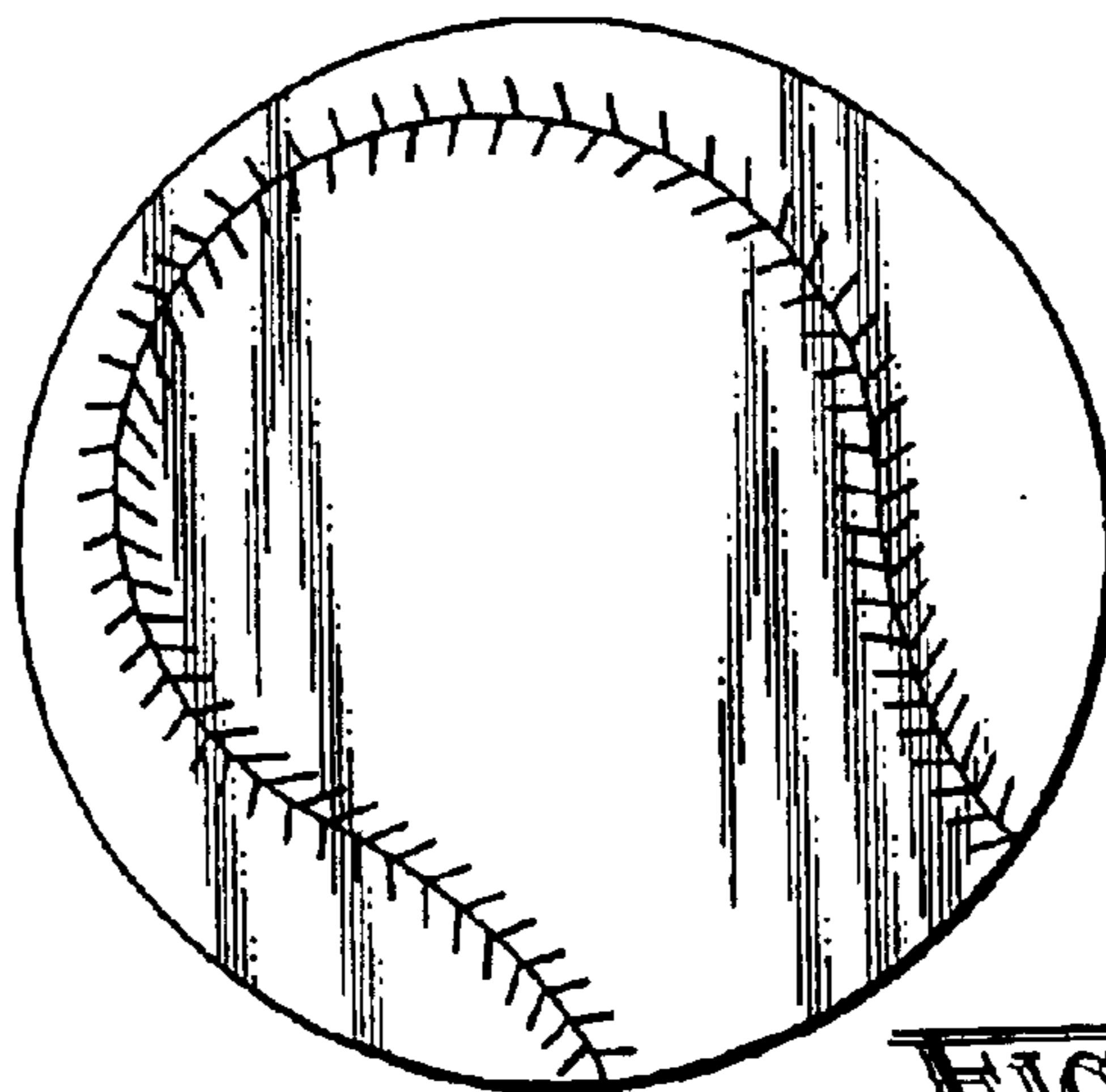
