(57) **CLAIM**

The ornamental design for a motorcycle rim with spinning spoke, as shown and described.

**DESCRIPTION**

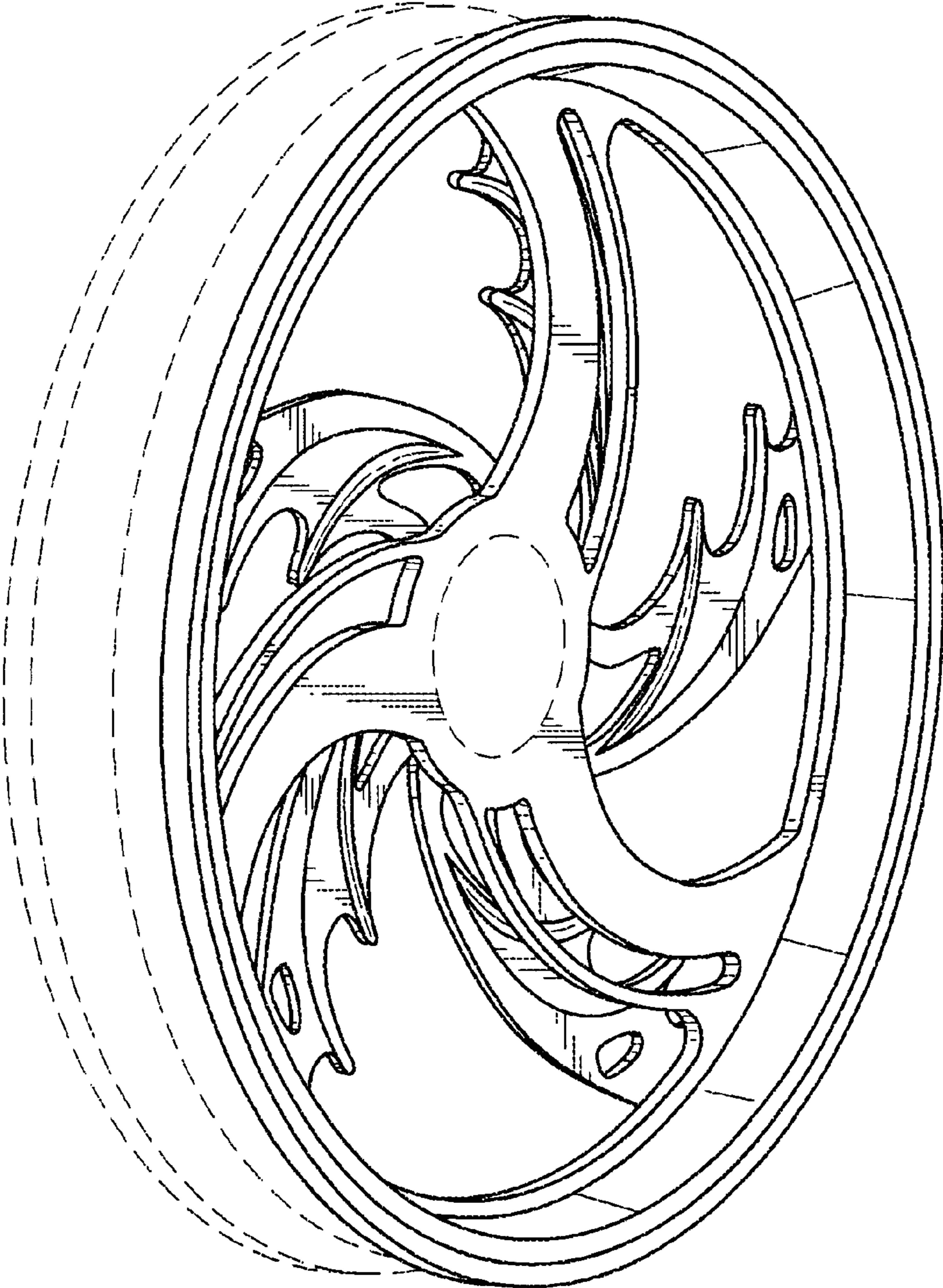
