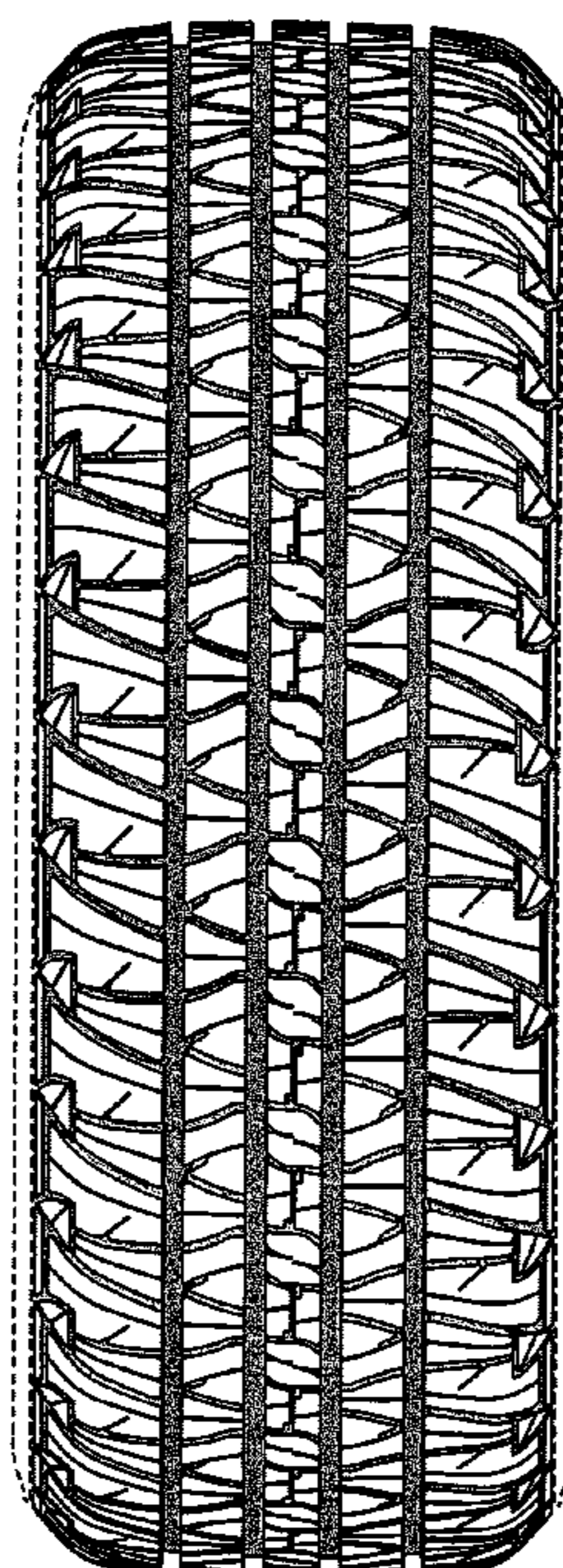

FIG. 1 is a side perspective view of a tire tread showing our new design, it being understood that the tread pattern is repeated throughout the circumference of the tire tread, the opposite side being the same as that shown; FIG. 2 is a front elevational view thereof; FIG. 3 is a side elevational view of the right side thereof, the opposite side being identical thereto; and, FIG. 4 is an enlarged fragmentary side perspective view thereof.

The broken line showing of the tire sidewall, inner bead and peripheral boundary between the tire tread and sidewall is for illustrative purposes only and forms no part of the claimed design.

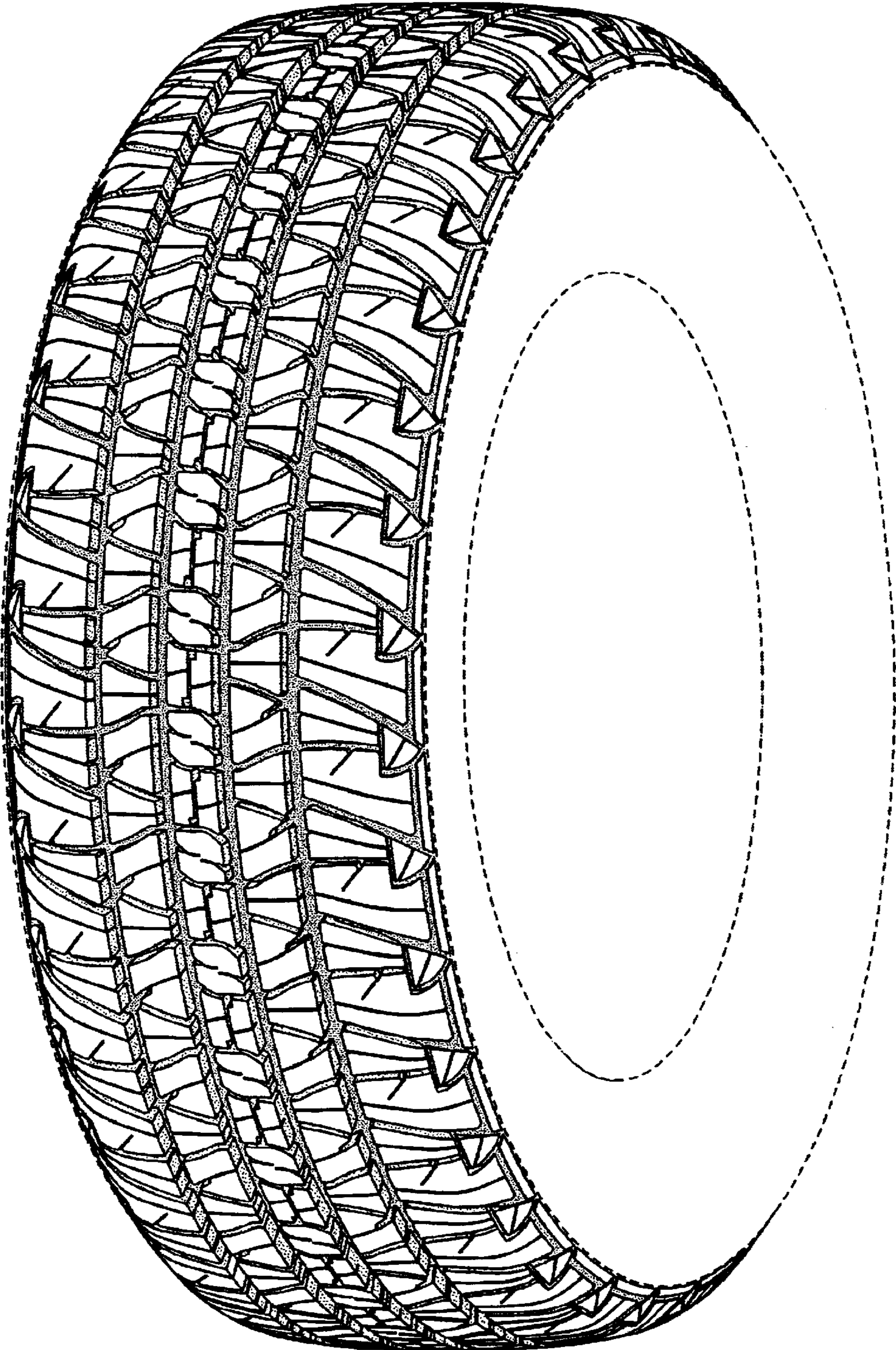

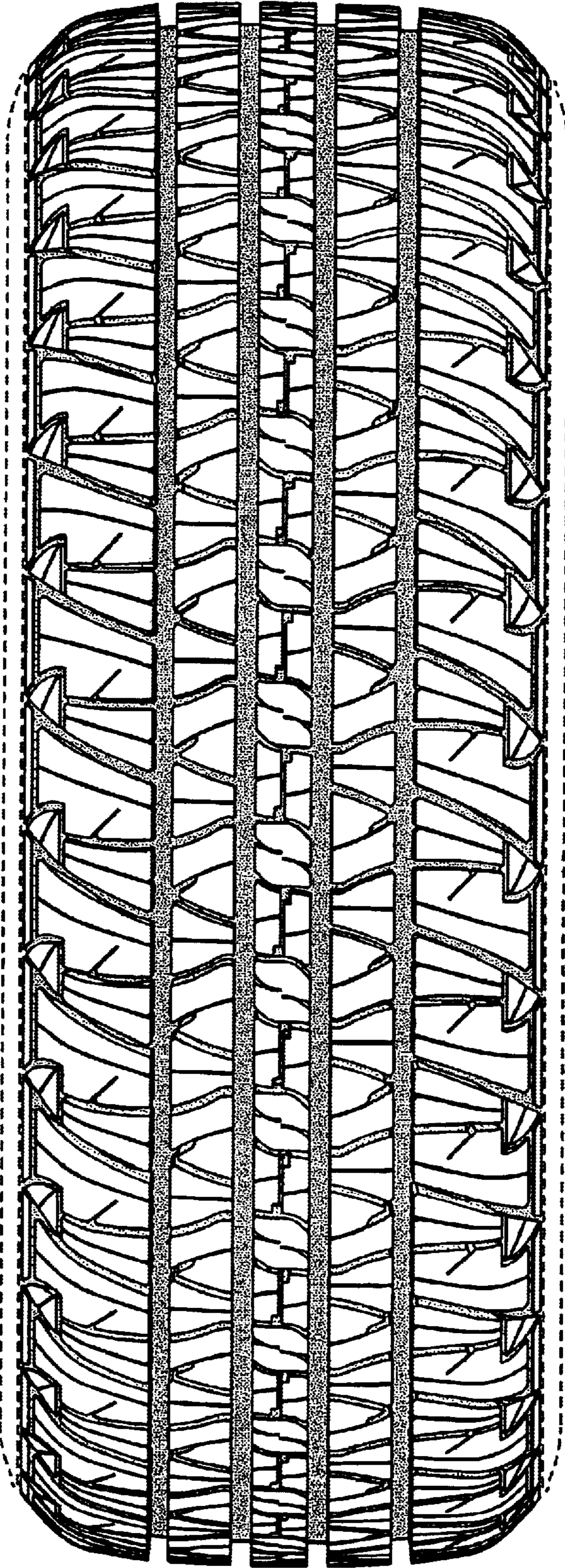

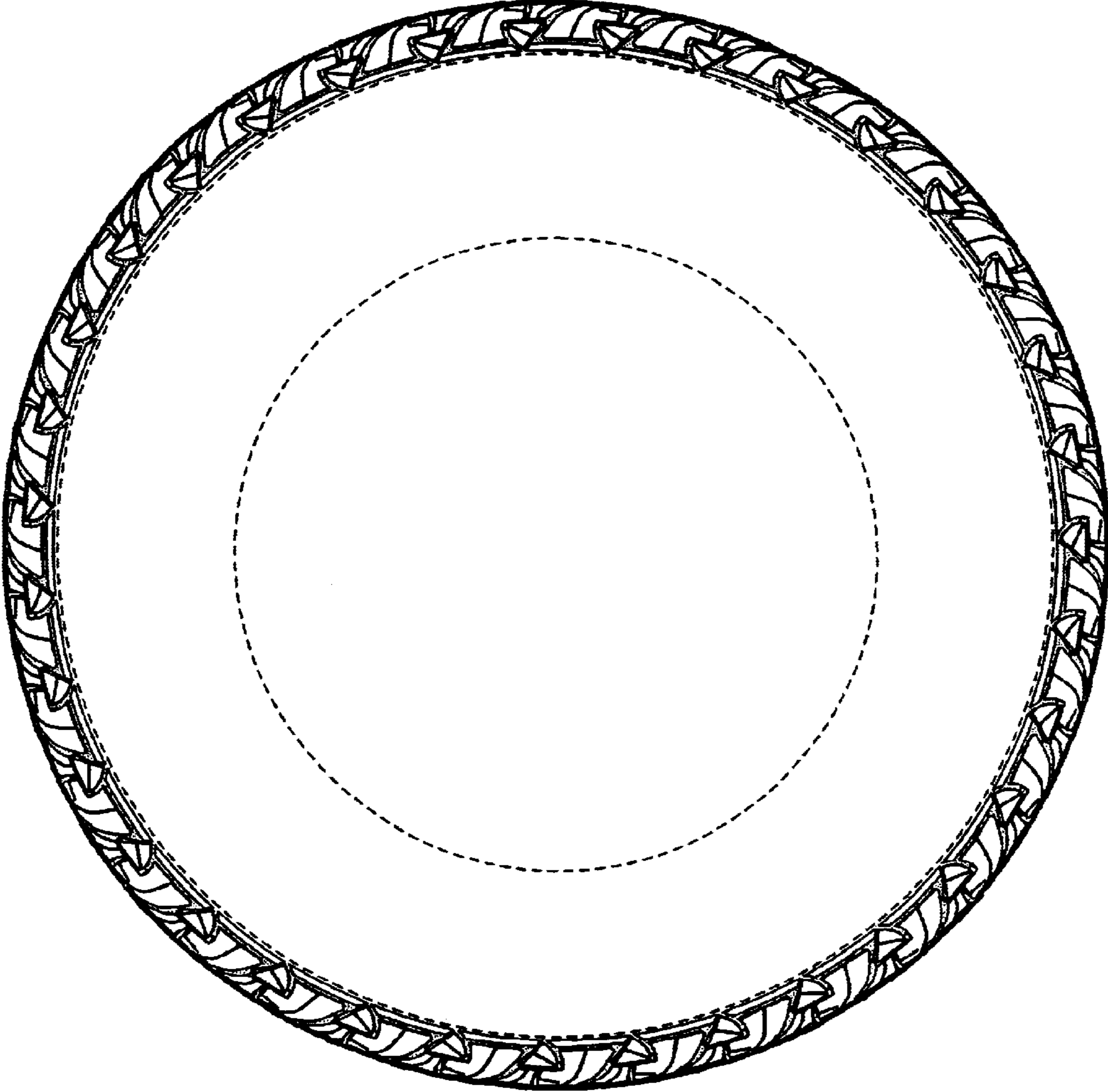

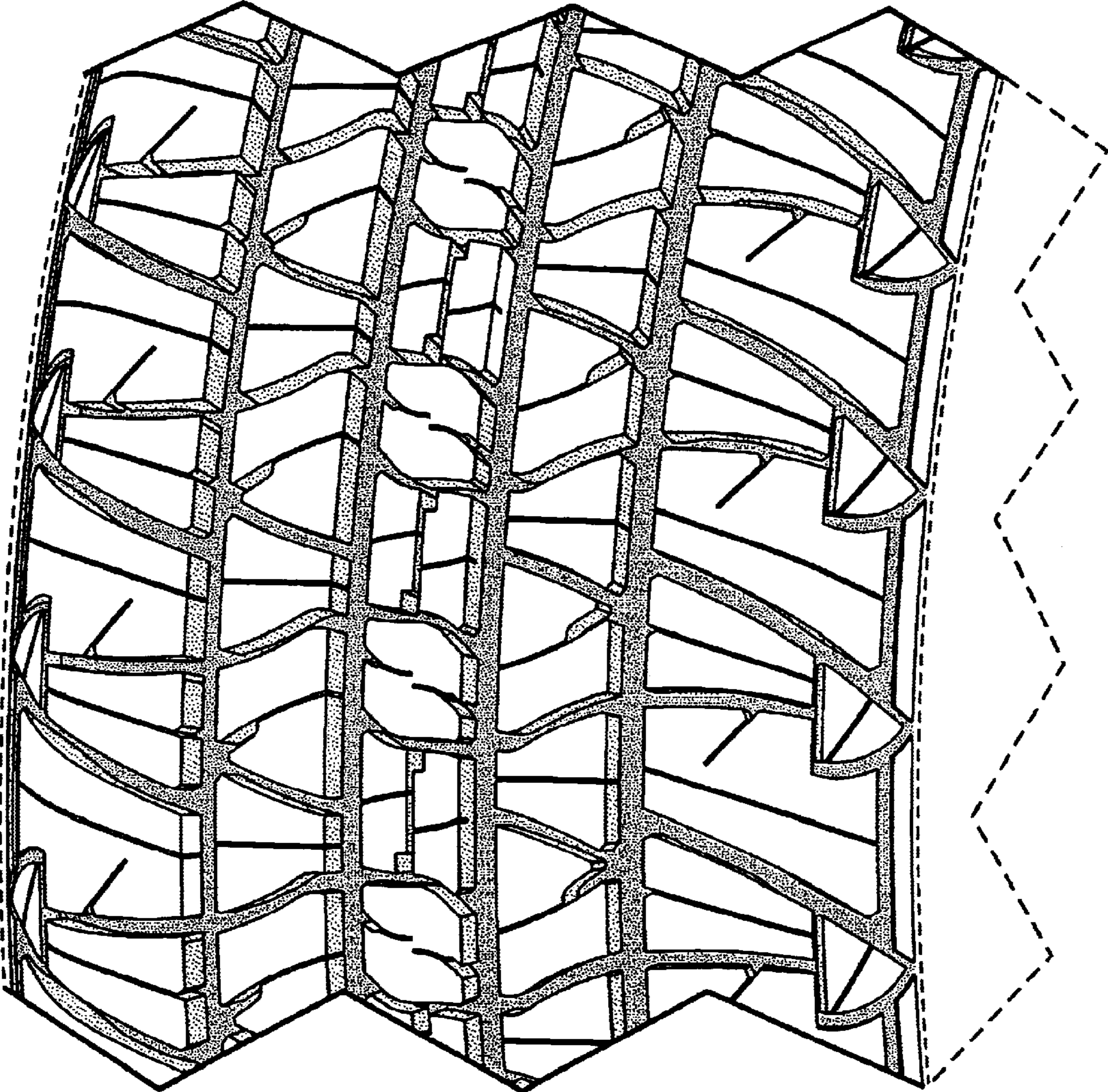
