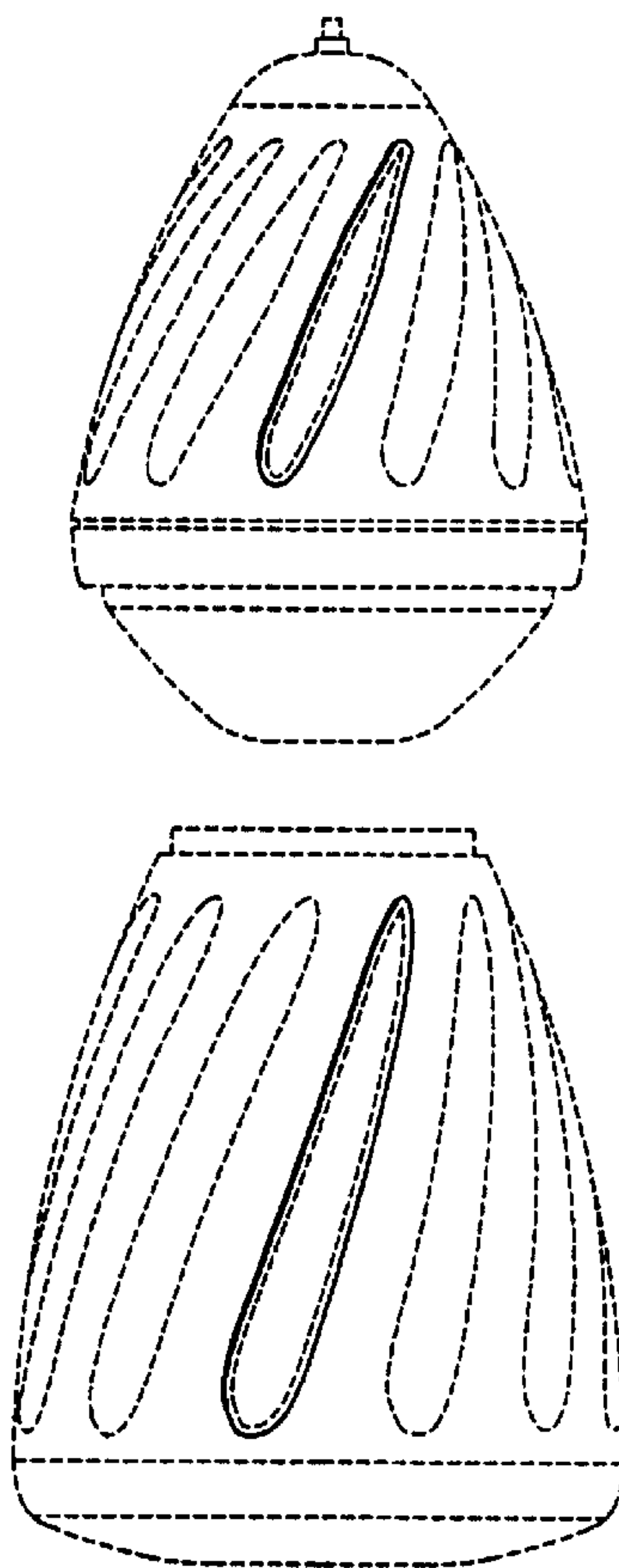
(57) **CLAIM**

The ornamental design for an element of an audio speaker enclosure, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of an element of audio speaker enclosure showing my new design;
FIG. 2 is a top view thereof;
FIG. 3 is a top perspective view thereof;
FIG. 4 is a bottom perspective view thereof;
FIG. 5 is a side elevational view of a second embodiment of FIG. 1;
FIG. 6 is a top view of FIG. 5;
FIG. 7 is a bottom perspective view of FIG. 5; and,
FIG. 8 is a top perspective view of FIG. 5.

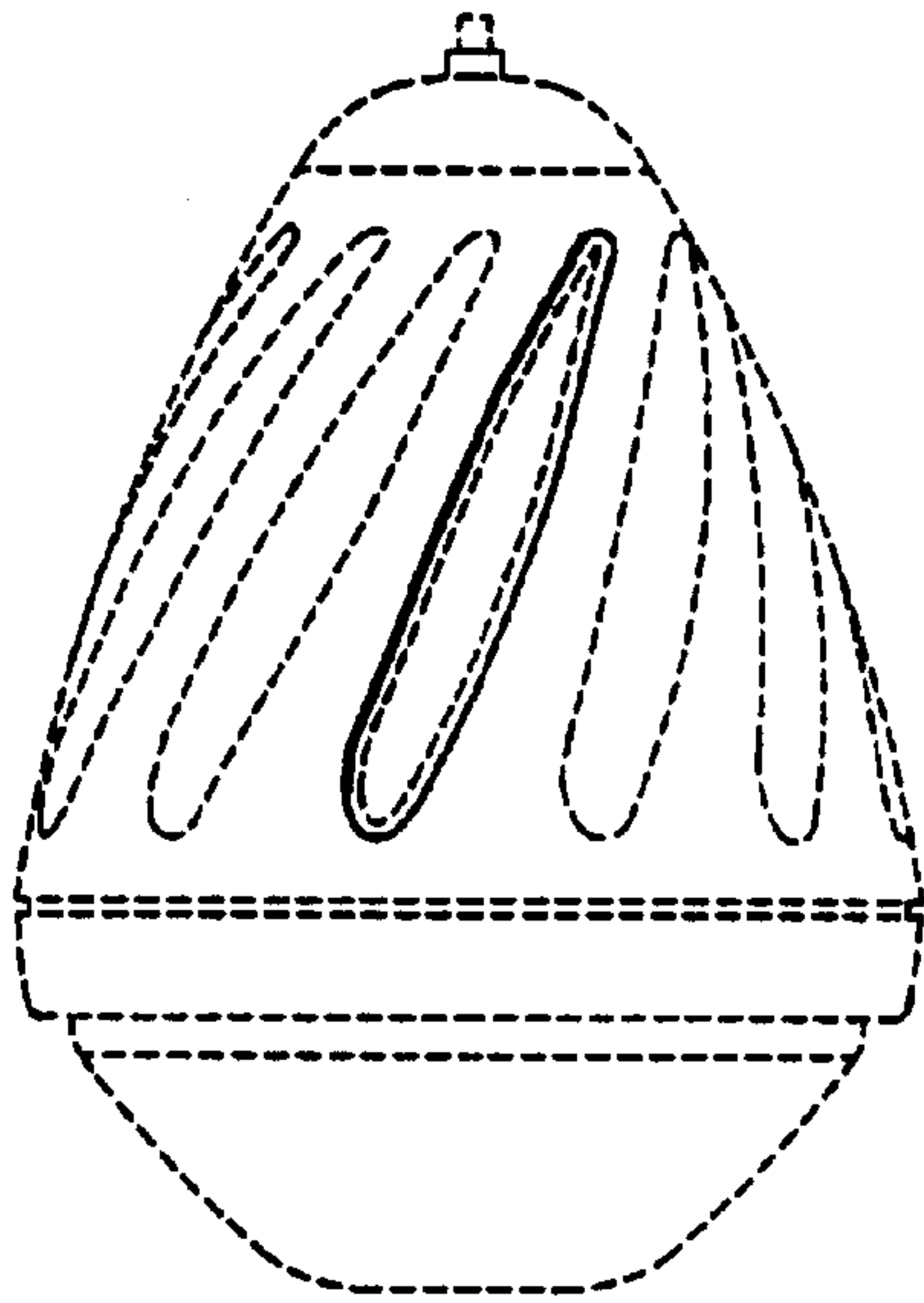

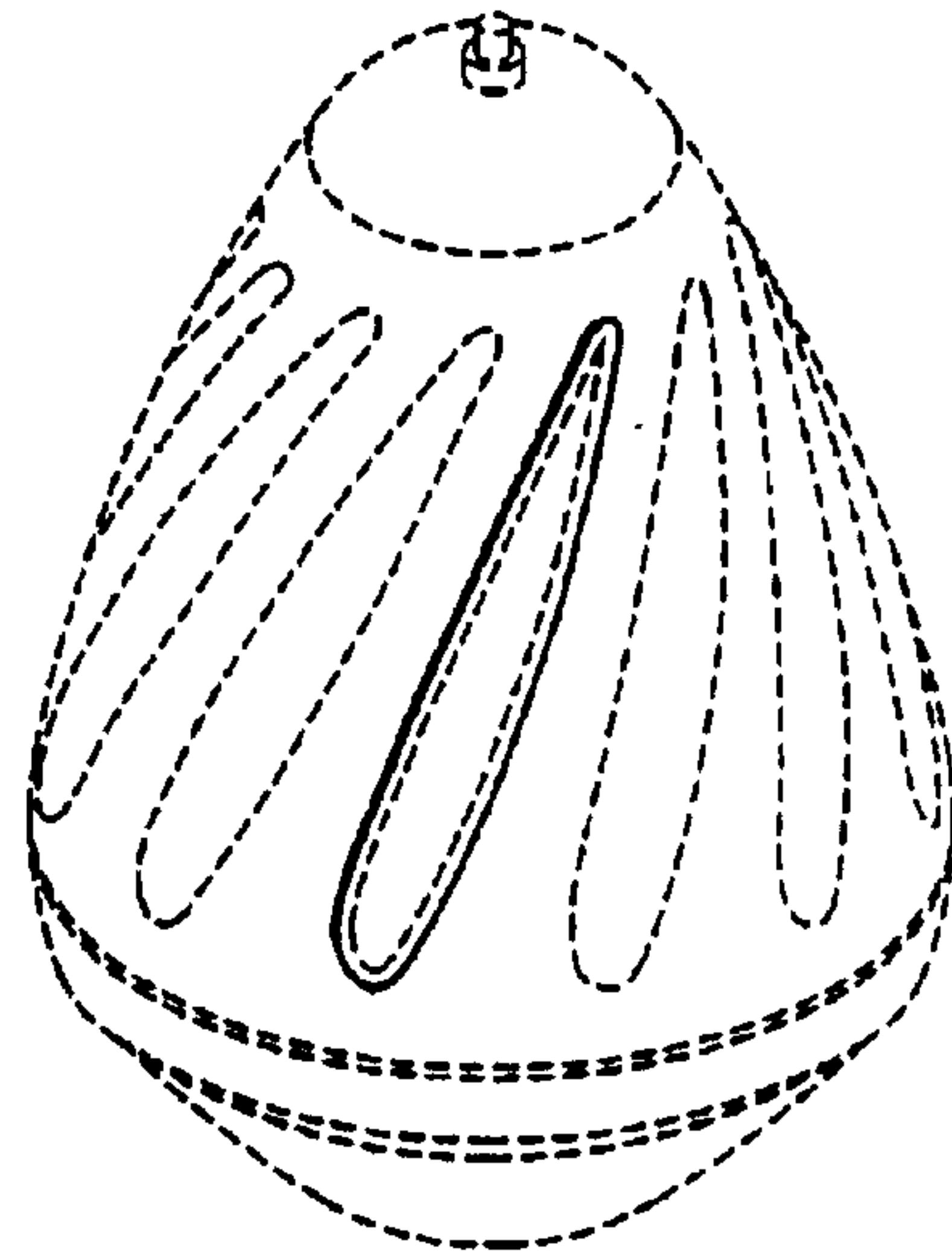

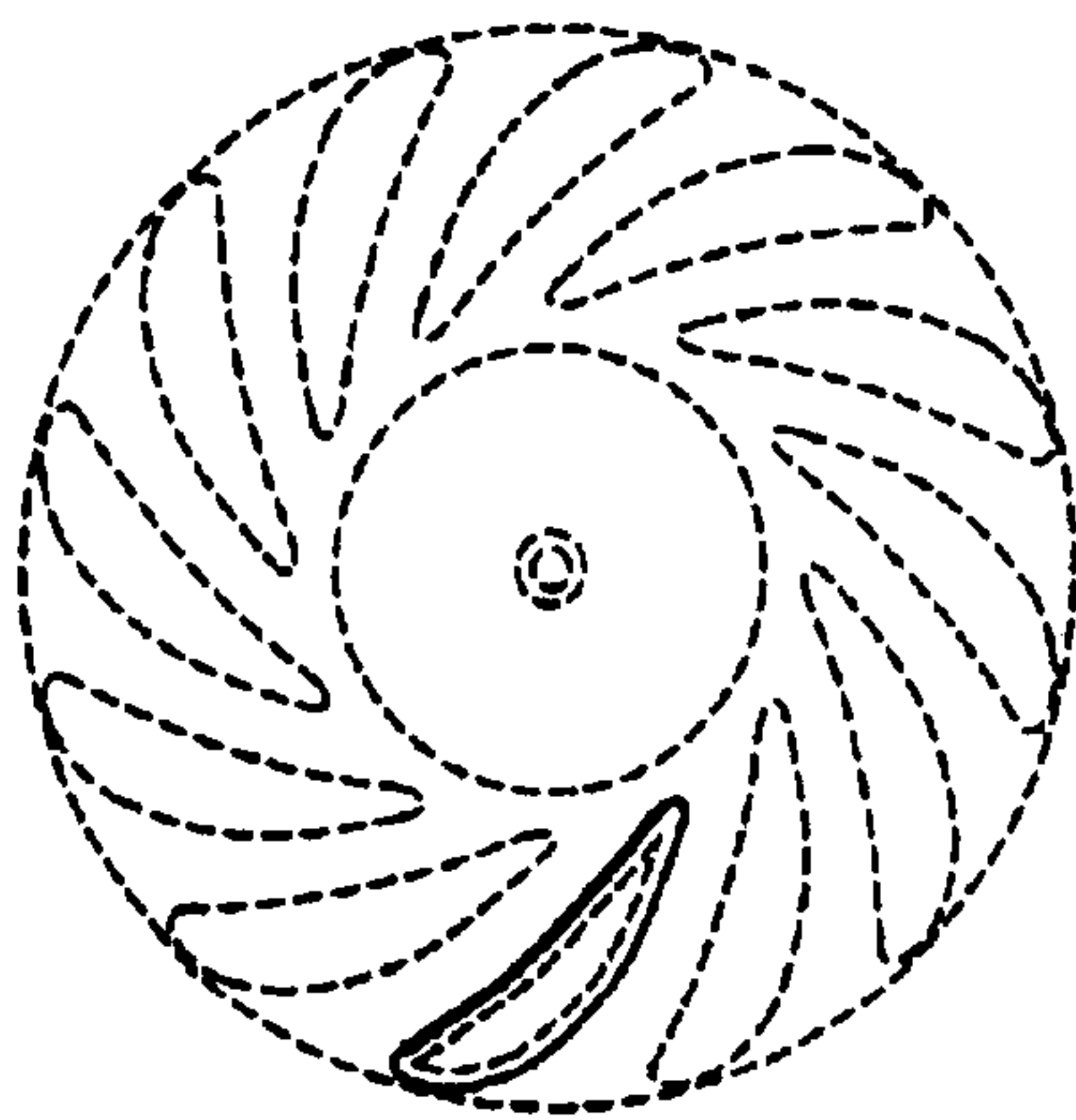

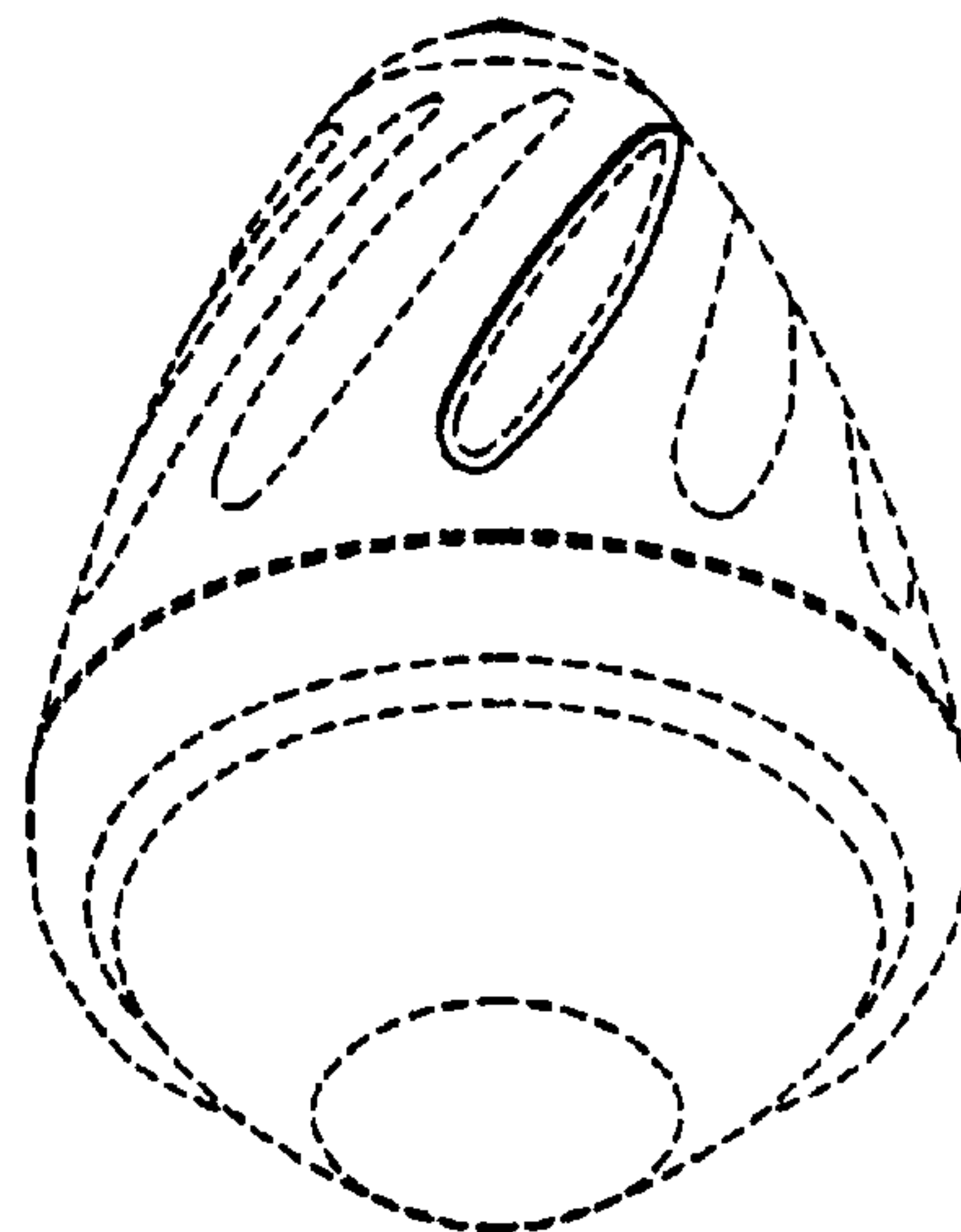

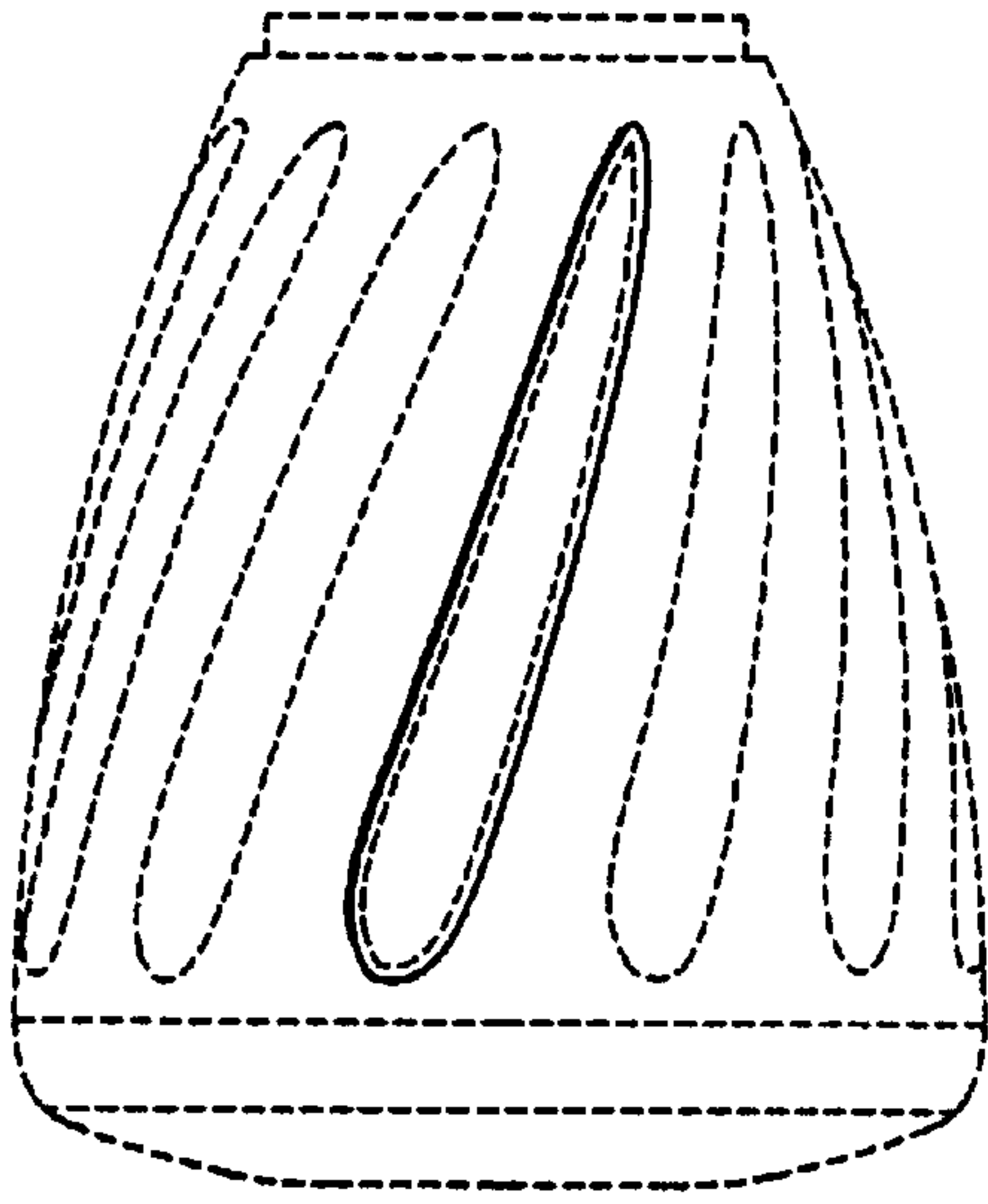

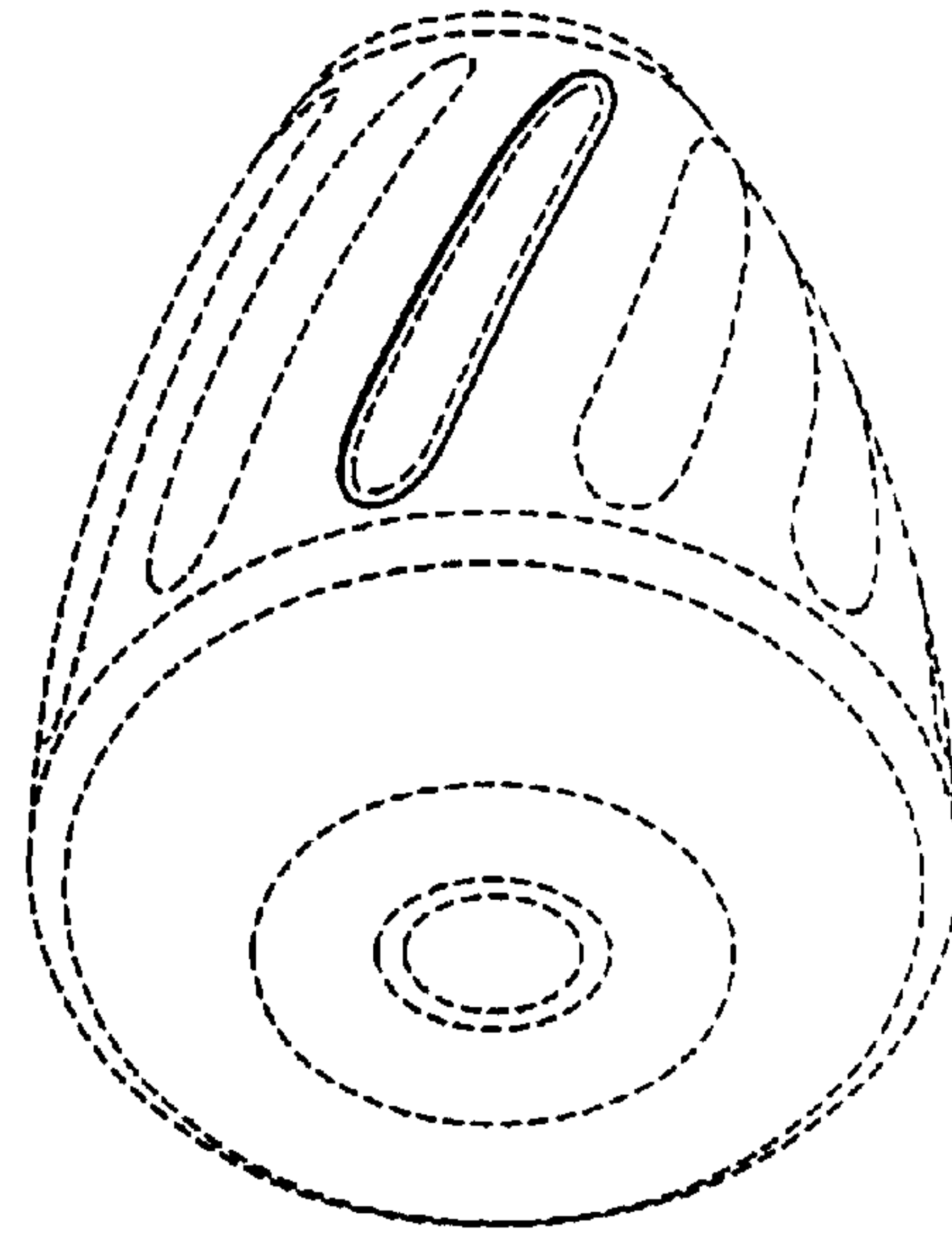

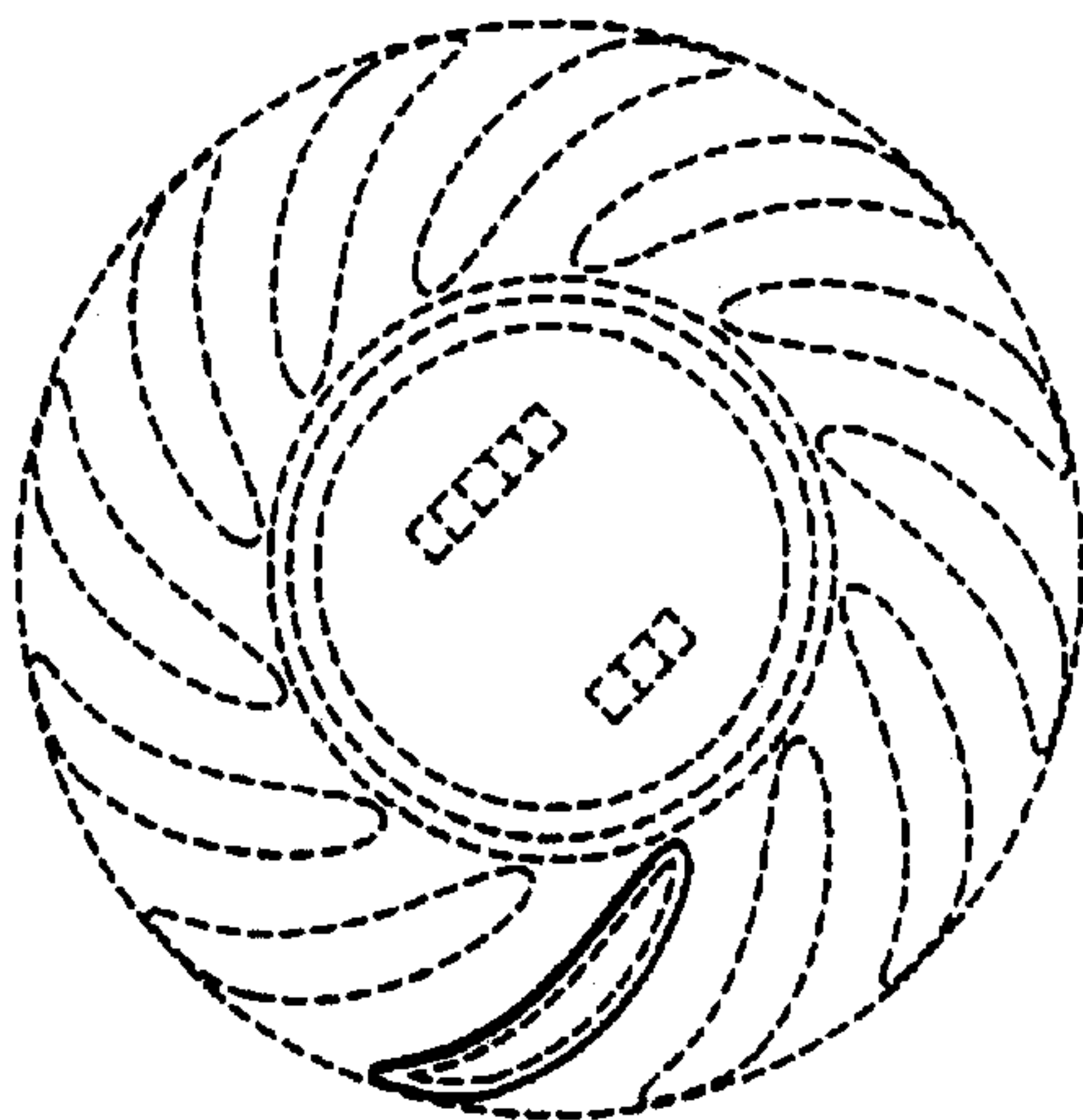

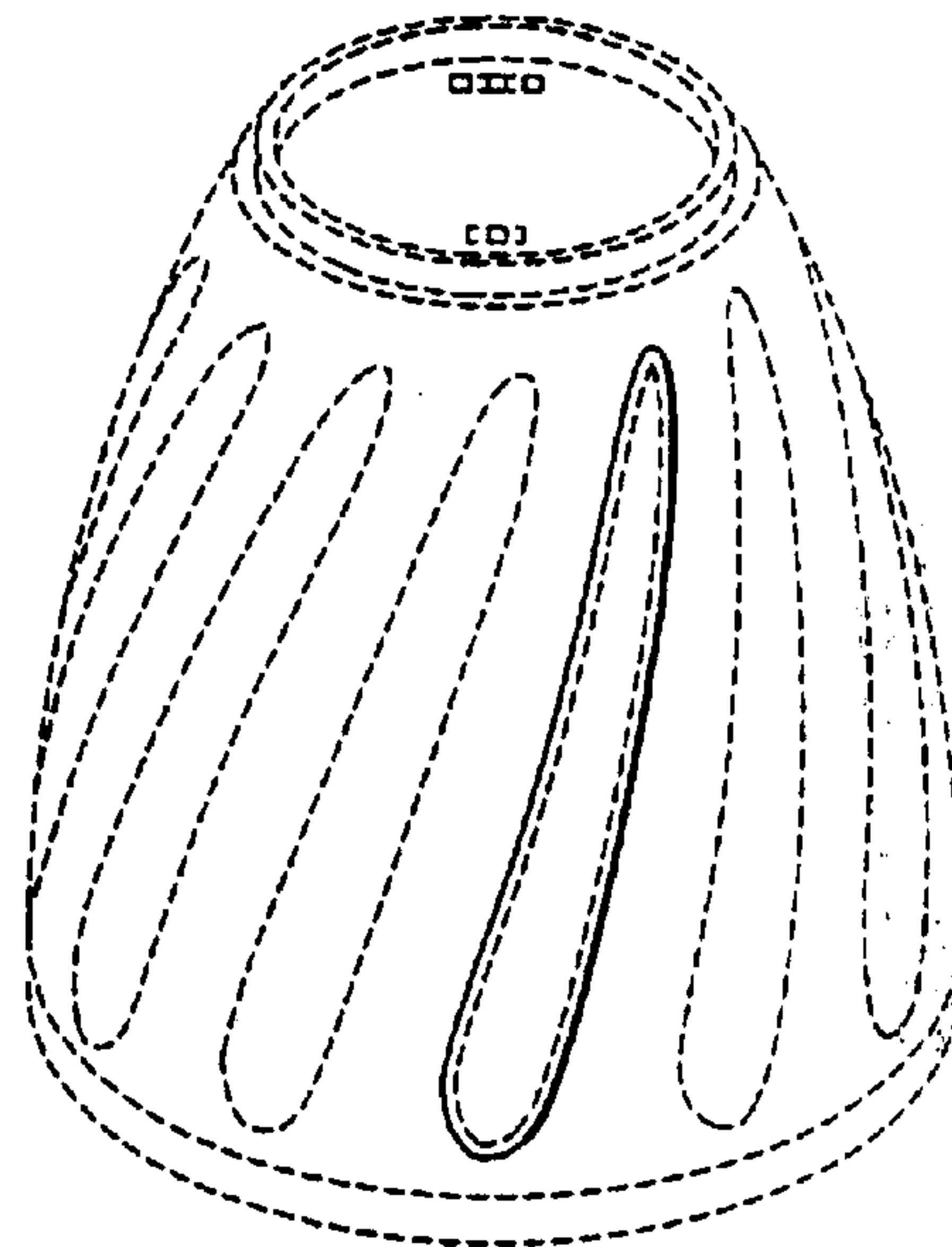
