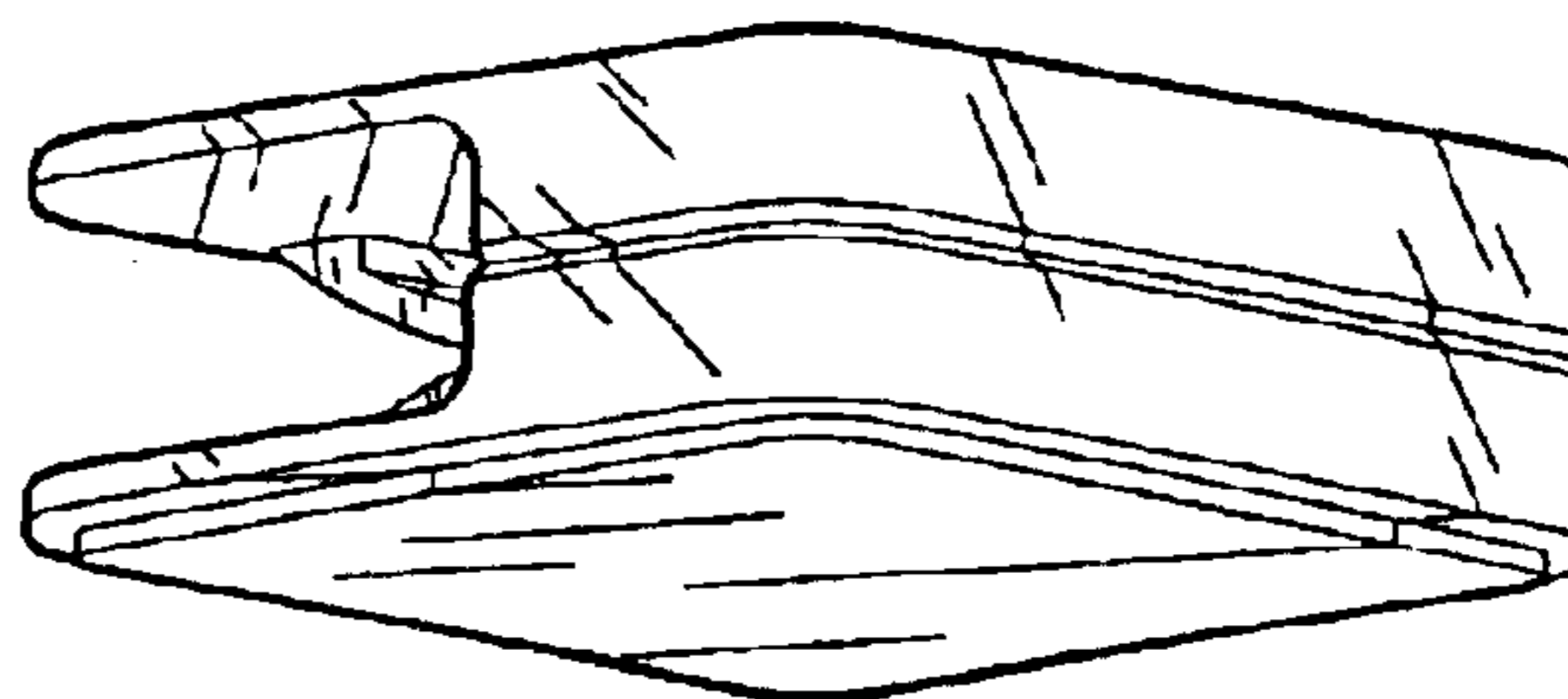
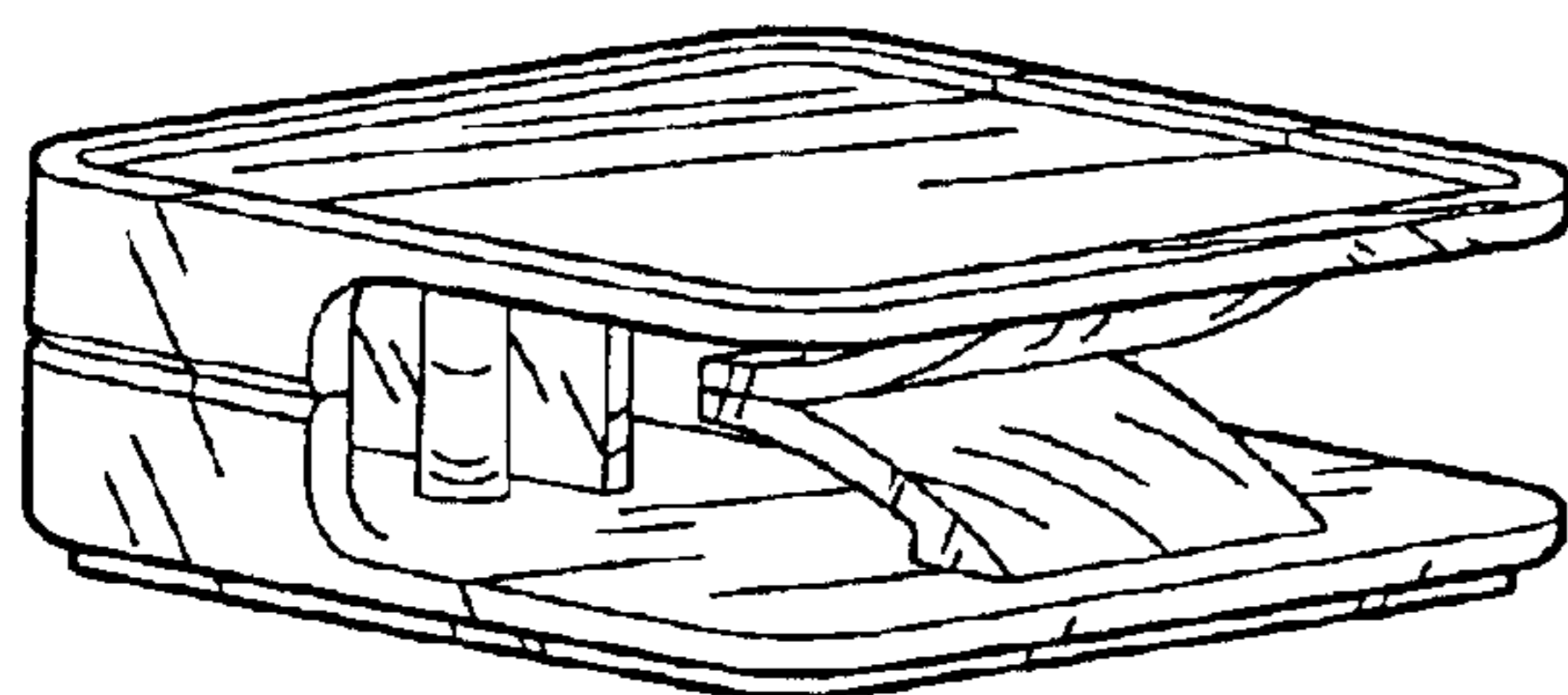
(57) **CLAIM**

The ornamental design for a square clip, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the square clip showing the front, top, and left sides of our new design; FIG. 2 is a perspective view of the square clip showing the rear, bottom, and right sides of our new design; FIG. 3 is a left side view of the square clip of FIG. 1; FIG. 4 is a top view of the square clip of FIG. 1; FIG. 5 is a front view of the square clip of FIG. 1; FIG. 6 is a rear view of the square clip of FIG. 1; FIG. 7 is a bottom view of the square clip of FIG. 1; and, FIG. 8 is a right side view of the square clip of FIG. 1.

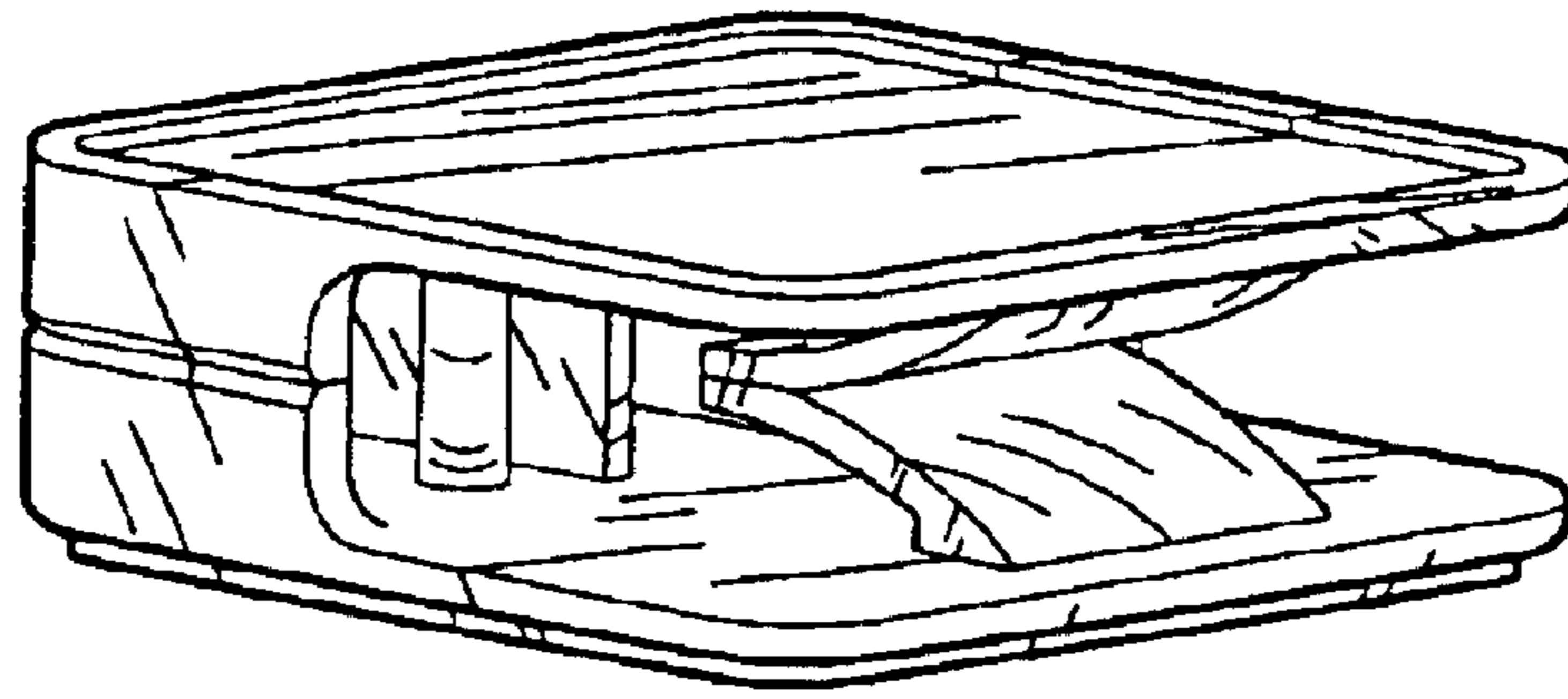

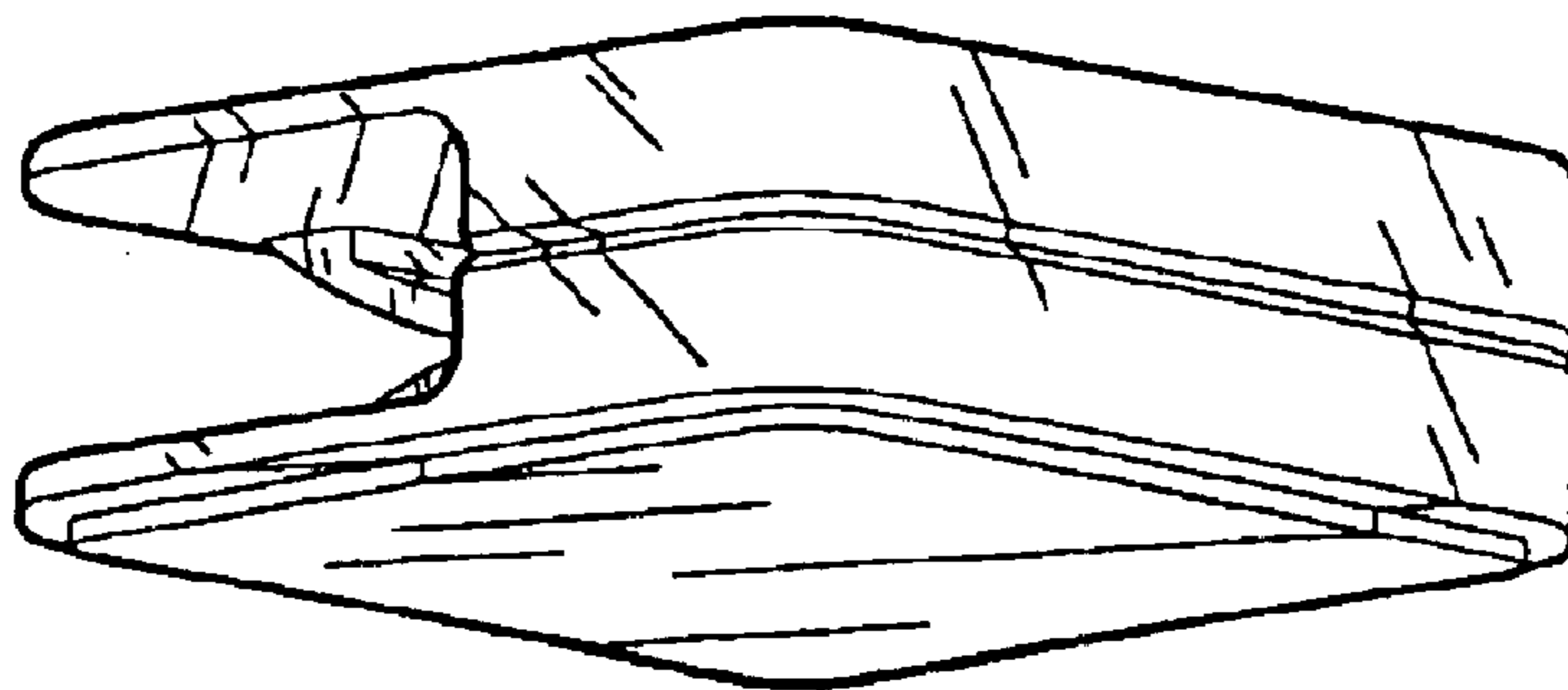

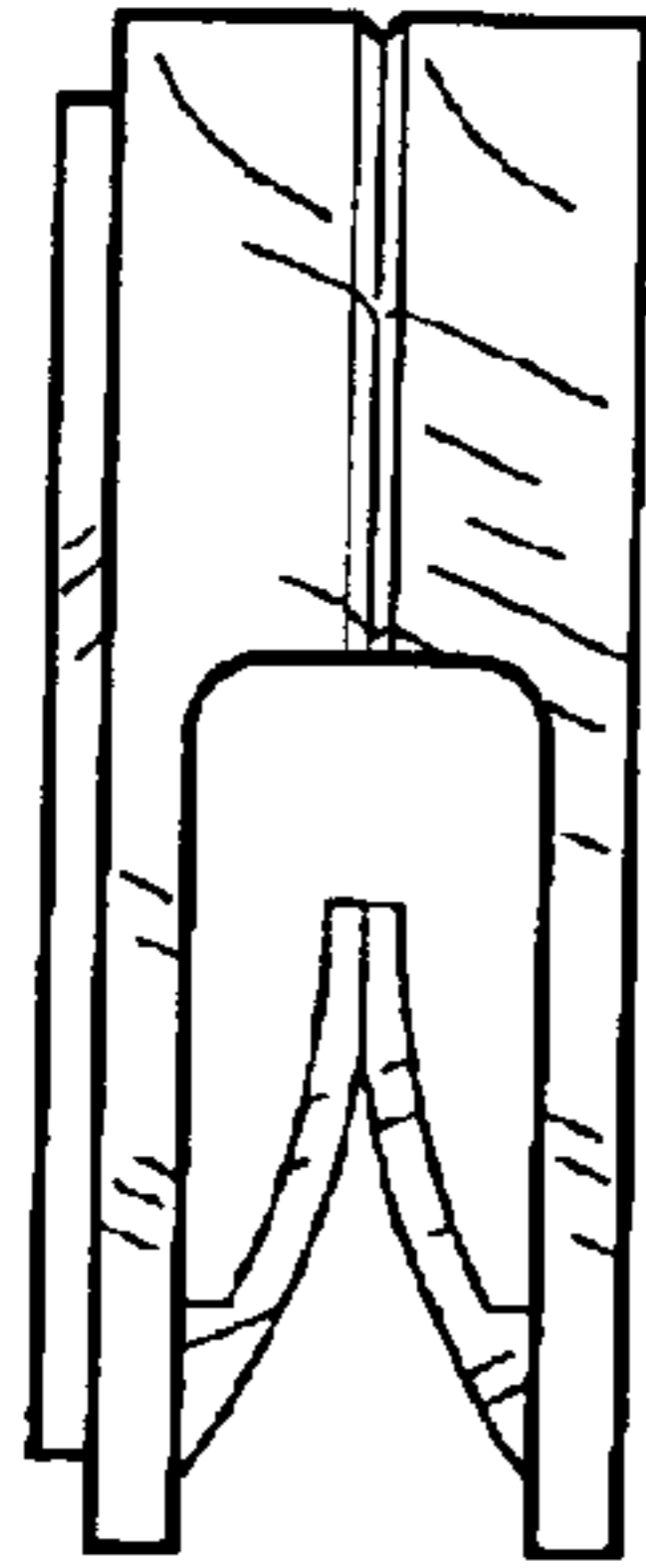

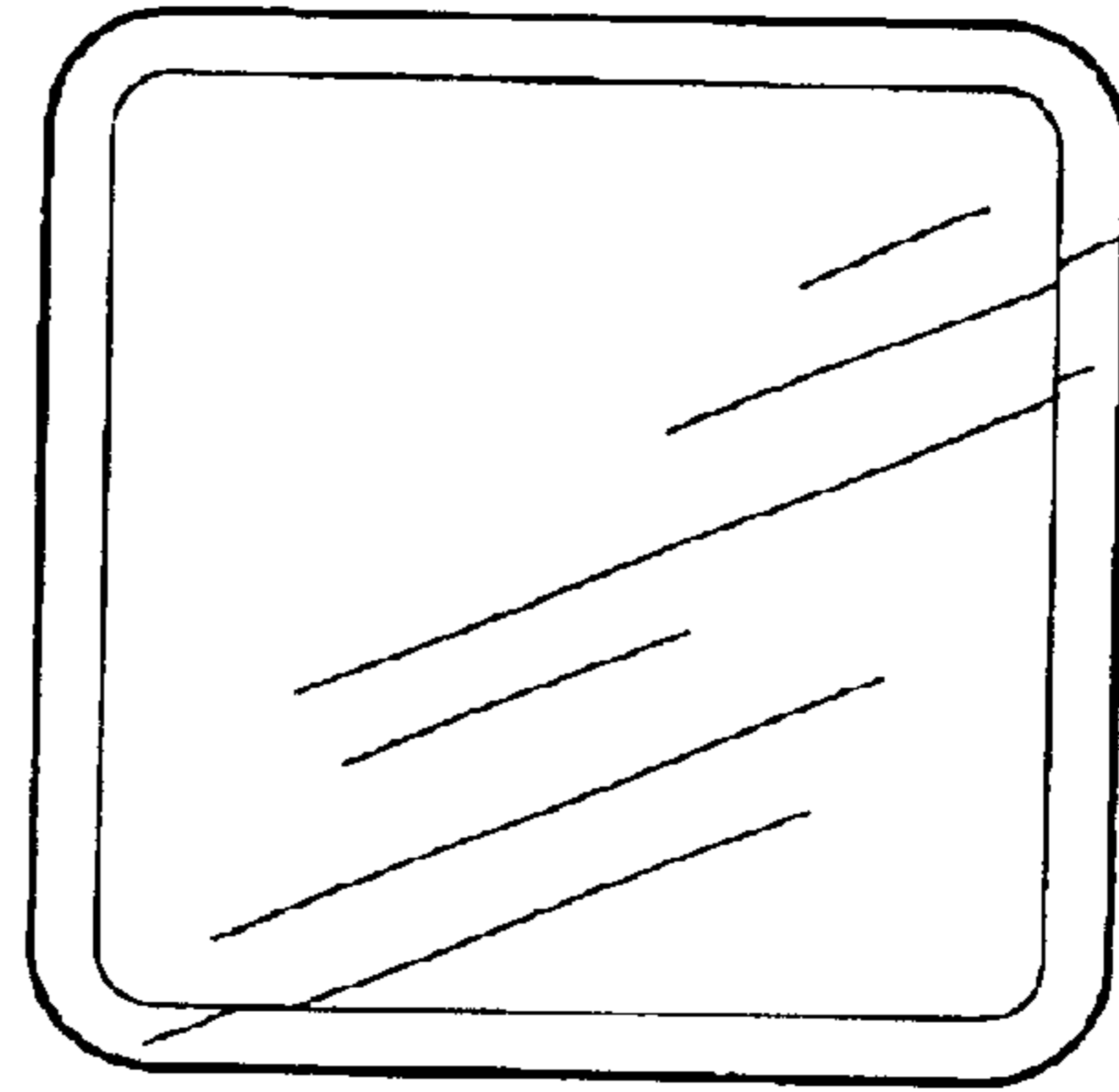

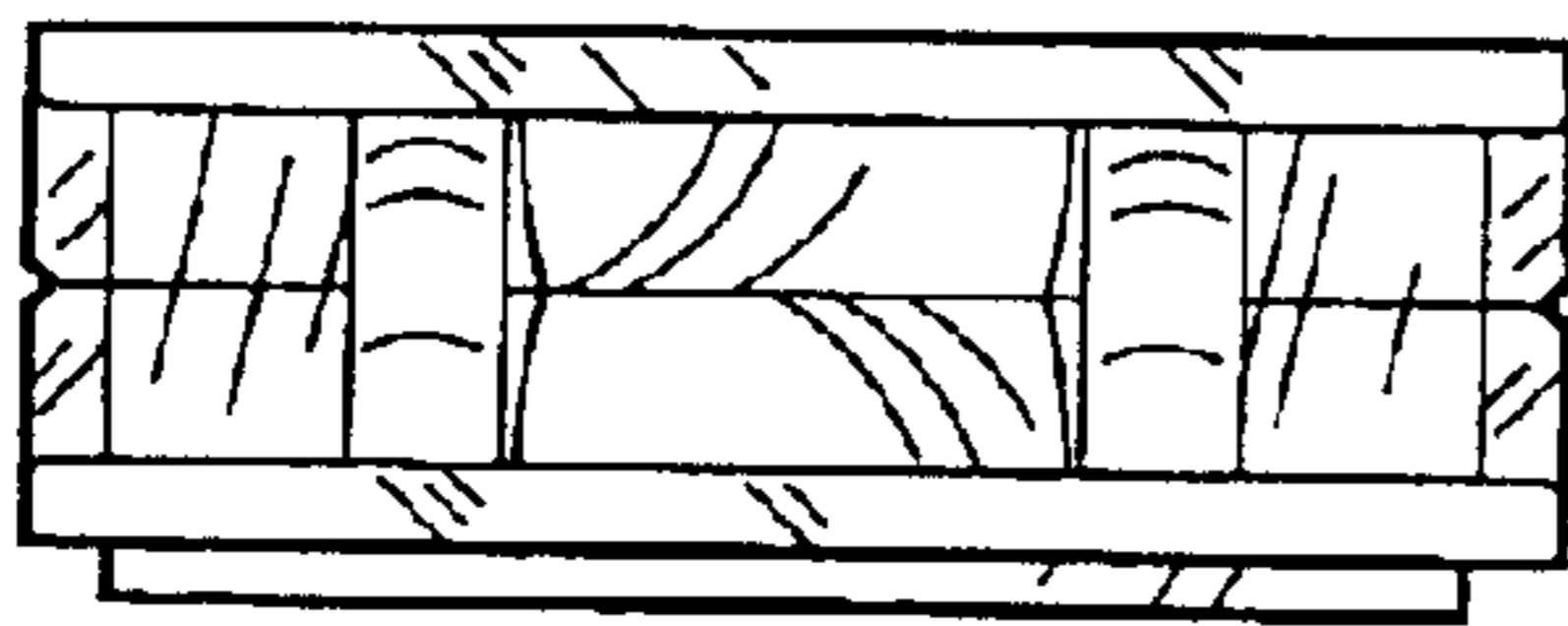

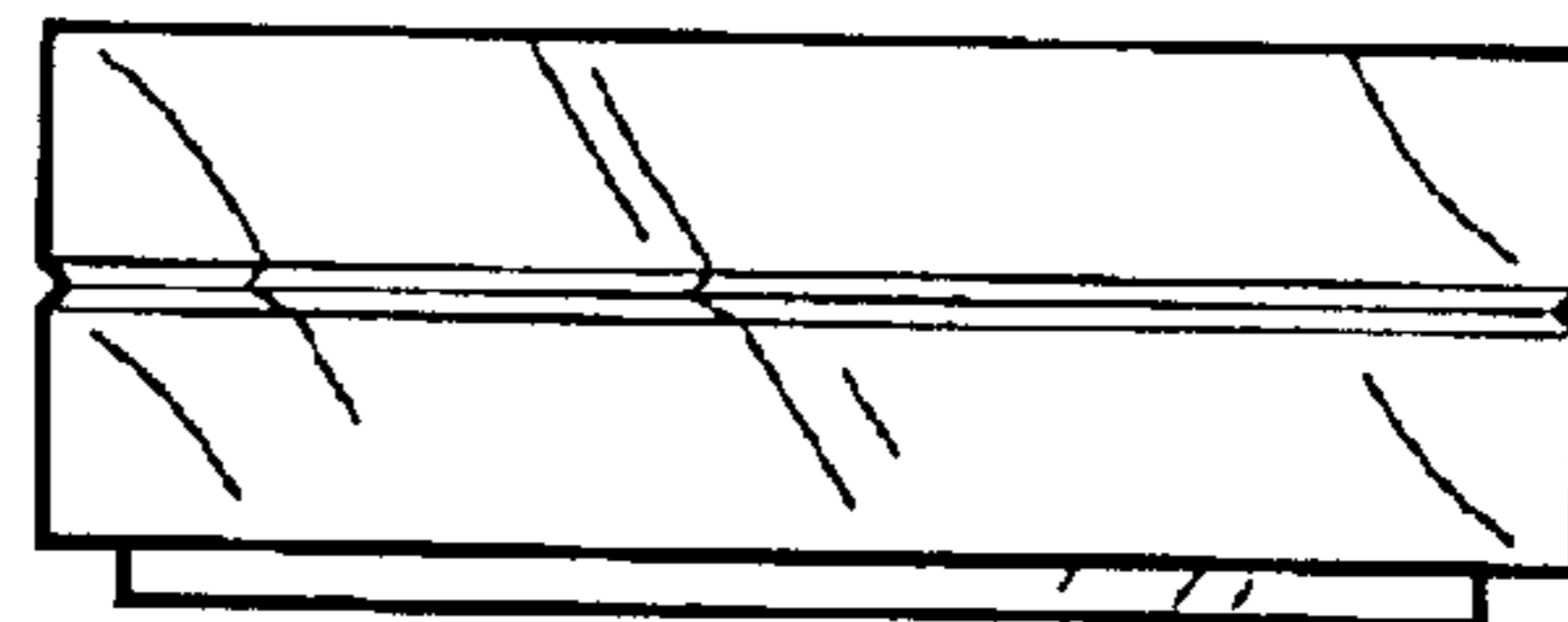

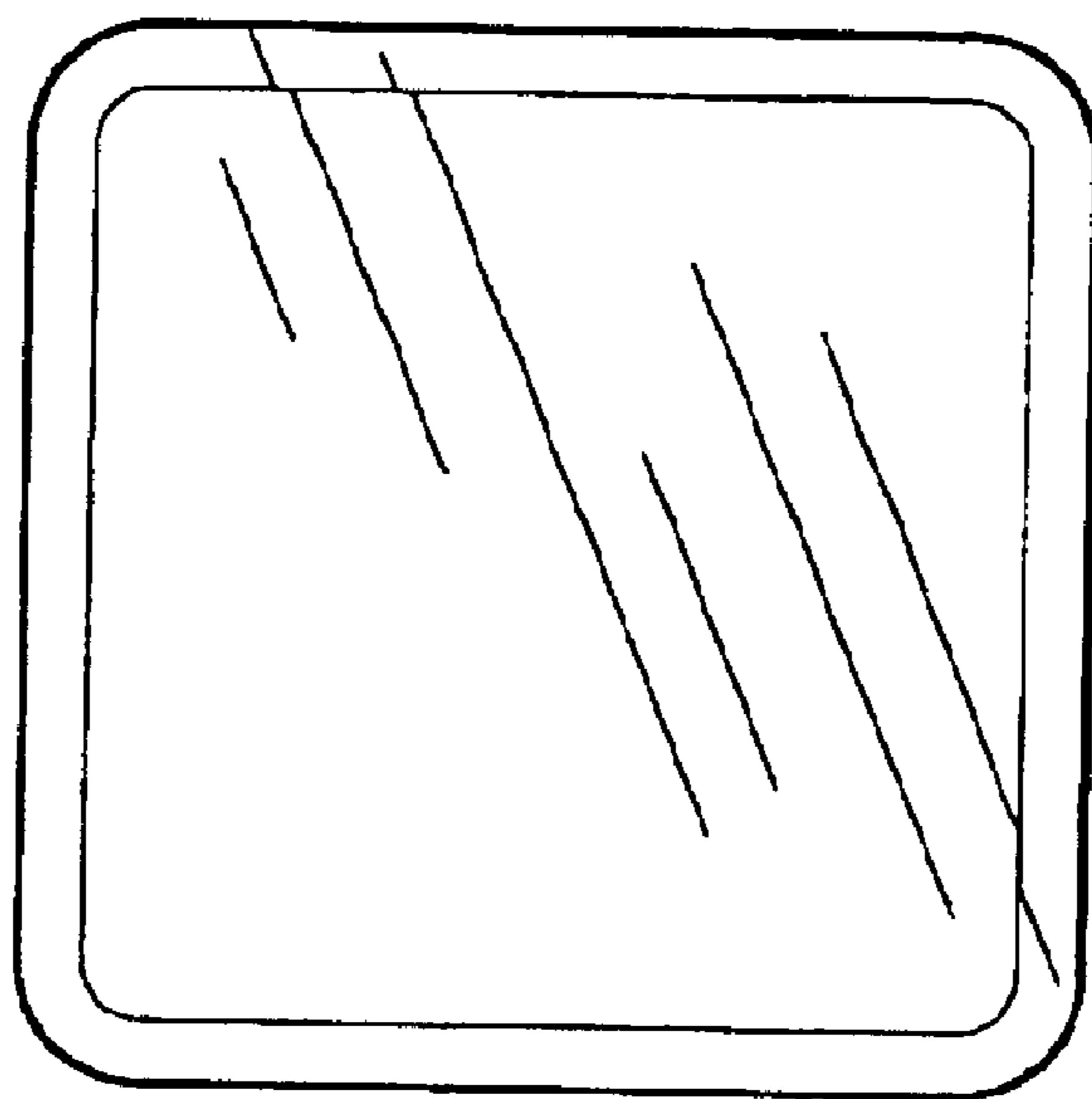

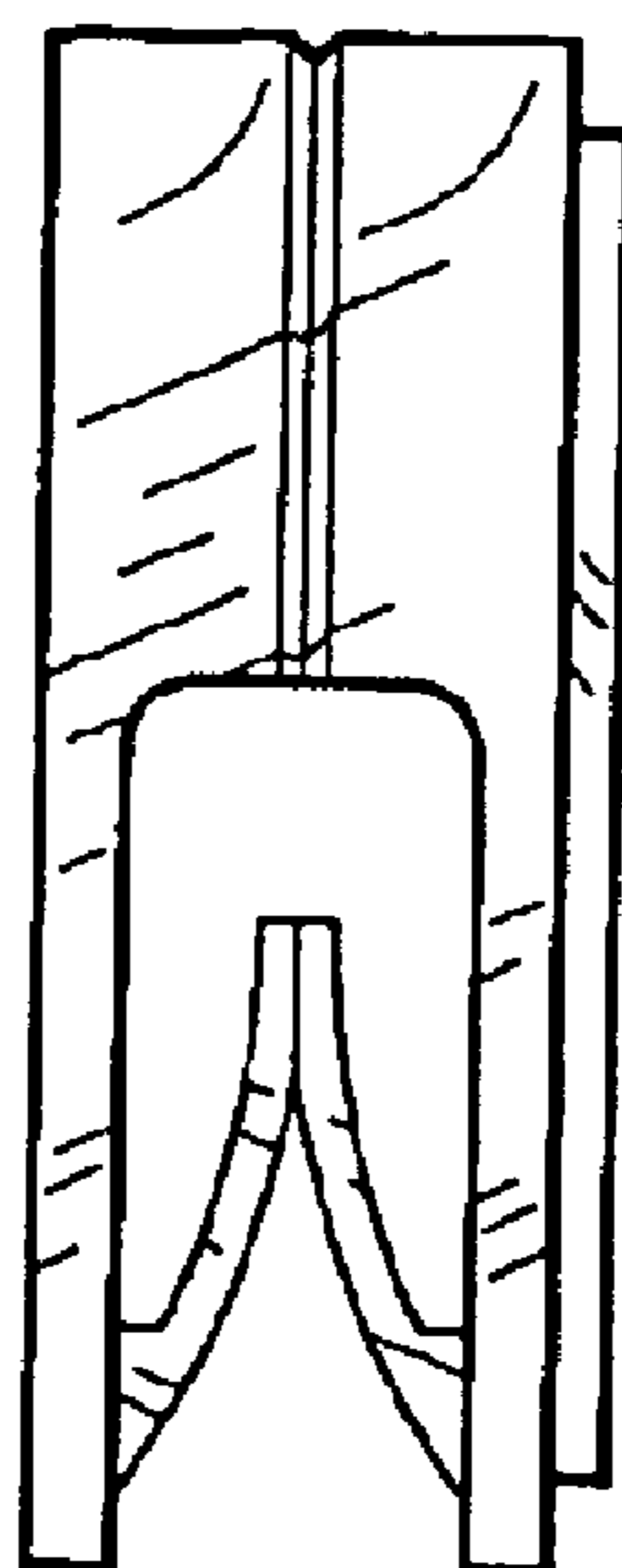
