(57) **CLAIM**

I claim the ornamental design for a set of overlays of a shoulder pad assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a set of overlays of a shoulder pad assembly according to the present design;

FIG. 2 is a front elevational view of the set of overlays of a shoulder pad assembly of FIG. 1;

FIG. 3 is a rear elevational view of the set of overlays of a shoulder pad assembly of FIG. 1;

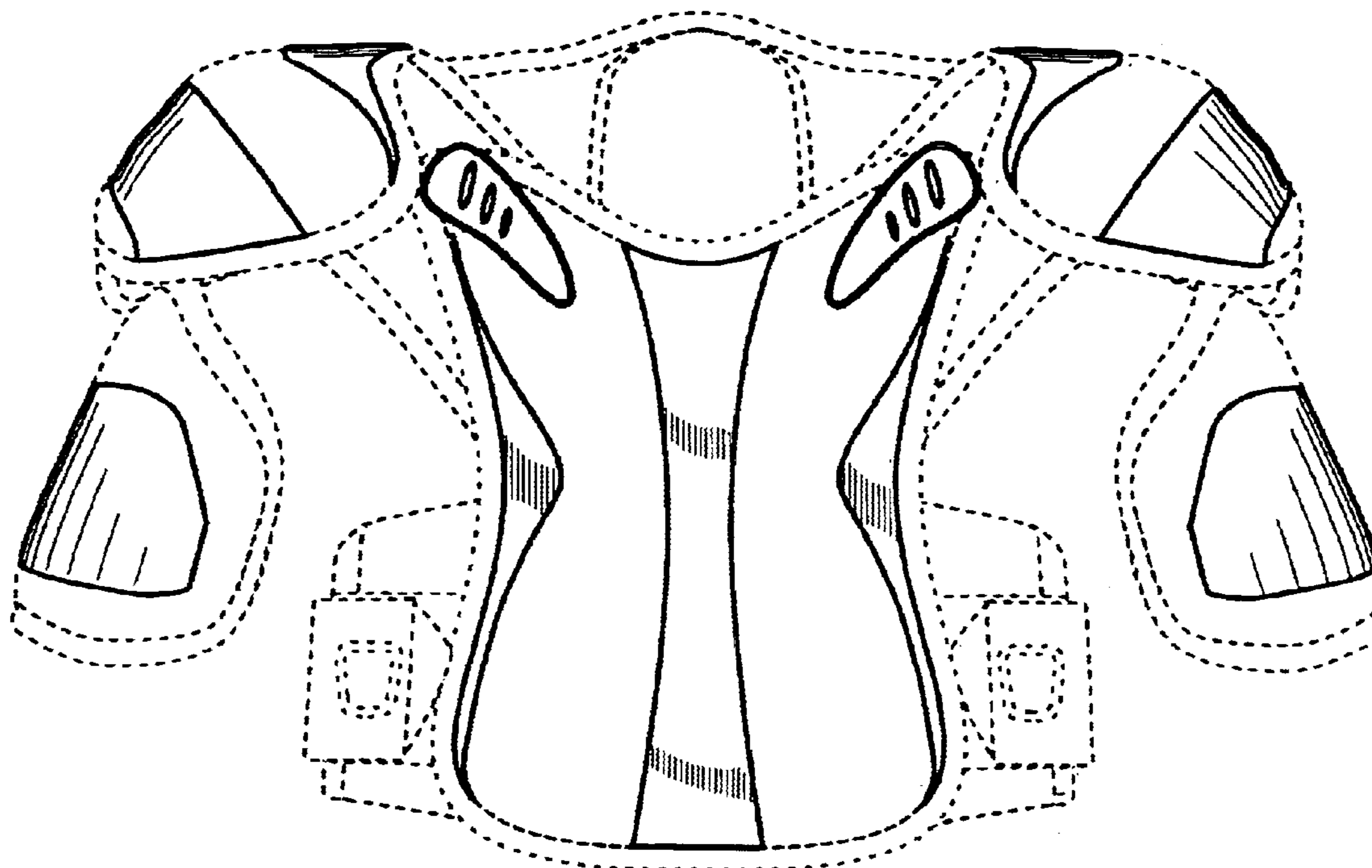
FIG. 4 is a right side elevation of the set of overlays of a shoulder pad assembly;

FIG. 5 is a left side elevation of the set of overlays of a shoulder pad assembly; and,

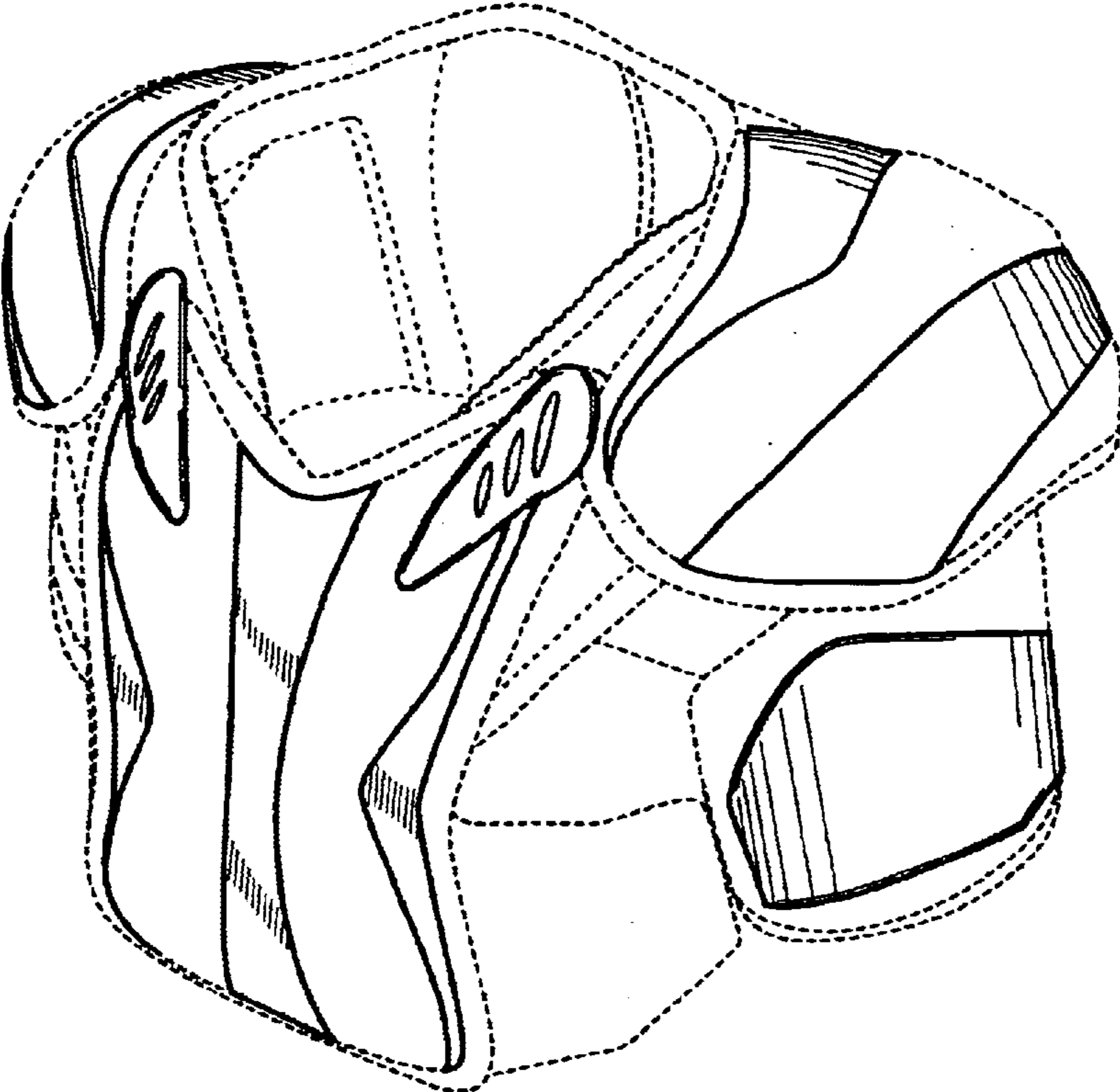

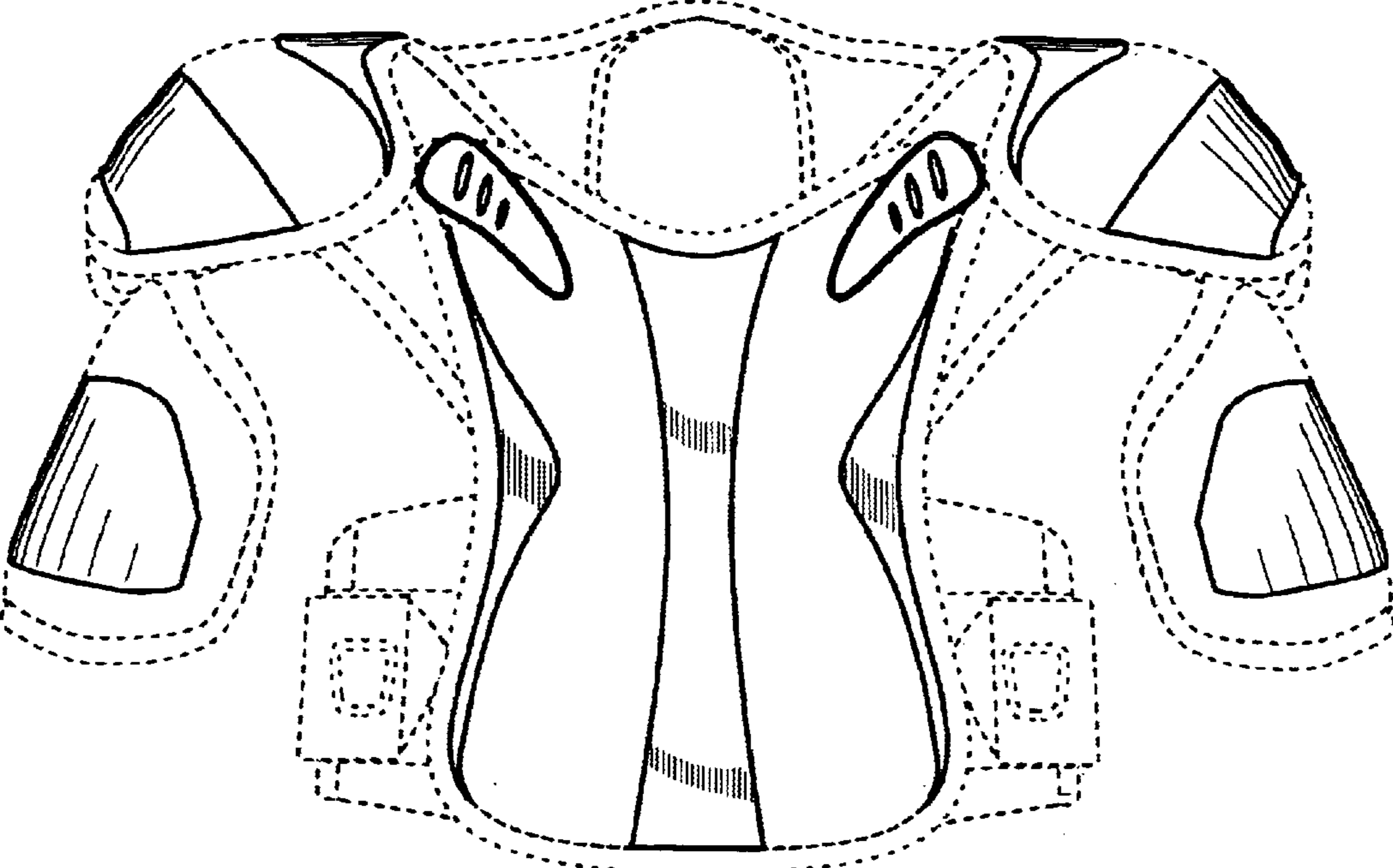

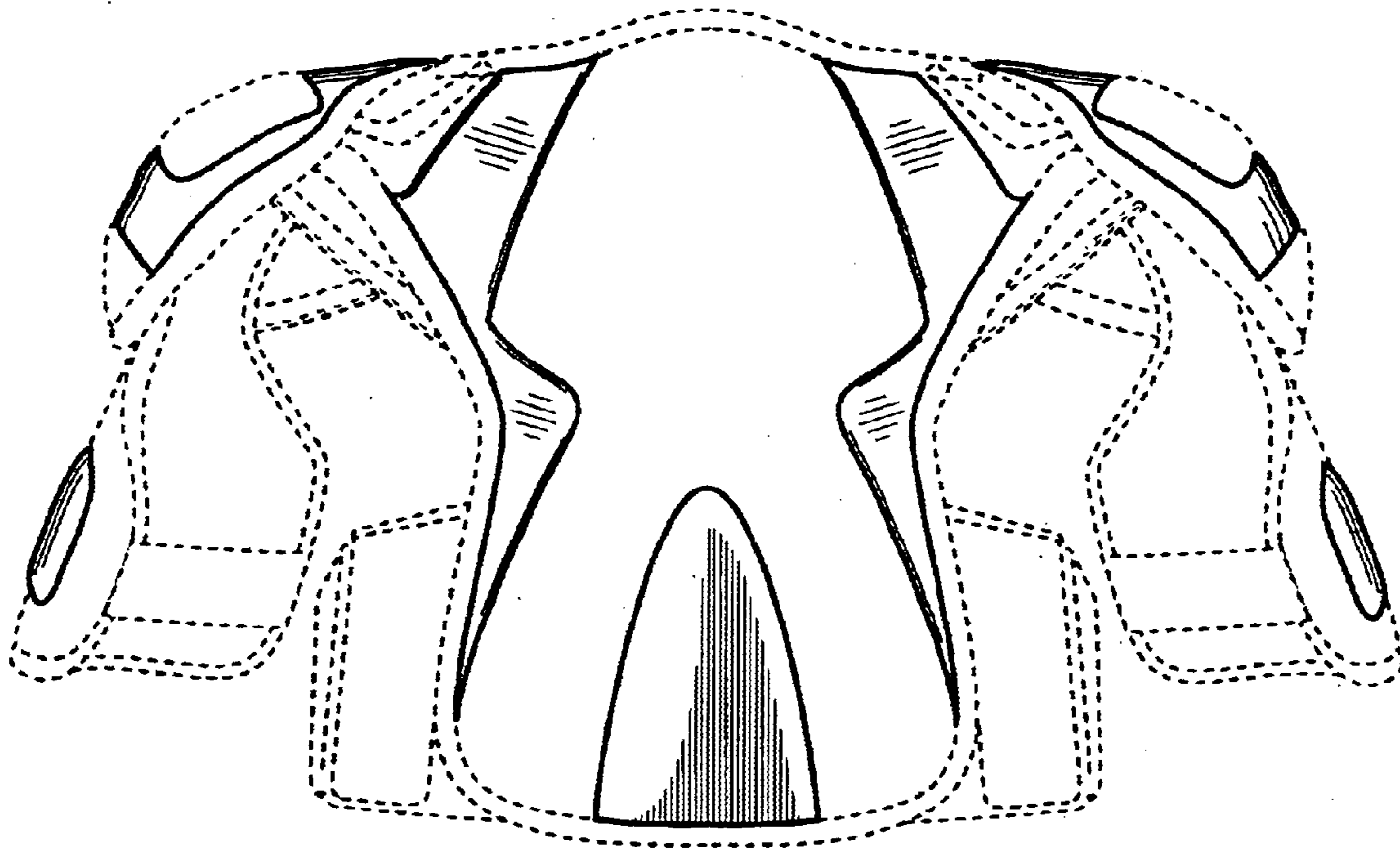

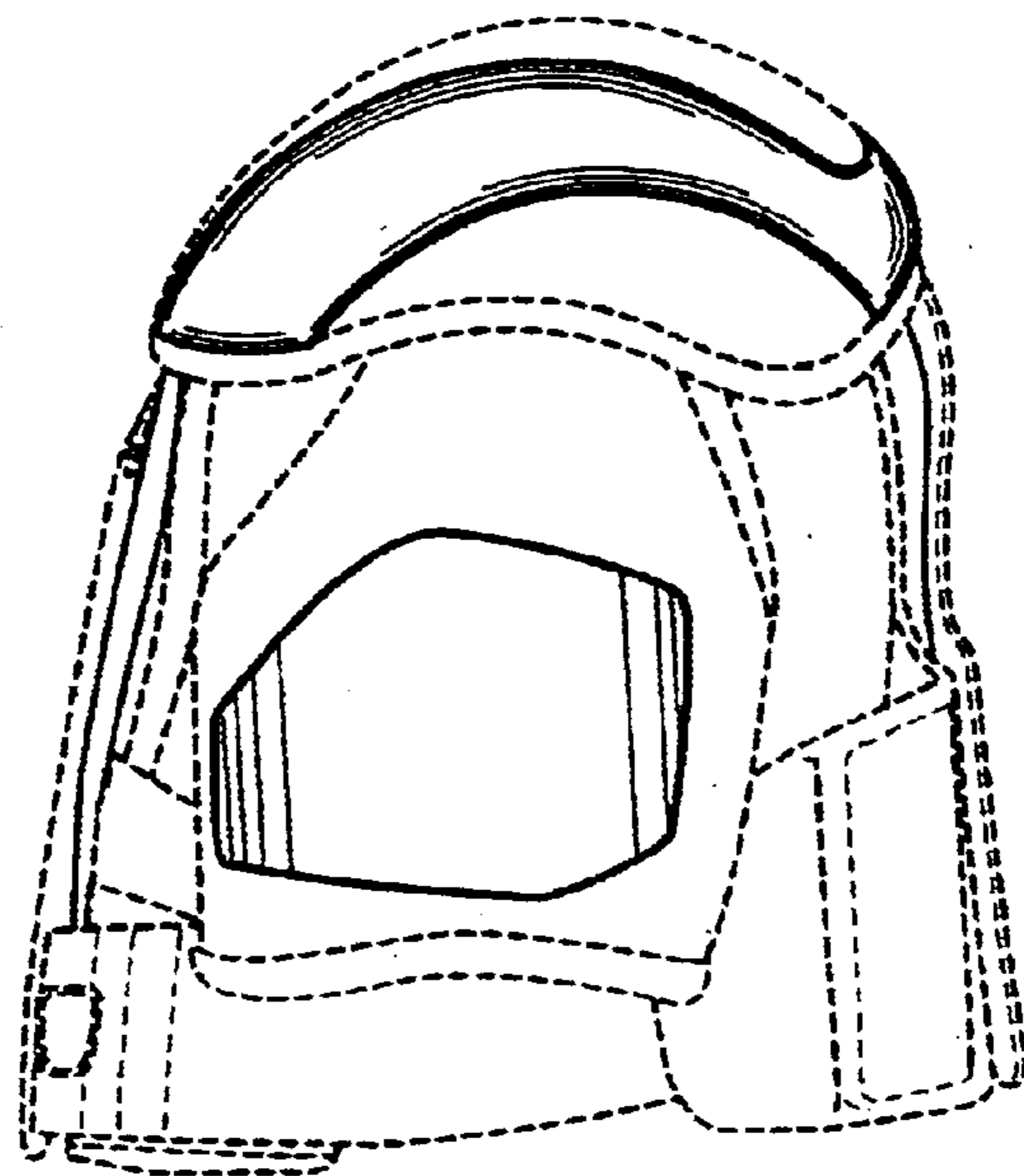

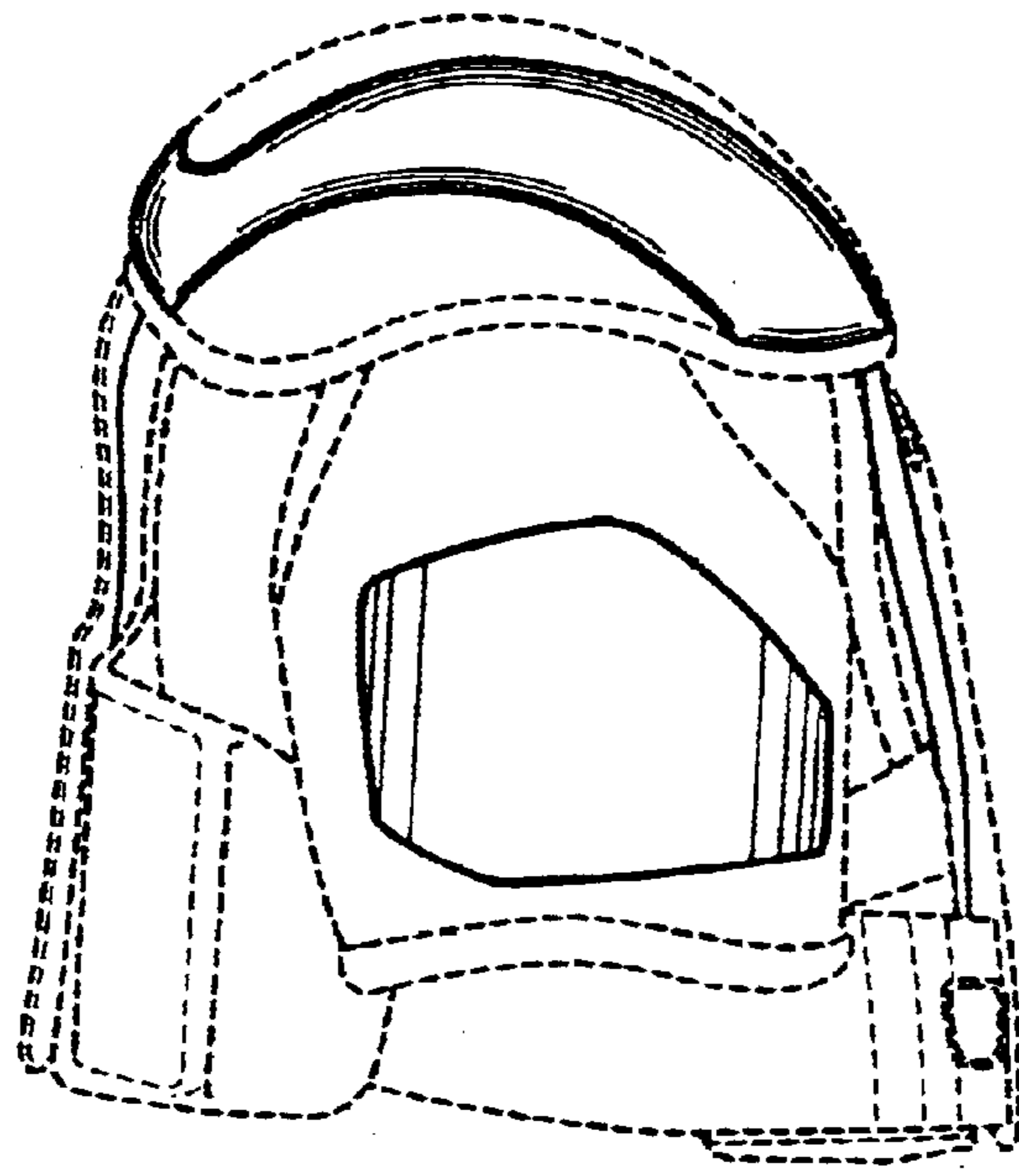

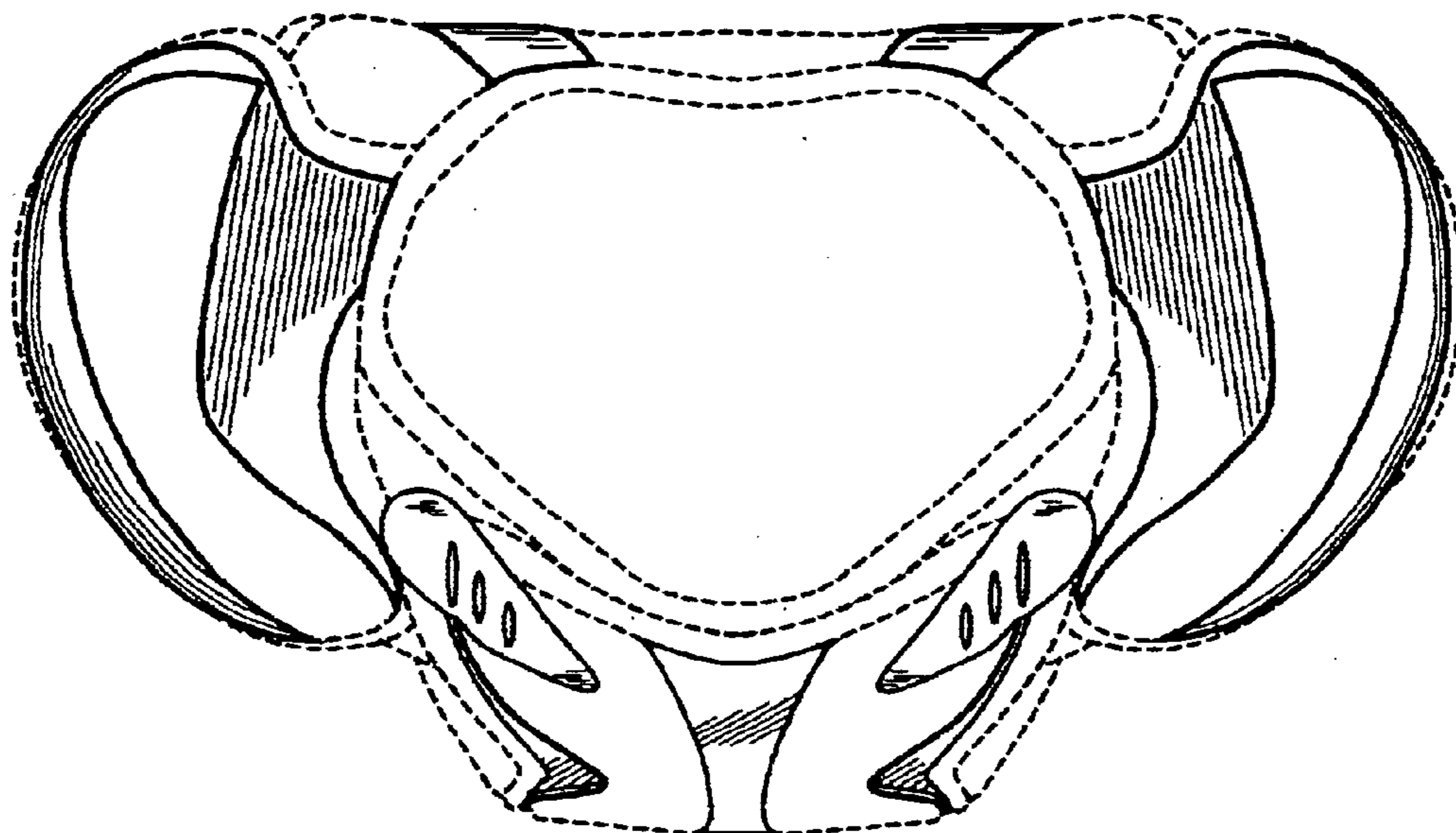
