(57) **CLAIM**

The ornamental design for a combined recycling, trash and advertisement bin with multiple compartments, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the combined recycling, trash and advertisement bin with multiple compartments showing the new design;

FIG. 2 is a rear view thereof;

FIGS. 3 & 4 are mirror images of the left and right views thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is a perspective view.

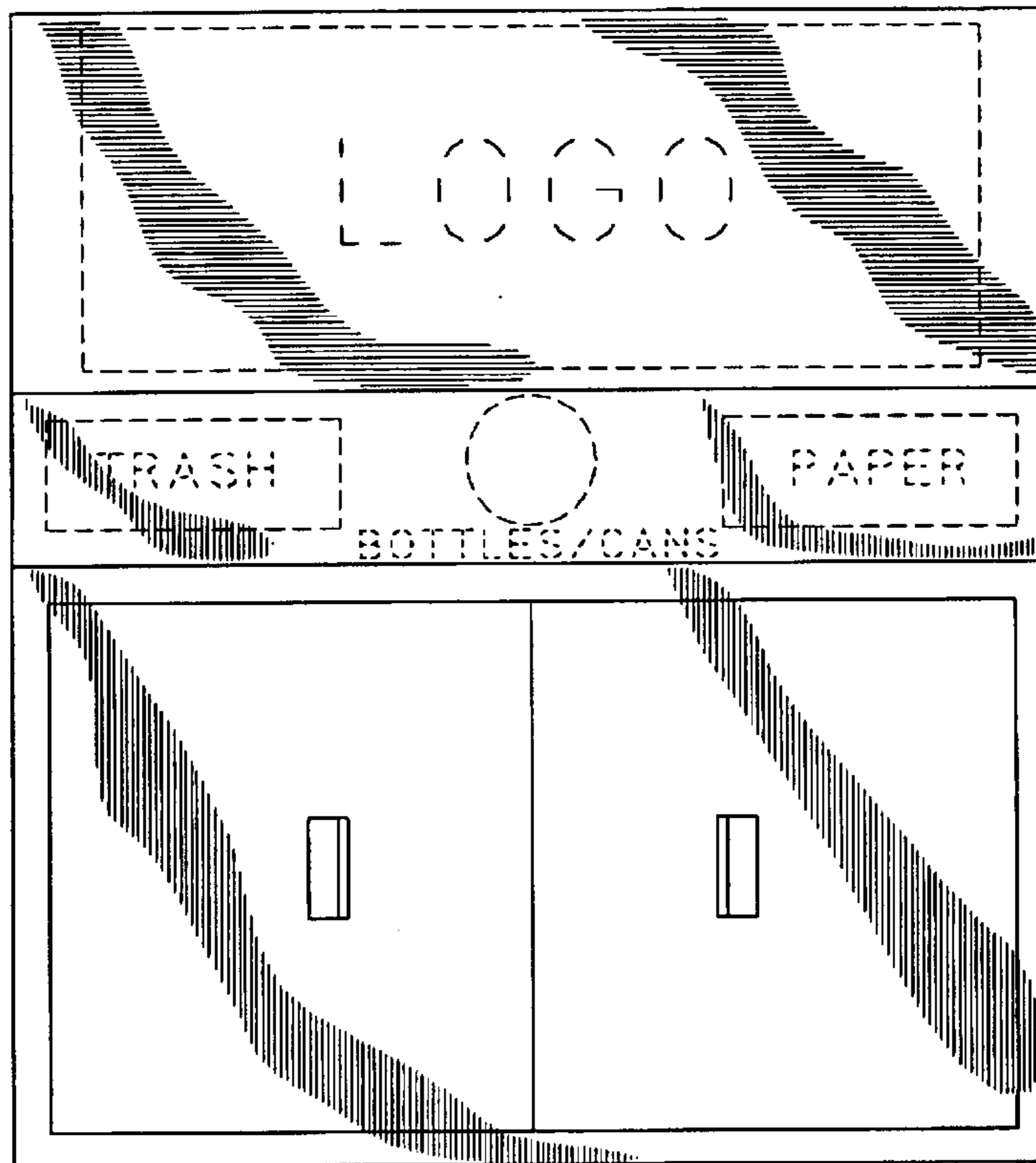

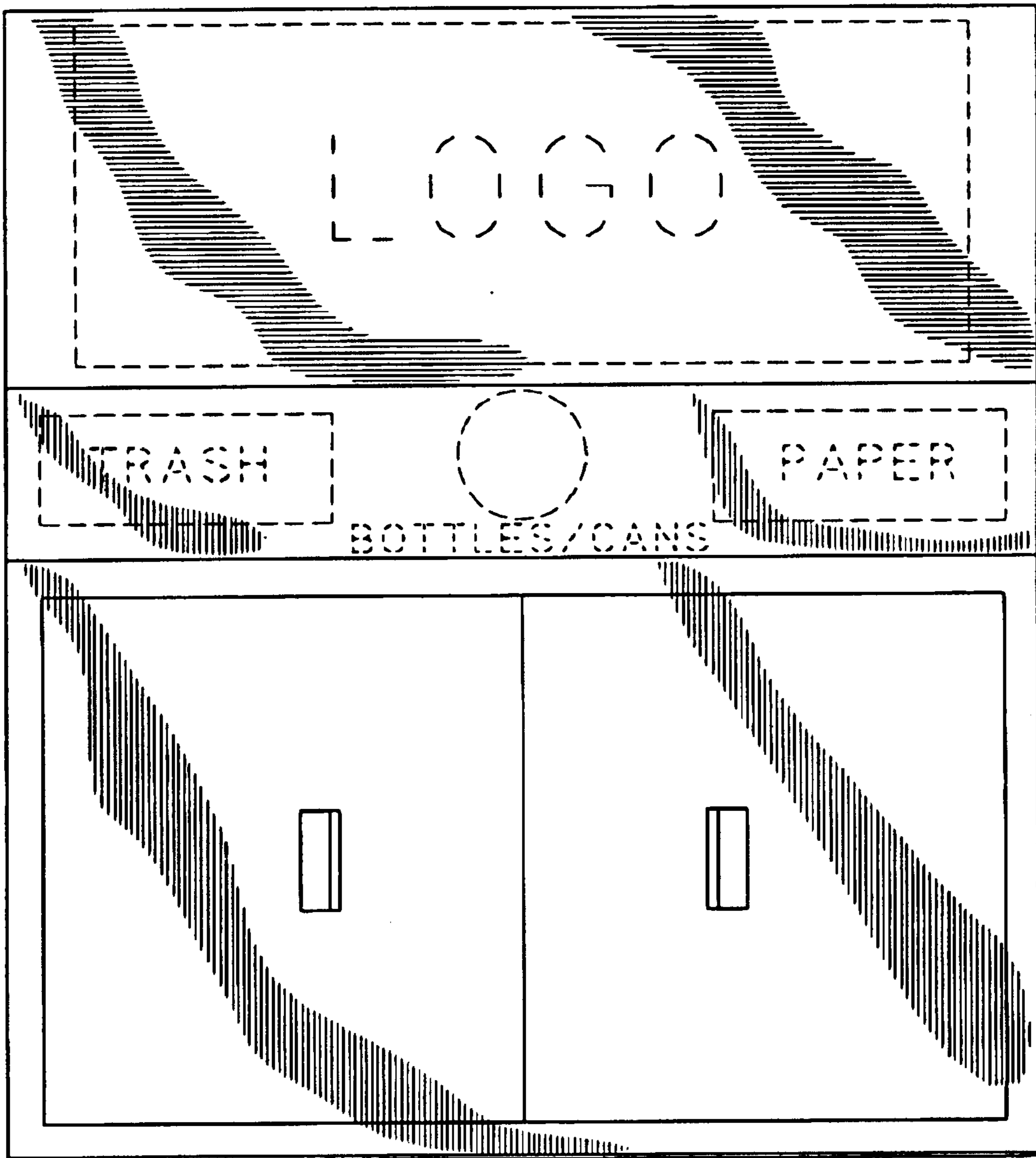

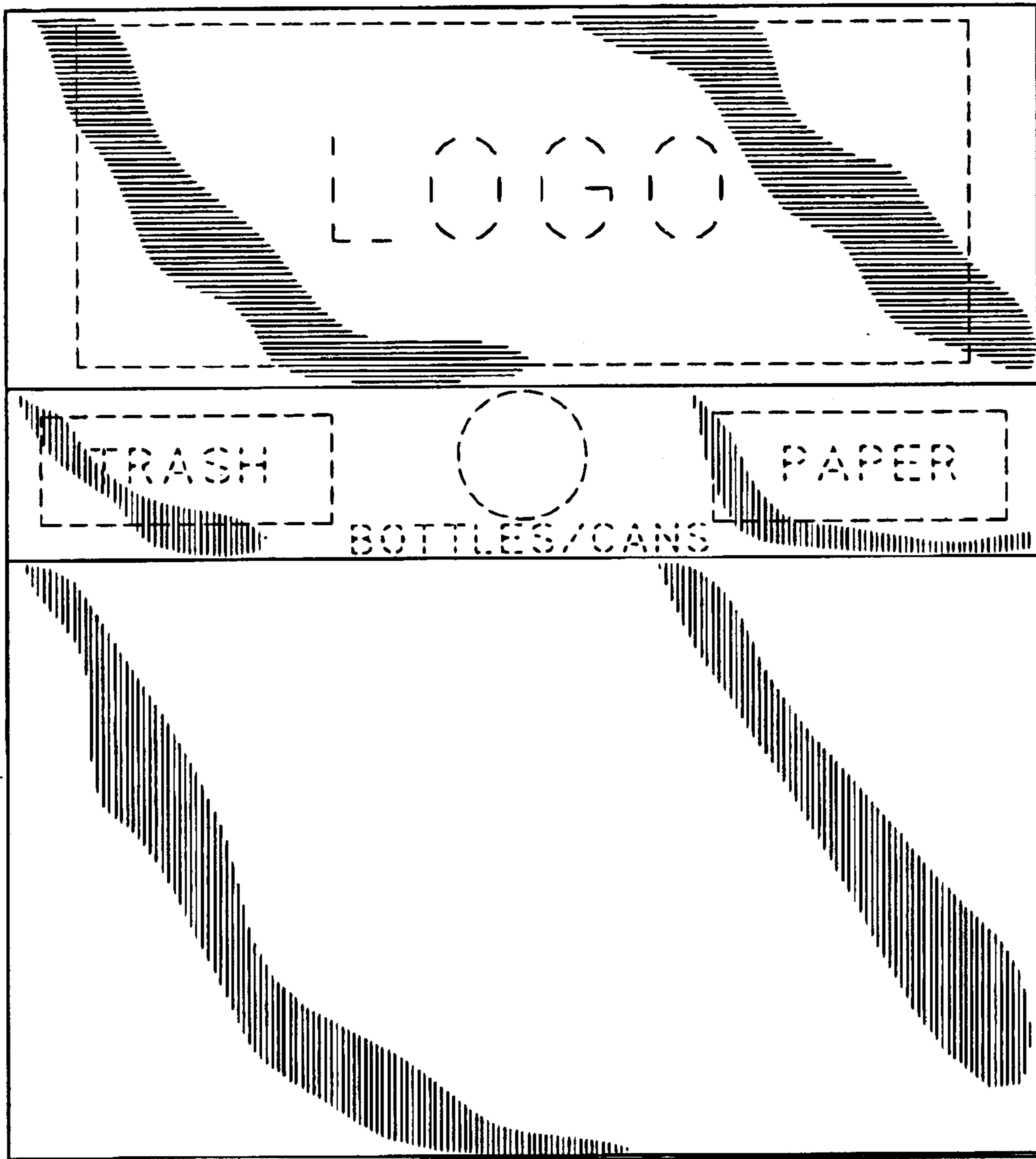

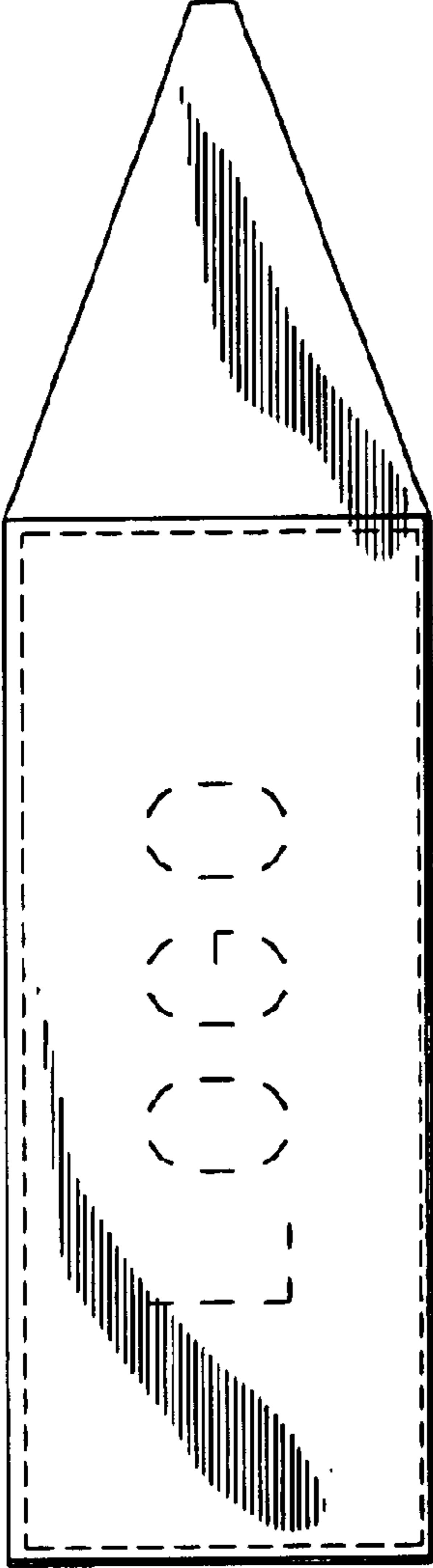

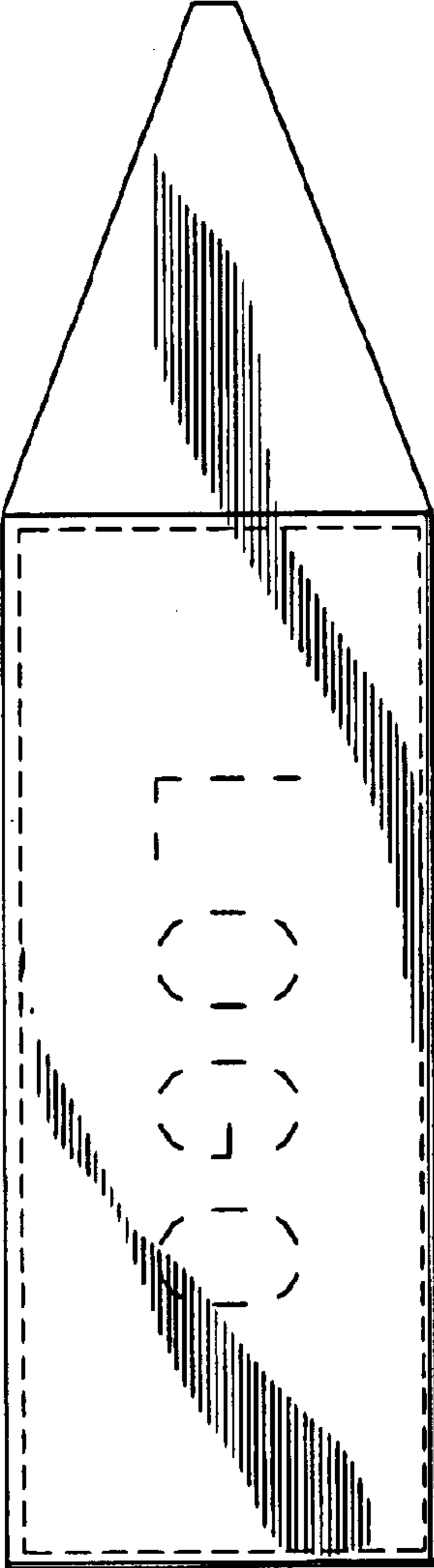

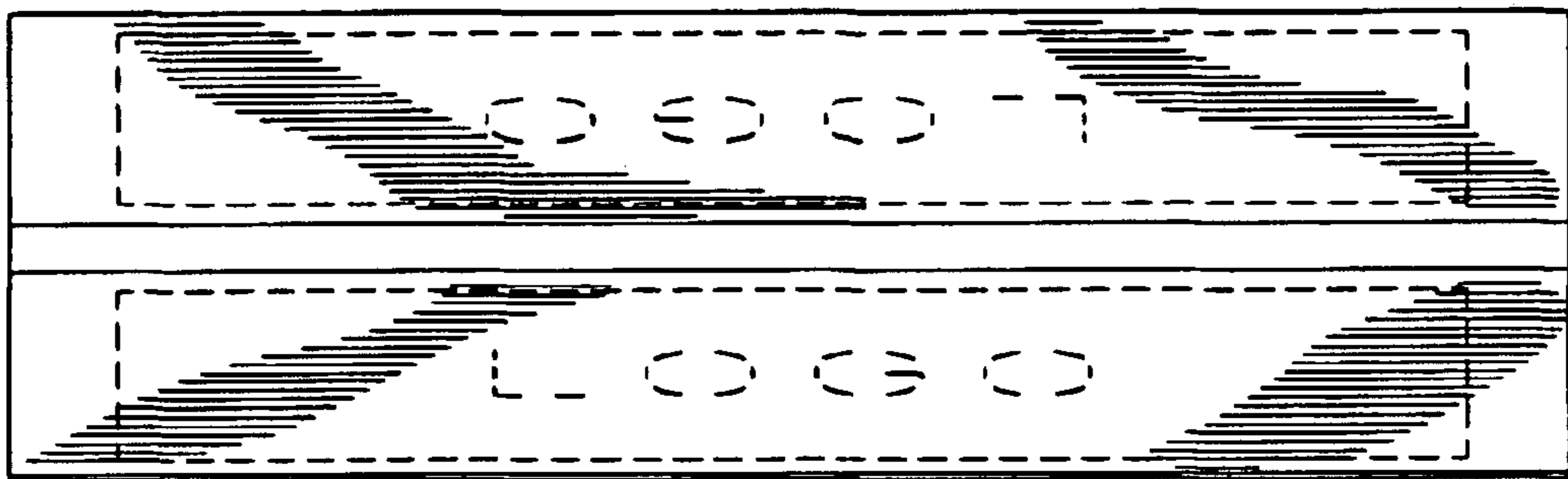
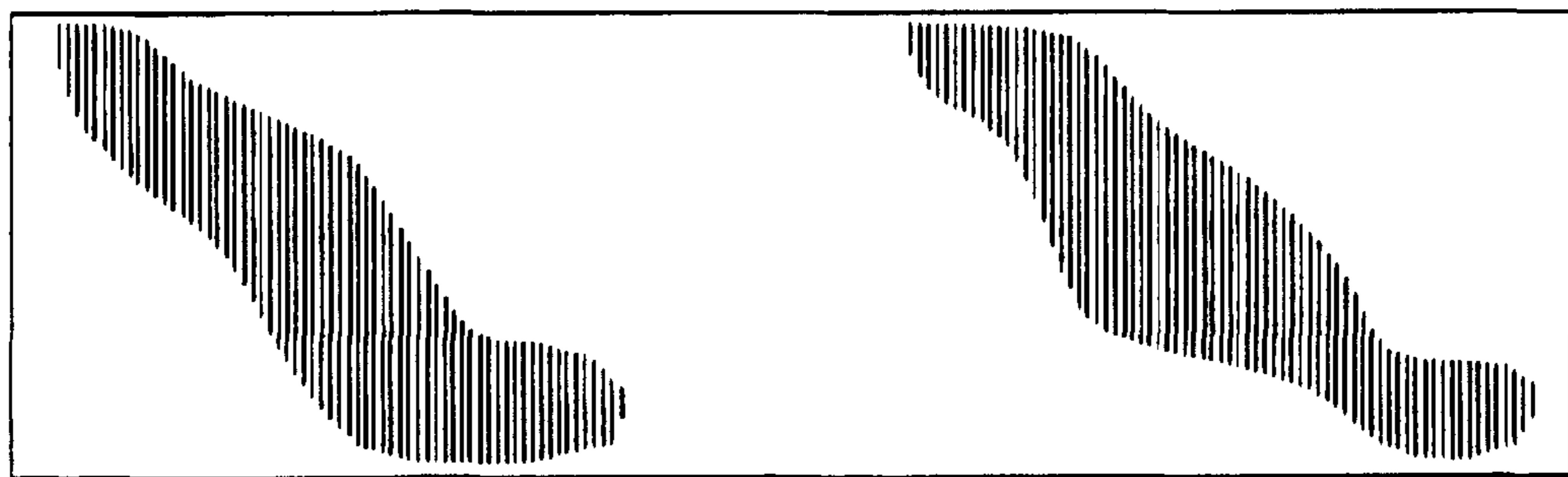

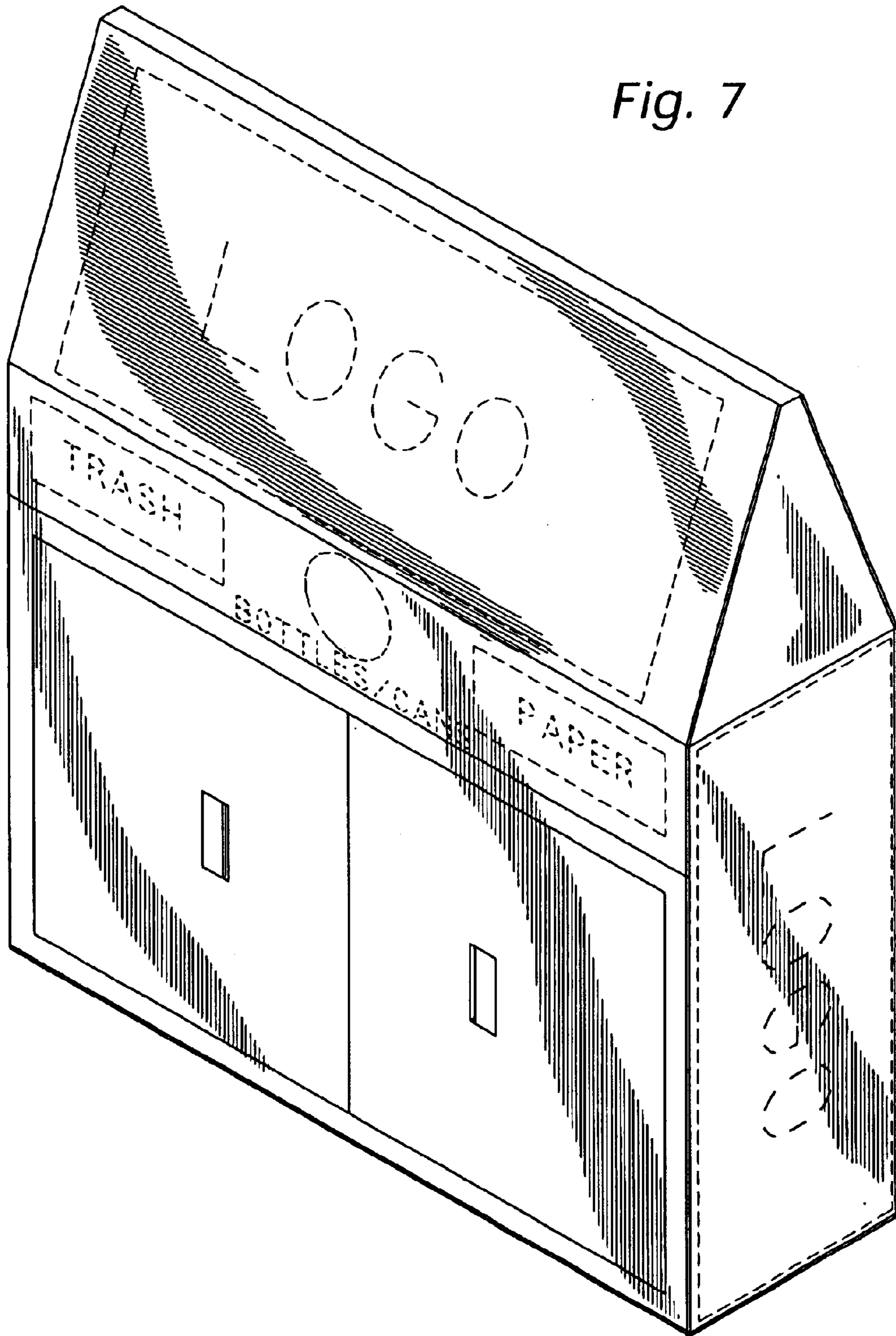
