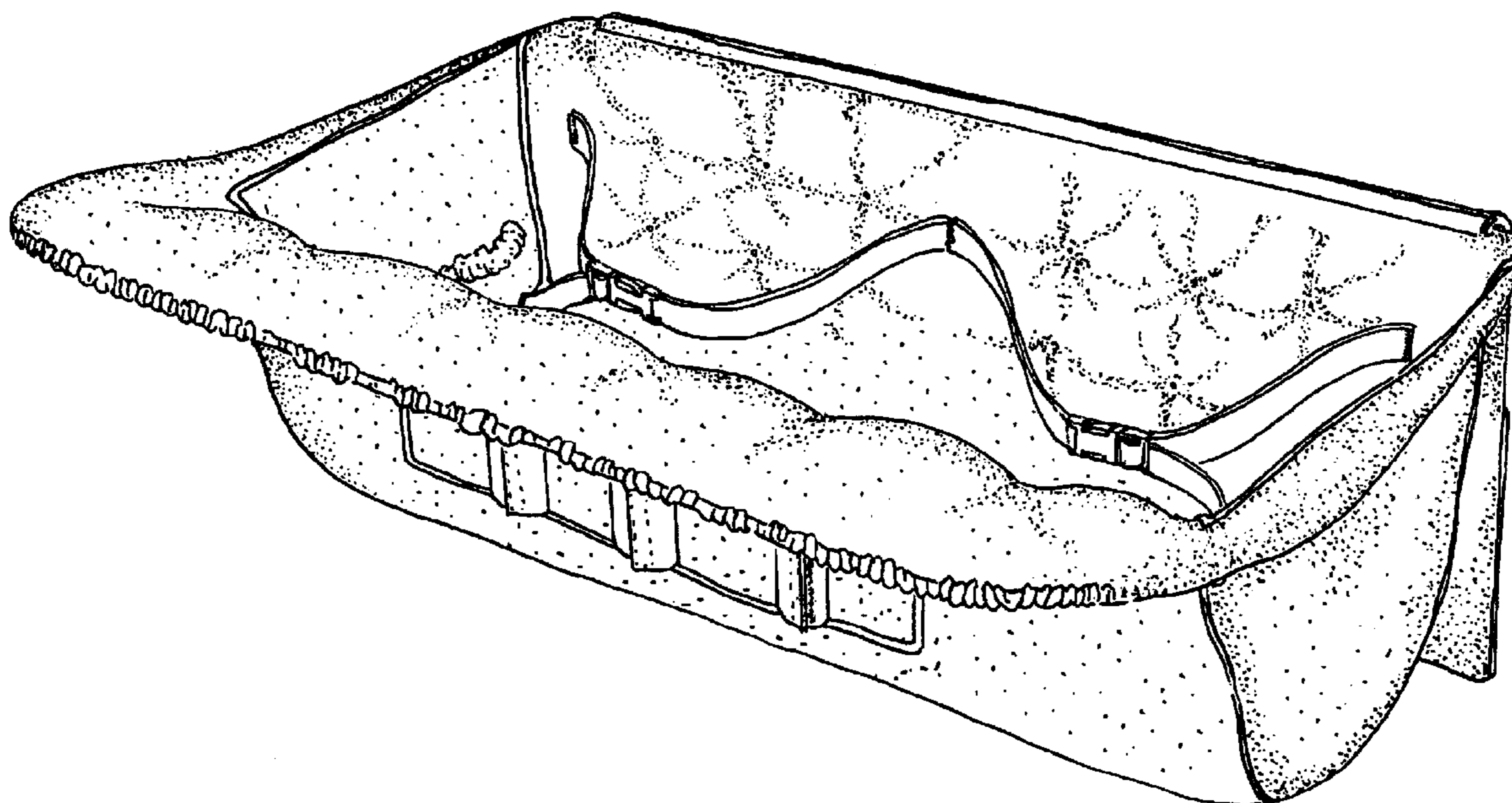
(57) **CLAIM**

The ornamental design for a twin grocery cart seat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the twin grocery cart seat embodying my new design;
 FIG. 2 is a top plan view of the design of FIG. 1;
 FIG. 3 is a bottom plan view of the design of FIG. 1;
 FIG. 4 is a left side elevational view of the design of FIG. 1;
 FIG. 5 is a right side elevational view of the design of FIG. 1;
 FIG. 6 is a front elevational view of the design of FIG. 1;
 FIG. 7 is a rear elevational view of the design of FIG. 1; and,
 FIG. 8 is a perspective view of the design of FIG. 1 being positioned in a grocery cart seat and having twin toddlers positioned therein.
 The phantom lines of FIG. 8 form no part of the claimed design.

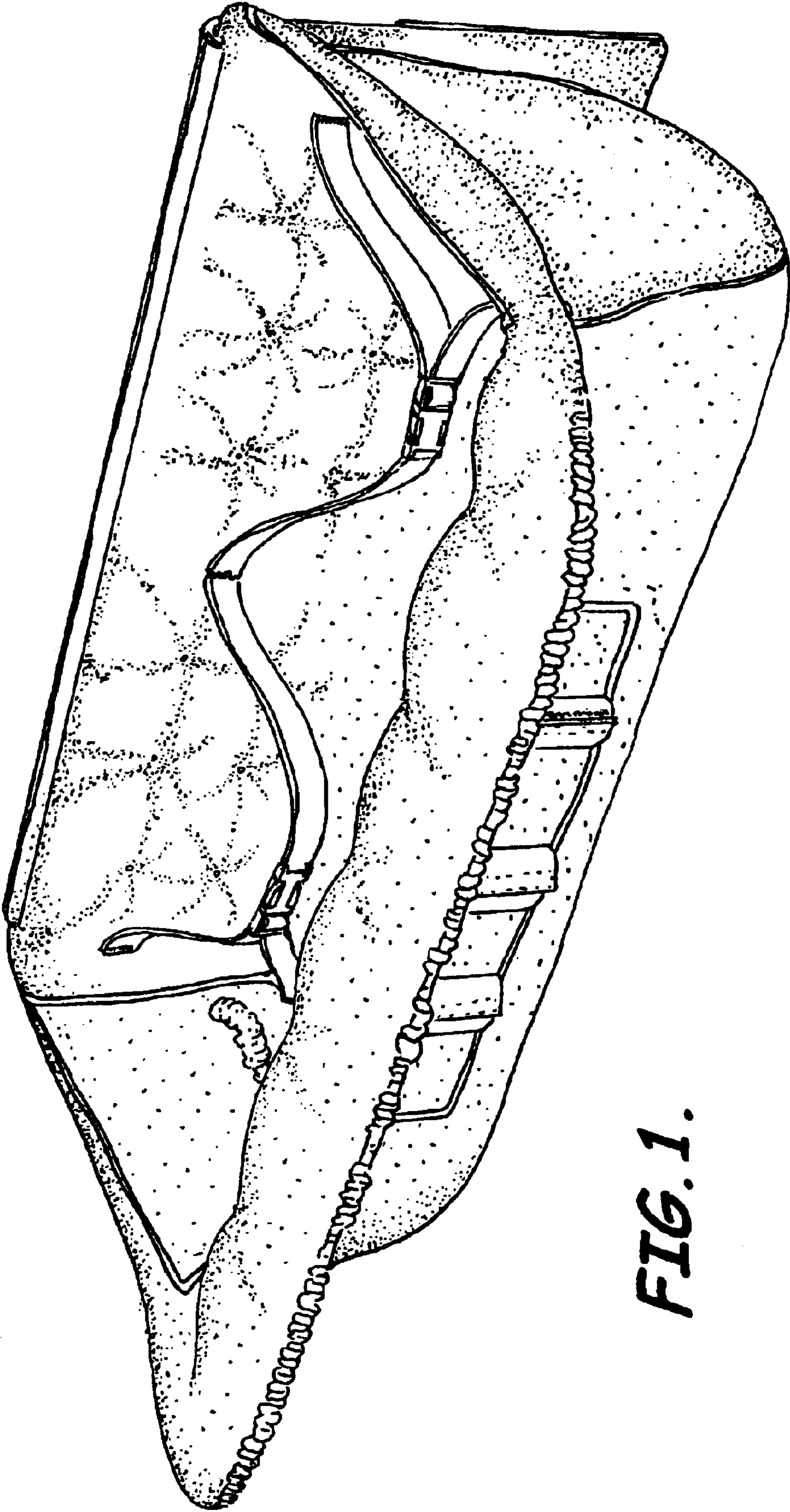

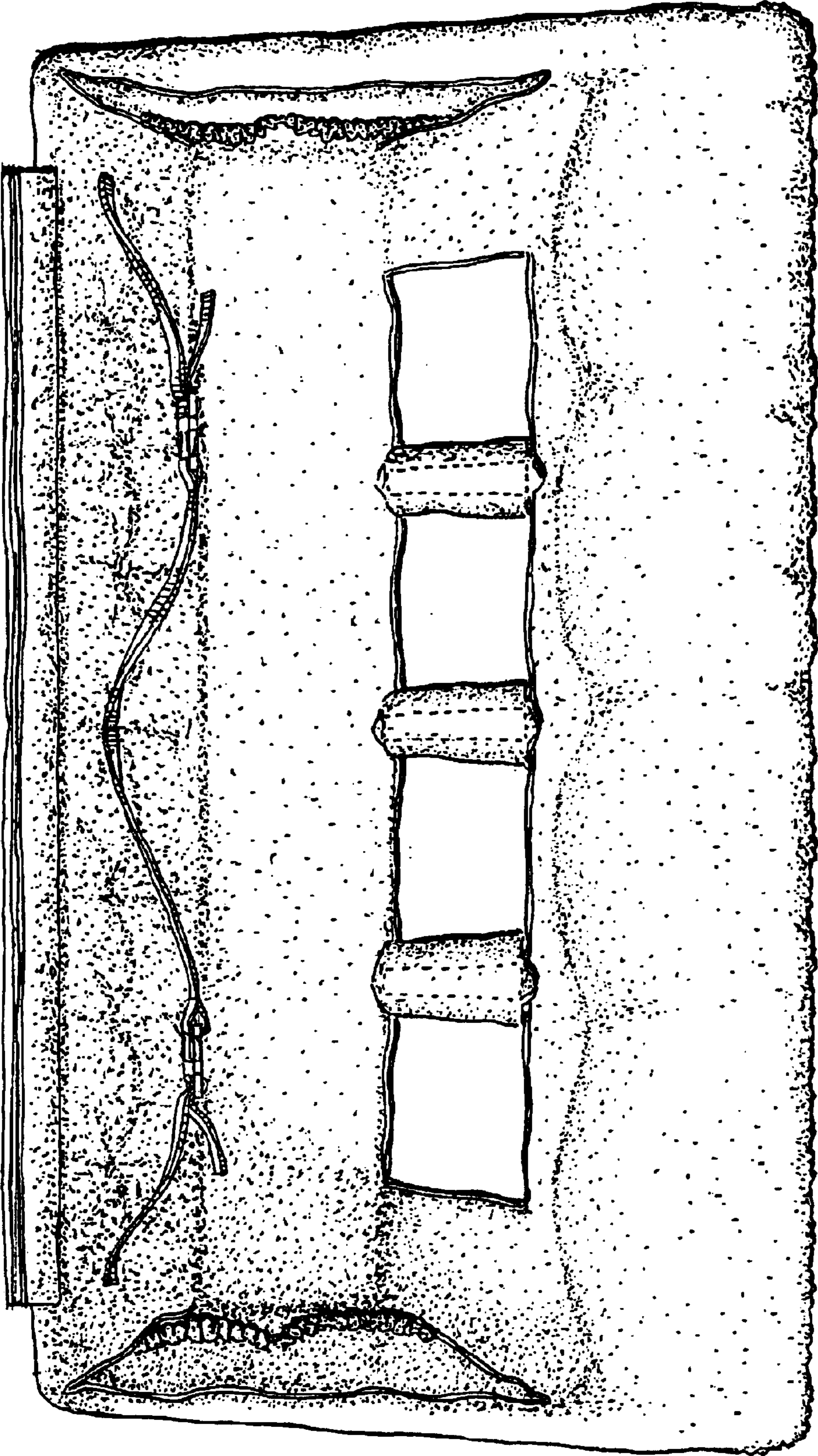

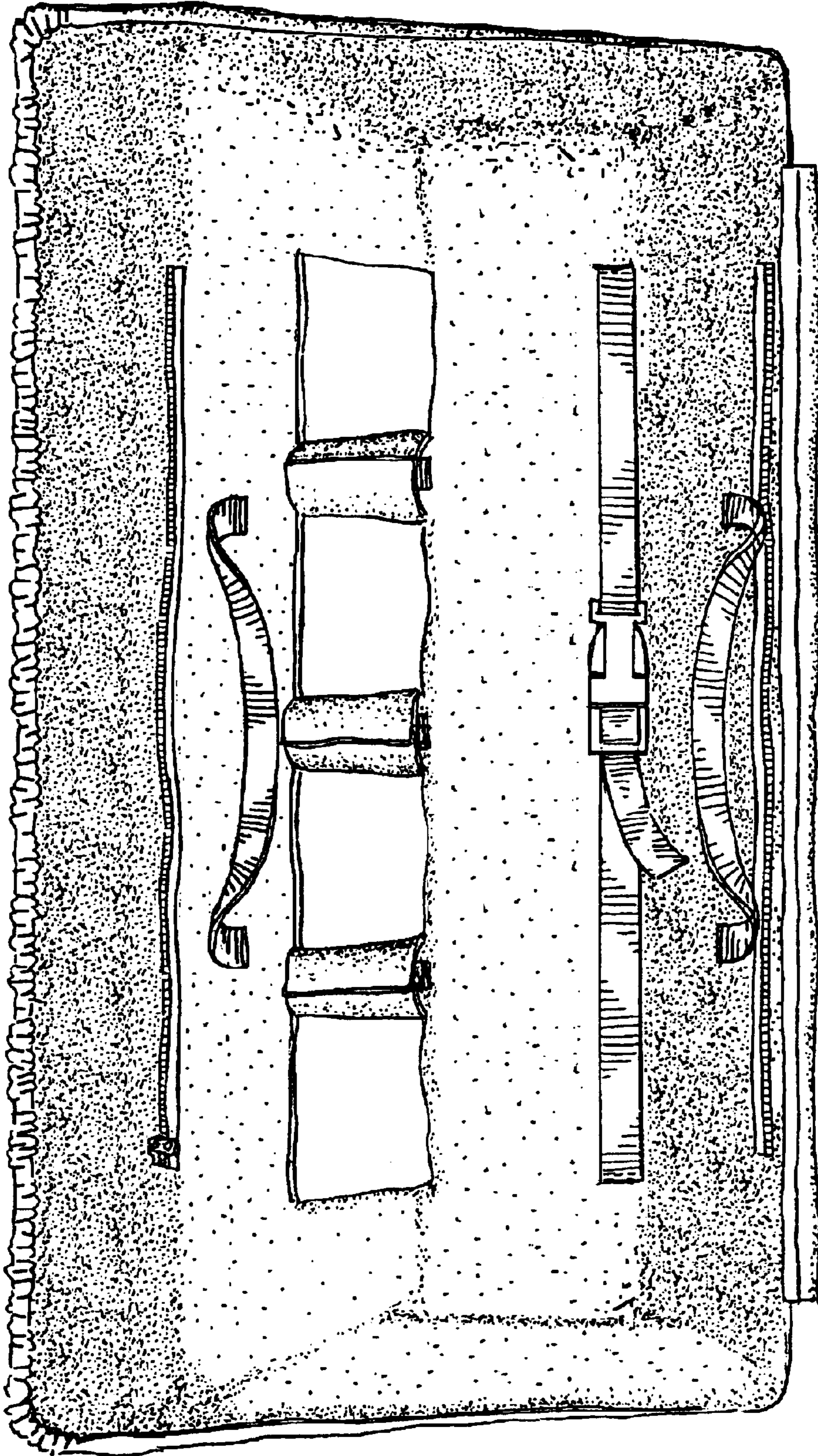

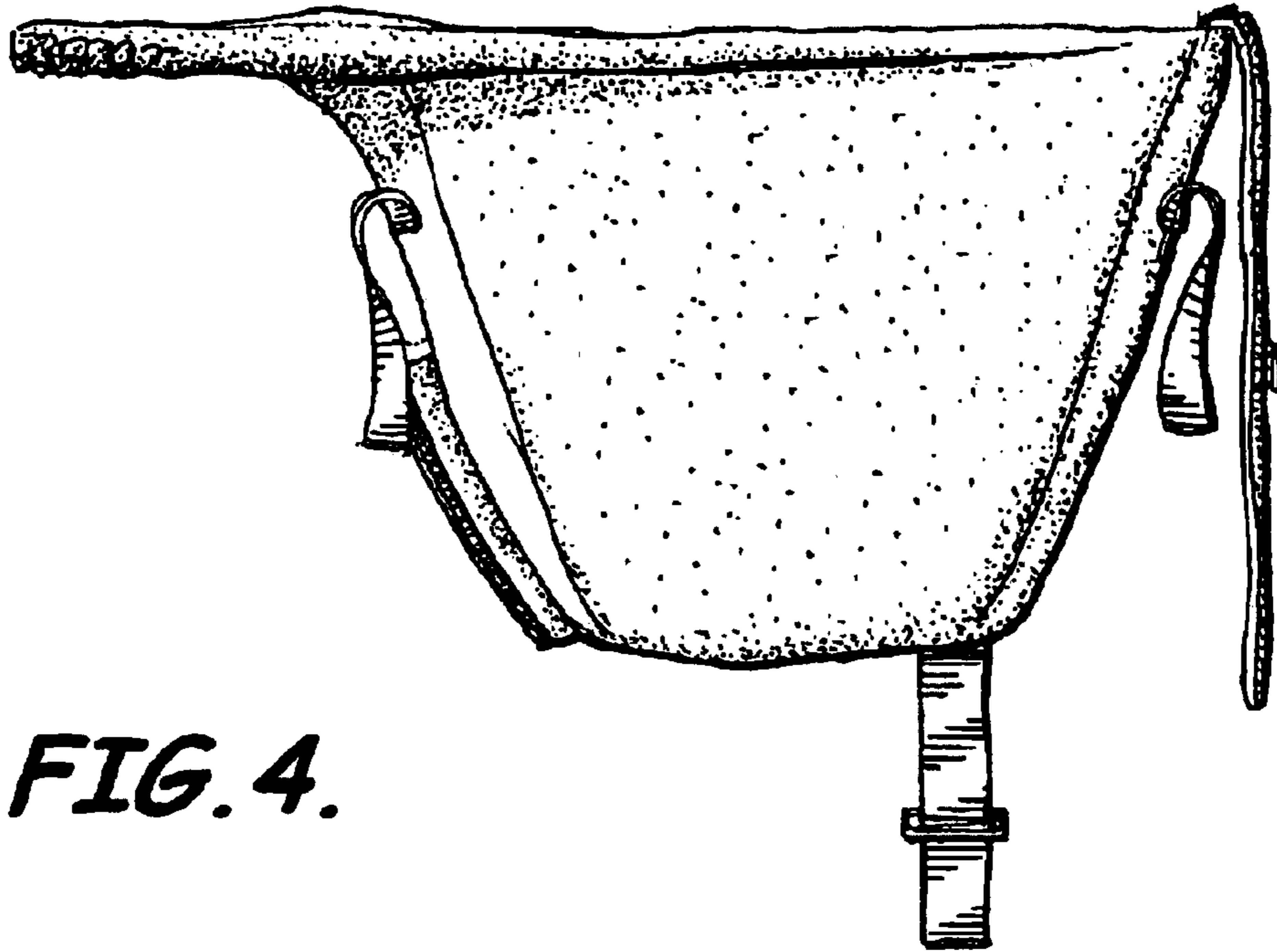

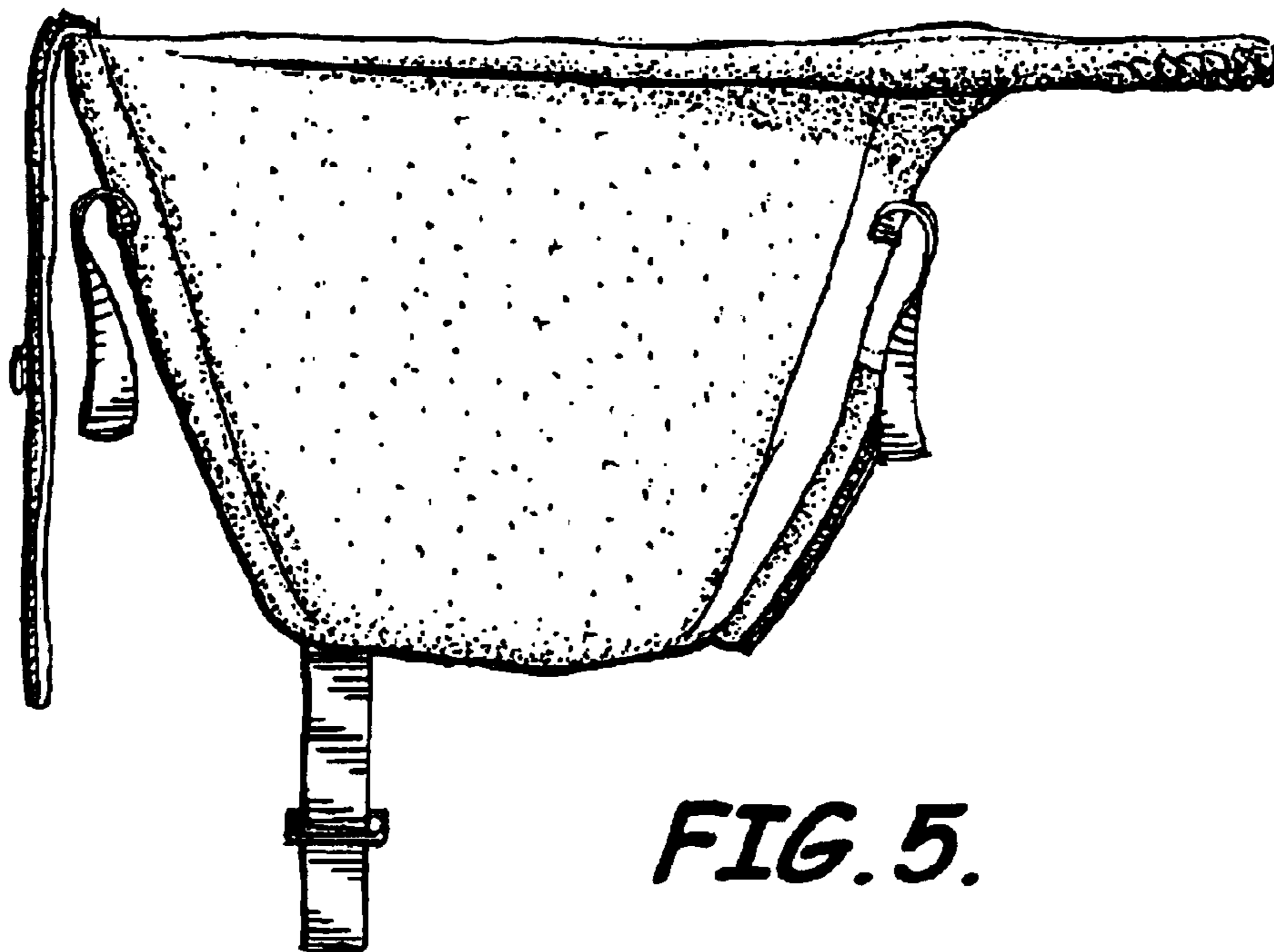

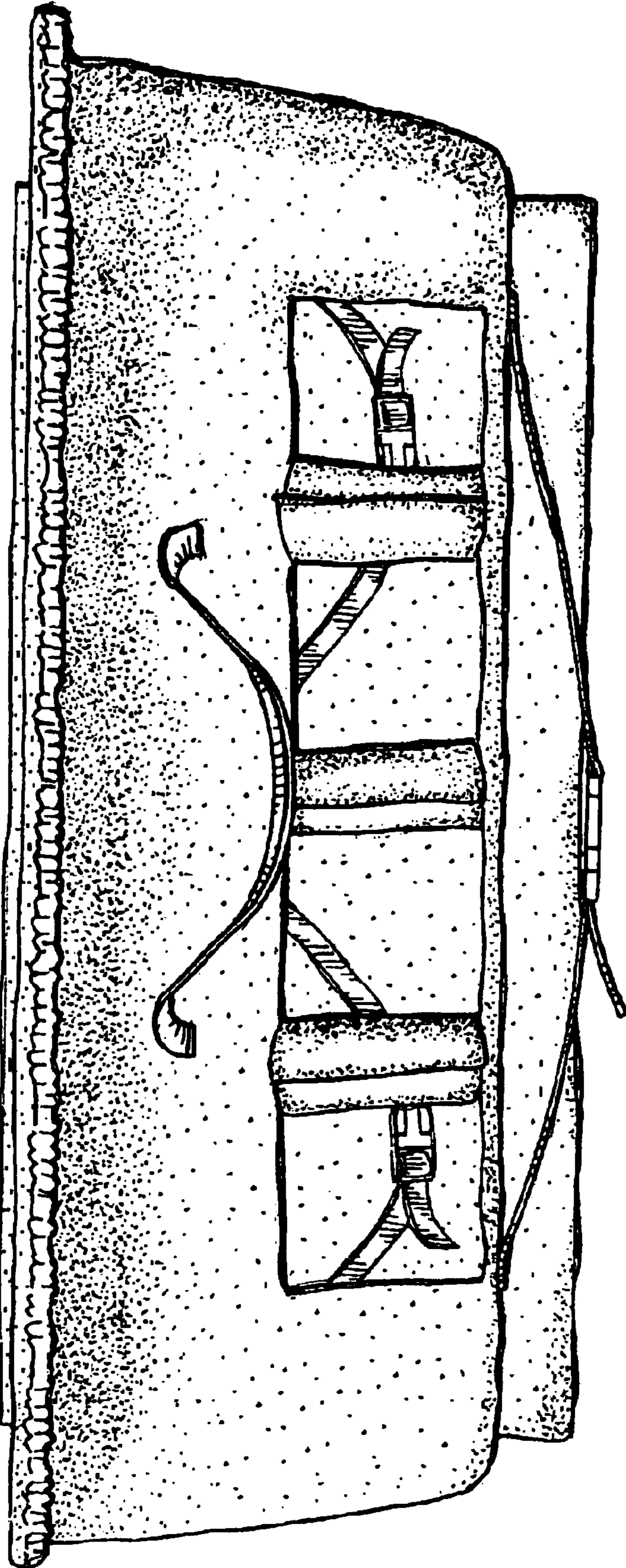
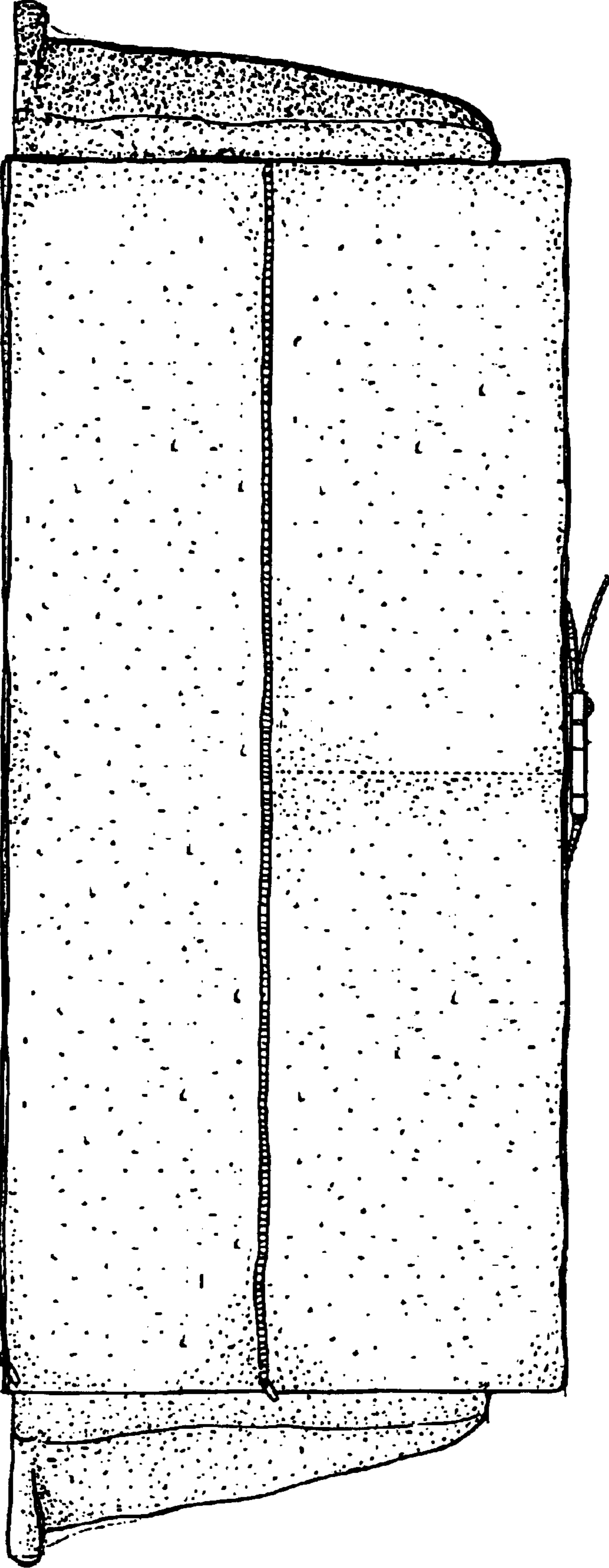

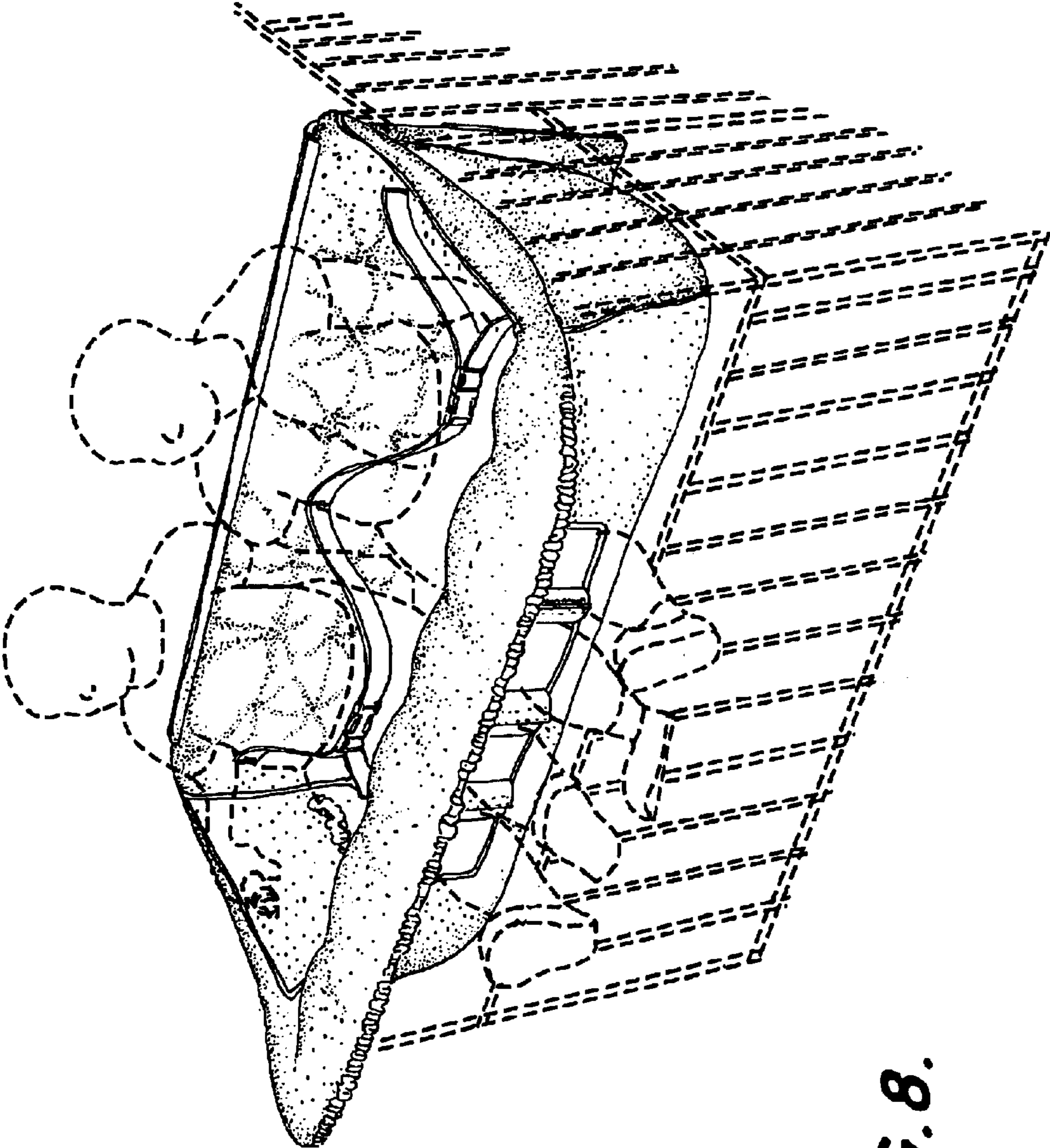
