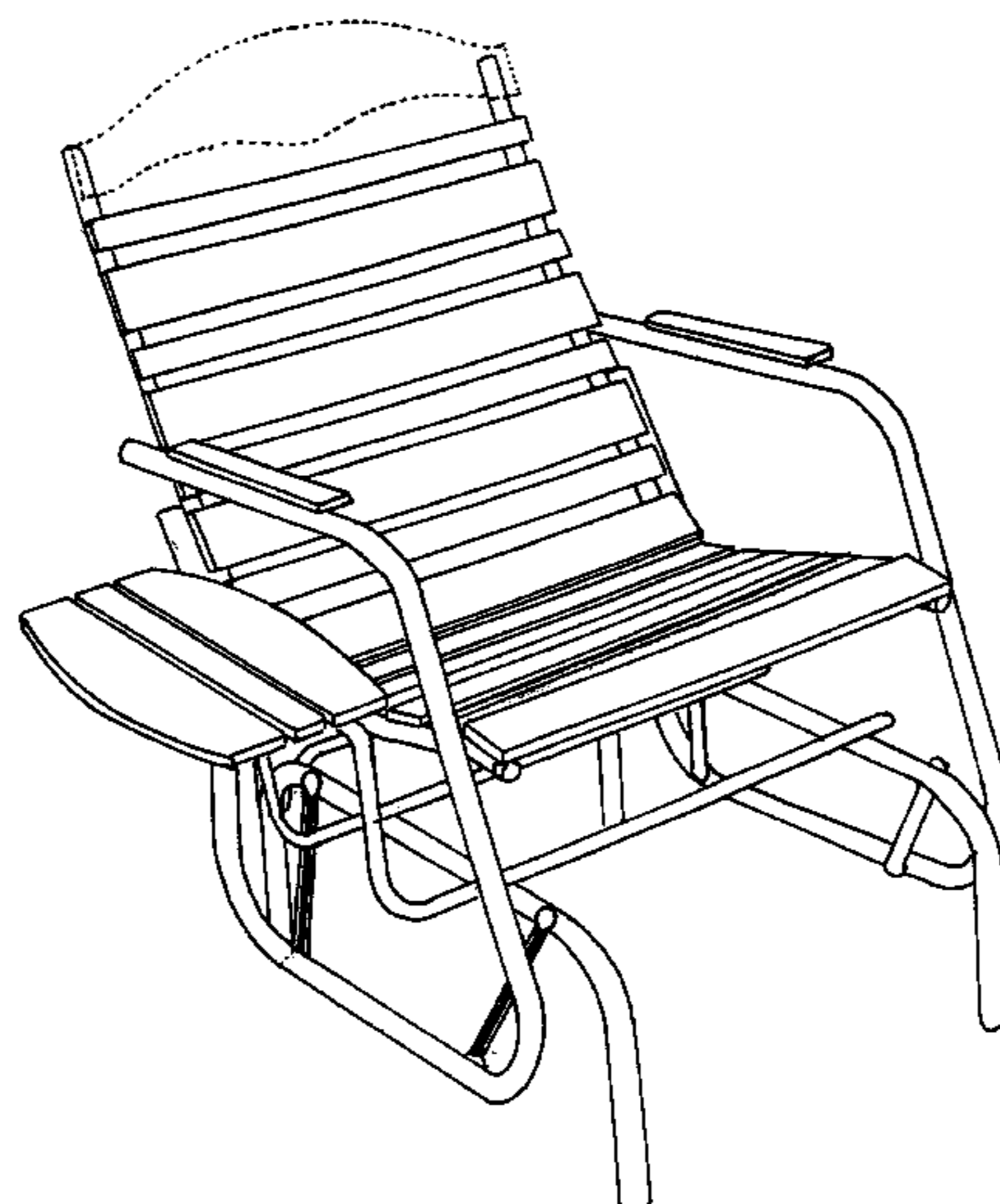
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of the chair glider showing our new design;
FIG. 2 is an end elevational view from one end;

FIG. 5 is a rear elevational view.

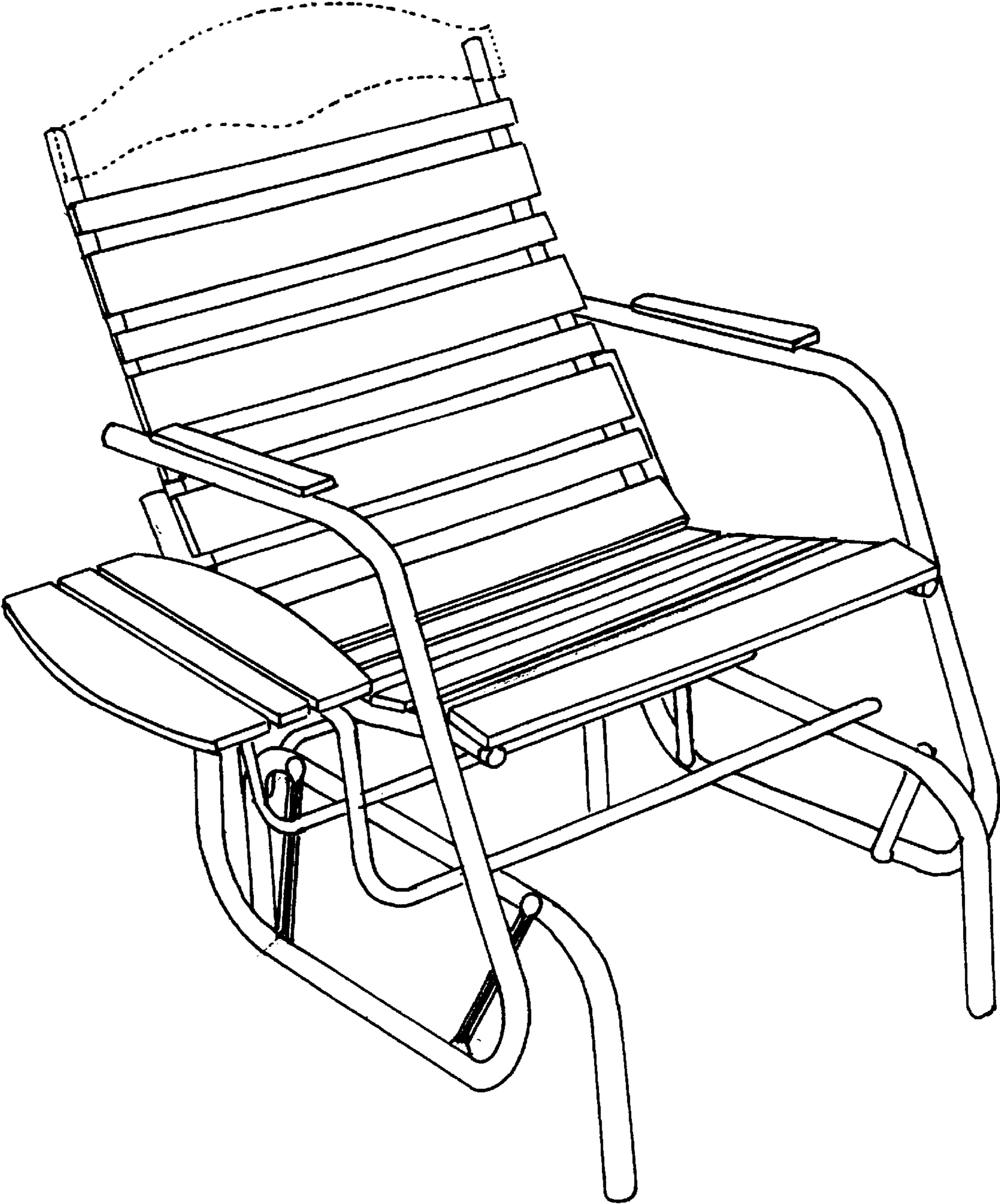

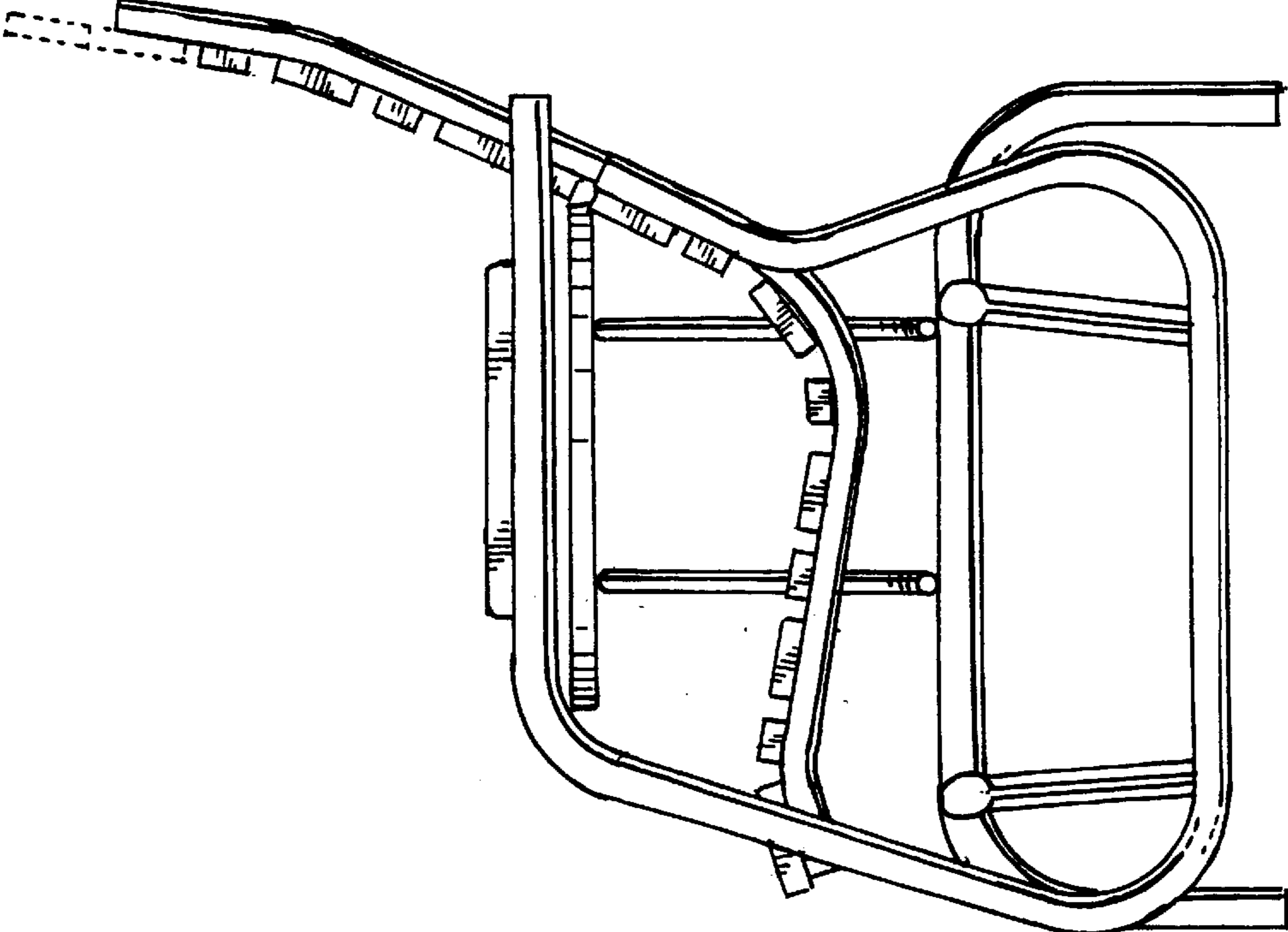

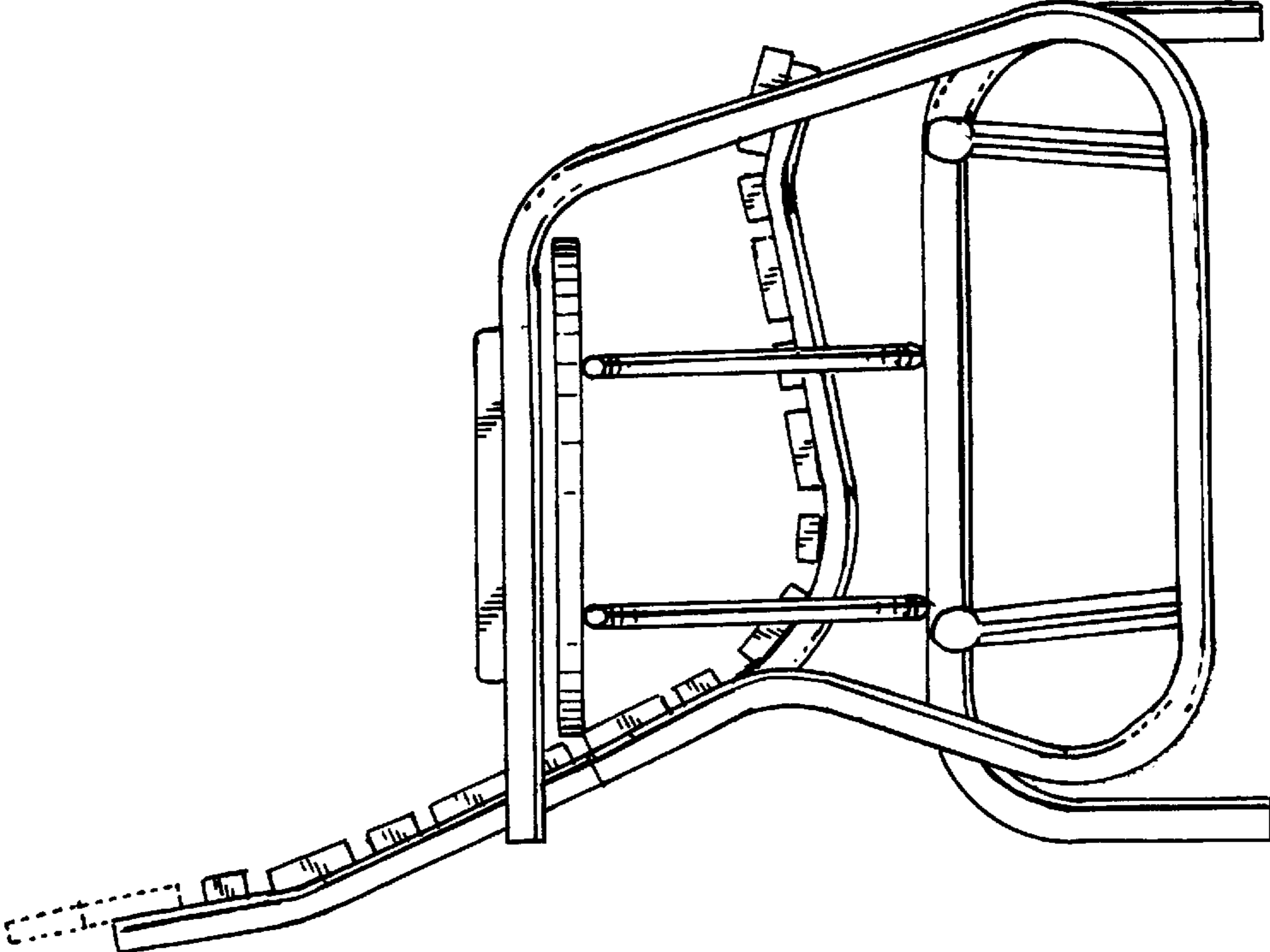

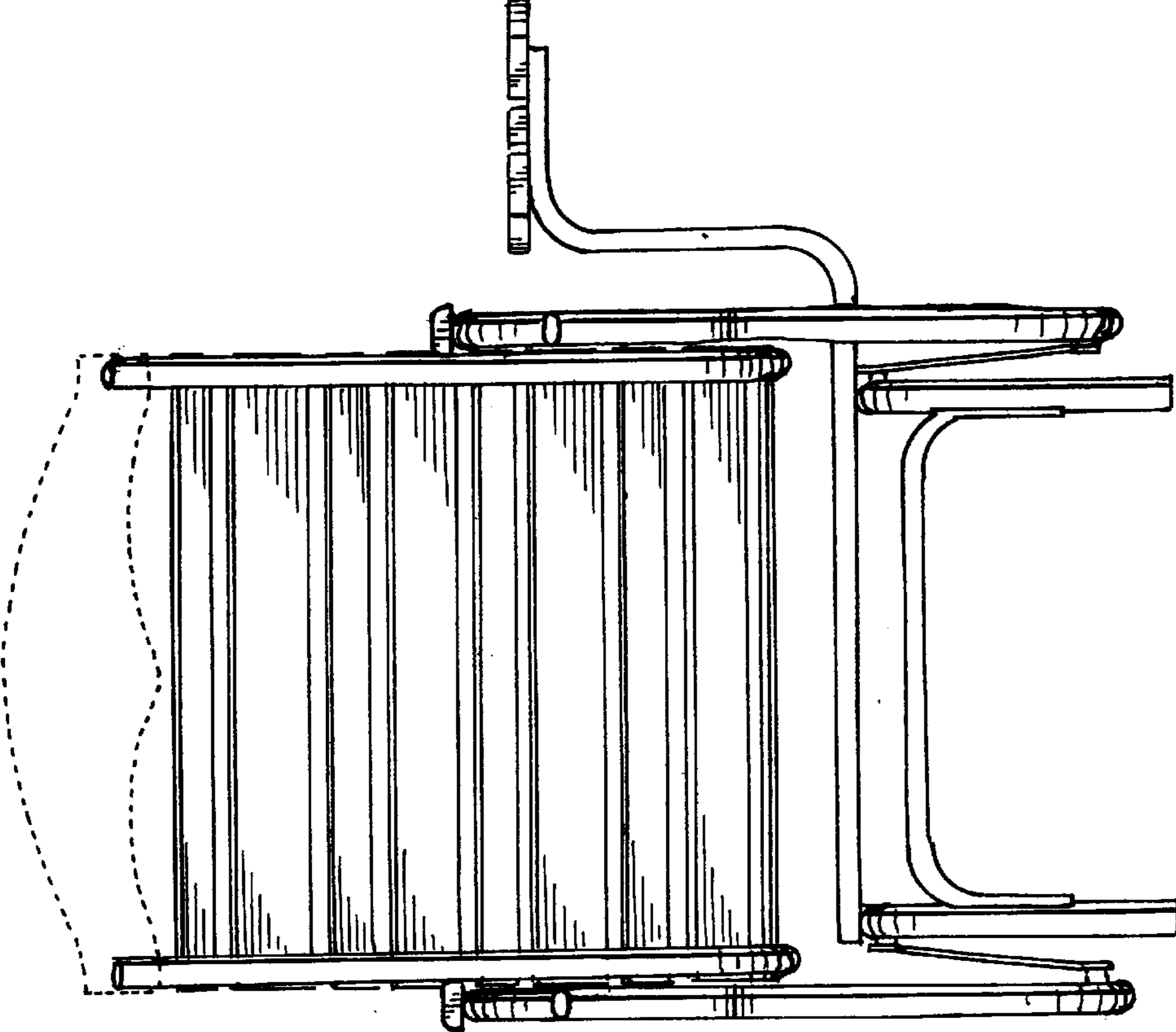

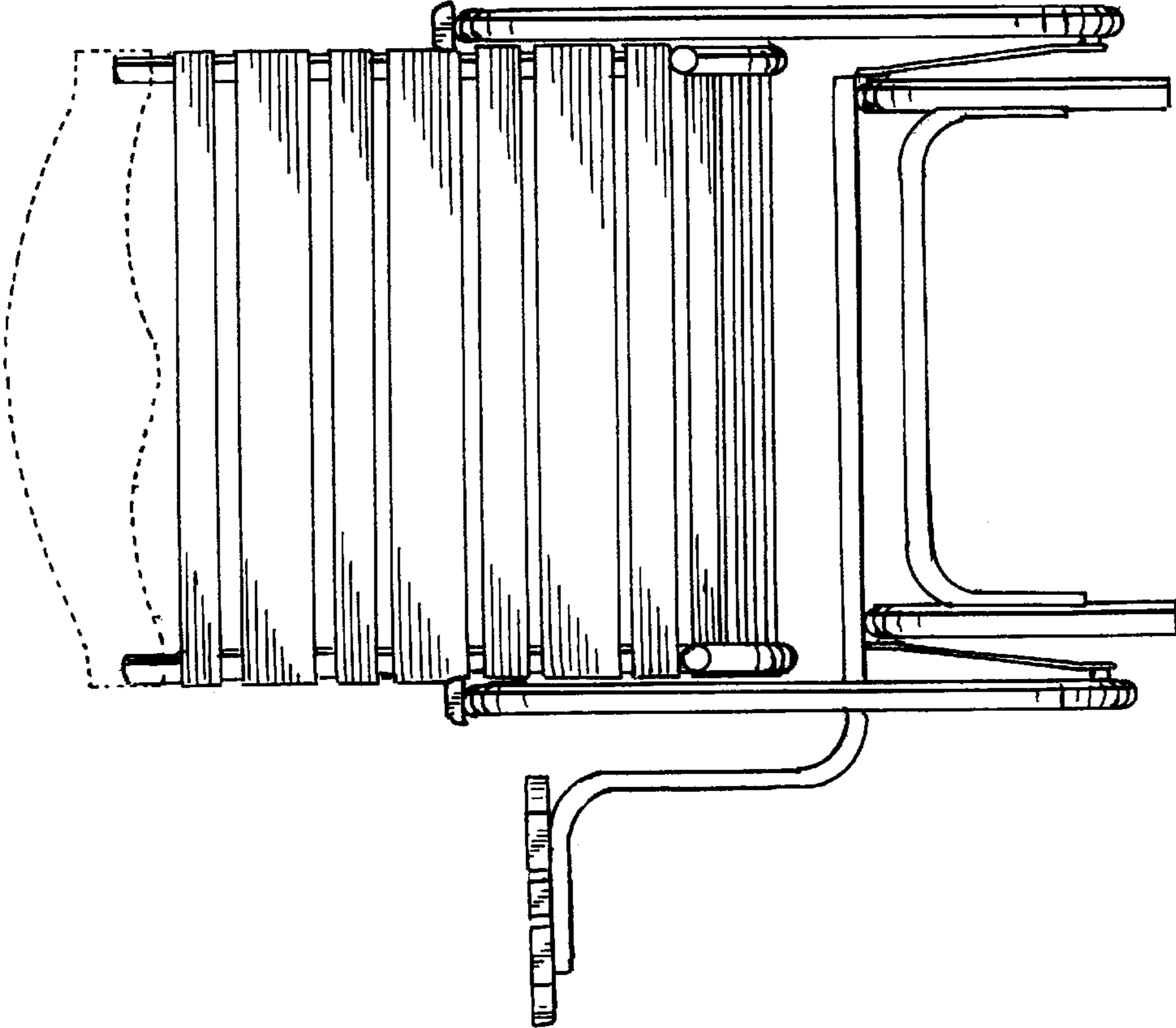

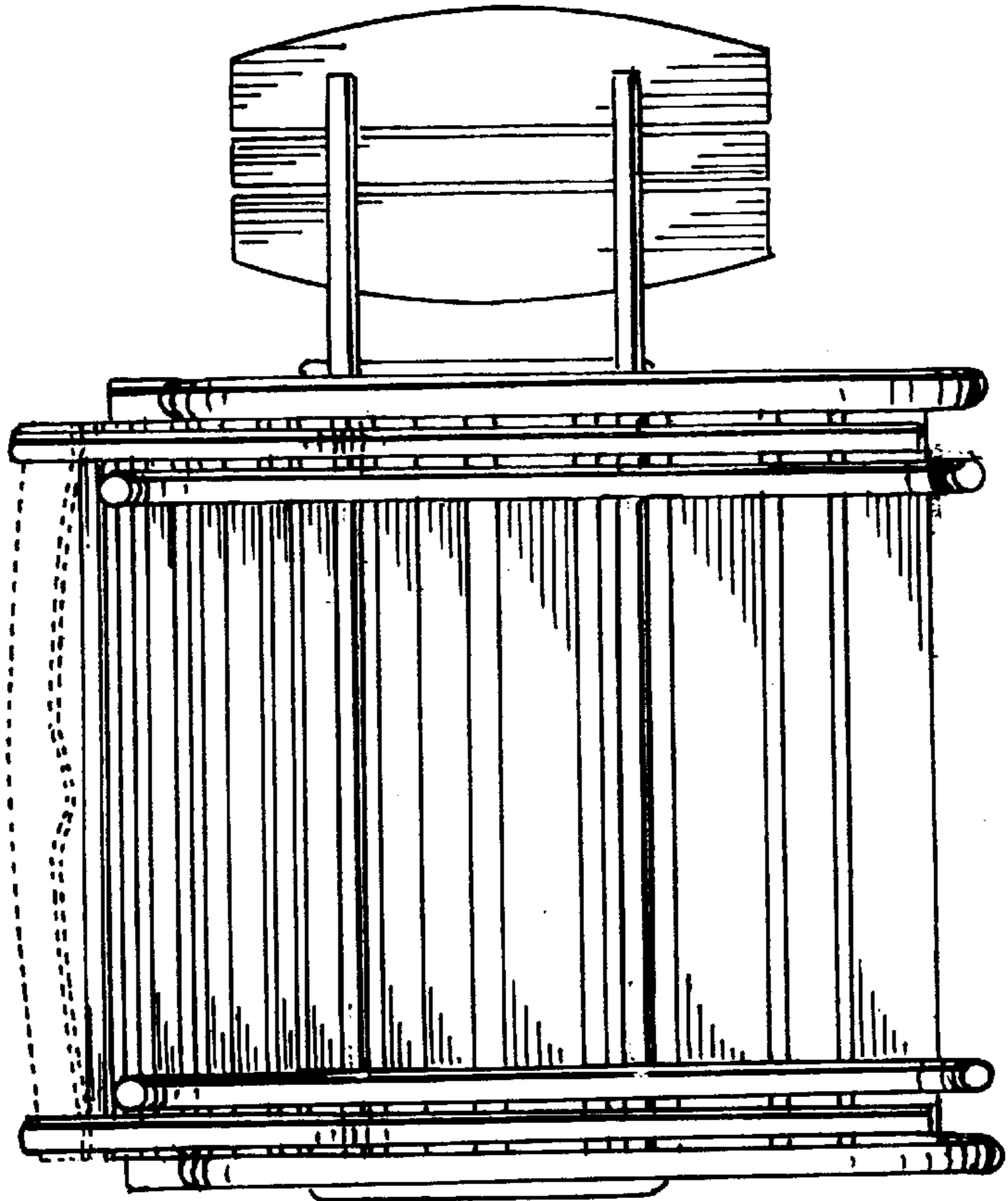

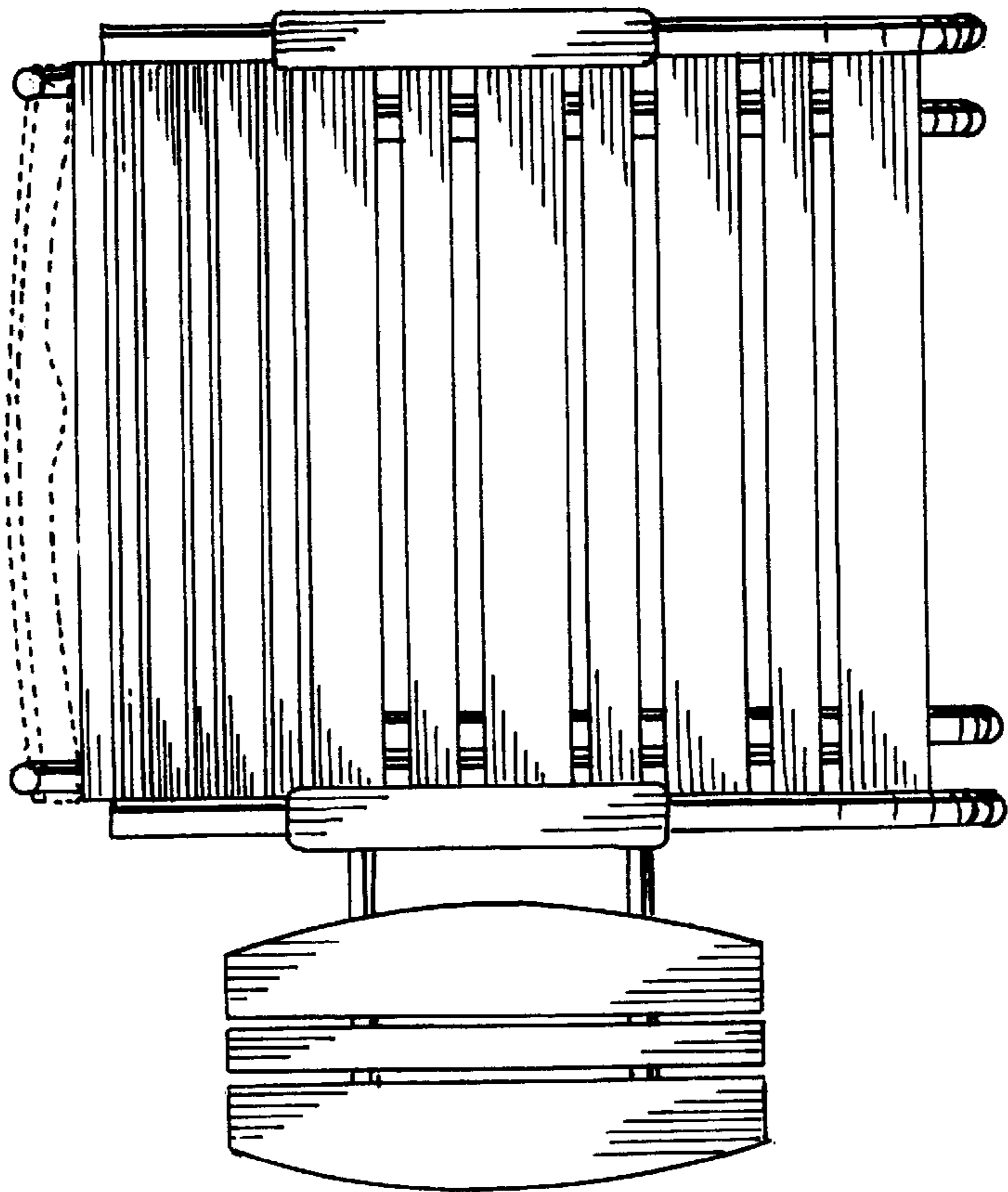
