The ornamental design for a bed, as shown and described.

**DESCRIPTION**

FIG. 1 is a left front perspective view of a bed showing the design of the present invention.

FIG. 2 is a top view of a bed showing the design of the present invention.

FIG. 3 is a right side elevation view of a bed showing the design of the present invention.

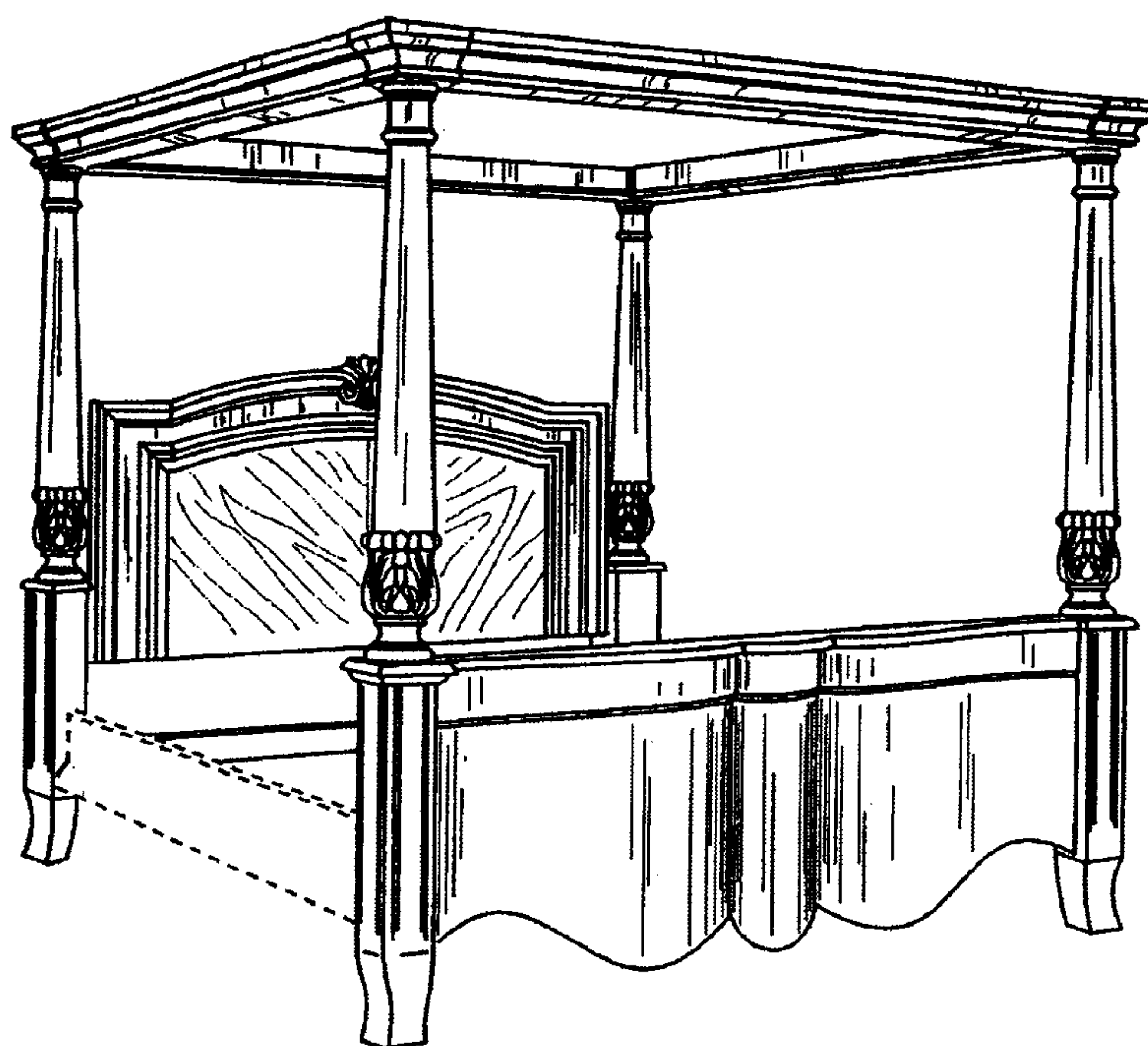
FIG. 4 is a front elevation view of the headboard portion of a bed showing the design of the present invention; and,

FIG. 5 is a front elevation view of the tailboard portion of a bed showing the design of the present invention.

The rear views of the headboard and tailboard portions are not shown and form no part of the claimed design. The dashed lines represent environmental elements only and form no part of the claimed design.

The headboard and footboard are shown separately for convenience of illustration.

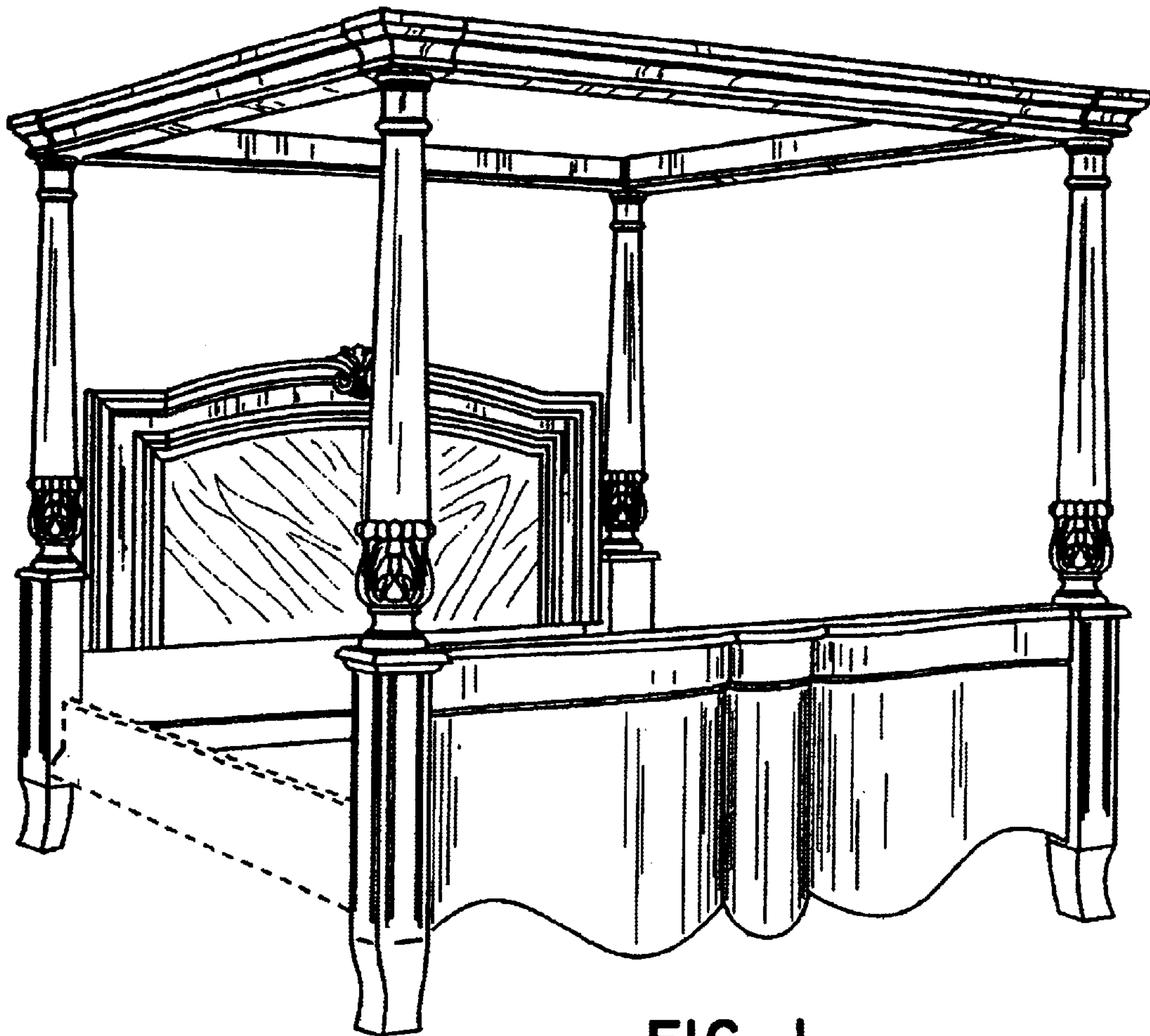

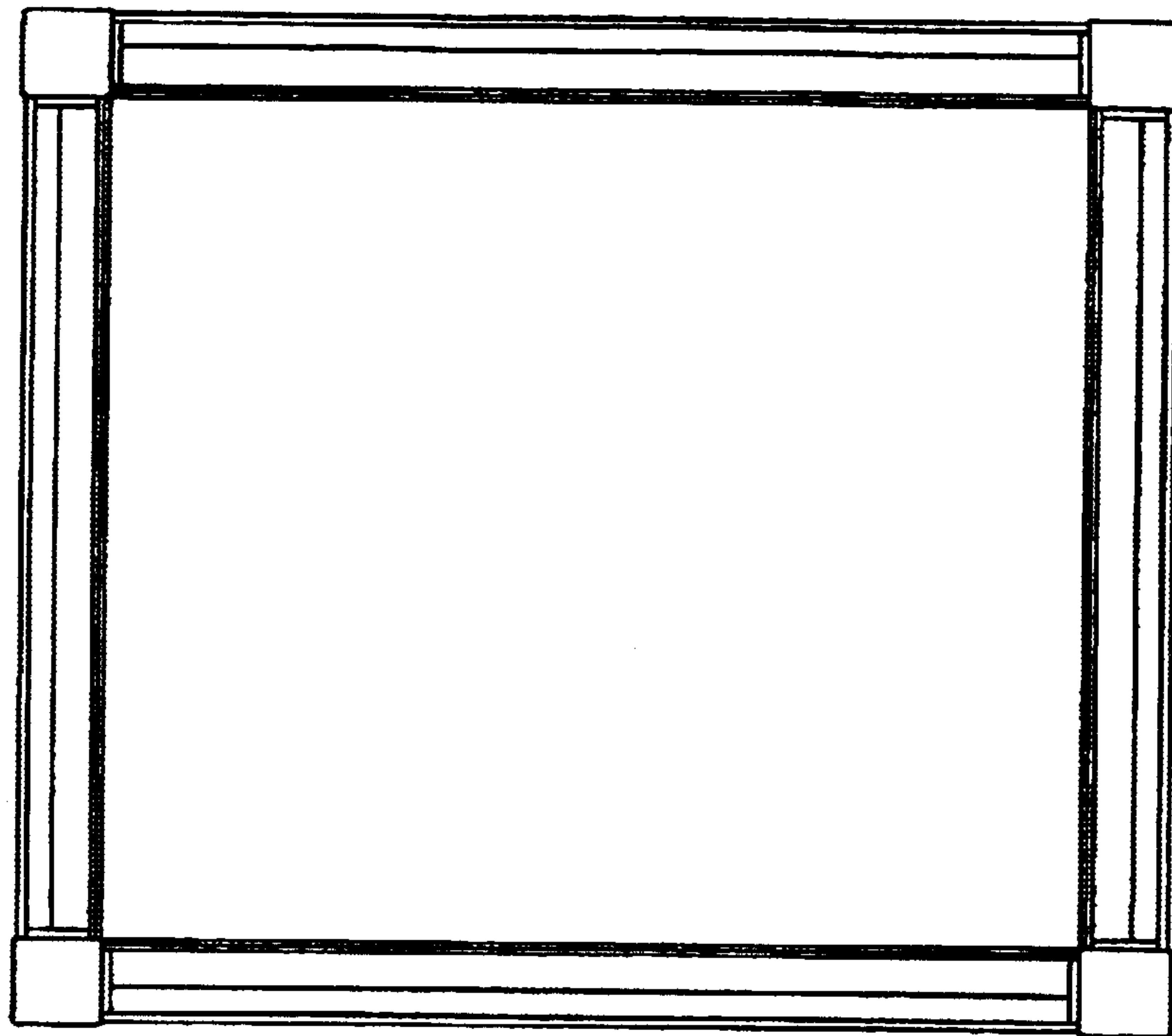

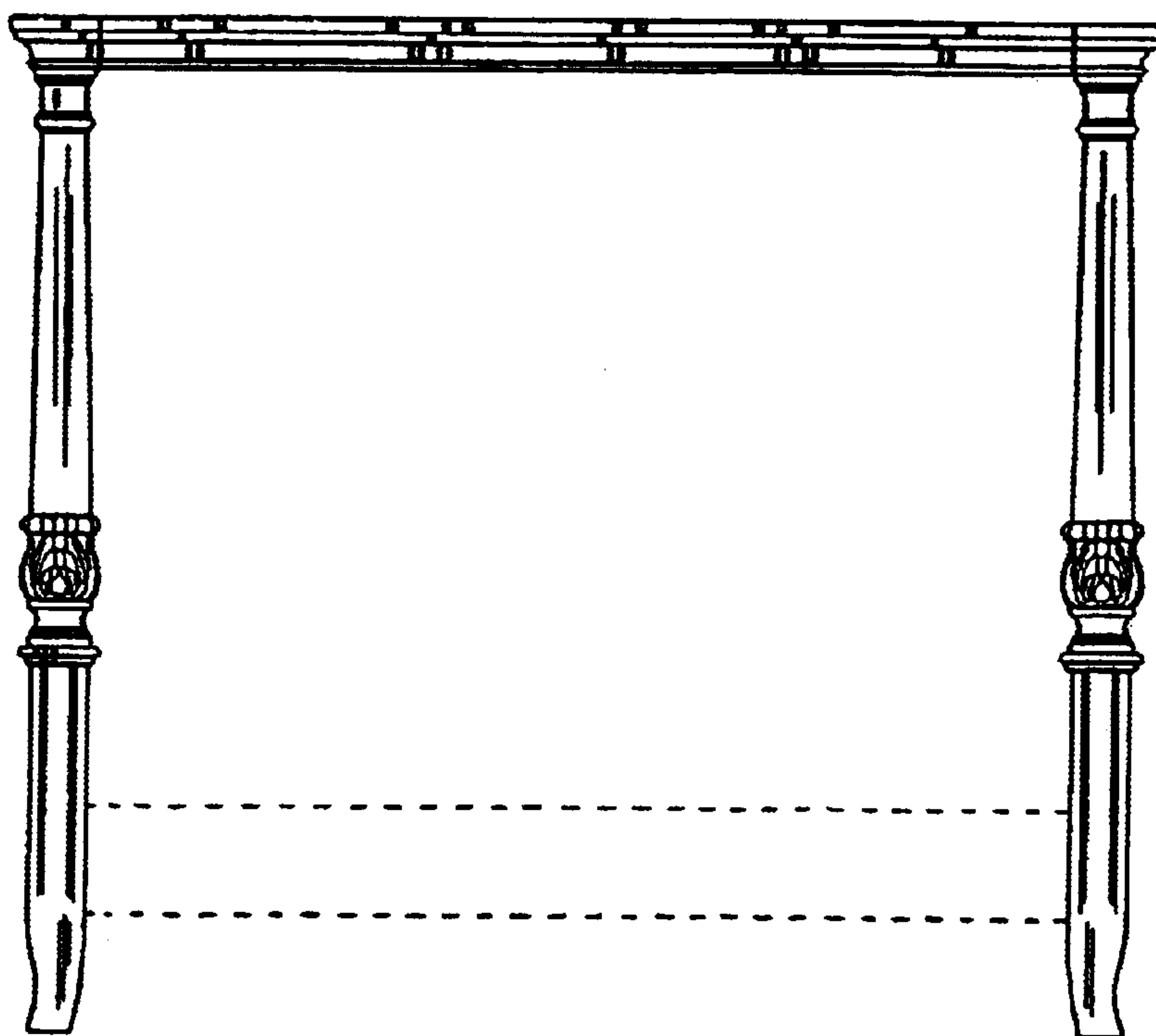

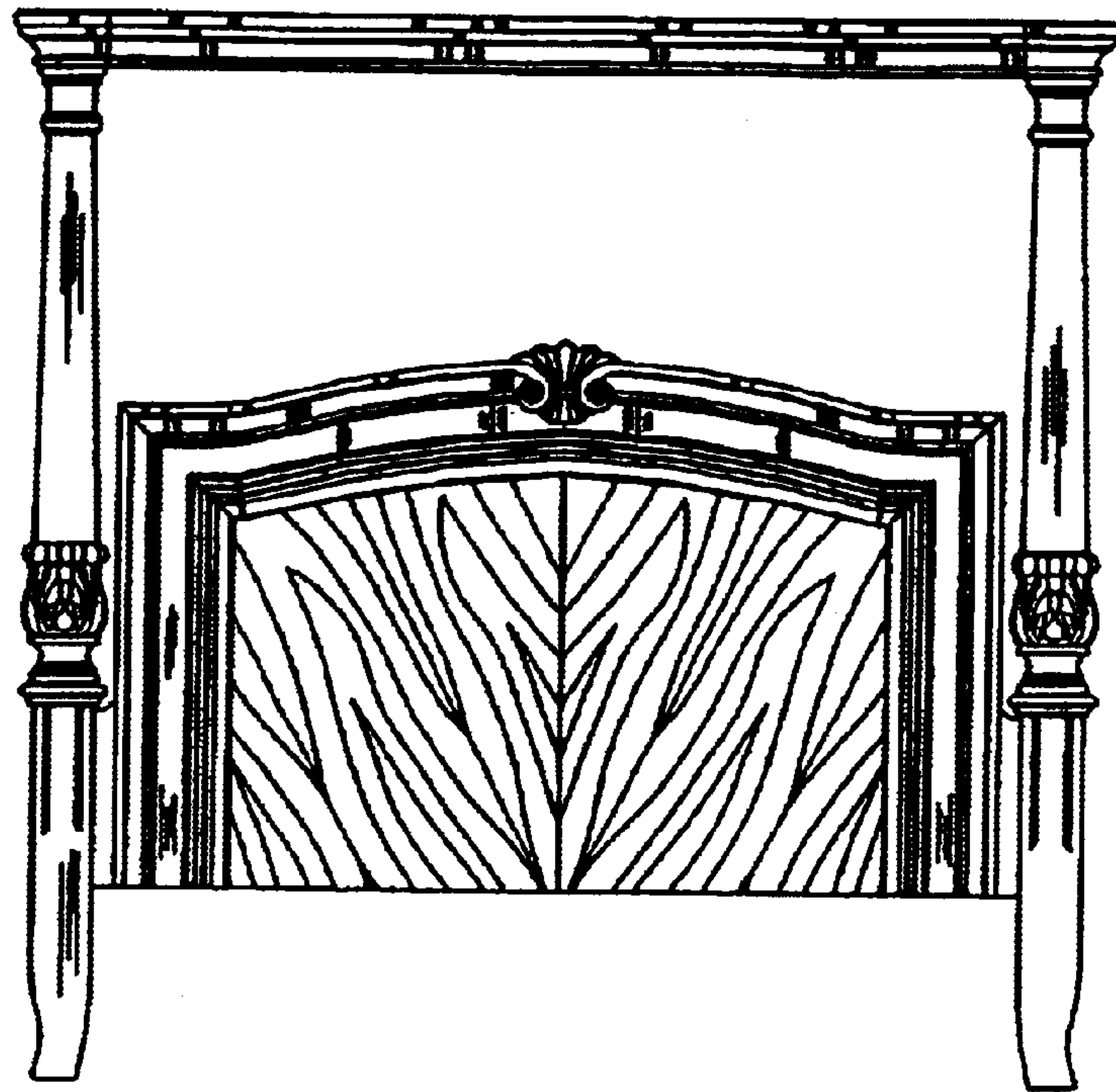

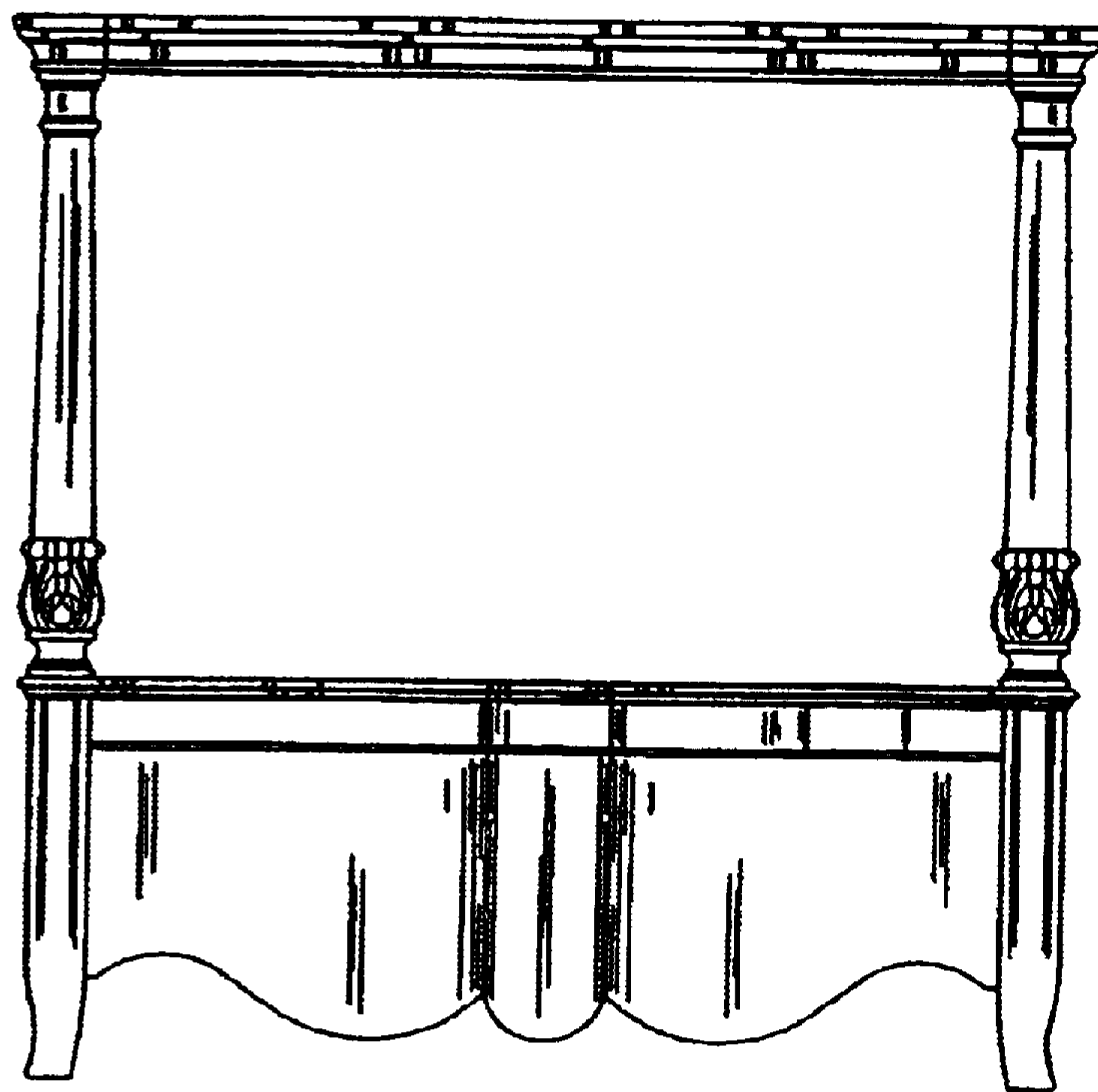
