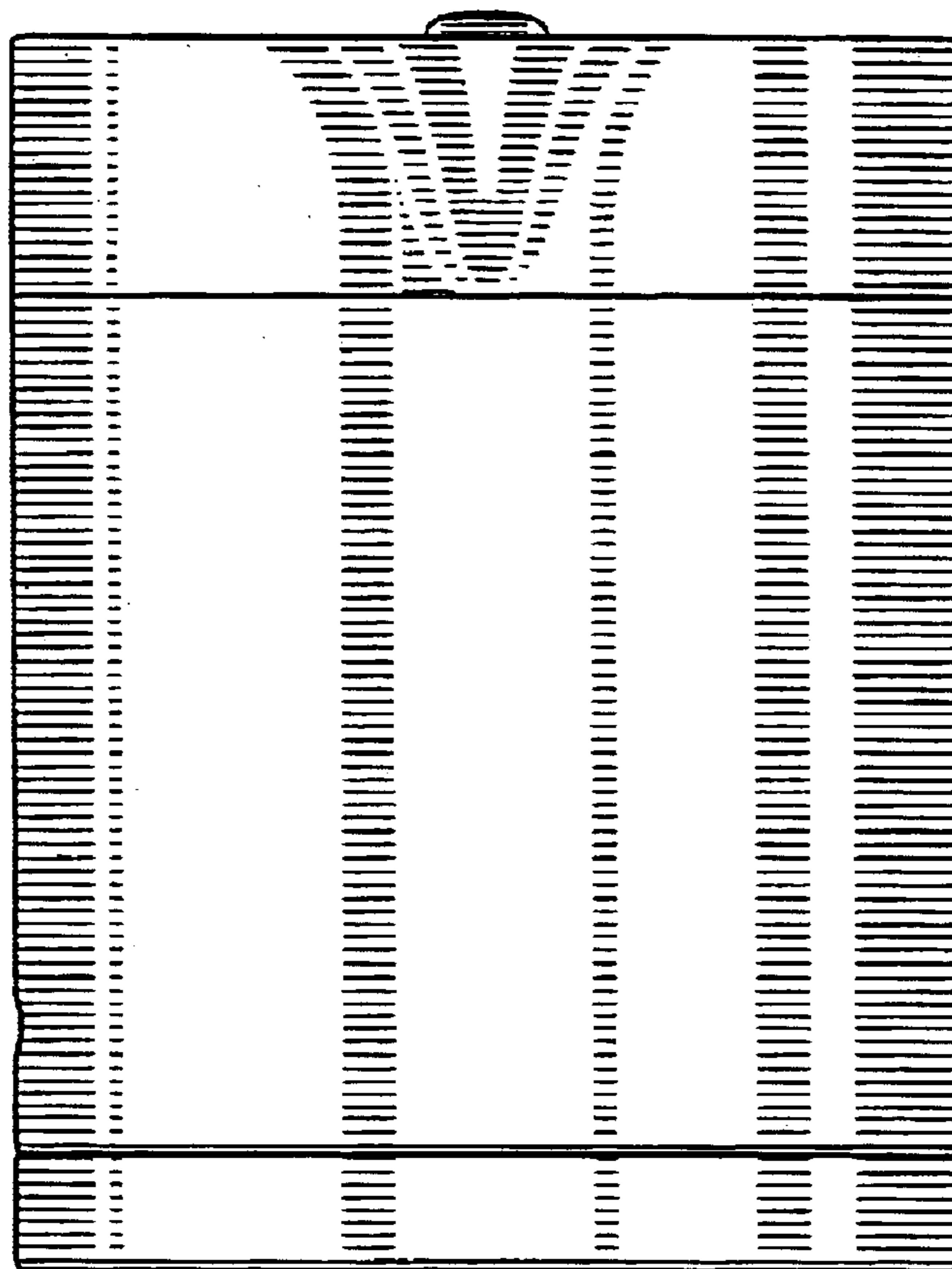

FIG. 1 is a top, rear and side perspective view of a kettle showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a side elevational rear view thereof from the right of FIG. 2;

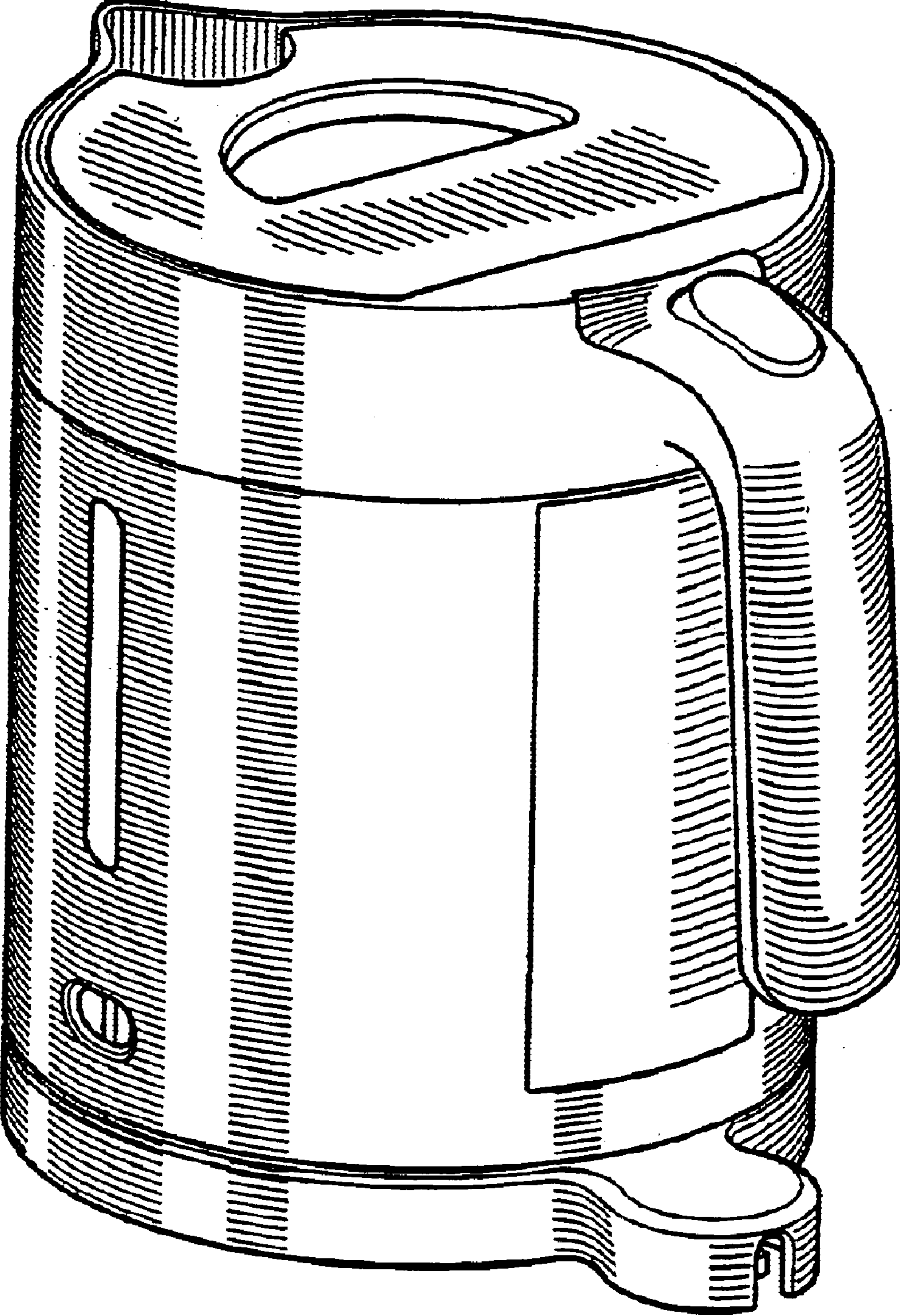

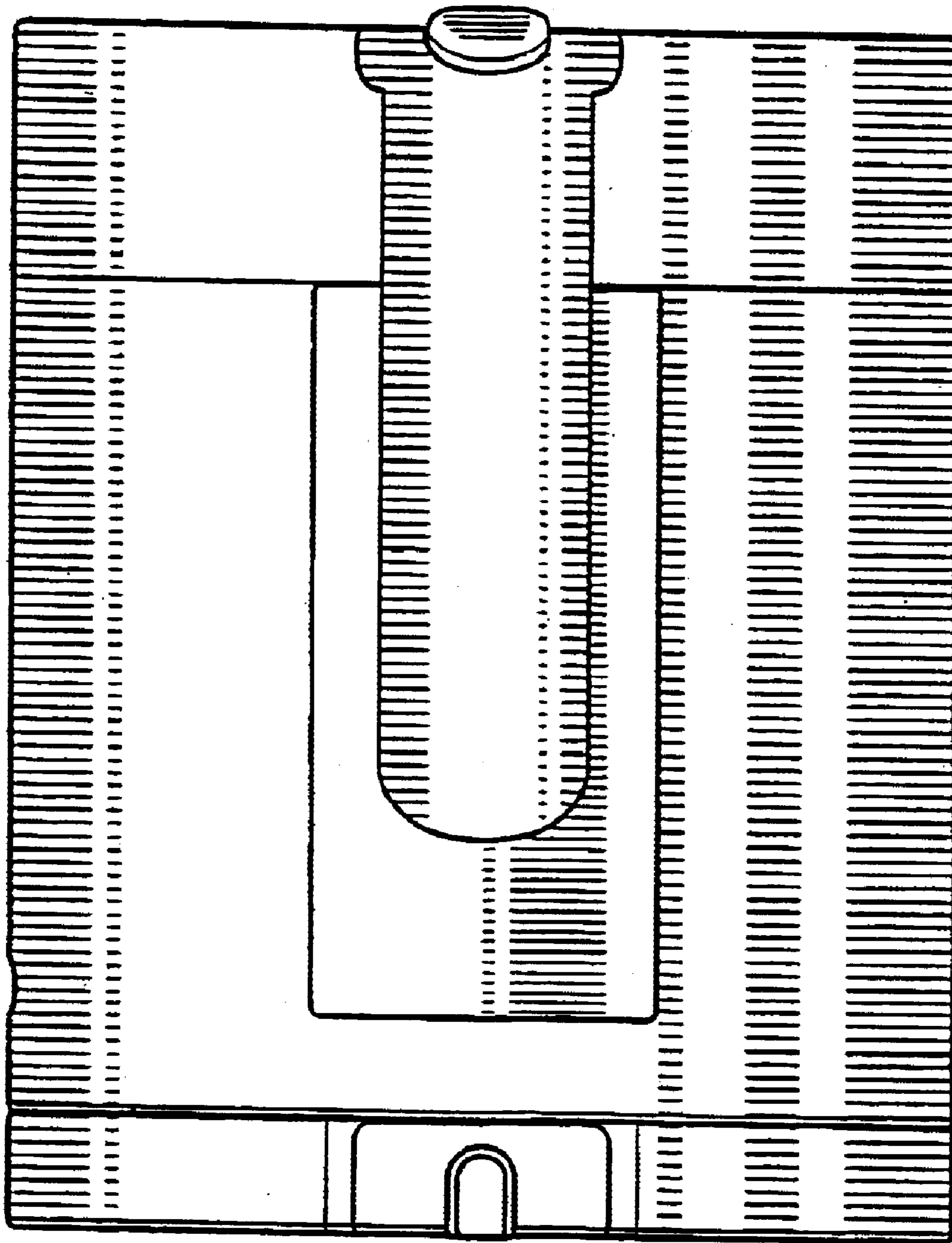

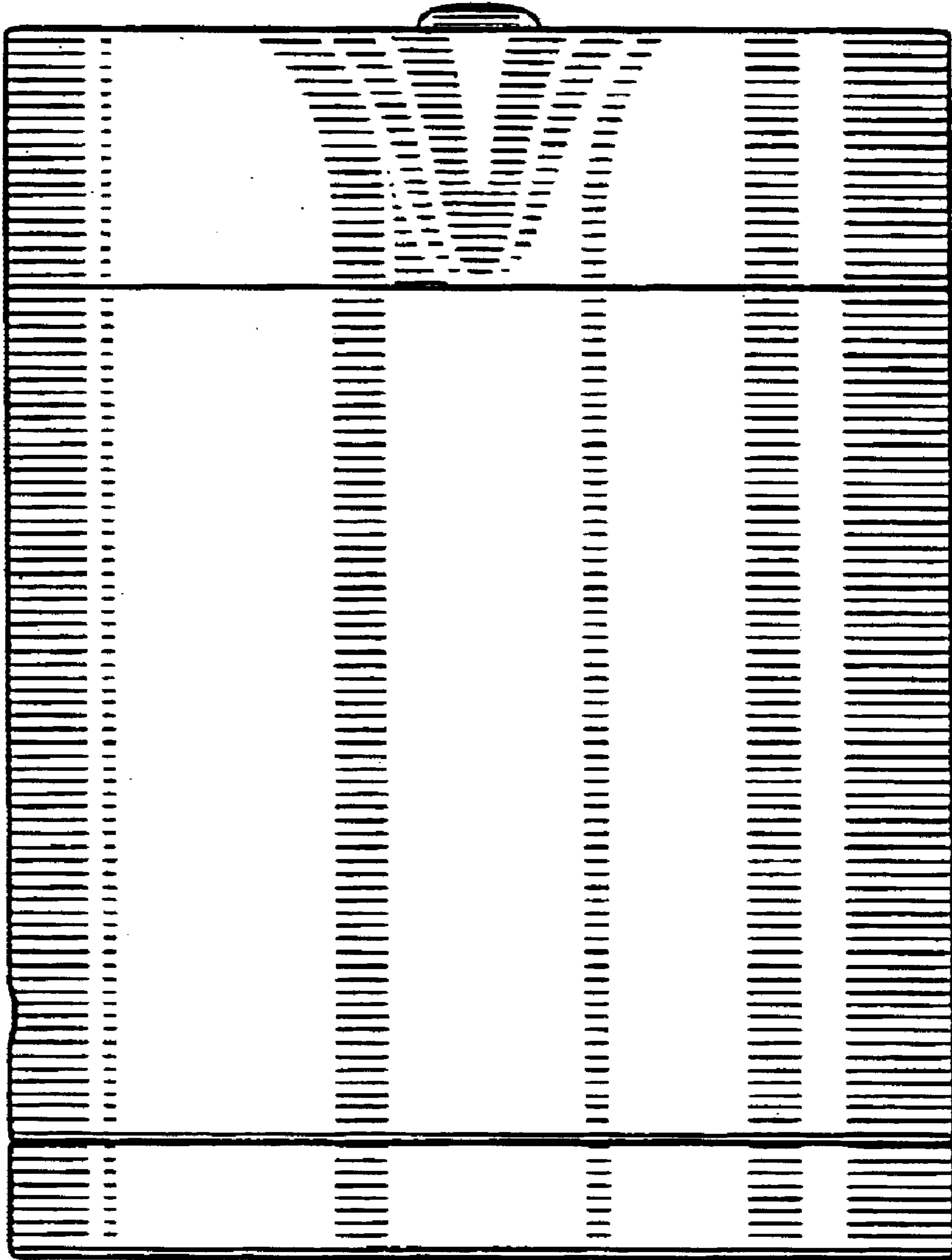

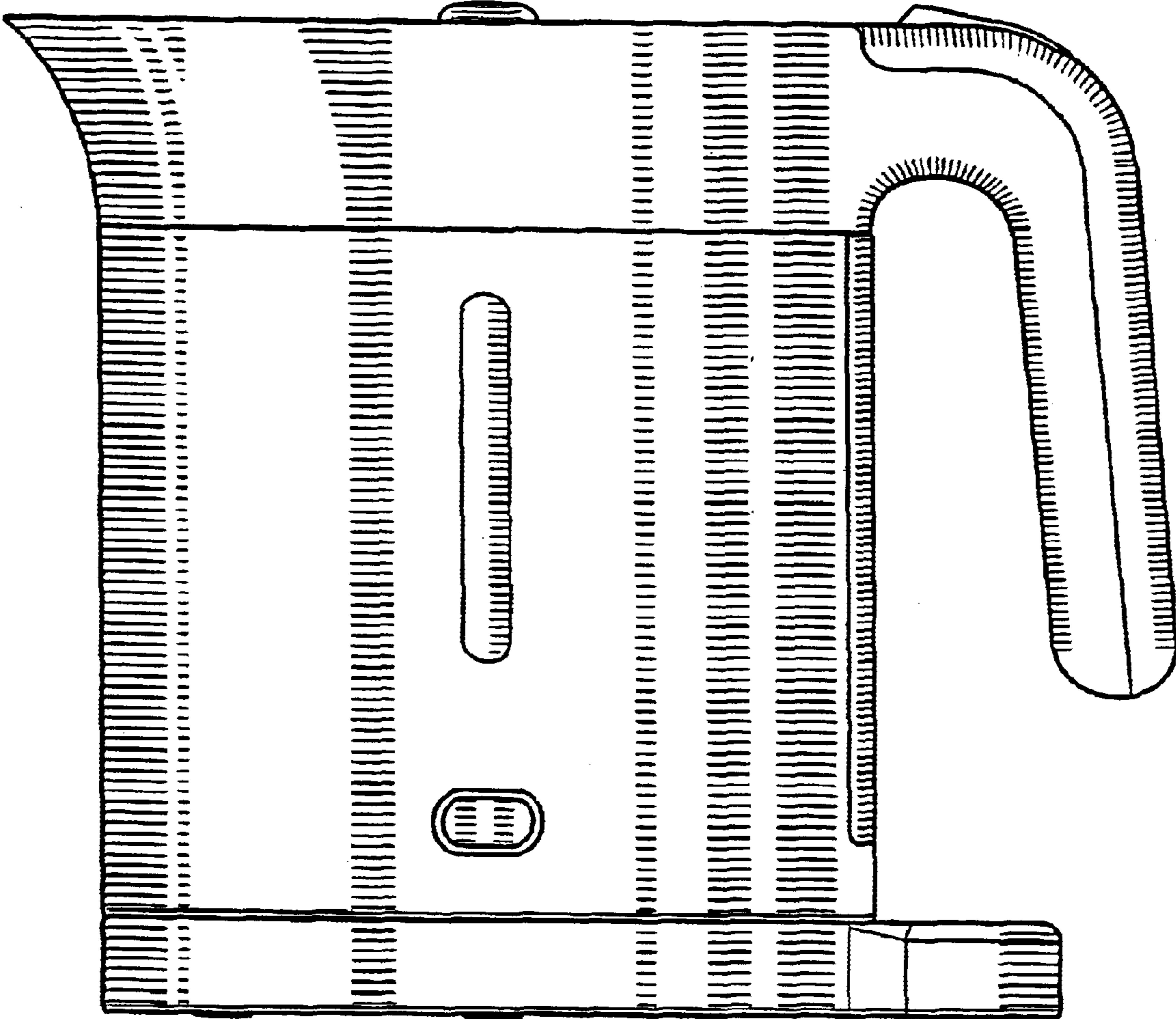

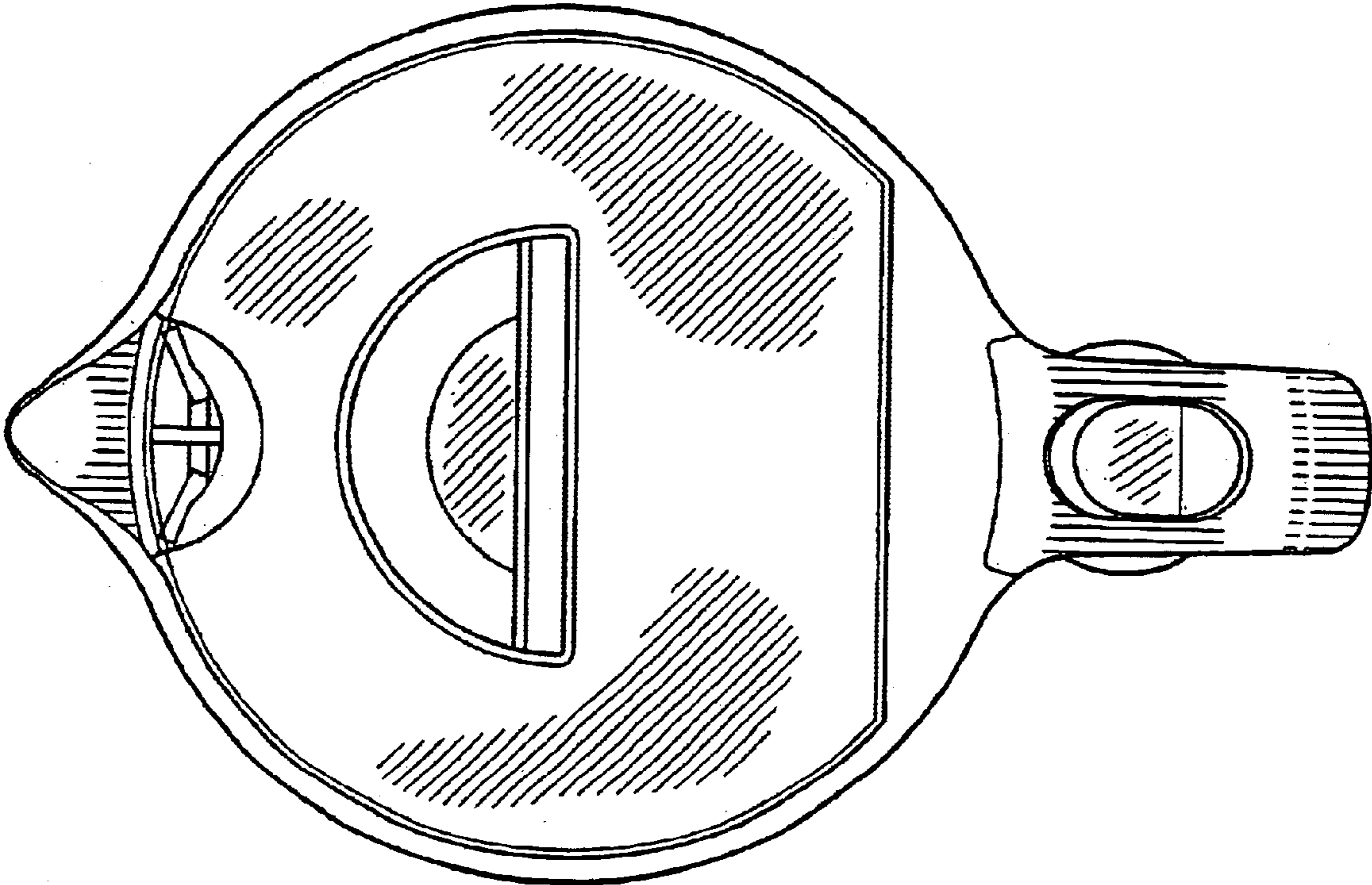

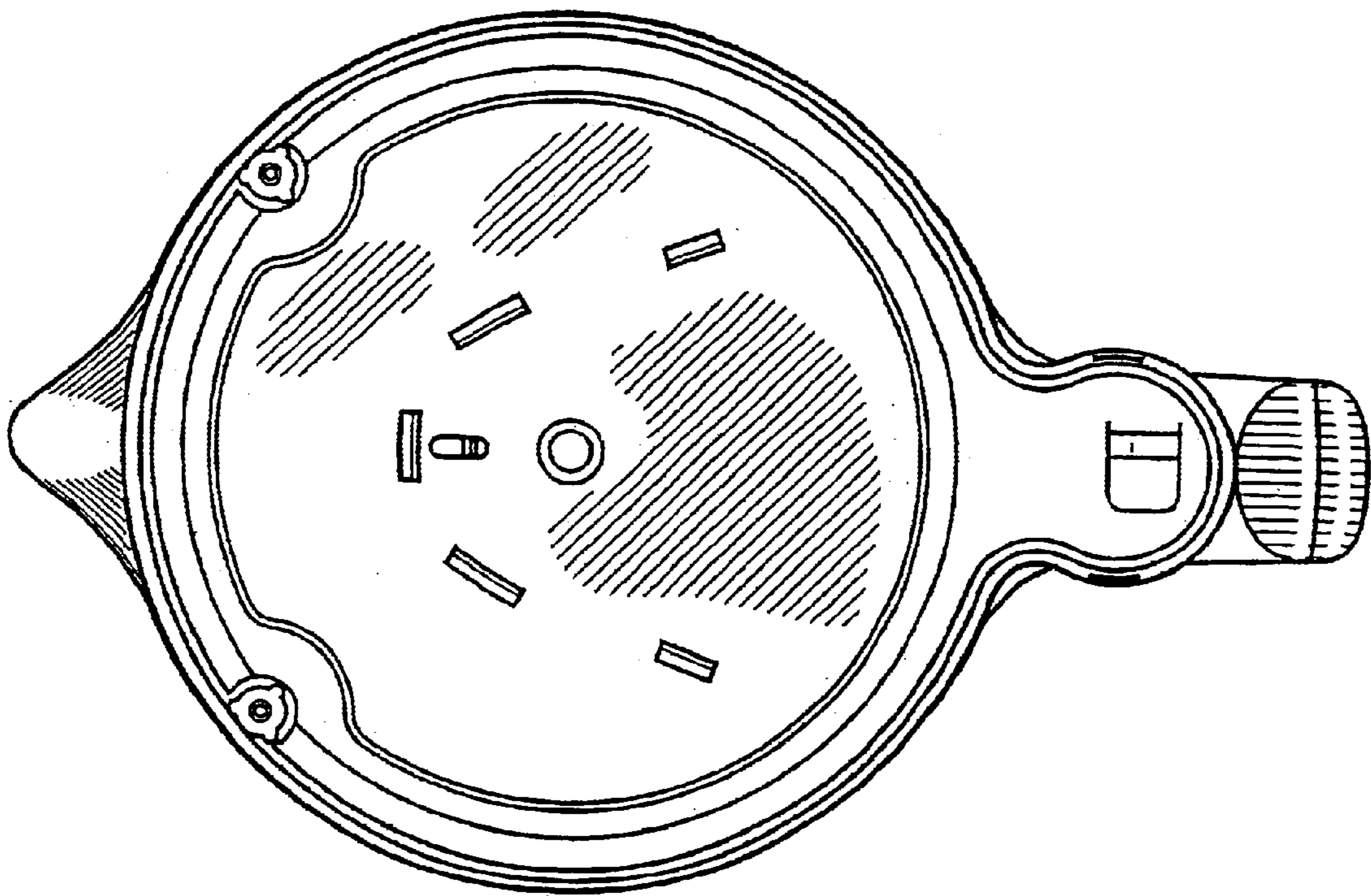
