(57) **CLAIM**

The ornamental design for a locking strap with handle structure, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the locking strap with handle structure design;

FIG. 2 is a front elevation view of the locking strap with handle structure design;

FIG. 3 is a first side elevation view of the locking strap with handle structure design;

FIG. 4 is a back elevation view of the locking strap with handle structure design;

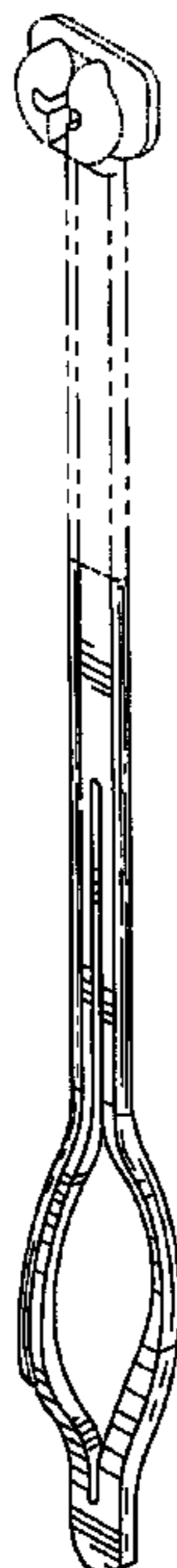
FIG. 5 is a second side elevation view of the locking strap with handle structure design;

FIG. 6 is a top plan view of the locking strap with handle structure design; and,

FIG. 7 is a bottom plan view of the locking strap with handle structure design.

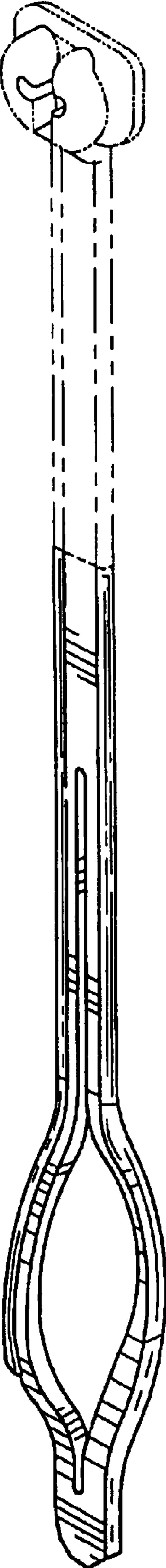

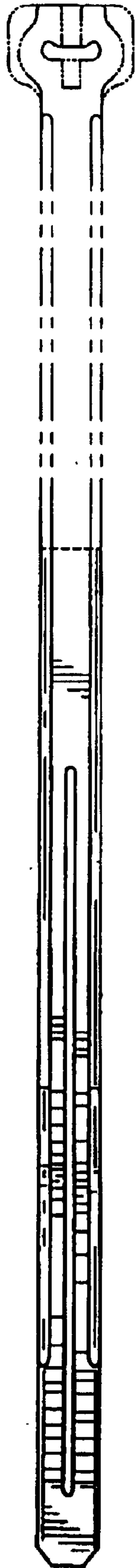

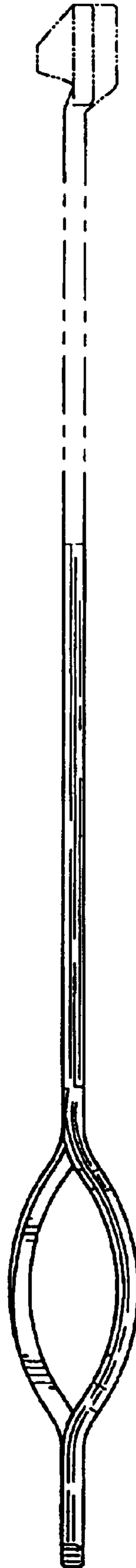

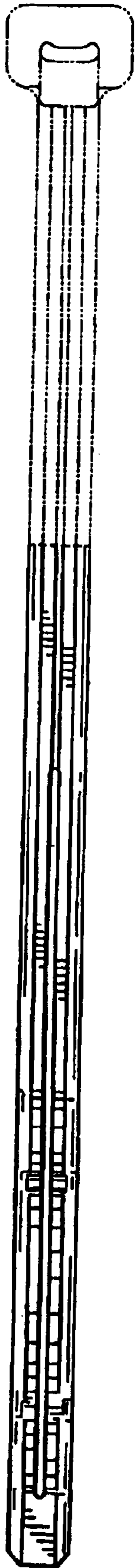

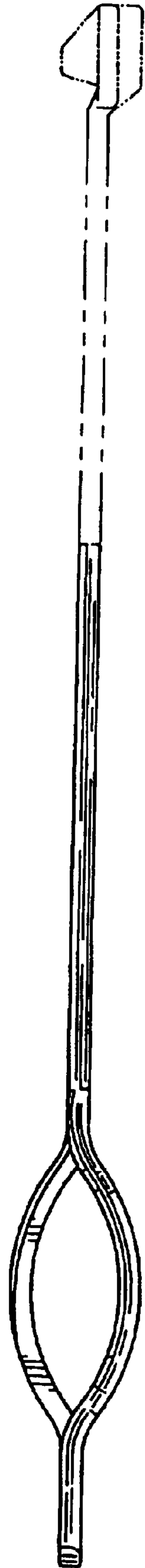

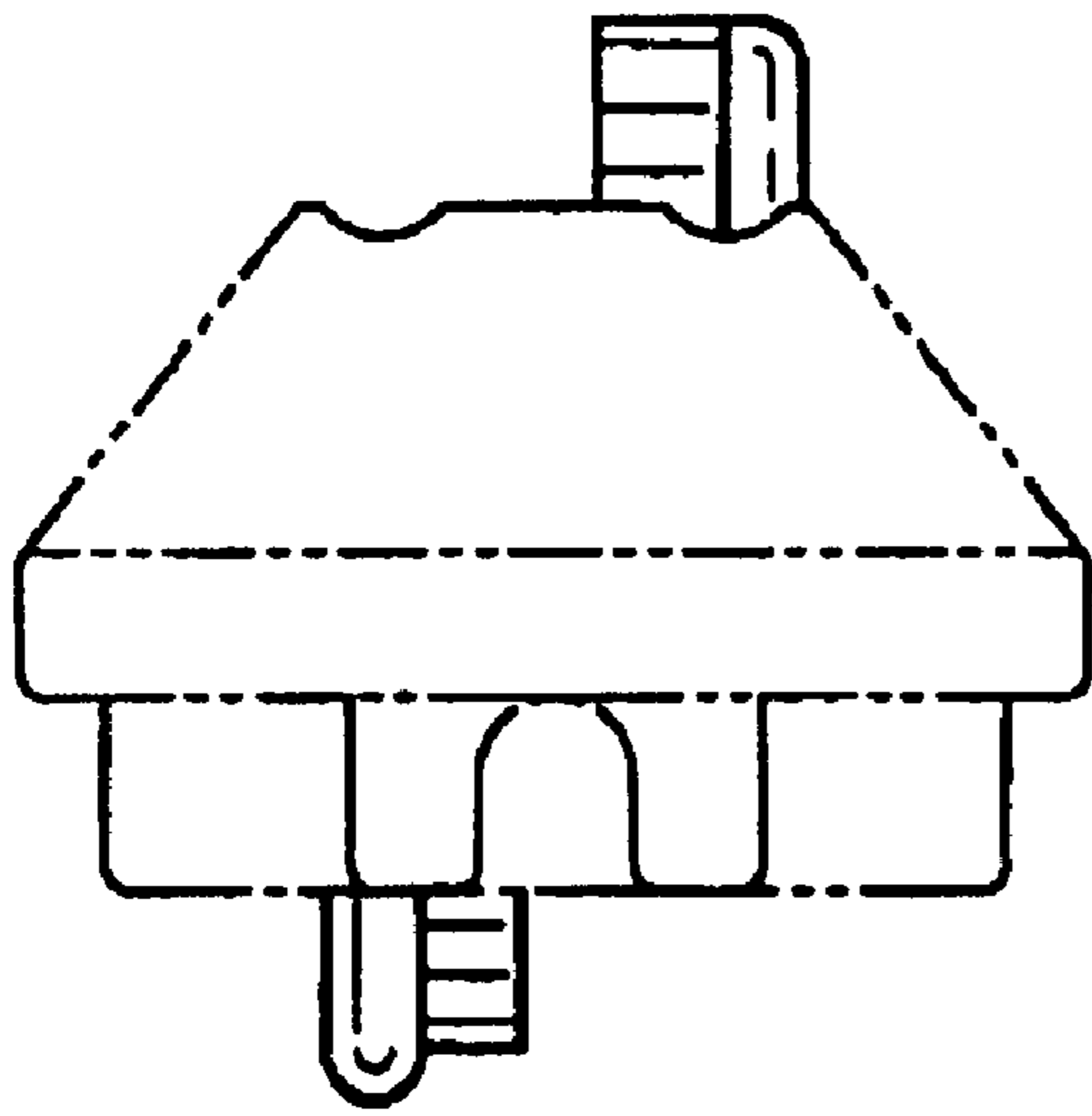

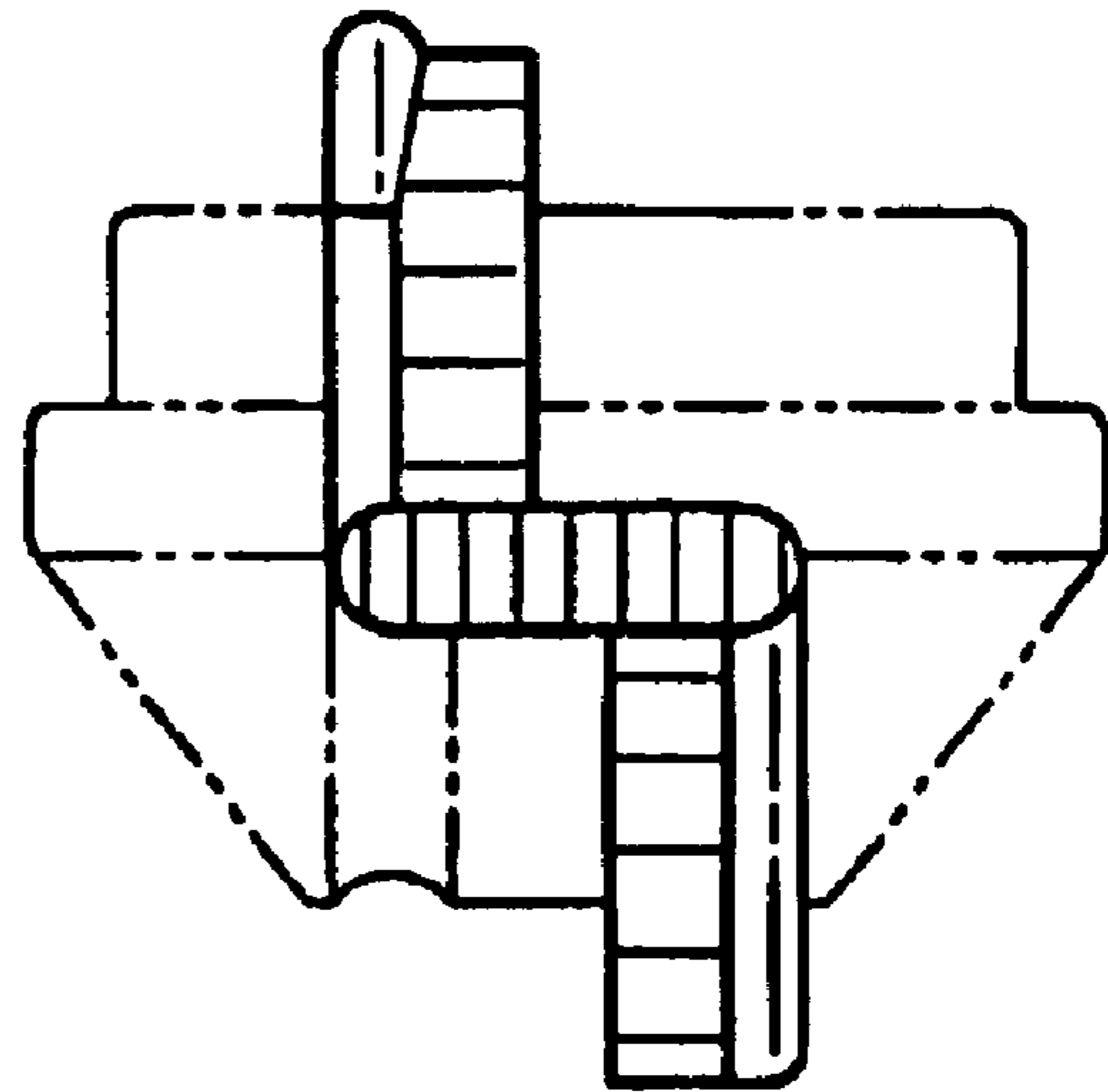
