I claim the ornamental design for a cap cover, as shown and described.

DESCRIPTION

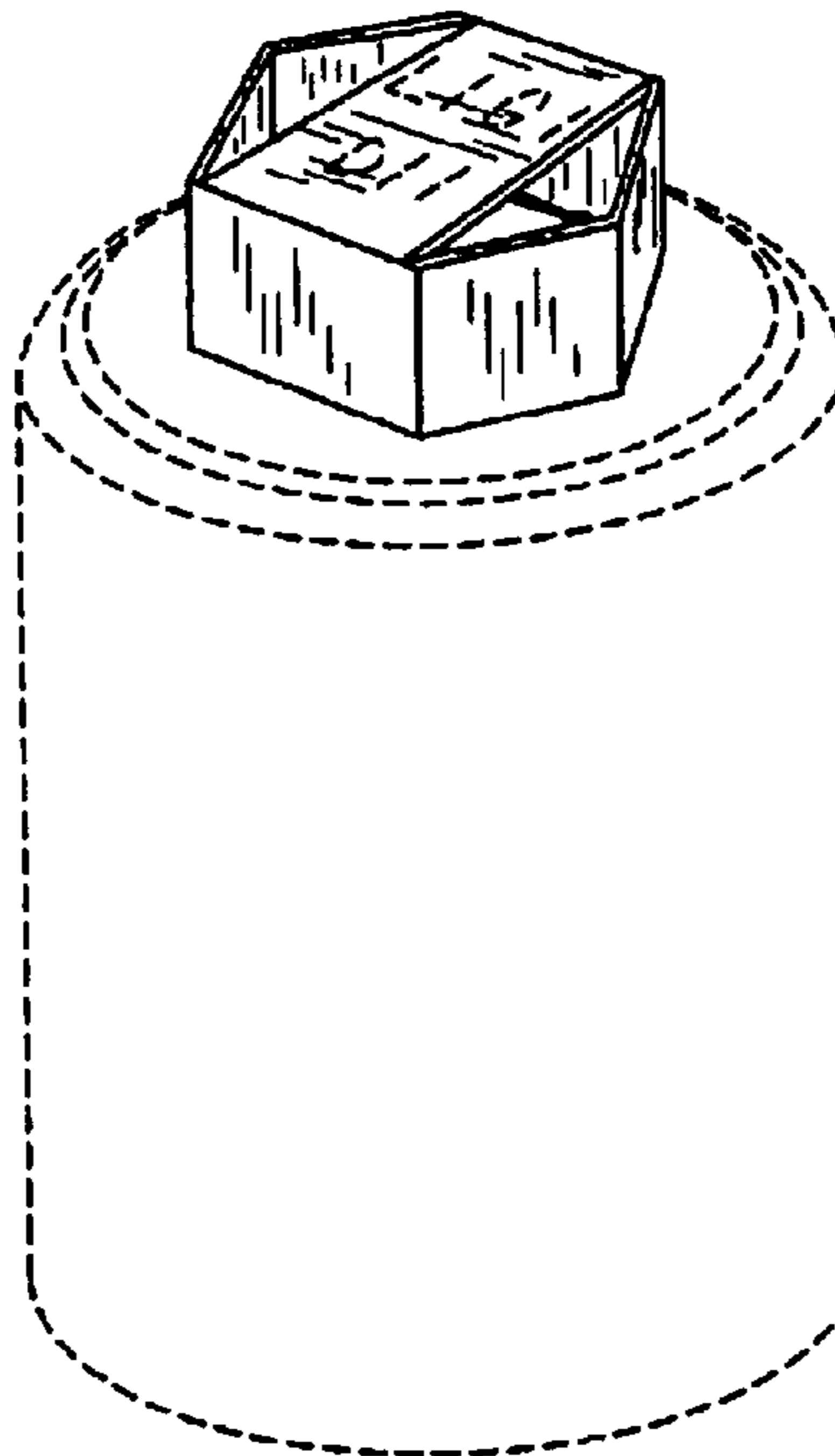
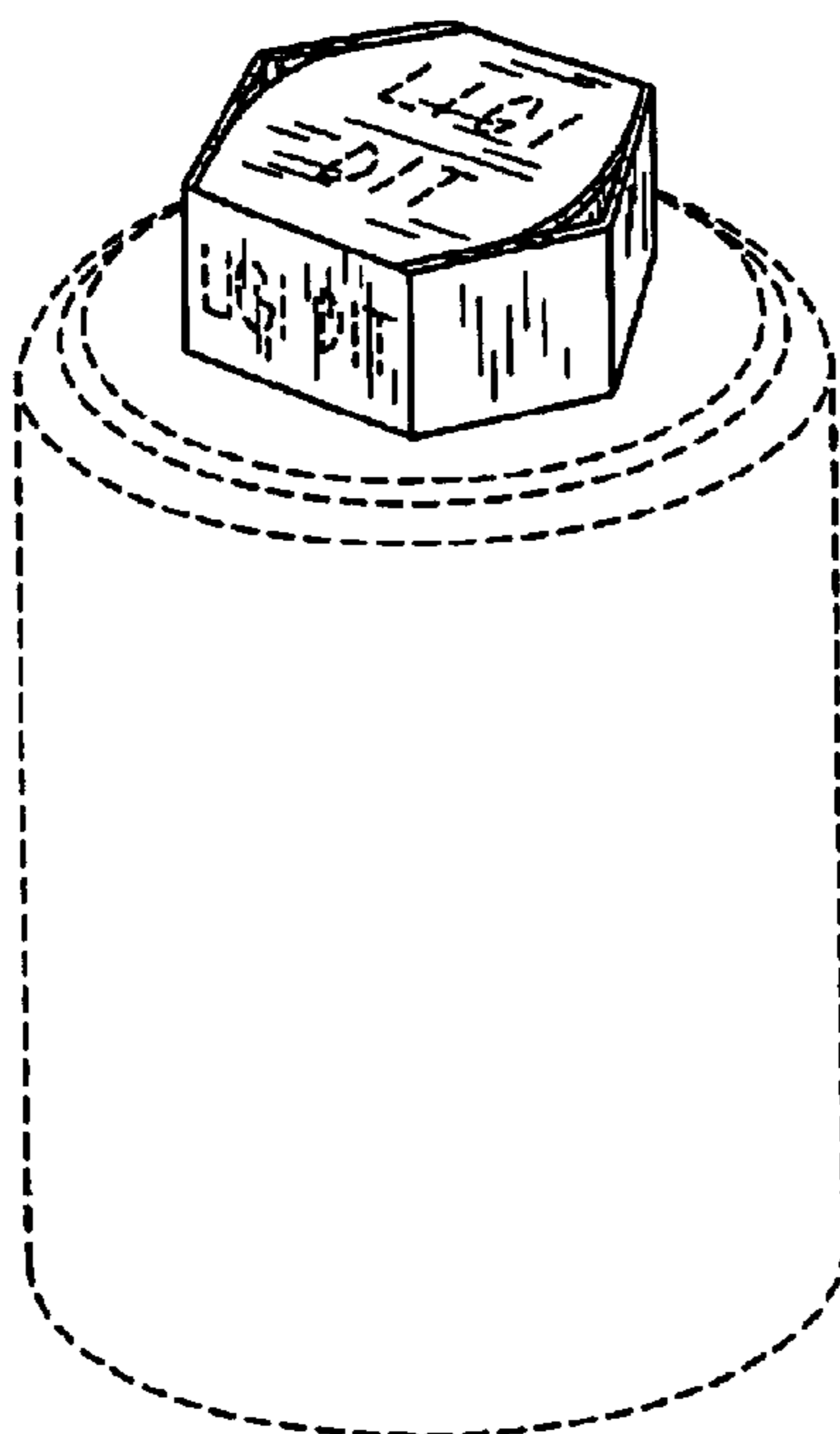
FIG. 1 is a perspective view of first embodiment of a cap cover of the present invention;
FIG. 2 is a top plan view of the cap cover shown in FIG. 1;
FIG. 3 is a bottom plan view of the cap cover of FIG. 1;
FIG. 4 is a front elevational view of the cap cover shown in FIG. 3, it being understood that the rear view is the same;
FIG. 5 is a perspective view of a second embodiment of a cap cover of the present invention;
FIG. 6 is a top plan view of the cap cover shown in FIG. 5;
FIG. 7 is a bottom plan view of the cap cover of FIG. 5; and,
FIG. 8 is a front elevational view of the cap cover shown in FIG. 6, it being understood that the rear view is the same.

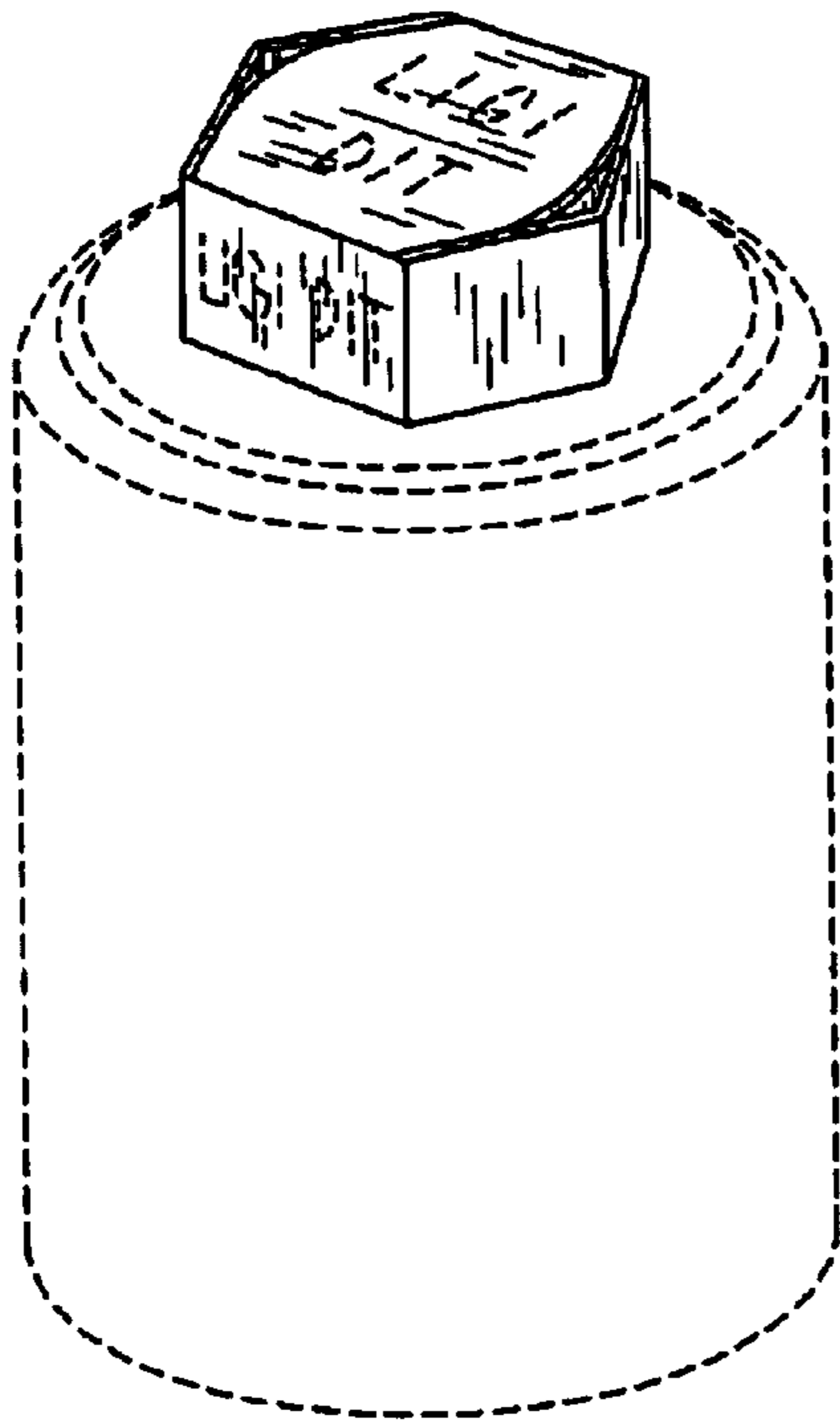

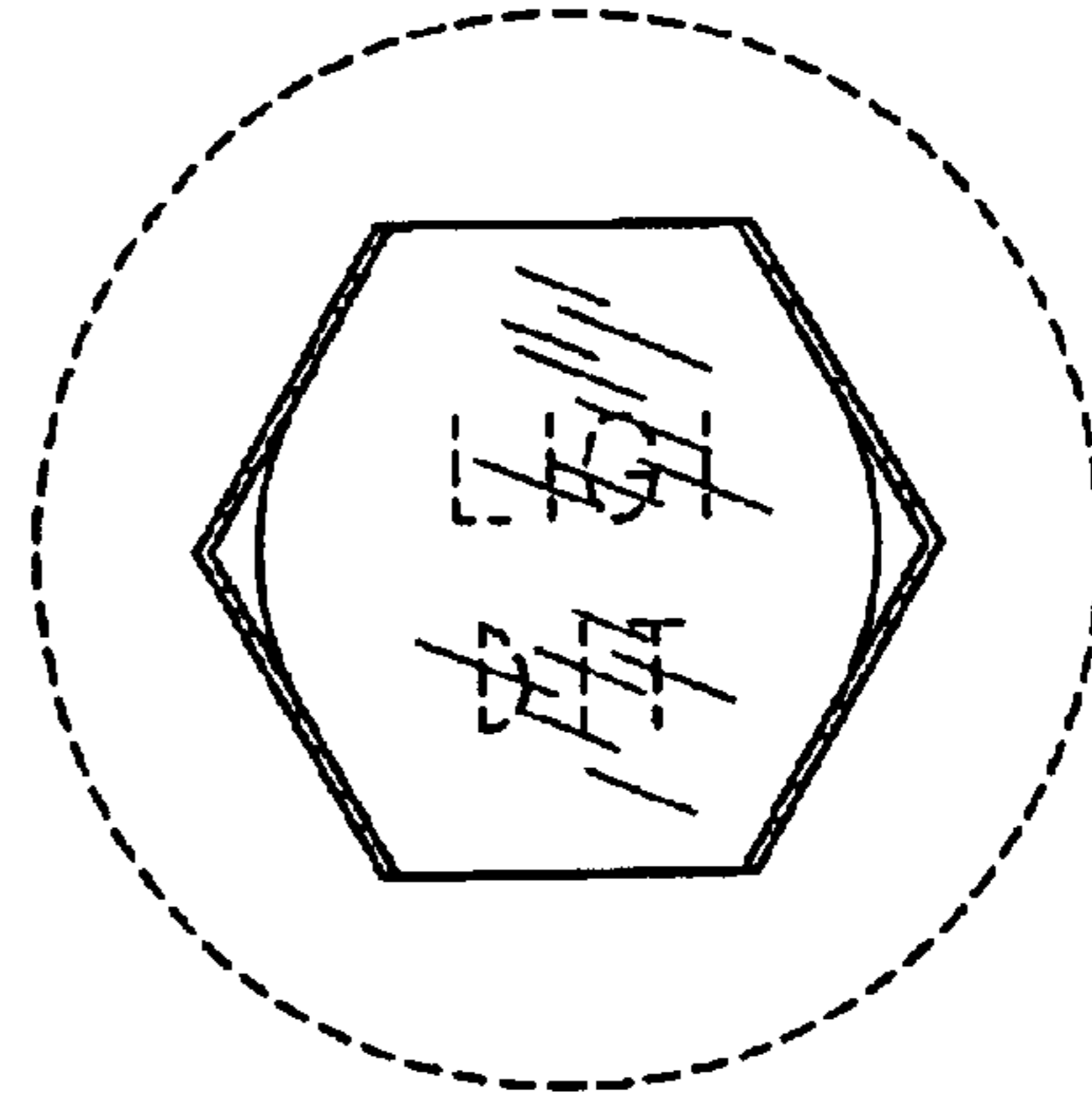

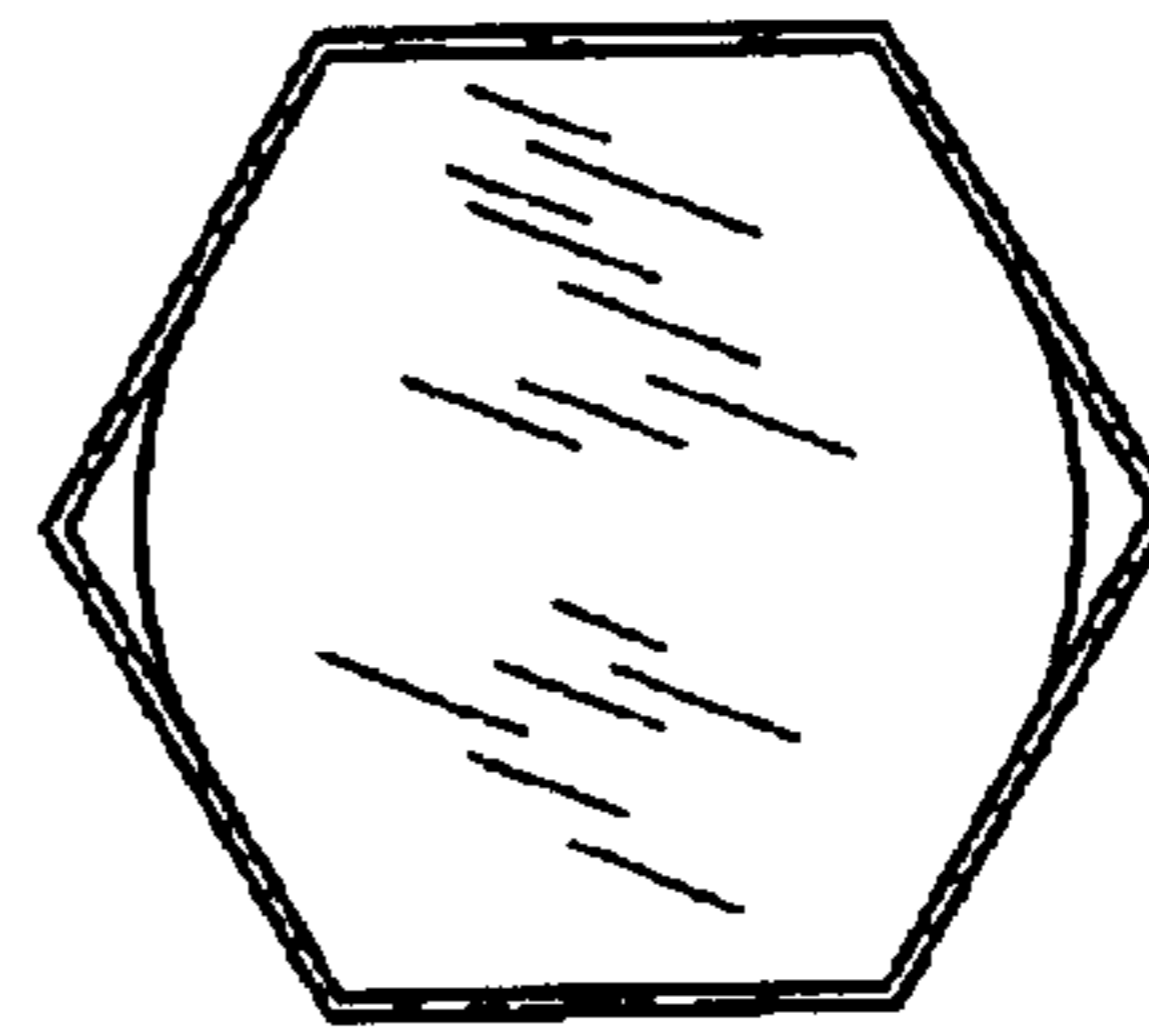

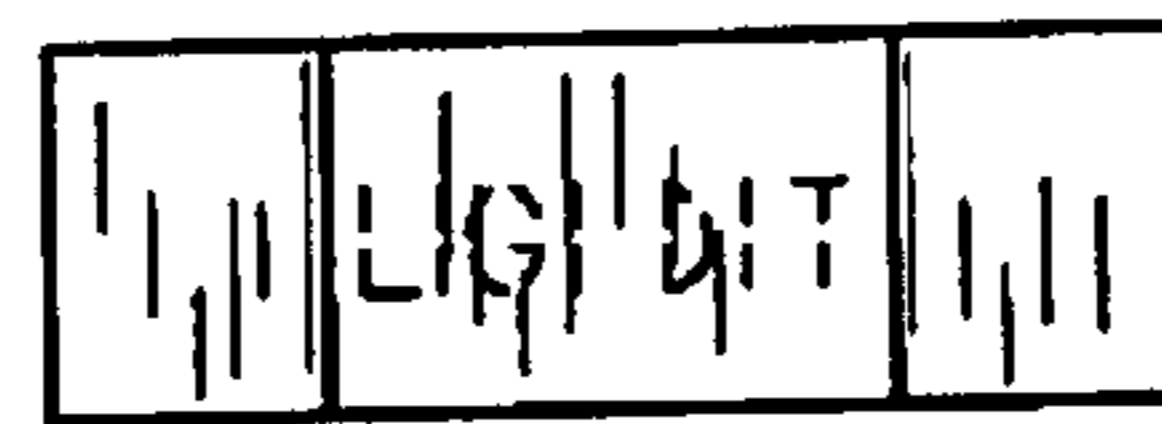

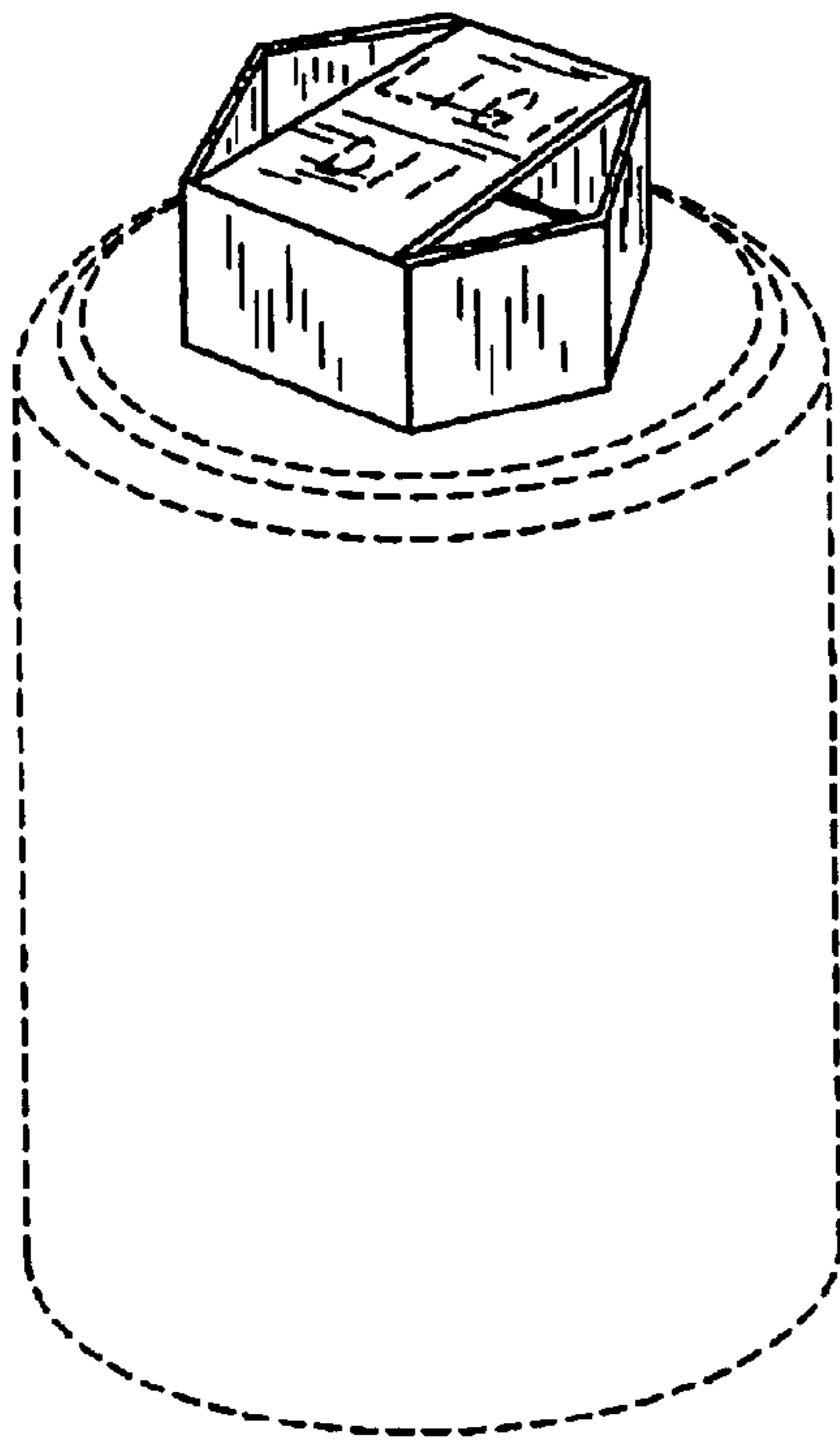

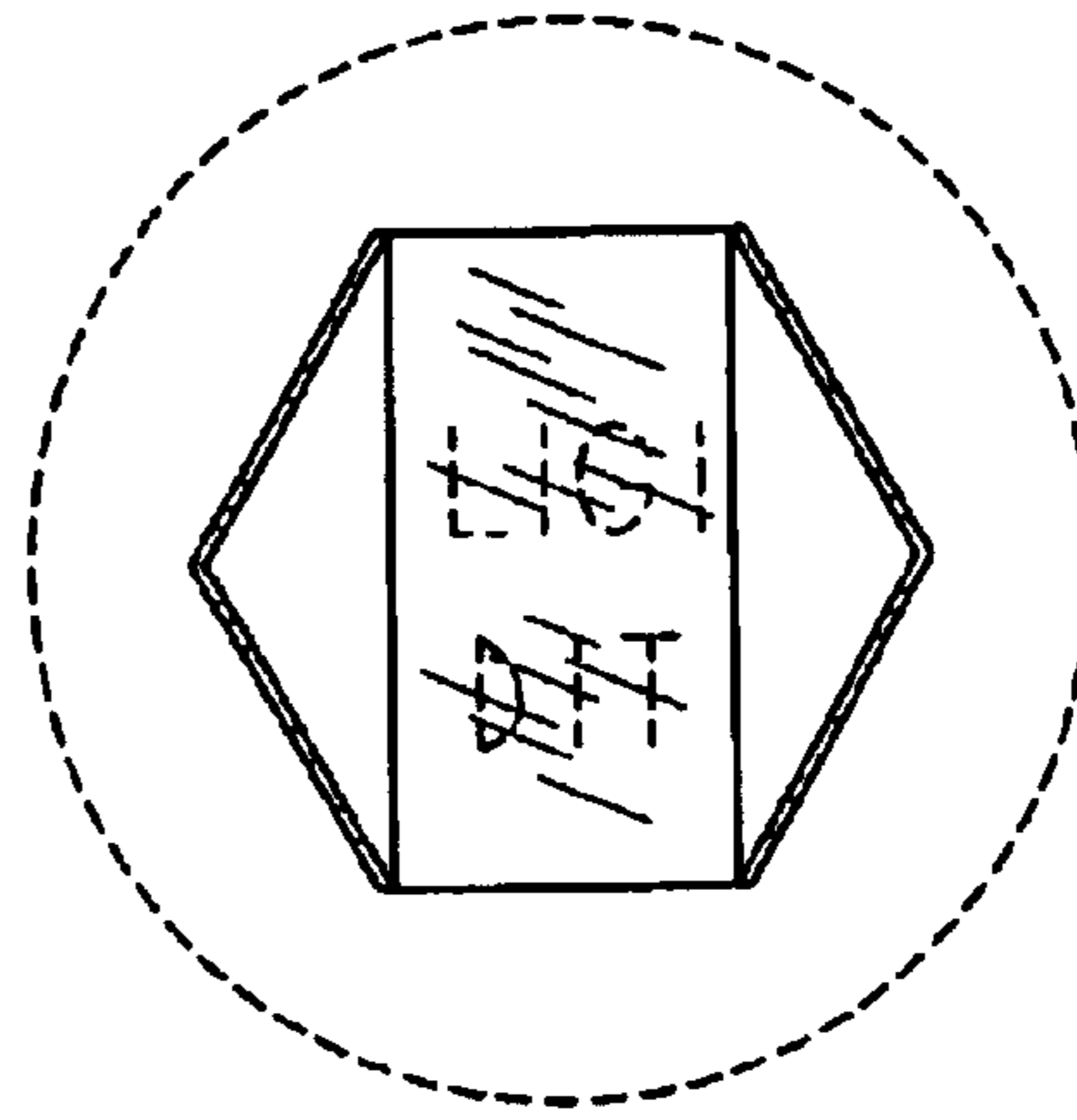

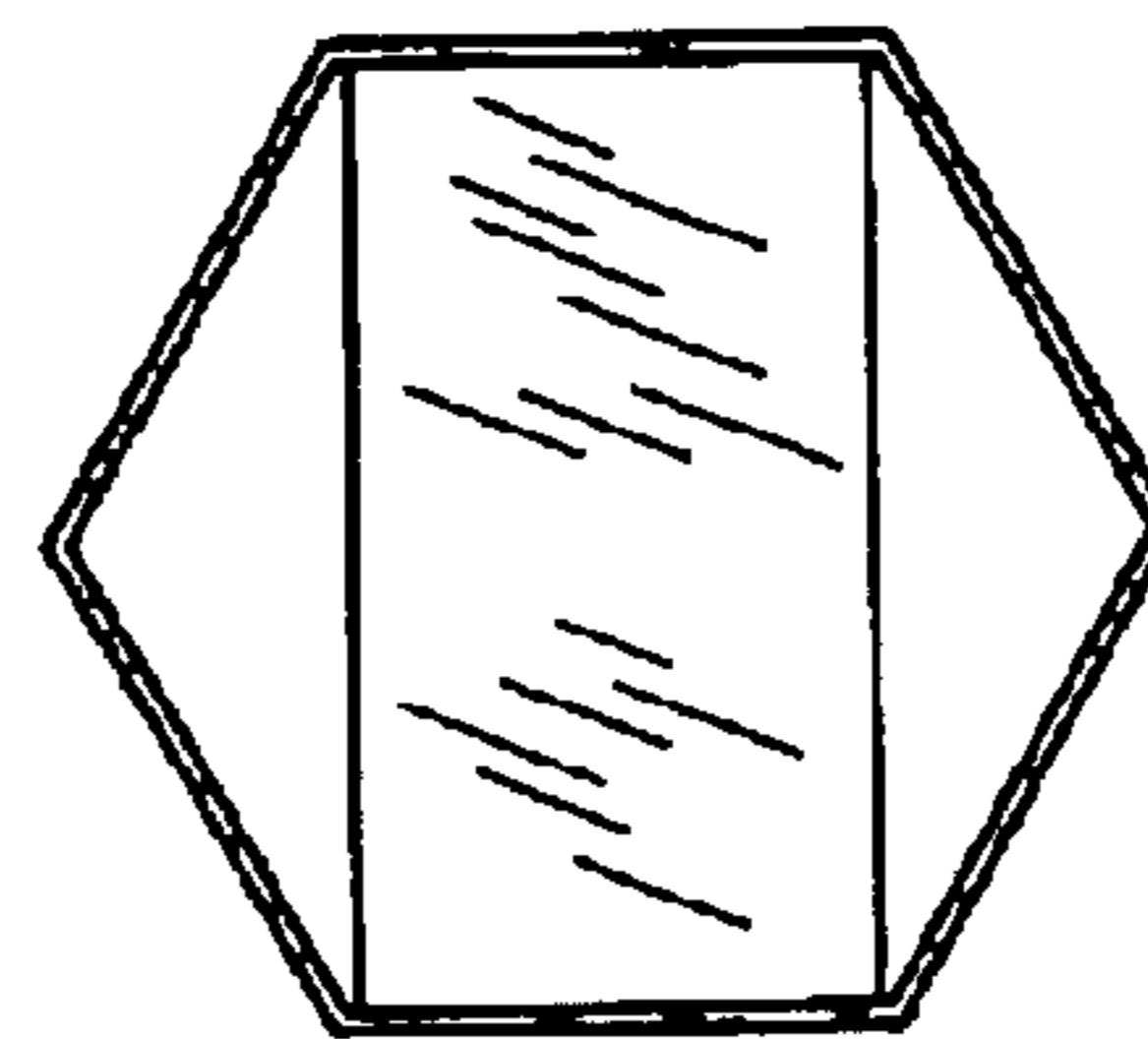
