(57) **CLAIM**

The ornamental design for skis that attach to a scooter, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a front ski and a rear ski that respectively attach to a front and a rear portion of a scooter, with broken lines showing typical adjoining structures, including a scooter, for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is a front view of the front ski;

FIG. 3 is a rear view of the front ski;

FIG. 4 is a right side view of the front ski;

FIG. 5 is left side view of the front ski;

FIG. 6 is top plan view of the front ski;

FIG. 7 is a bottom plan view of the front ski;

FIG. 8 is a front view of the rear ski;

FIG. 9 is rear view of the rear ski;

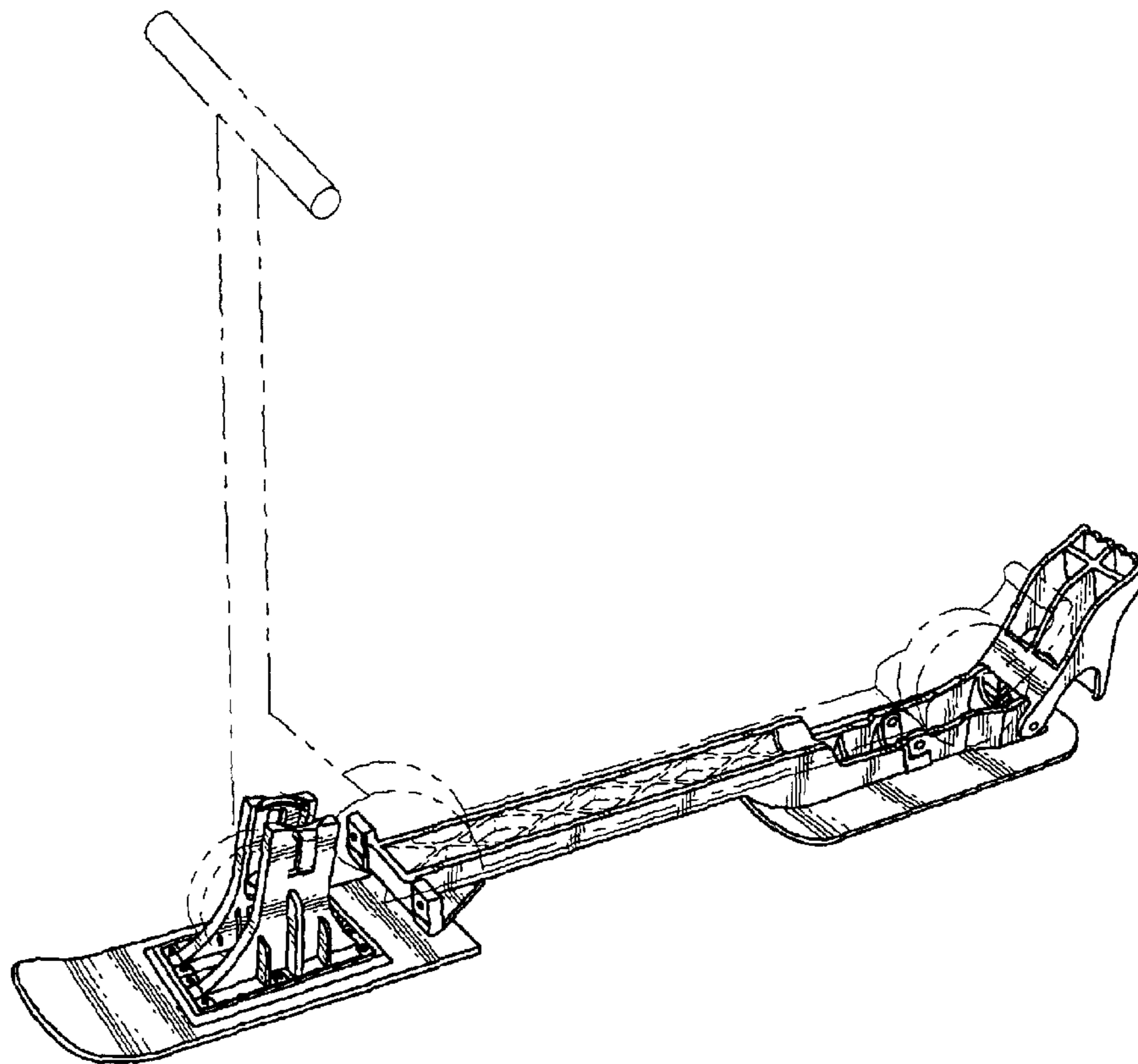
FIG. 10 is left side view of the rear ski;

FIG. 11 is a right side view of the rear ski;

FIG. 12 is top plan view of the rear ski, with a broken line showing adjoining structure for illustrative purposes only and forming no part of the claimed design; and,

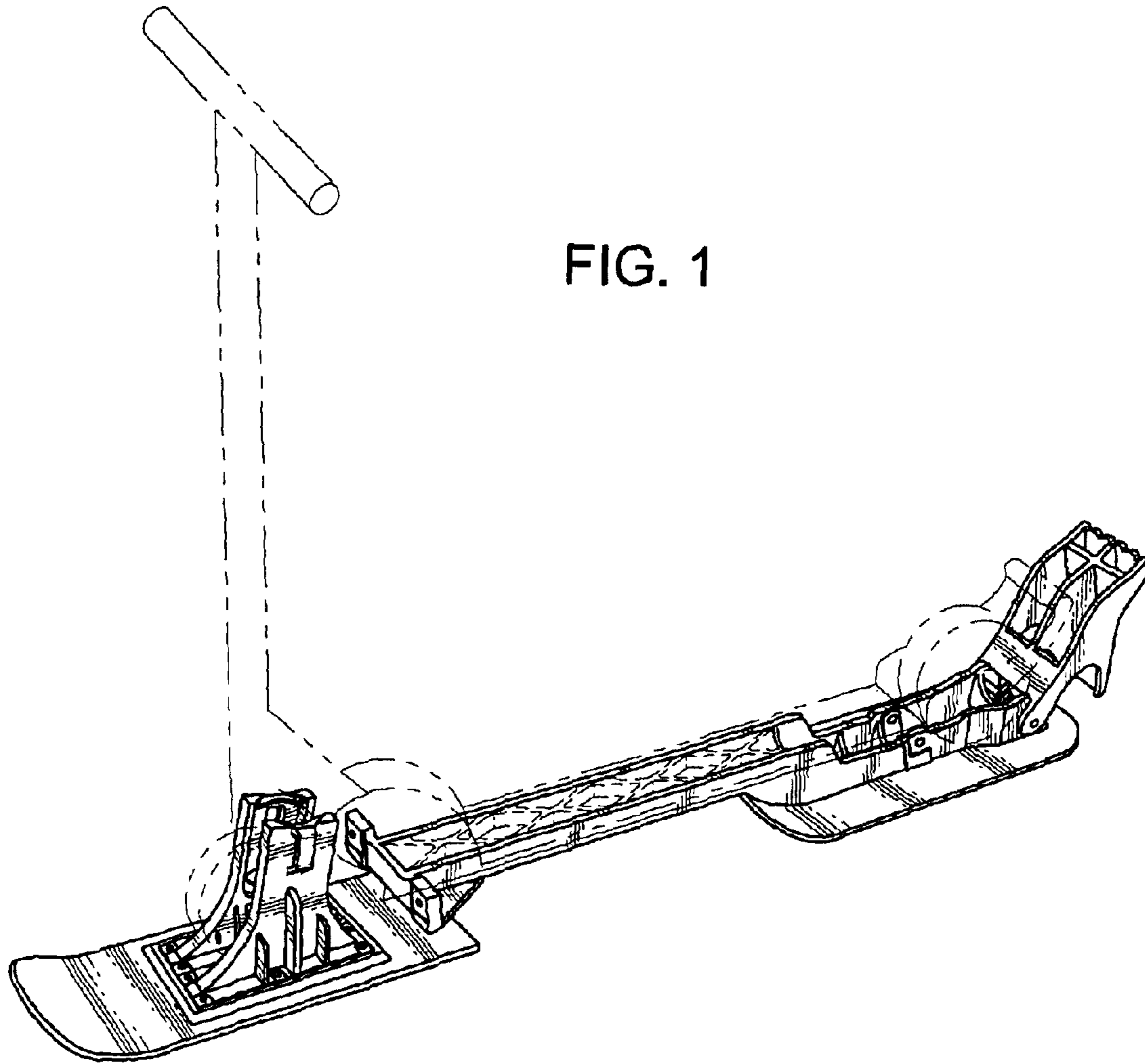

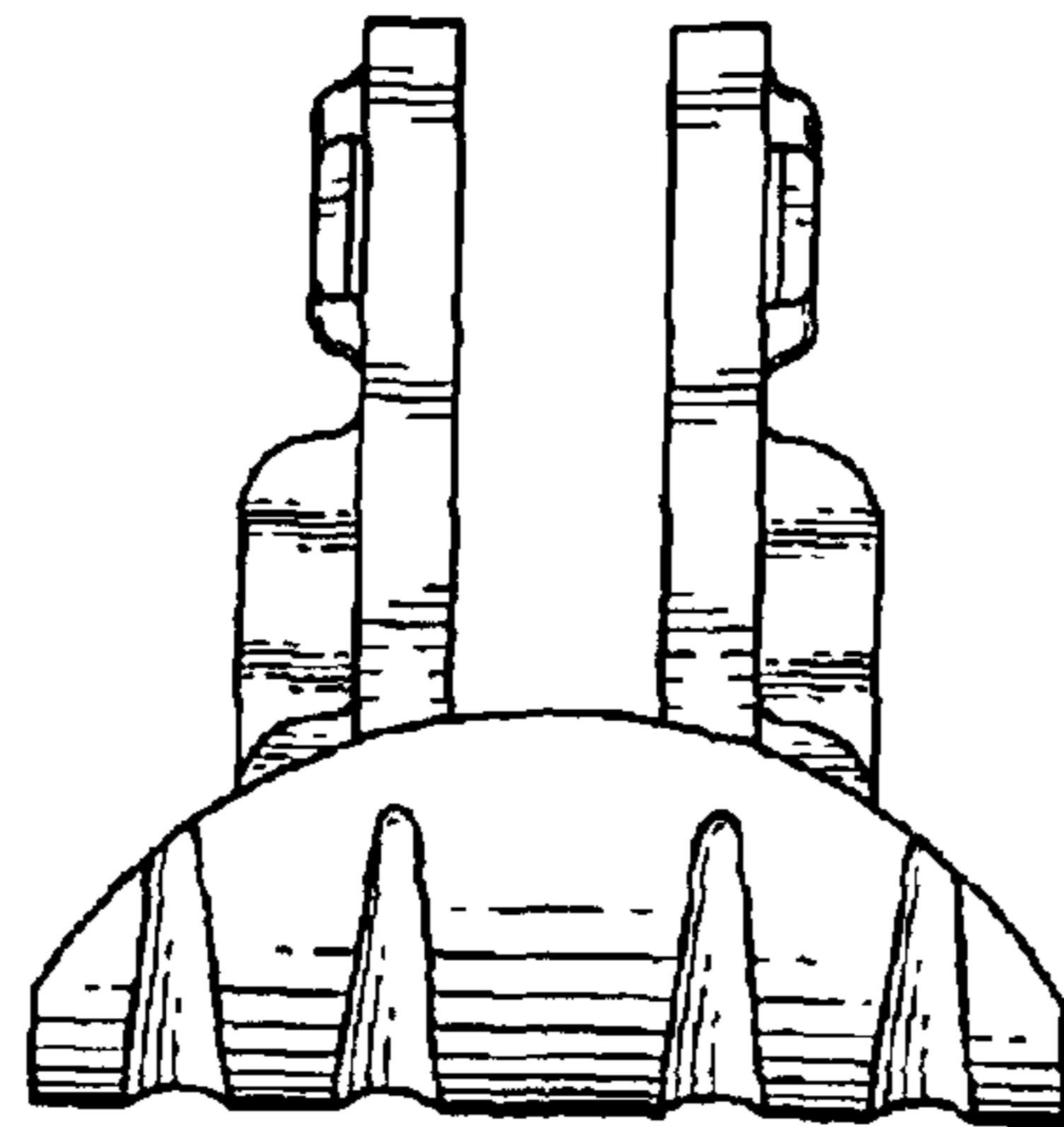
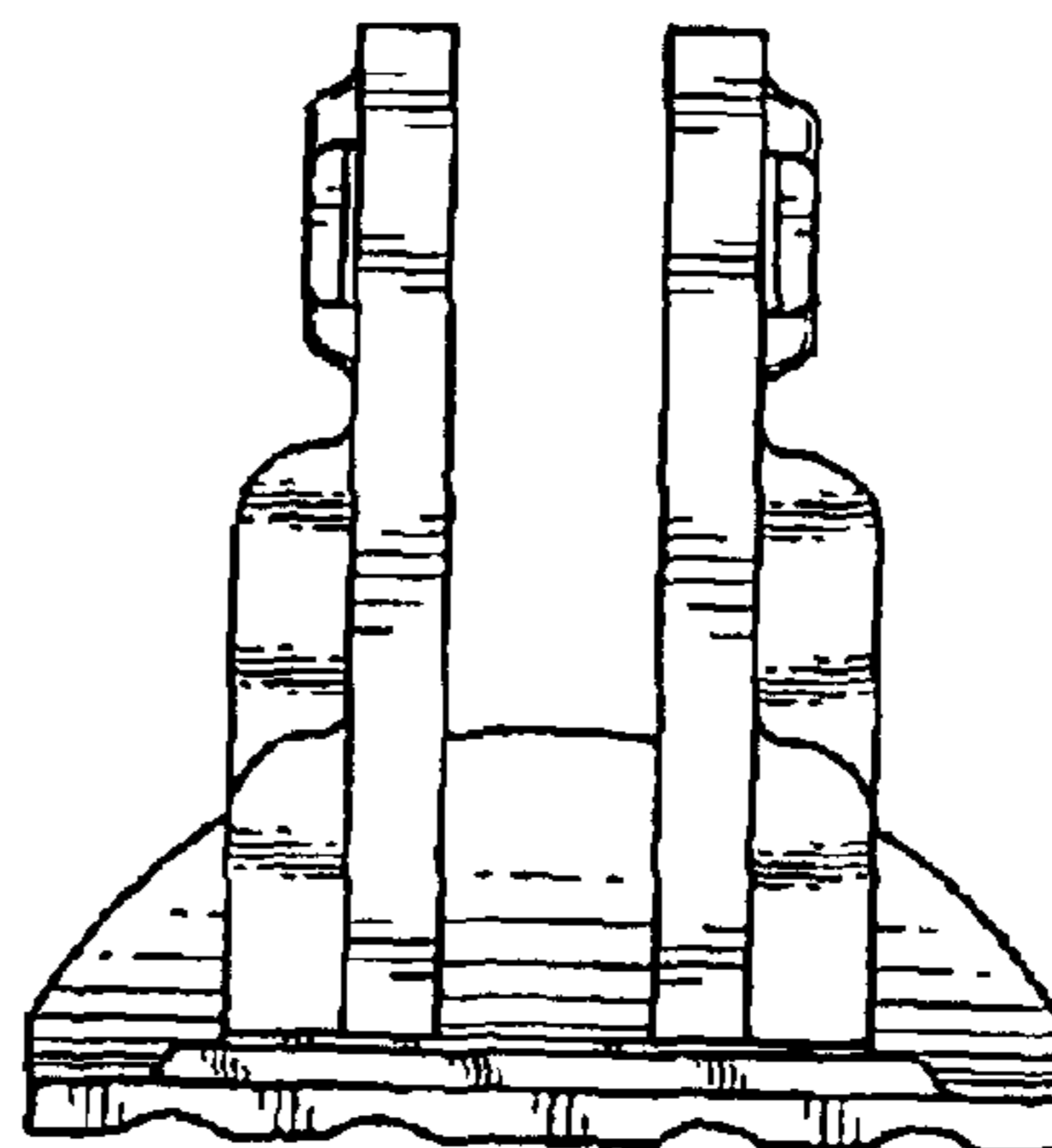

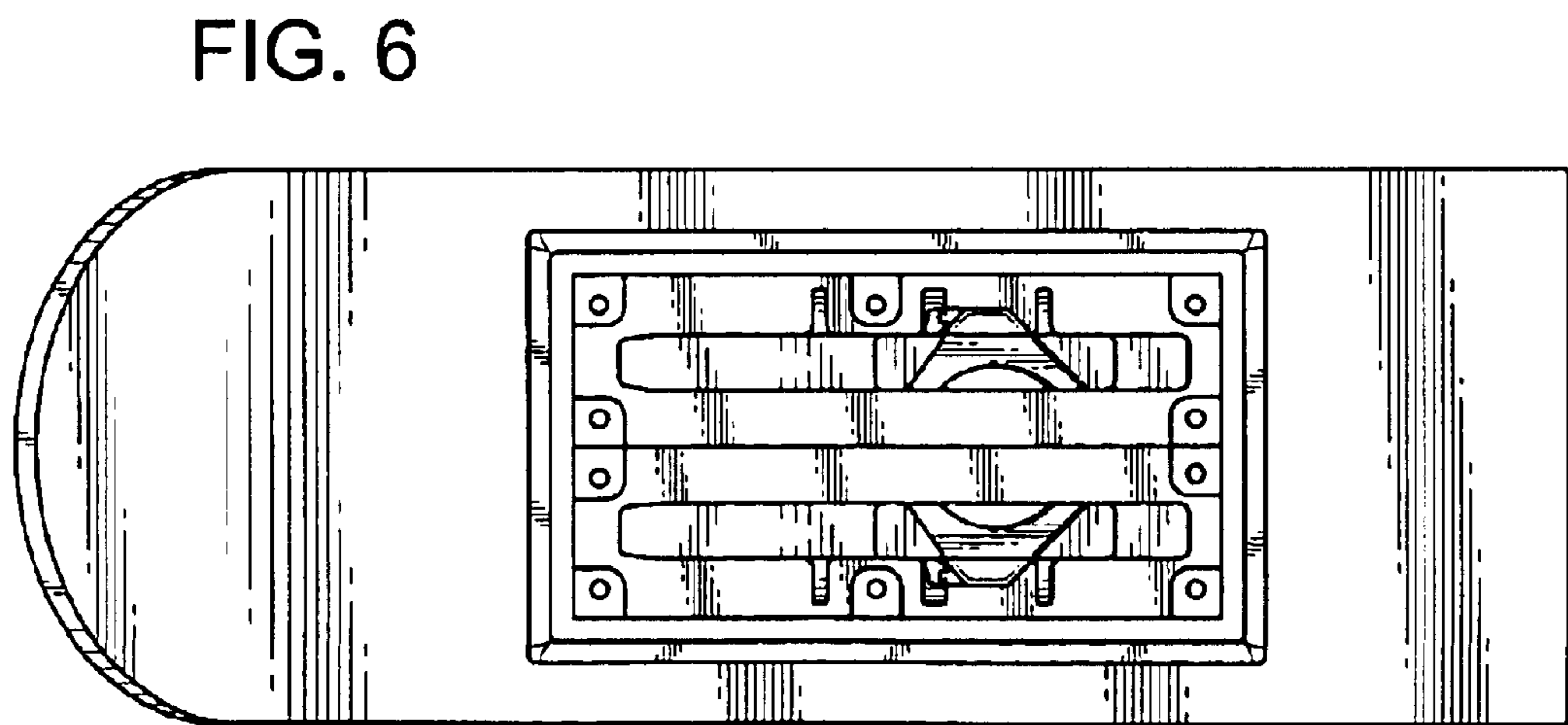
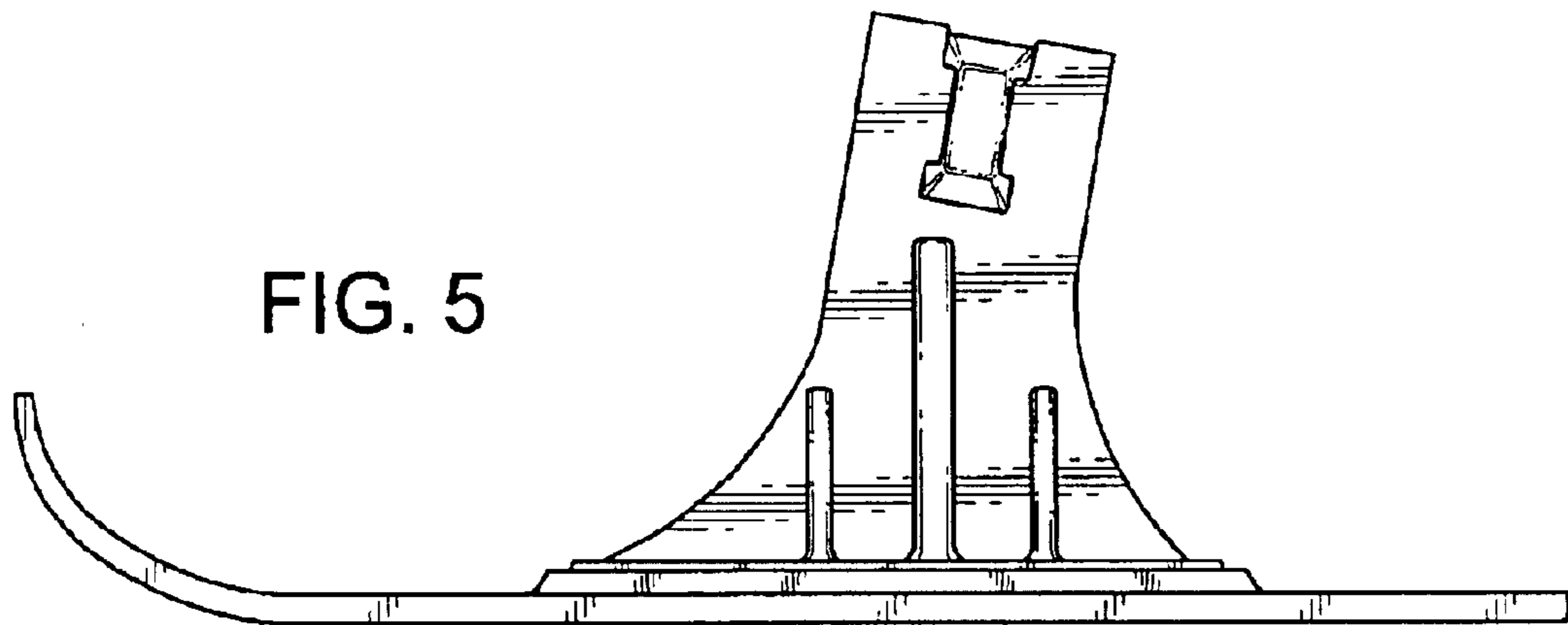
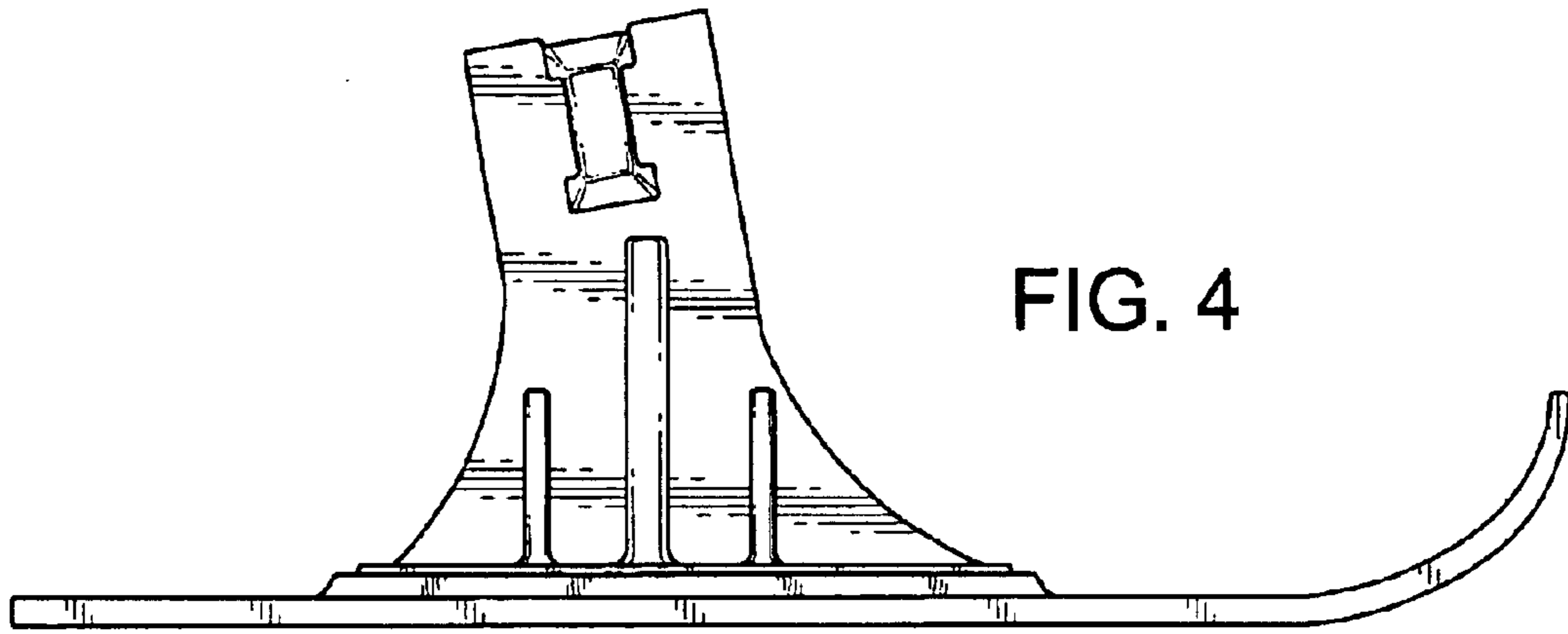

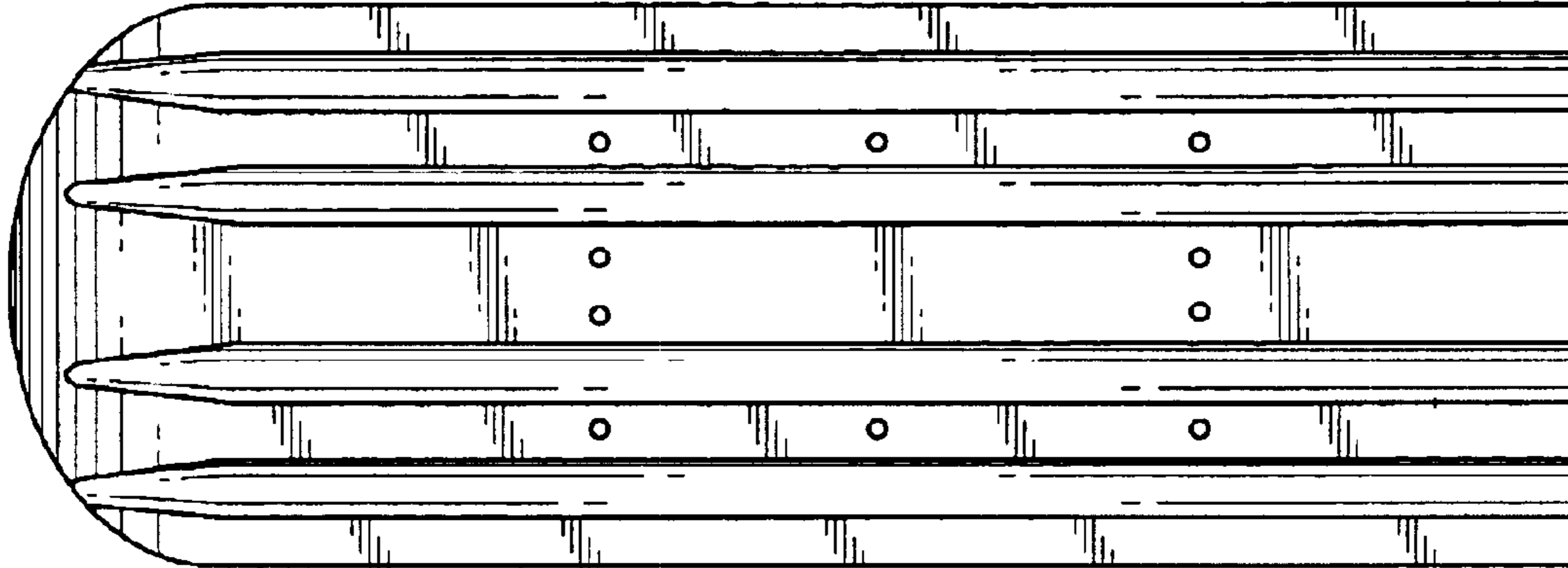

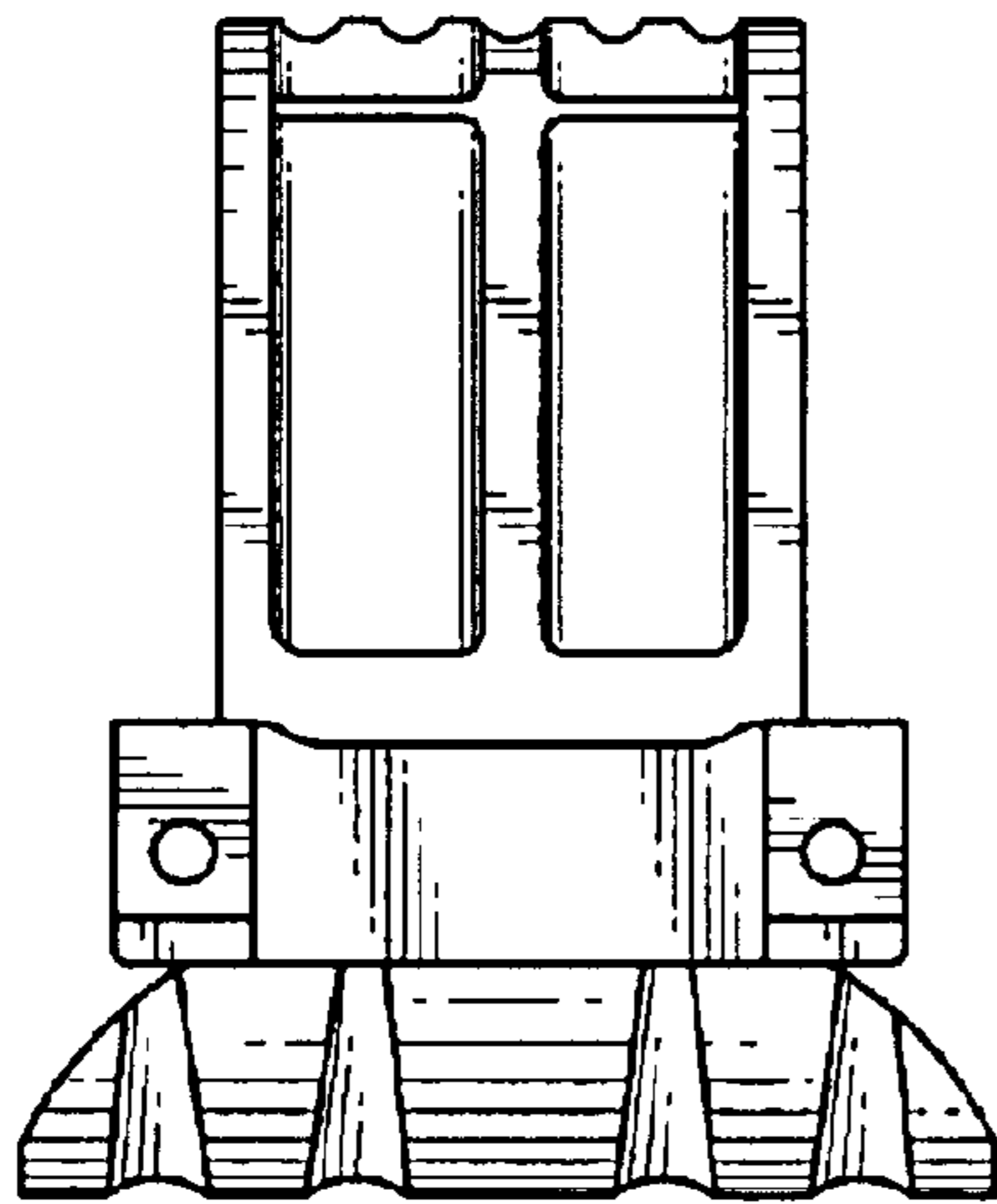
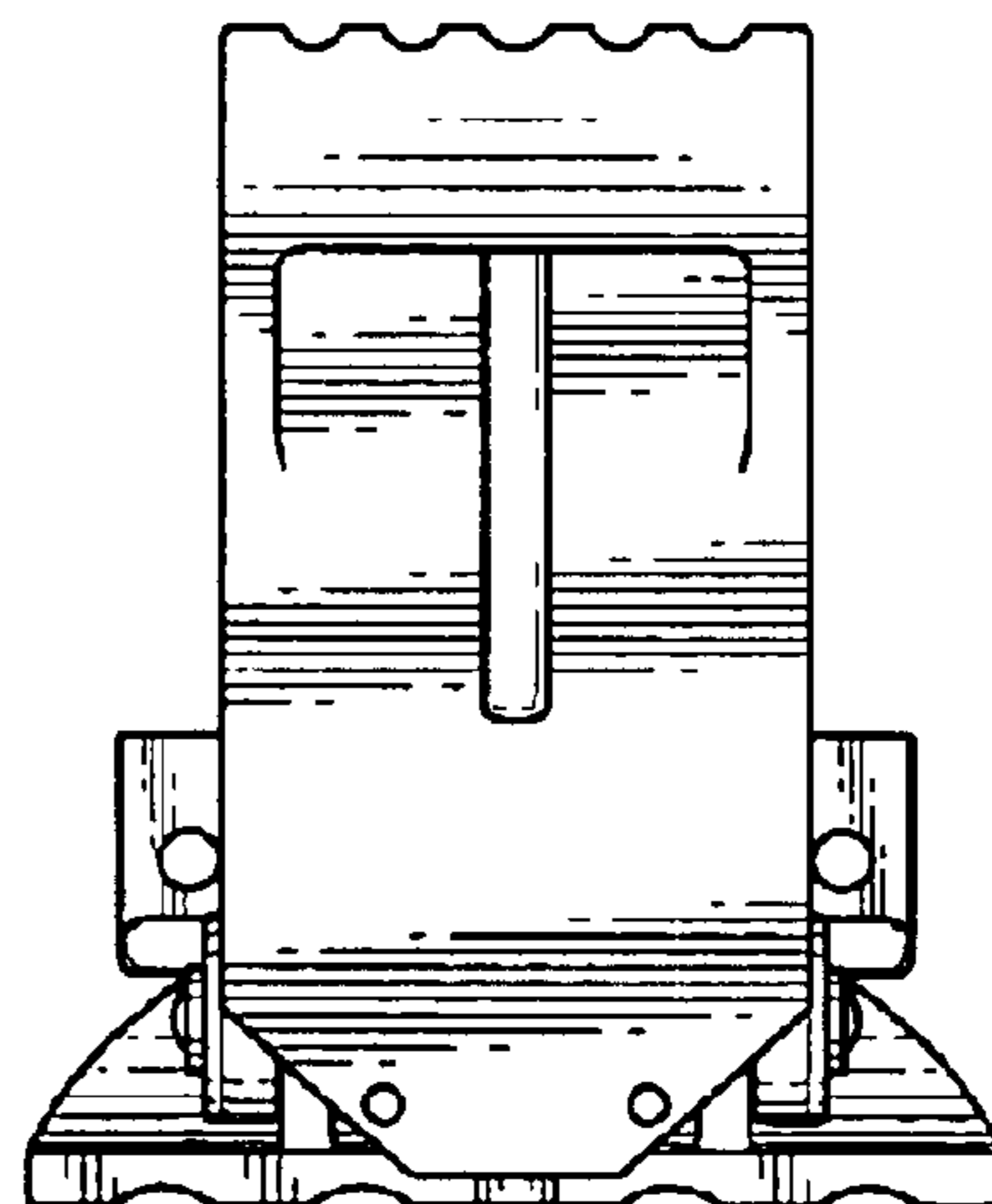

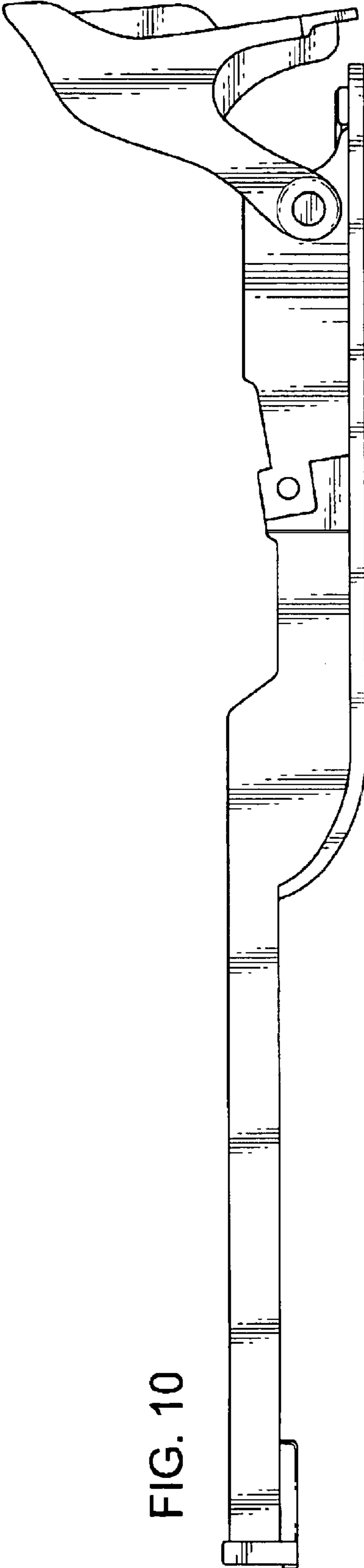

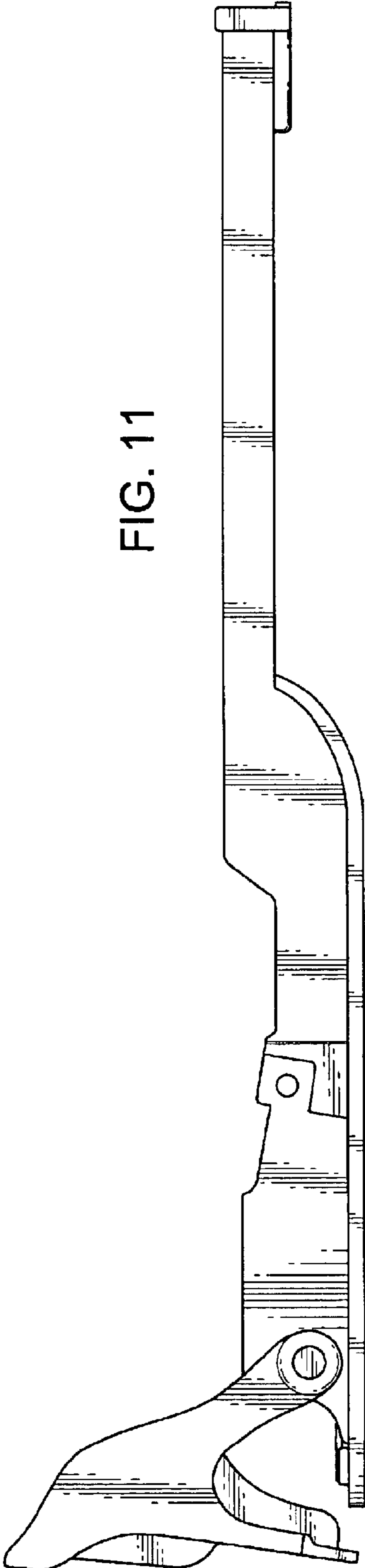
