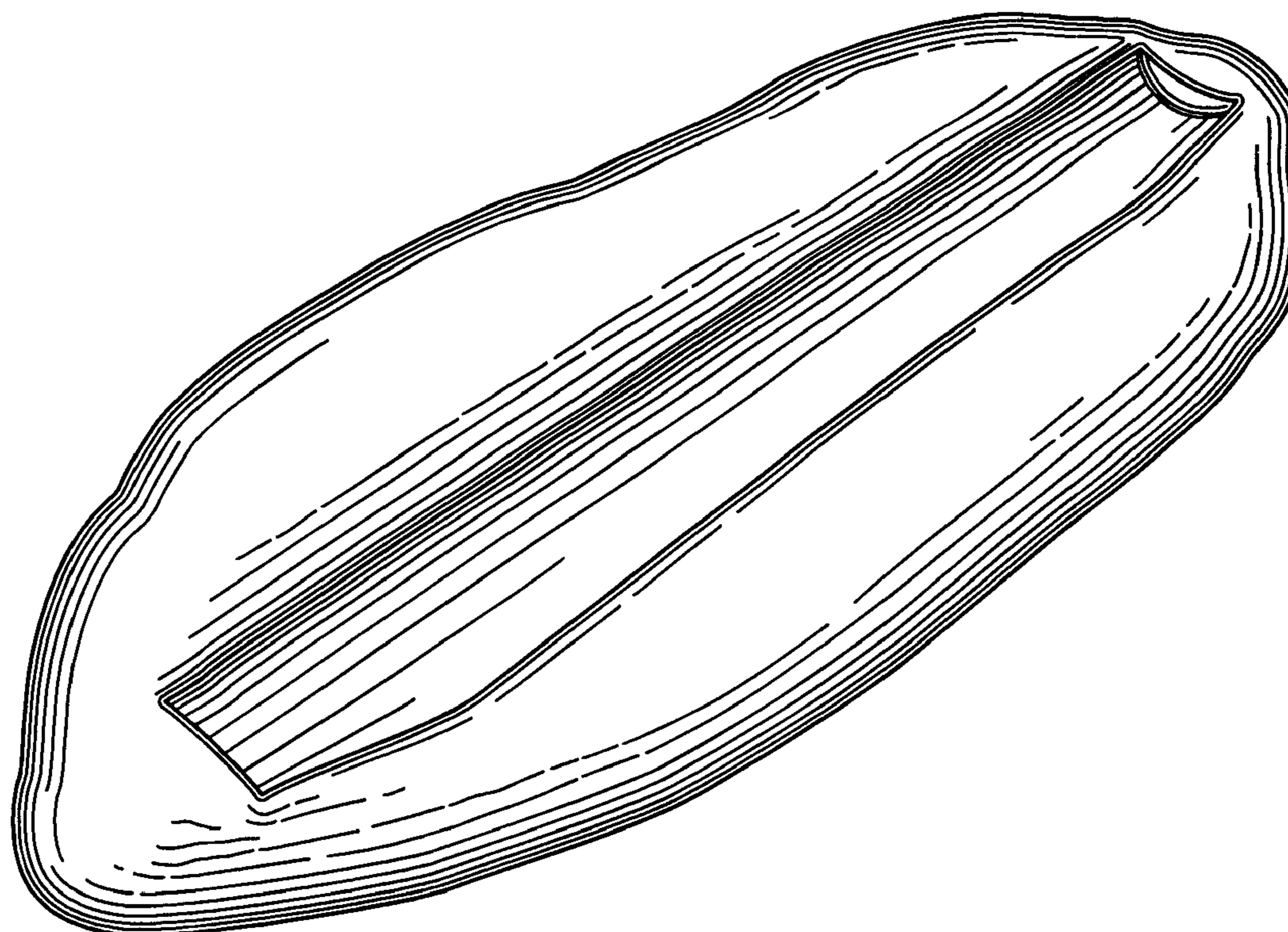
(57) **CLAIM**

The ornamental design for a bread shell, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bread shell in accordance with my design;
FIG. 2 is a top plan view of the bread shell of FIG. 1;
FIG. 3 is a bottom plan view of the bread shell of FIG. 1;
FIG. 4 is a left side view of the bread shell of FIG. 1;
FIG. 5 is a right side view of the bread shell of FIG. 1;
FIG. 6 is a front end view of the bread shell of FIG. 1;
FIG. 7 is a rear end view of the bread shell of FIG. 1;
FIG. 8 is a perspective view of the bread shell of FIG. 1 showing a hot dog in phantom lines disposed thereon;
FIG. 9 is a front perspective view of an alternate embodiment of a bread shell in accordance with my design;
FIG. 10 is a top plan view of the bread shell of FIG. 9;
FIG. 11 is a bottom plan view of the bread shell of FIG. 9;
FIG. 12 is a left side view of the bread shell of FIG. 9;
FIG. 13 is a right side view of the bread shell of FIG. 9;
FIG. 14 is a front end view of the bread shell of FIG. 9; and,
FIG. 15 is a rear end view of the bread shell of FIG. 9.

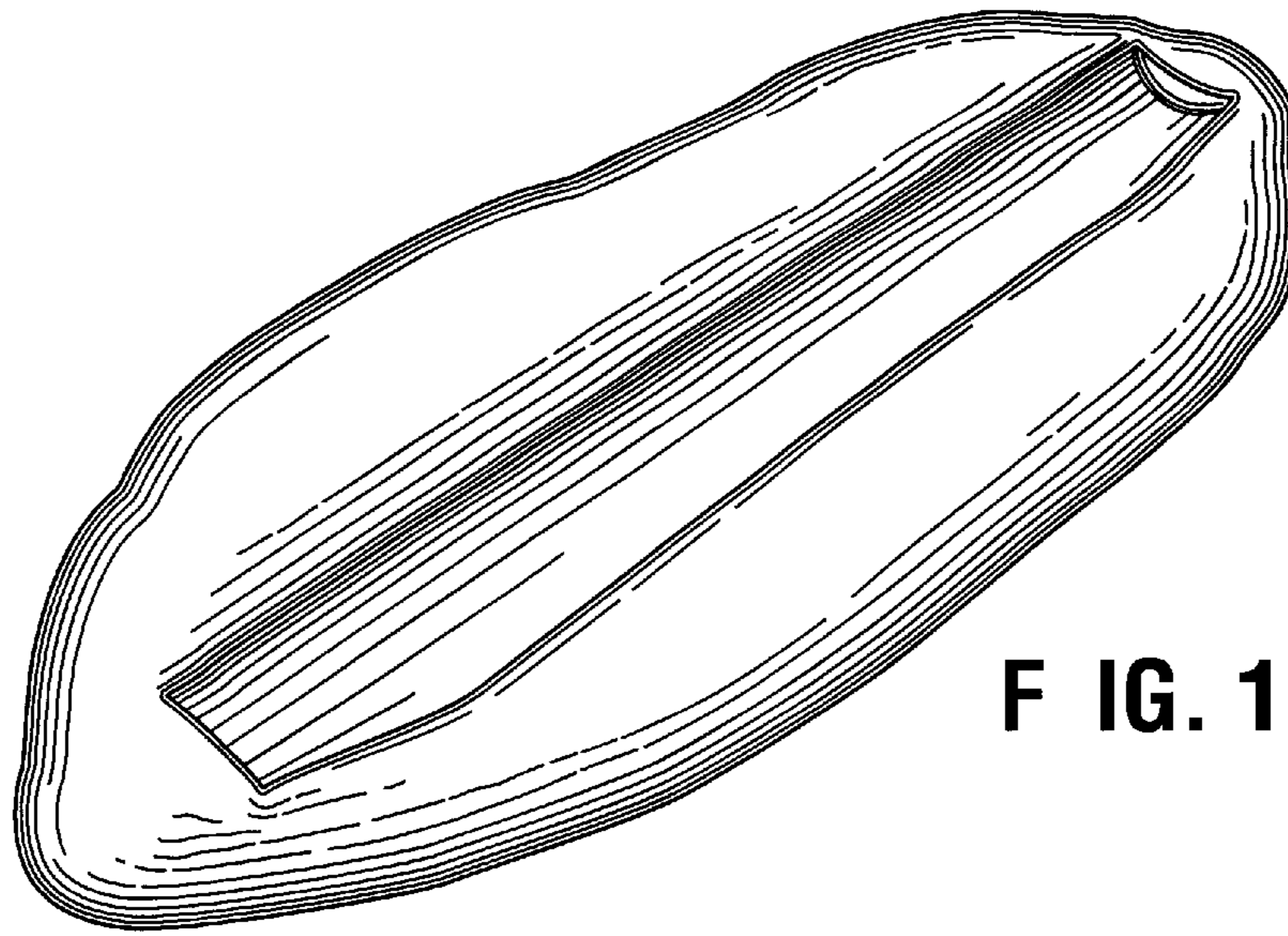

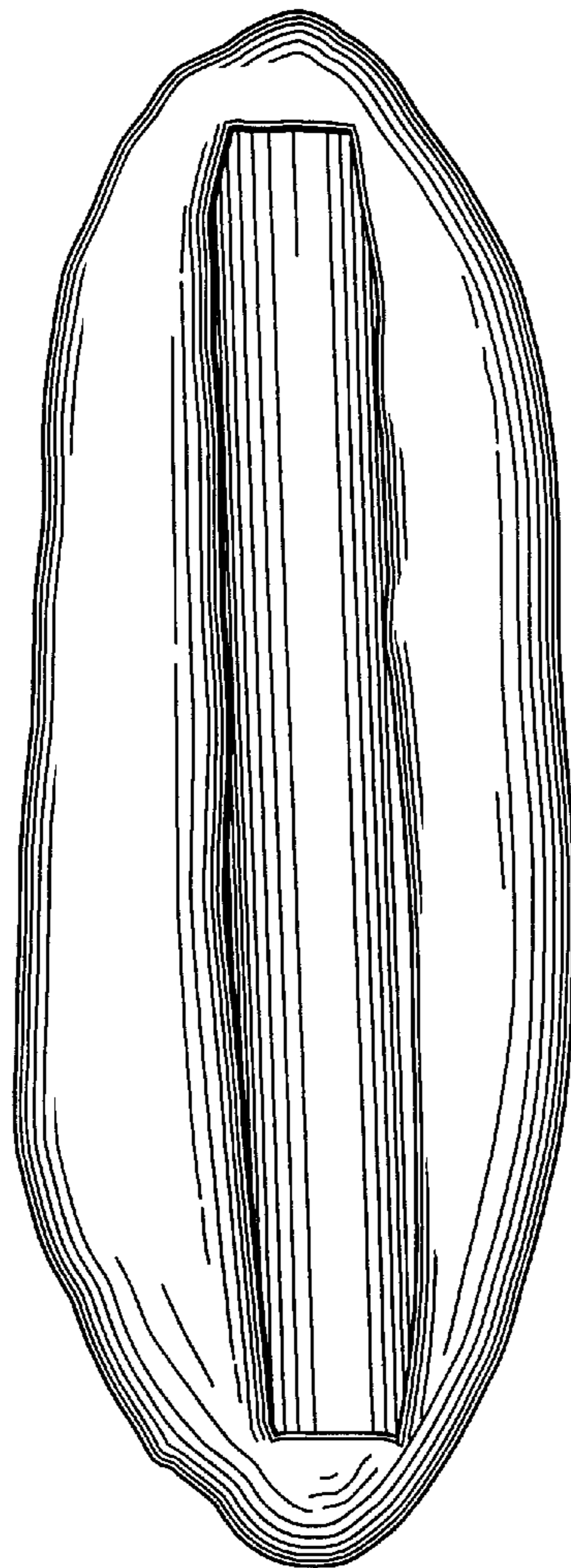

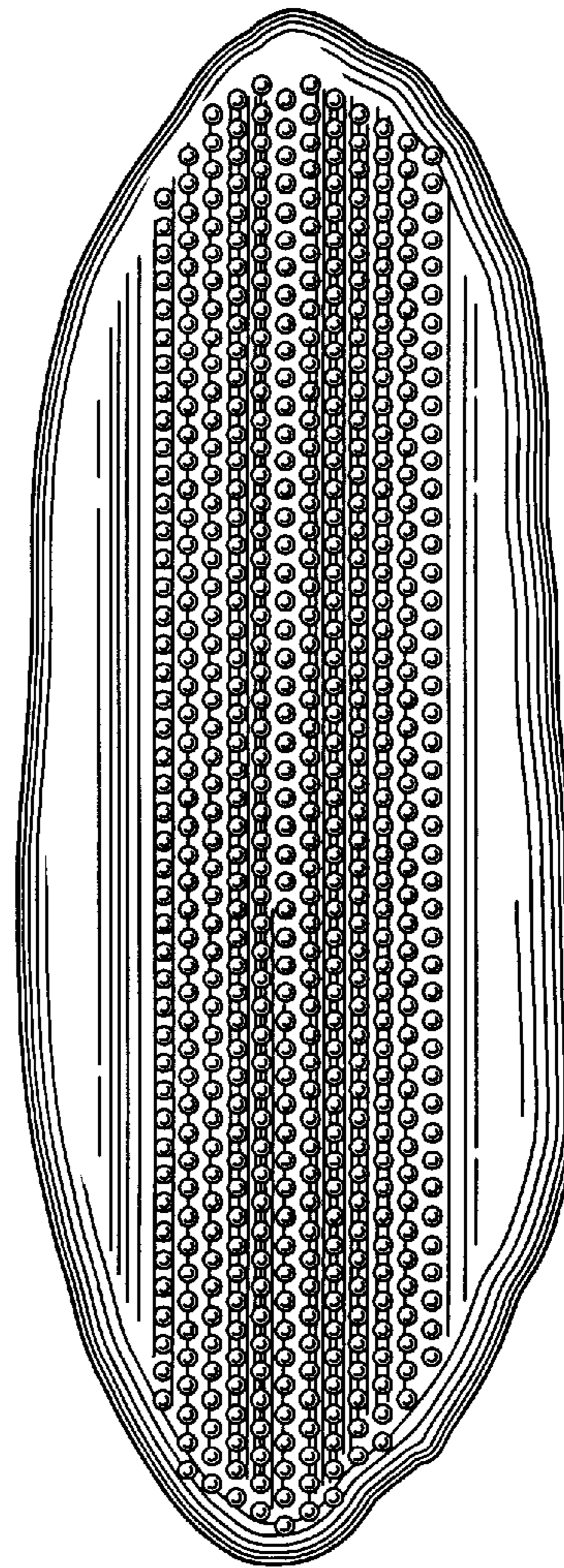

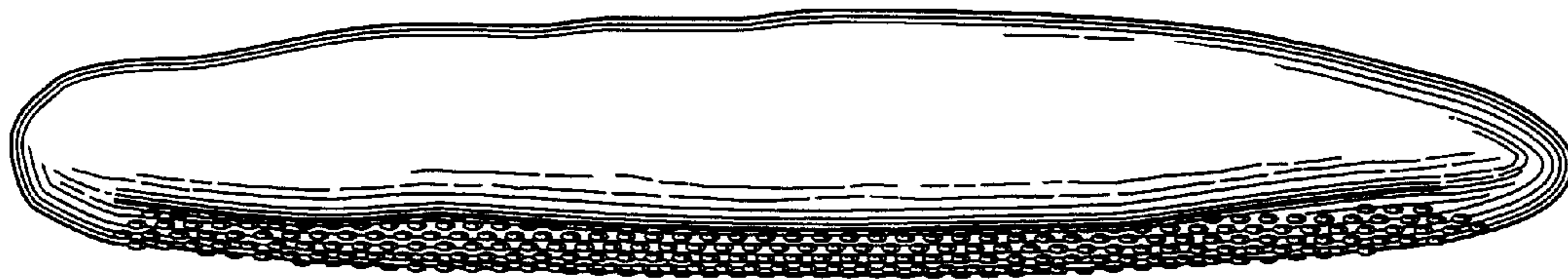

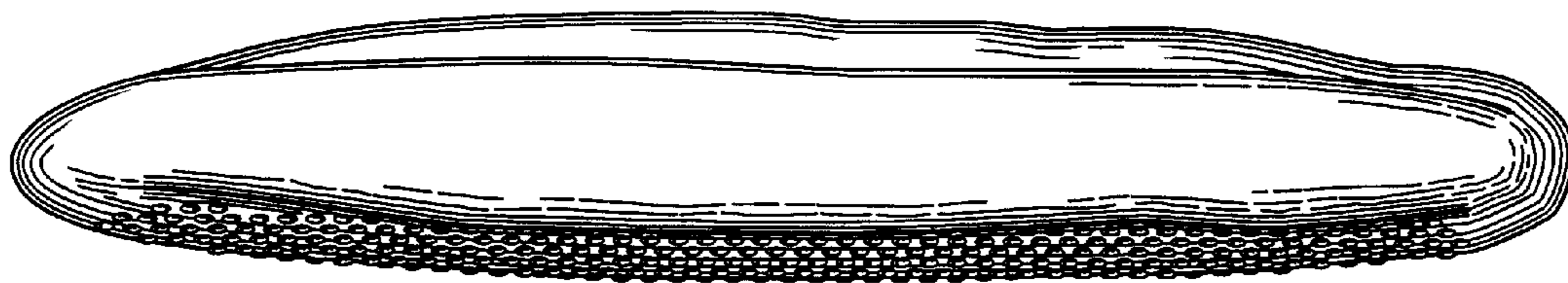

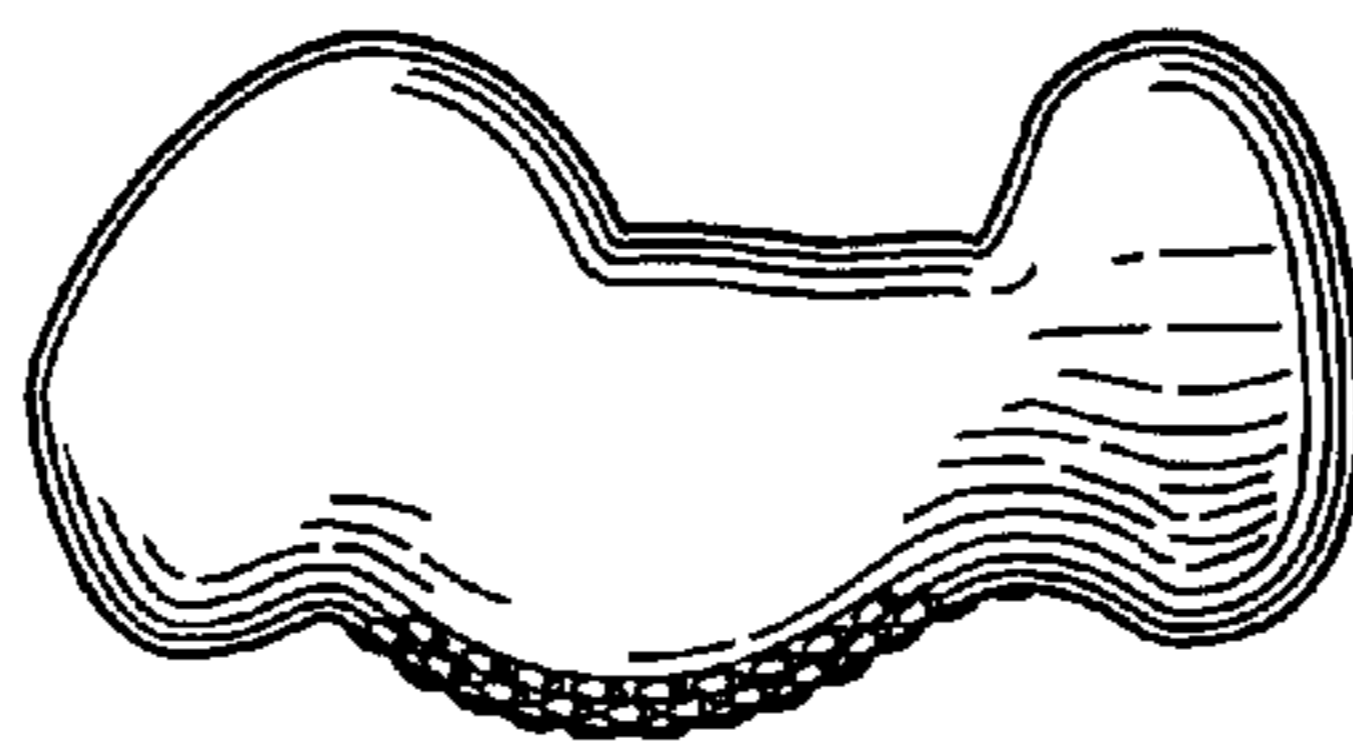

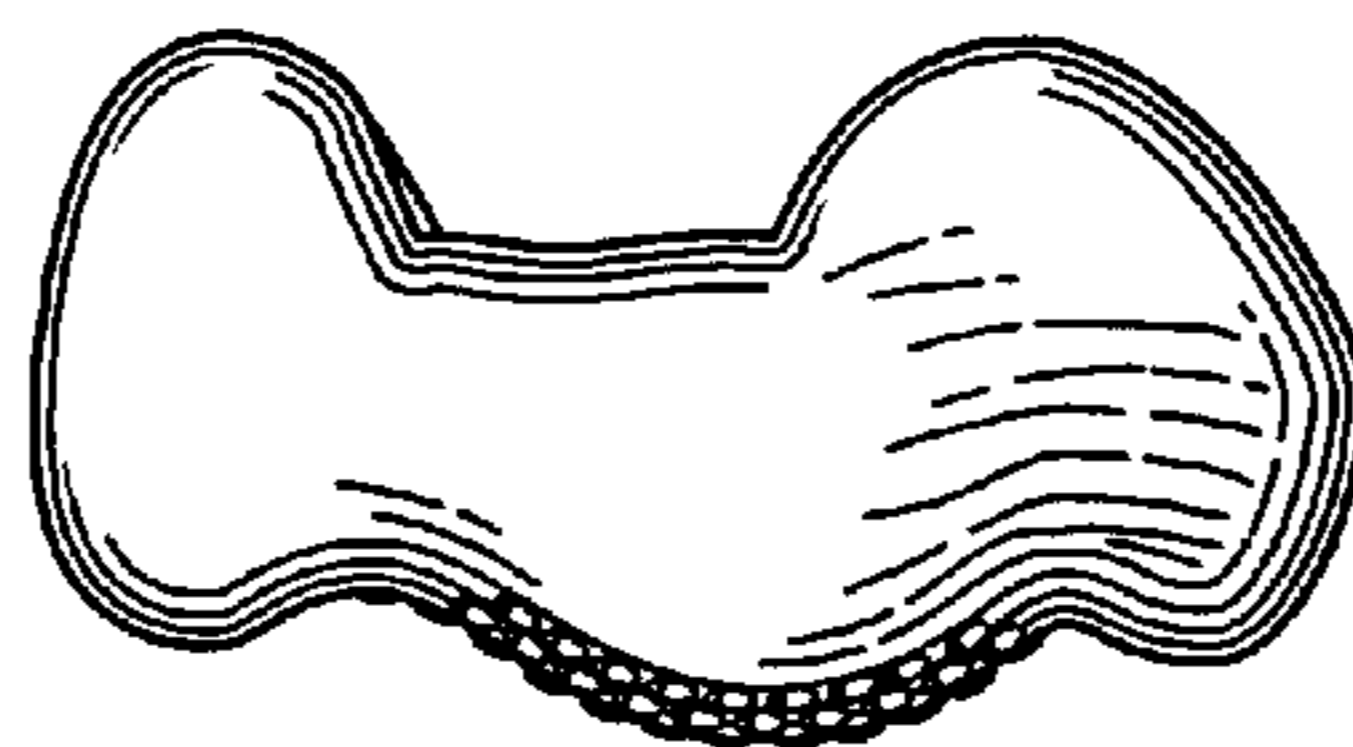

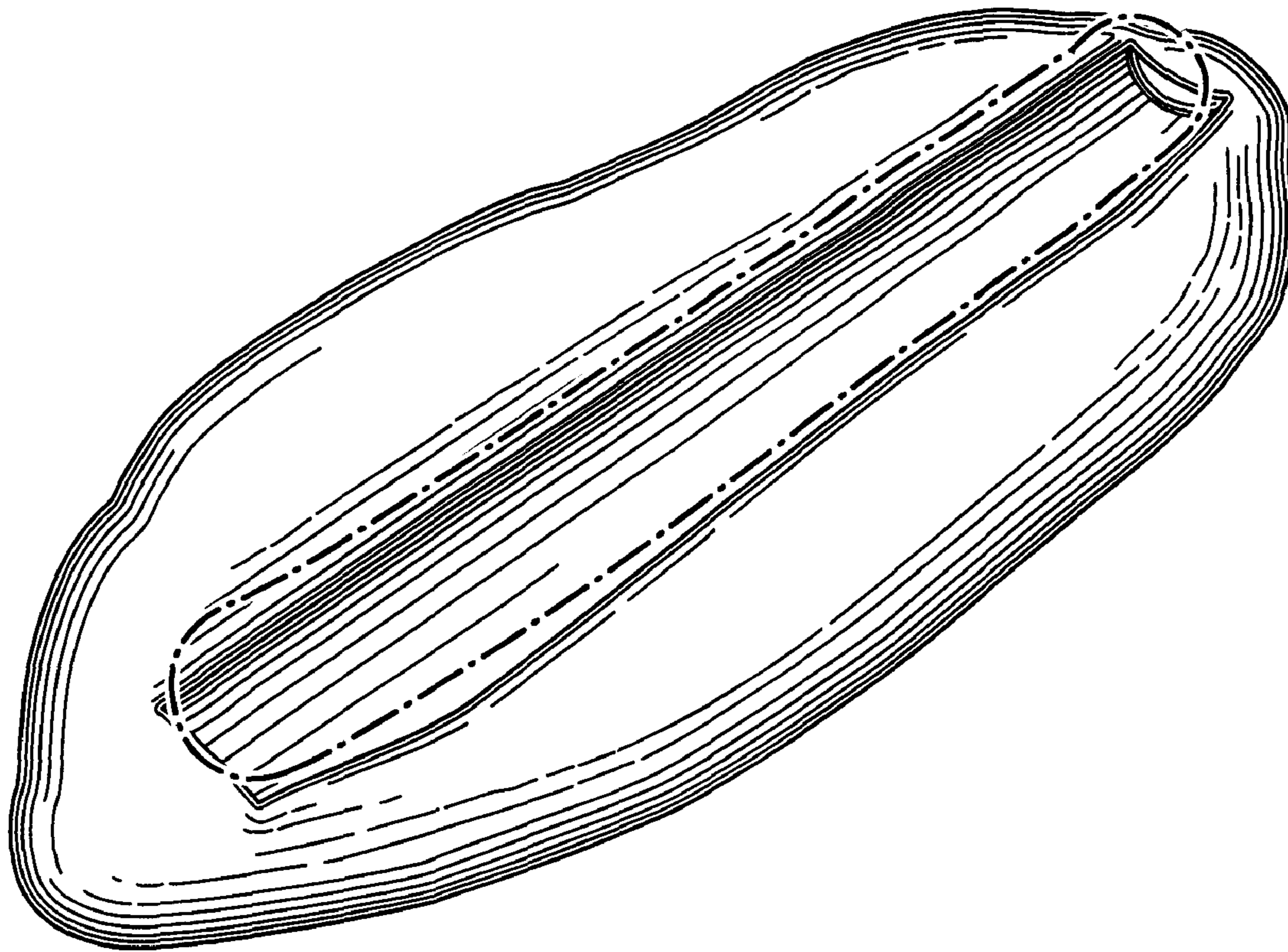

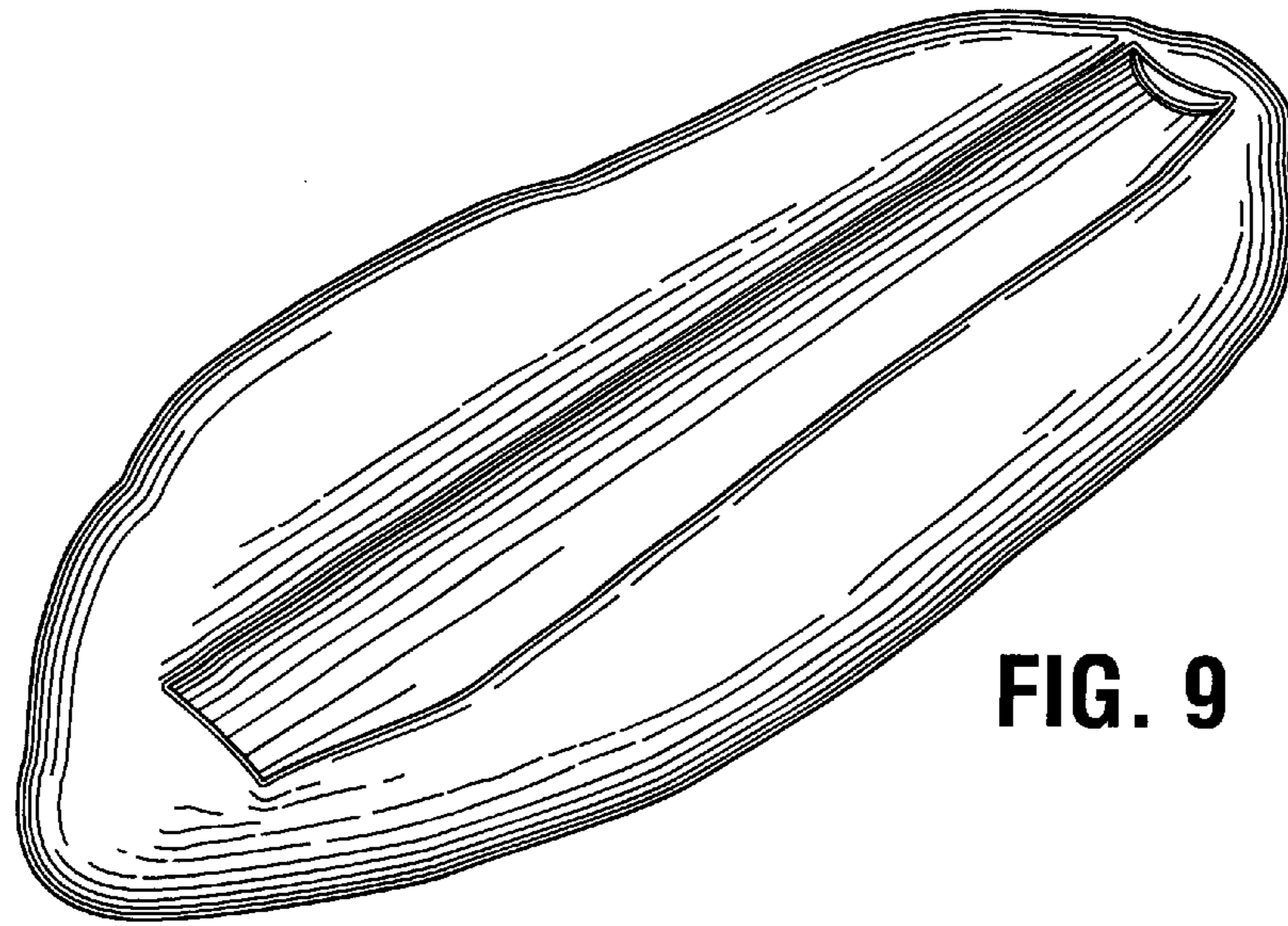

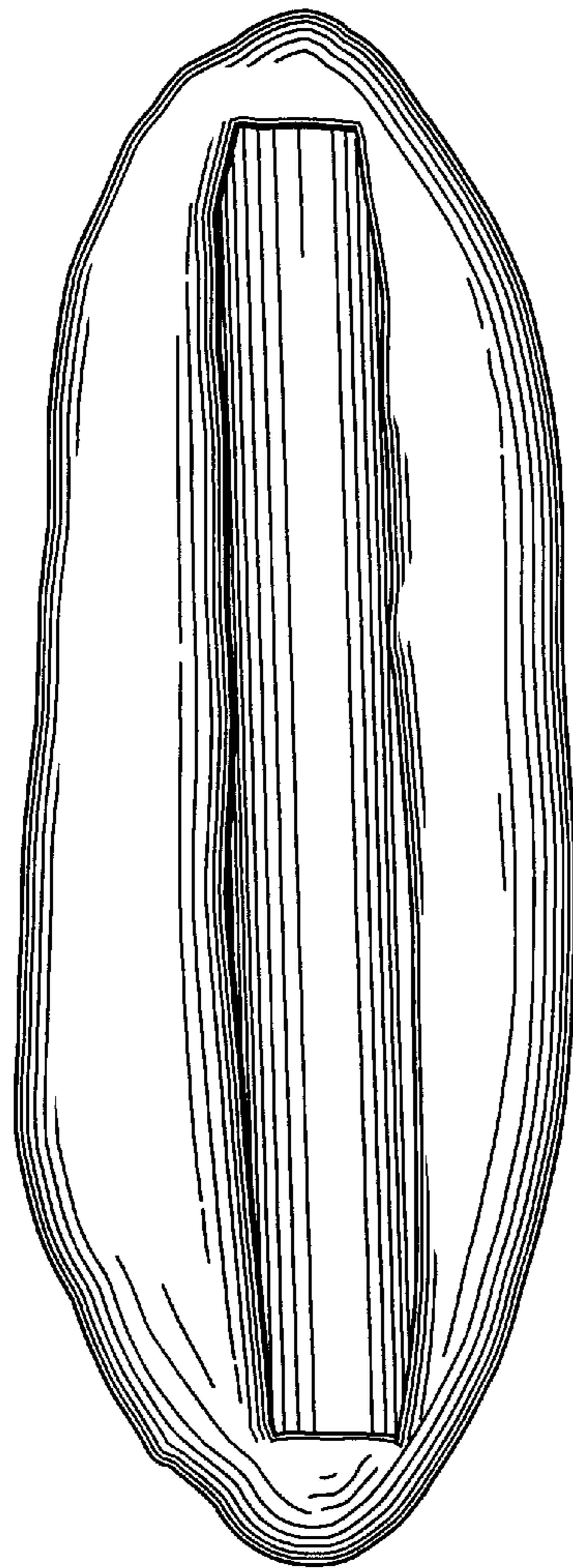

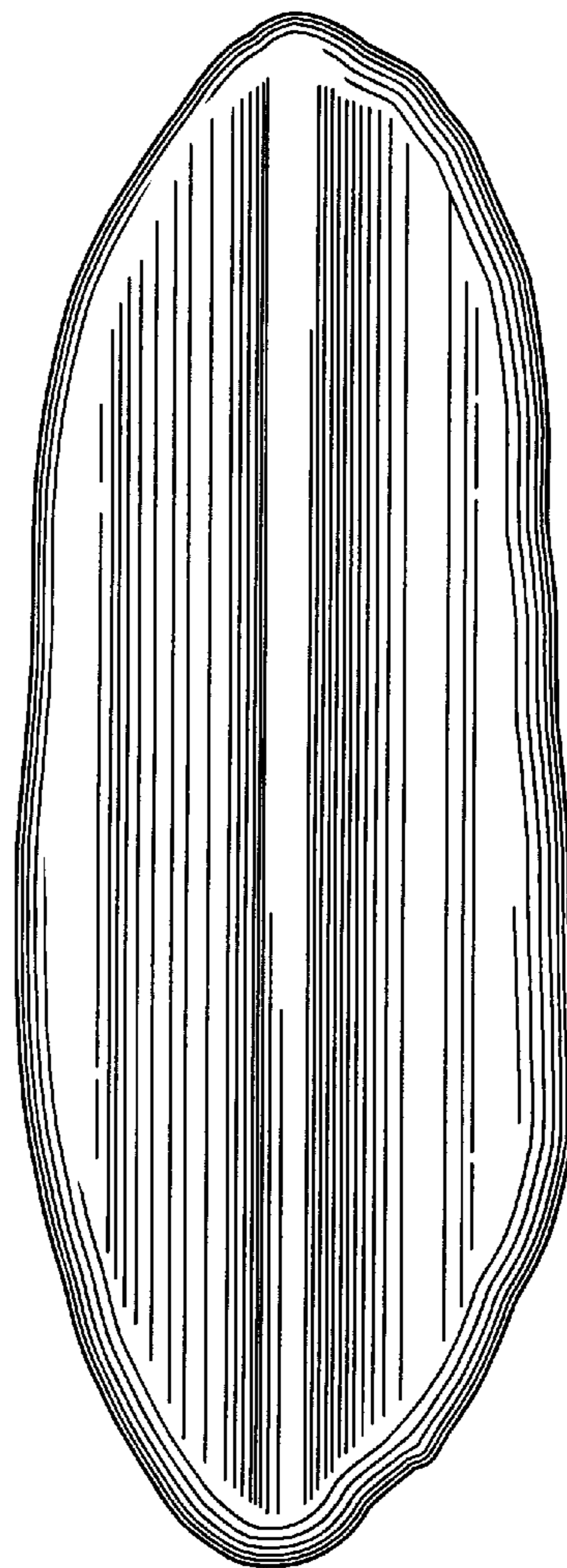

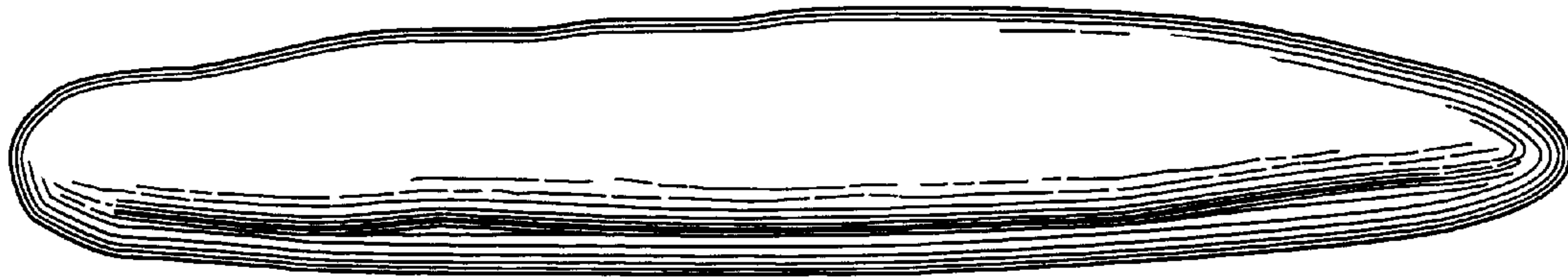

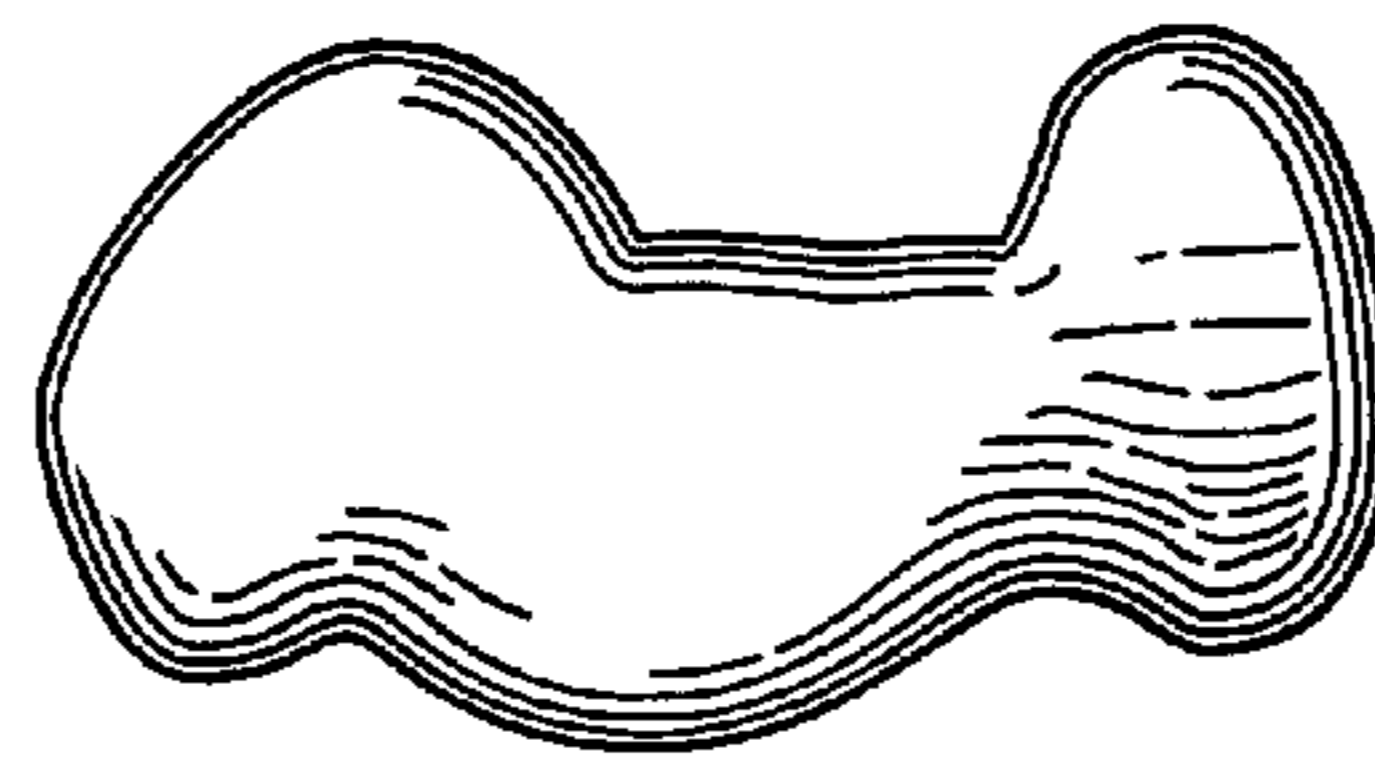

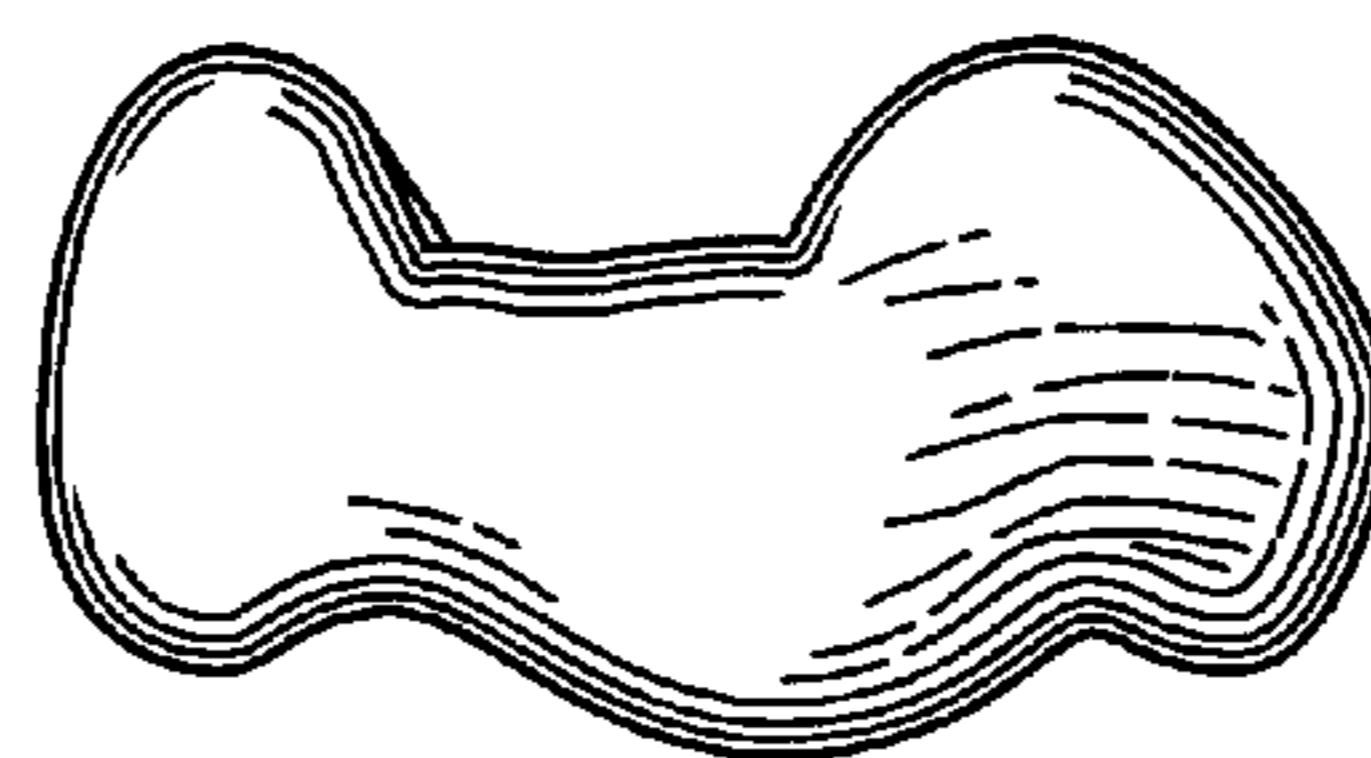
