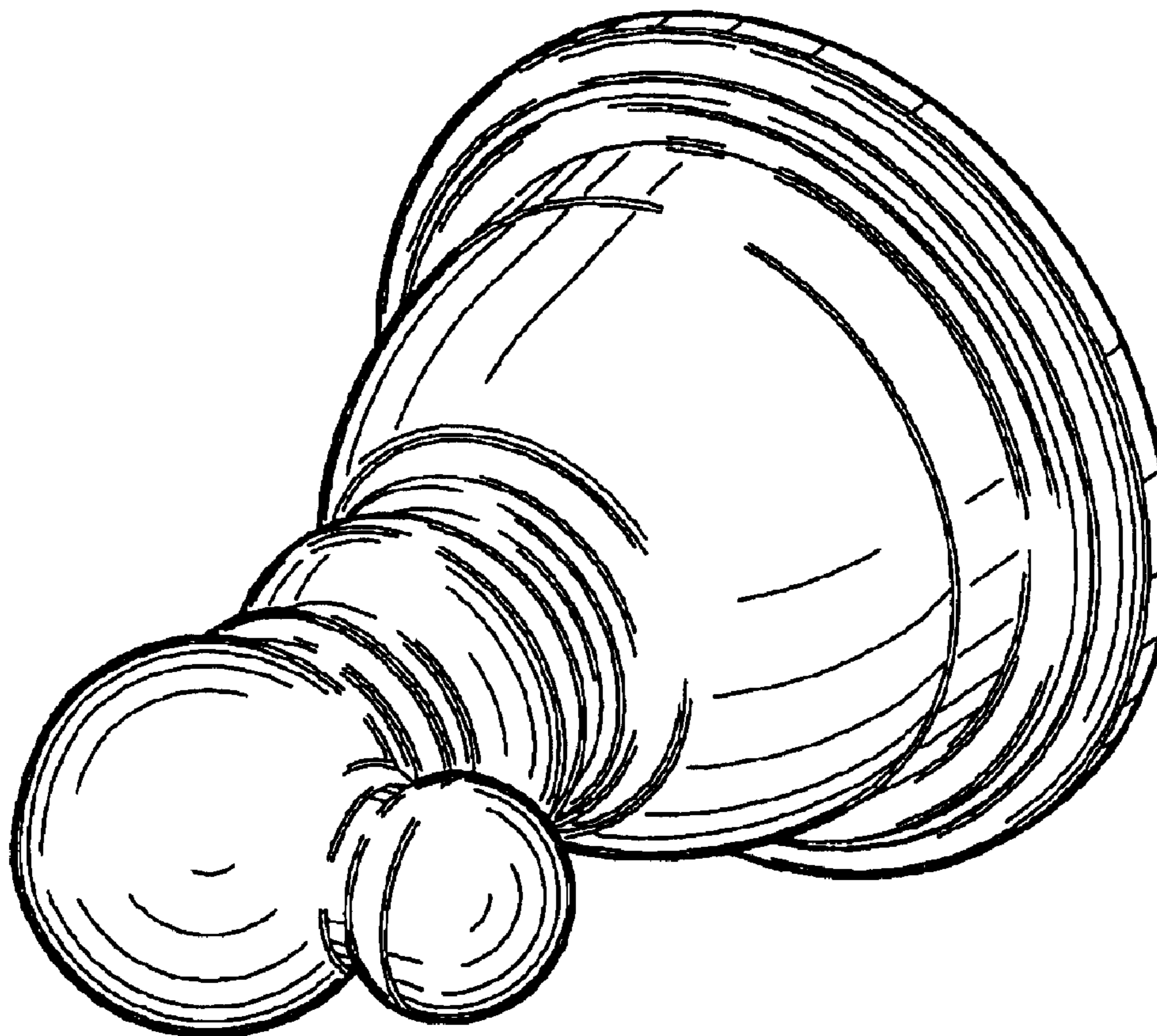

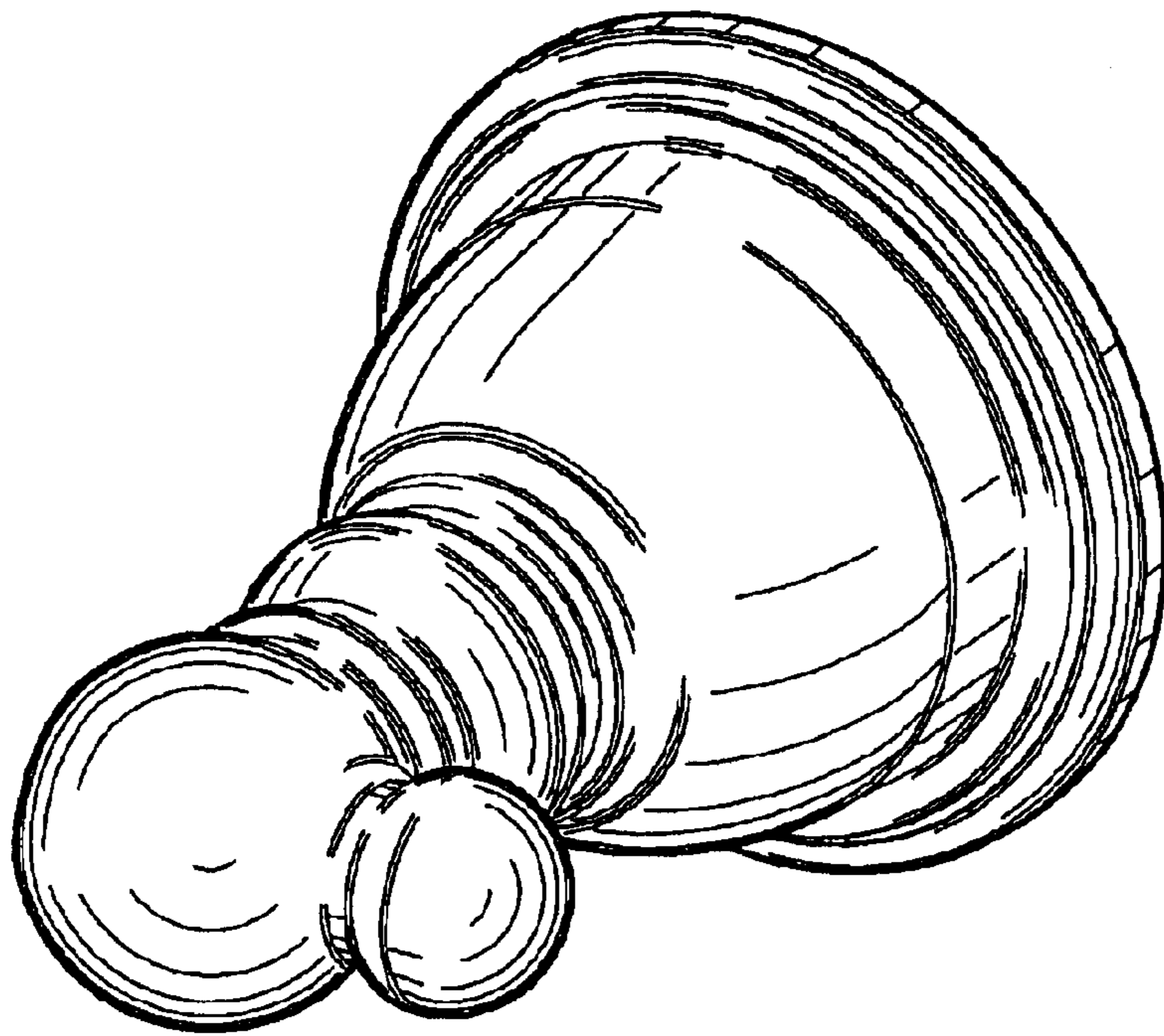
The ornamental design for a bath accessory post with finial,

**DESCRIPTION**

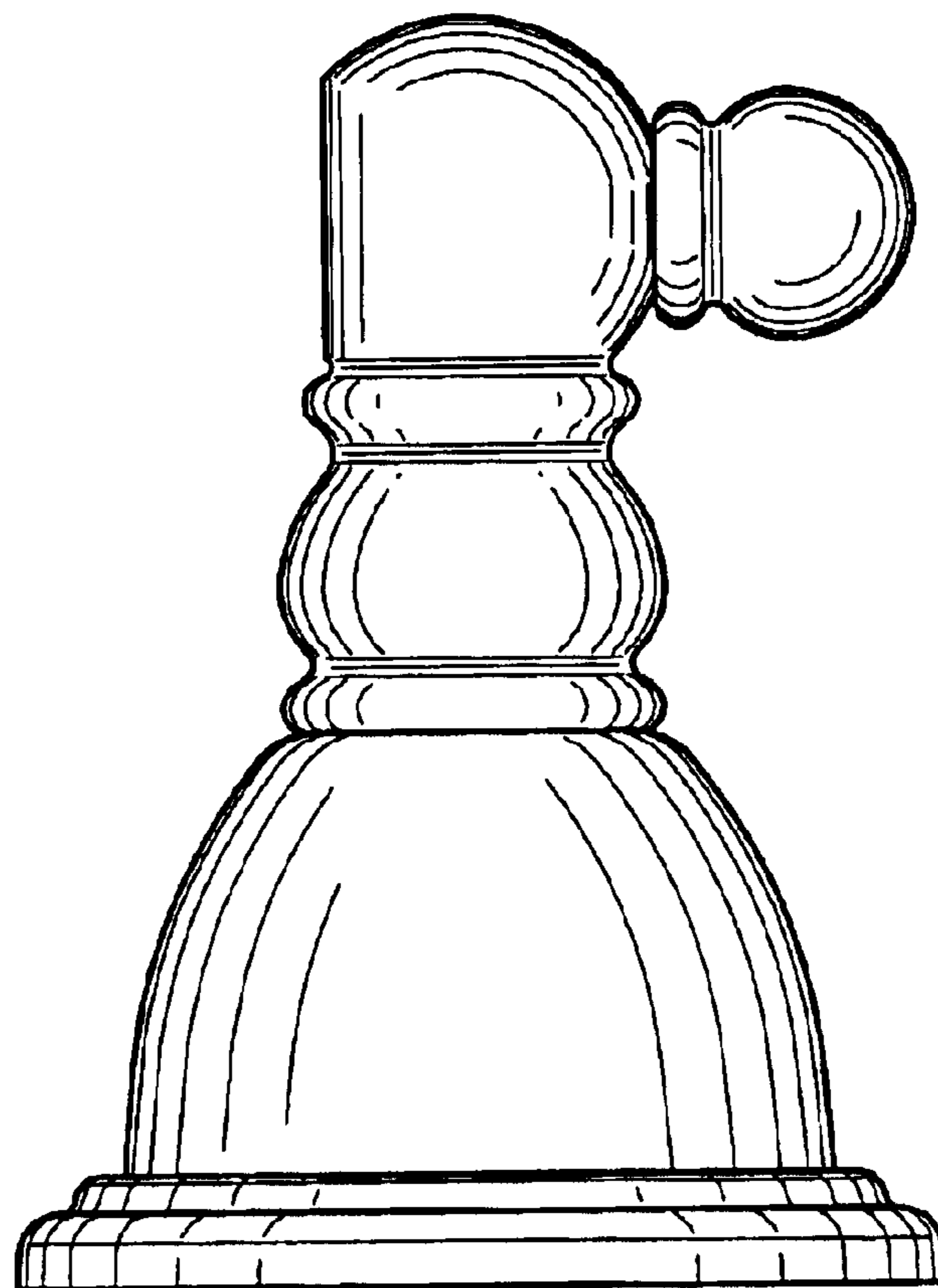
FIG. 1 is a perspective view of a bath accessory post with

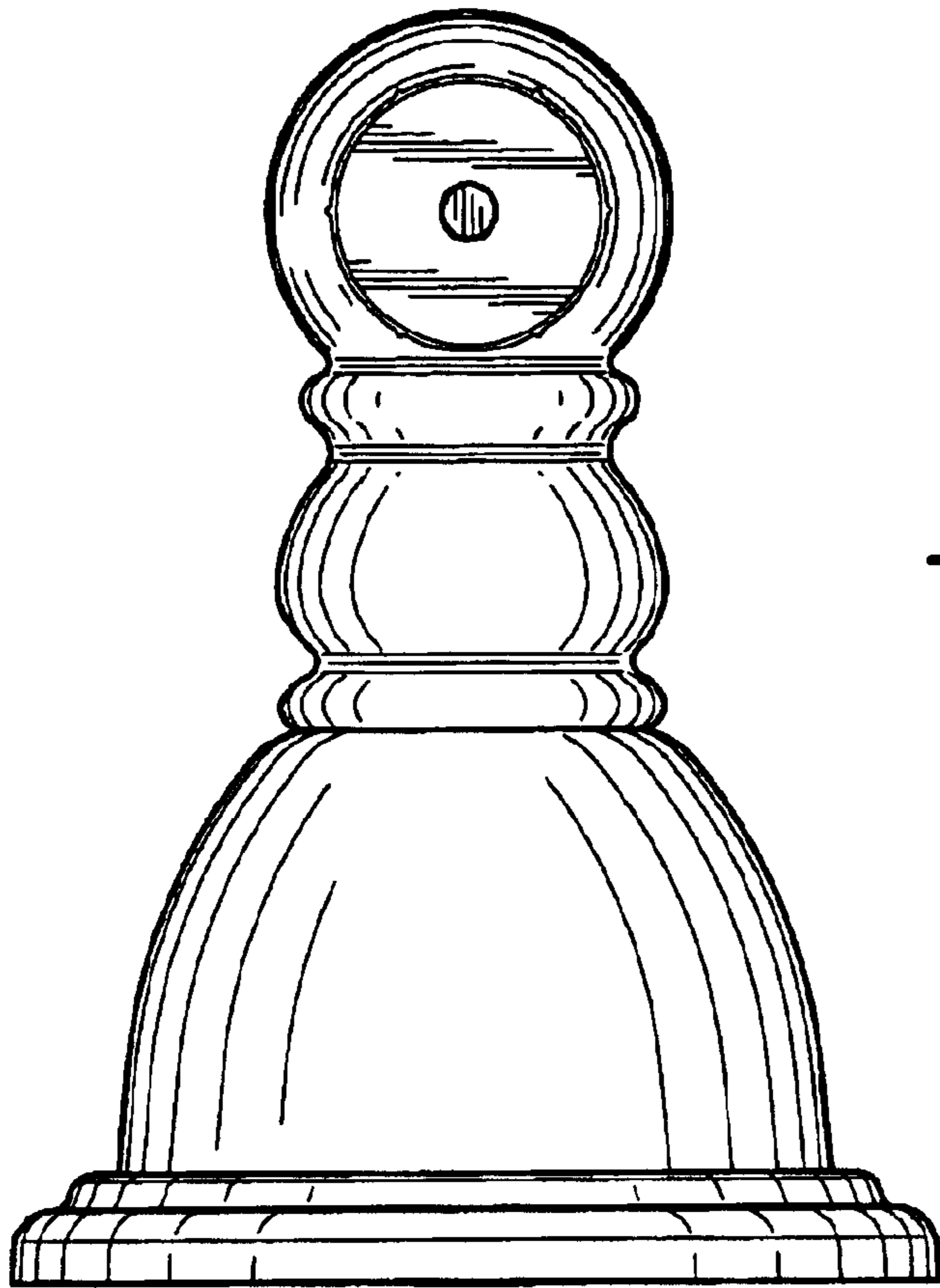




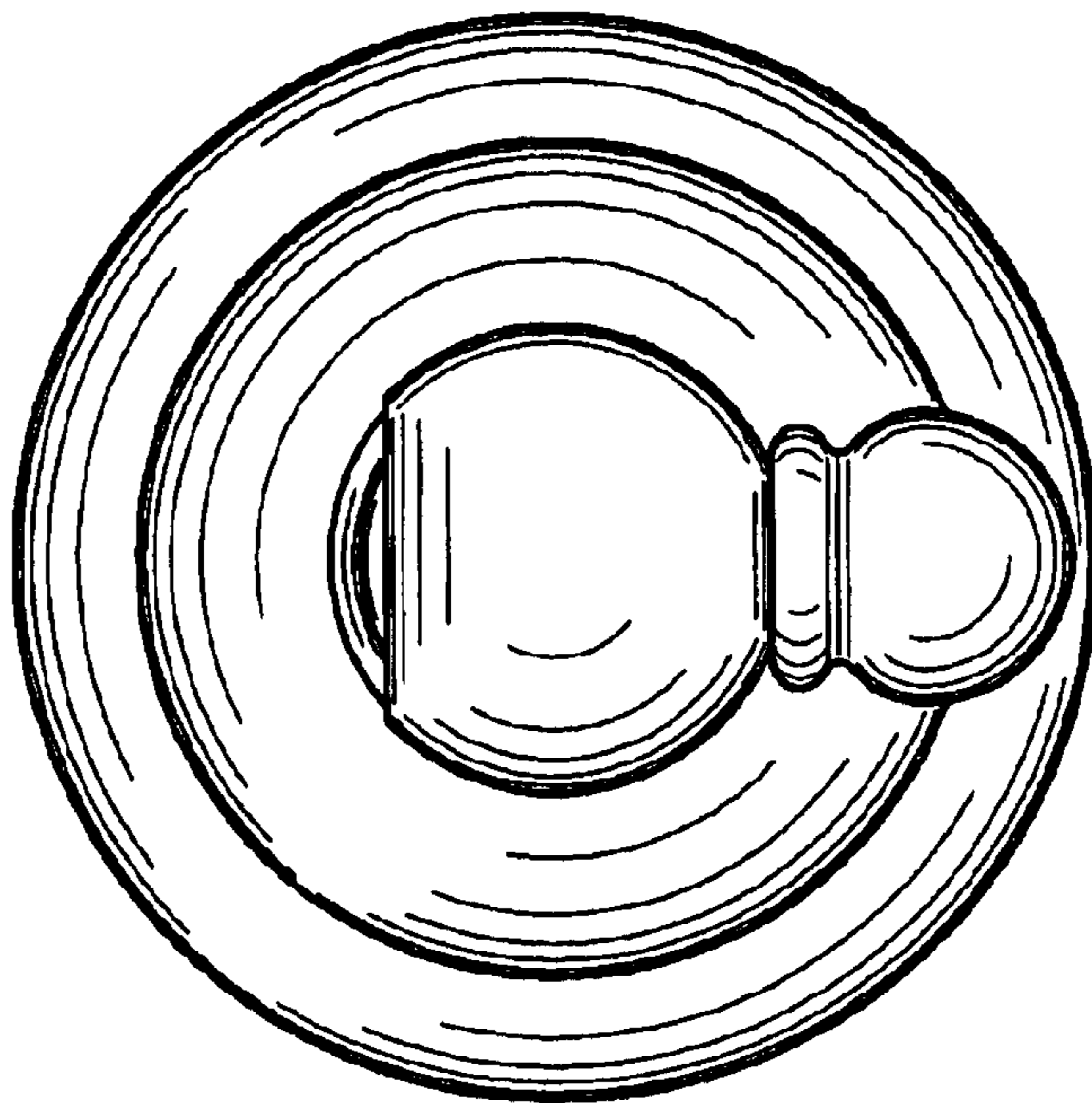

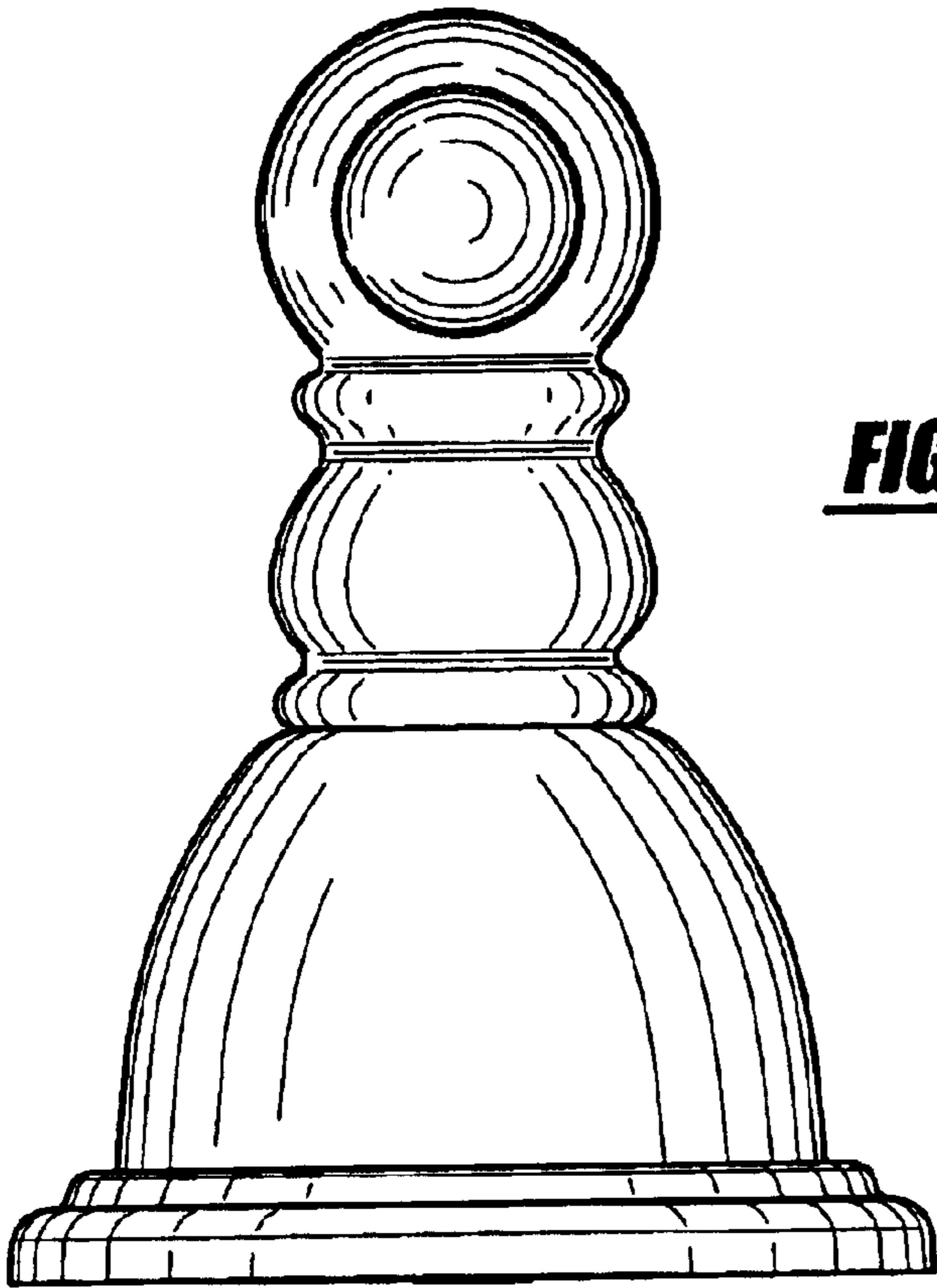

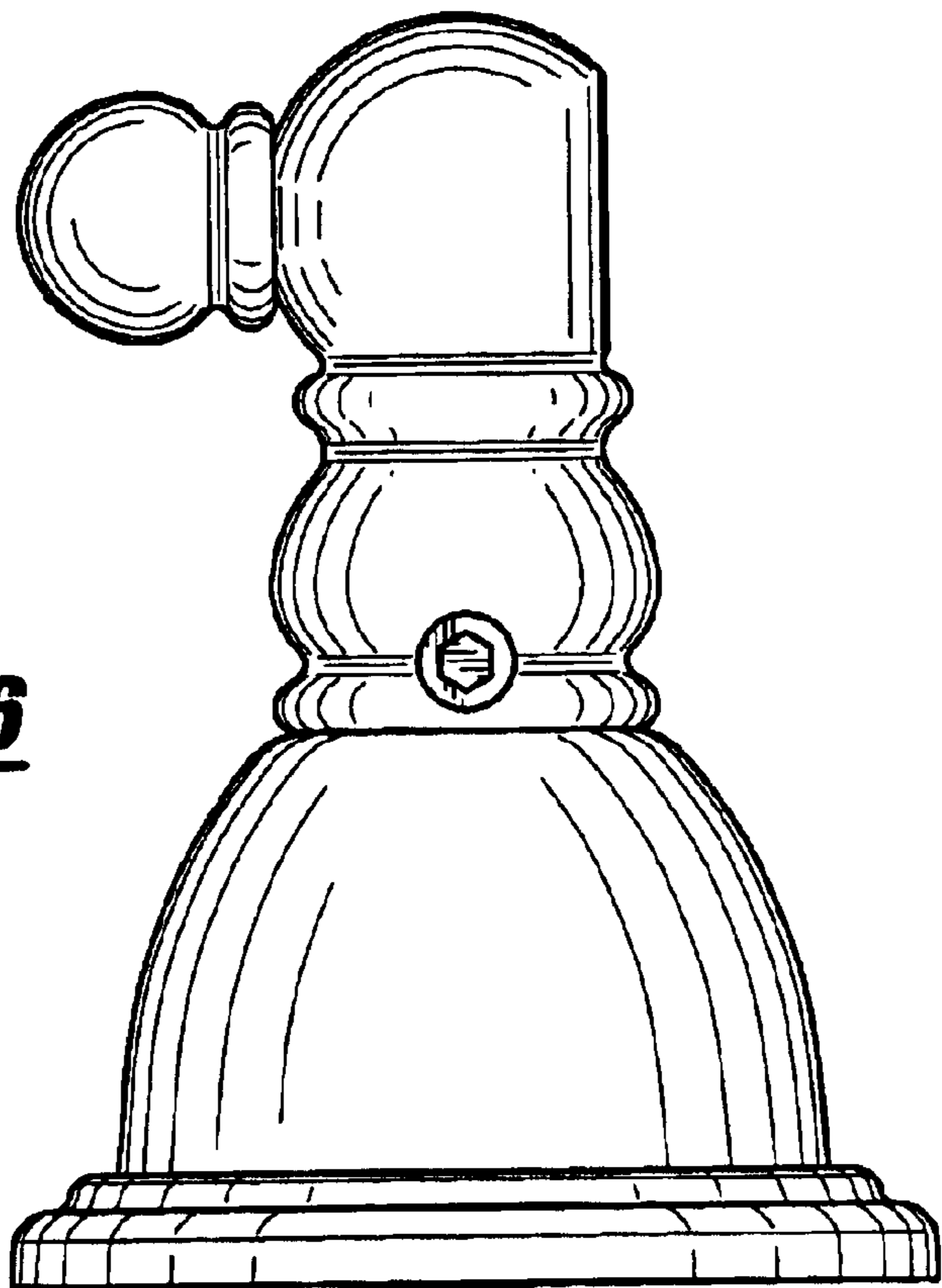
