A right side view is a mirror image of the left side view shown in FIG. 7.

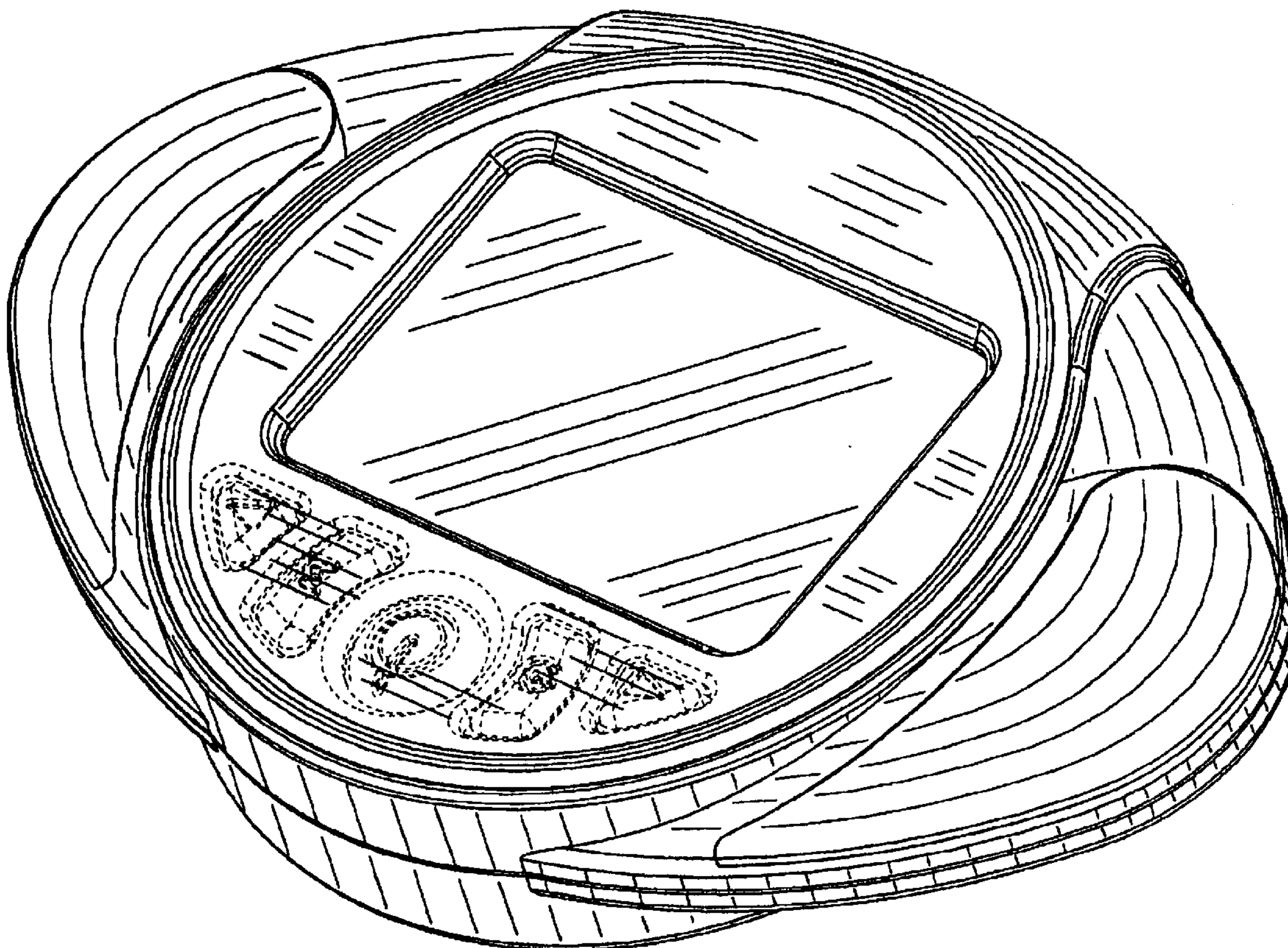

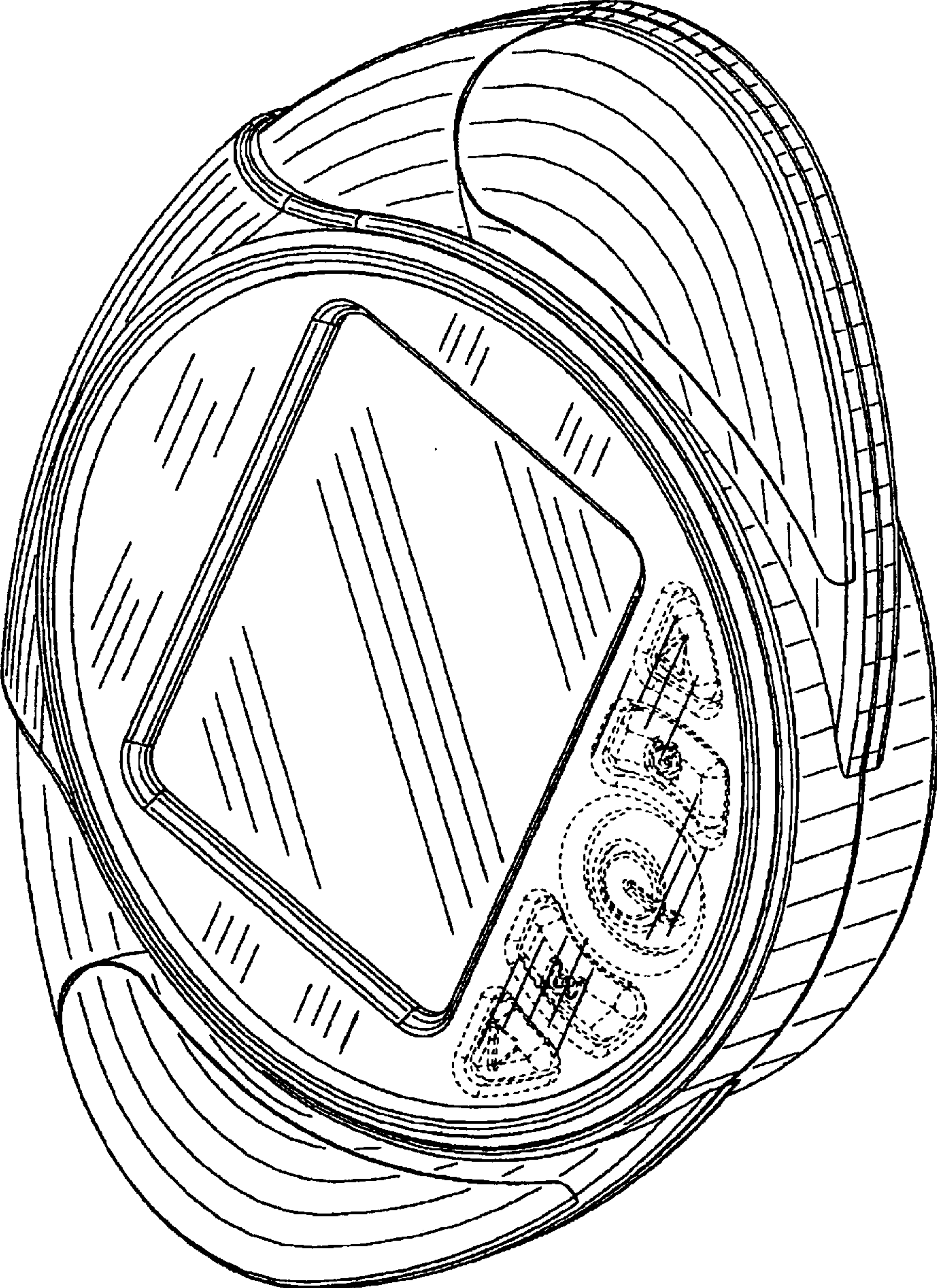

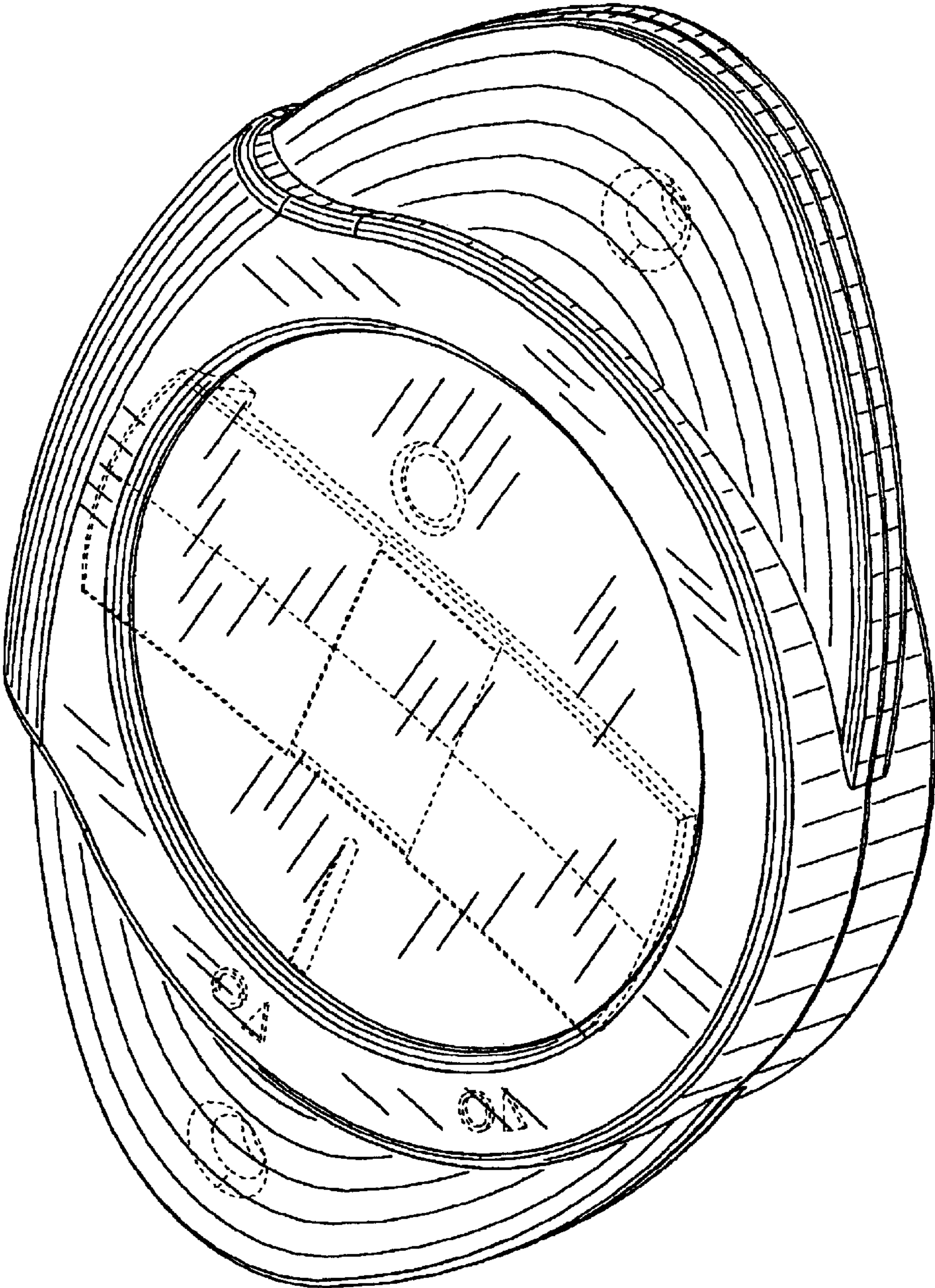

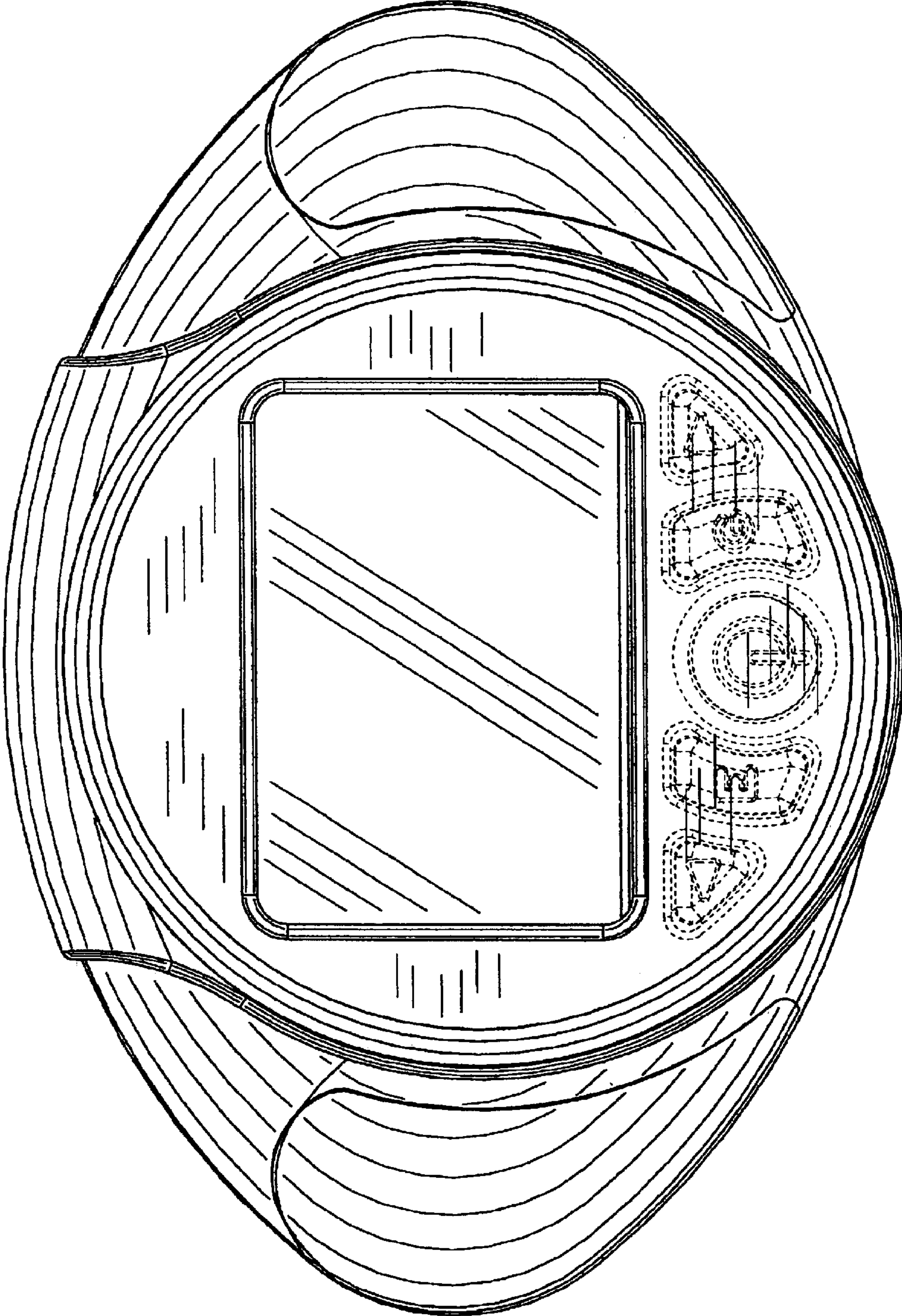

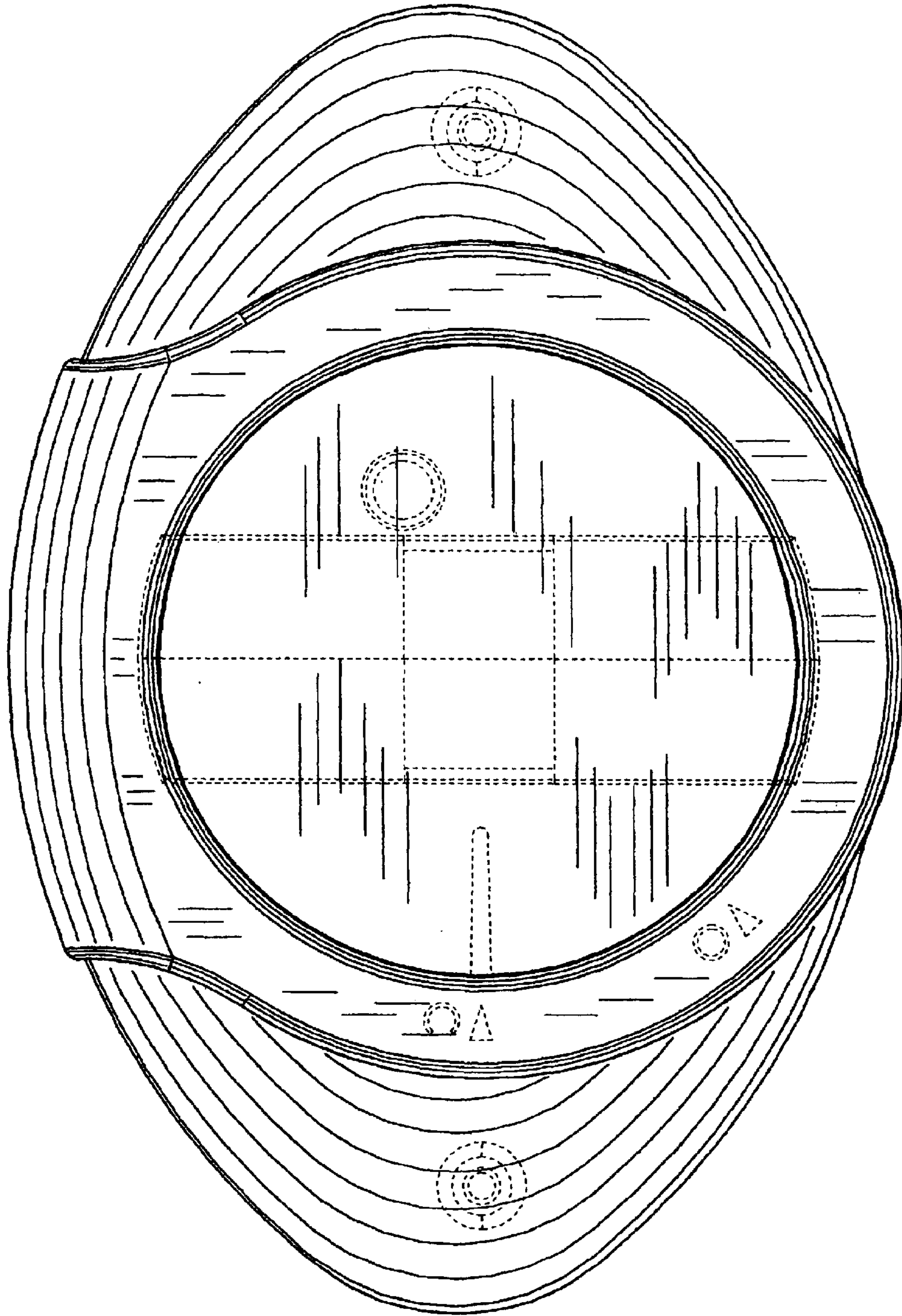

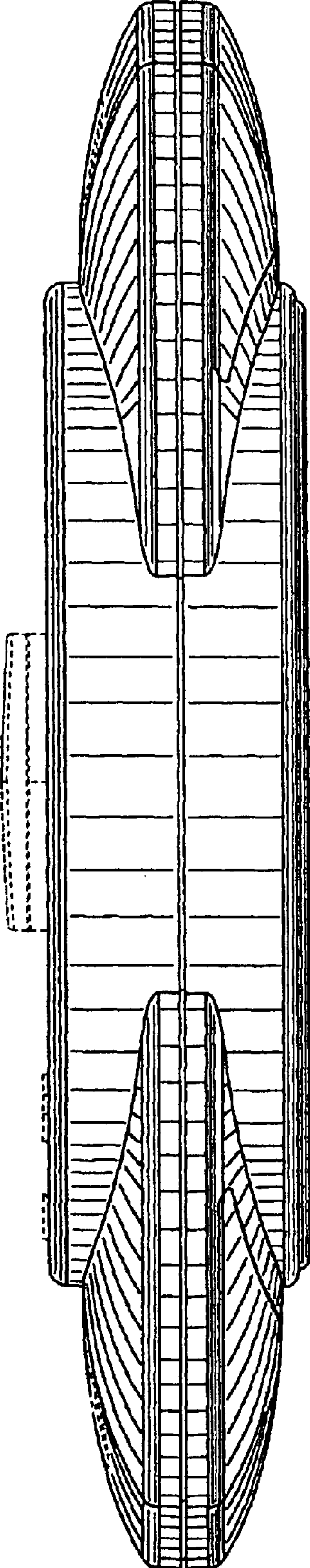

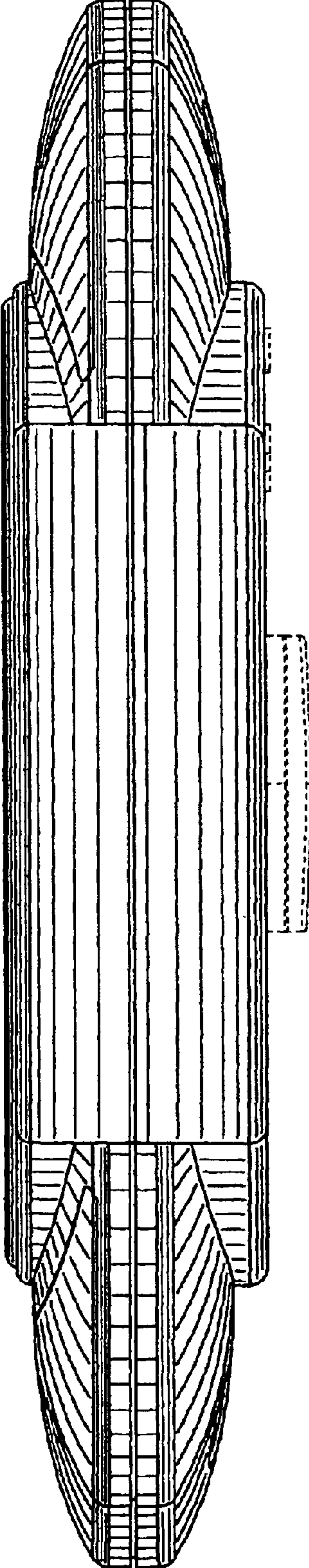

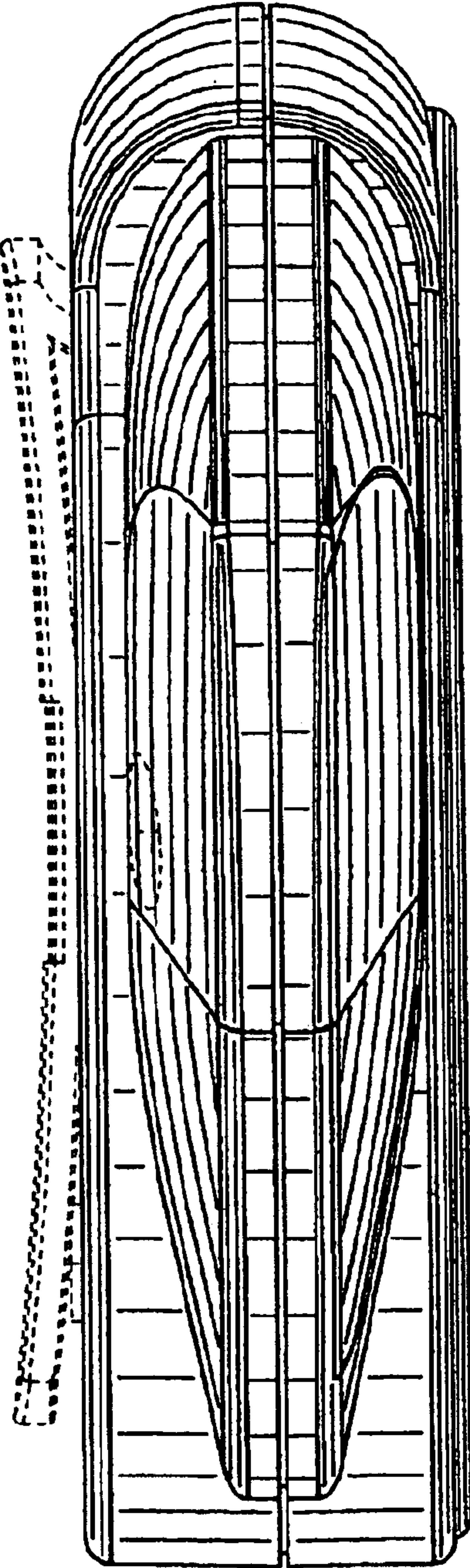
