(57) **CLAIM**

The ornamental design for a saddle bag ornament, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevational view of a saddle bag ornament illustrating my new design of the present invention;  
FIG. 2 is an end elevational view thereof, from the right end as viewed in FIG. 1;  
FIG. 3 is an opposite end elevational view taken from the left end of FIG. 1;  
FIG. 4 is a top plan view thereof; and,  
FIG. 5 is a bottom plan view thereof.

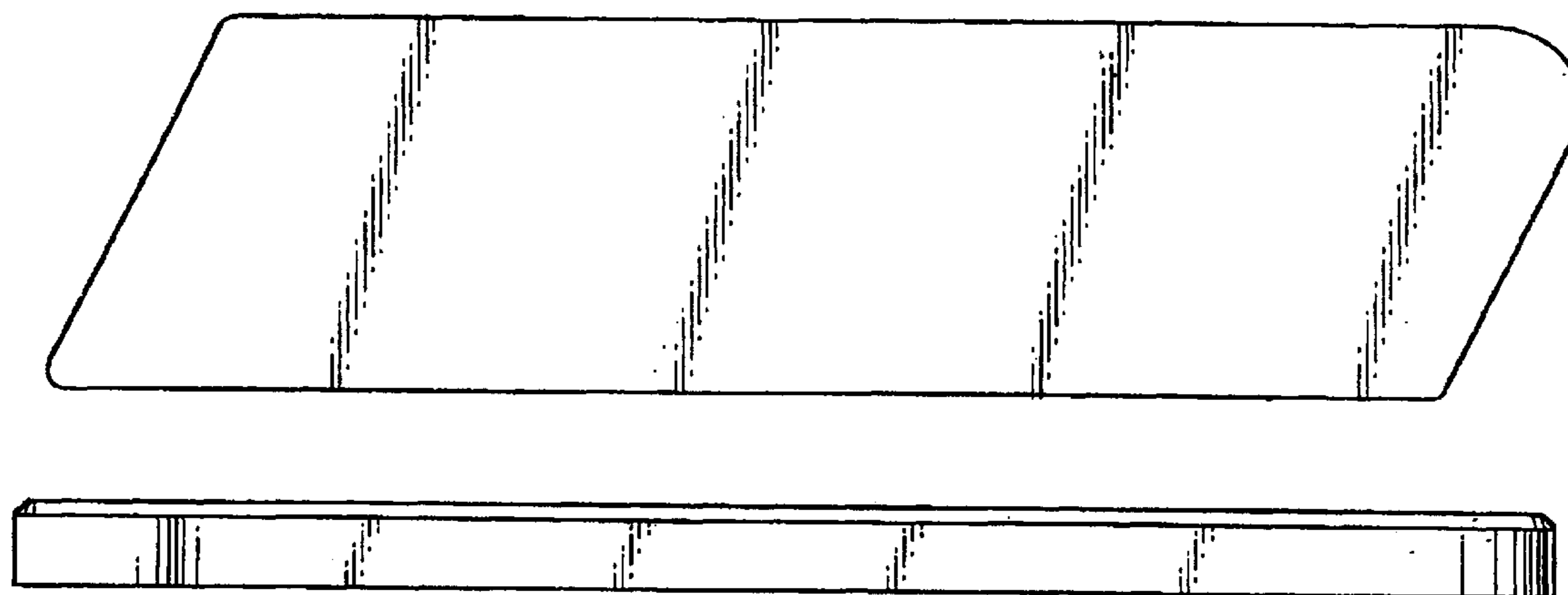

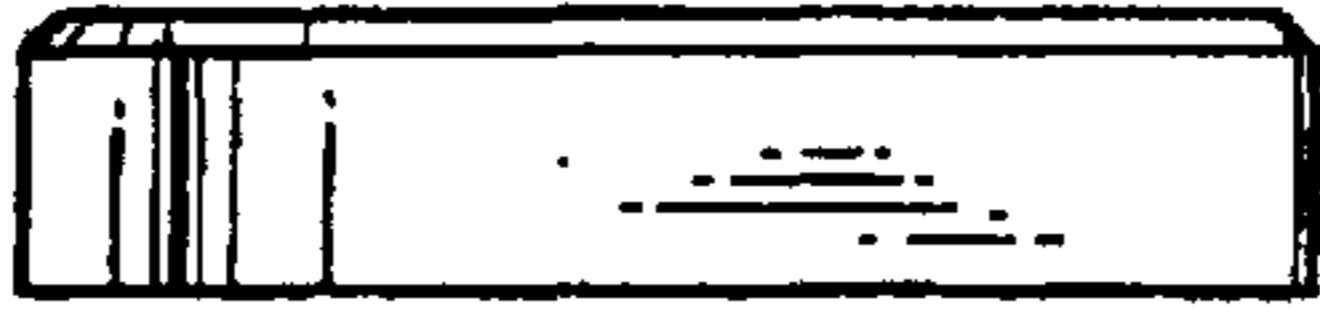

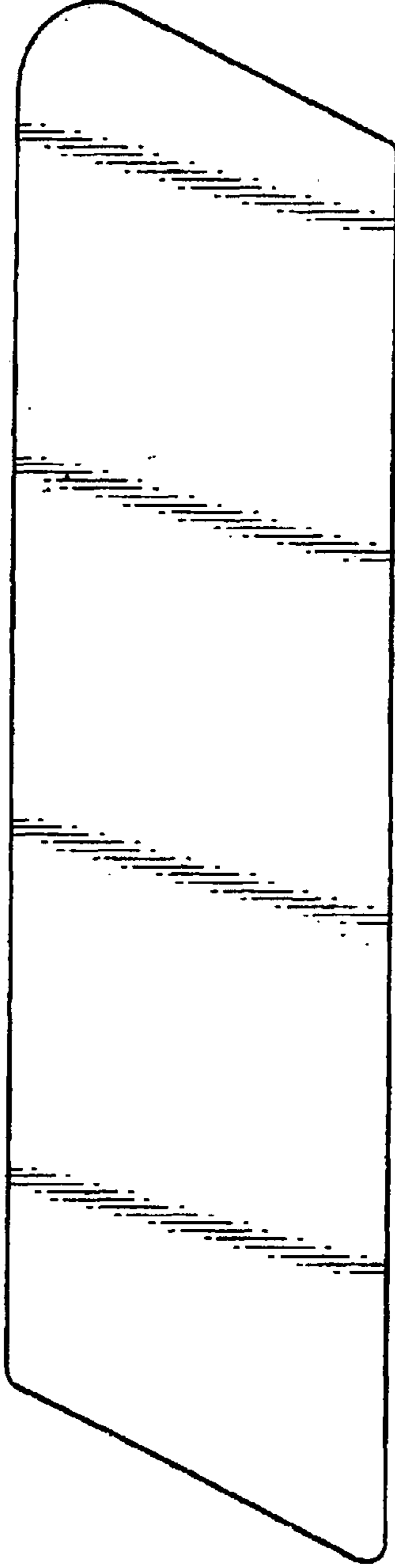

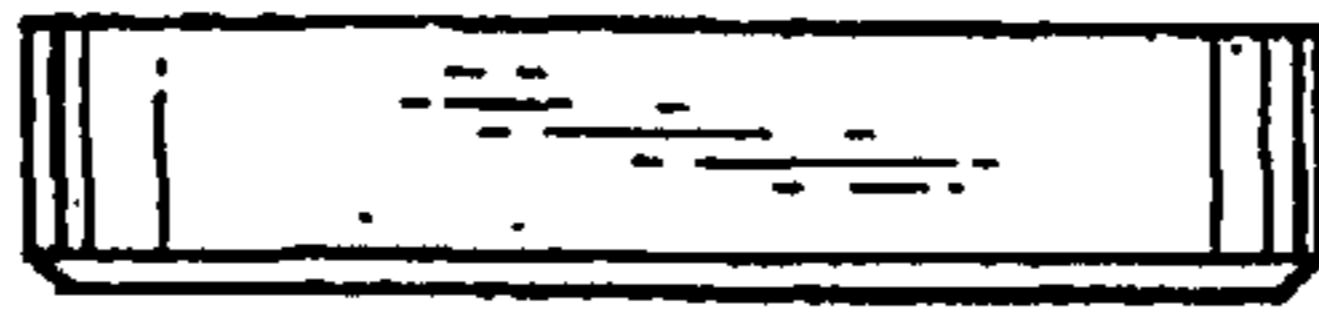
