FIG. 1 is a perspective view of a lighting fixture illustrating my new design;

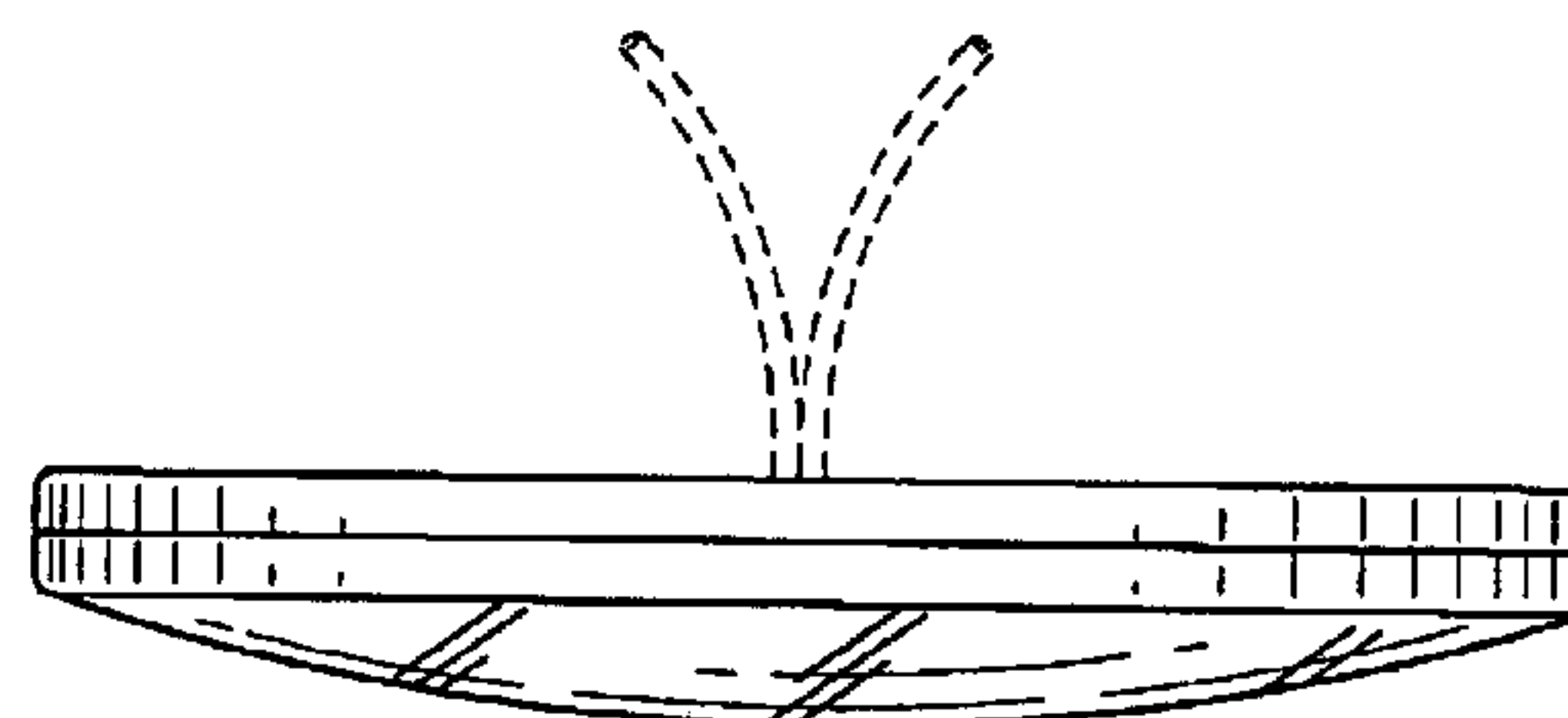
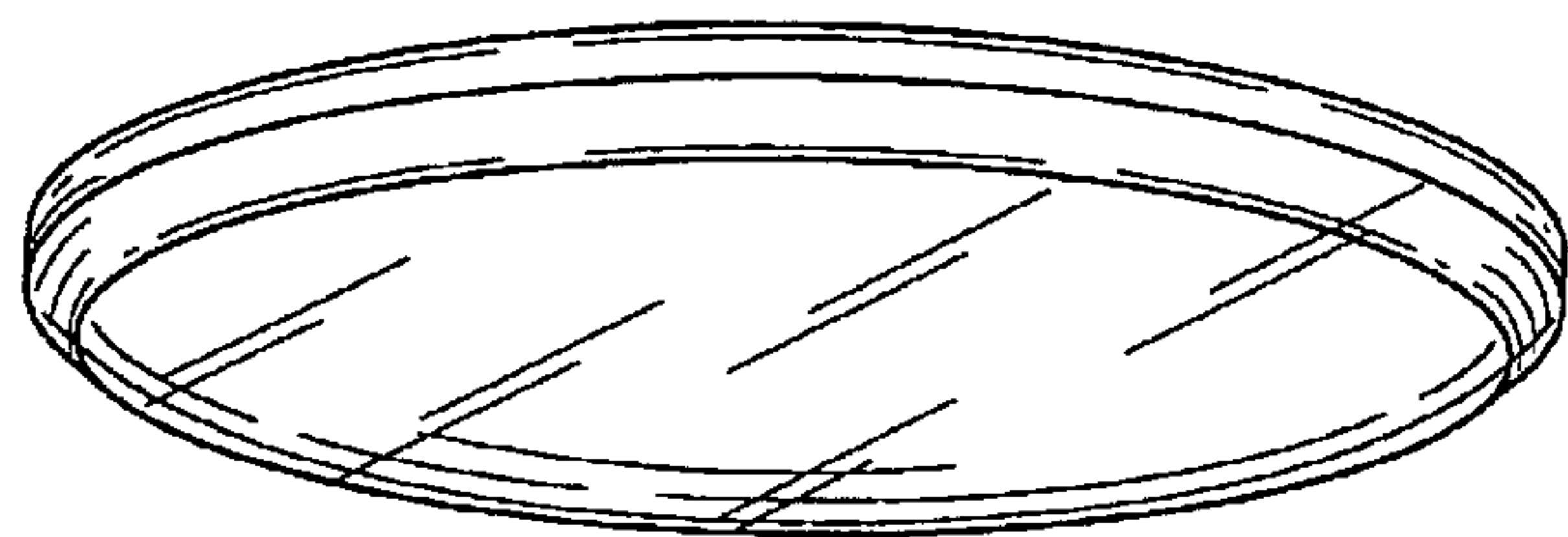
FIG. 2 is a side elevation view thereof;

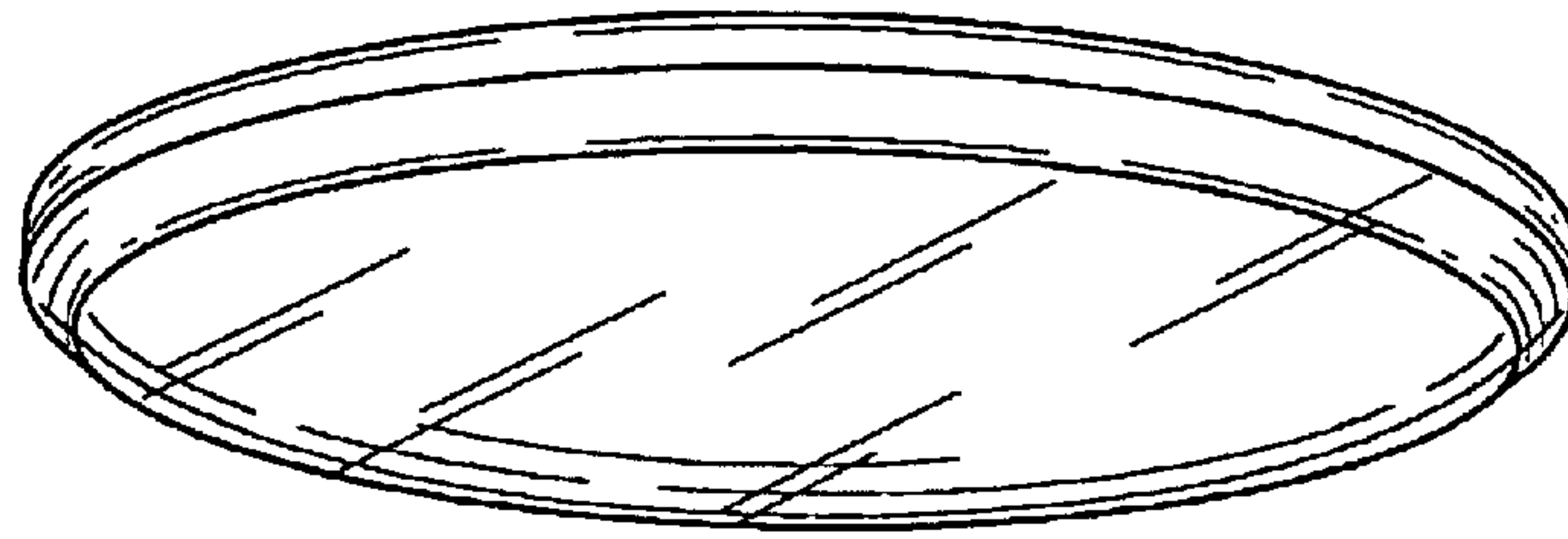
FIG. 3 is a top plan view thereof; and,

FIG. 4 is a bottom plan view thereof.

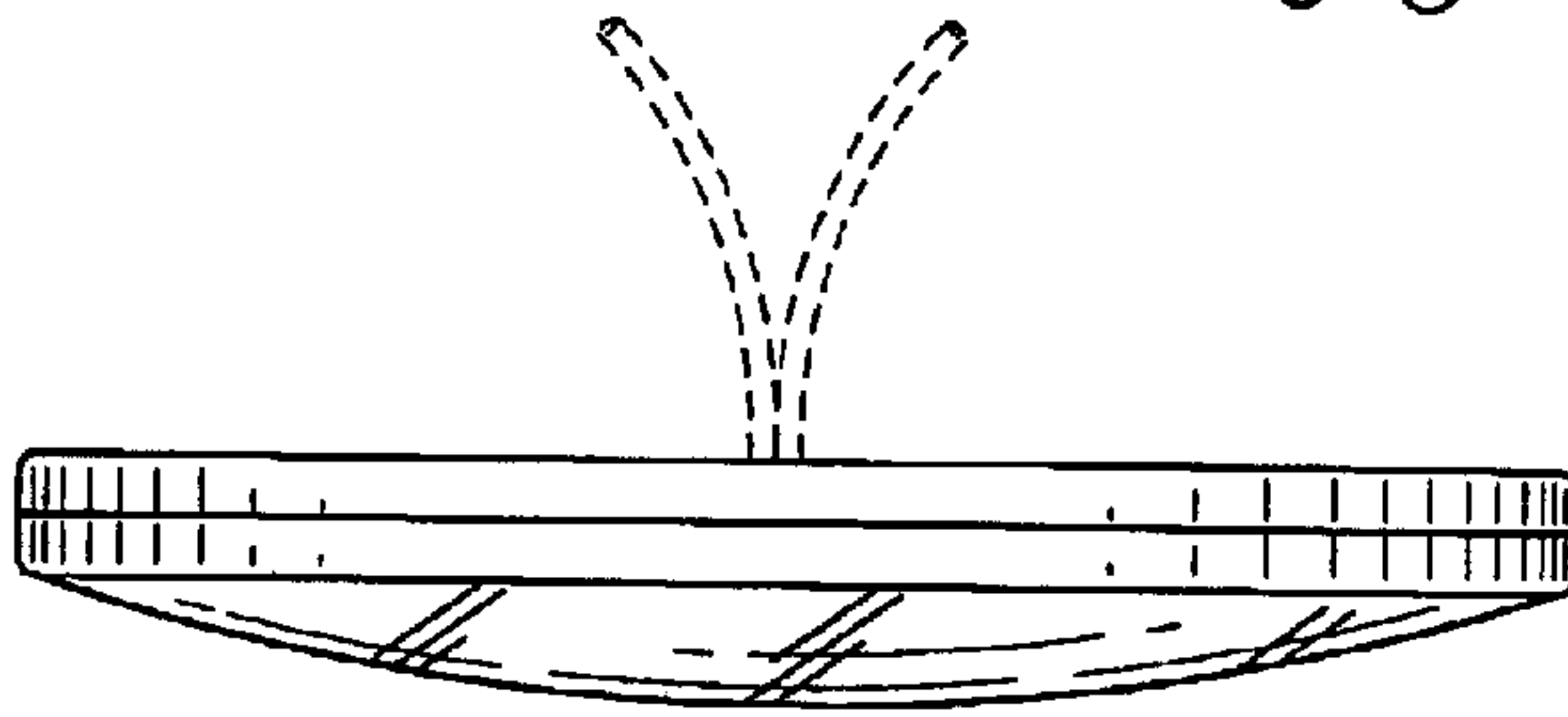
The broken line showing wires in FIGS. 2 and 3 are environmental structure only and does not form part of the claimed design.

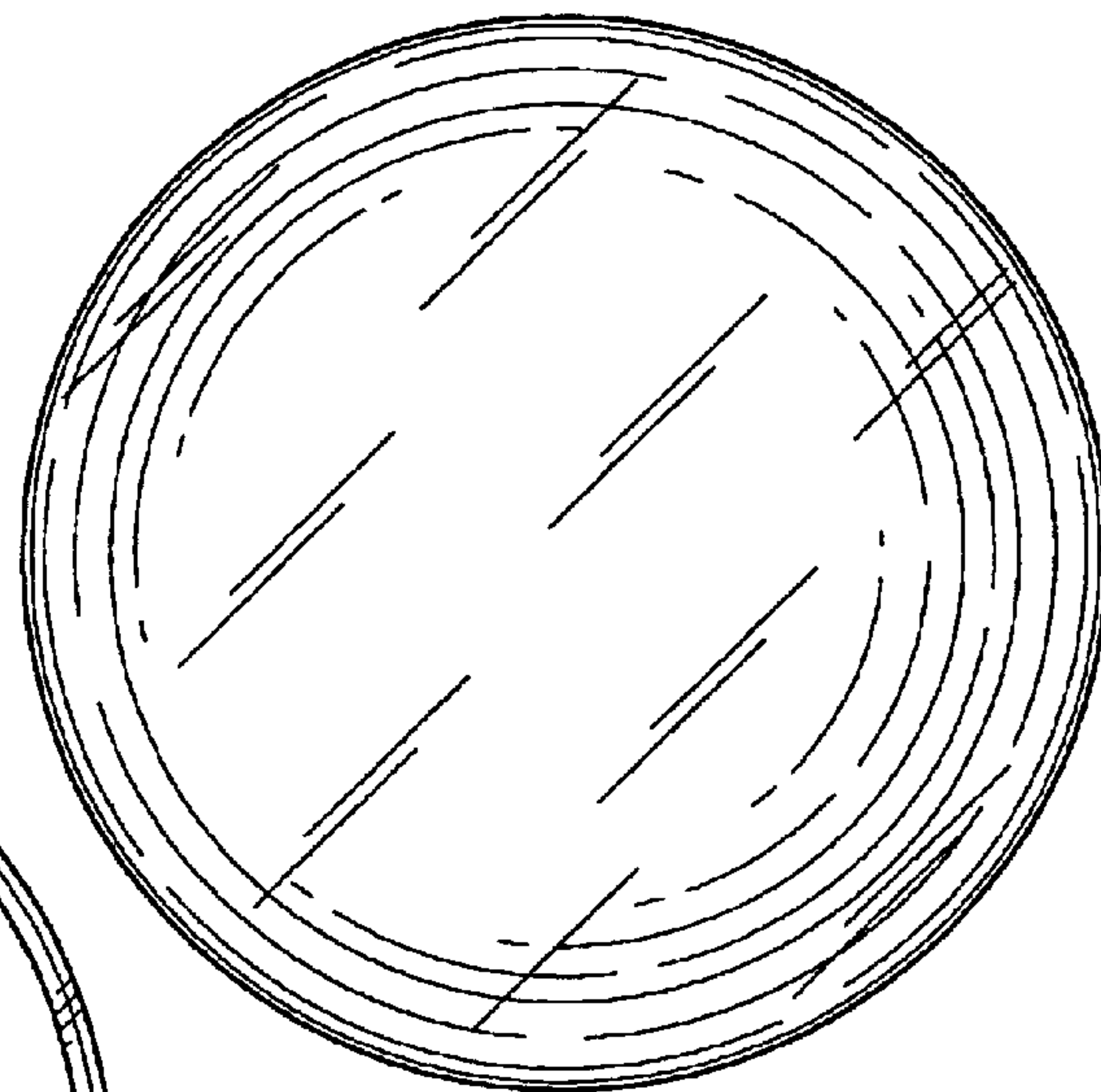




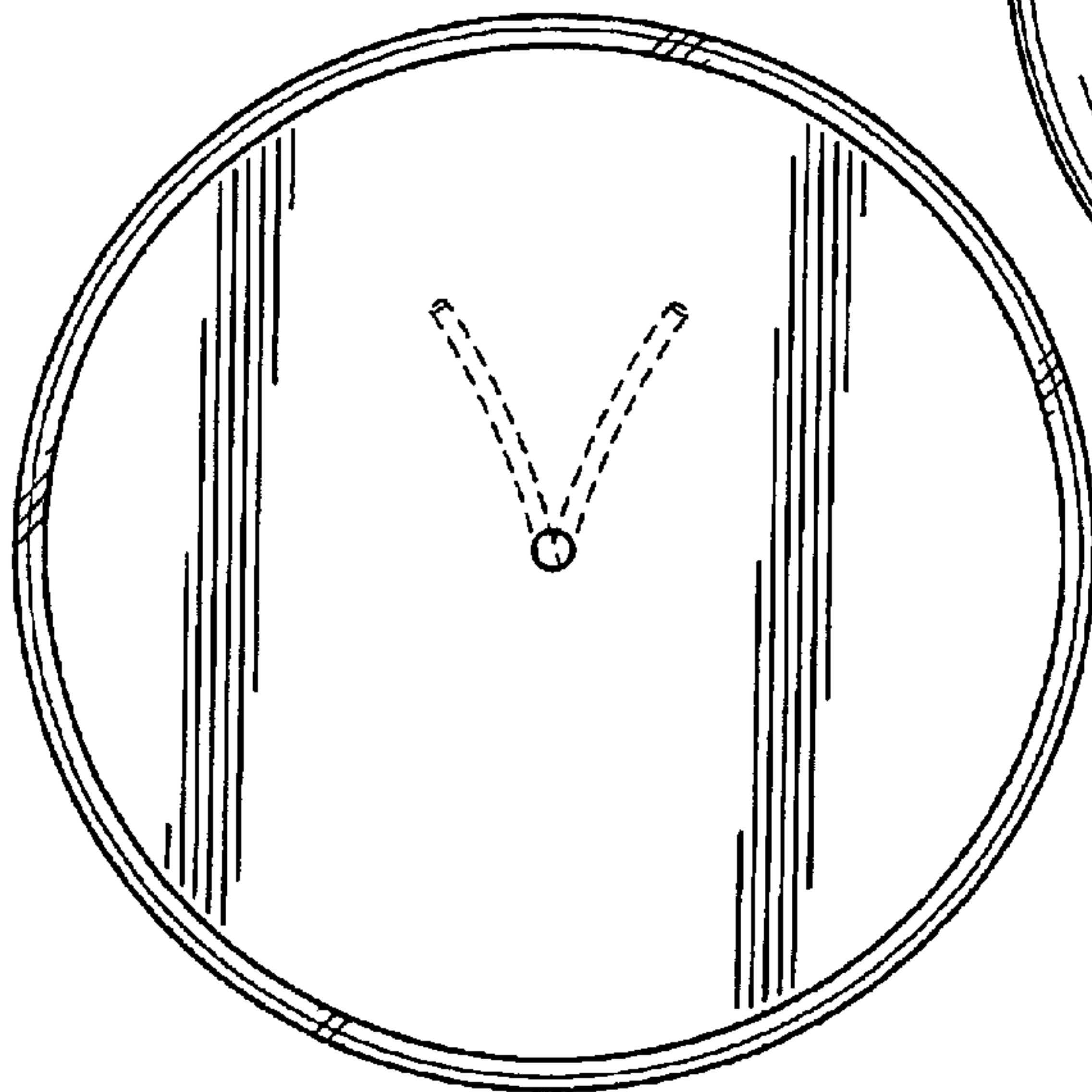
