FIG. 1 is a side view of an inner thigh and knee pillow showing my new design.

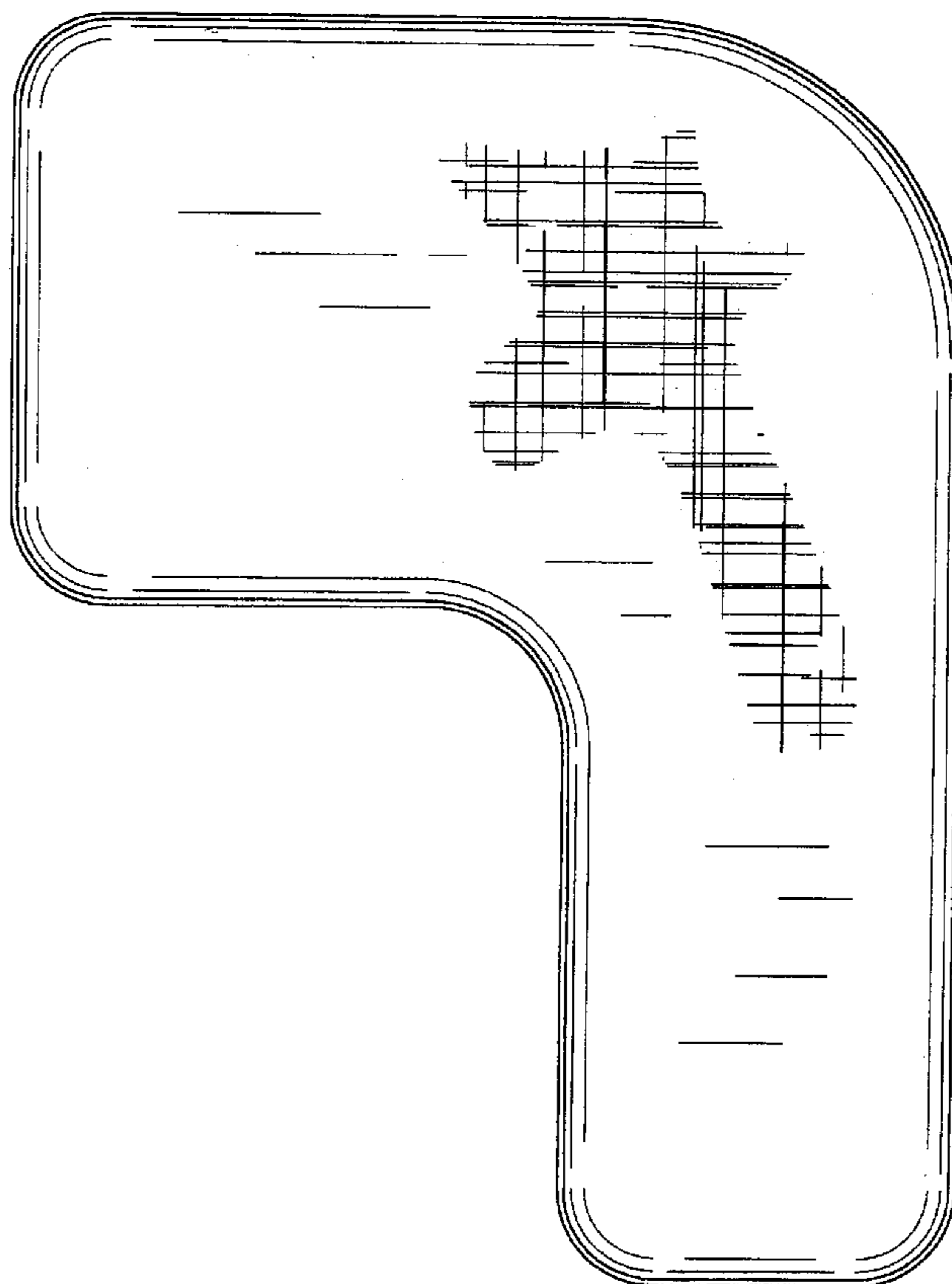
FIG. 2 is a left edge view of the inner thigh and knee pillow.

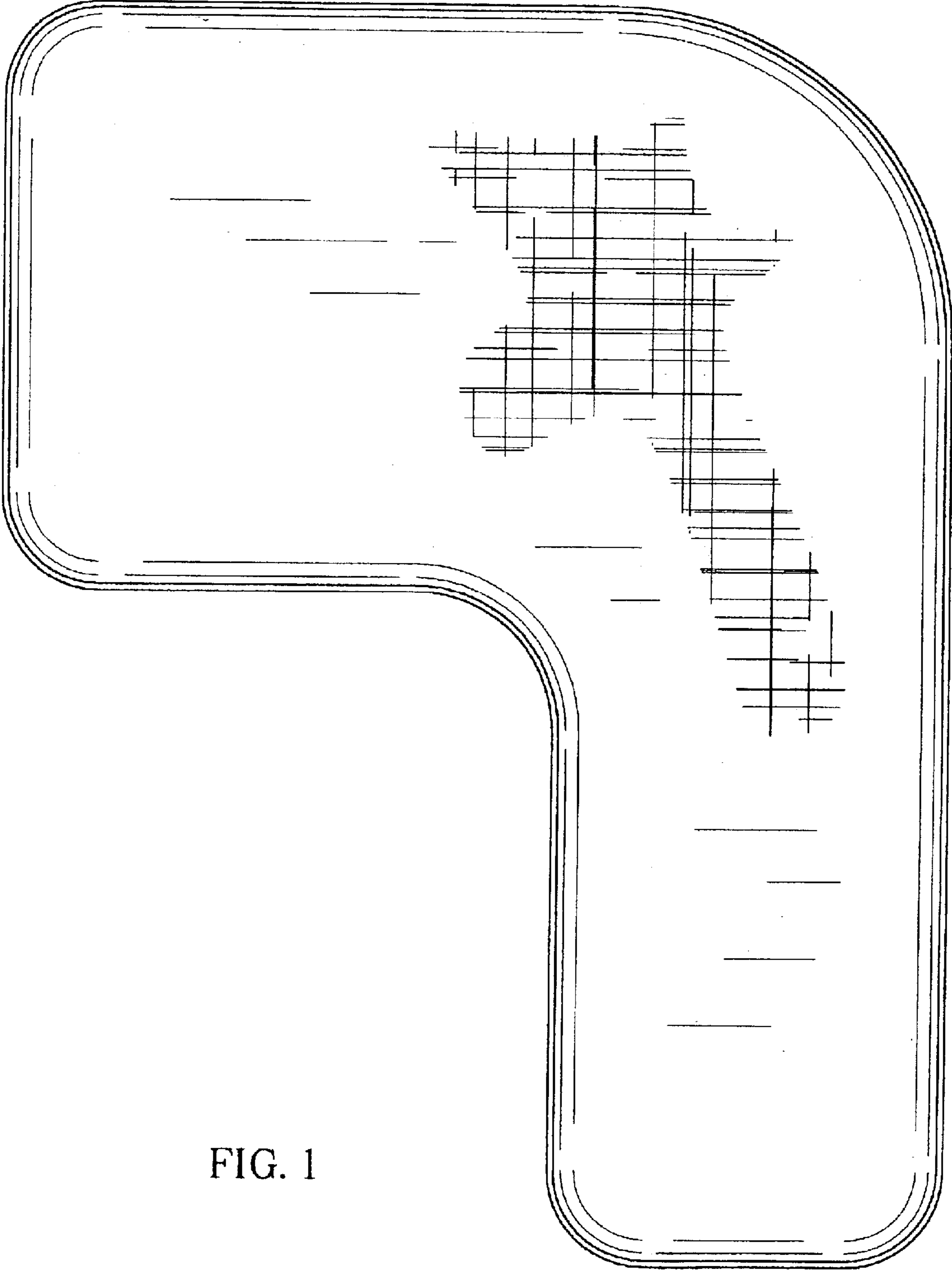

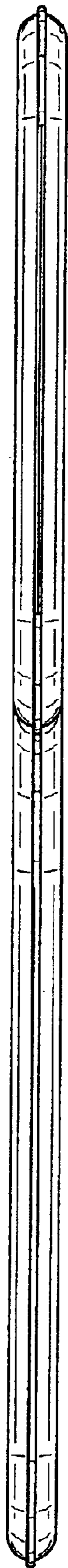

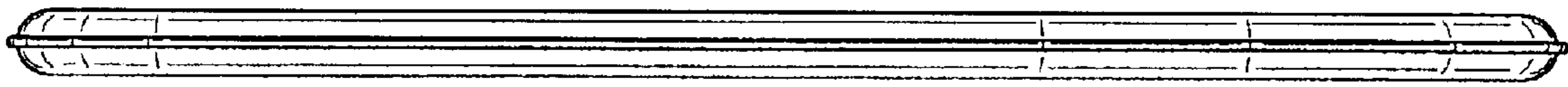

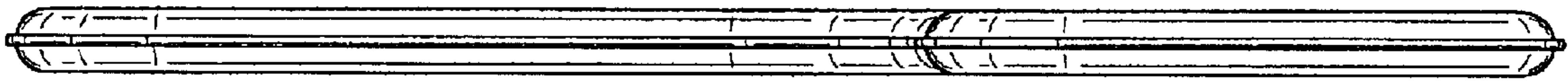
