**DESCRIPTION**

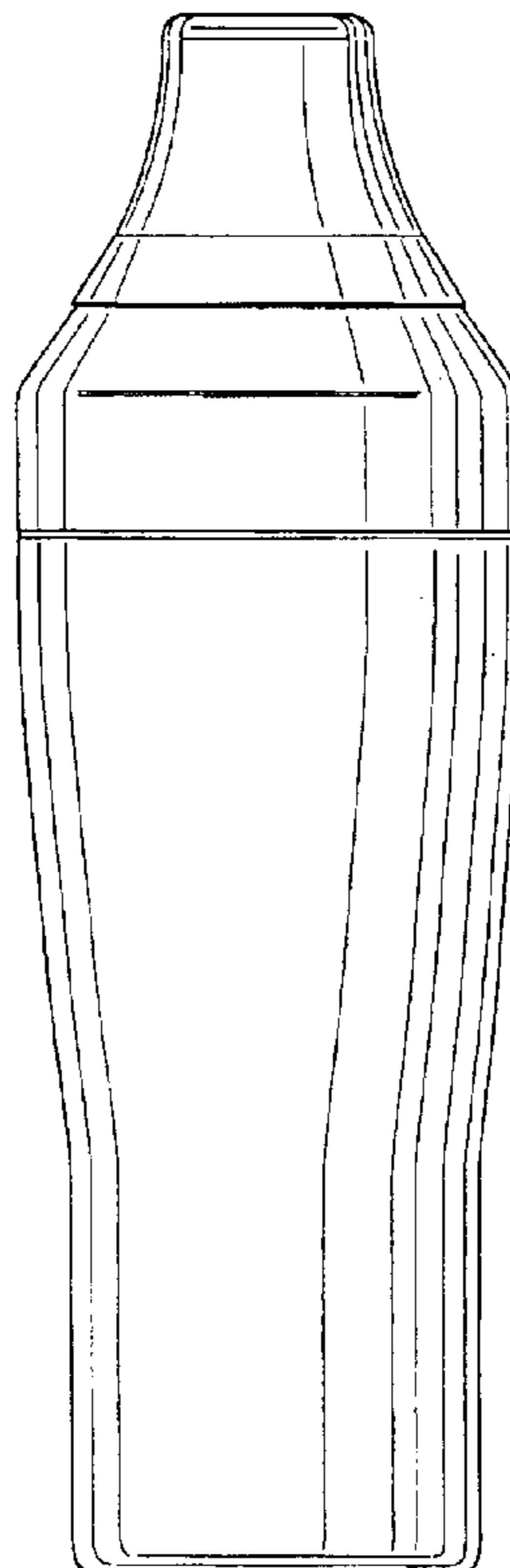
FIG. 1 is a perspective view of the shaker incorporating our new design;

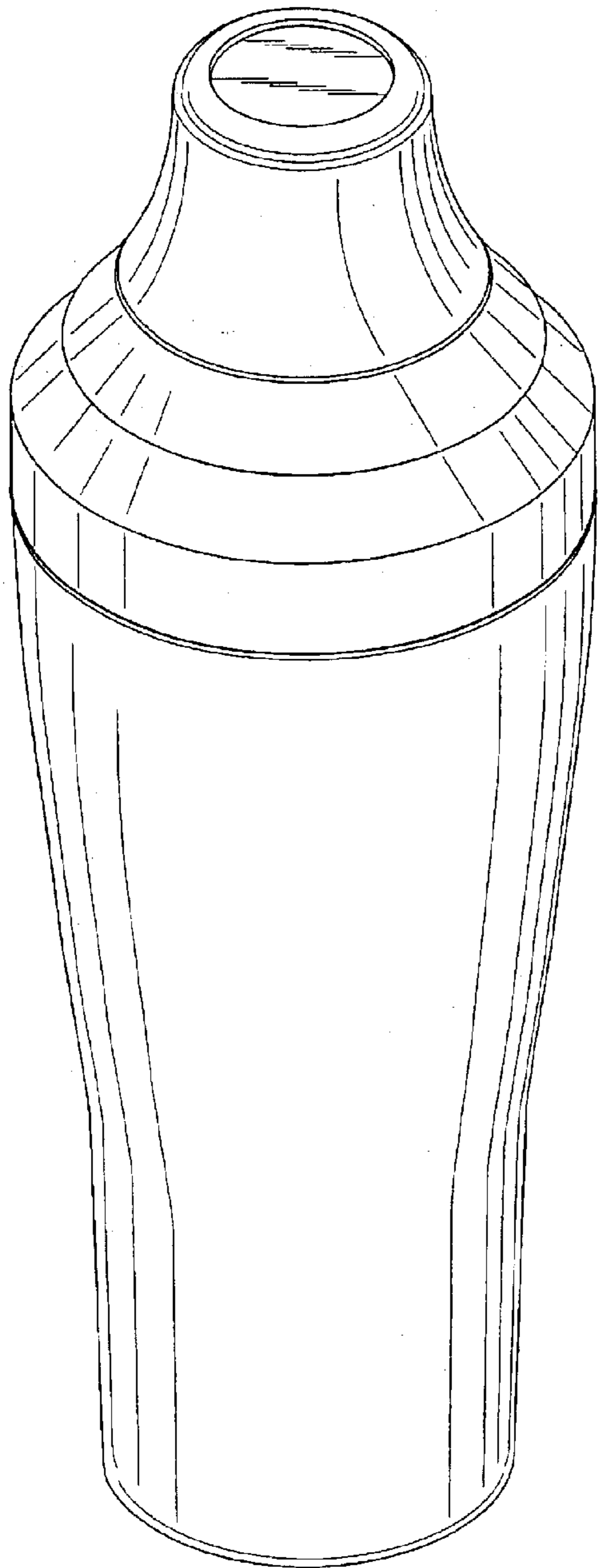

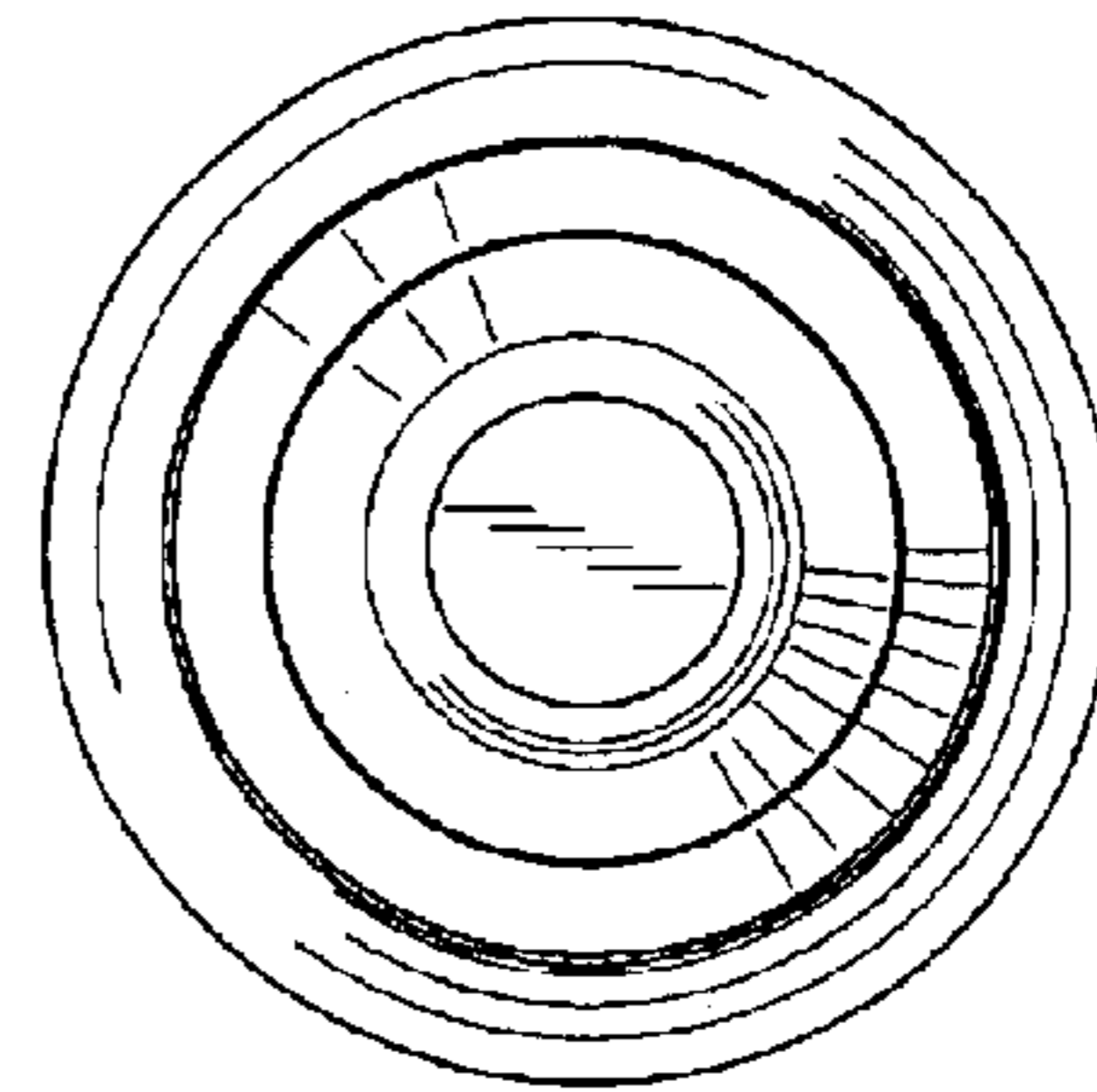

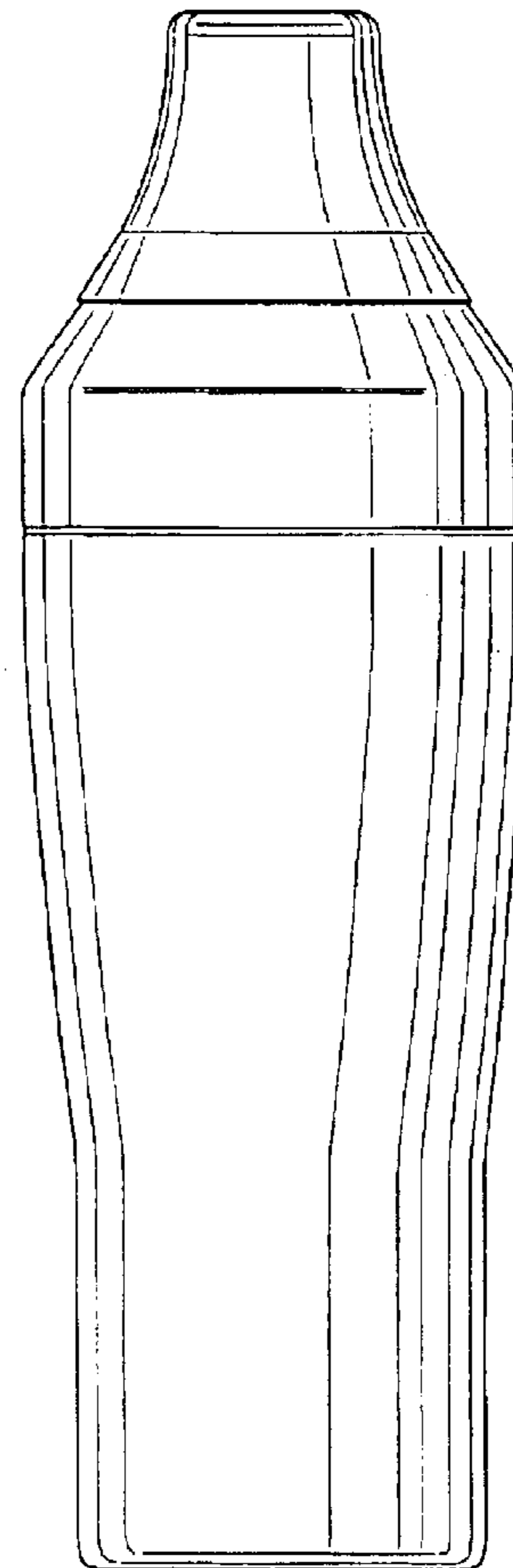
