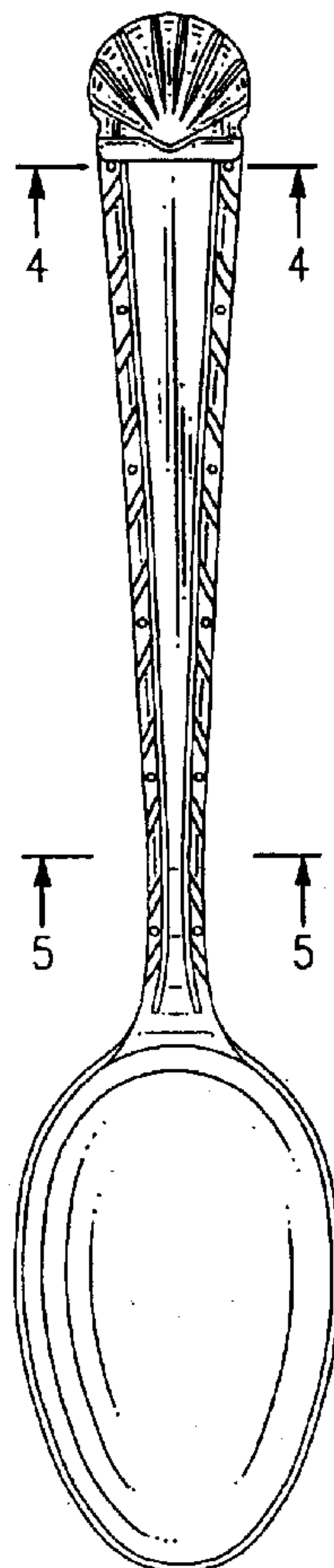
(57) **CLAIM**

The ornamental design for a spoon, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a spoon illustrating my new design; FIG. 2 is a bottom view thereof; FIG. 3 is a right hand elevation view thereof, the left hand elevation view being a mirror image thereof; FIG. 4 is a cross-sectional view taken along lines 4—4 of FIG. 1; and, FIG. 5 is a cross-sectional view taken along lines 5—5 of FIG. 1.

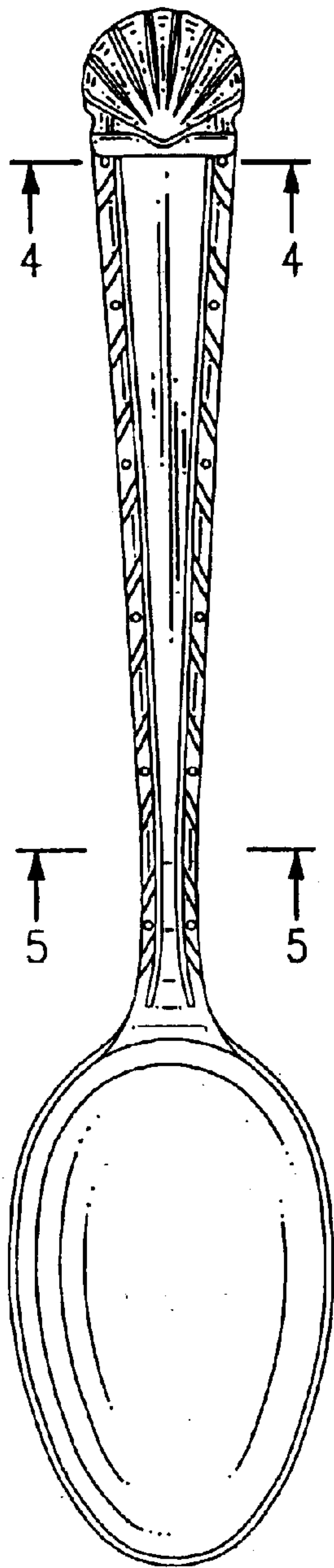

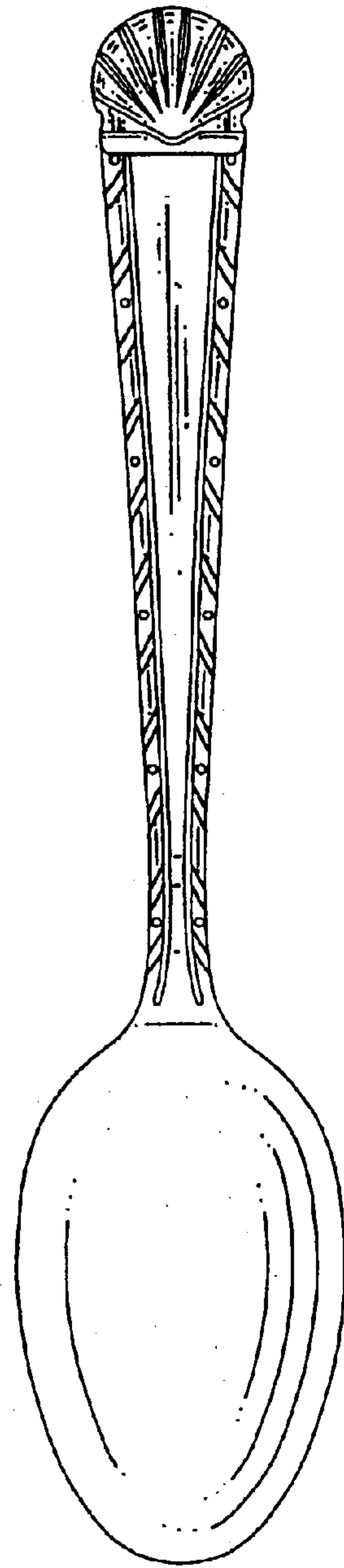

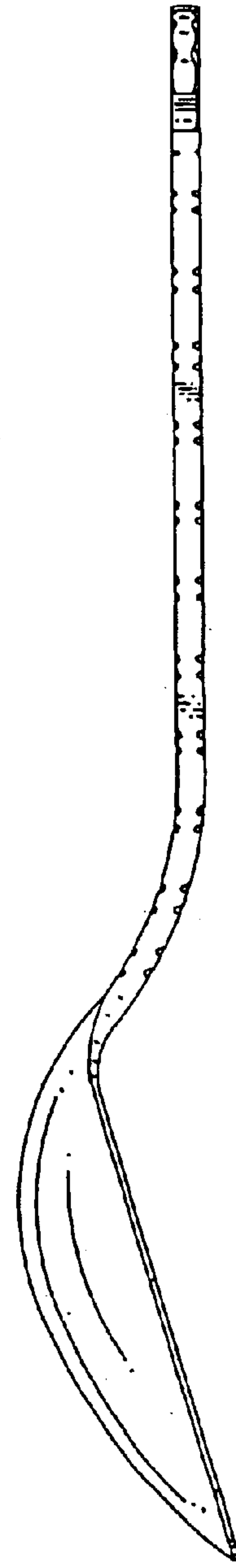
