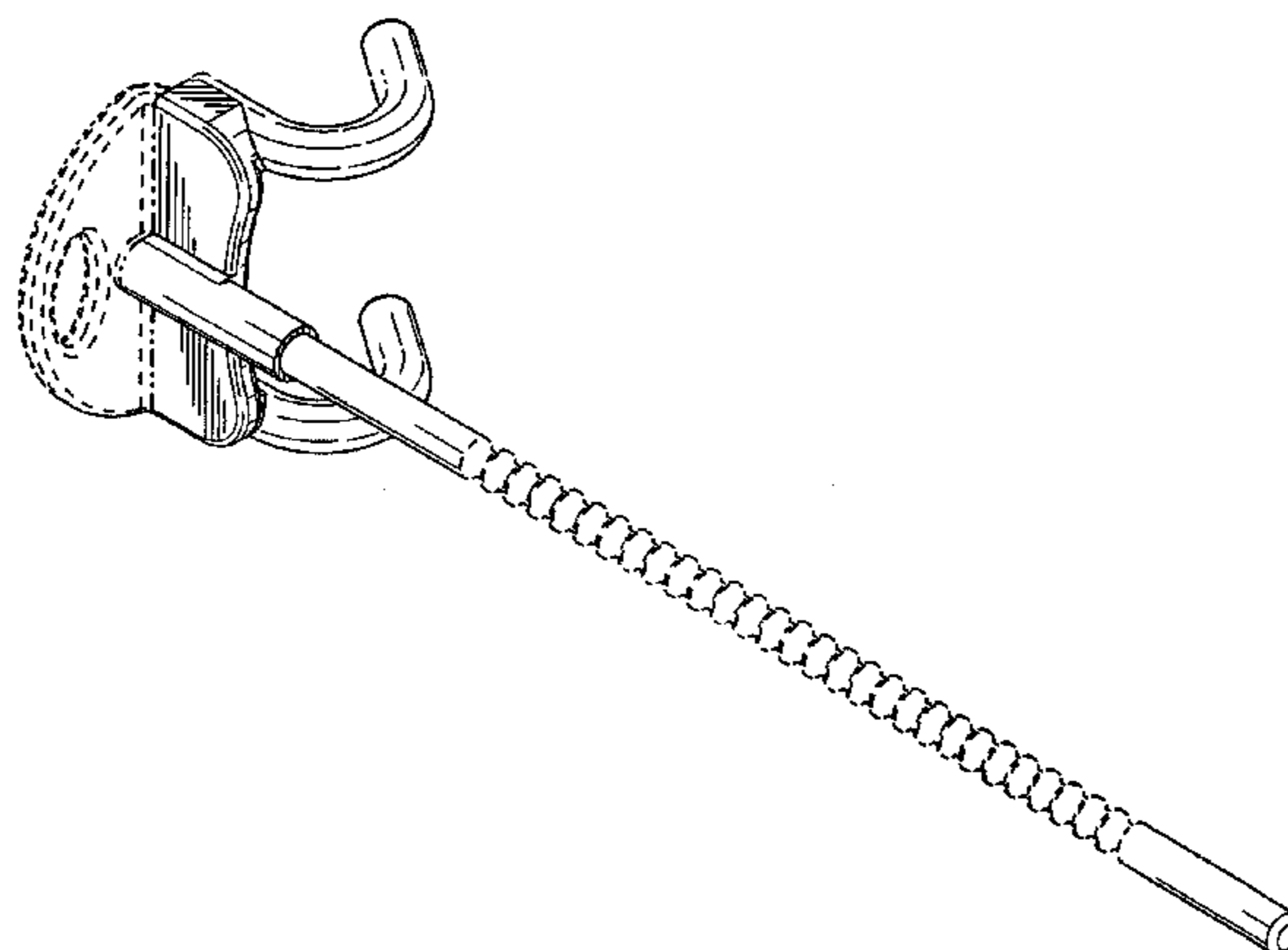
(57) **CLAIM**

We claim the ornamental design for a lock assembly component, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a lock assembly component according to a first preferred embodiment of our new design; FIG. 2 is a second perspective view of the lock assembly component of FIG. 1; FIG. 3 is a left side elevational view of the lock assembly component of FIG. 1; FIG. 4 is a right side elevational view of the lock assembly component of FIG. 1; FIG. 5 is a front elevational view of the lock assembly component of FIG. 1; FIG. 6 is a rear elevational view of the lock assembly component of FIG. 1; FIG. 7 is a top plan view of the lock assembly component of FIG. 1; FIG. 8 is a bottom plan view of the lock assembly component of FIG. 1; FIG. 9 is a perspective view of a lock assembly component according to a second preferred embodiment of our new design; FIG. 10 is a second perspective view of the lock assembly component of FIG. 9; FIG. 11 is a left side elevational view of the lock assembly component of FIG. 9; FIG. 12 is a right side elevational view of the lock assembly component of FIG. 9; FIG. 13 is a front elevational view of the lock assembly component of FIG. 9; FIG. 14 is a rear elevational view of the lock assembly component of FIG. 9; FIG. 15 is a top plan view of the lock assembly component of FIG. 9; and, FIG. 16 is a bottom plan view of the lock assembly component of FIG. 9. The dashed lines in FIGS. 1-16 represent environment and are for illustrative purposes only and do not constitute part of the claimed design. The phantom lines in FIGS. 1-16 define the border between claimed and unclaimed matter.

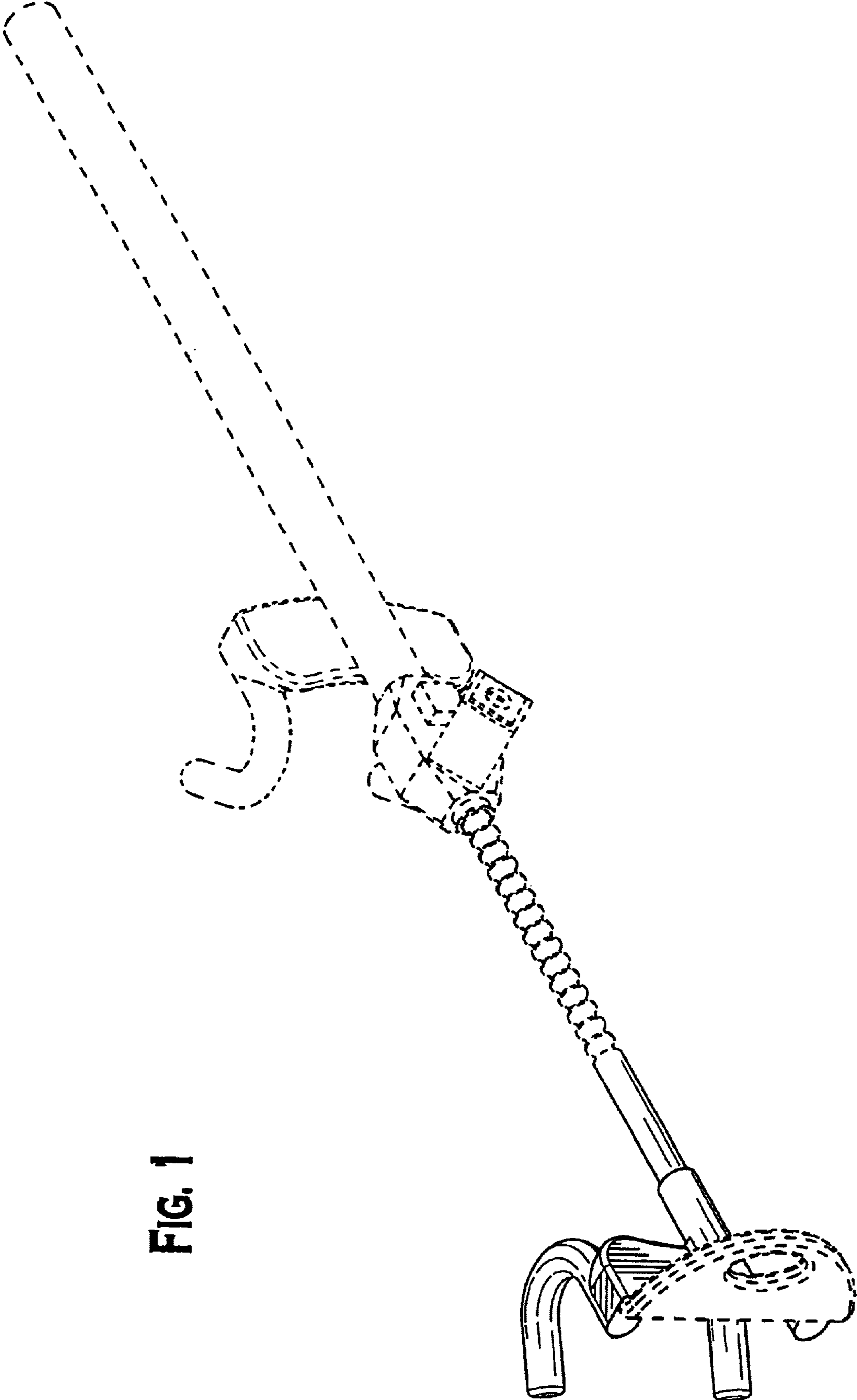

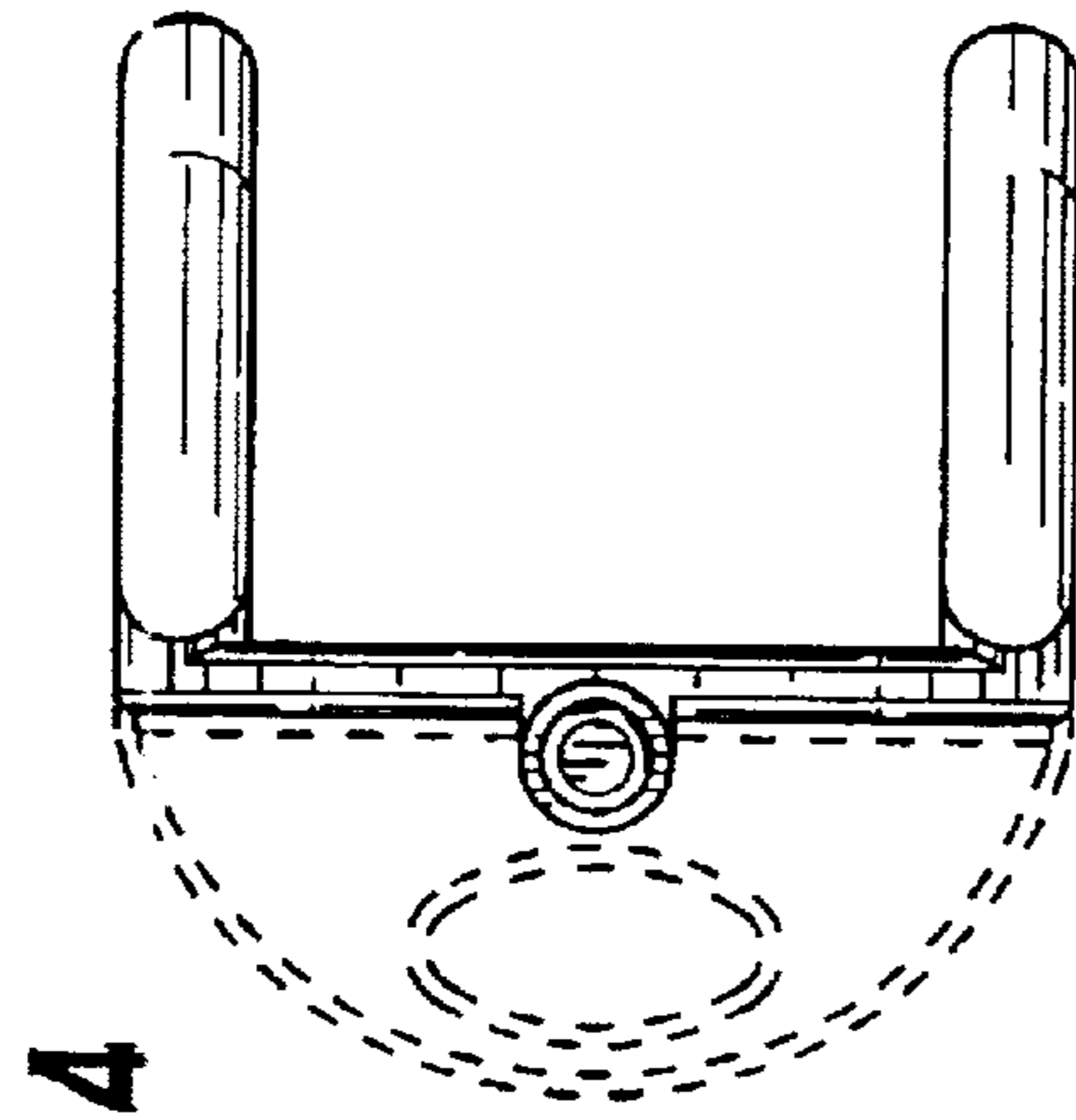

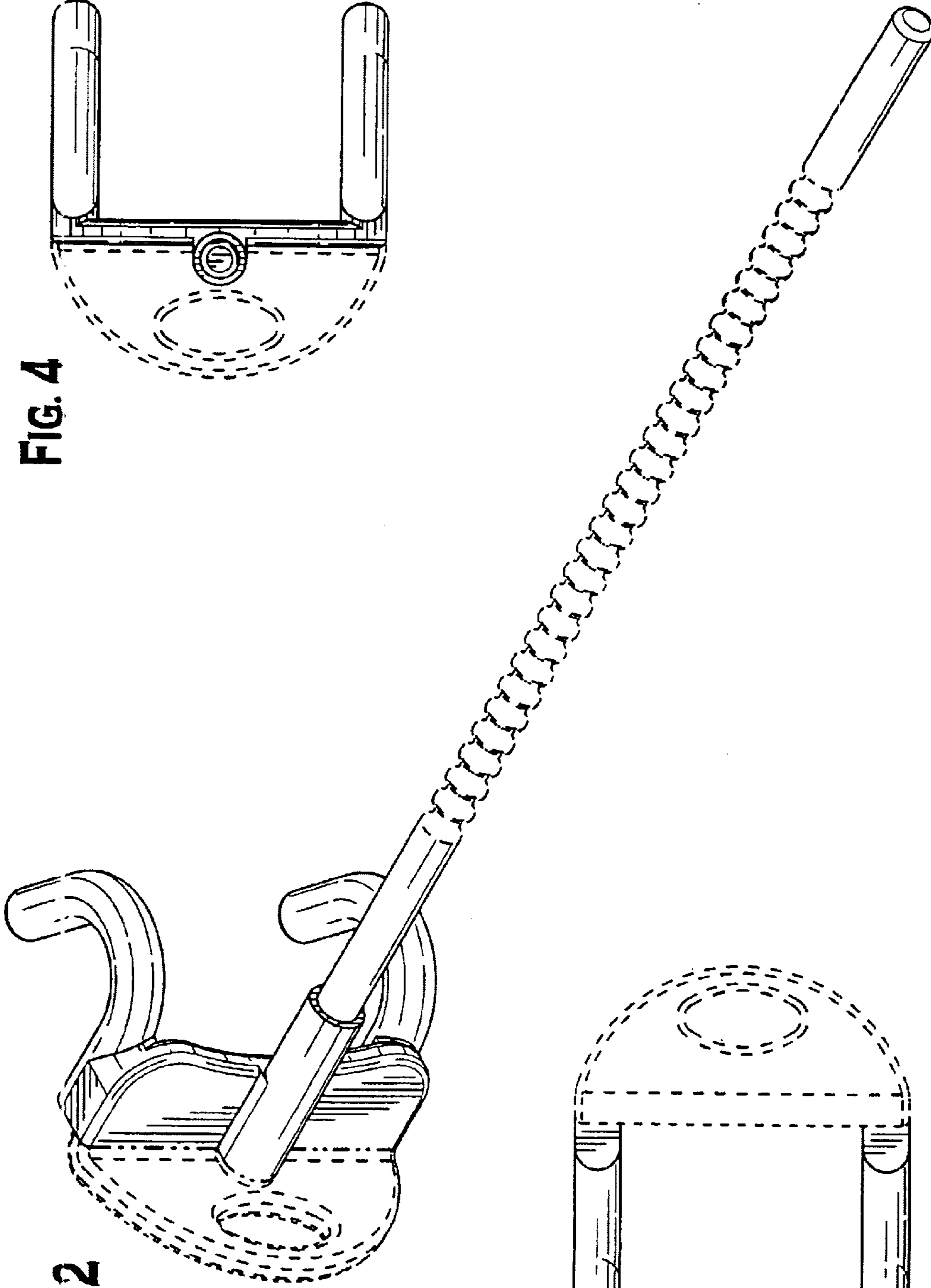

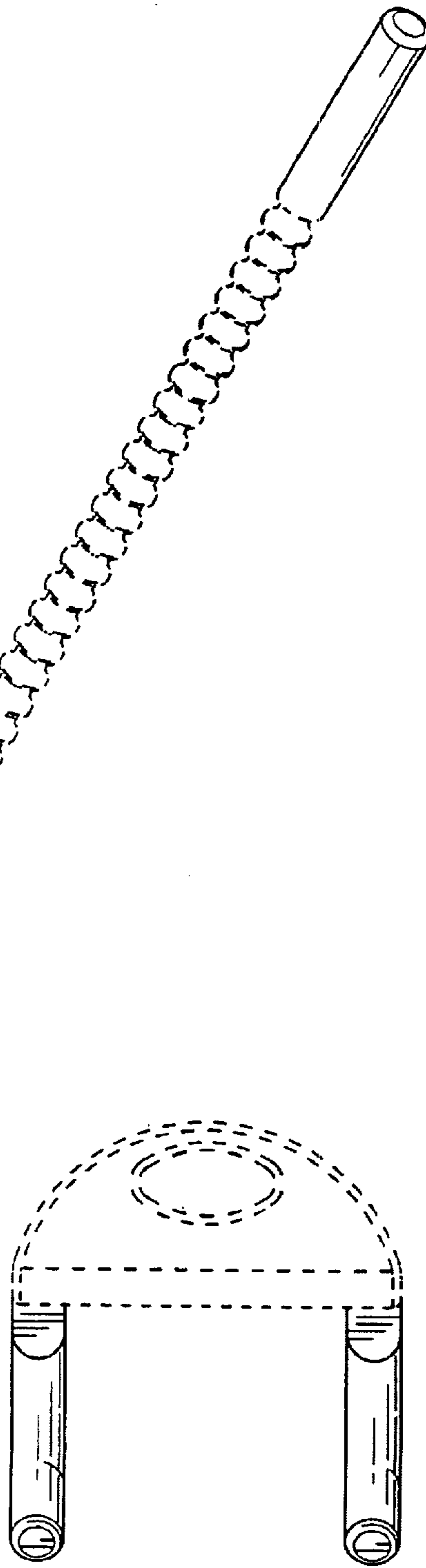
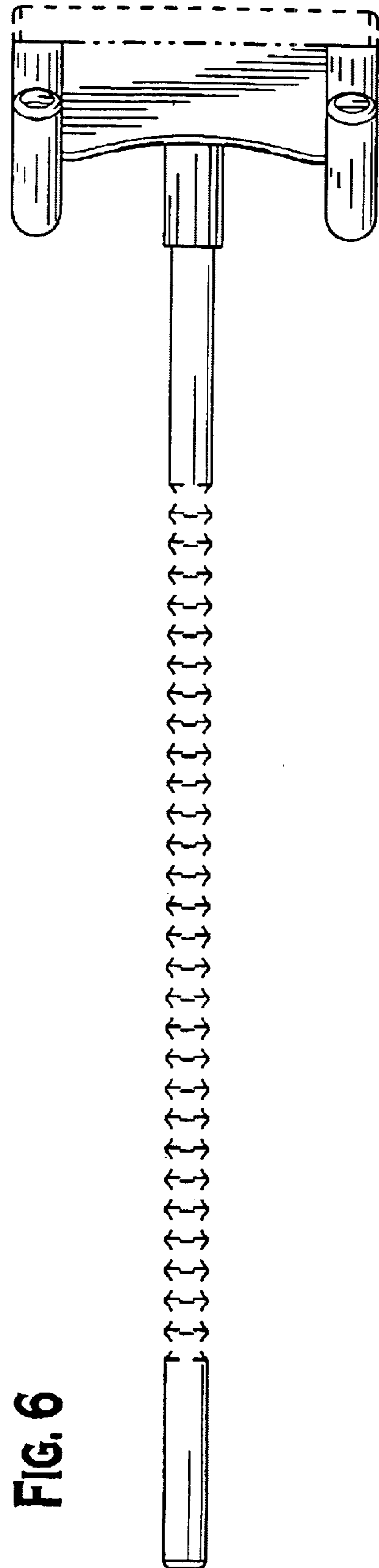
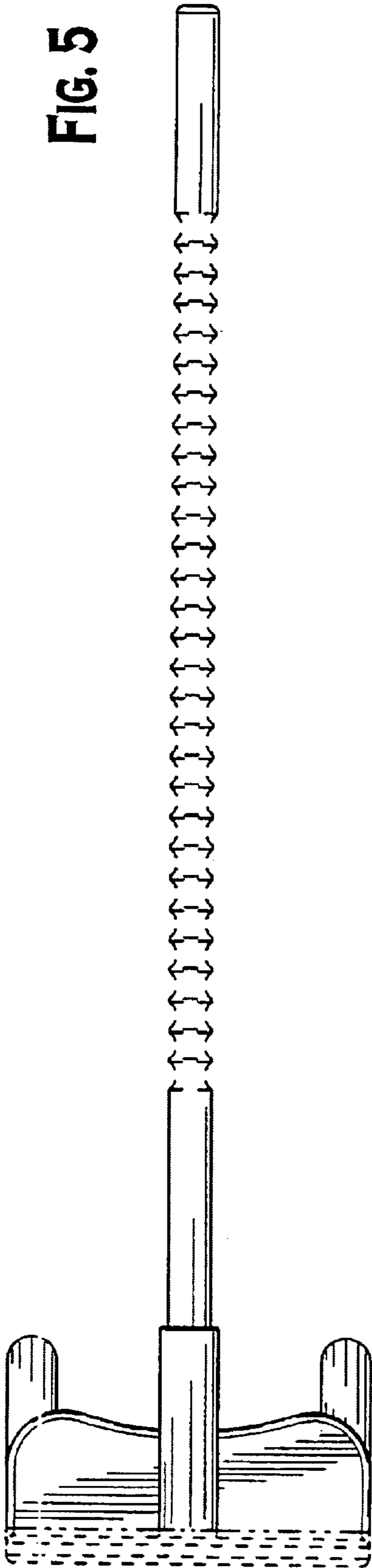

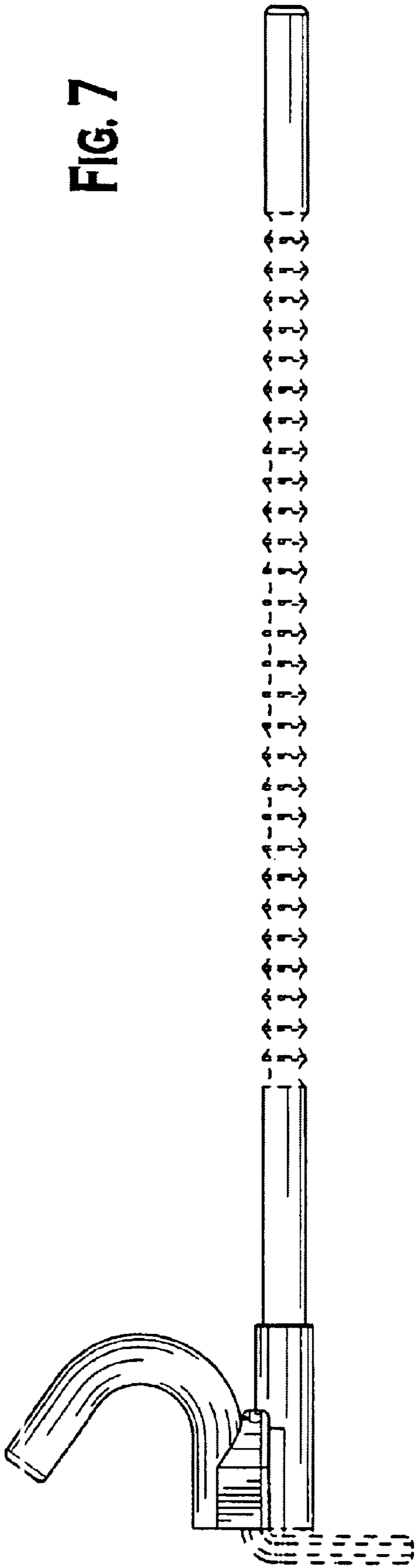
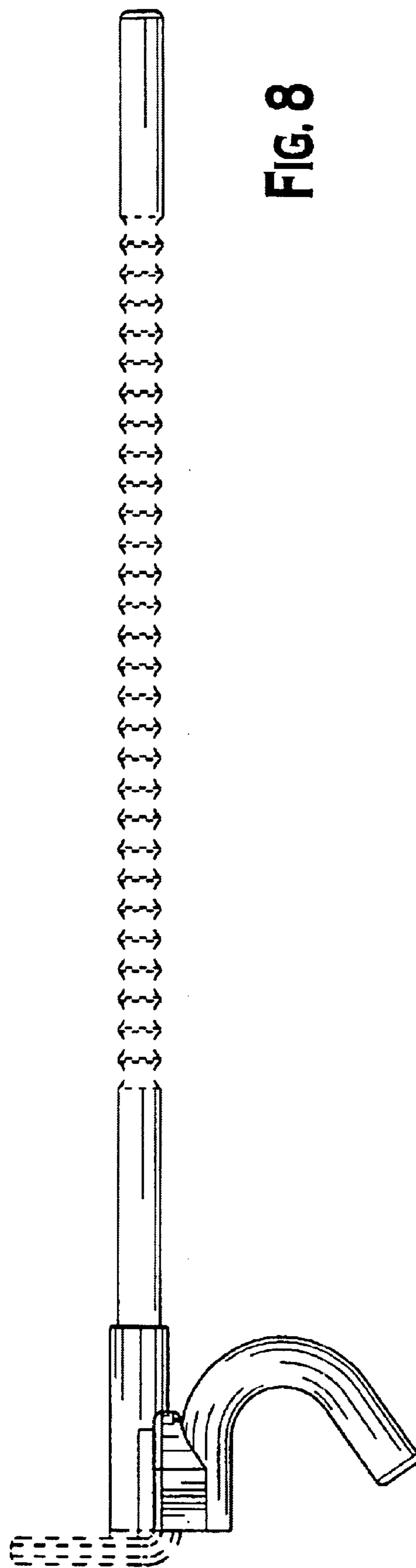

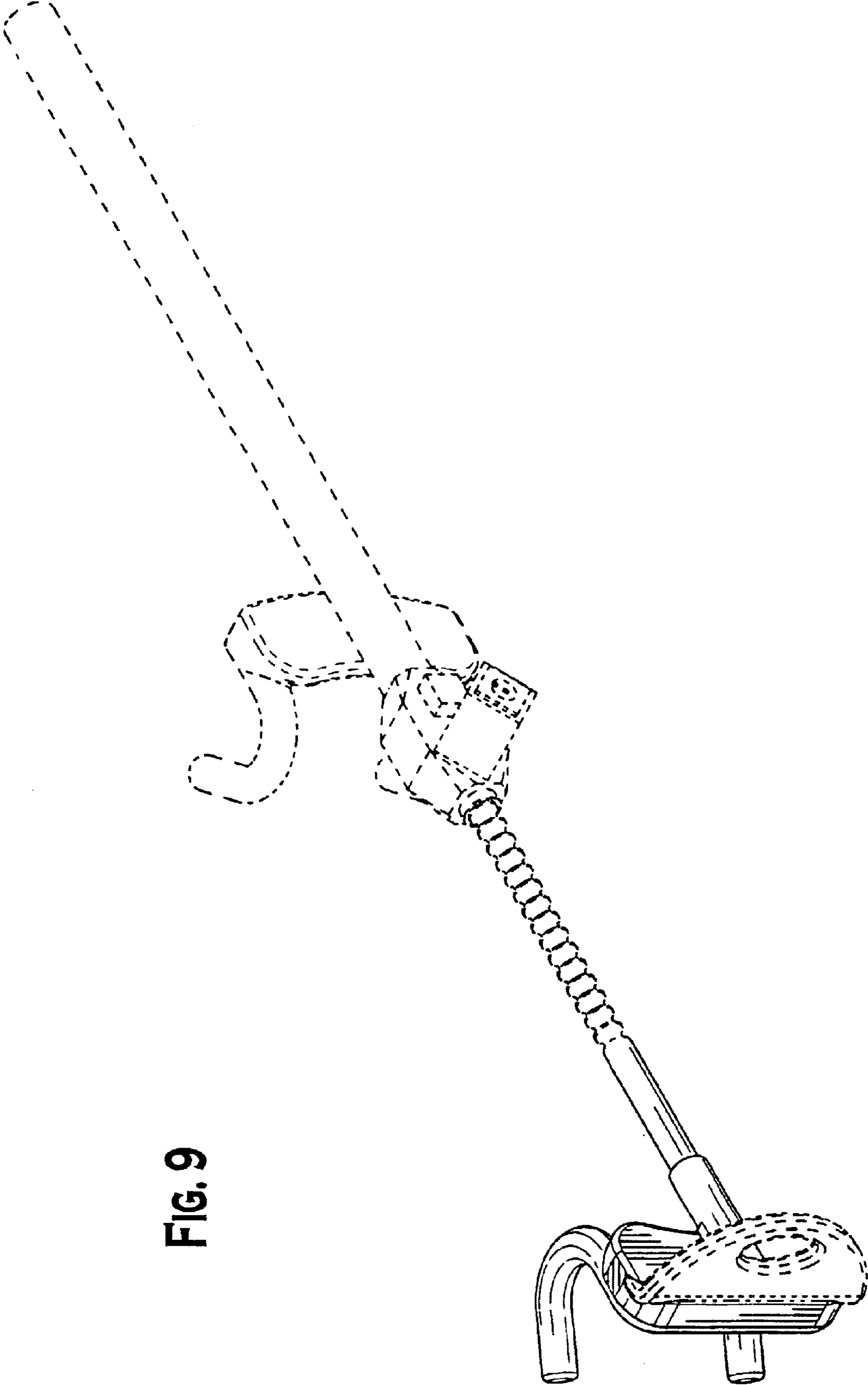

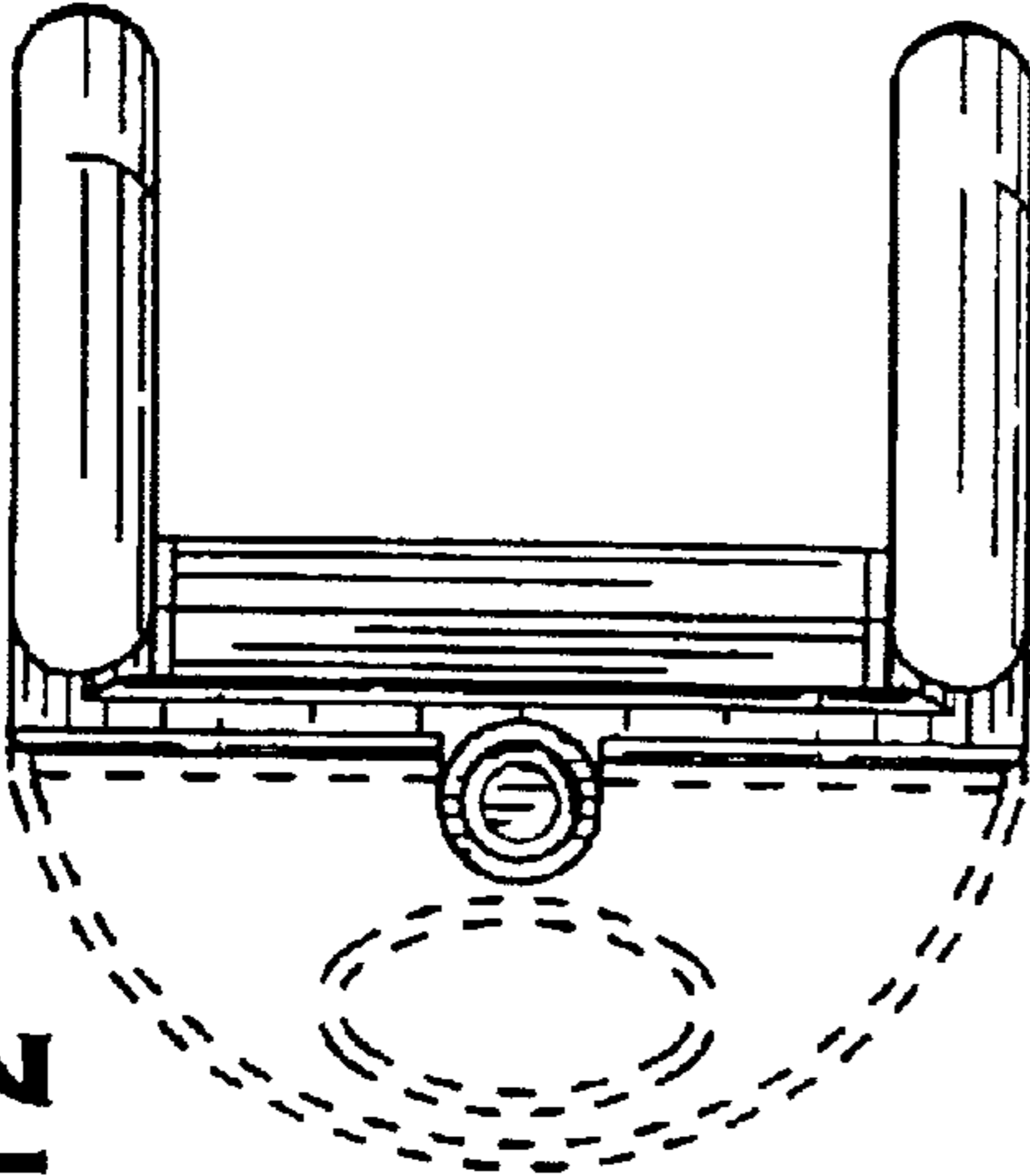

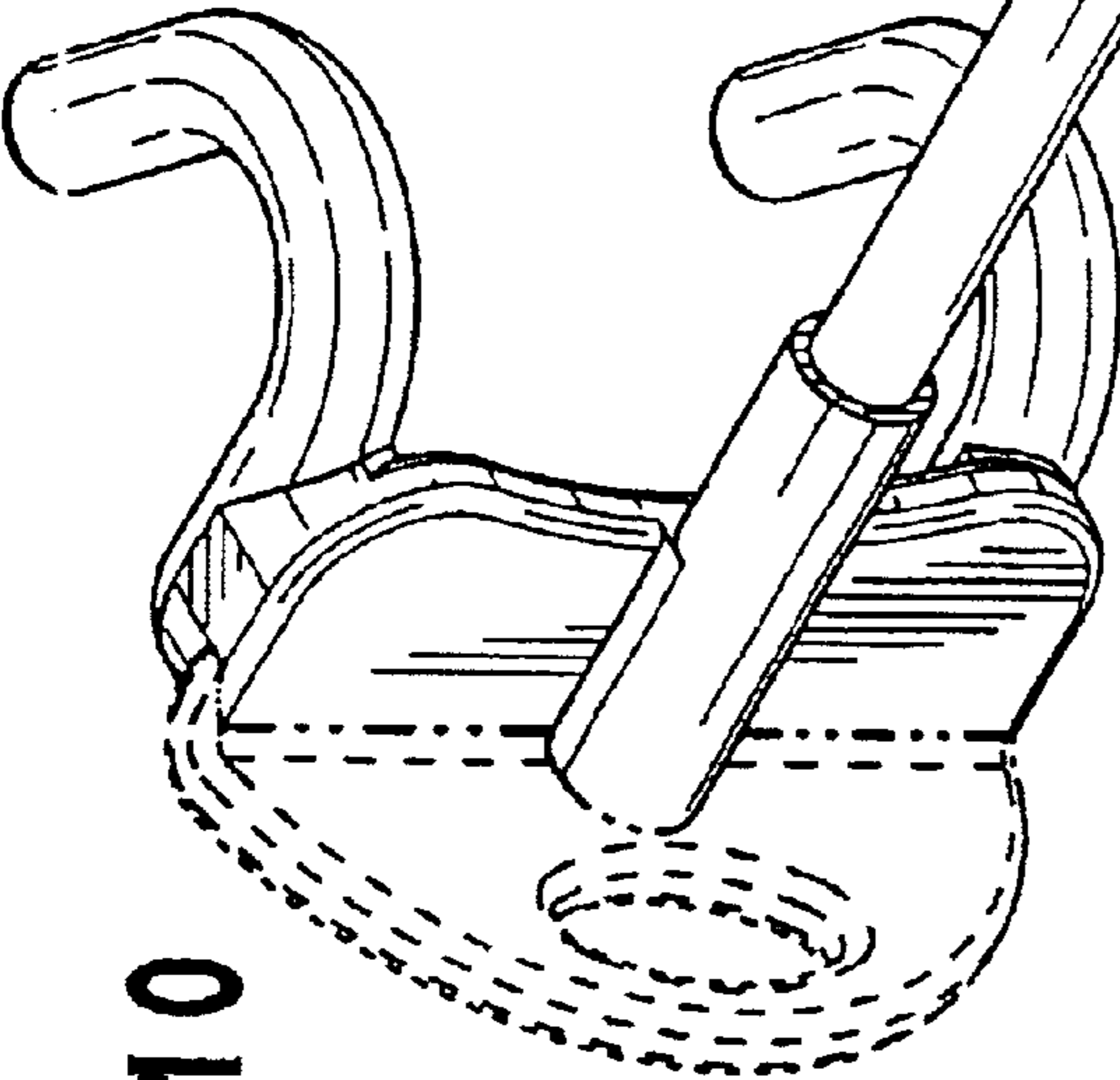

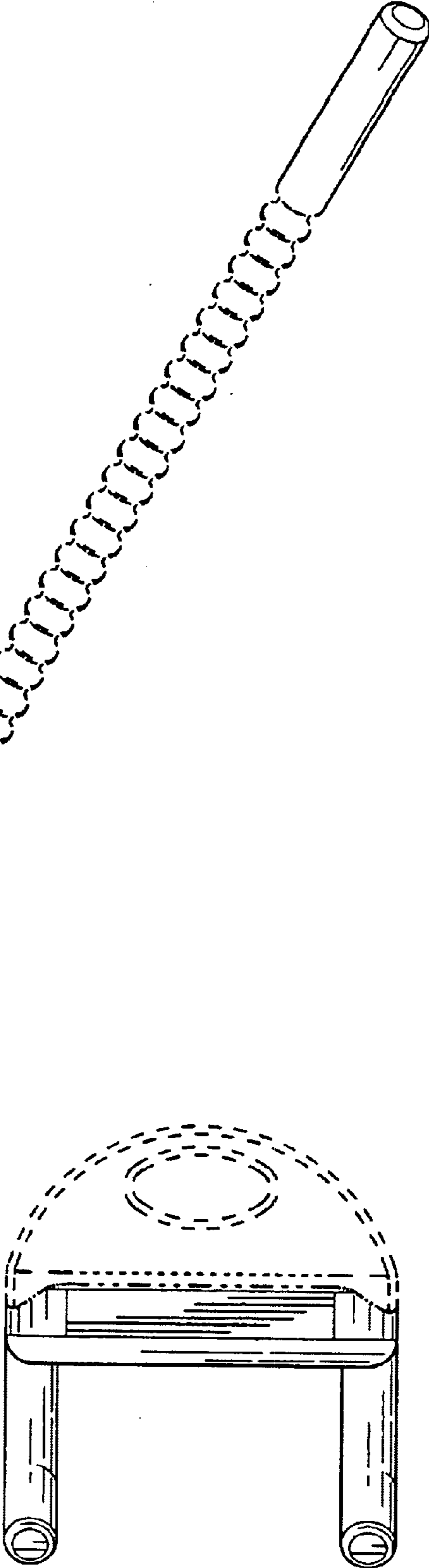
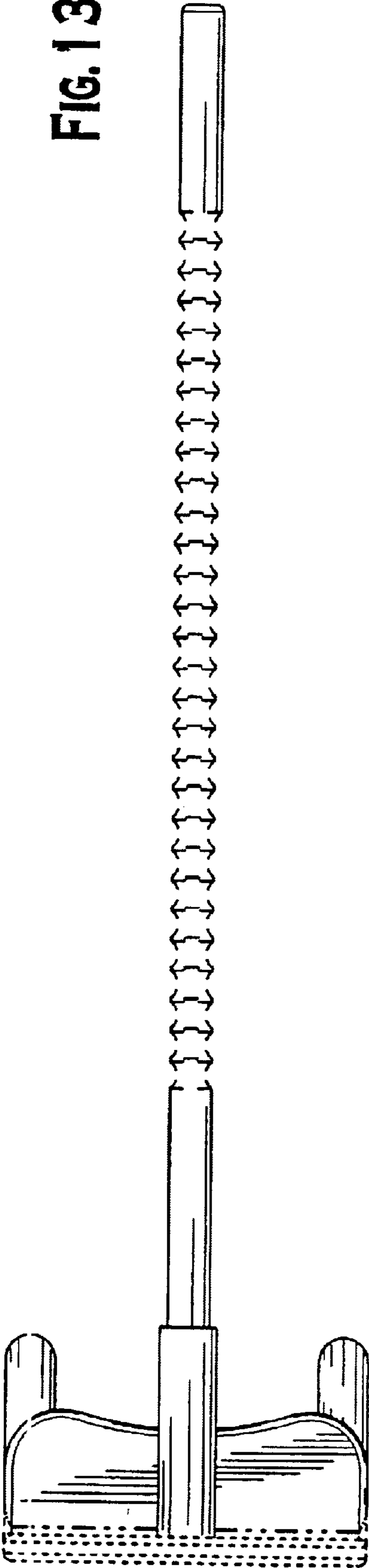

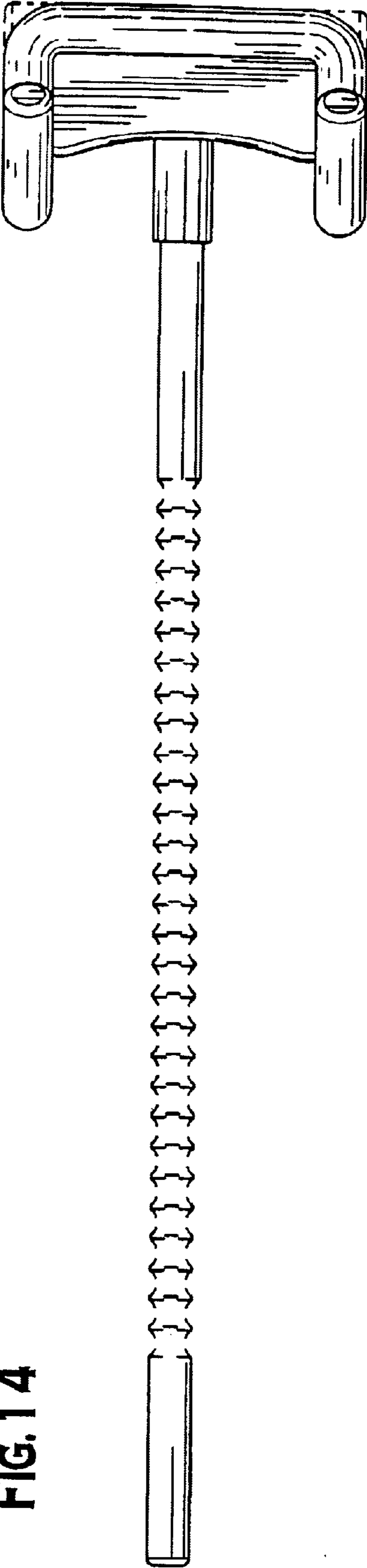

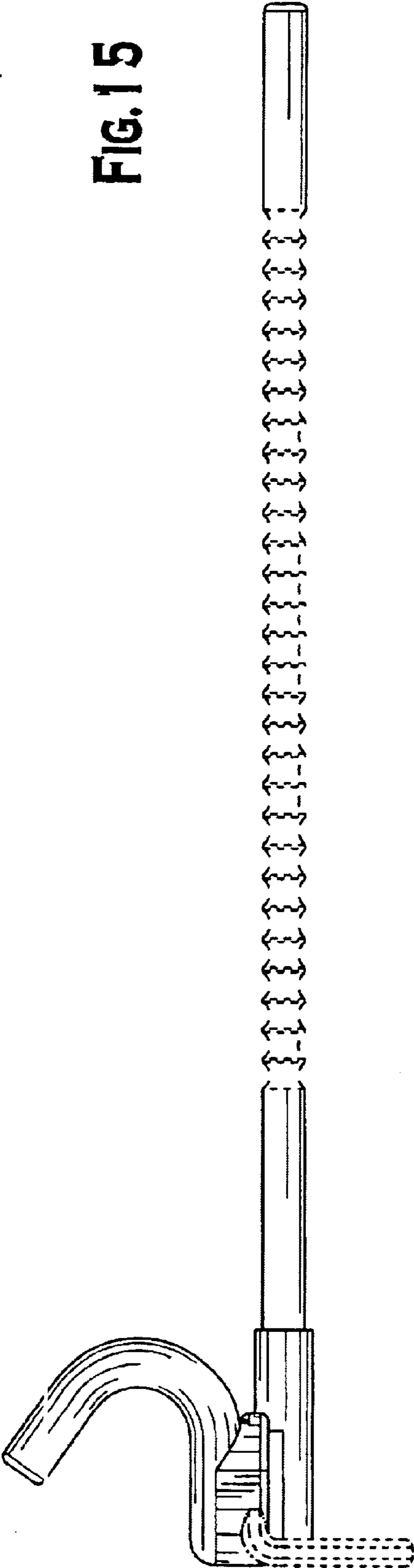
