The ornamental design for a watch casing and portion of a strap, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a watch casing and portion of a strap showing my new design;

FIG. 2 is a left side elevational view thereof;

FIG. 3 is a right side elevational view thereof;

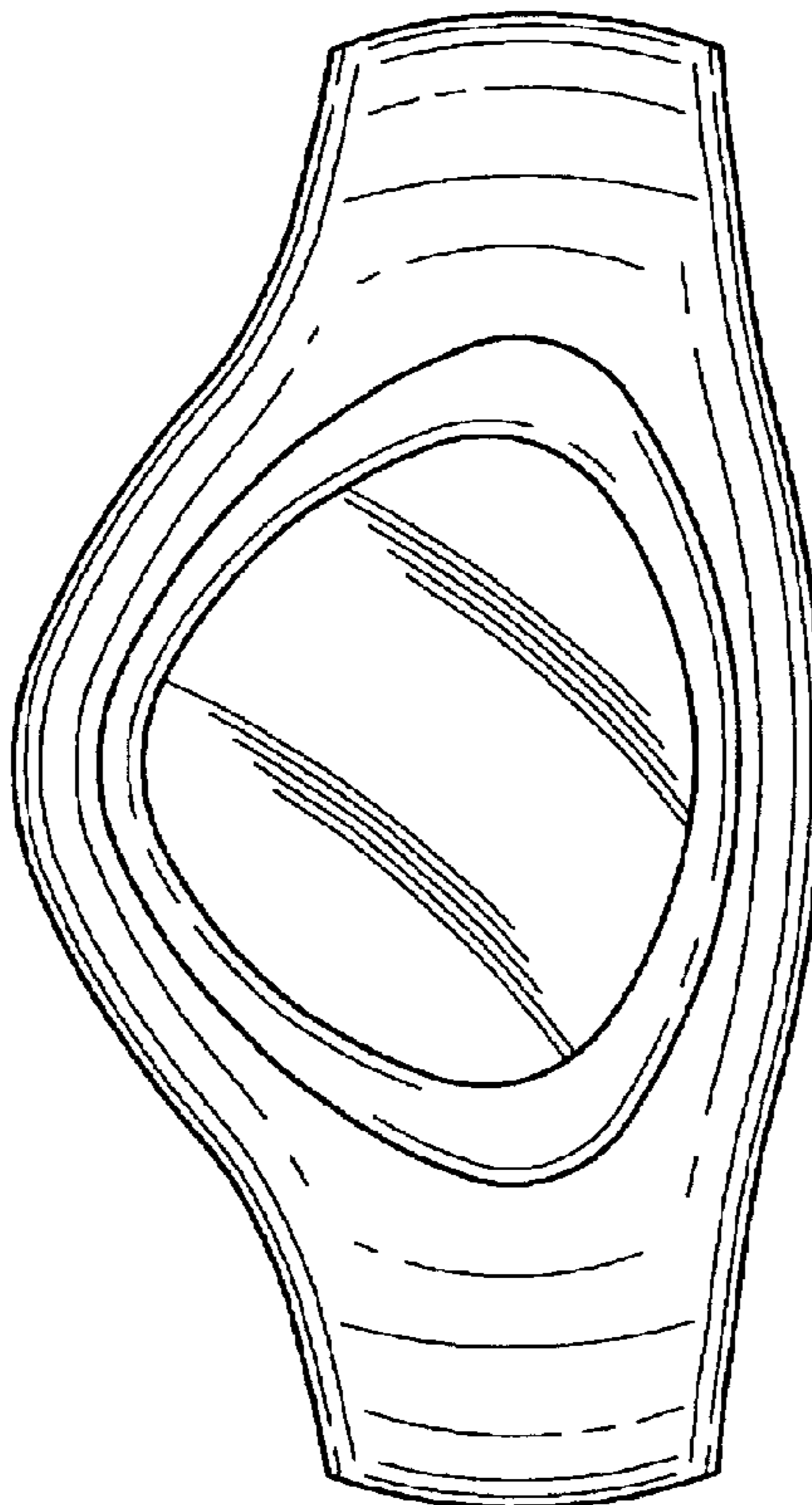
FIG. 4 is a bottom plan view thereof;

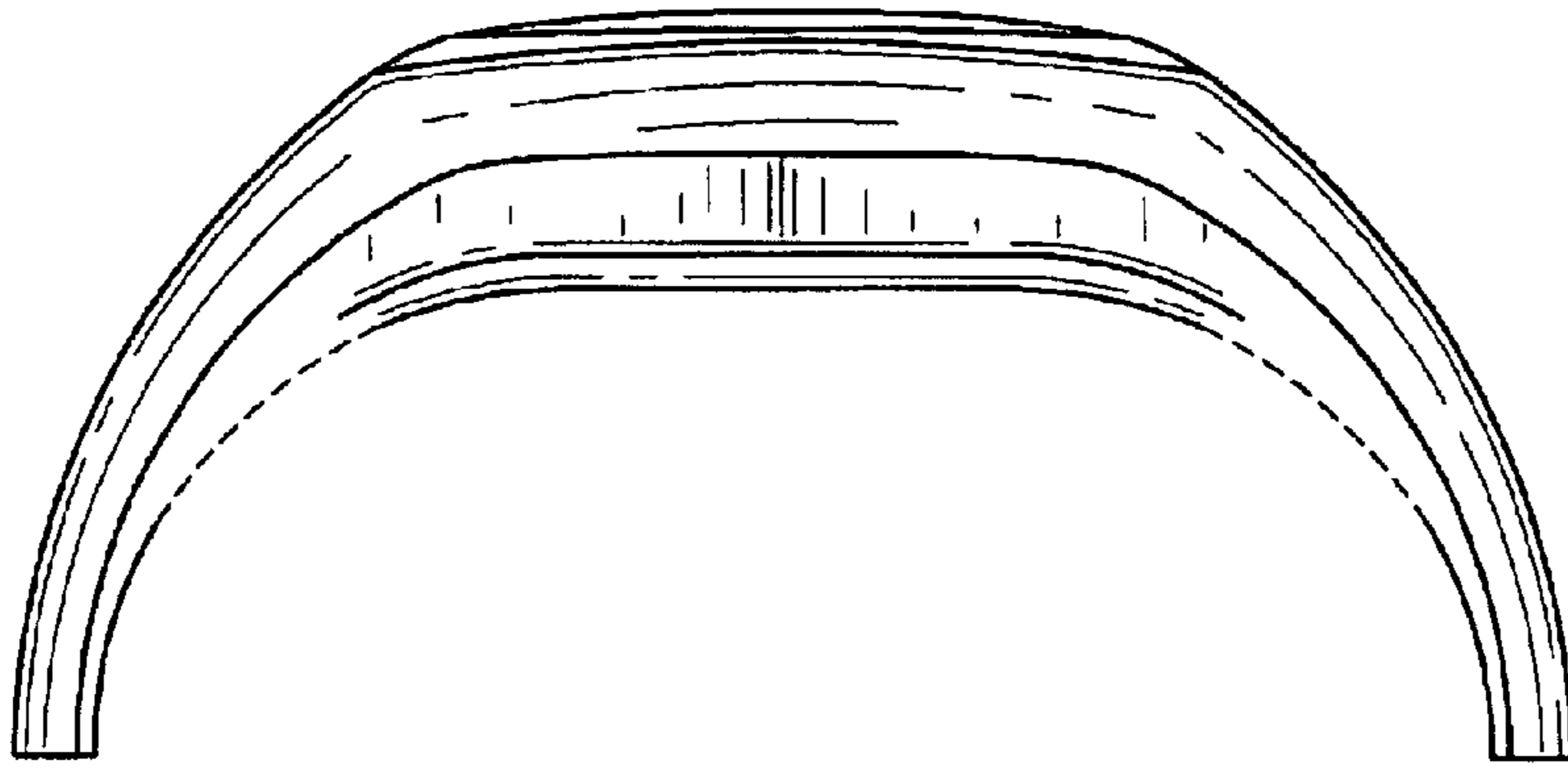

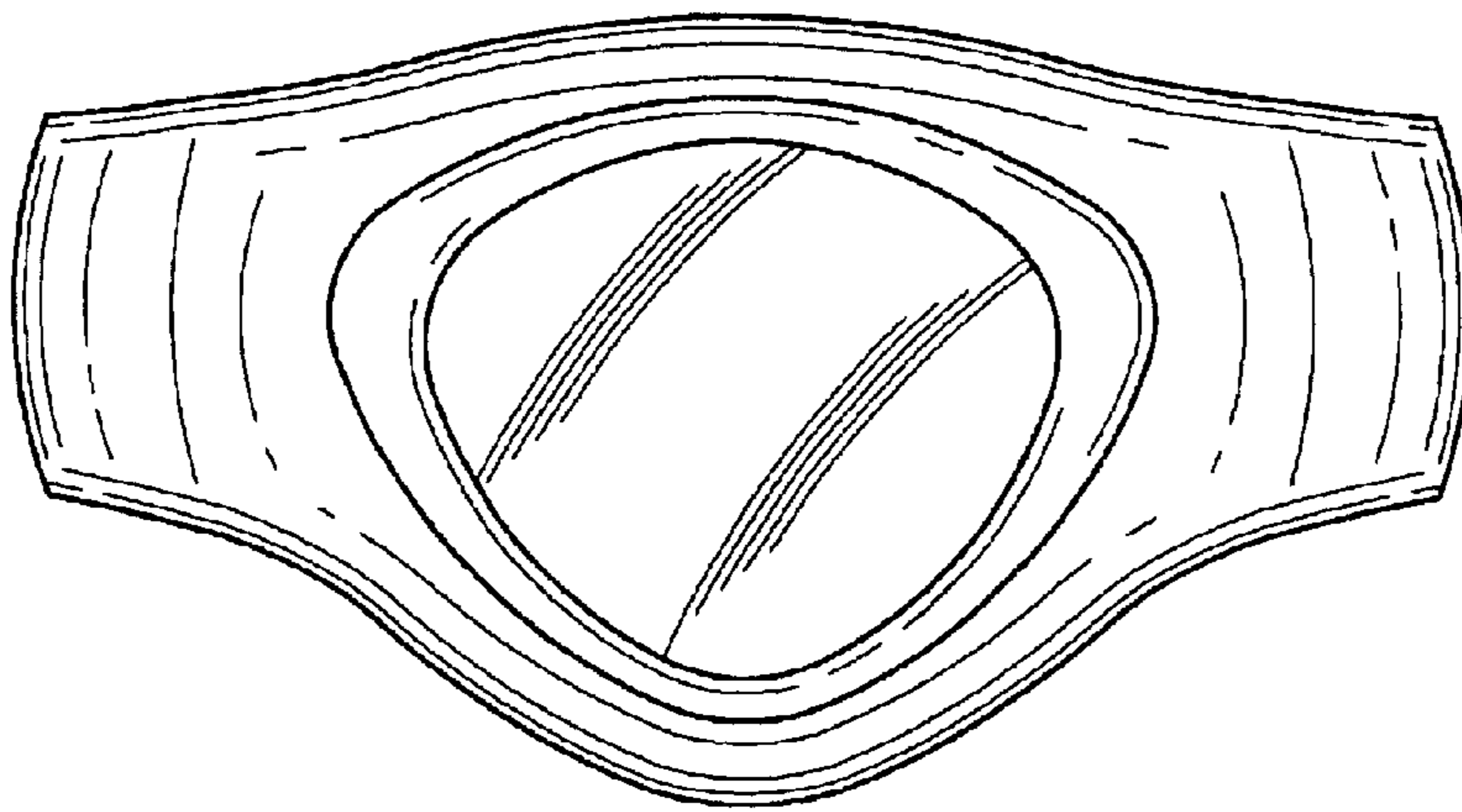

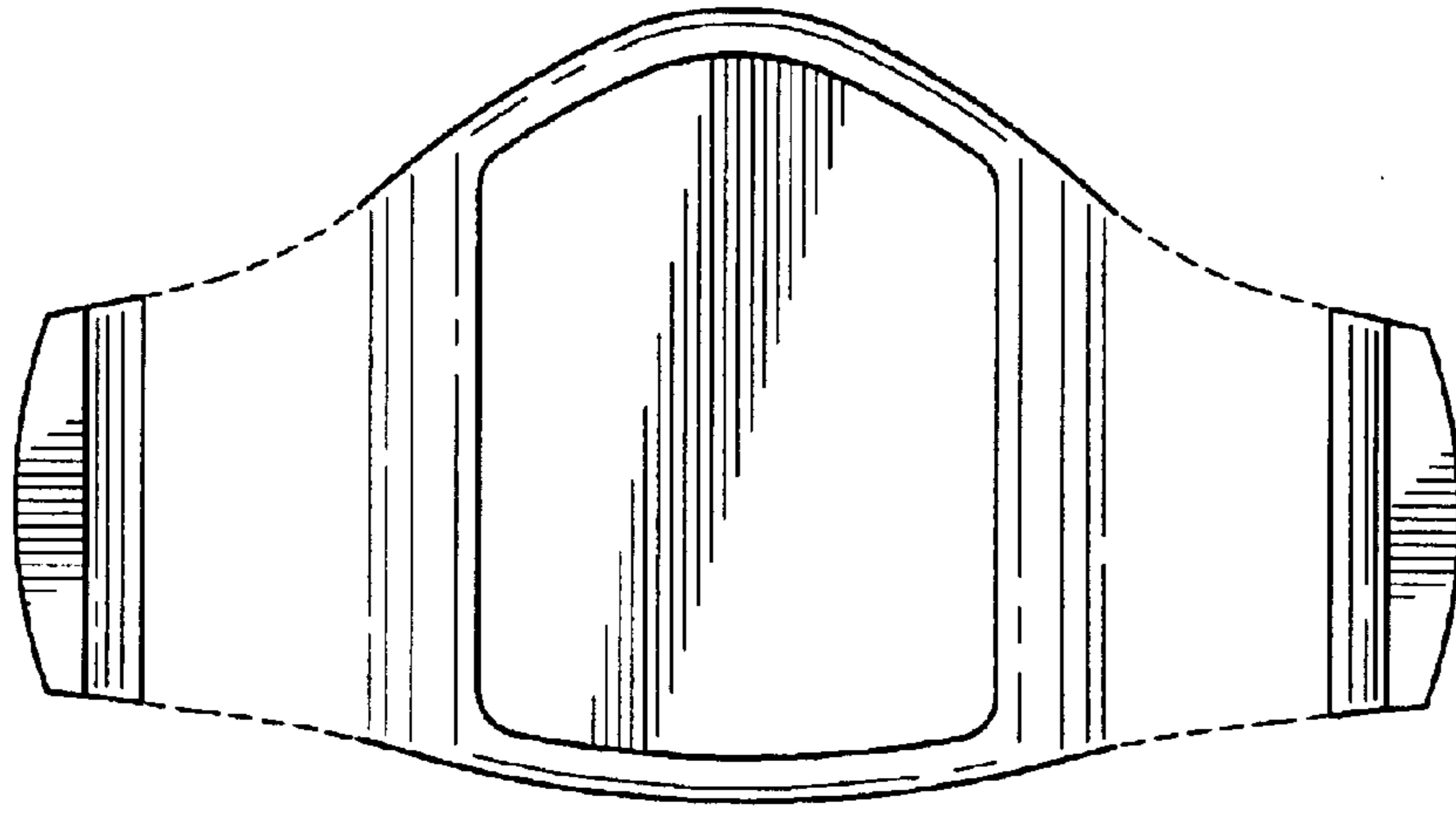

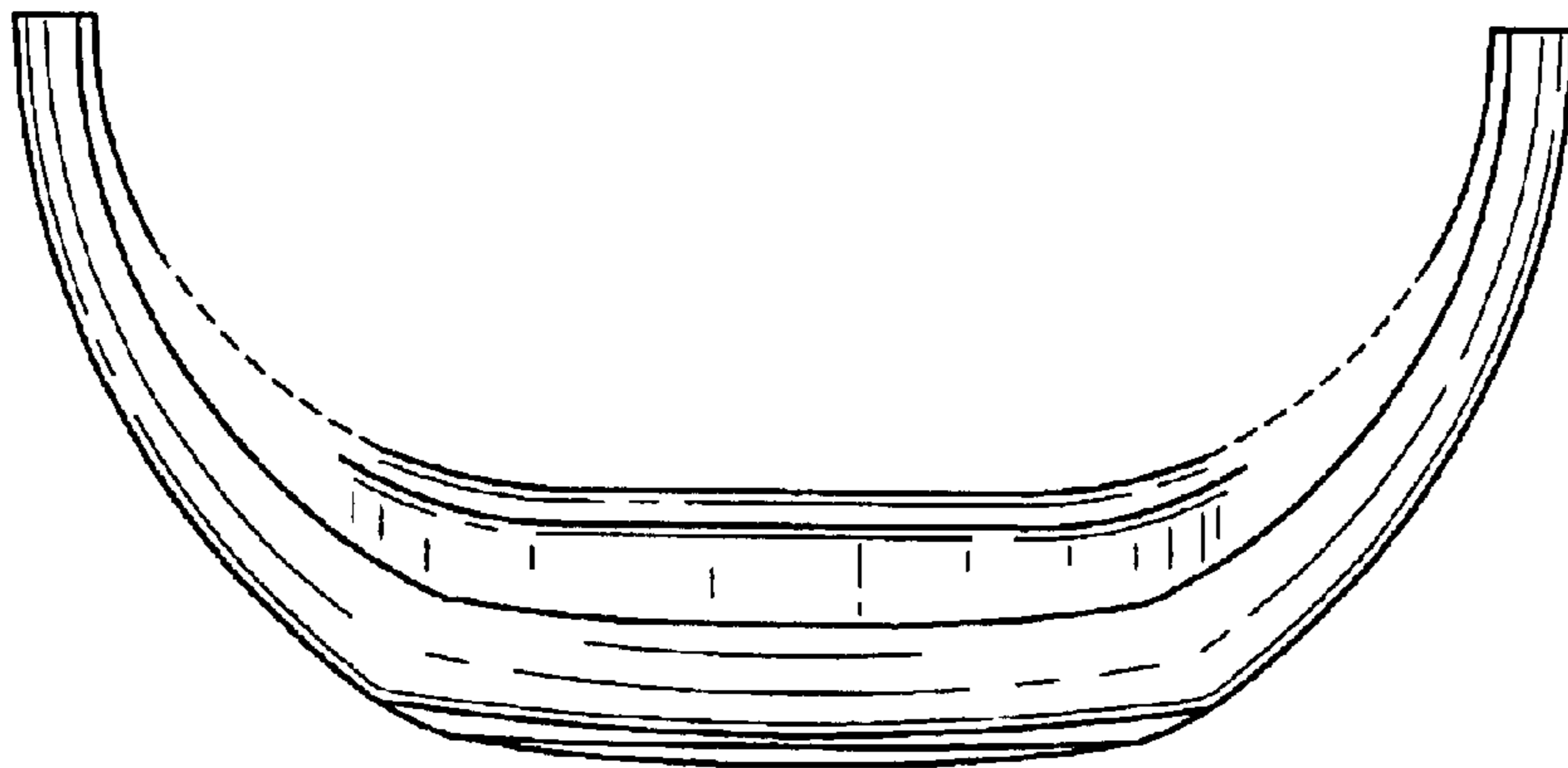

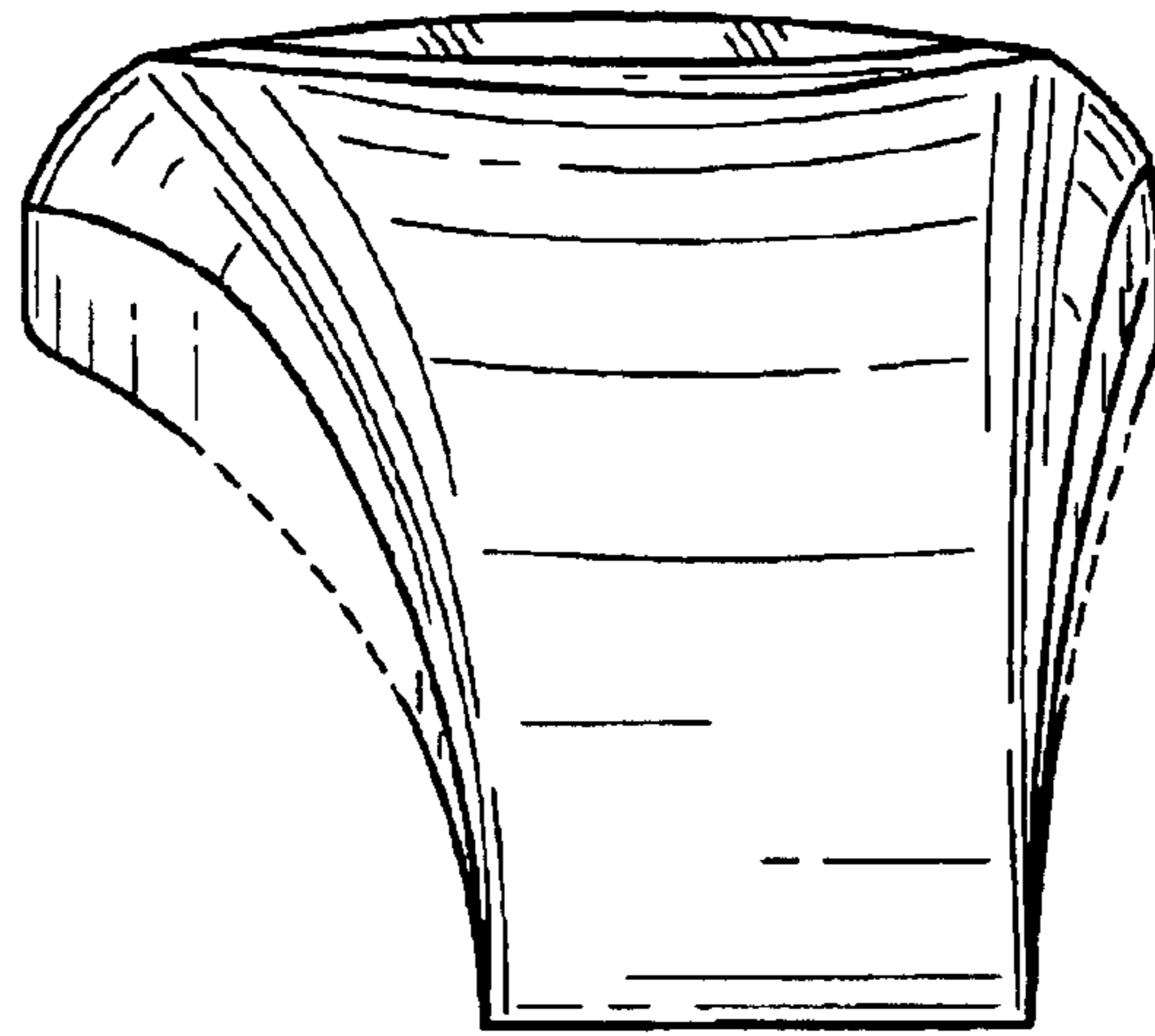

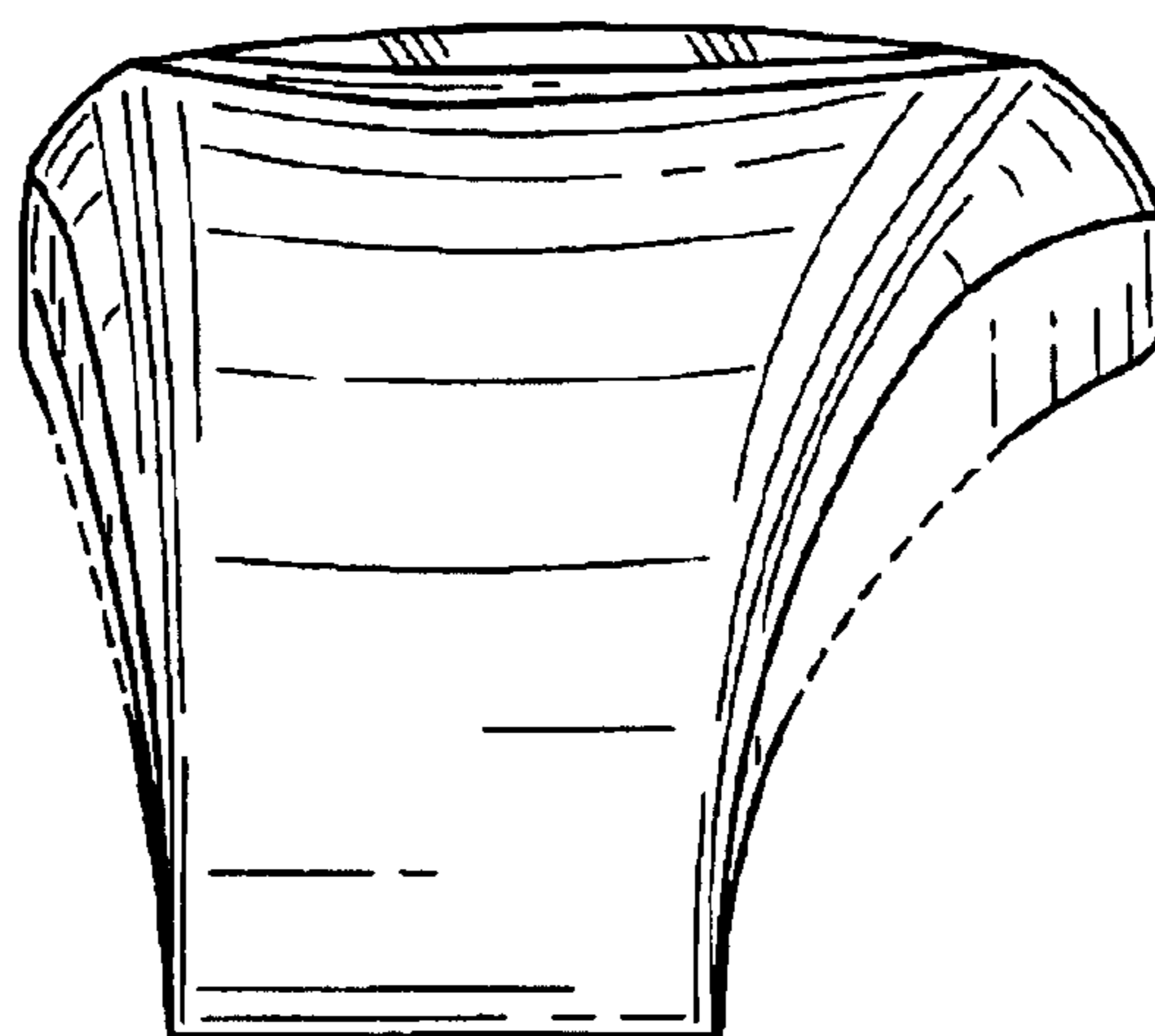
