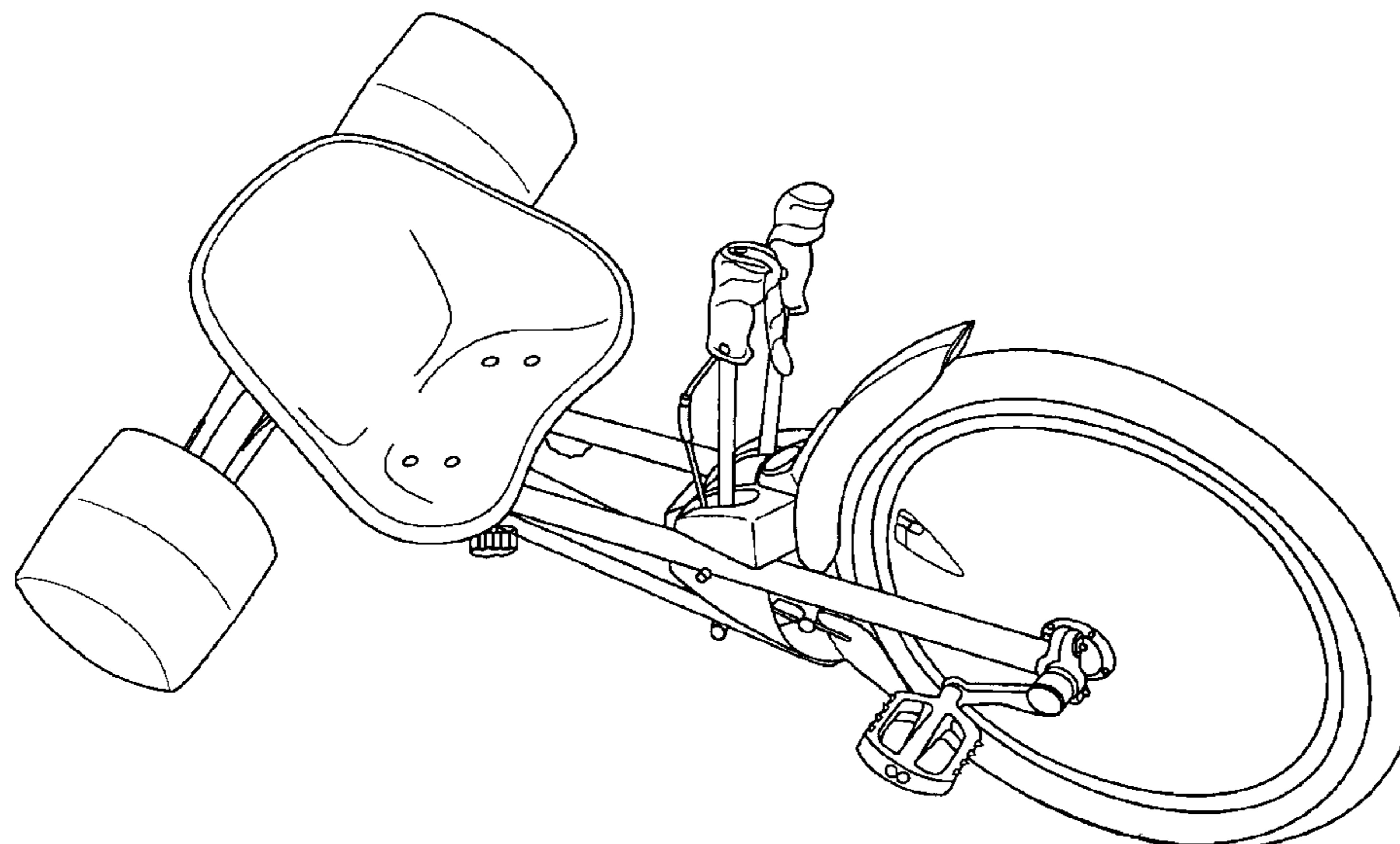

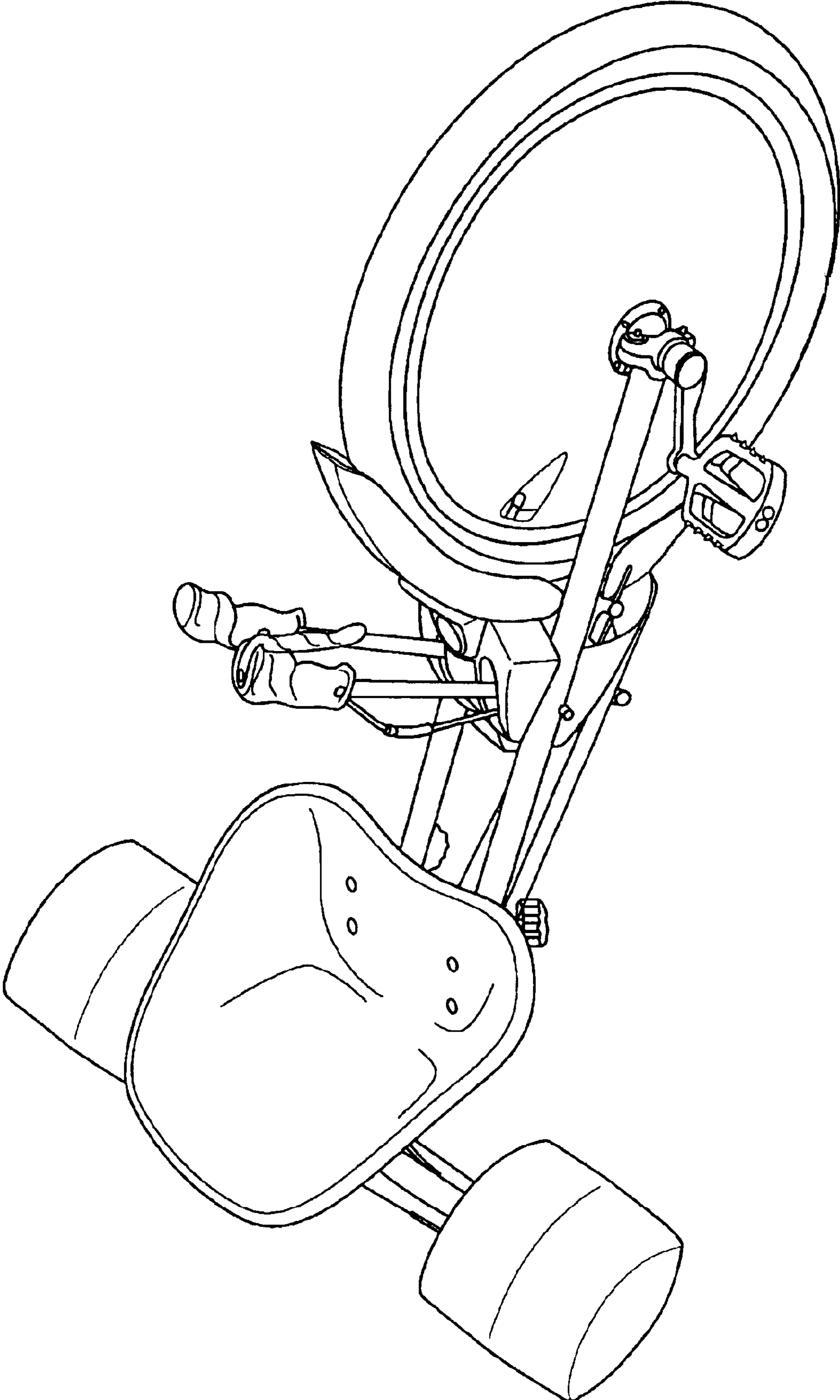
The ornamental design for a three wheeled vehicle, as shown and described.

**DESCRIPTION**

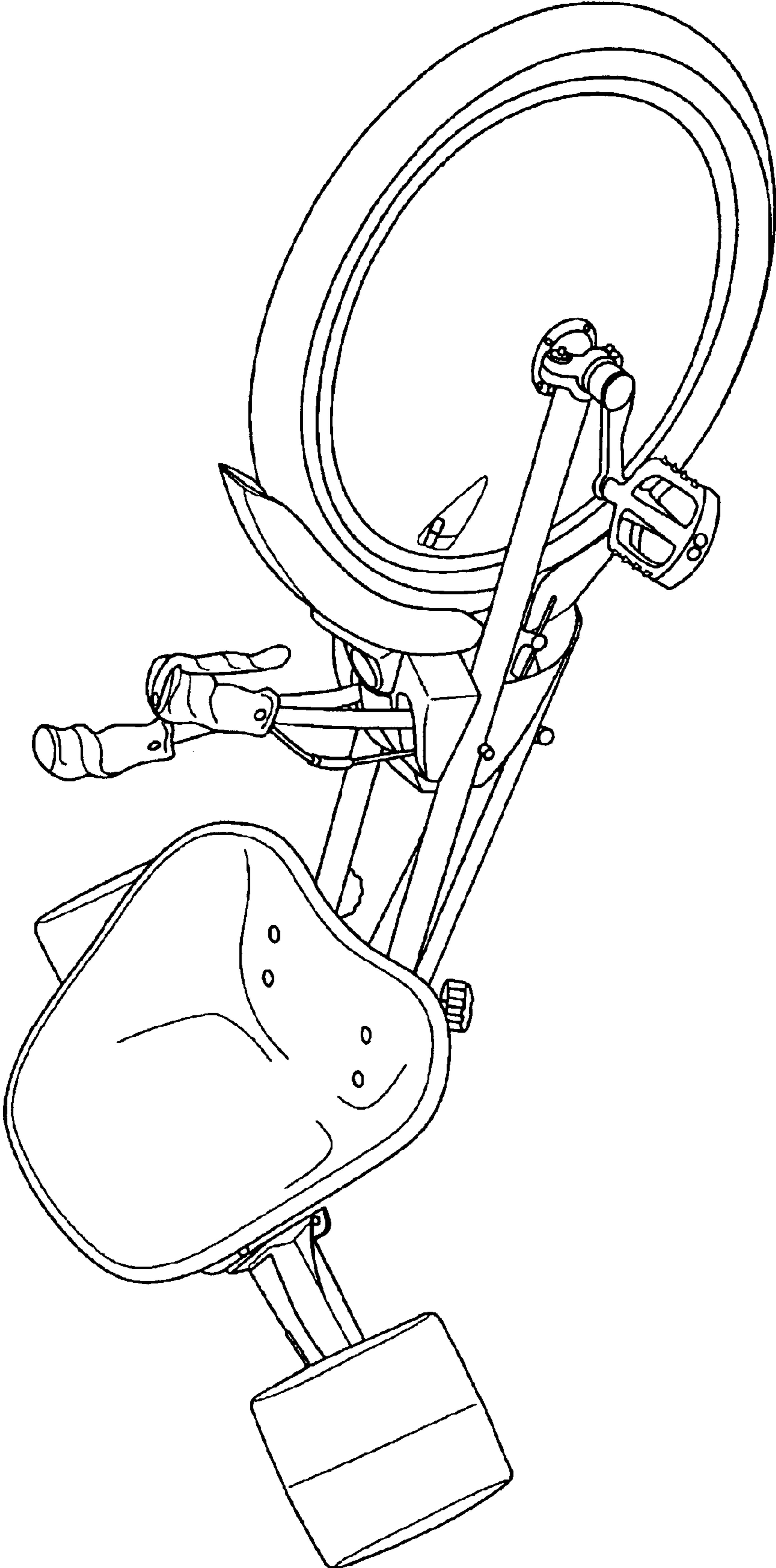
FIG. 1 is a perspective view of a three wheeled vehicle embodying my design;  
 FIG. 2 is a perspective view thereof with the control levers and rear wheels in an alternate position;  
 FIG. 3 is a front elevational view of the view depicted in FIG. 1;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a right side elevational view thereof;  
 FIG. 6 is a left side elevational view thereof;  
 FIG. 7 is a top plan view thereof; and,  
 FIG. 8 is a bottom plan view thereof.  
 The pedals are shown in different positions of use in the drawing views.

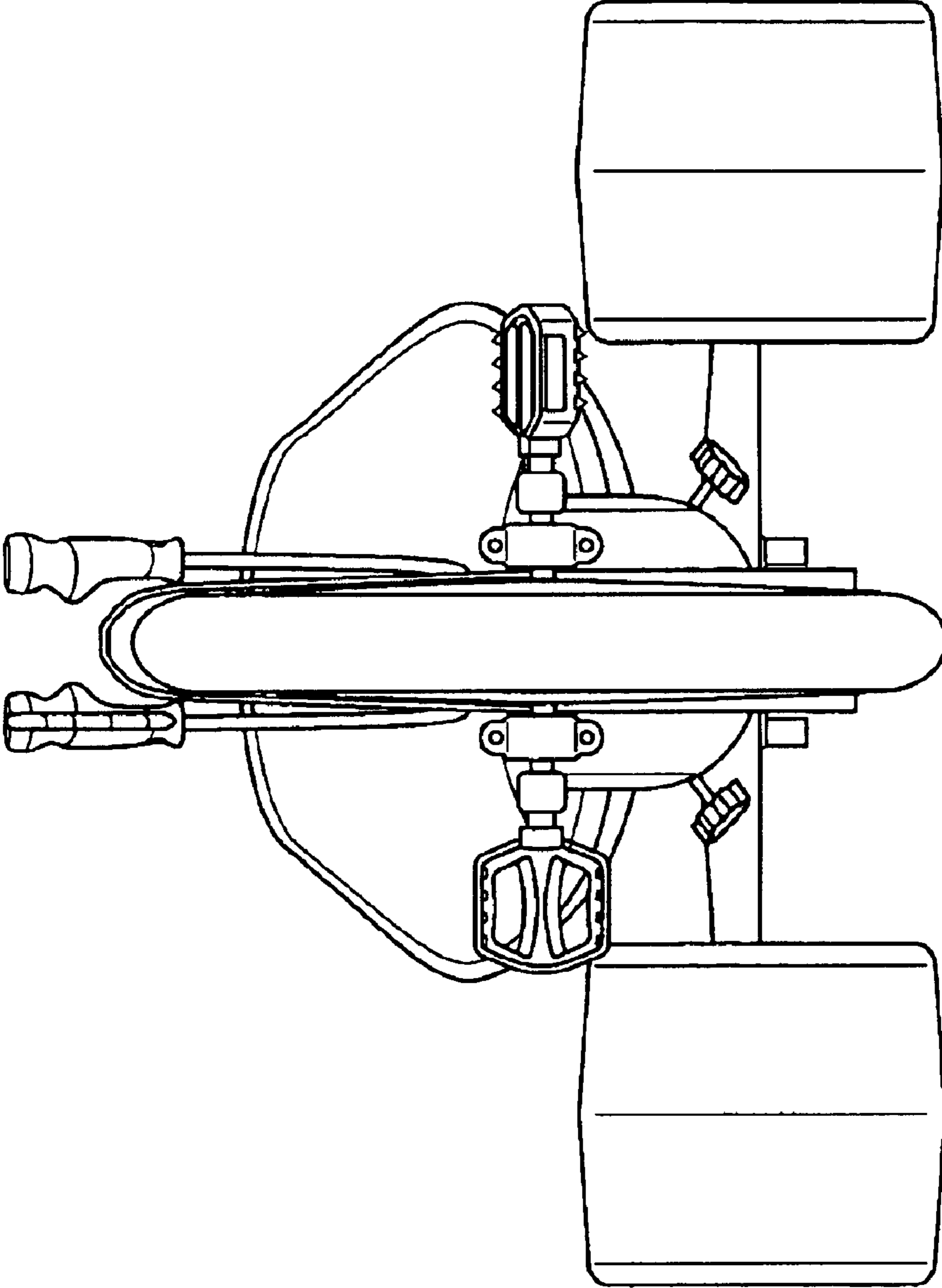




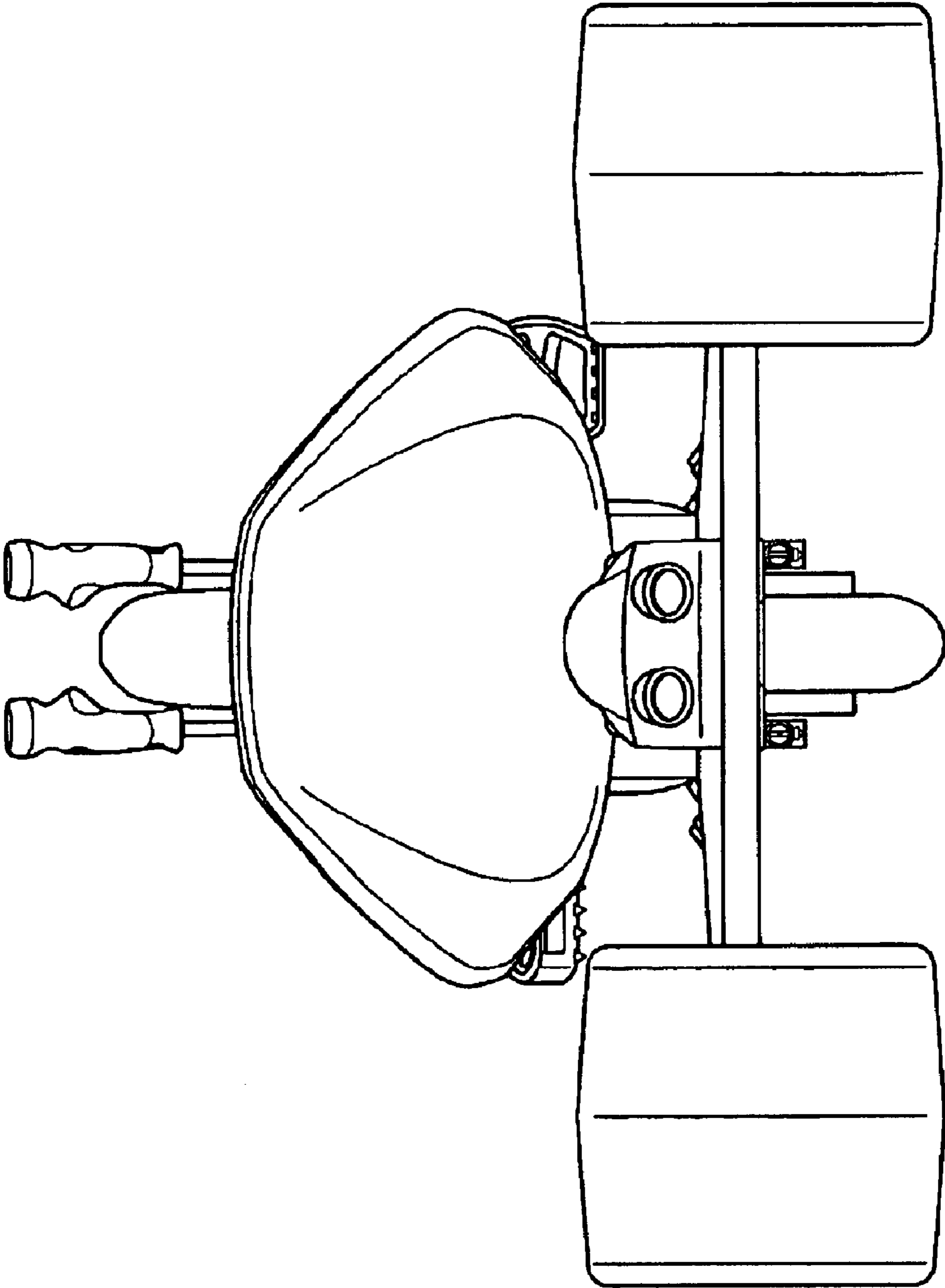

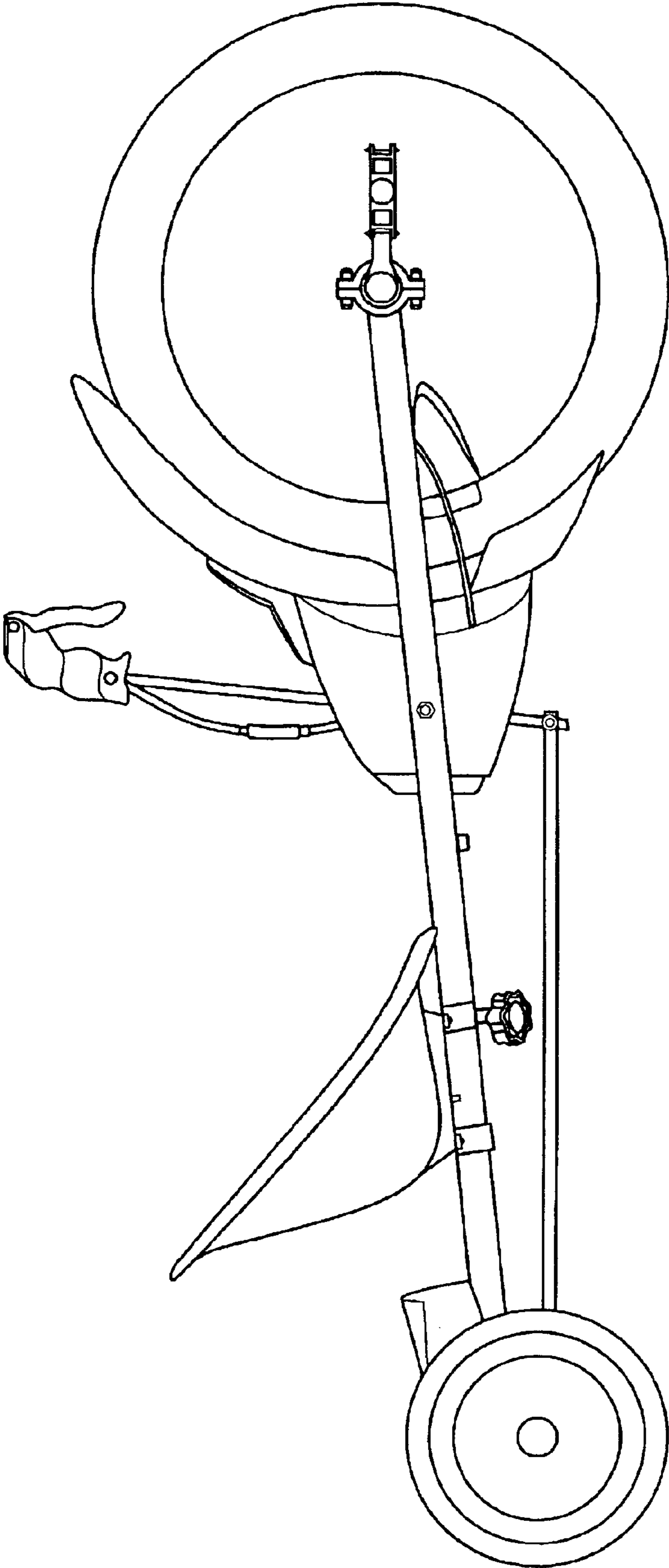

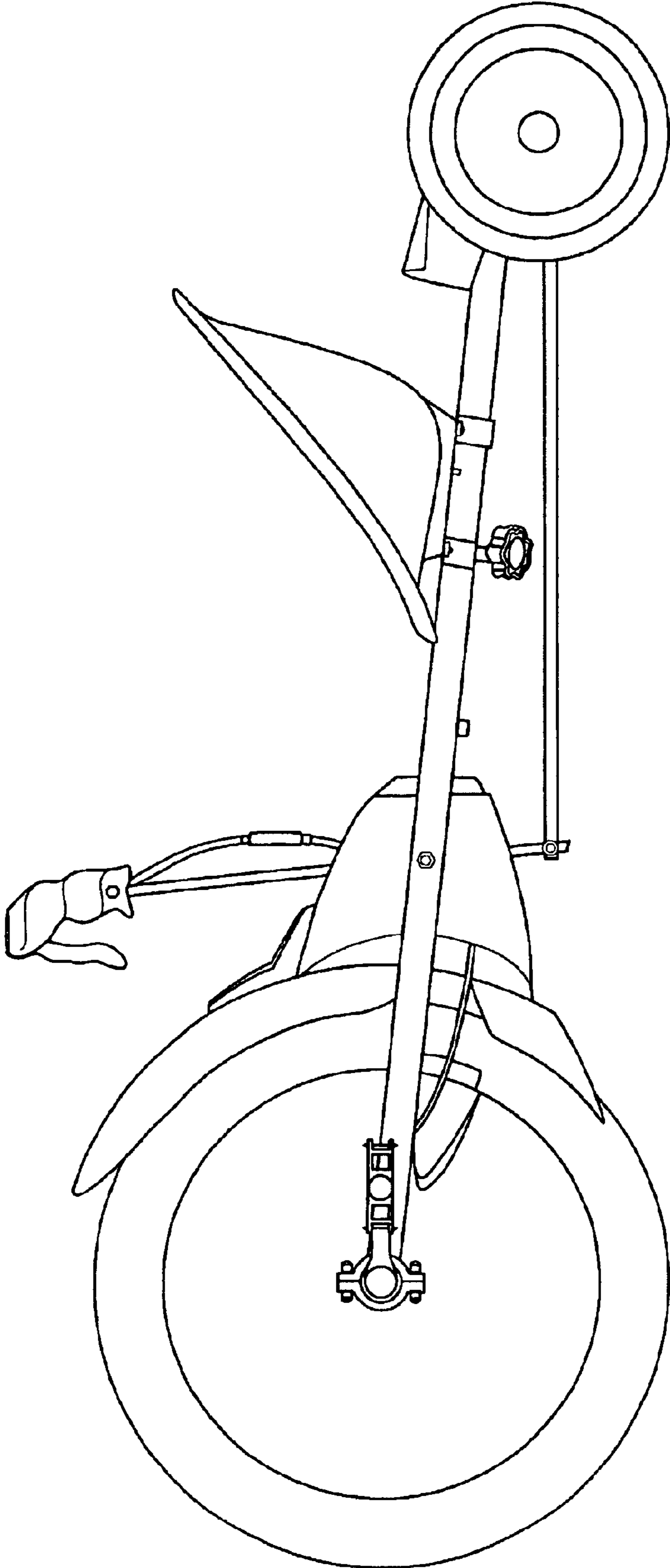

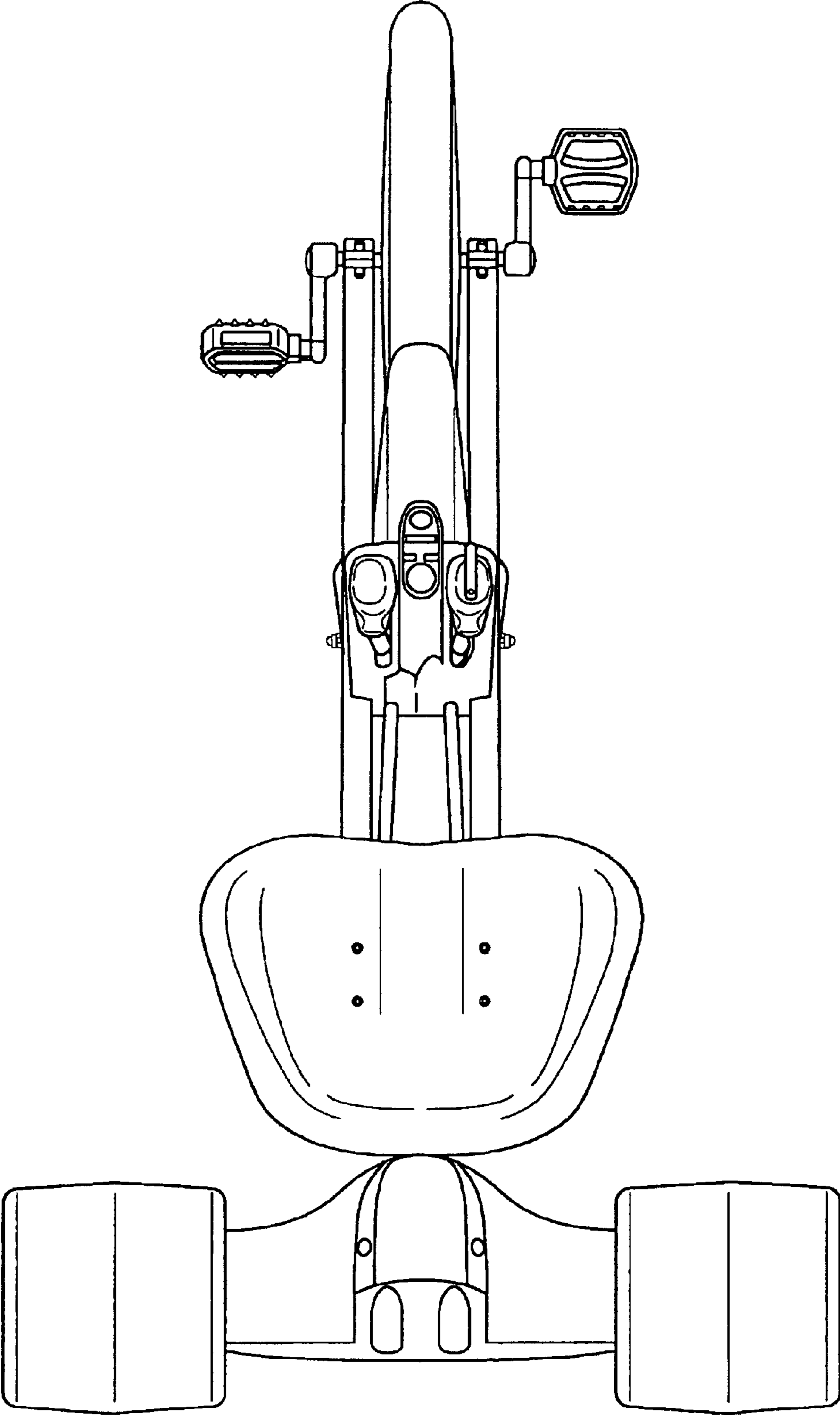

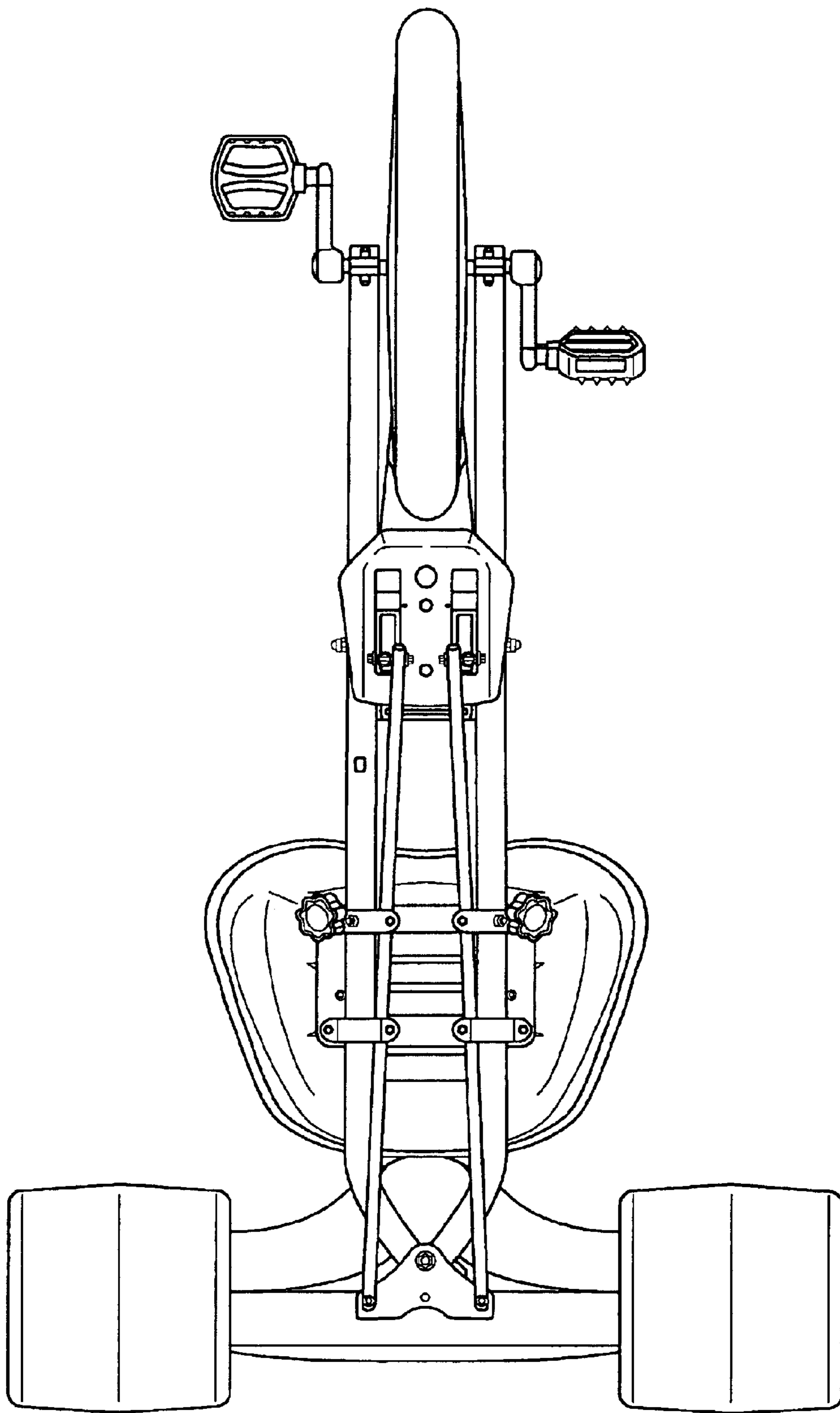
