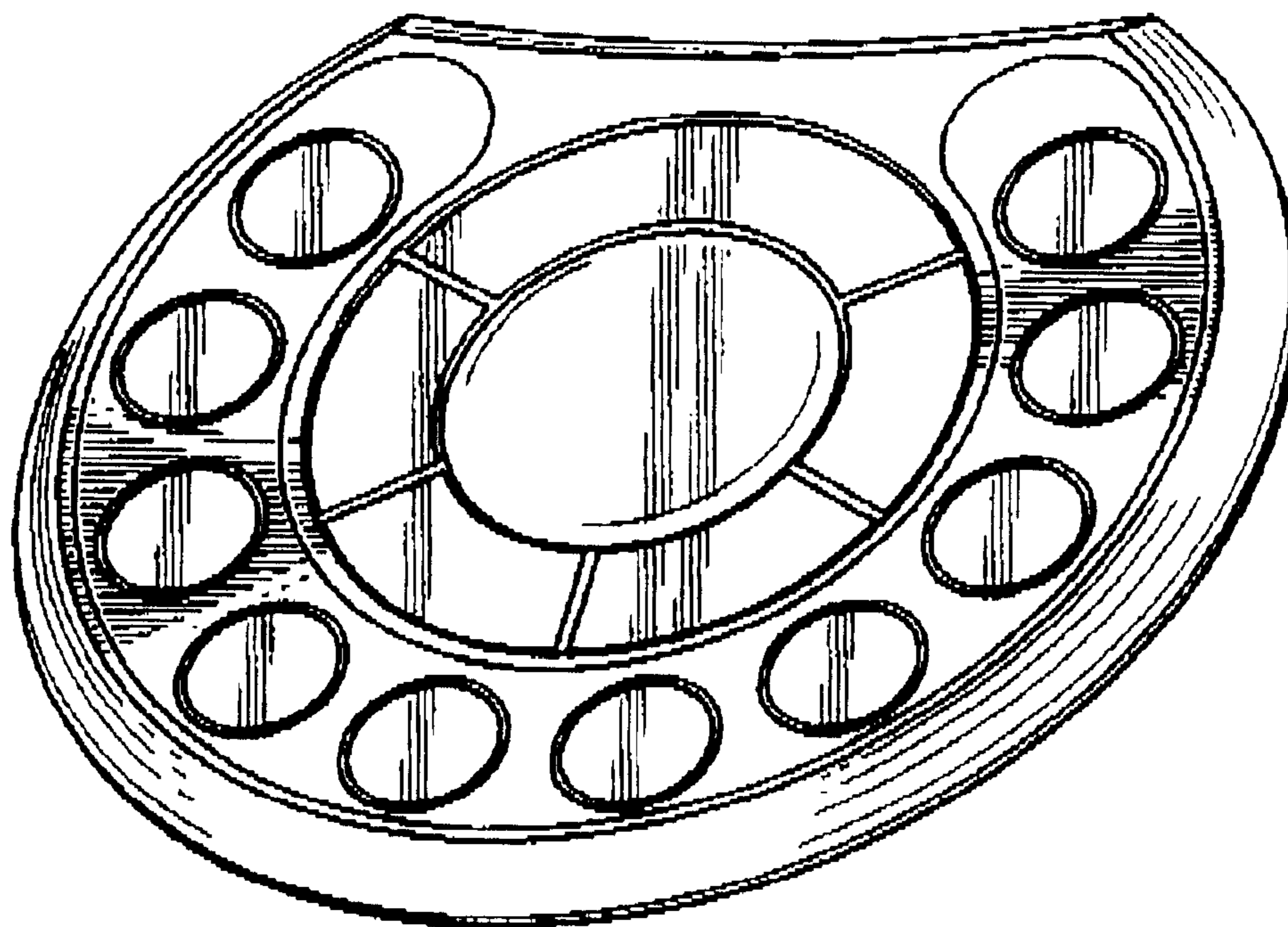

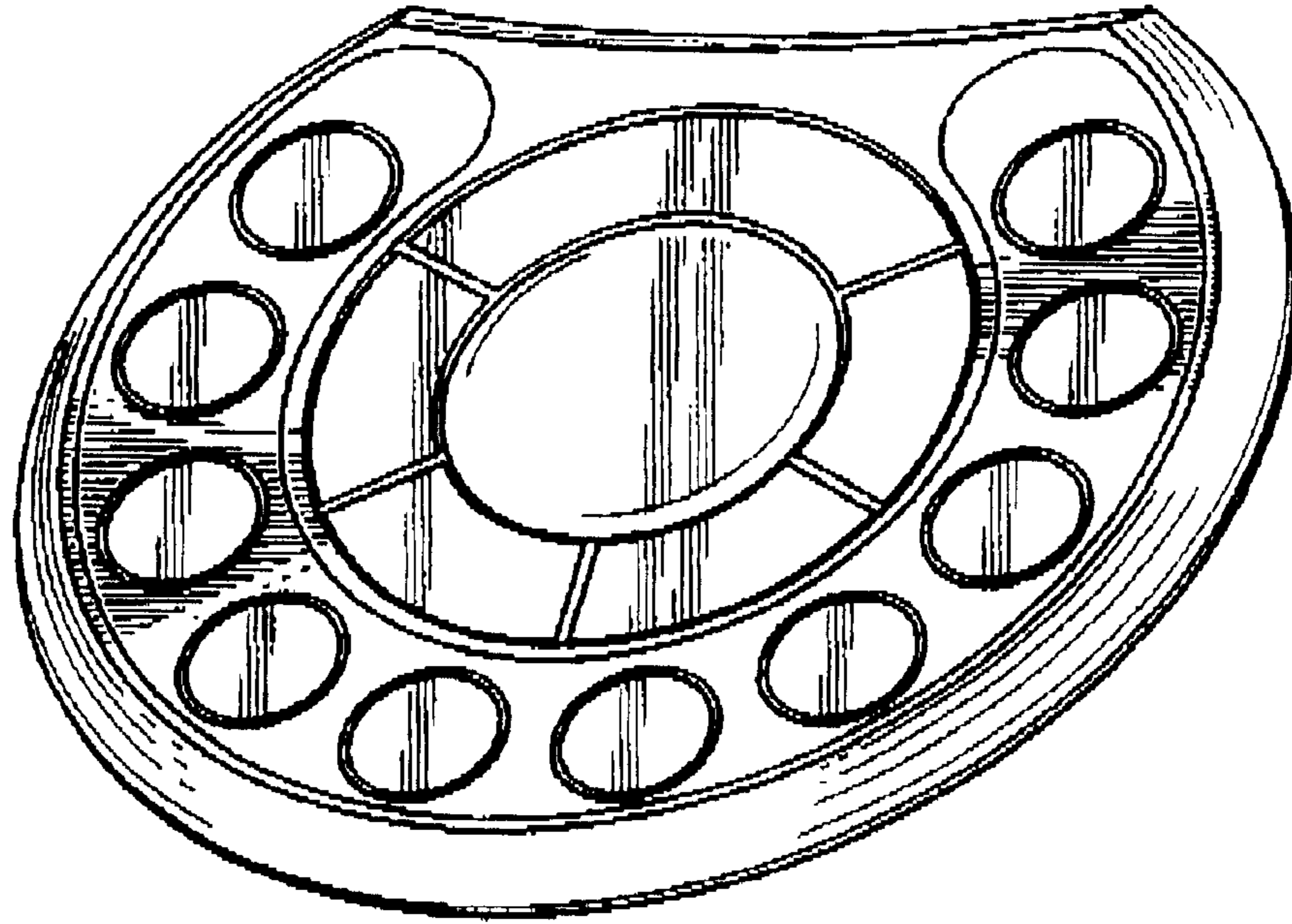
The ornamental design for a keypad, as shown and described.

**DESCRIPTION**

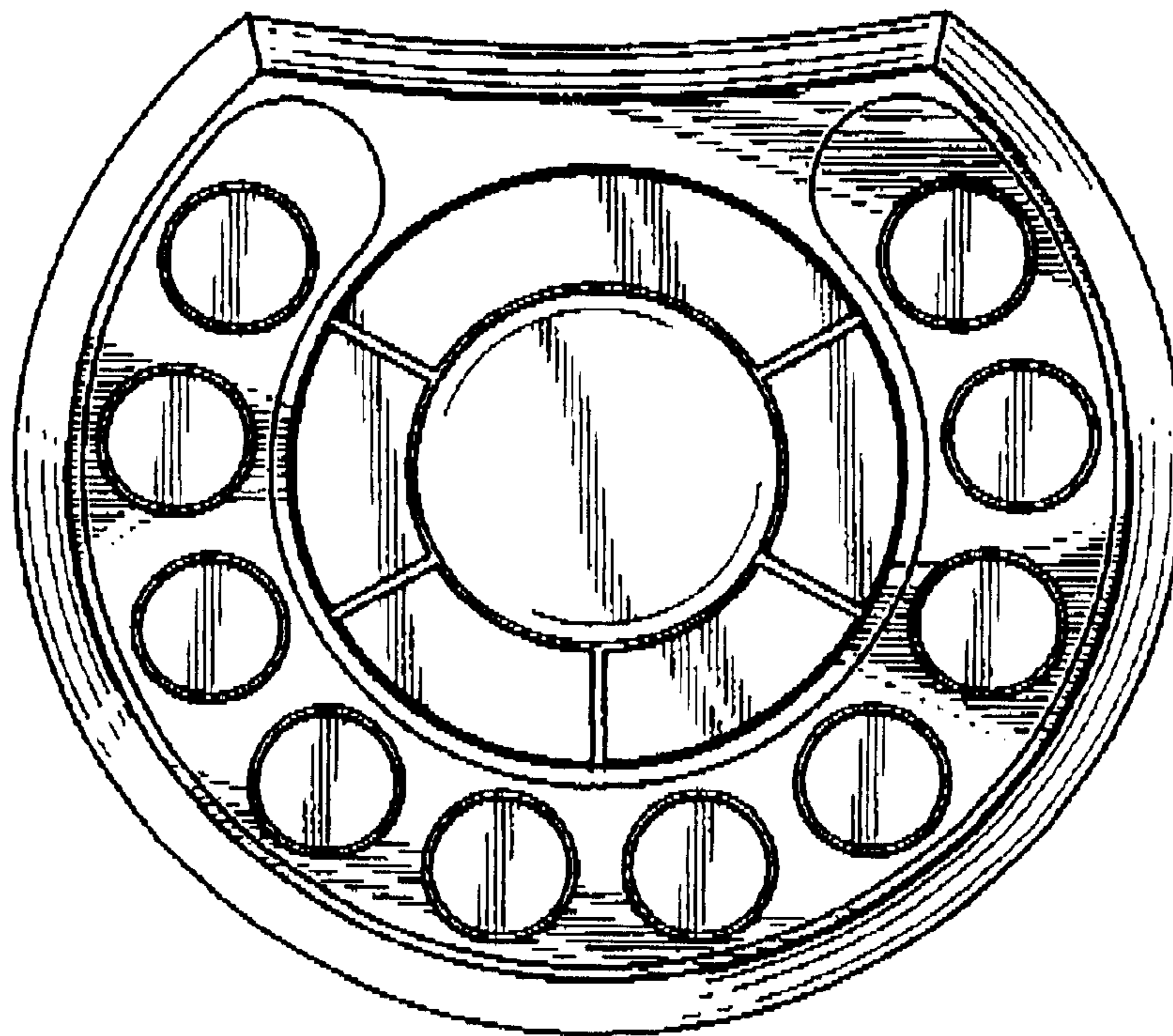
FIG. 1 is a perspective view, as viewed from the front, of a keypad showing our new design;

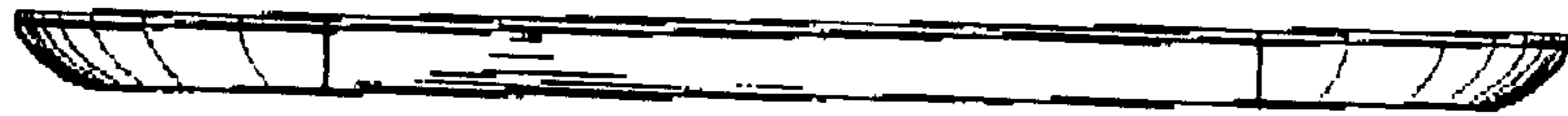

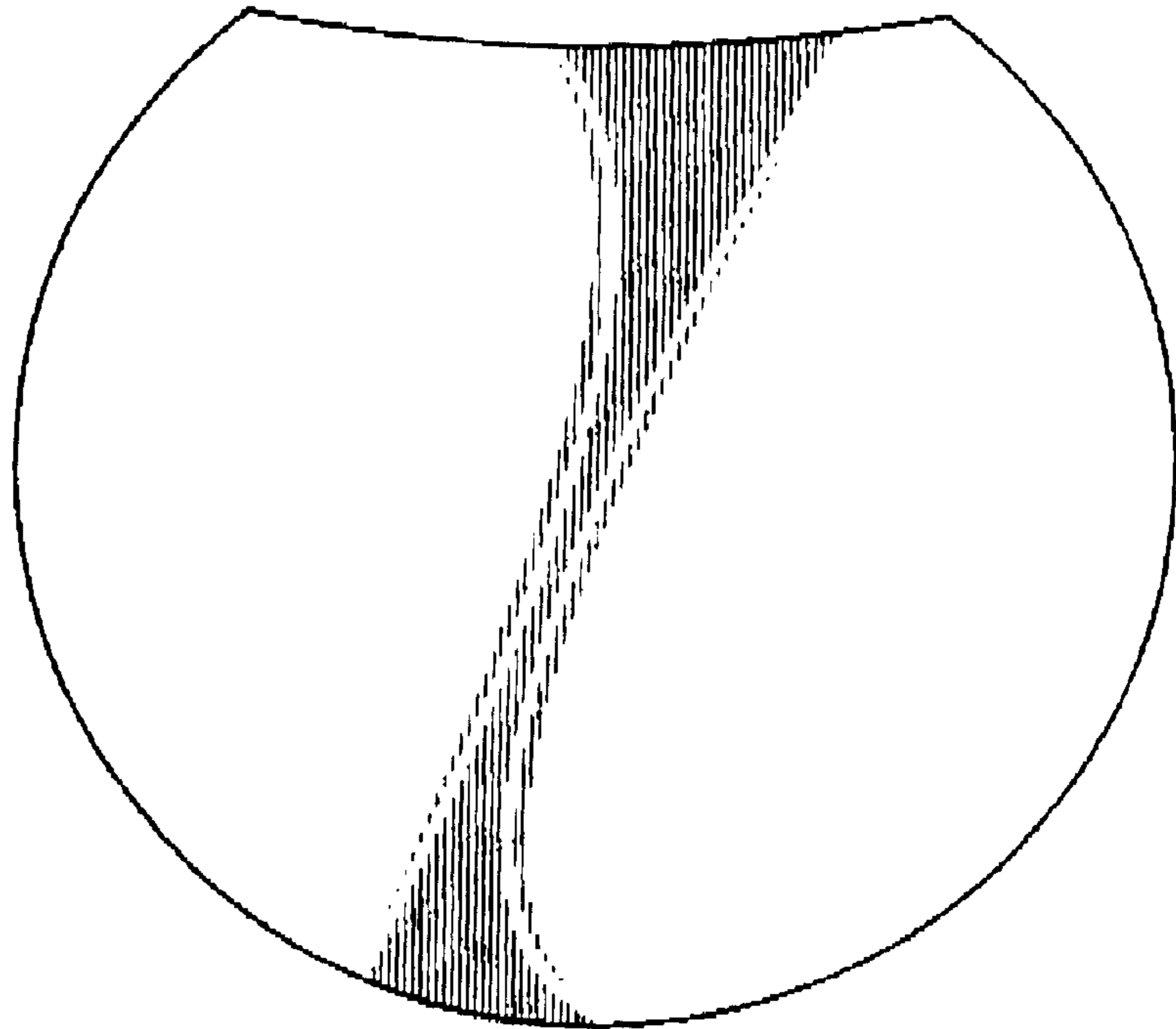

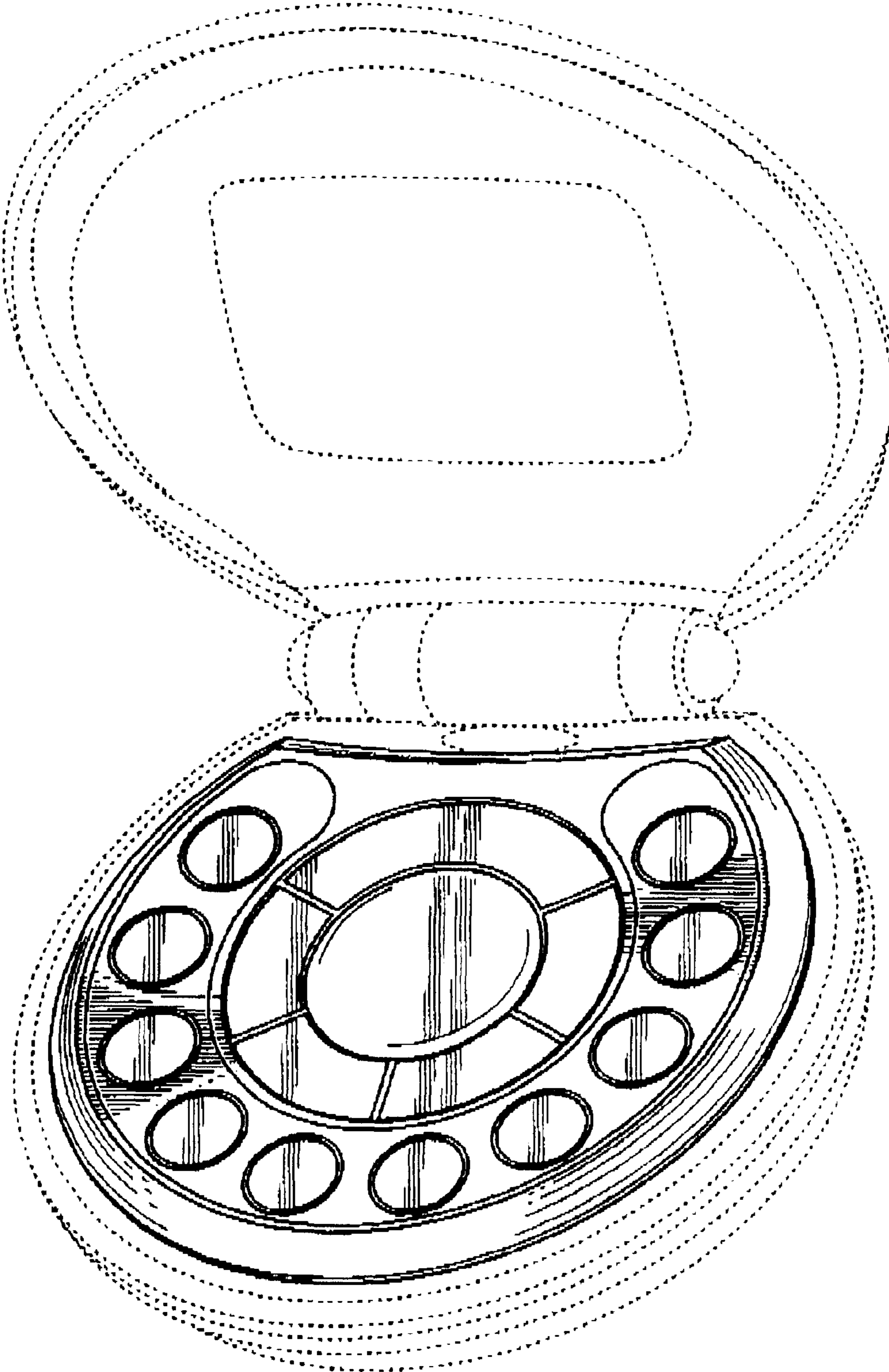
