DESCRIPTION

FIG. 1 is a perspective view of a combined computer and disc recorder/player showing my new design;

FIG. 3 is a rear elevational view thereof;

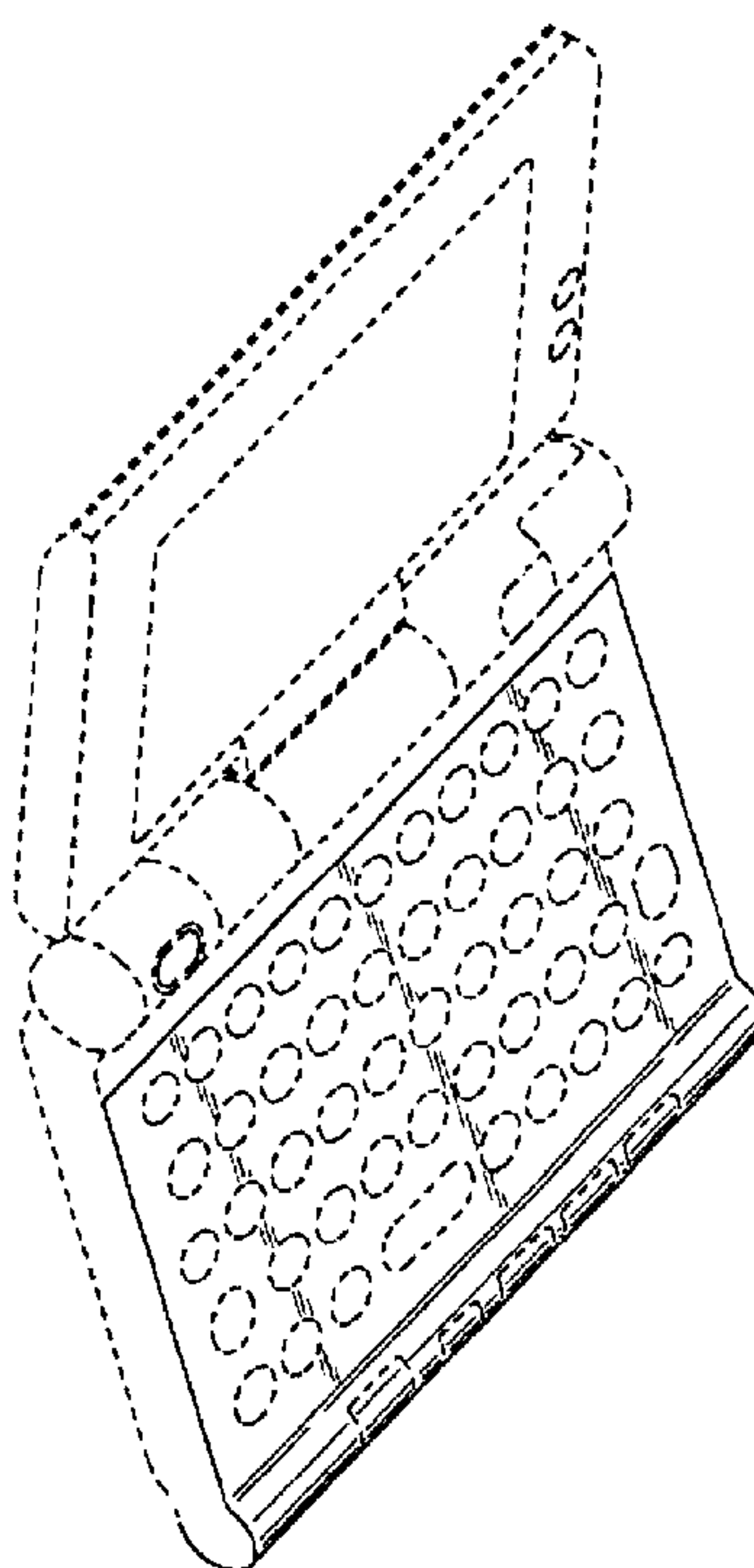
FIG. 4 is a left side elevational view thereof;

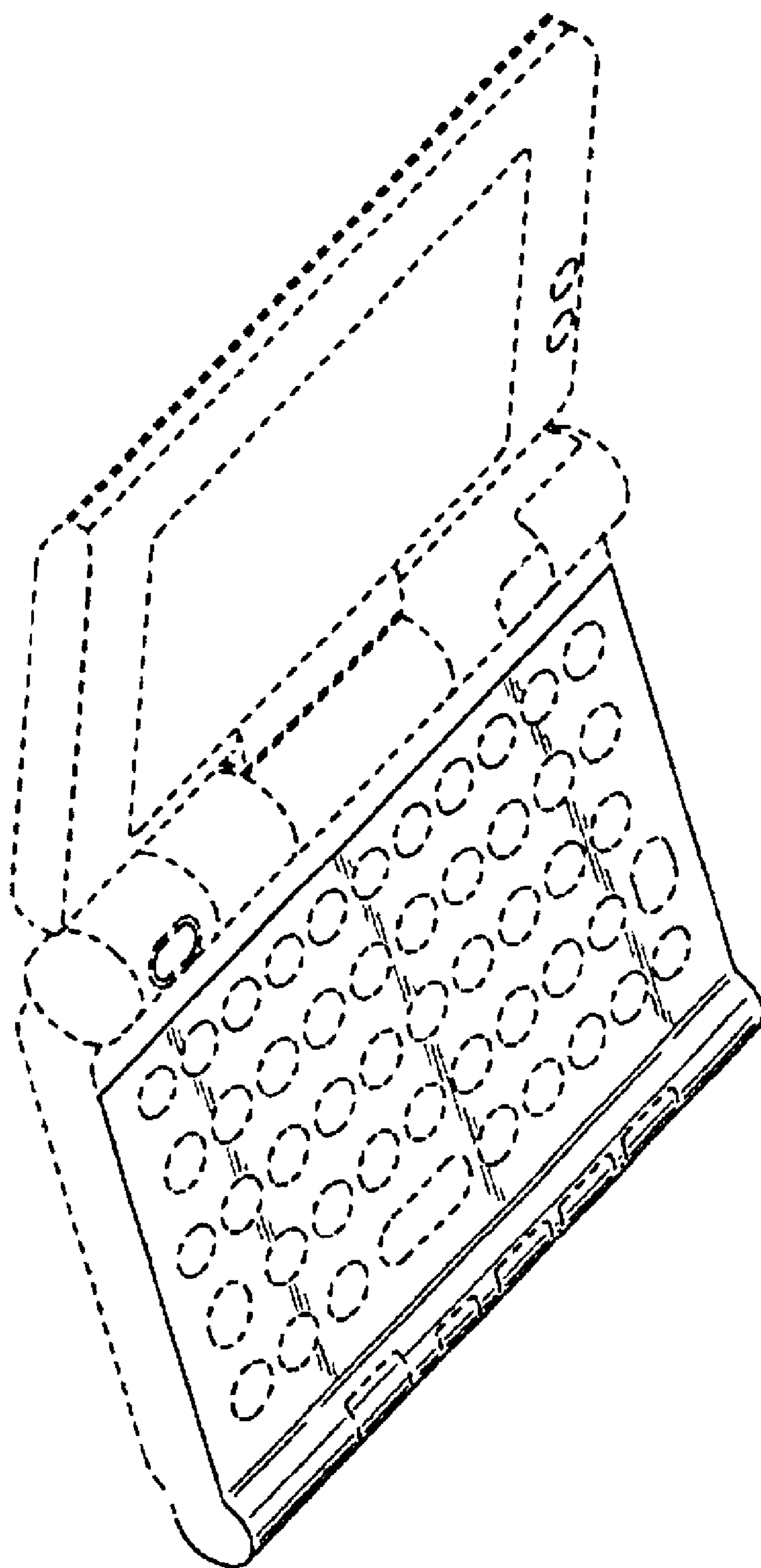

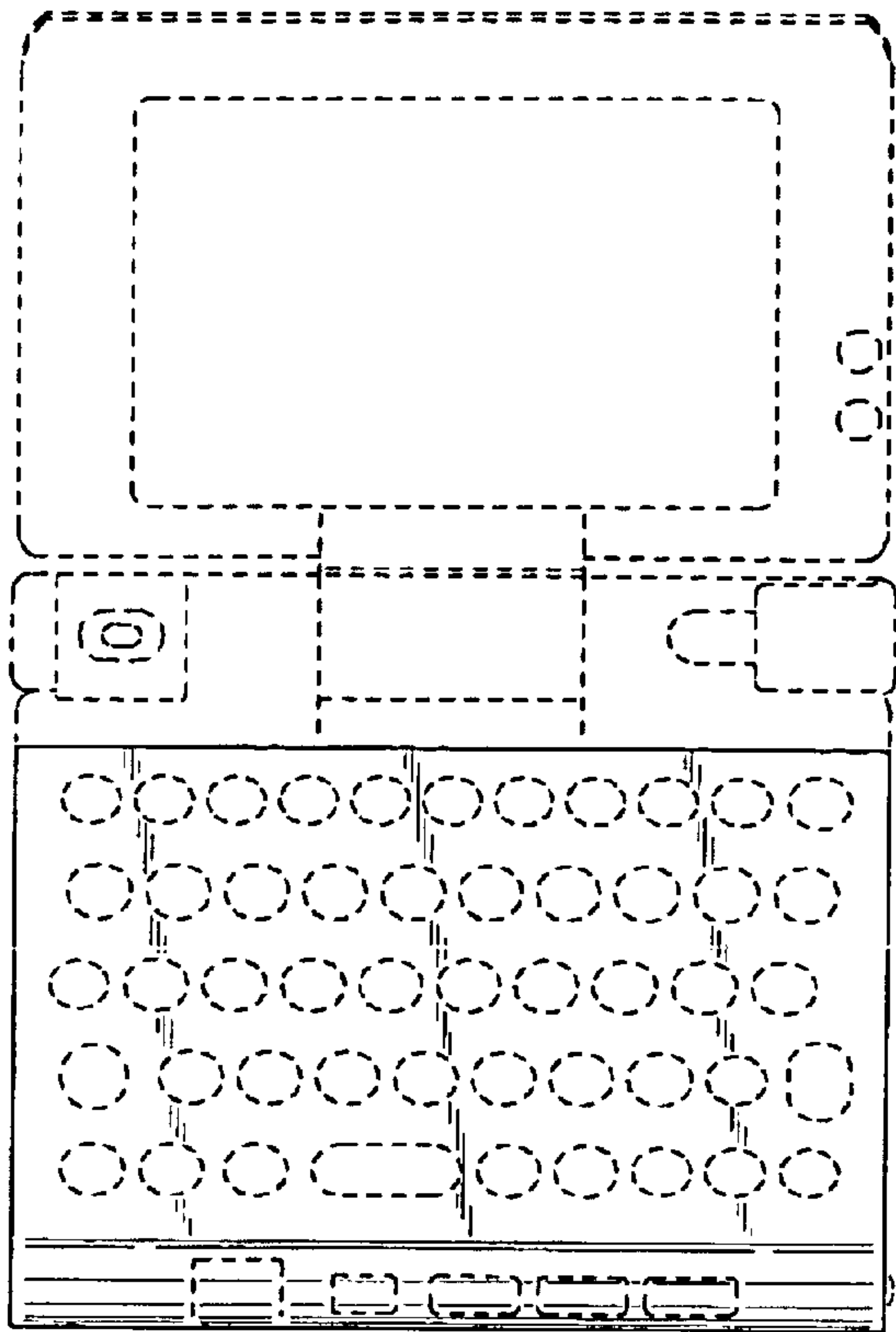

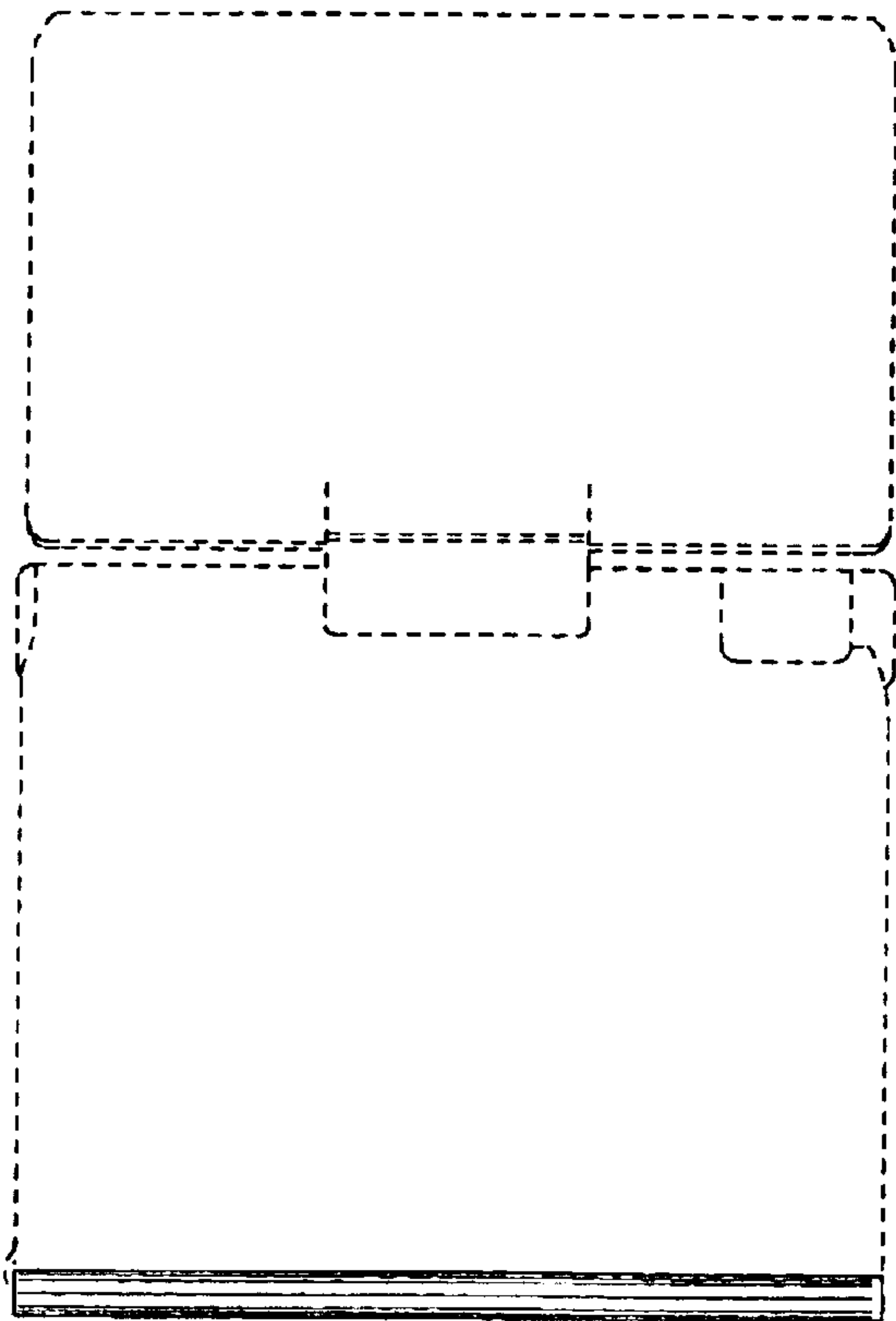

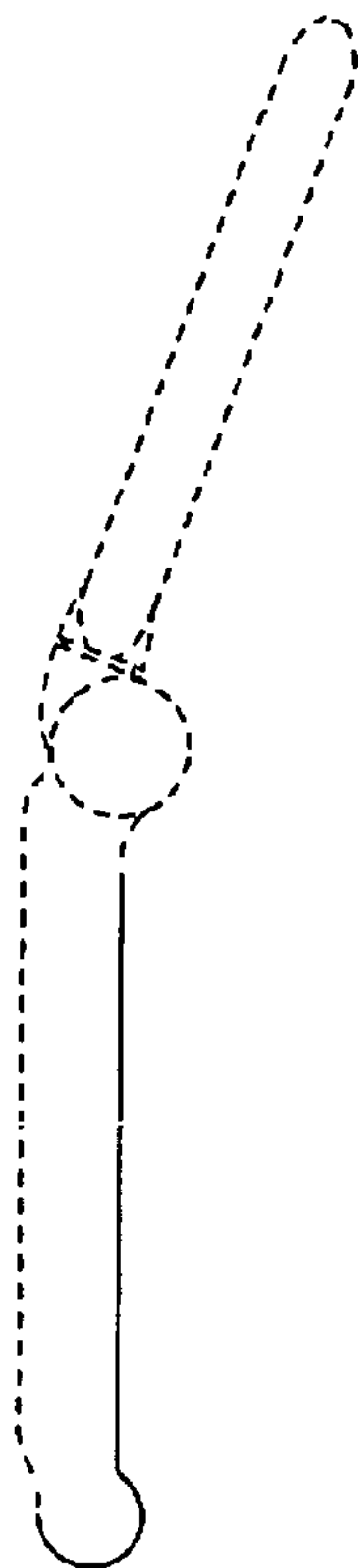

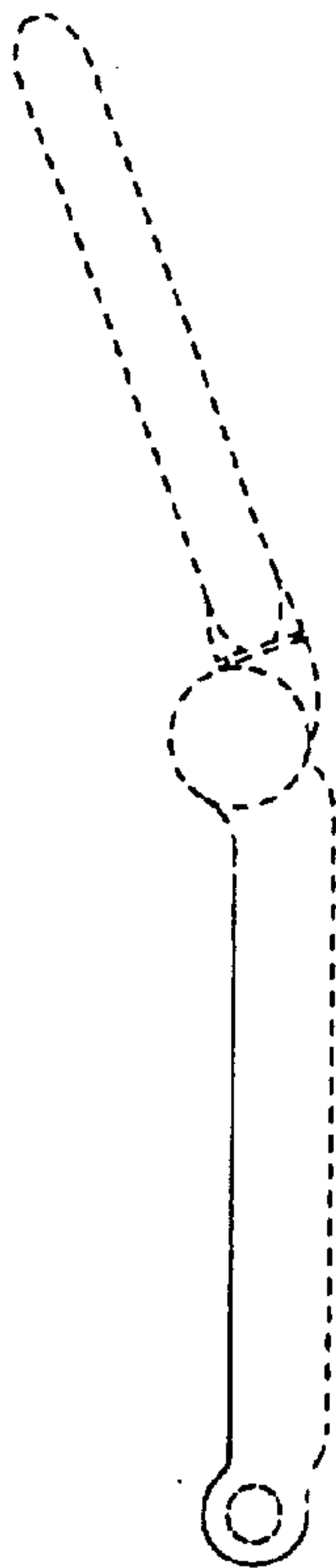

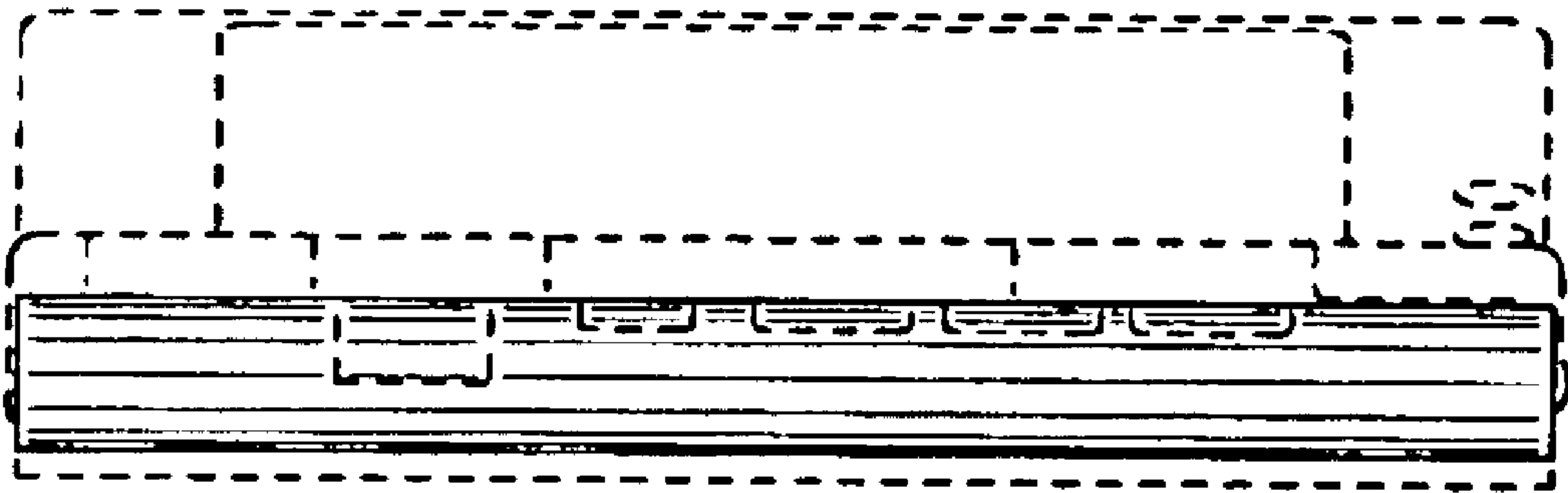
