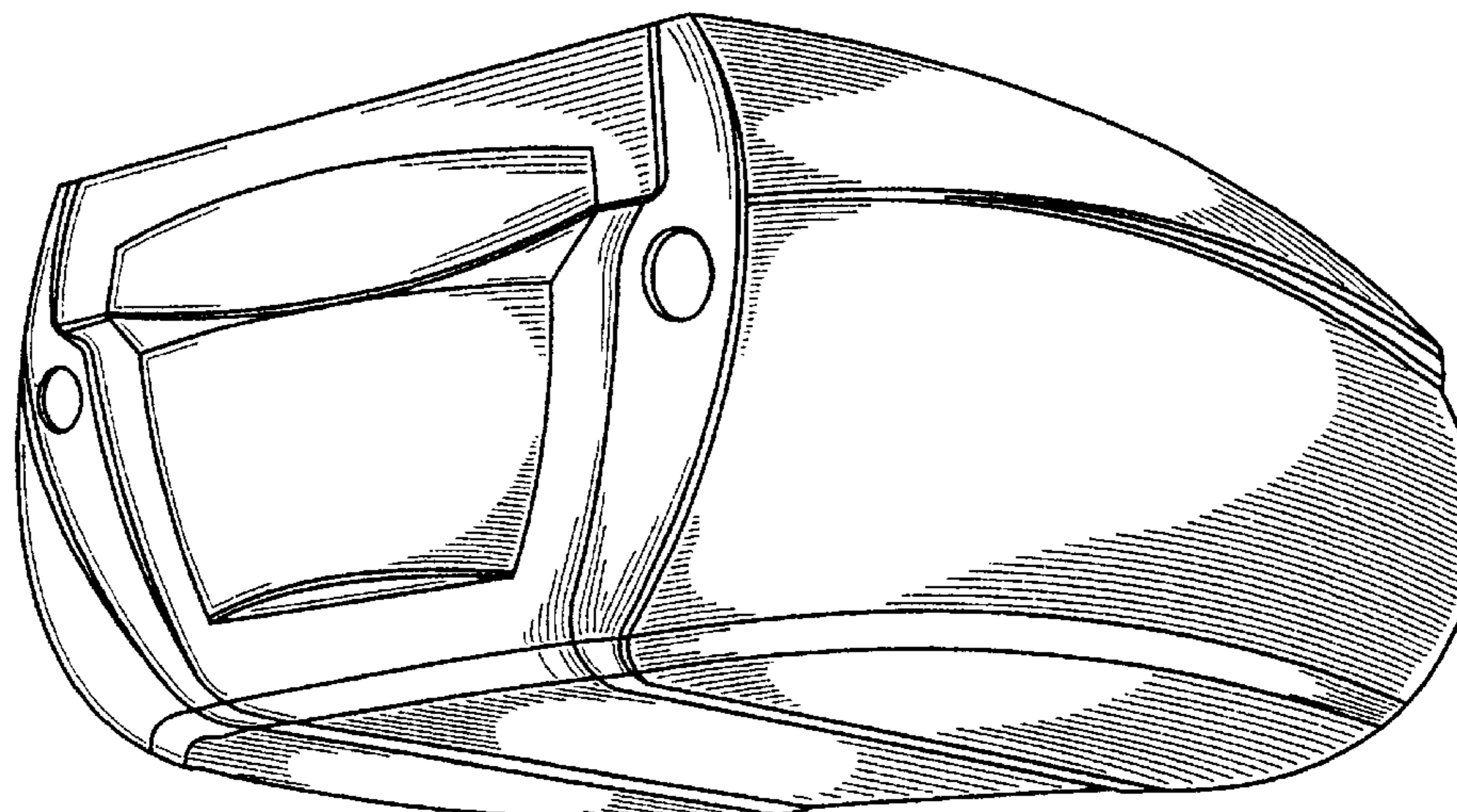
(57) **CLAIM**

We claim the ornamental design for a medallion and housing for a barrier movement operator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the medallion and housing for a barrier movement operator showing our new design; FIG. 2 is a front elevational view of the medallion and housing for a barrier movement operator of FIG. 1; FIG. 3 is a rear elevational view of the medallion and housing for a barrier movement operator of FIG. 1; FIG. 4 is a left side elevational view of the medallion and housing for a barrier movement operator of FIG. 1; FIG. 5 is a right side elevational view of the medallion and housing for a barrier movement operator of FIG. 1; FIG. 6 is a top plan view of the medallion and housing for a barrier movement operator of FIG. 1; FIG. 7 is a bottom plan view of the medallion and housing for a barrier movement operator of FIG. 1; FIG. 8 is a perspective view of the medallion, the housing having been omitted for ease of illustration; FIG. 9 is a front elevational view of the medallion, the housing having been omitted for ease of illustration; FIG. 10 is a top view of the medallion, the housing having been omitted for ease of illustration; FIG. 11 is a right side elevational view of the medallion, the housing having been omitted for ease of illustration; FIG. 12 is a rear elevational view of the medallion, the housing having been omitted for ease of illustration; FIG. 13 is a bottom plan view of the medallion, the housing having been omitted for ease of illustration; and, FIG. 14 is a left side elevational view of the medallion, the housing having been omitted for ease of illustration.

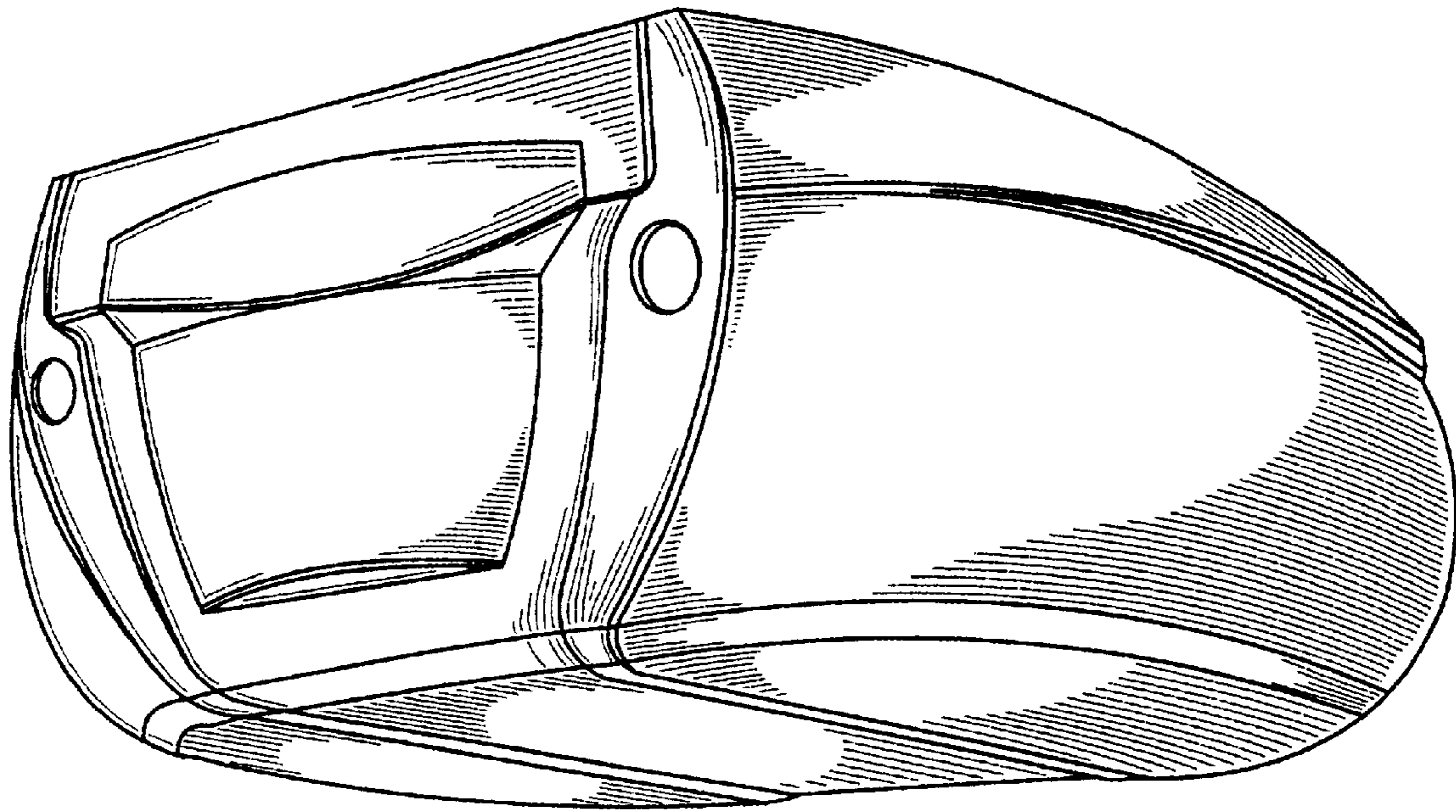

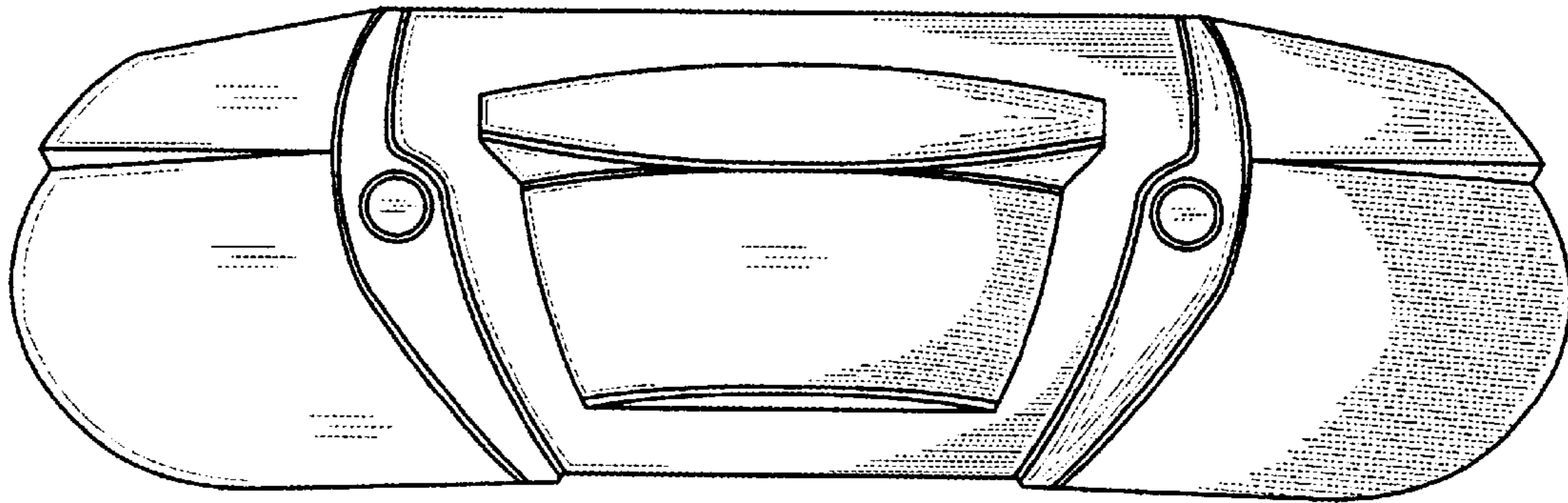

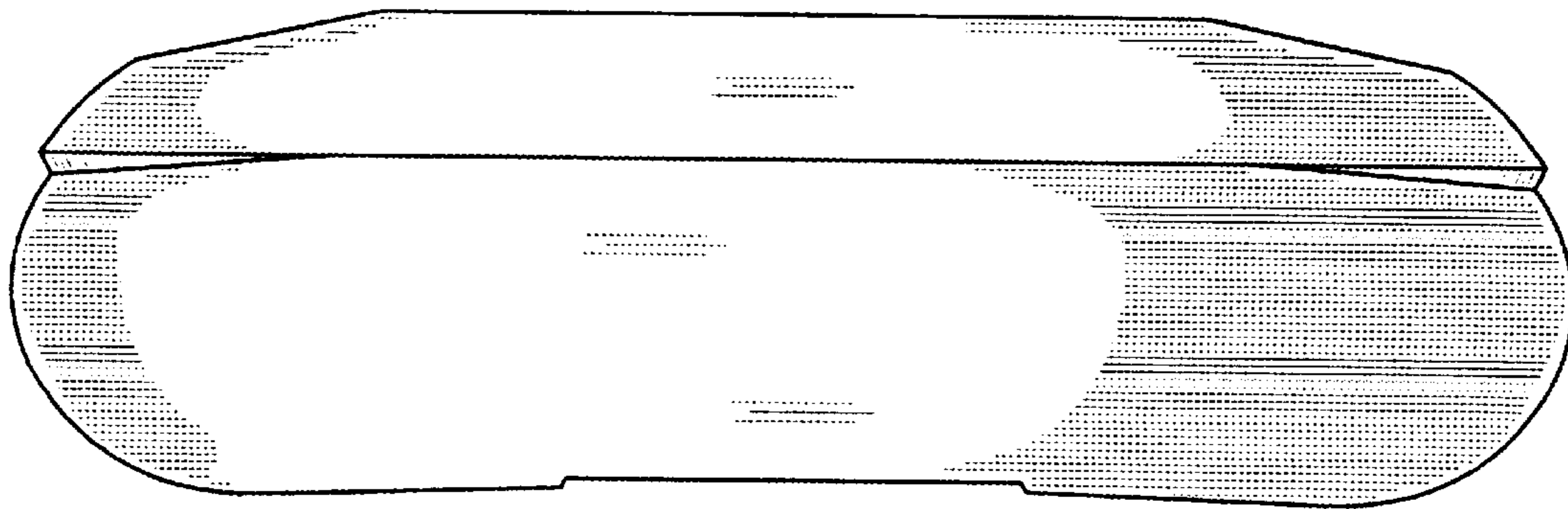

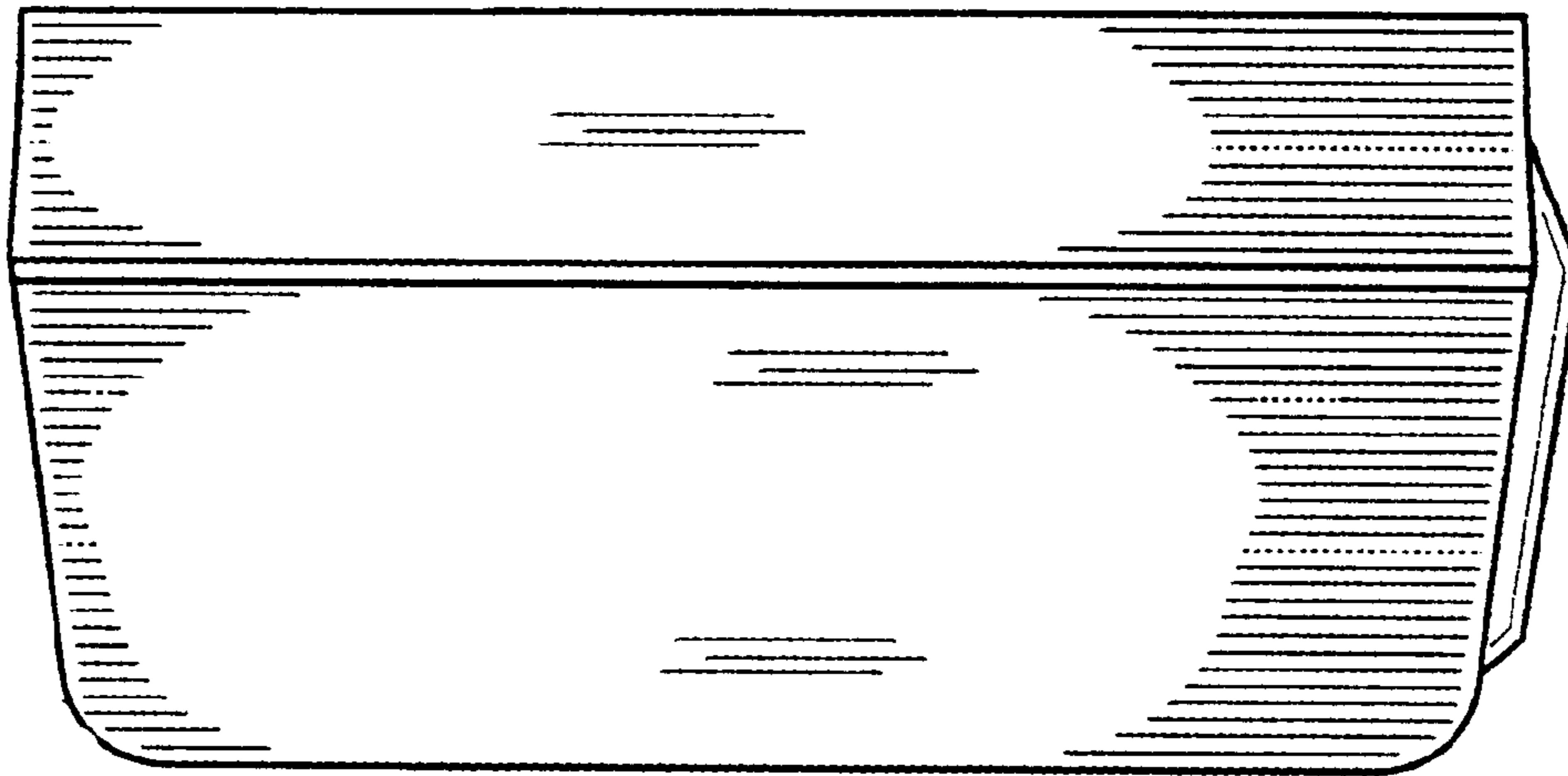

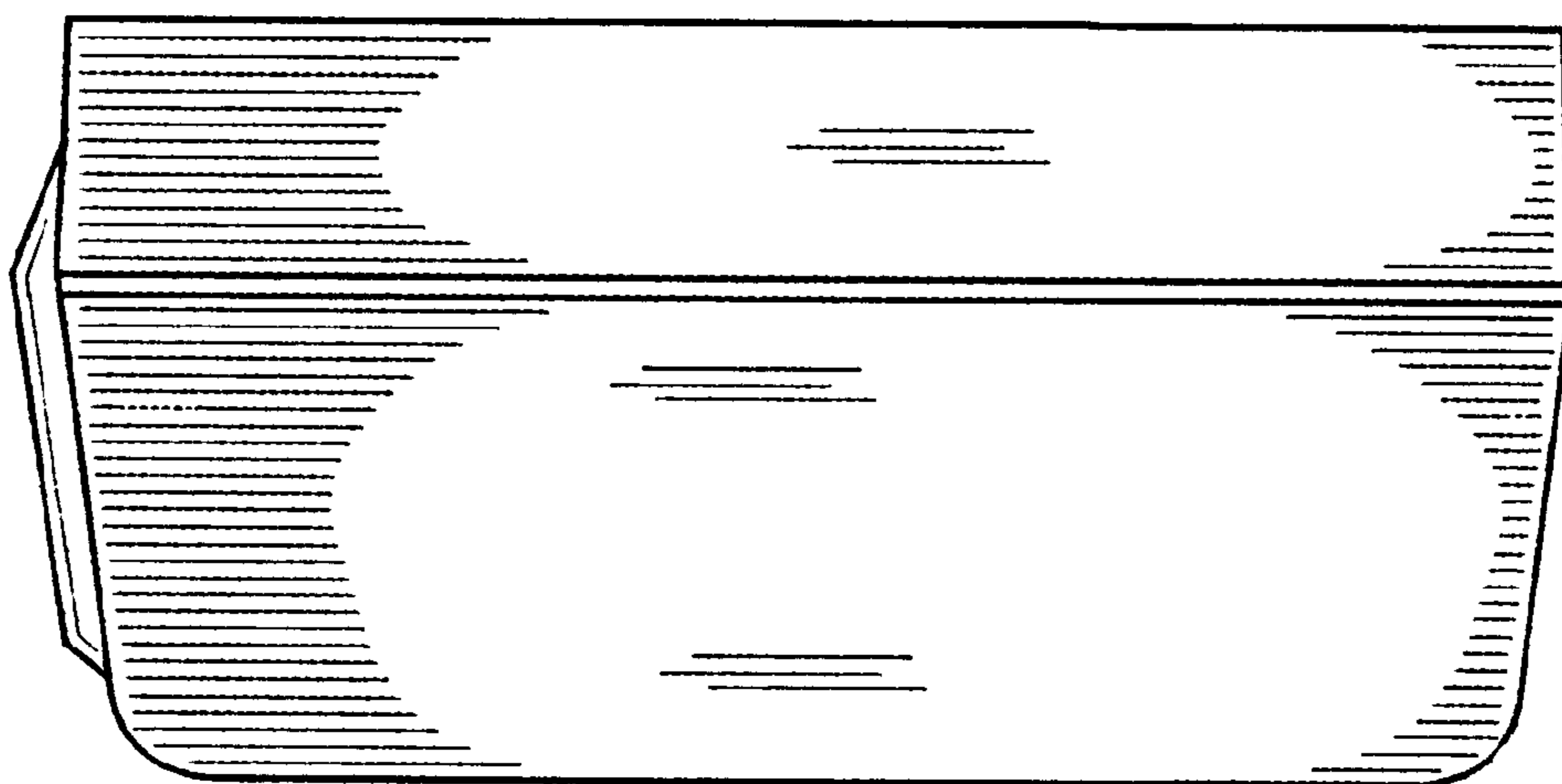

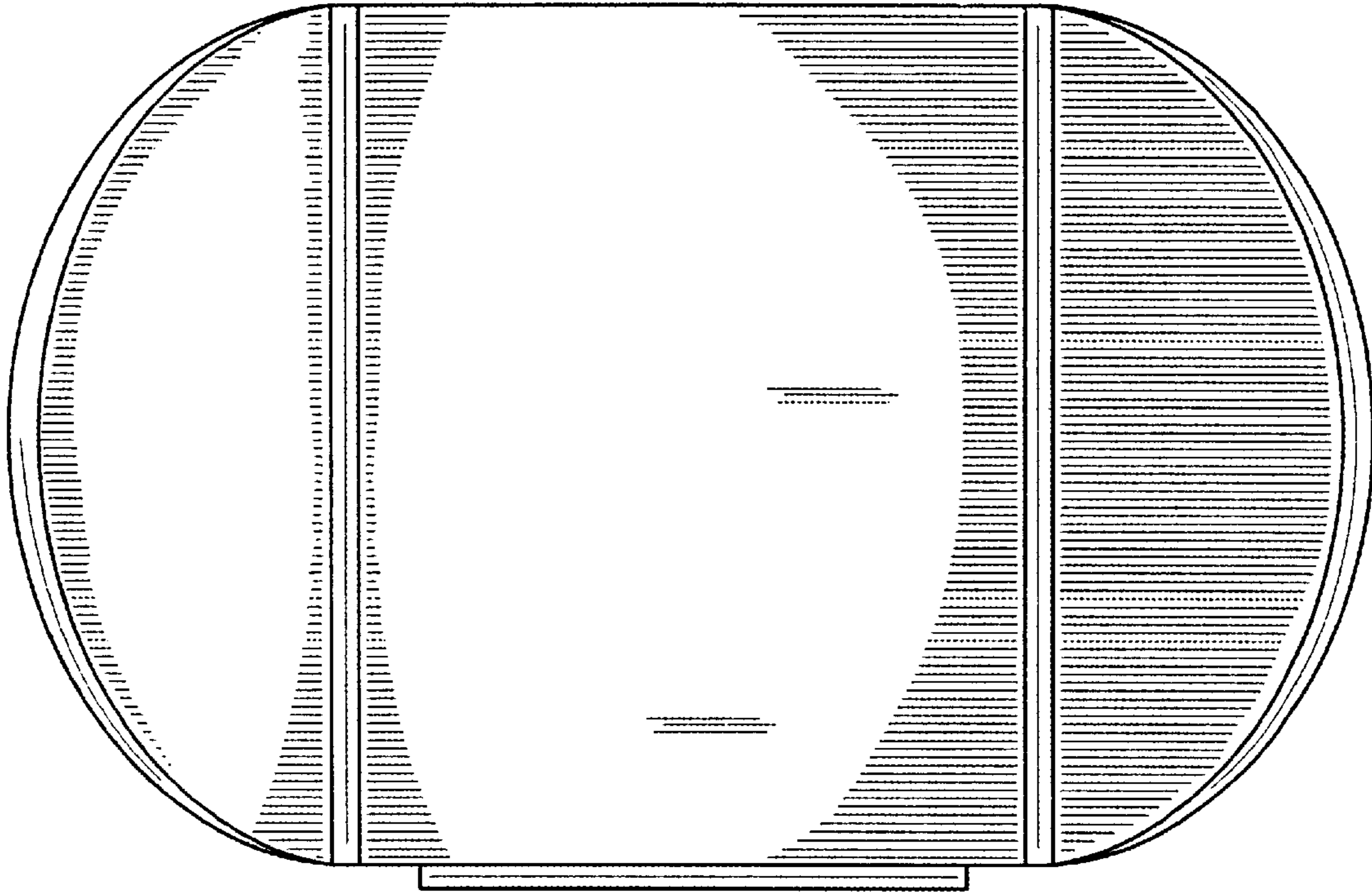

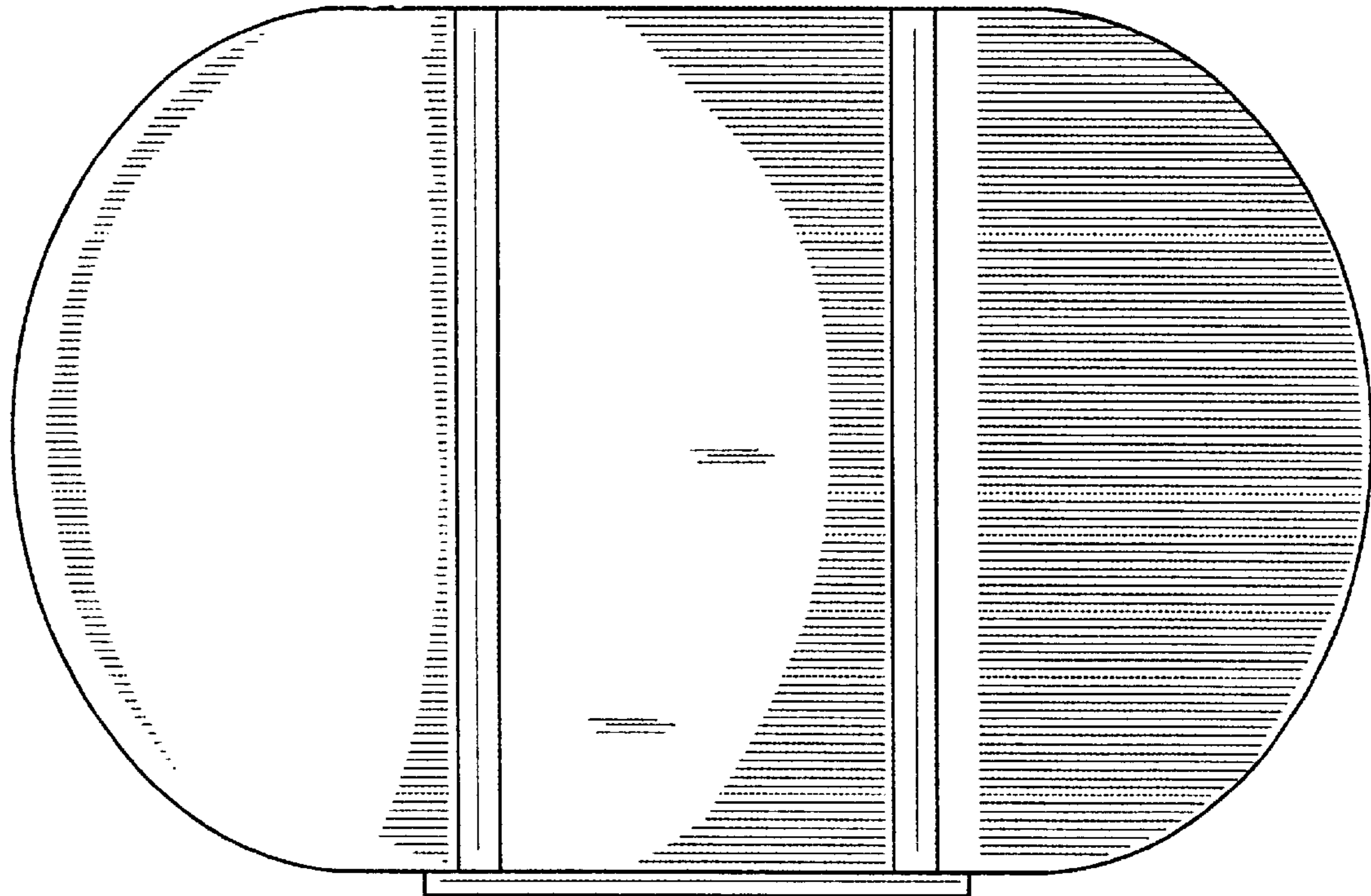

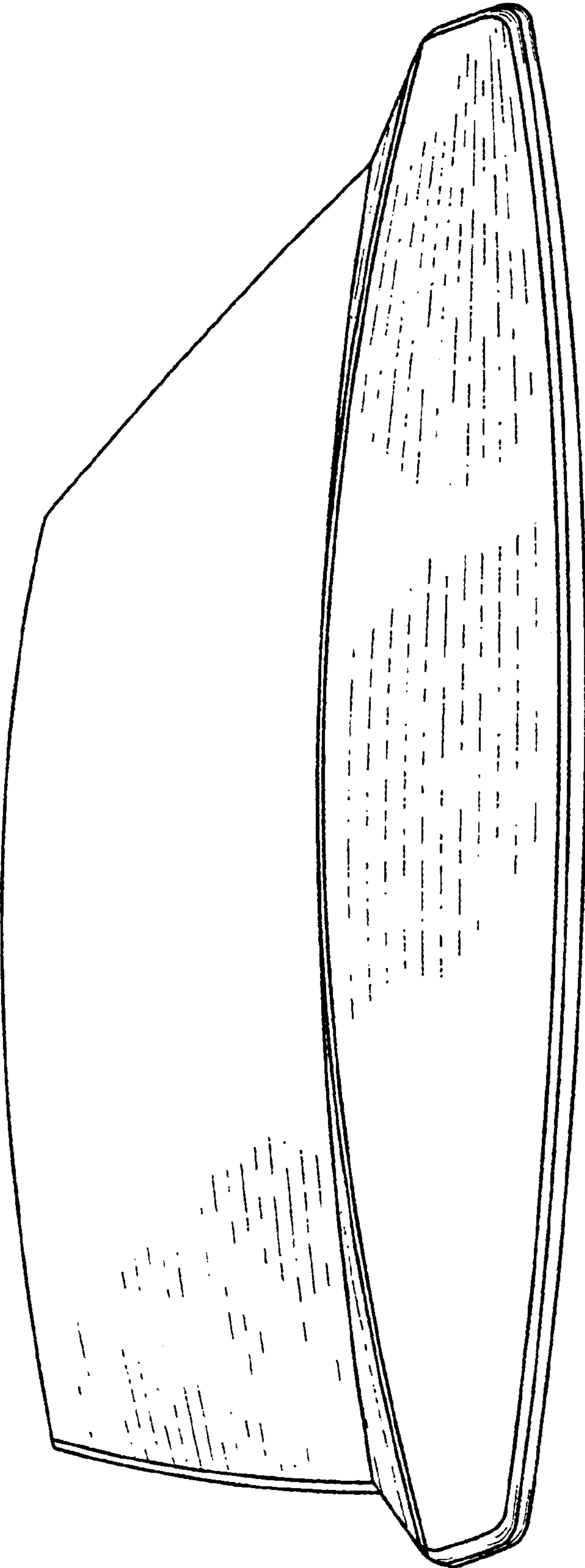

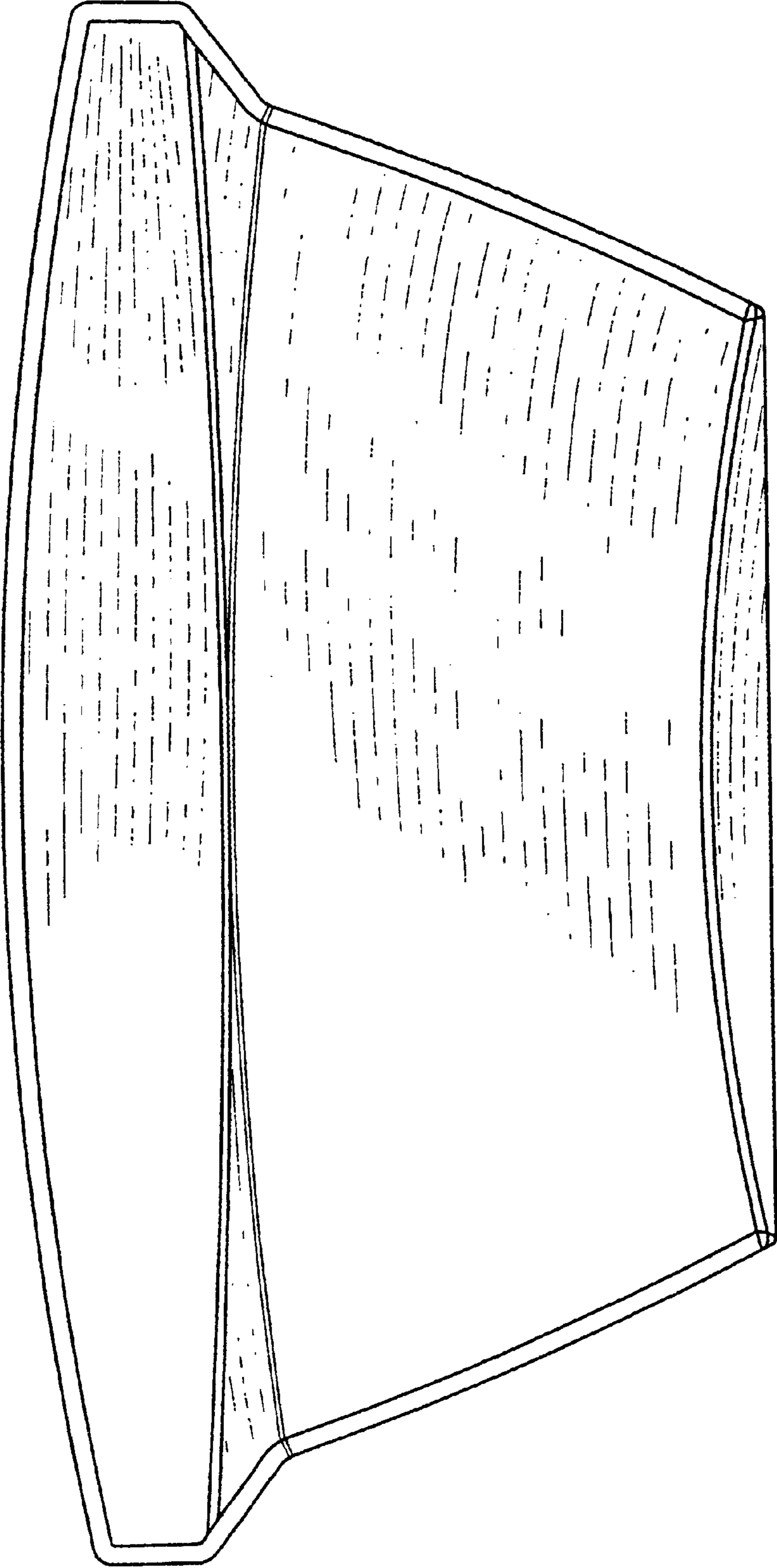

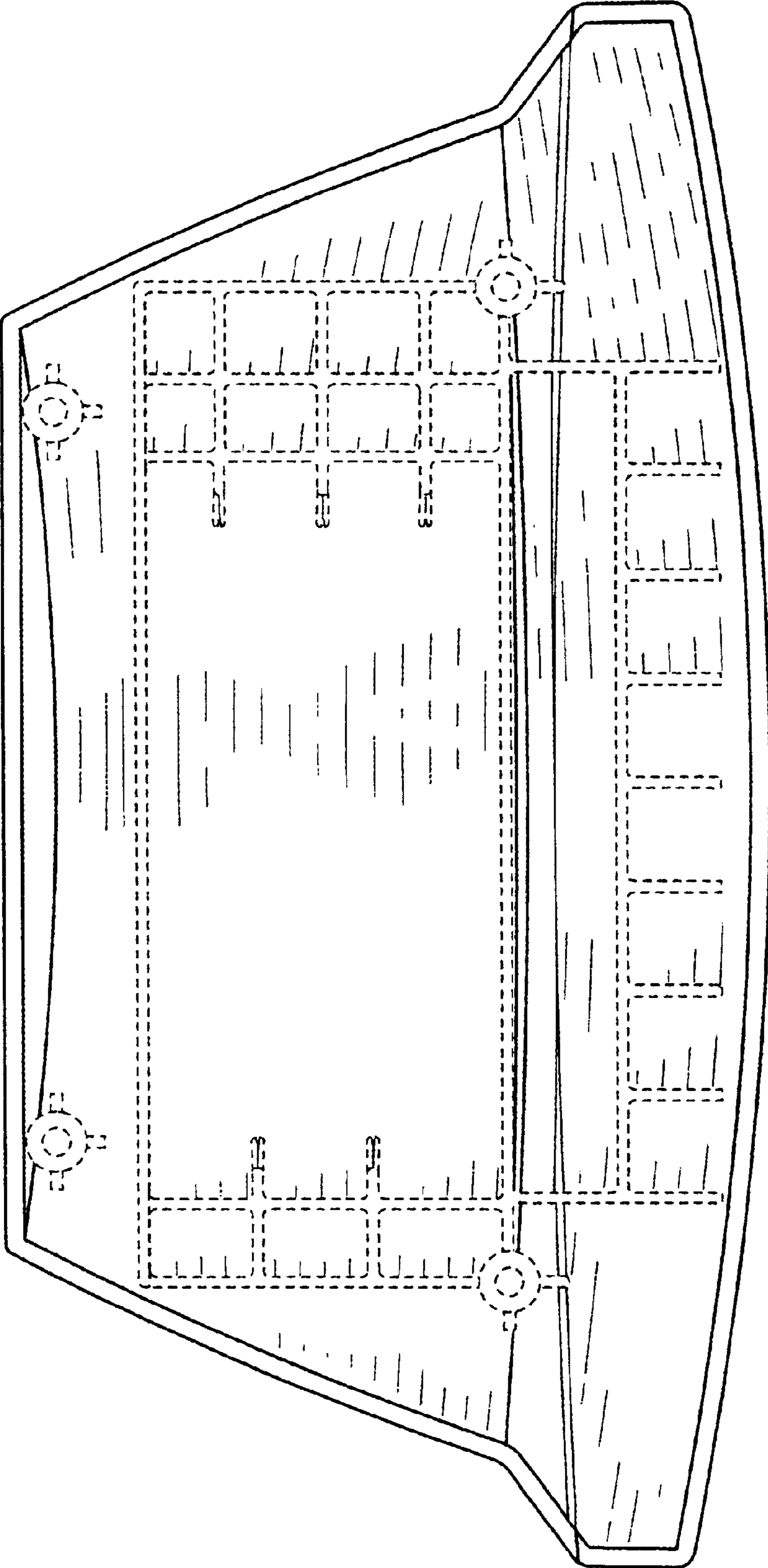

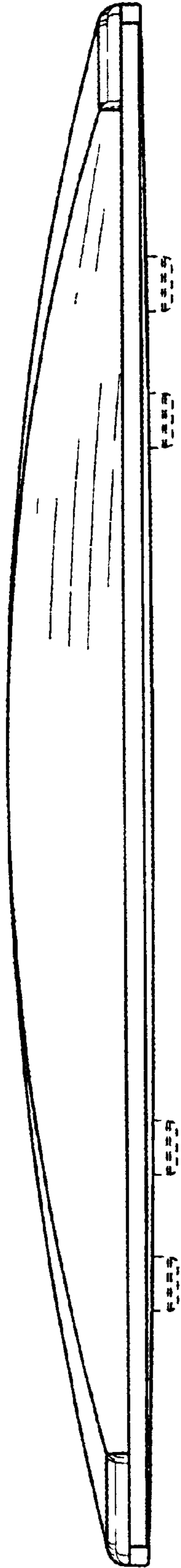

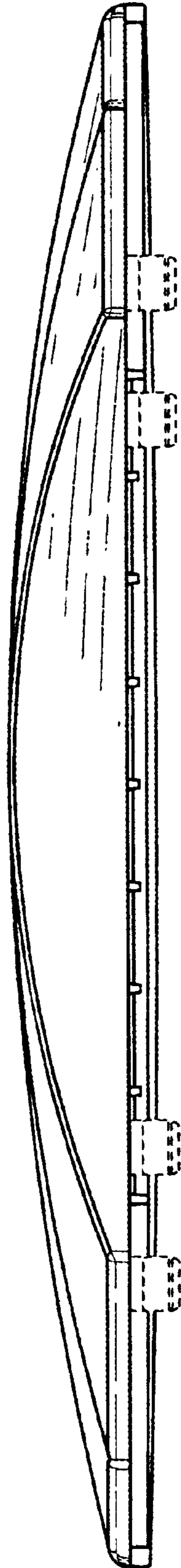

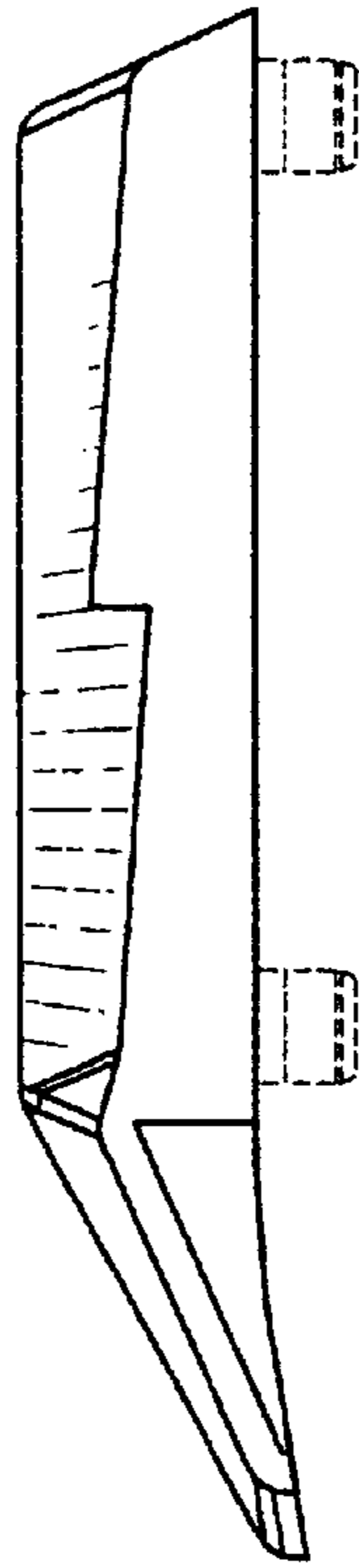

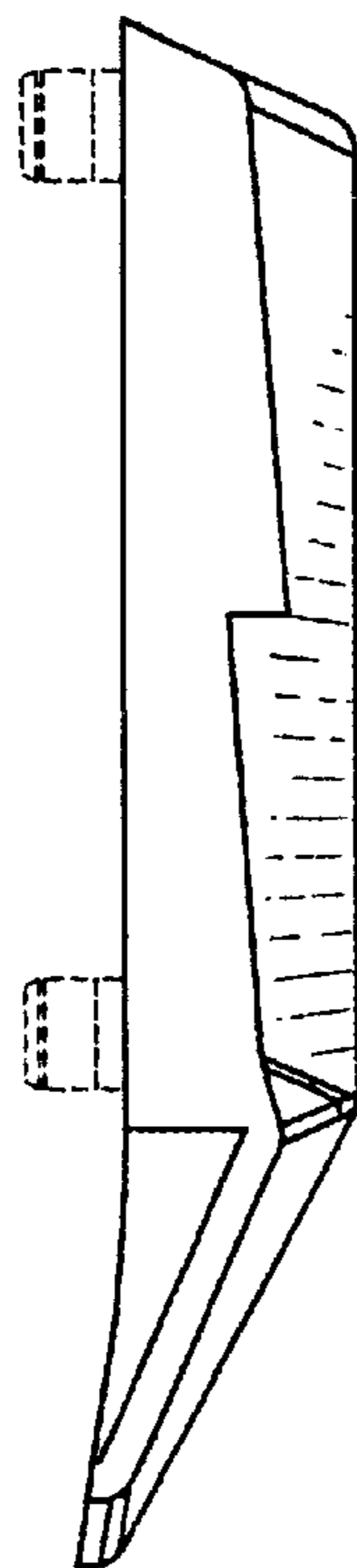
