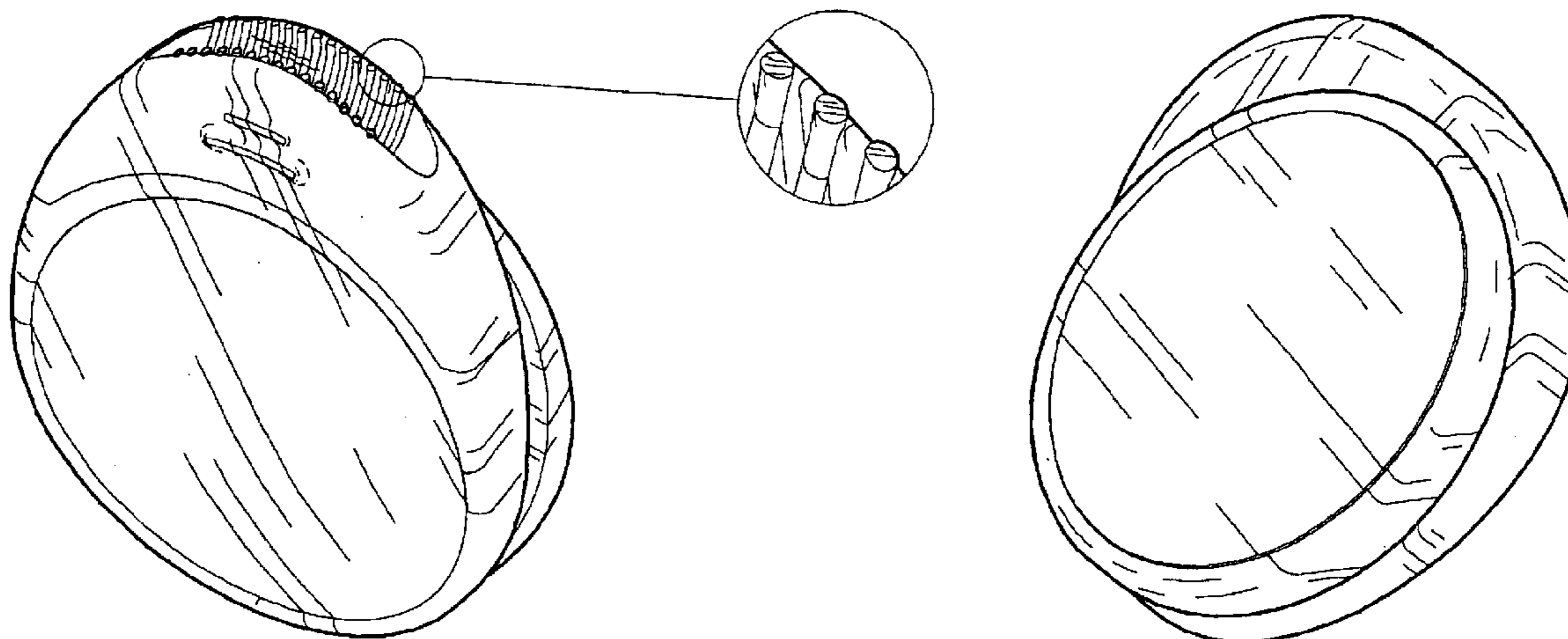
(57) **CLAIM**

The ornamental design for an oval clip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the oval clip showing the top, rear, and right sides of our new design;
 FIG. 2 is a perspective view of the oval clip showing the bottom, front, and left sides of our new design;
 FIG. 3 is an enlarged view of a ribbed section of the oval clip of FIG. 1;
 FIG. 4 is a rear and left side view of the oval clip of FIG. 1;
 FIG. 5 is a rear view of the oval clip of FIG. 1;
 FIG. 6 is a left side view of the oval clip of FIG. 1;
 FIG. 7 is a top view of the oval clip of FIG. 1;

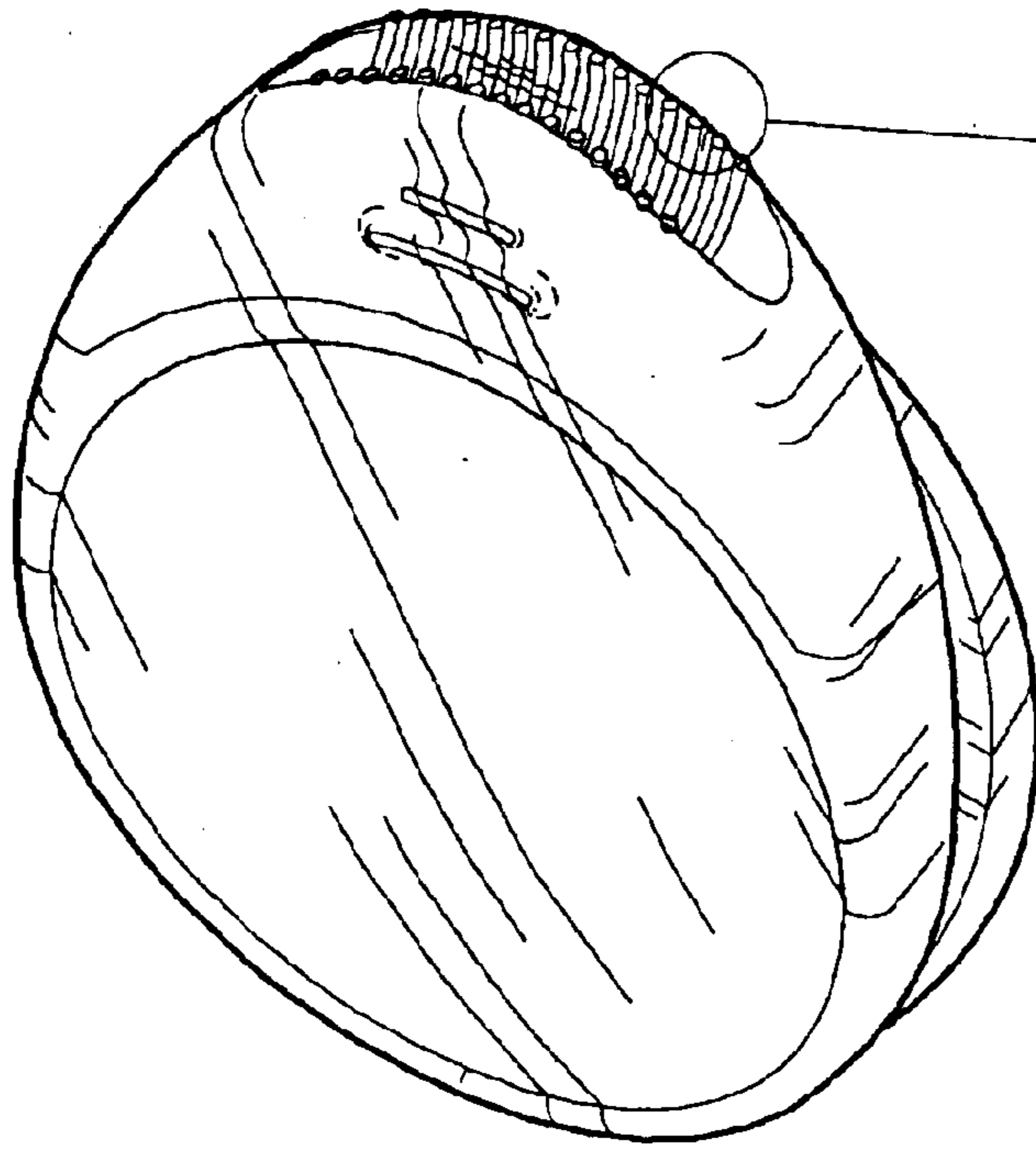

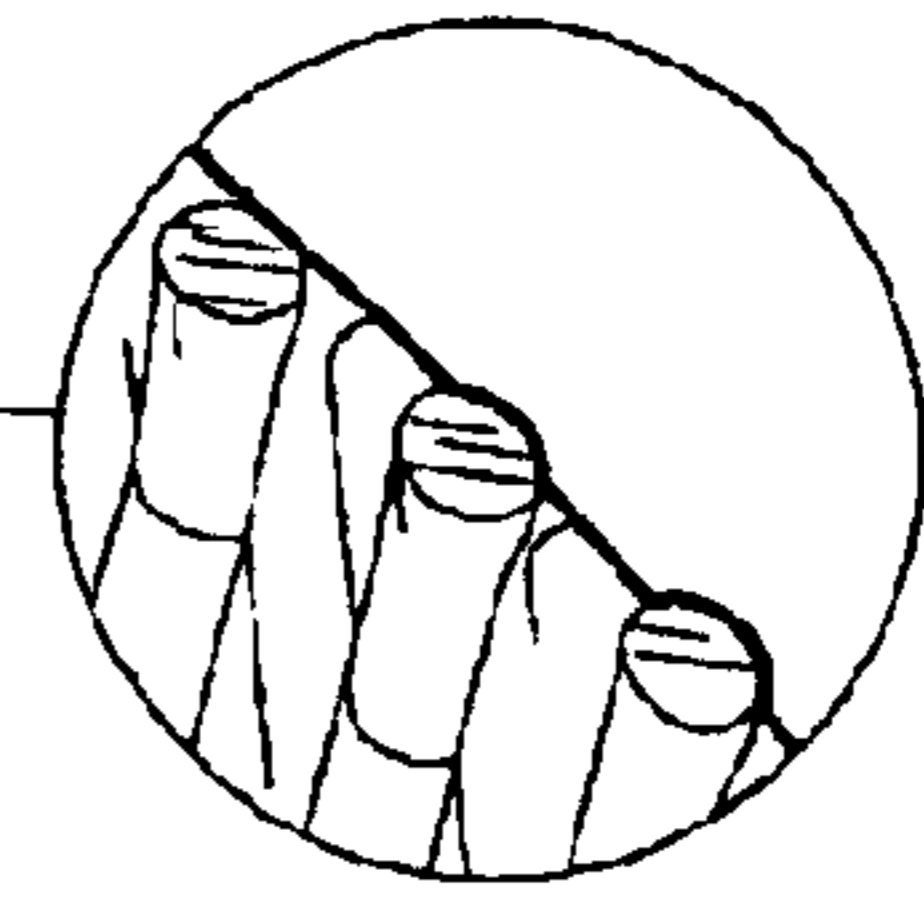

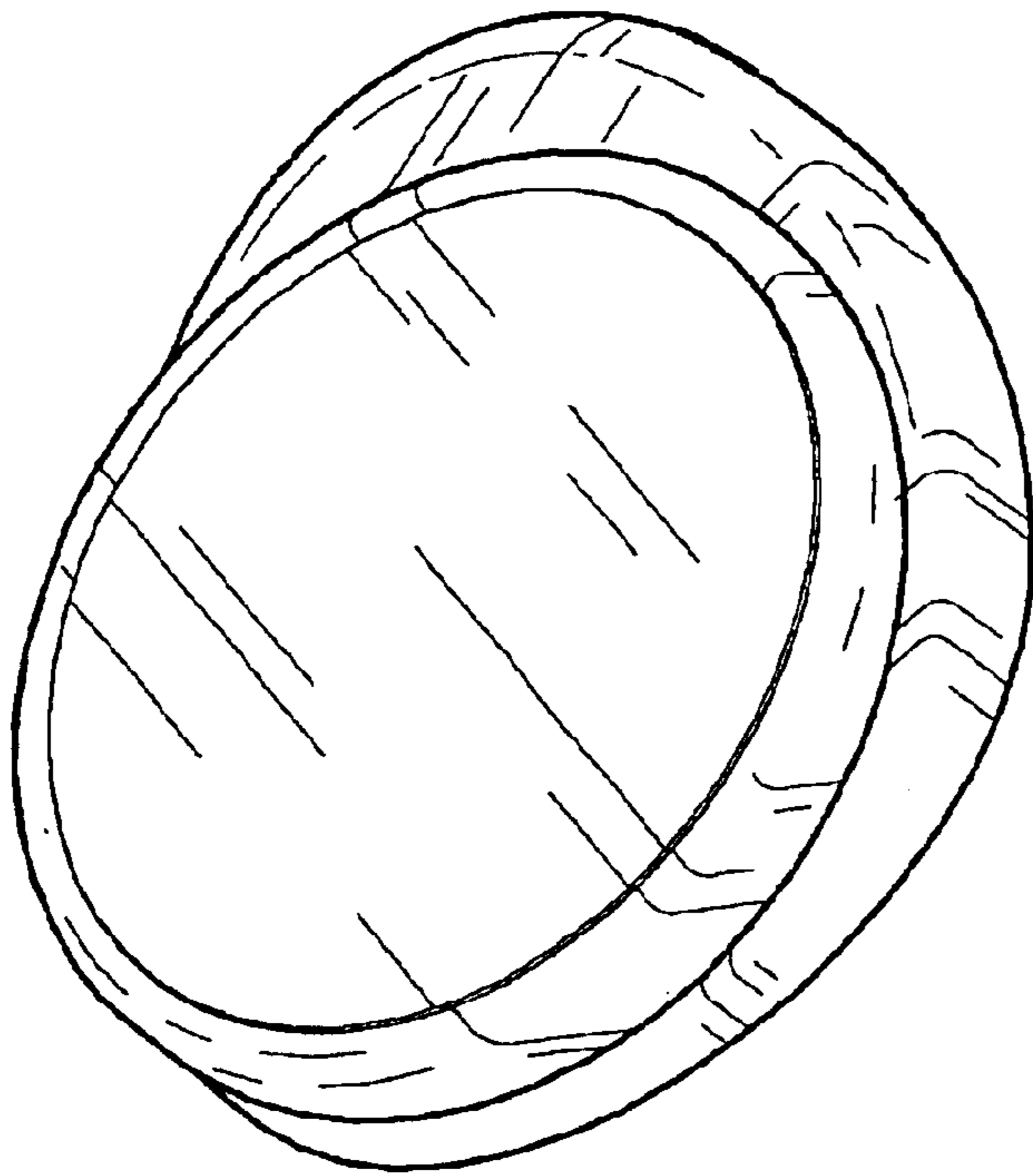

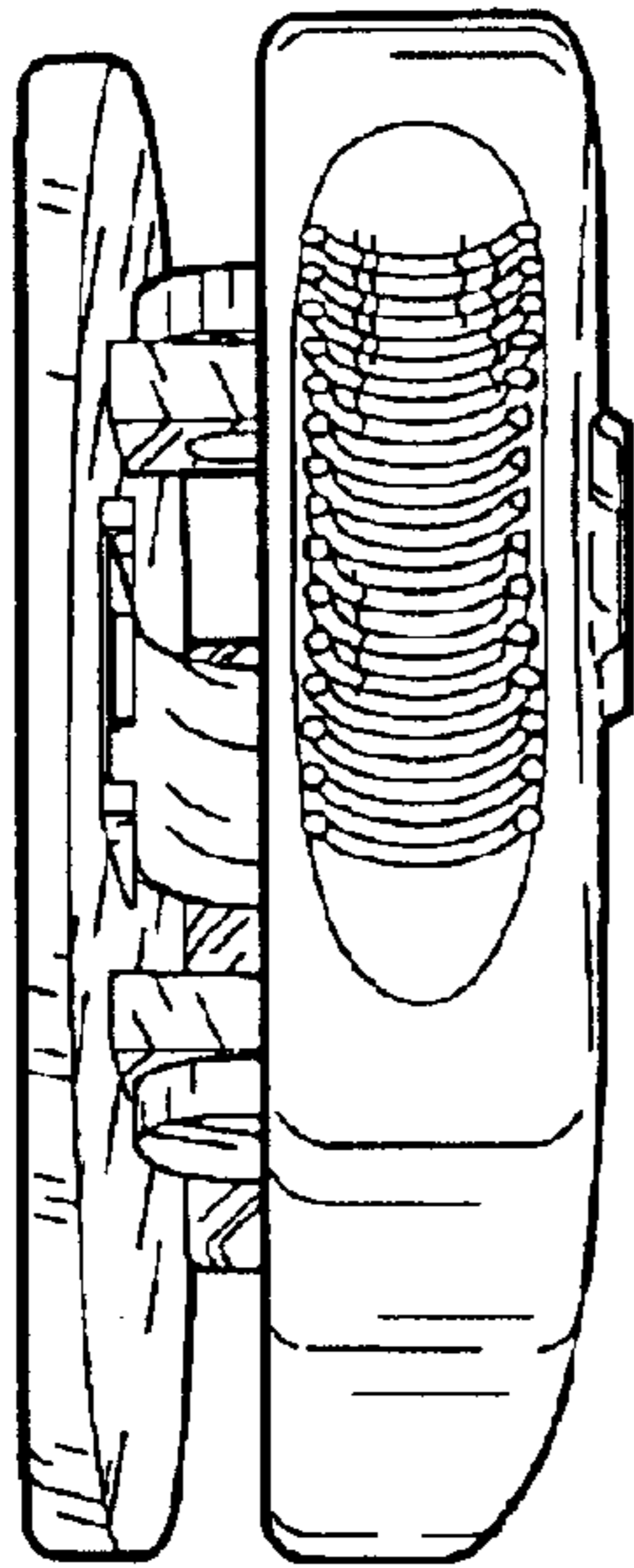

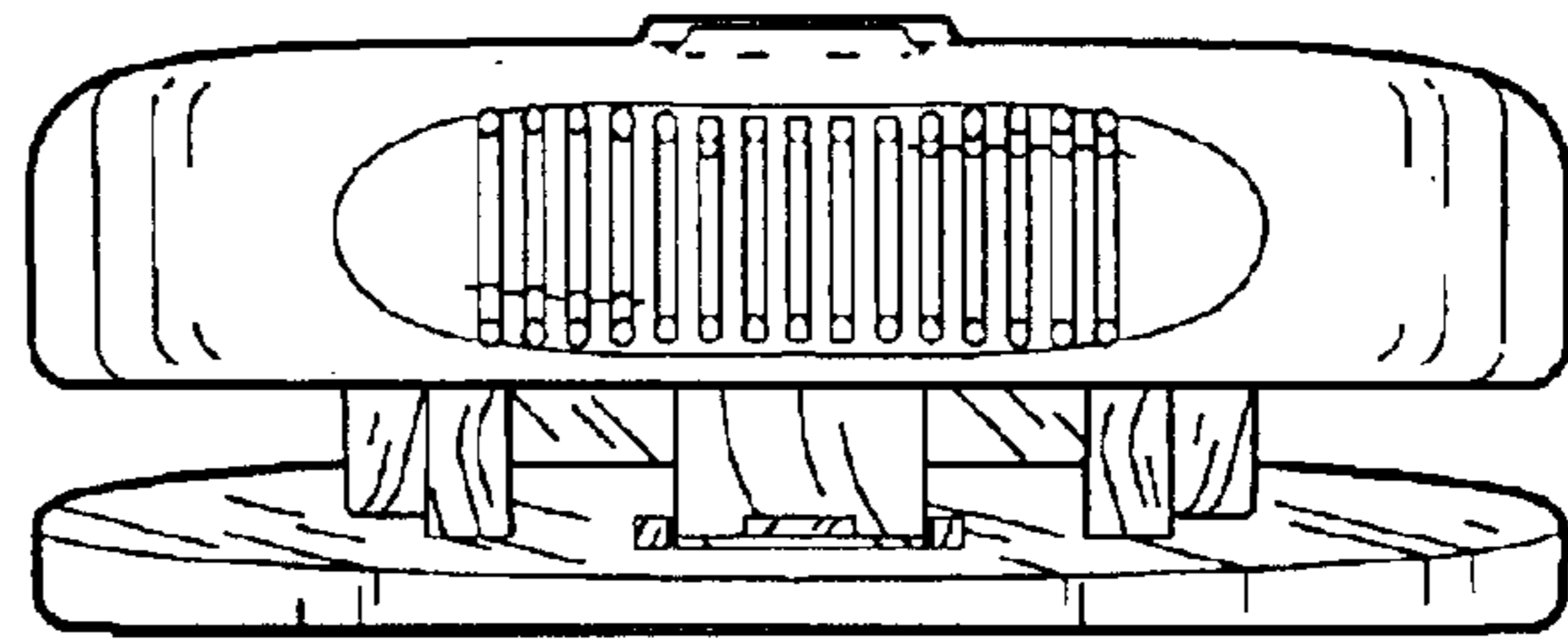

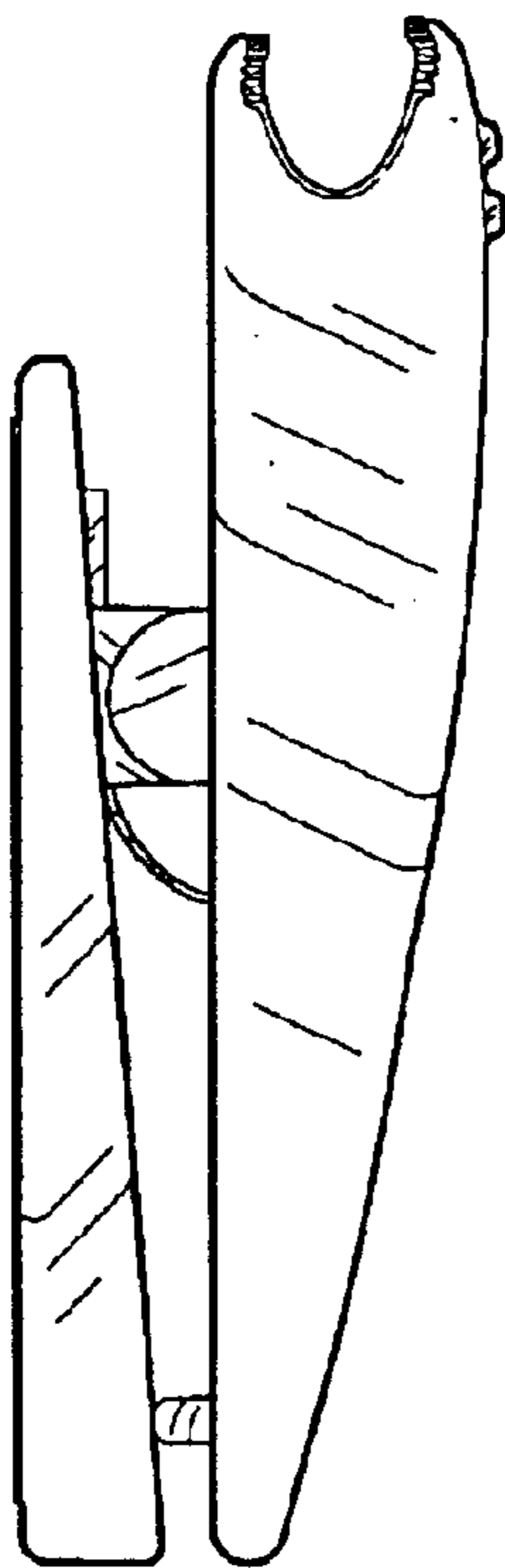

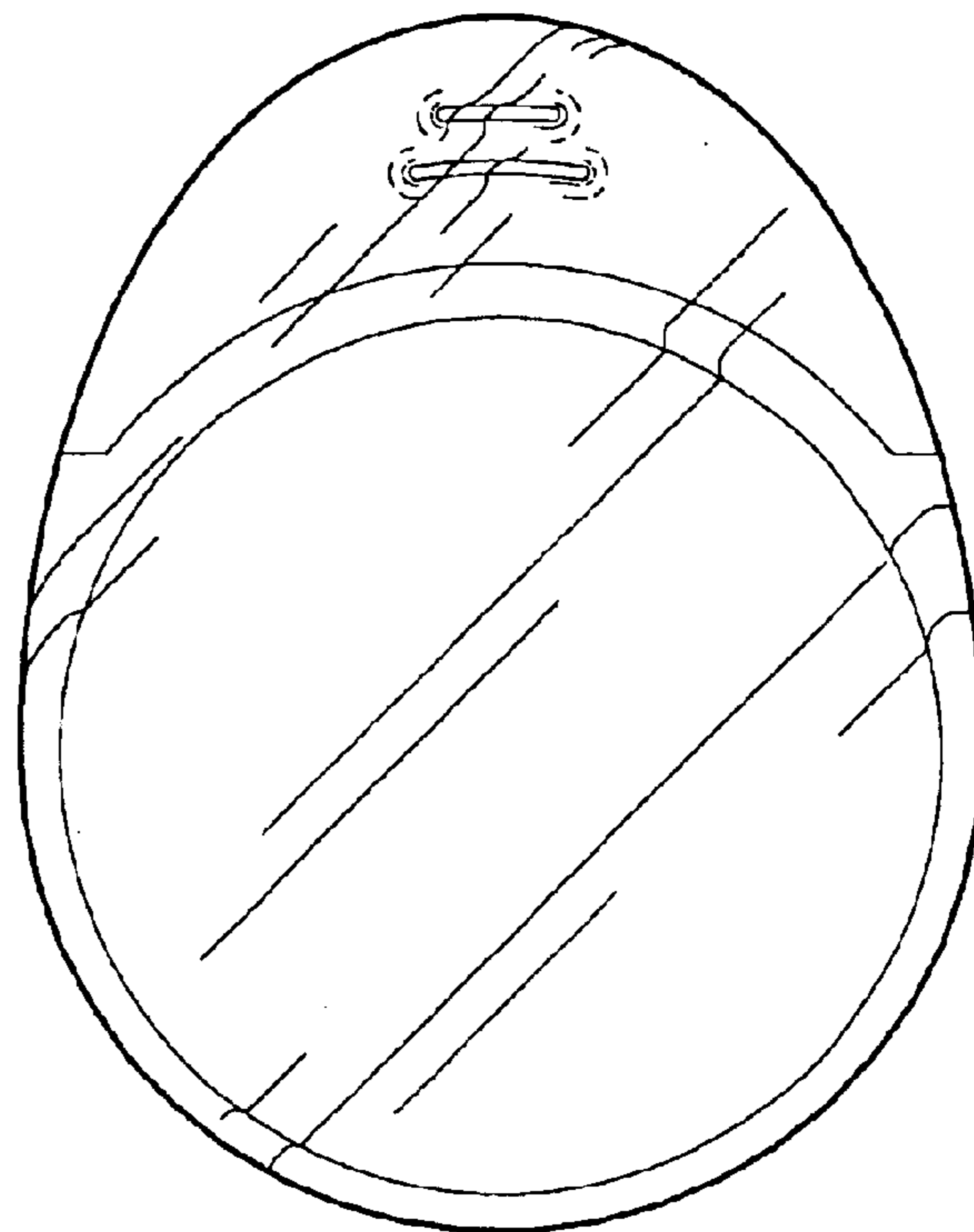

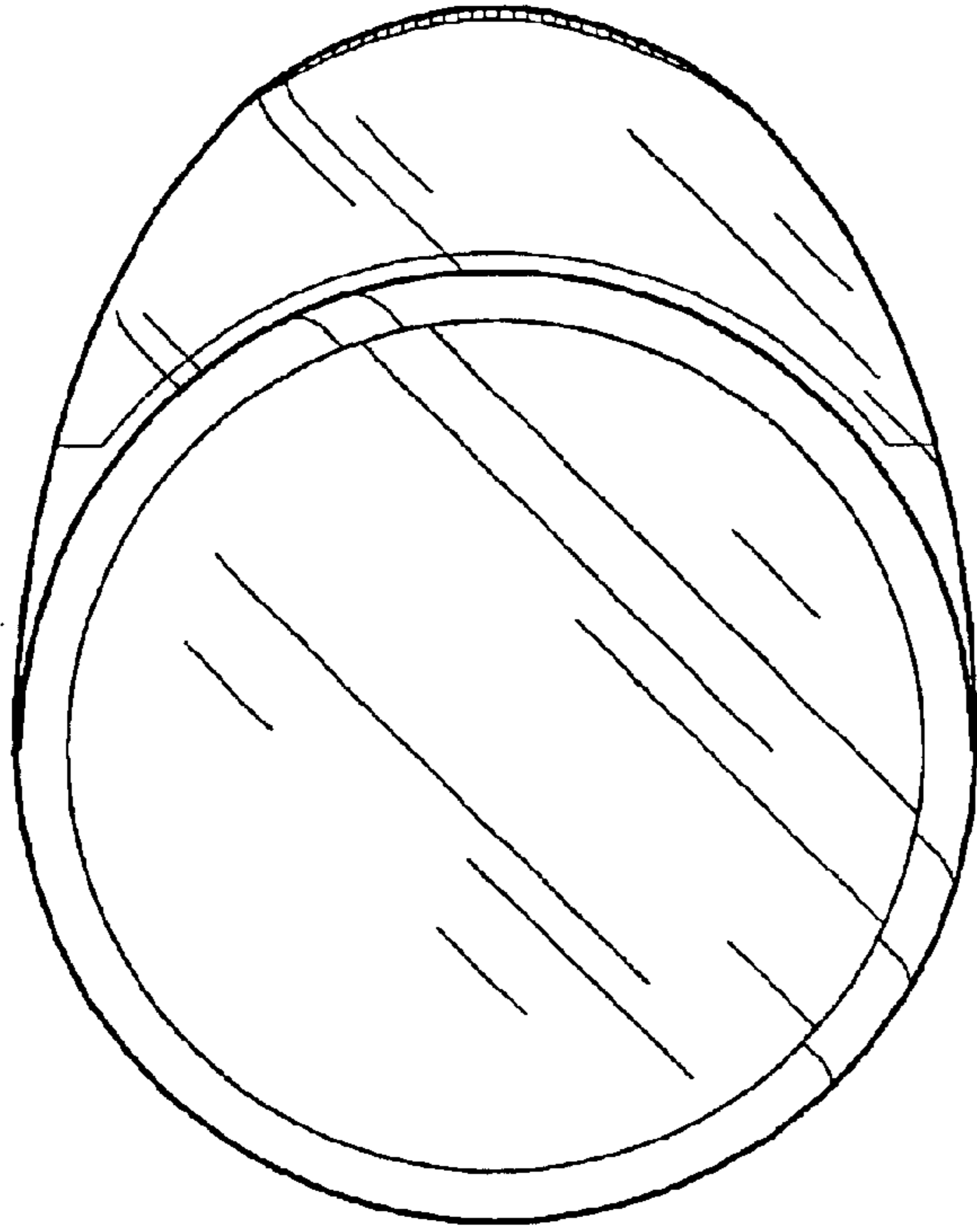

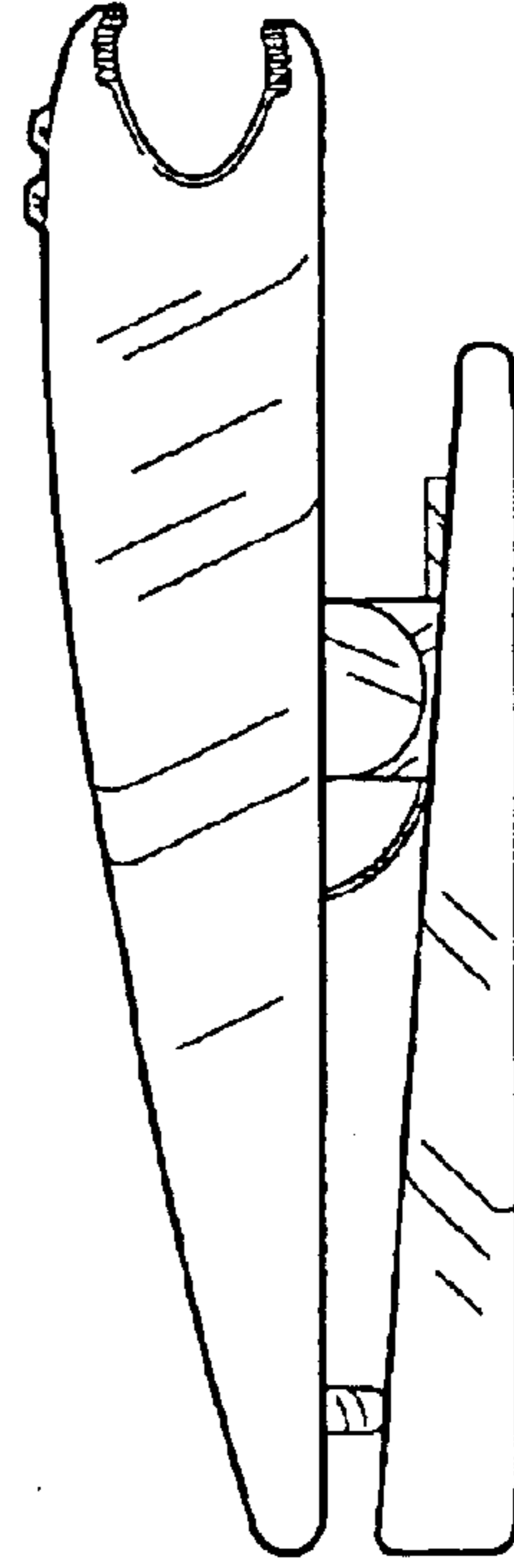

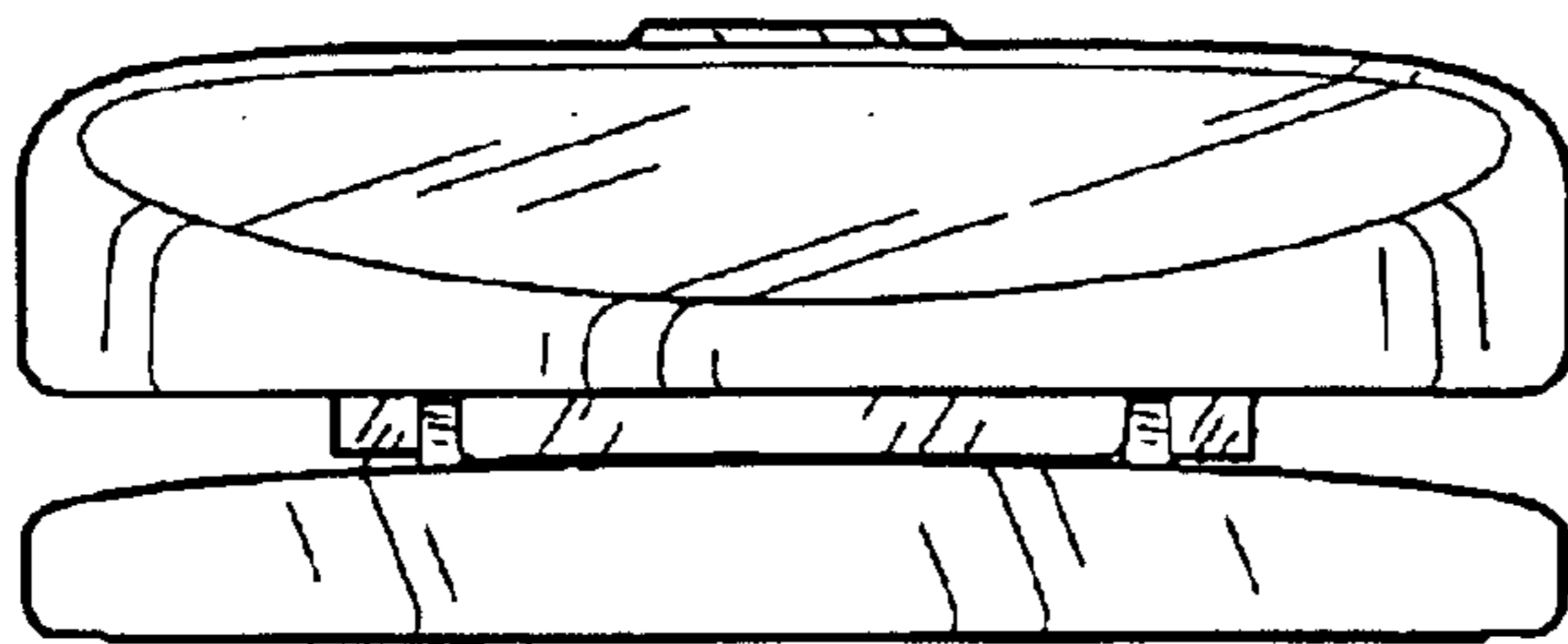
