(57) **CLAIM**

The ornamental design for a two-colored swirled cereal piece, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a two-colored swirled cereal piece in accordance with the present invention;

FIG. 2 is a top plan view of the cereal piece of FIG. 1;

FIG. 3 is a bottom plan view of the cereal piece of FIG. 1;

FIG. 4 is a rear elevational view of the cereal piece of FIG. 2;

FIG. 5 is a left side elevational view of the cereal piece of FIG. 2;

FIG. 6 is a front elevational view of the cereal piece of FIG. 2;

FIG. 7 is a right side elevational view of the cereal piece of FIG. 2;

FIG. 8 is a perspective view of a two-colored cereal piece having a frosted coating in accordance with the present invention;

FIG. 9 is a top plan view of the cereal piece of FIG. 8;

FIG. 10 is a bottom plan view of the cereal piece of FIG. 8;

FIG. 11 is a rear elevational view of the cereal piece of FIG. 9;

FIG. 12 is a left side elevational view of the cereal piece of FIG. 9;

FIG. 13 is a front elevational view of the cereal piece of FIG. 9;

FIG. 14 is a right side elevational view of the cereal piece of FIG. 9;

FIG. 15 is an enlarged perspective view of a two-colored swirled cereal piece having a cinnamon and sugar coating in accordance with the present invention;

FIG. 16 is a top plan view of the cereal piece of FIG. 15;

FIG. 17 is a bottom plan view of the cereal piece of FIG. 15;

FIG. 18 is a rear elevational view of the cereal piece of FIG. 16;

FIG. 19 is a left side elevational view of the cereal piece of FIG. 16;

FIG. 20 is a front elevational view of the cereal piece of FIG. 16; and,

FIG. 21 is a right side elevational view of the cereal piece of FIG. 16.

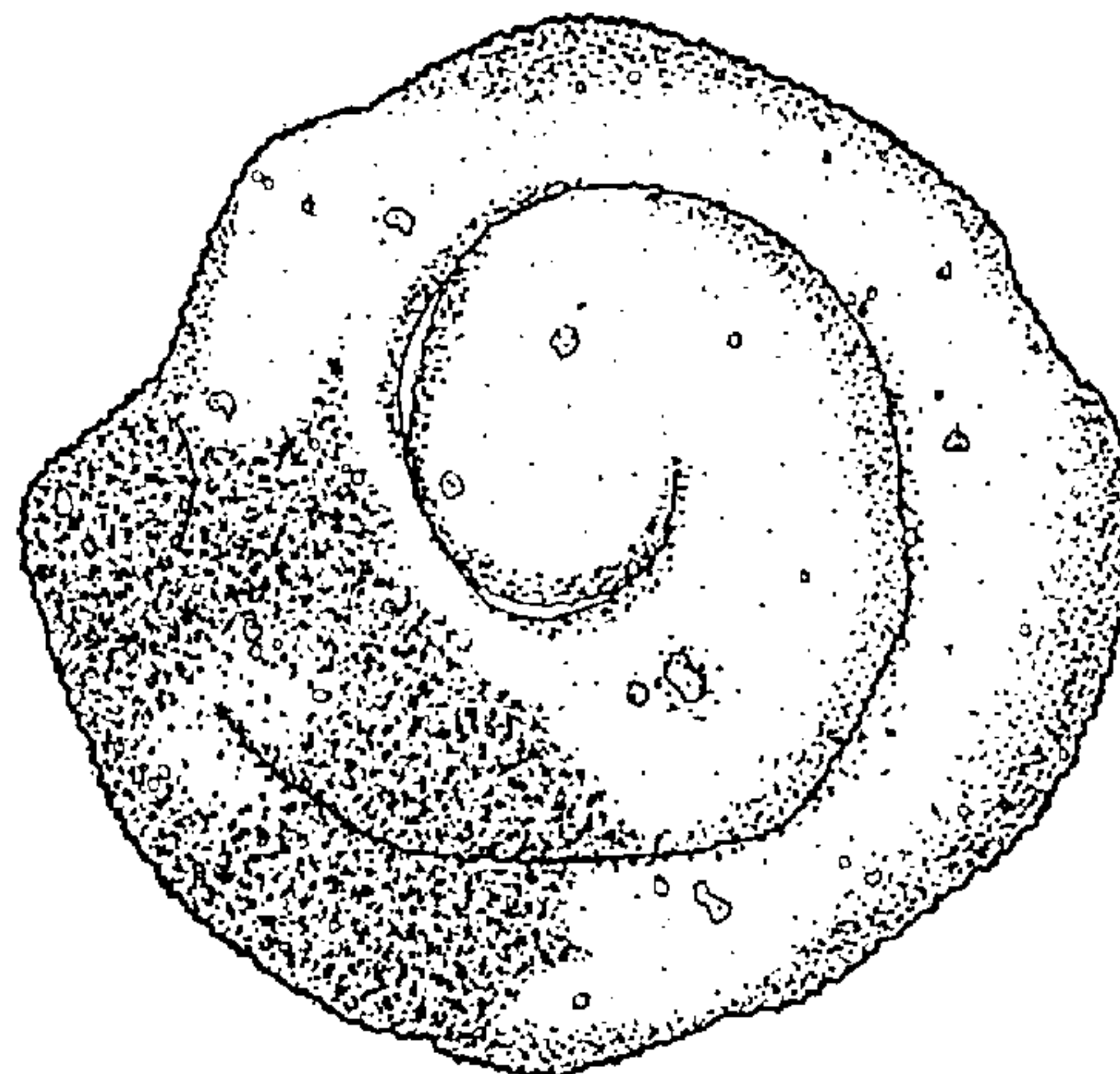
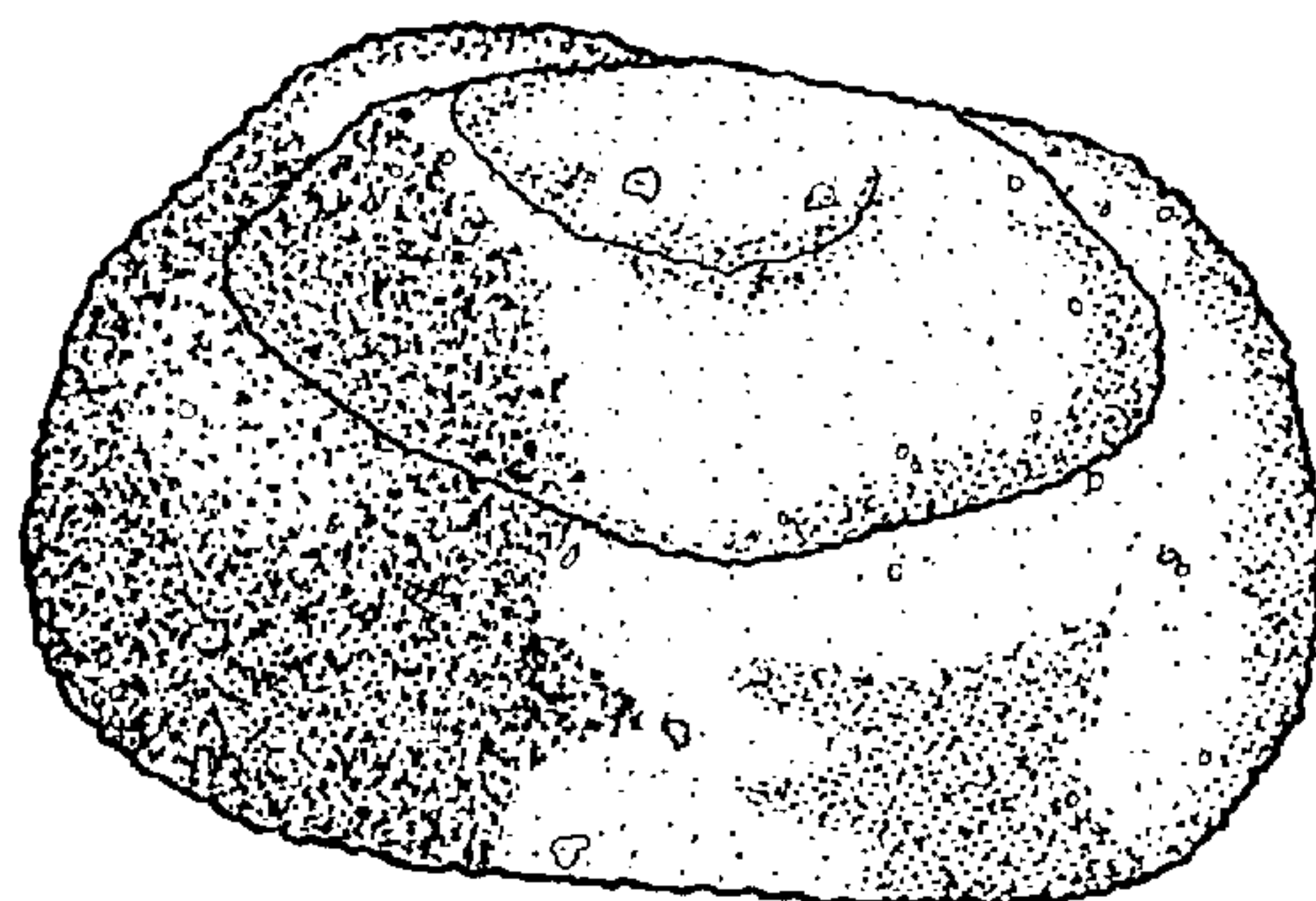

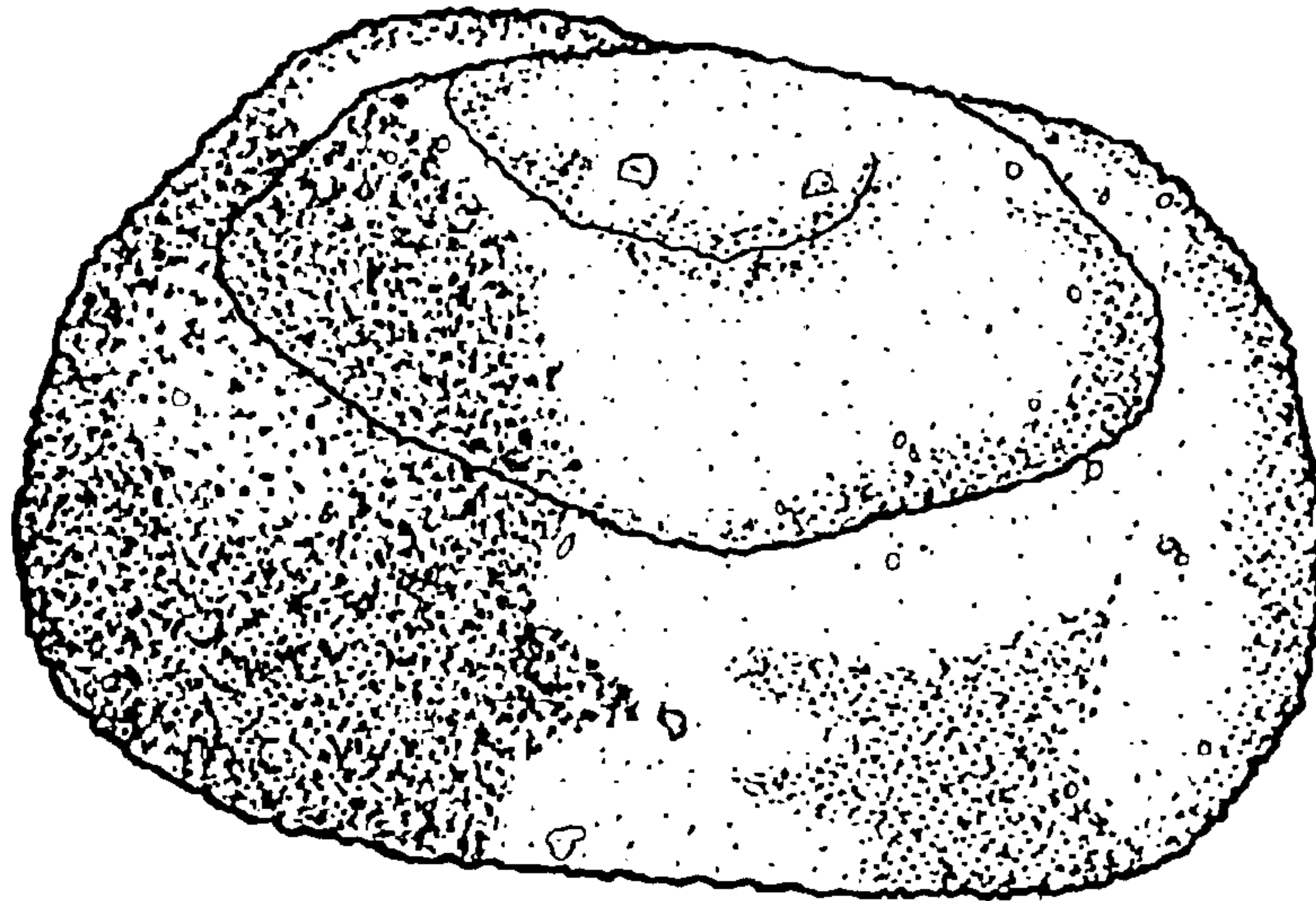

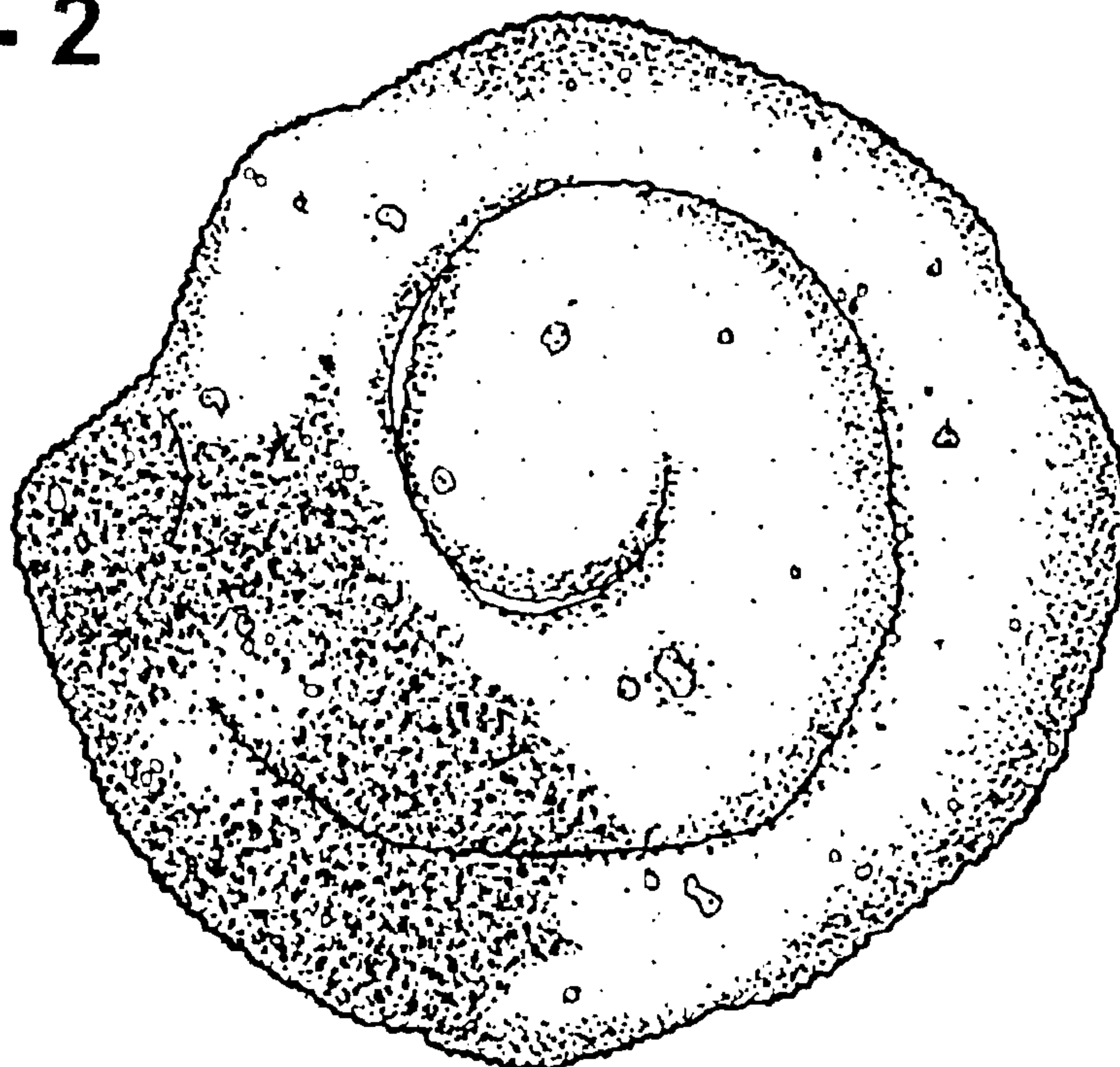

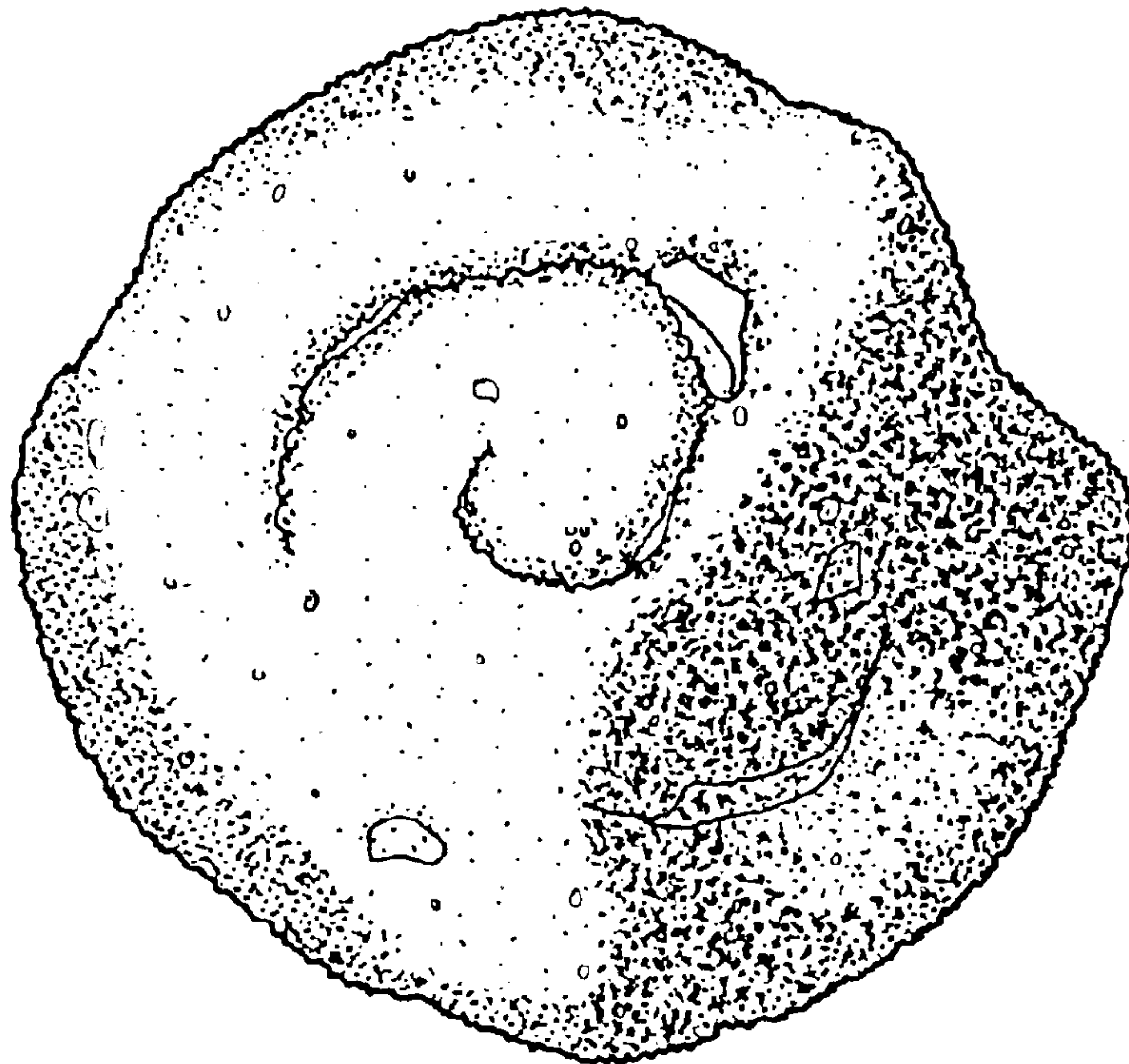

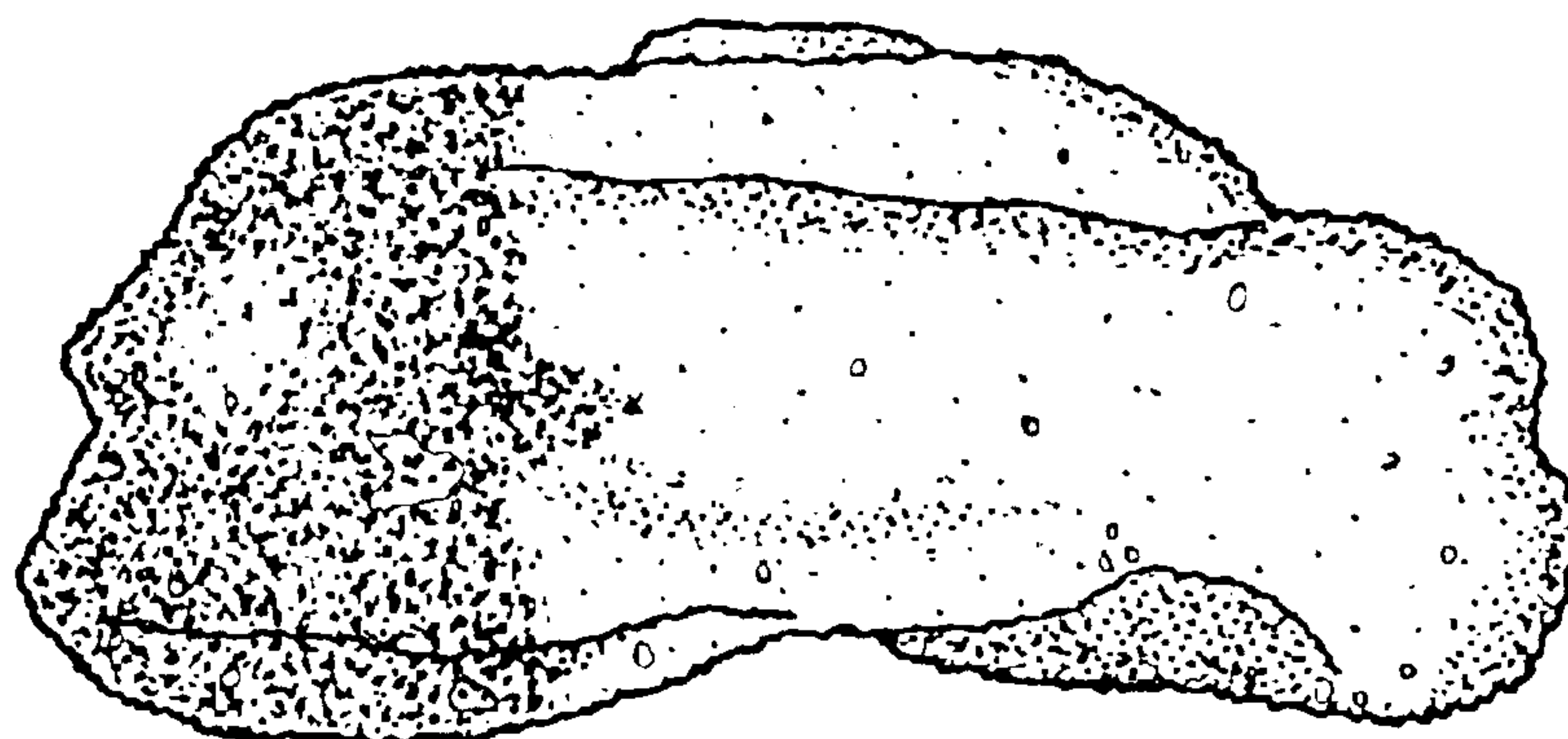

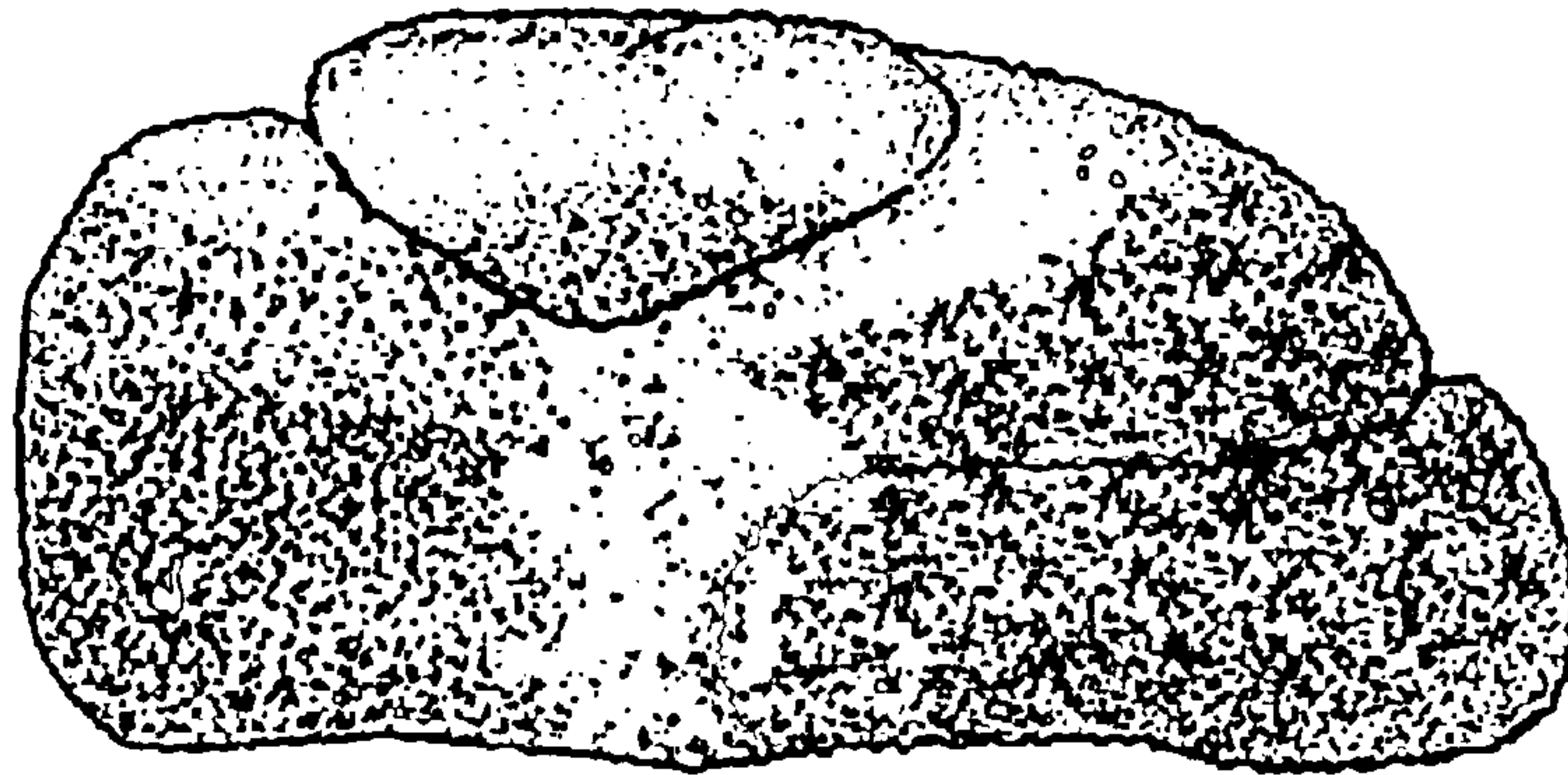

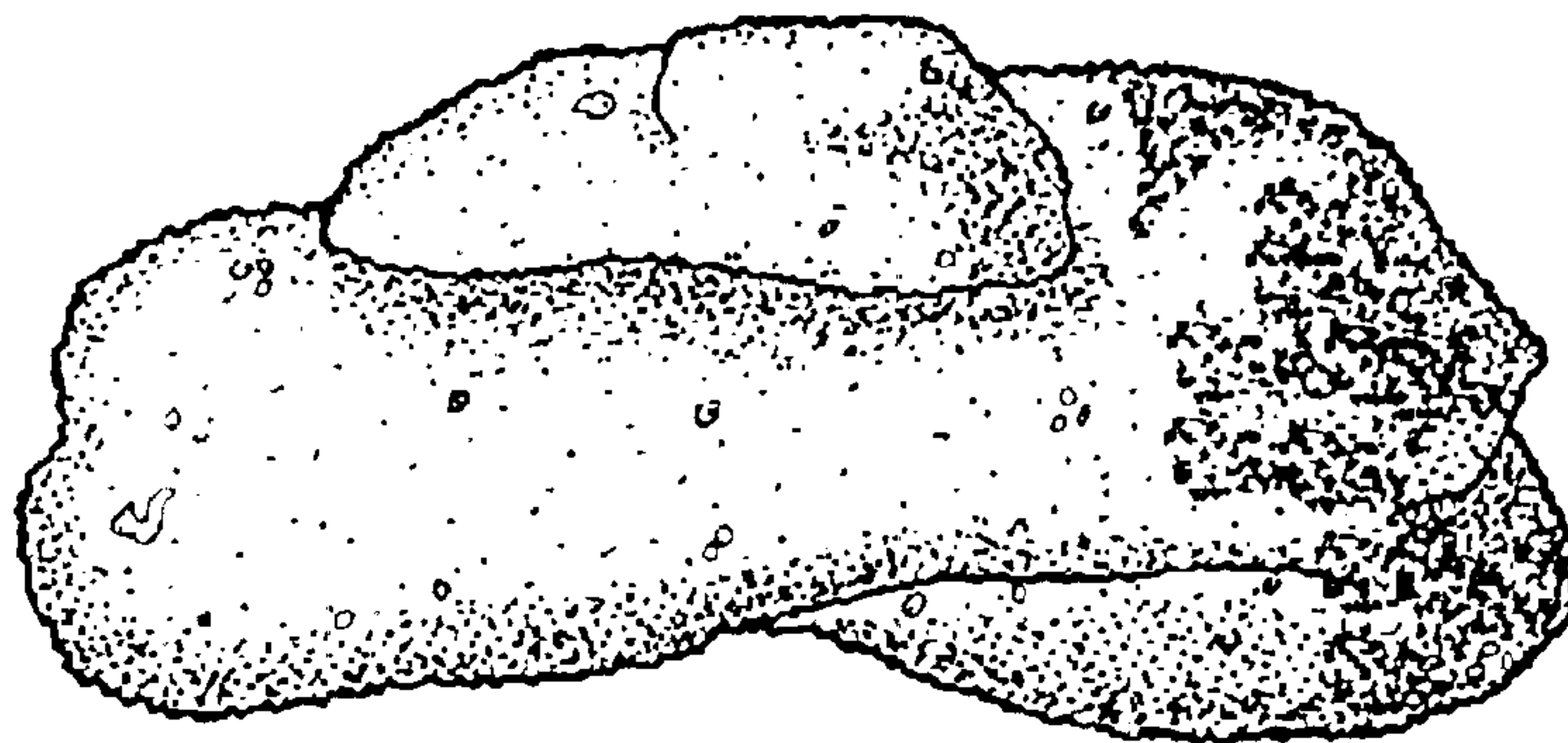

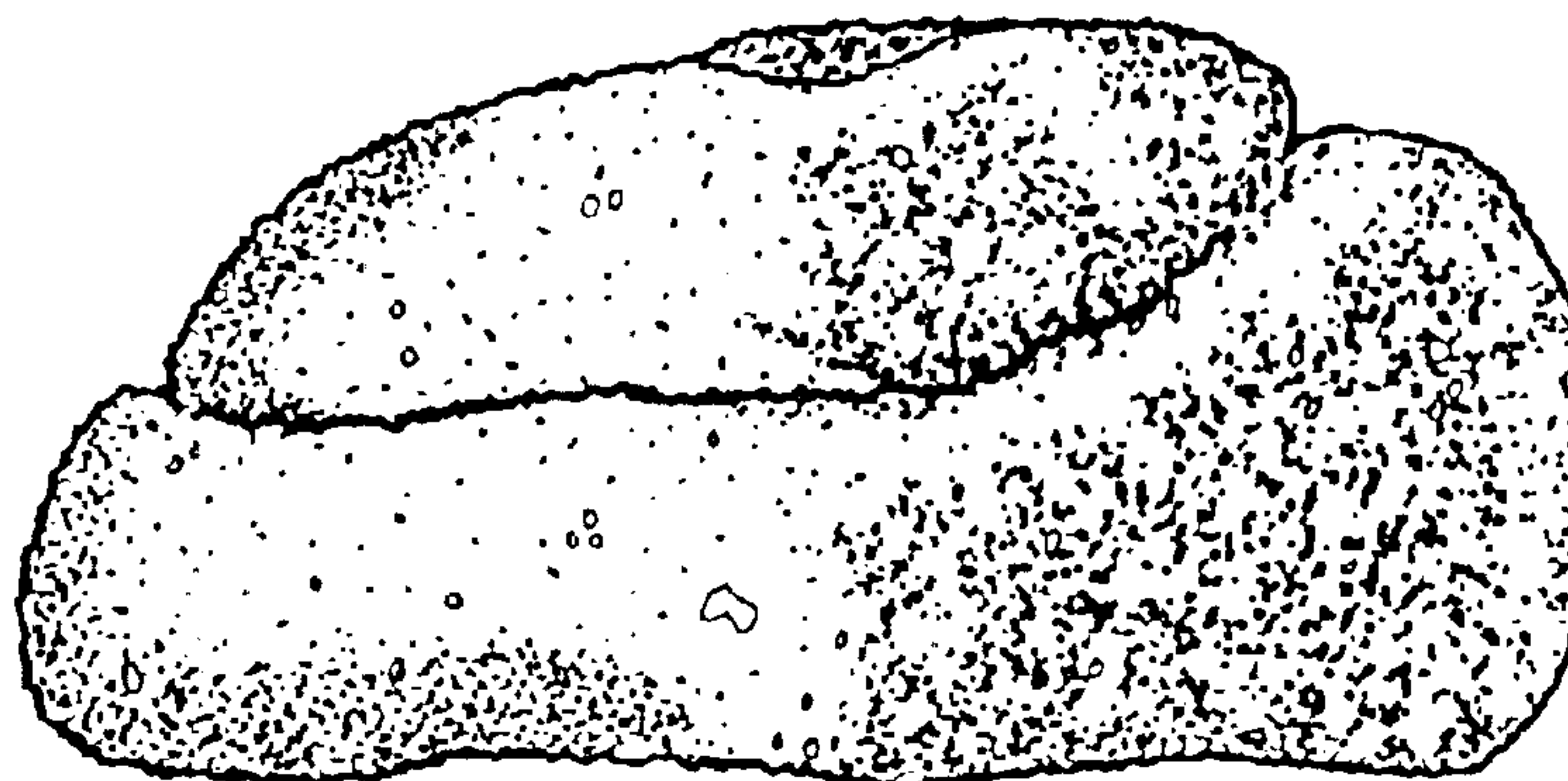

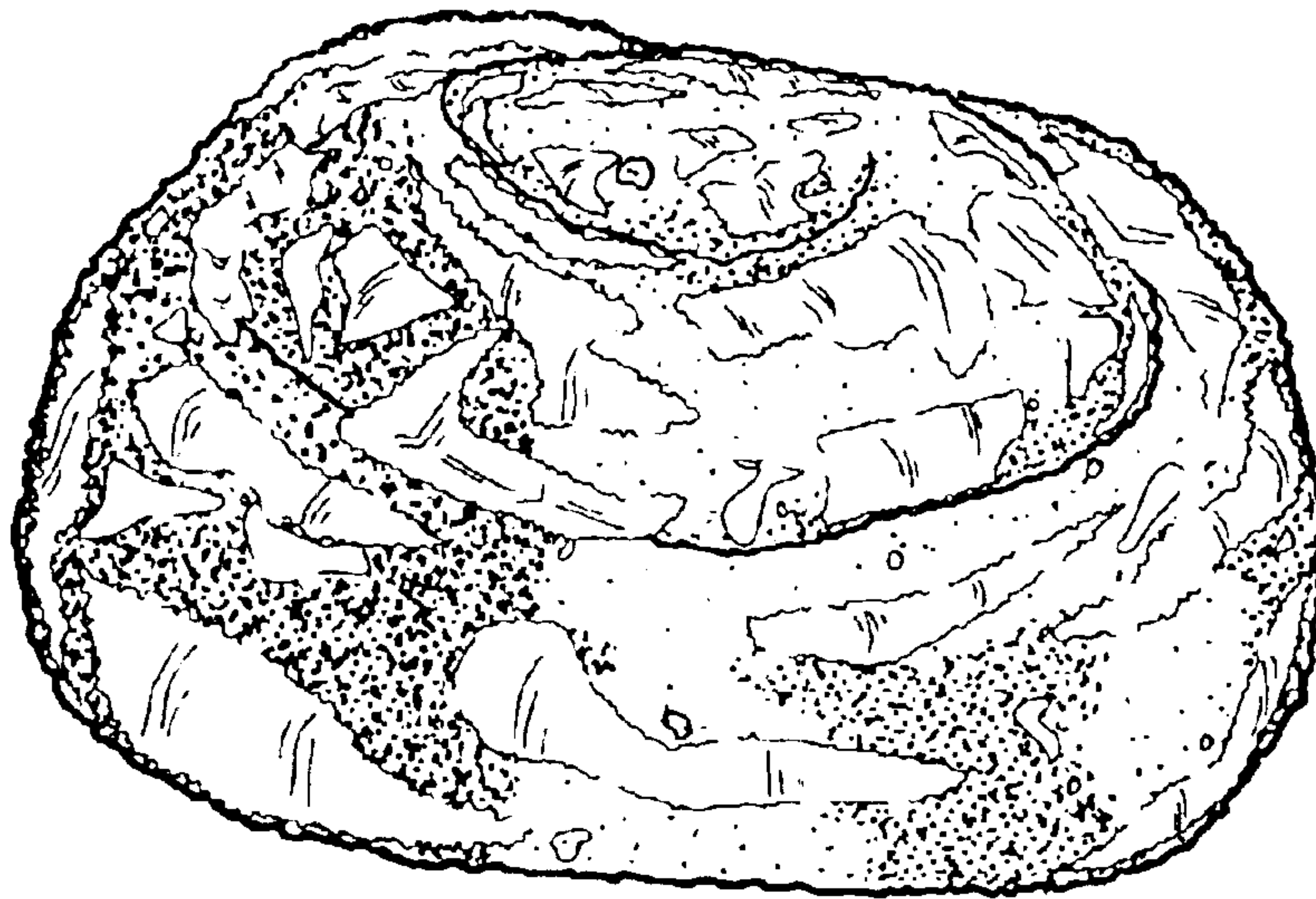

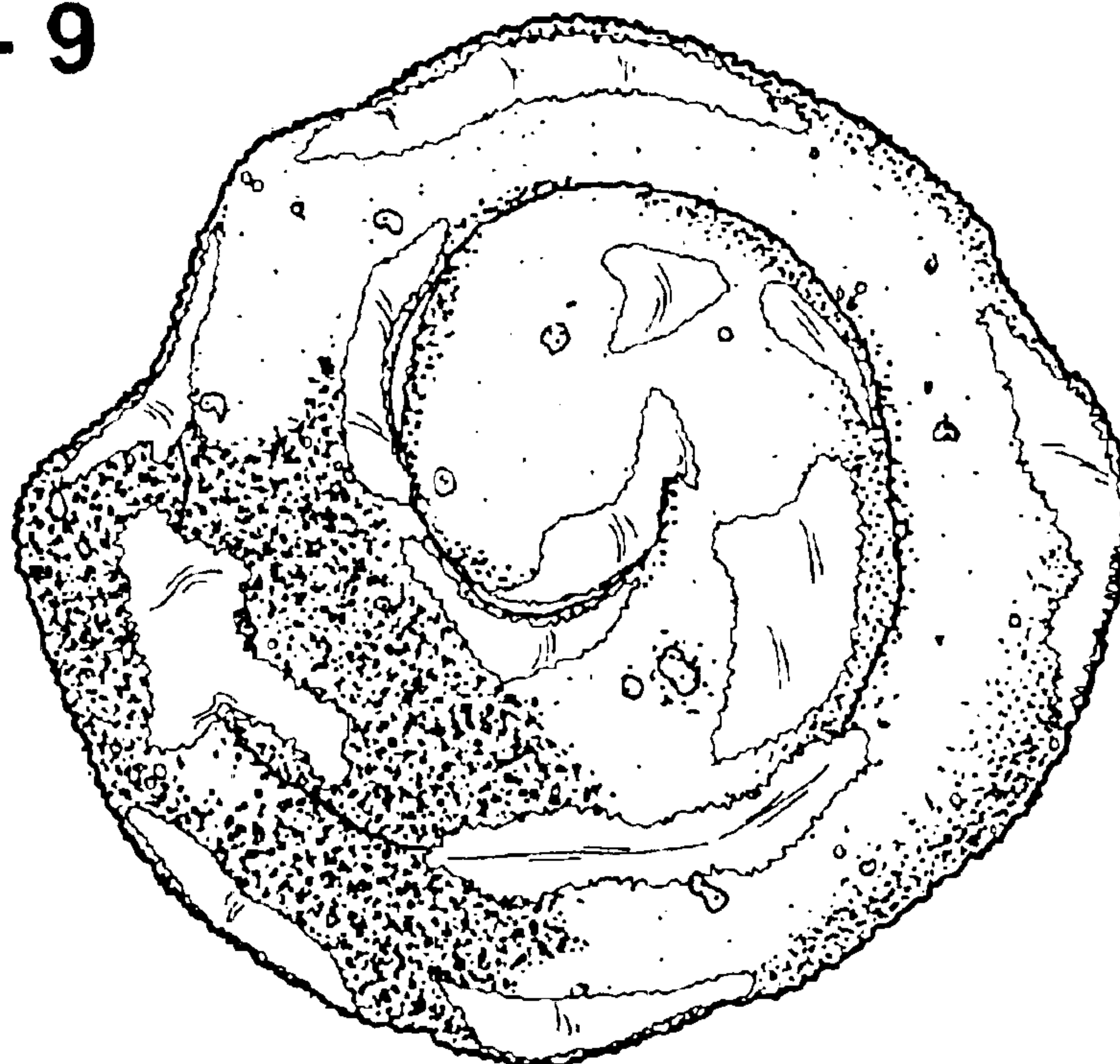

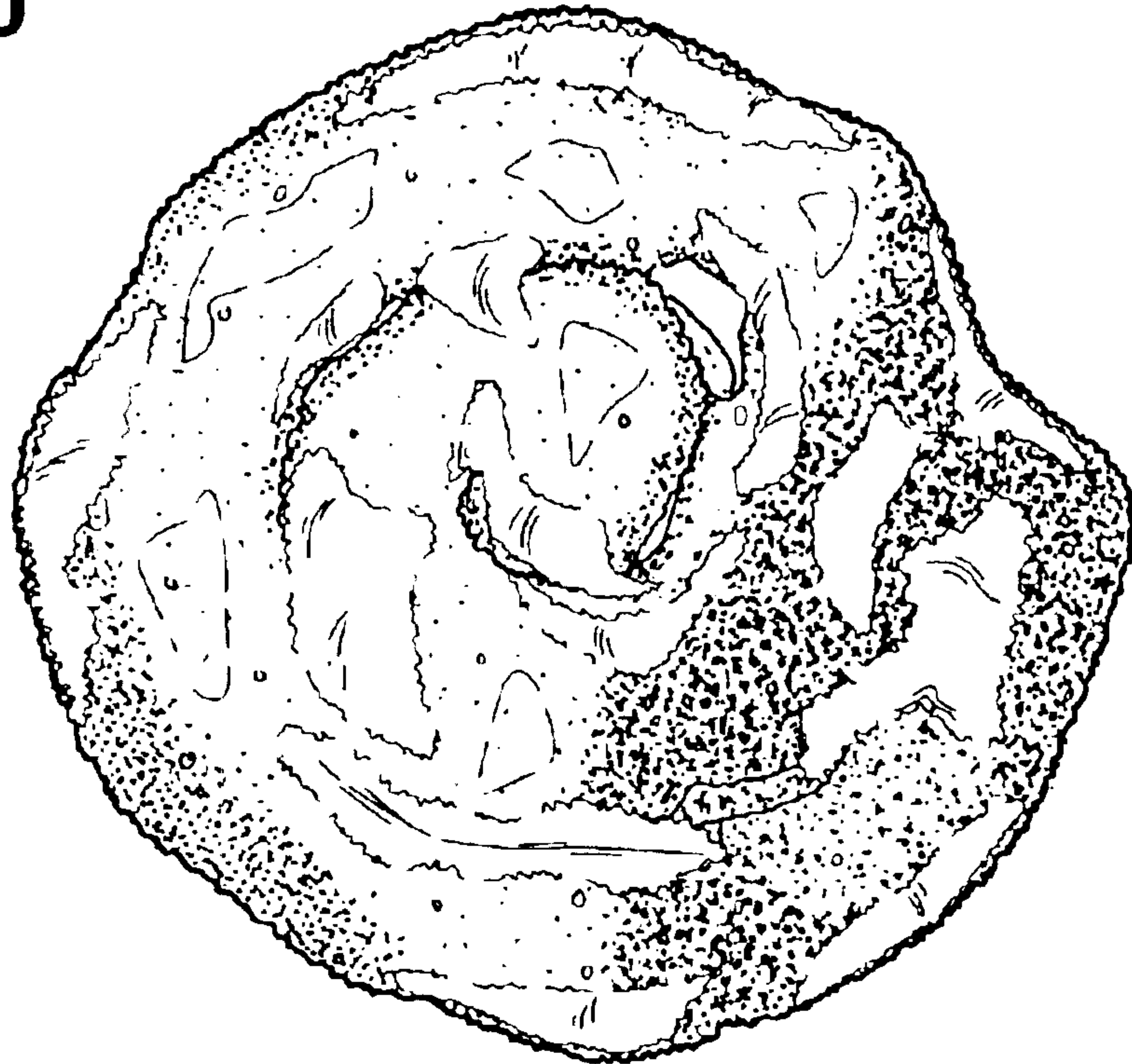

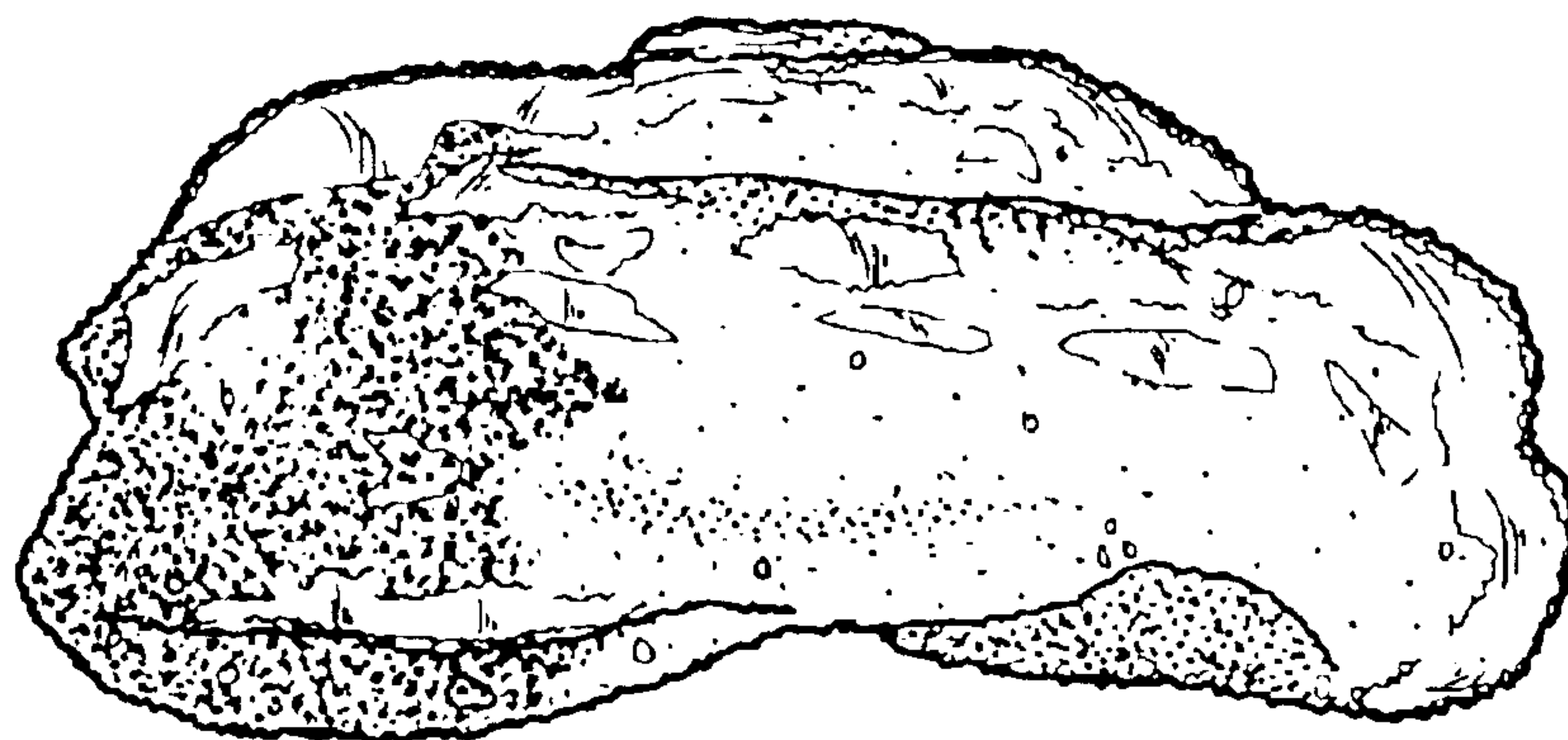

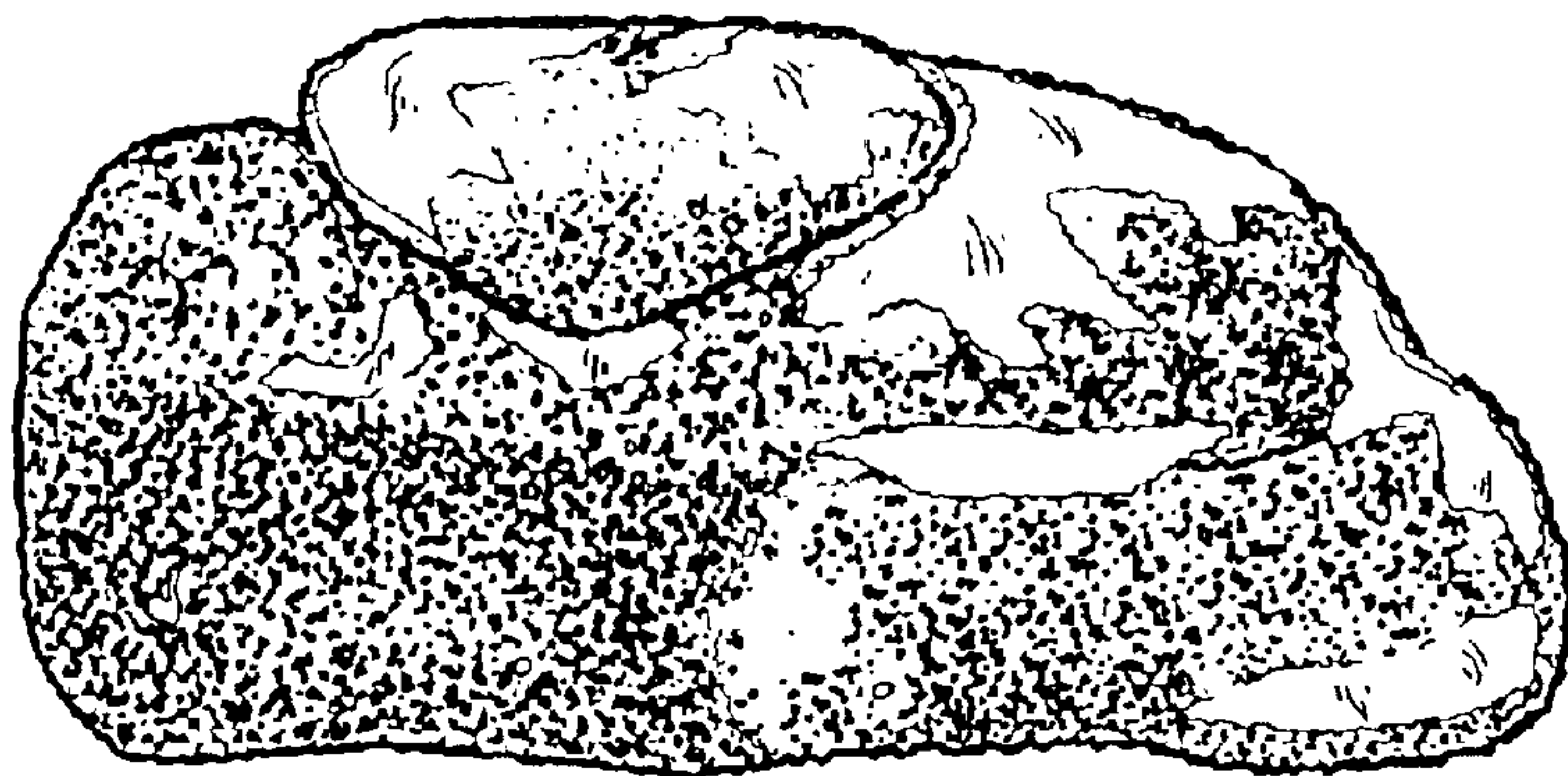

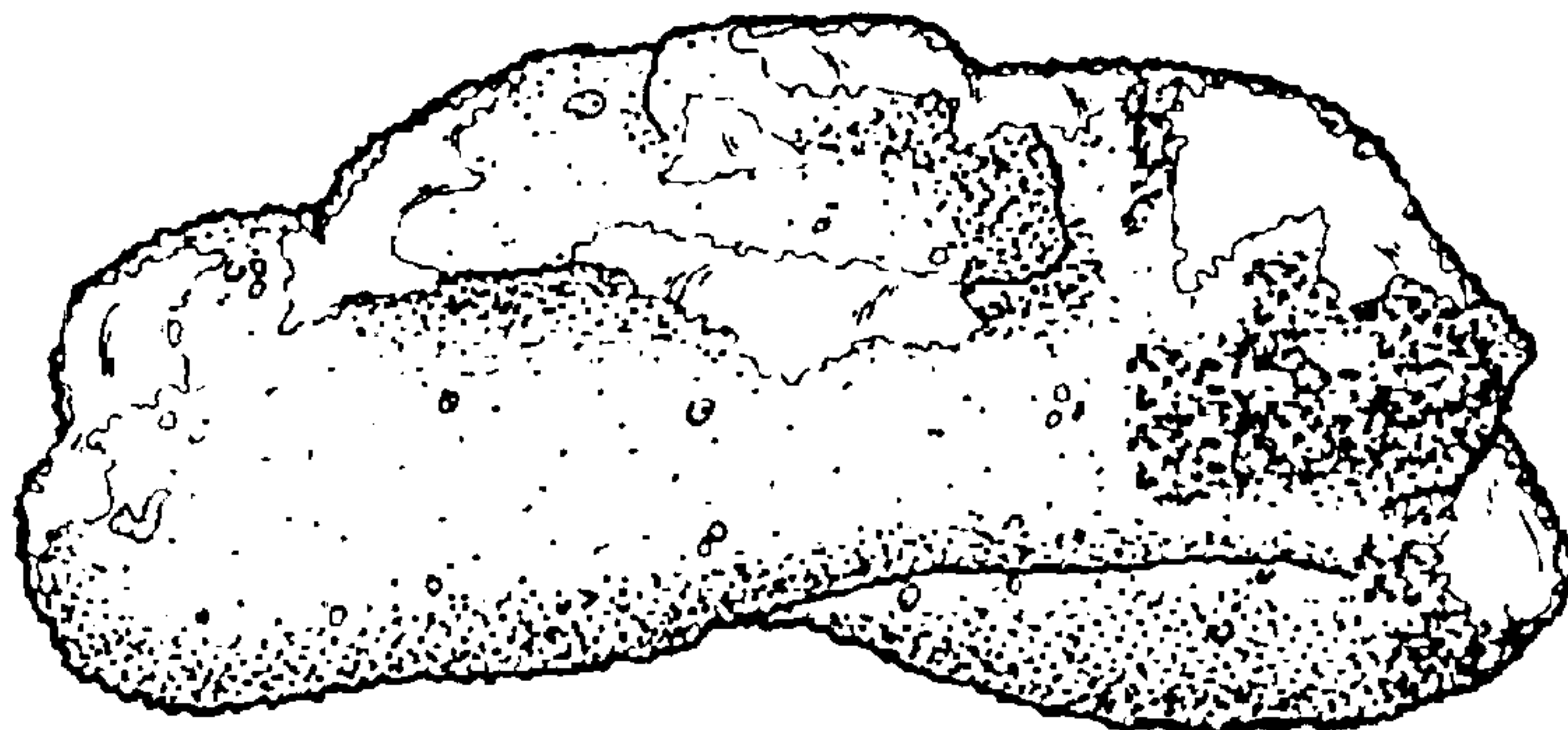
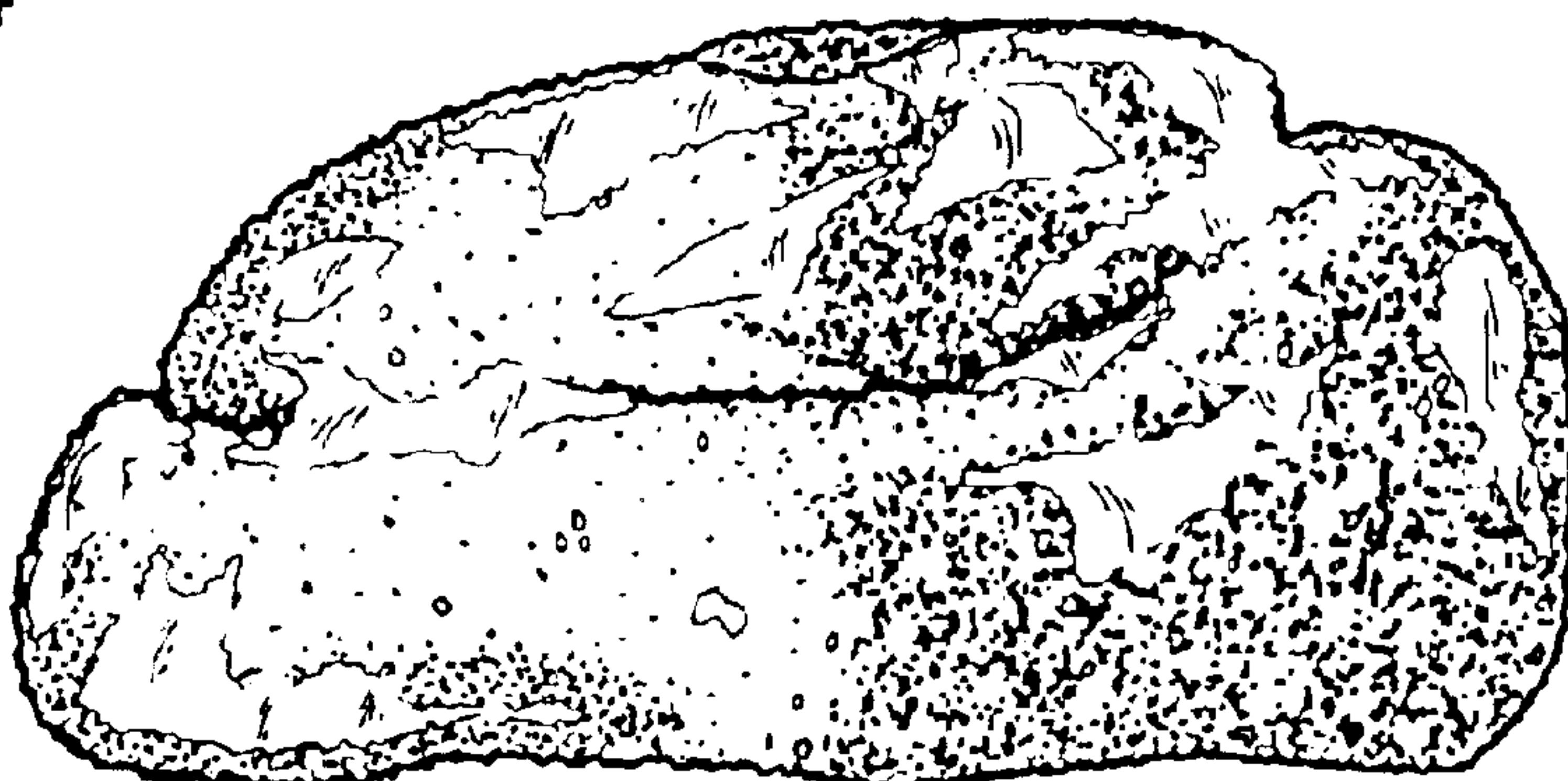

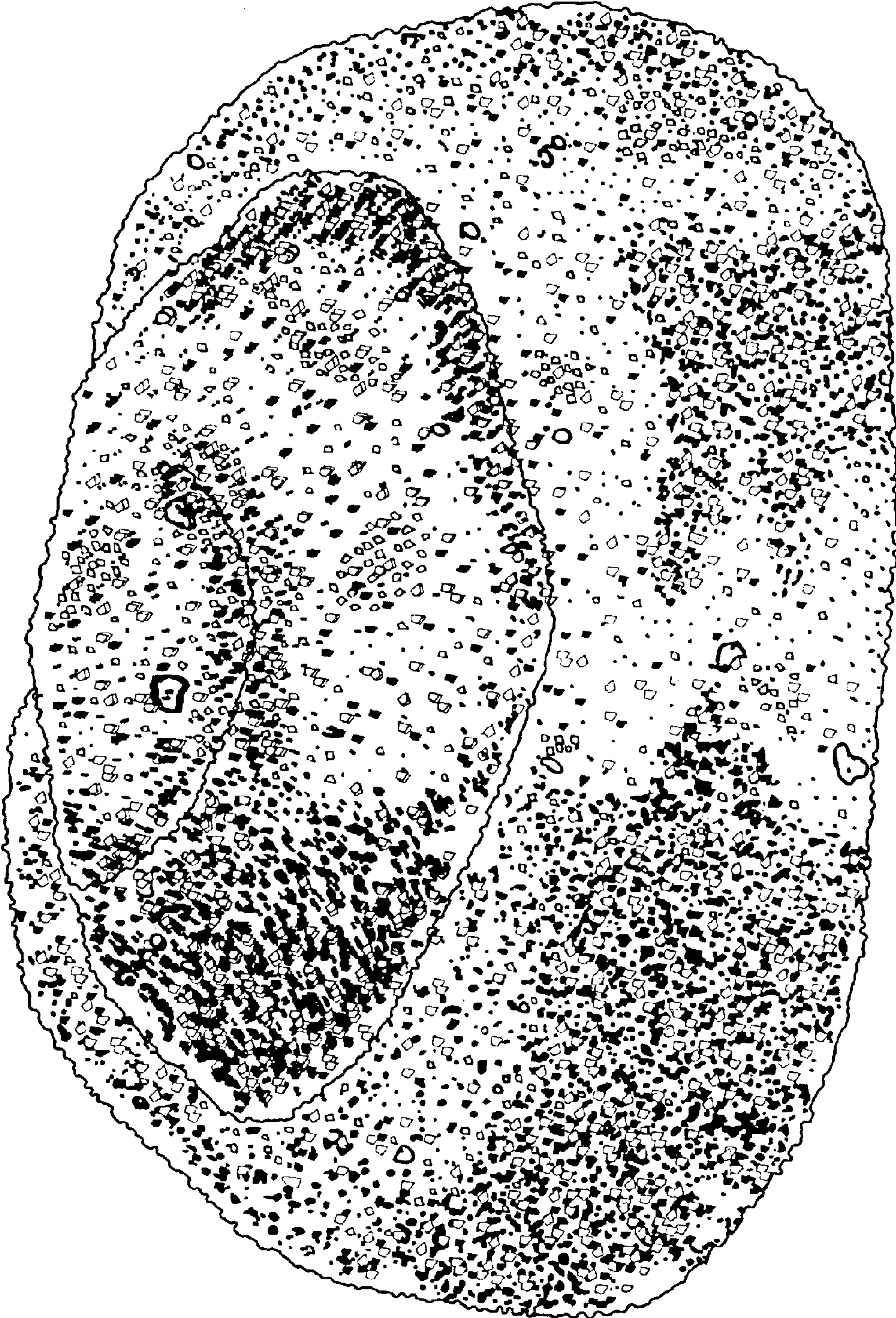

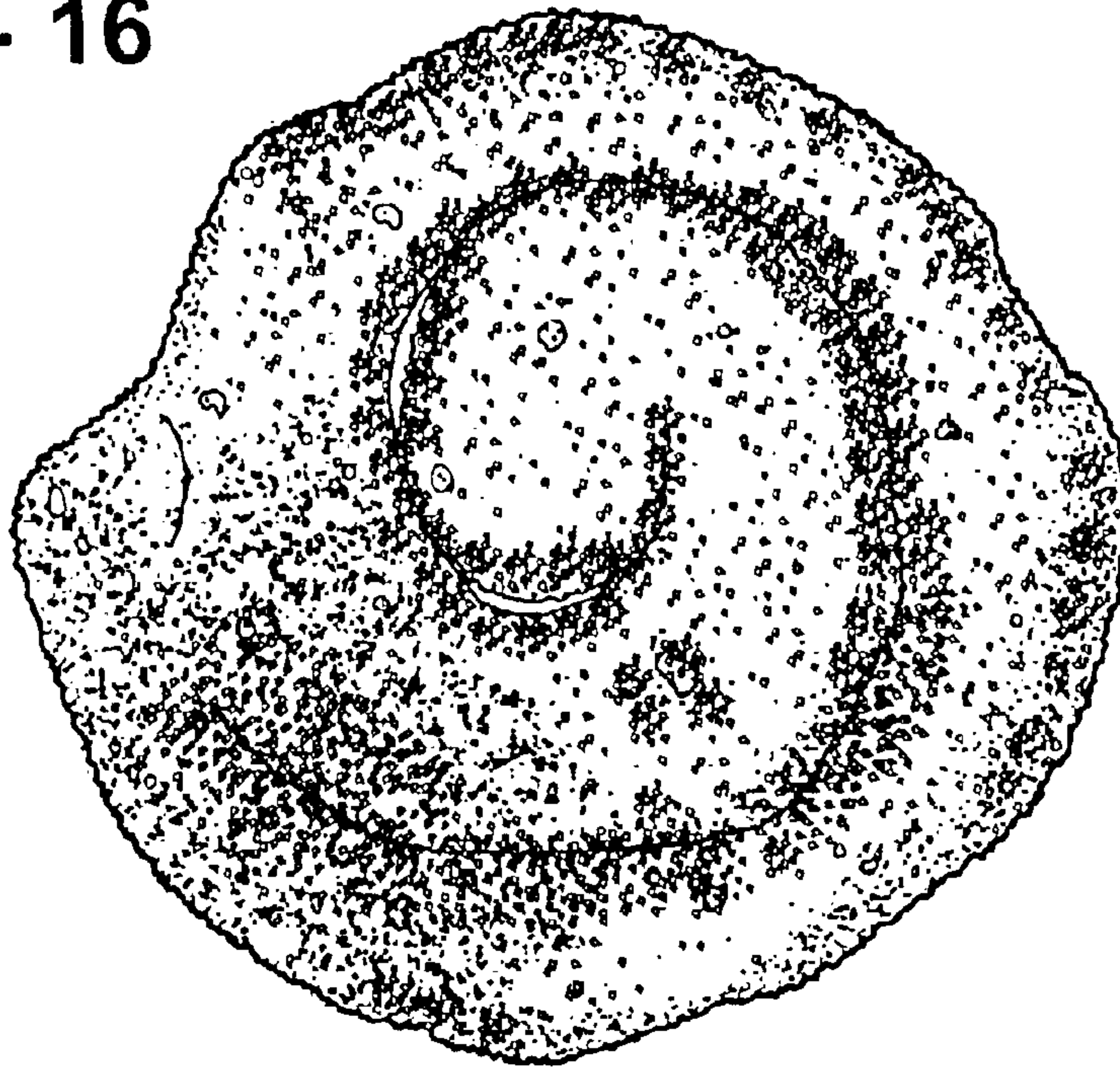

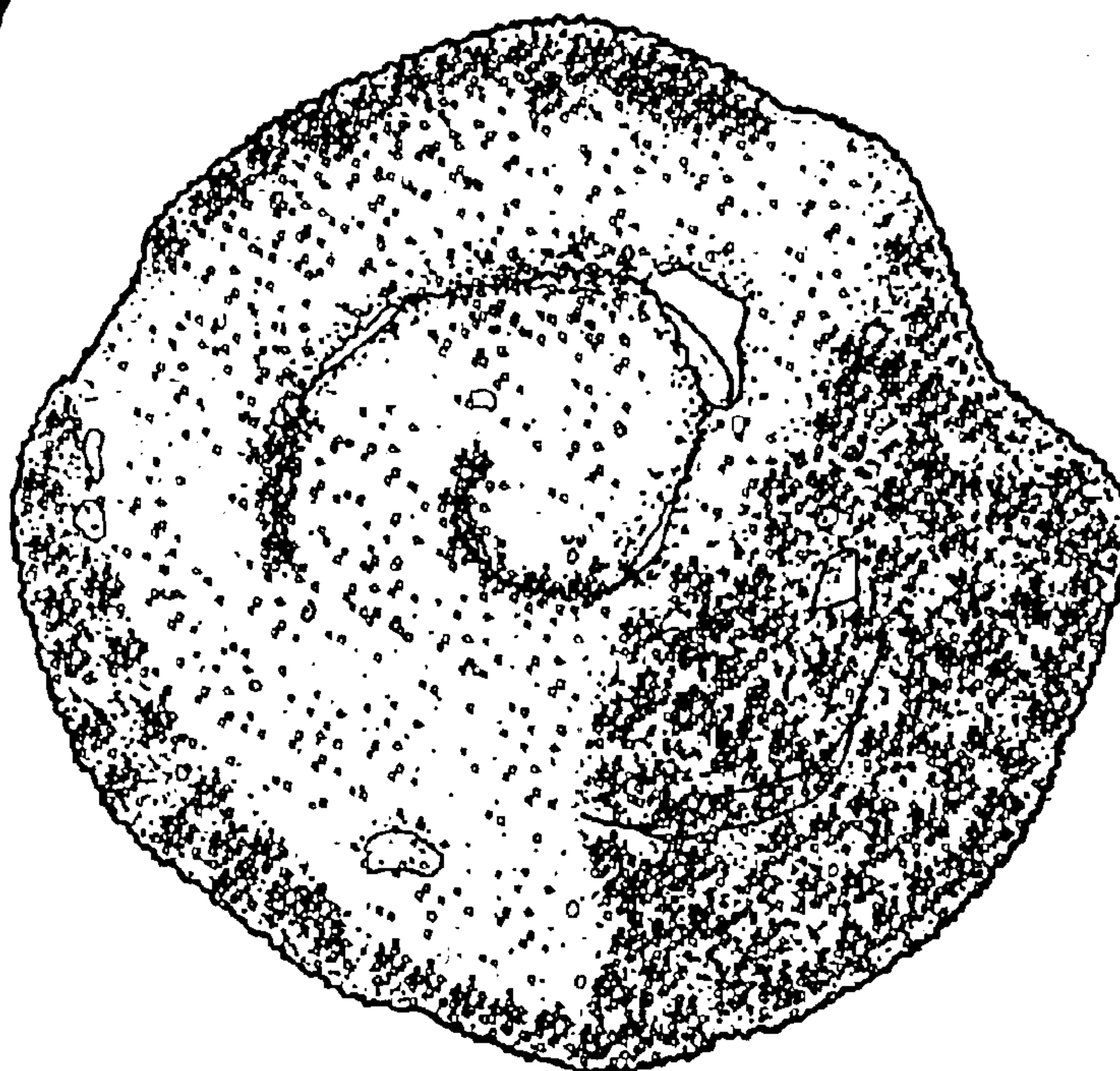

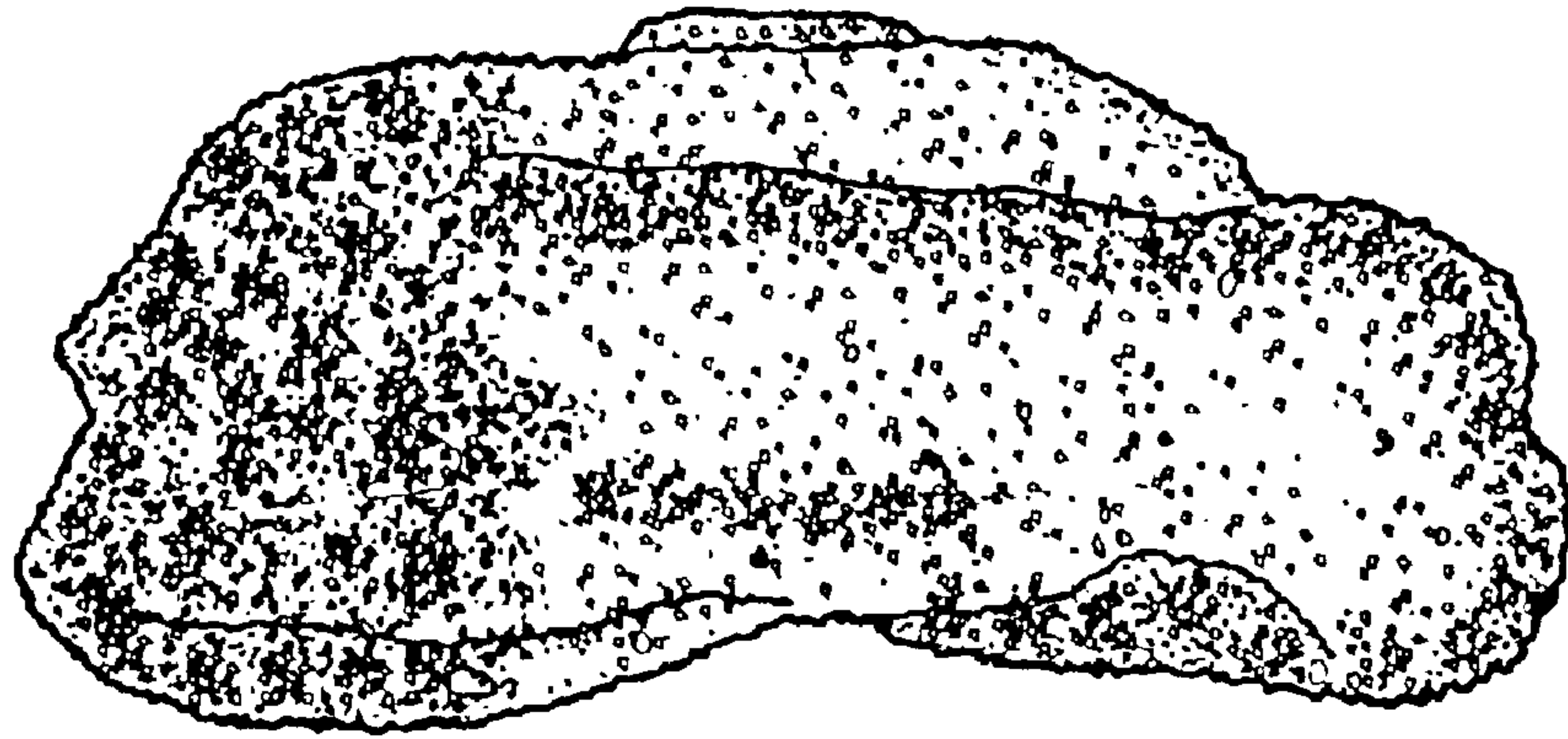

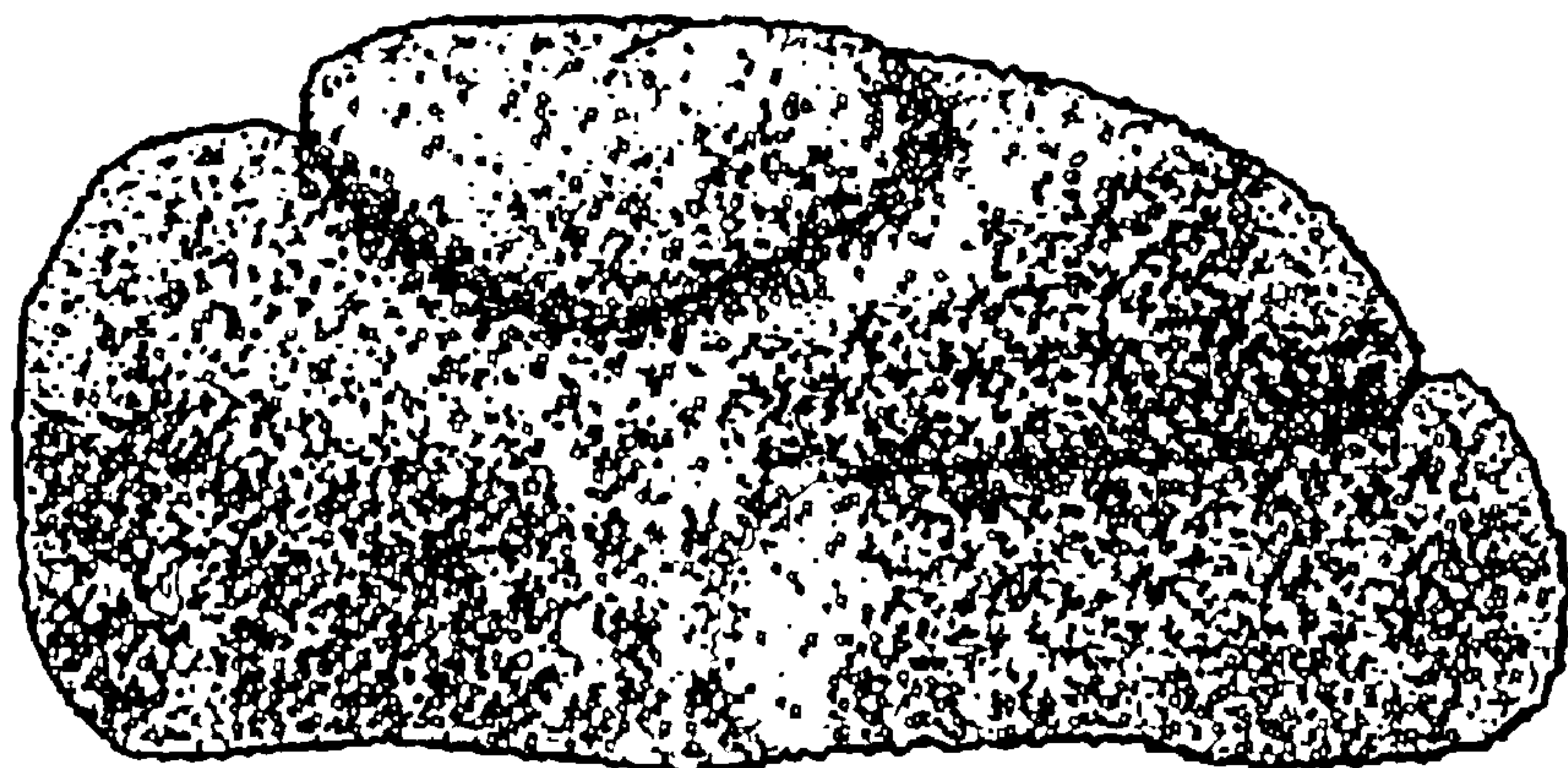

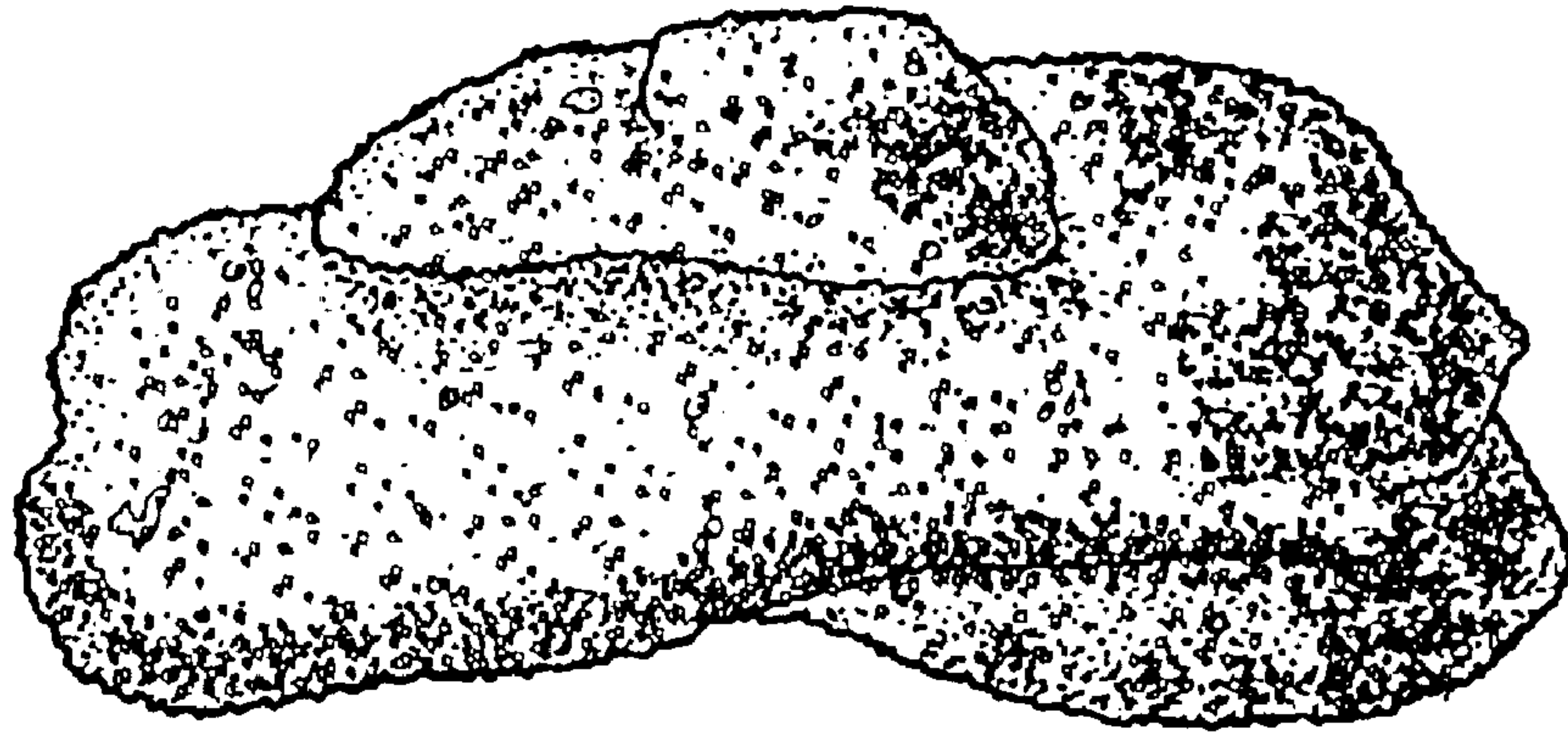
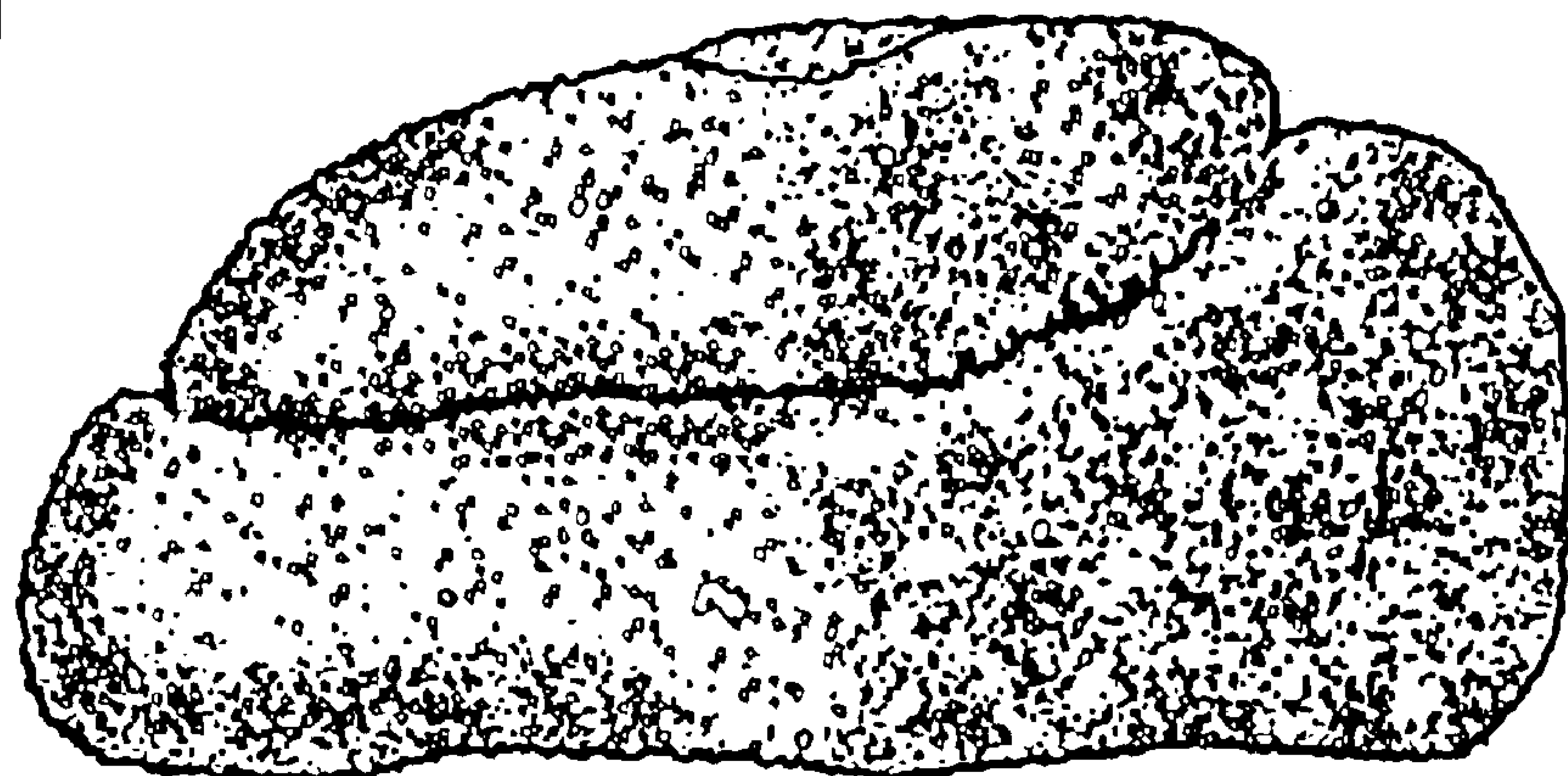
