(57) **CLAIM**

The ornamental design for a circular handbag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a handbag having a circular base;

FIG. 2 is a front elevation view of a first embodiment of the circular handbag, the rear view being a mirror image;

FIG. 3 is a right side elevation view of a first embodiment of the circular handbag, the left side being a mirror image;

FIG. 4 is a top view of a first embodiment of the circular handbag;

FIG. 5 is a bottom view of a first embodiment of the circular handbag;

FIG. 6 is a perspective view of a first embodiment of the circular handbag in a first closed position;

FIG. 7 is a perspective view of a first embodiment of the circular handbag in a second closed position;

FIG. 8 is a perspective view of a second embodiment of the circular handbag in an open position;

FIG. 9 is a perspective view of a second embodiment of the circular handbag in a first closed position;

FIG. 10 is a perspective view of a second embodiment of the circular handbag in a second closed position;

FIG. 11 is a perspective view of a third embodiment of the circular handbag in an open position;

FIG. 12 is a perspective view of a third embodiment of the circular handbag in a first closed position;

FIG. 13 is a perspective view of a third embodiment of the circular handbag in a second closed position;

FIG. 14 is a perspective view of a fourth embodiment of the circular handbag in an open position;

FIG. 15 is a perspective view of a fourth embodiment of the circular handbag in a first closed position;

FIG. 16 is a perspective view of a fourth embodiment of the circular handbag in a second closed position;

FIG. 17 is a perspective view of a fifth embodiment of the circular handbag in an open position;

FIG. 18 is a perspective view of a fifth embodiment of the circular handbag in a first closed position;


FIG. 19 is a perspective view of a fifth embodiment of the circular handbag in a second closed position;










































