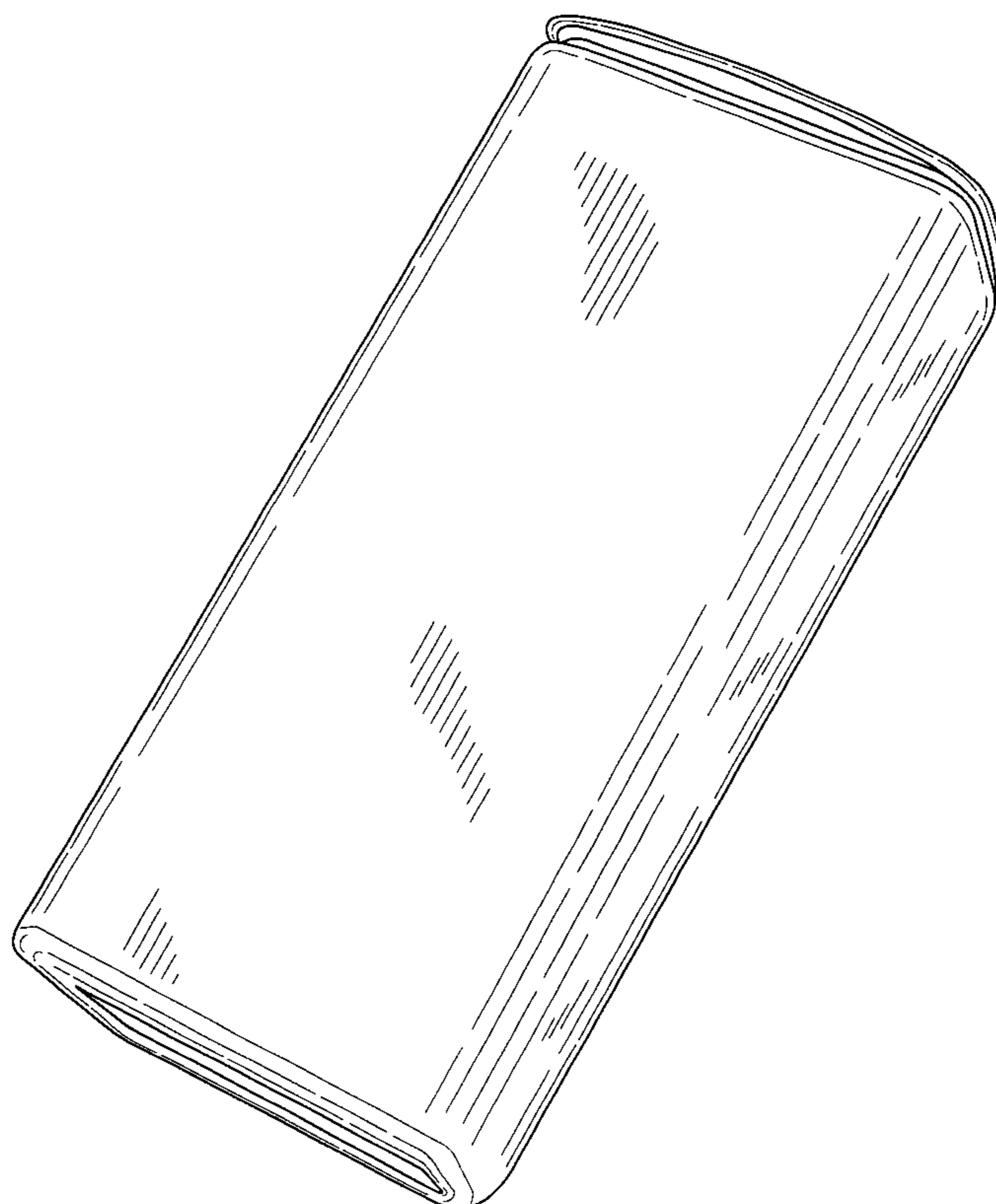
(57) **CLAIM**

I claim the ornamental design for a hinged lid container, as shown in the accompanying figures.

DESCRIPTION

FIG. 1 is a perspective view of the container of the present invention, with the container lid in its closed position; FIG. 2 is a front elevation view of the container of the present invention, as depicted in FIG. 1; FIG. 3 is a rear elevation view of the container of the present invention, as depicted in FIG. 1; FIGS. 4 and 5 are, respectively, right and left side elevation views of the container of the present invention, as depicted in FIG. 1; FIG. 6 is a bottom plan view of the container of the present invention, as depicted in FIG. 1; FIG. 7 is a top plan view of the container of the present invention, as depicted in FIG. 1; FIG. 8 is a right side elevation views of the container of the present invention in which the container lid is in its open position; FIG. 9 is a top plan view of the container of the present invention, as depicted in FIG. 8; and, FIG. 10 is a perspective view of the hinged lid container with the lid in an open position.

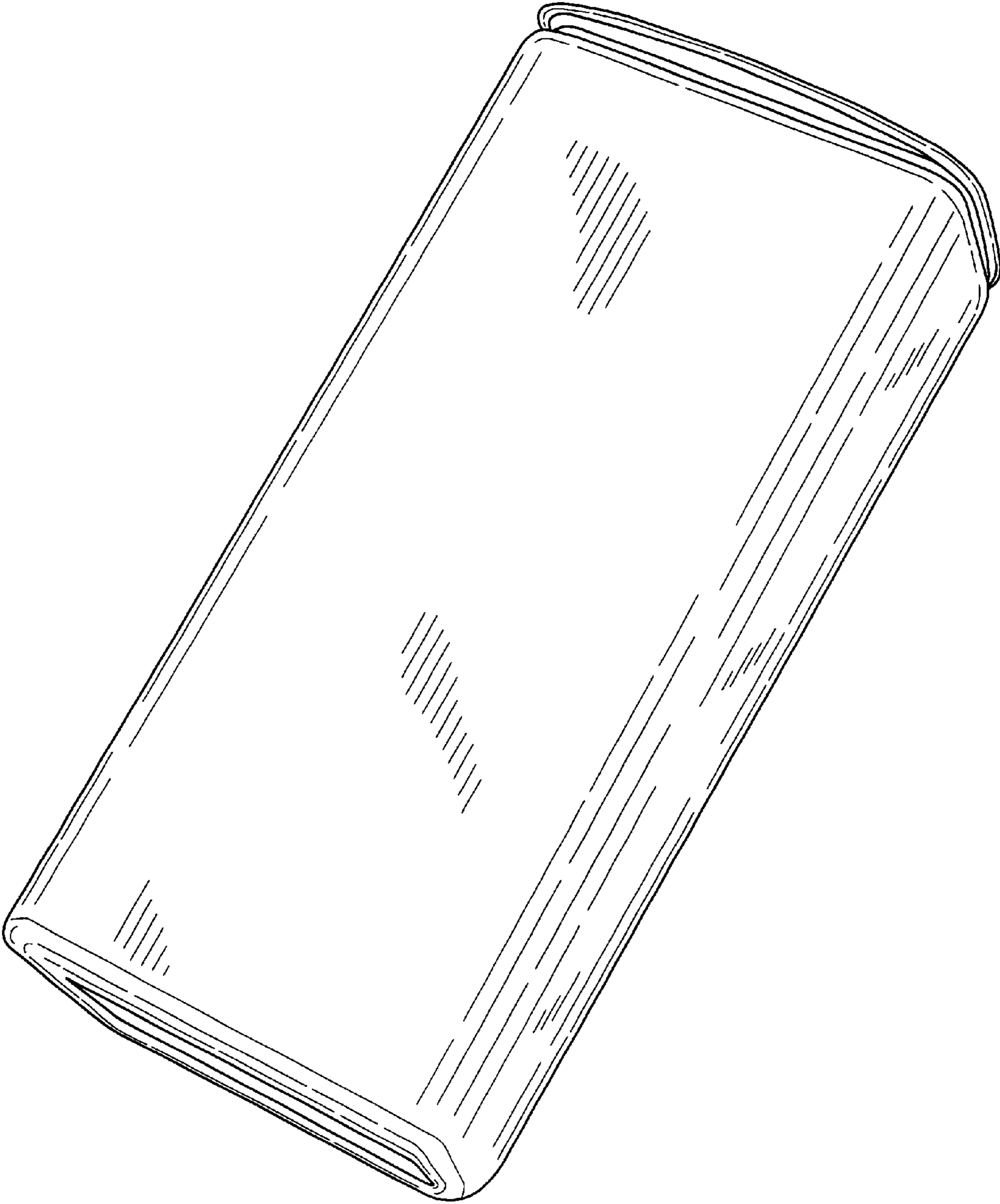

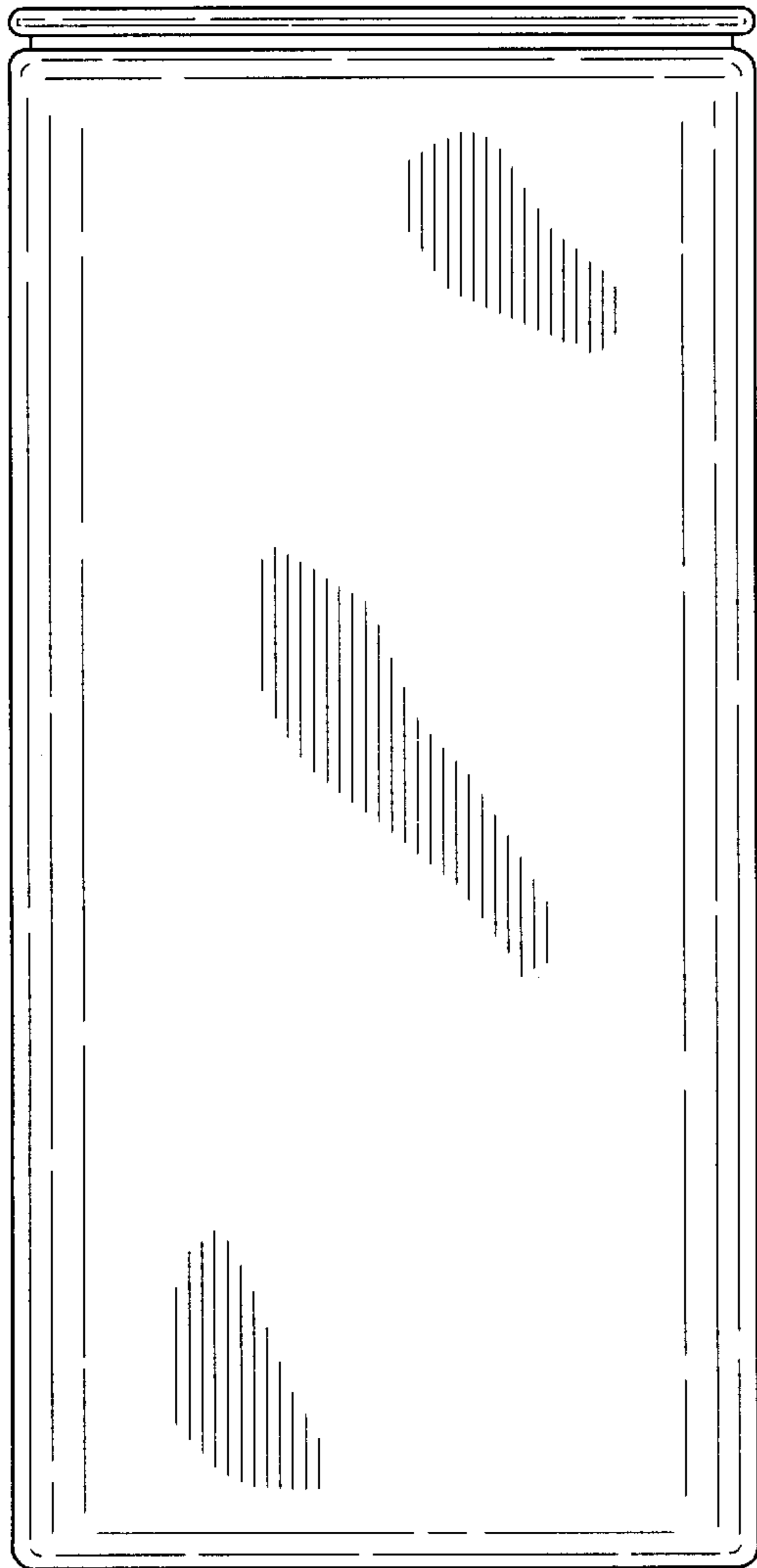

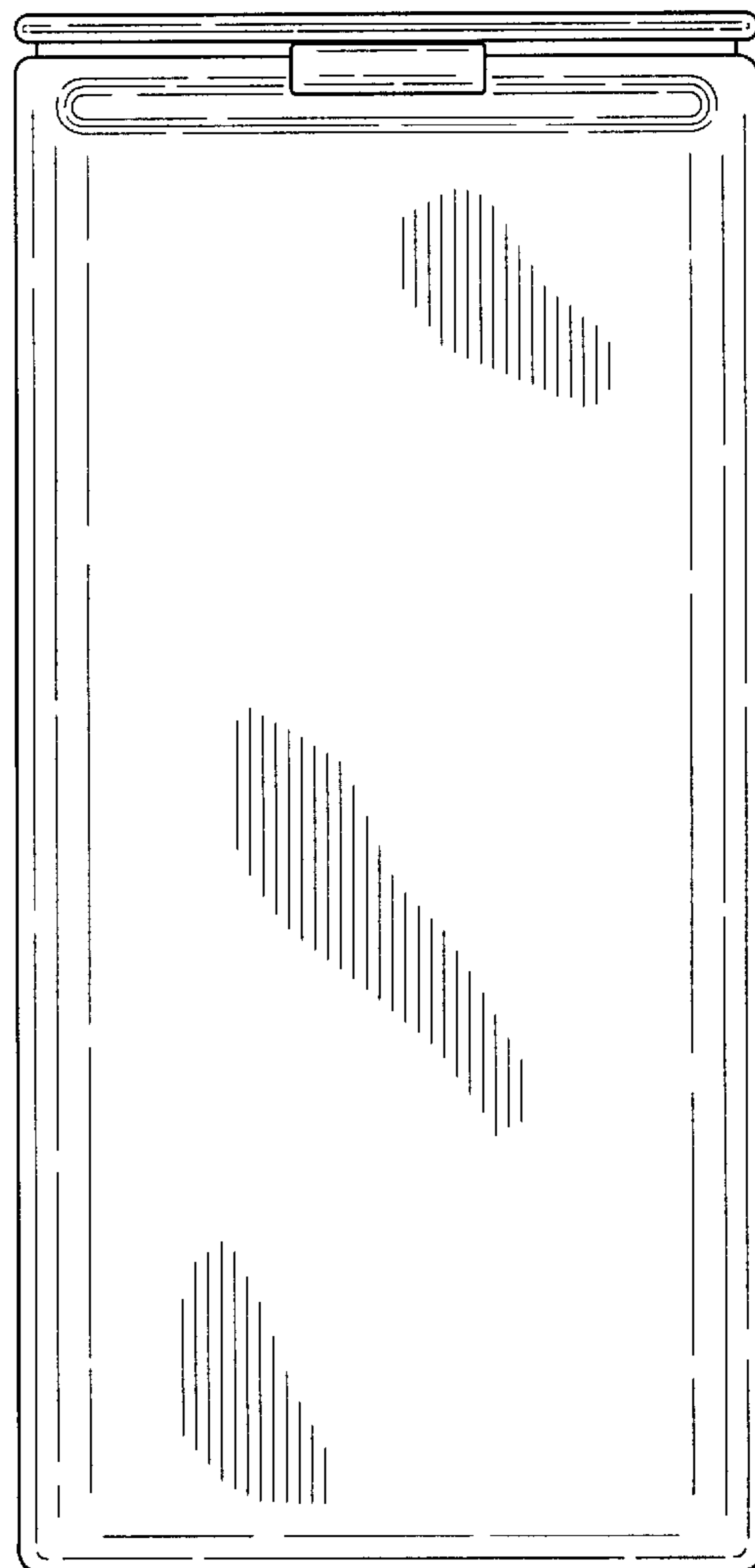

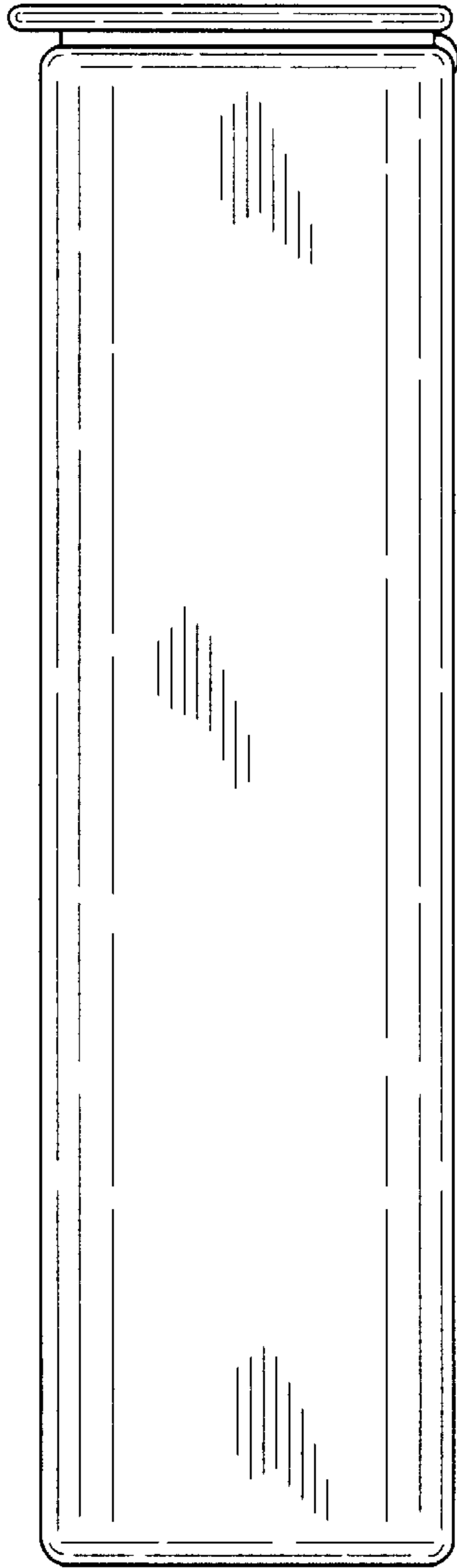

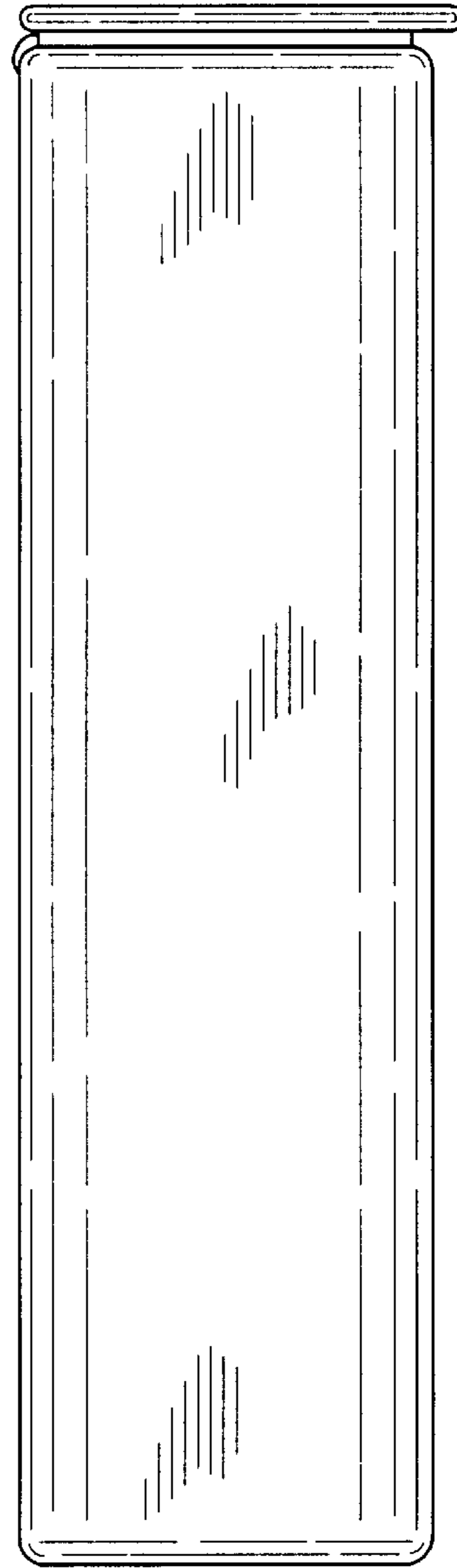

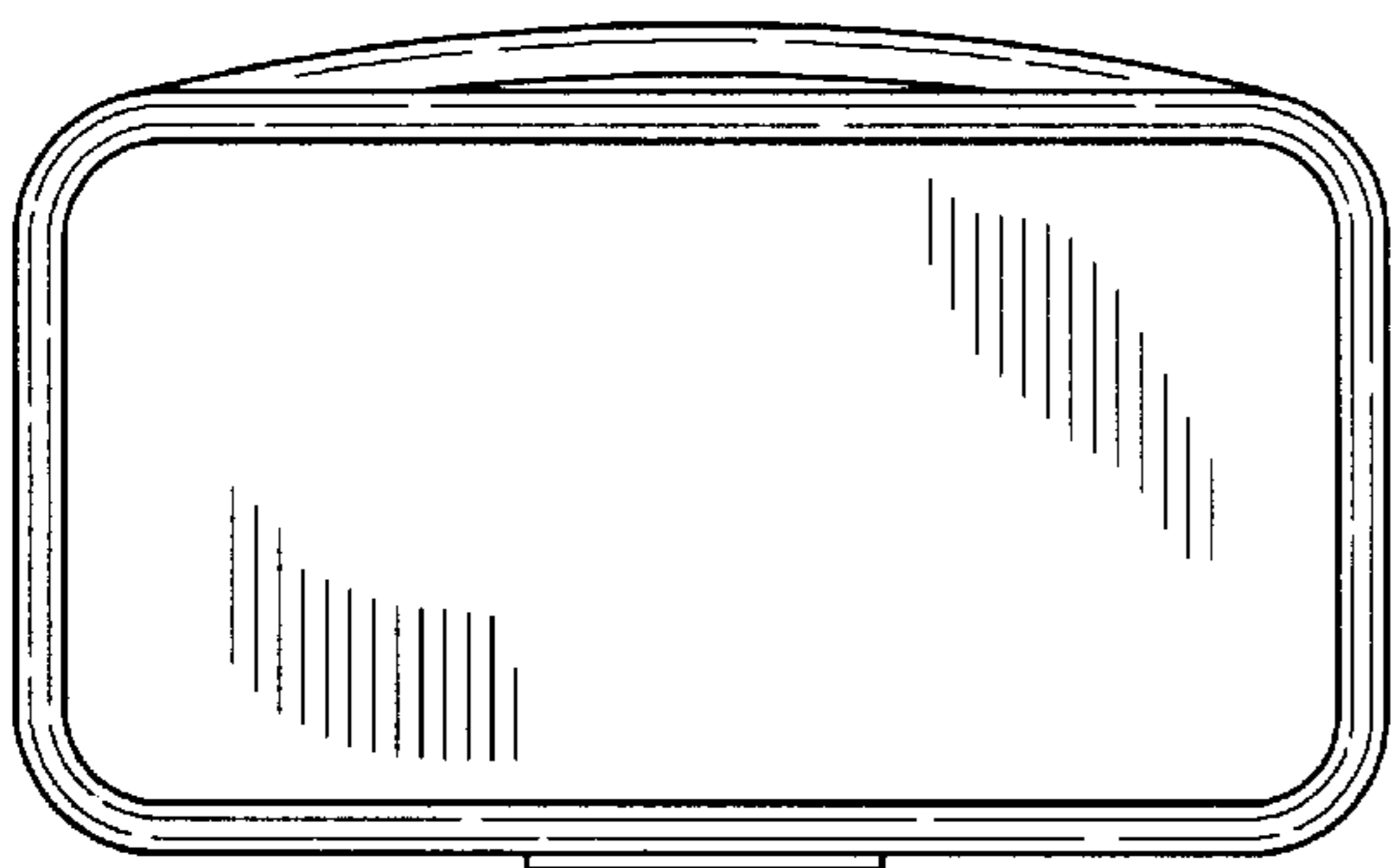

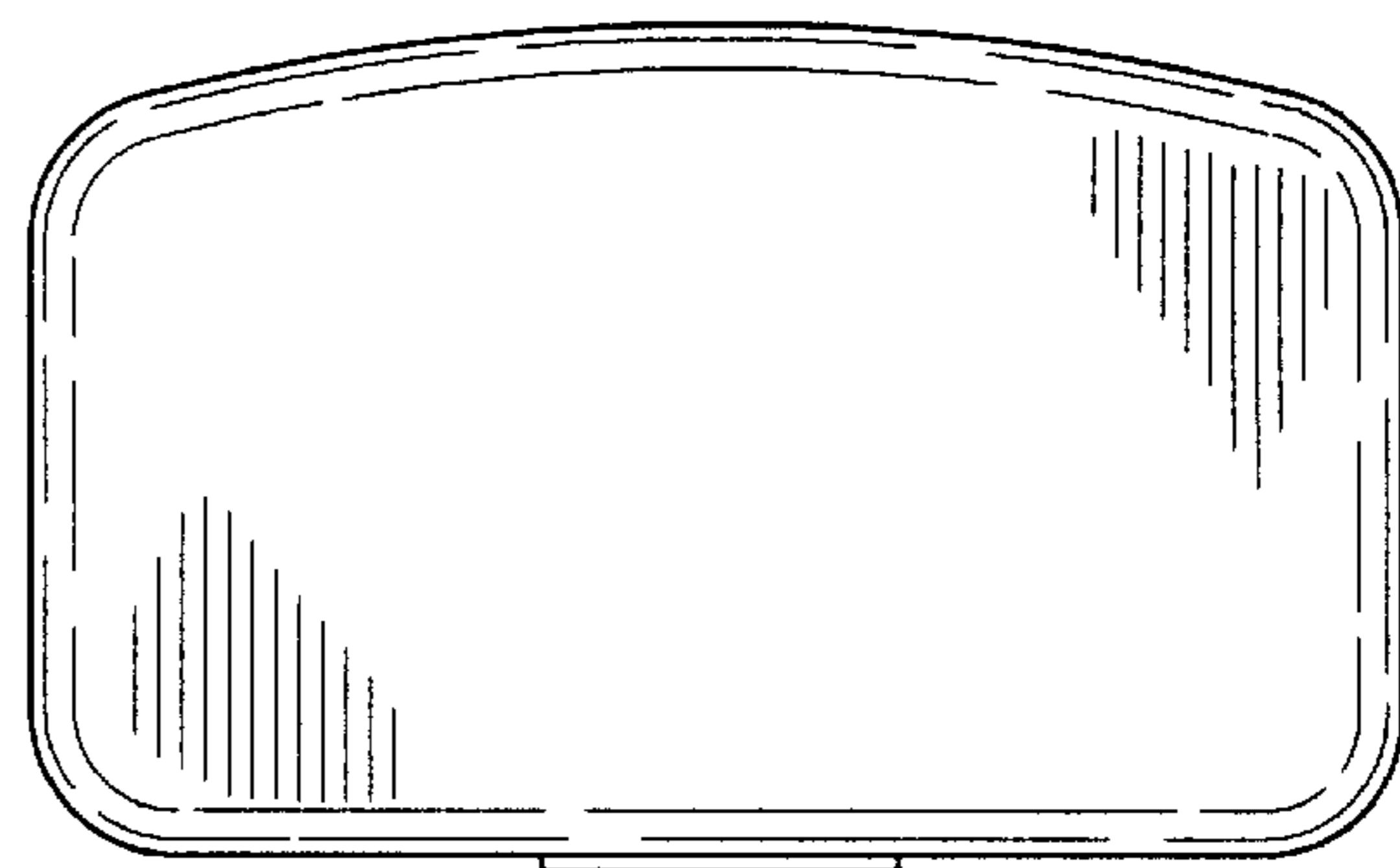

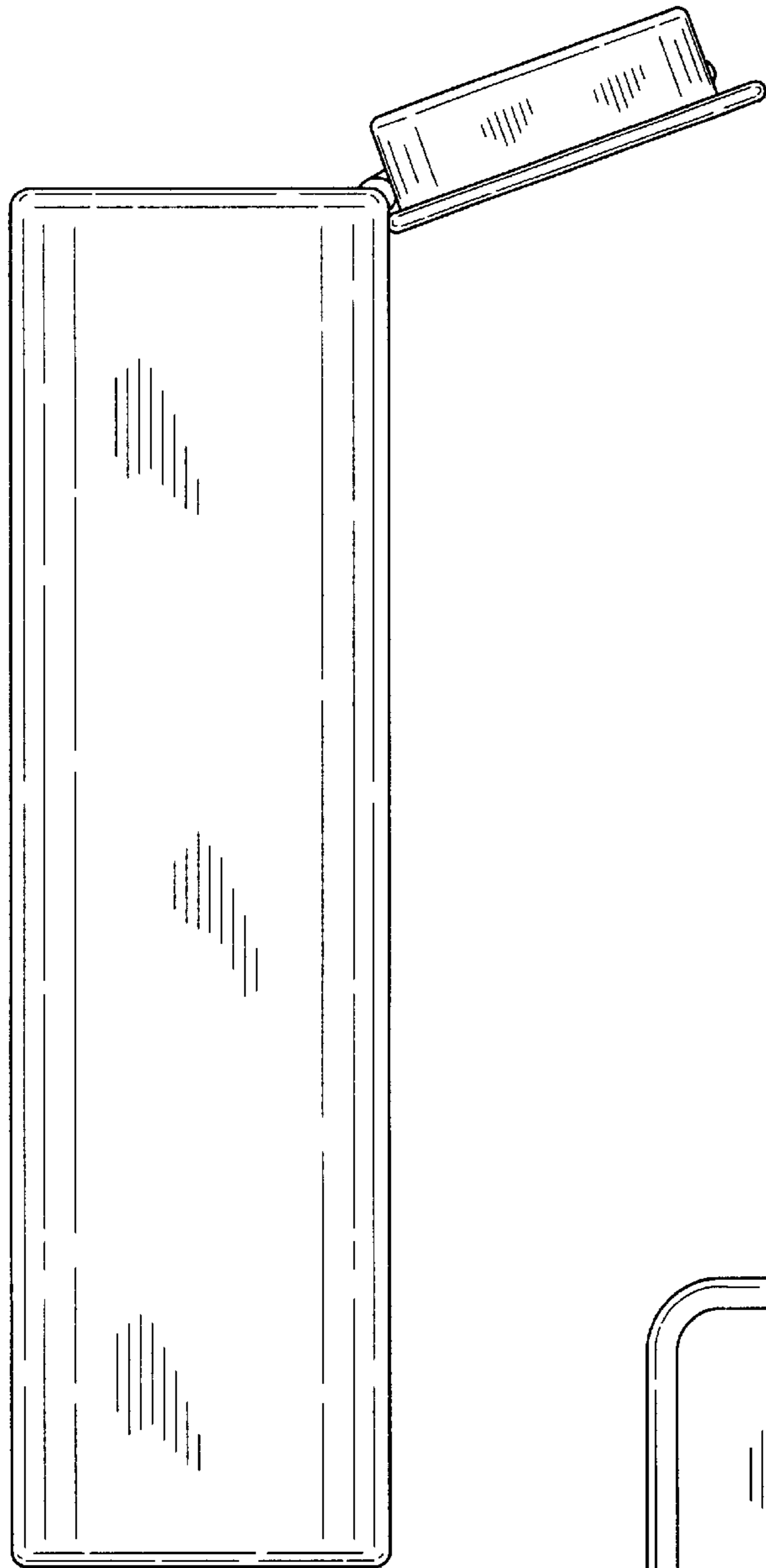

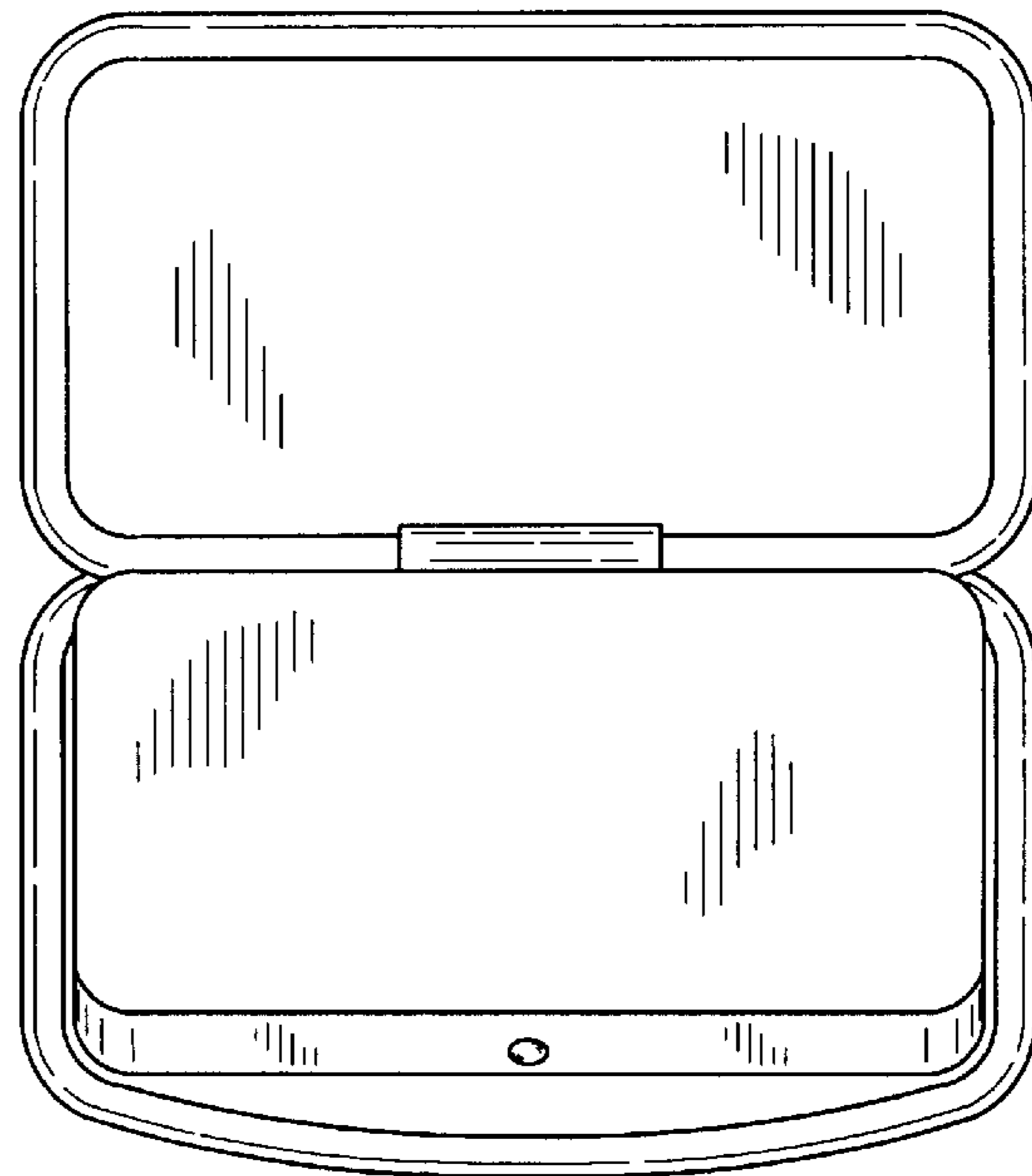

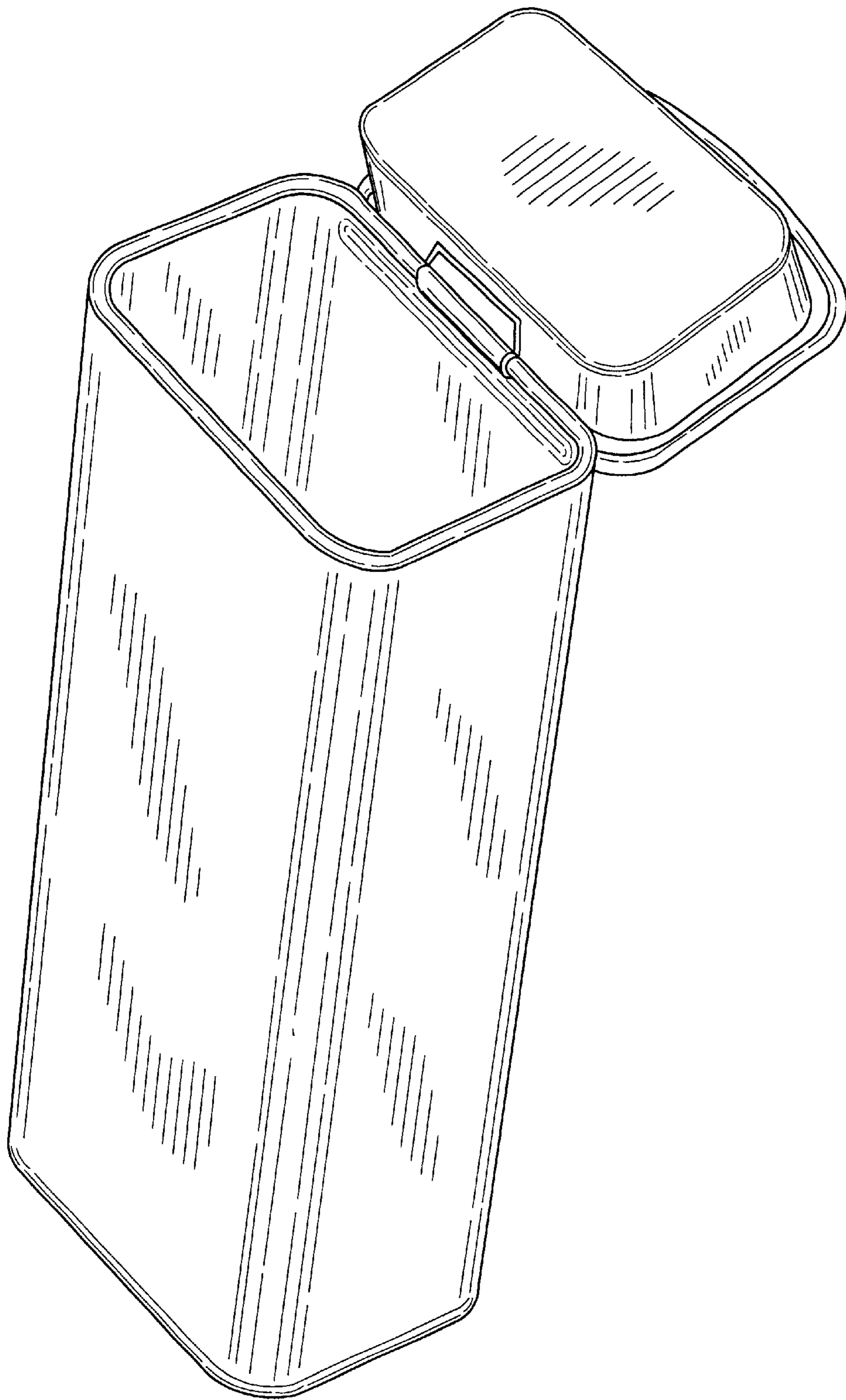
