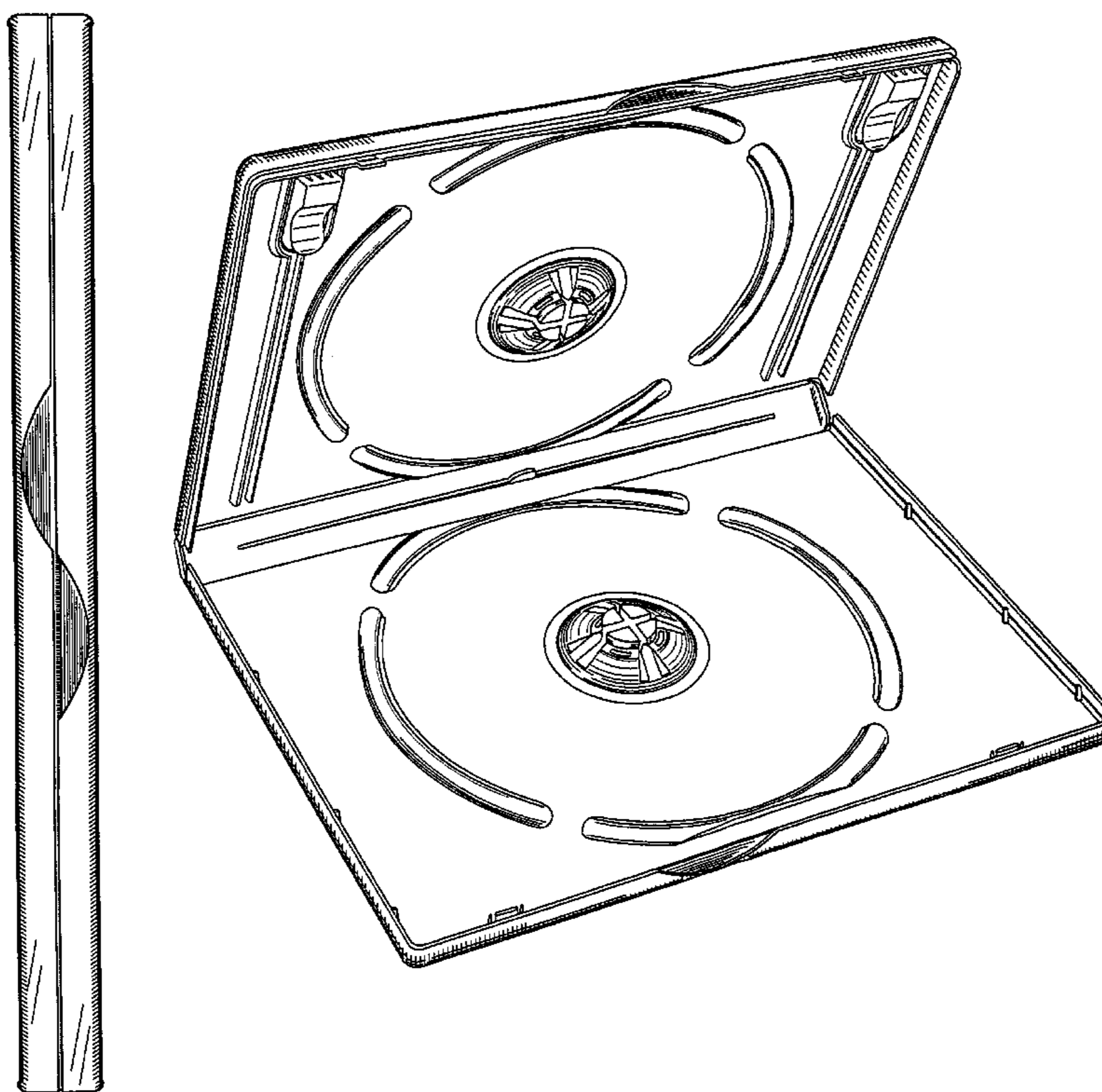
(57) **CLAIM**

I claim the ornamental design for a DVD holder, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the DVD holder showing my new design;

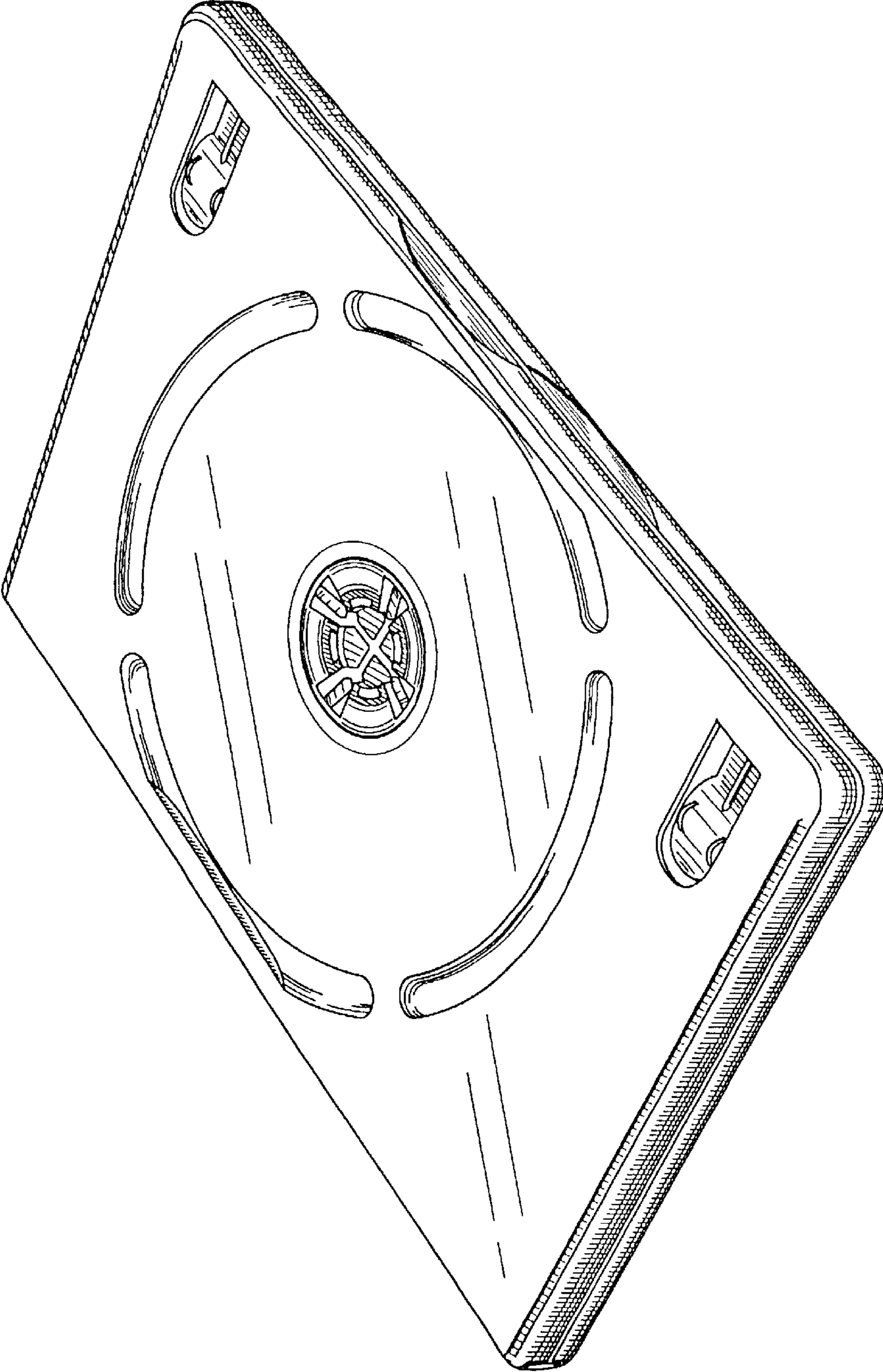

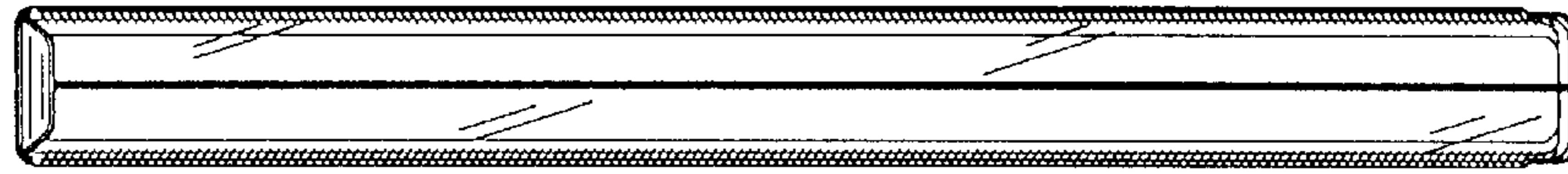
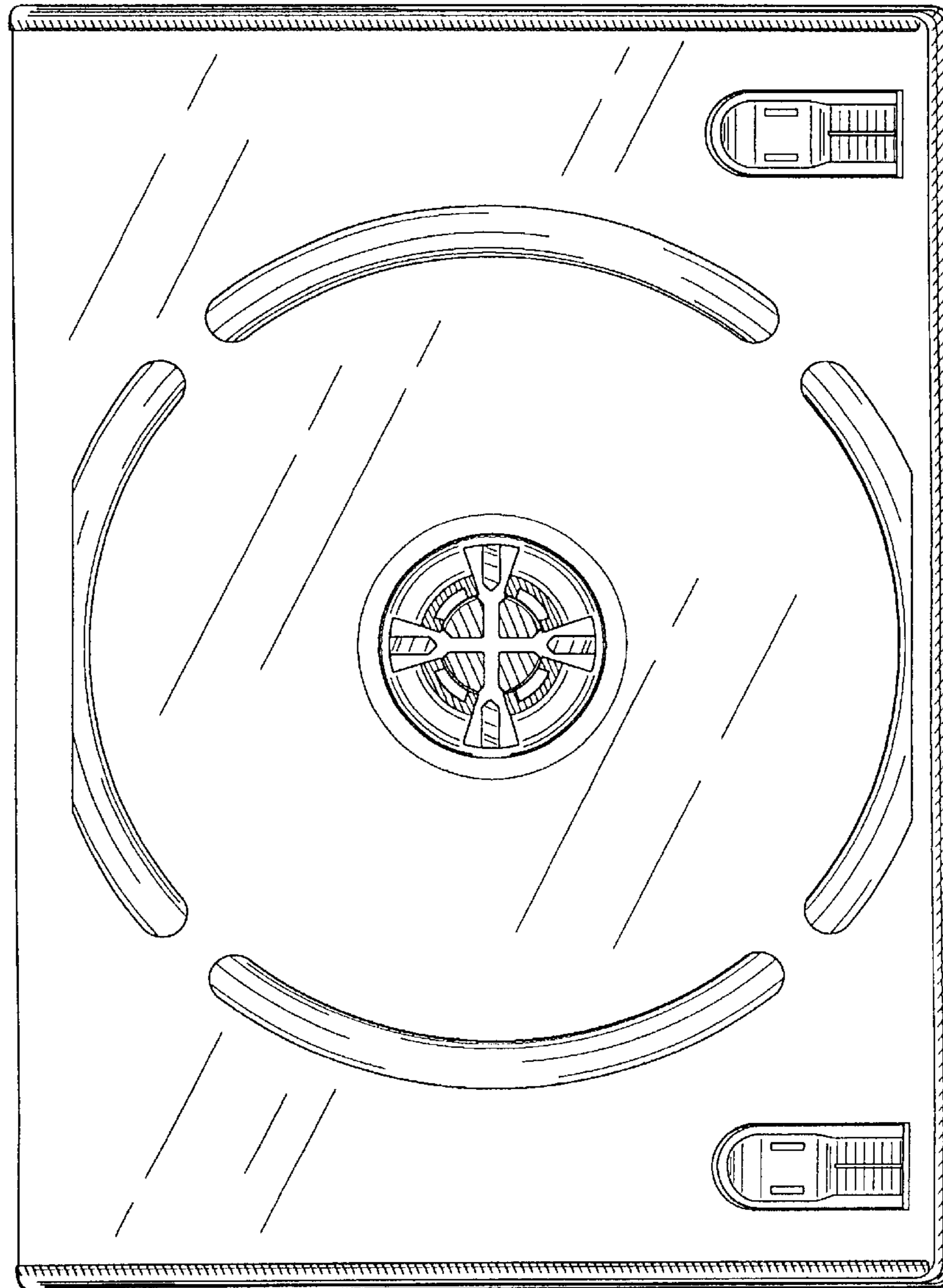

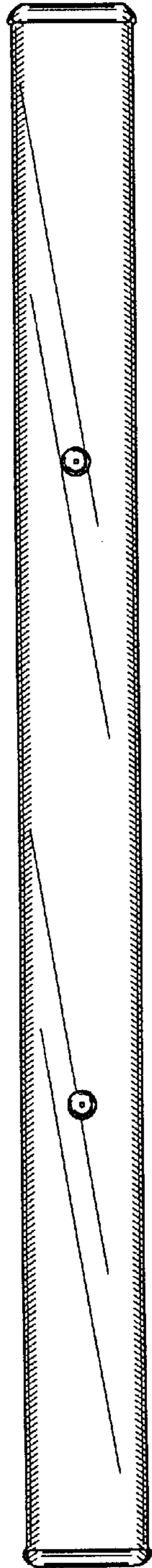

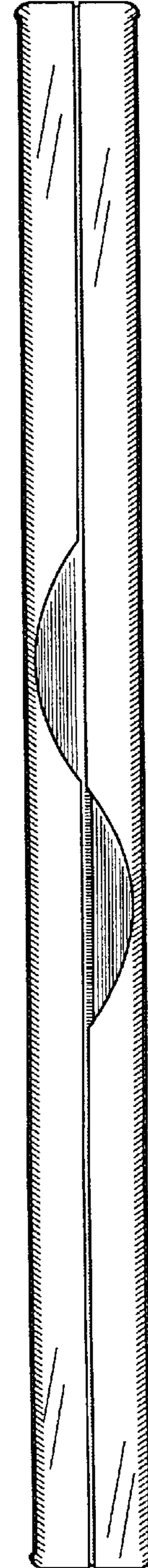

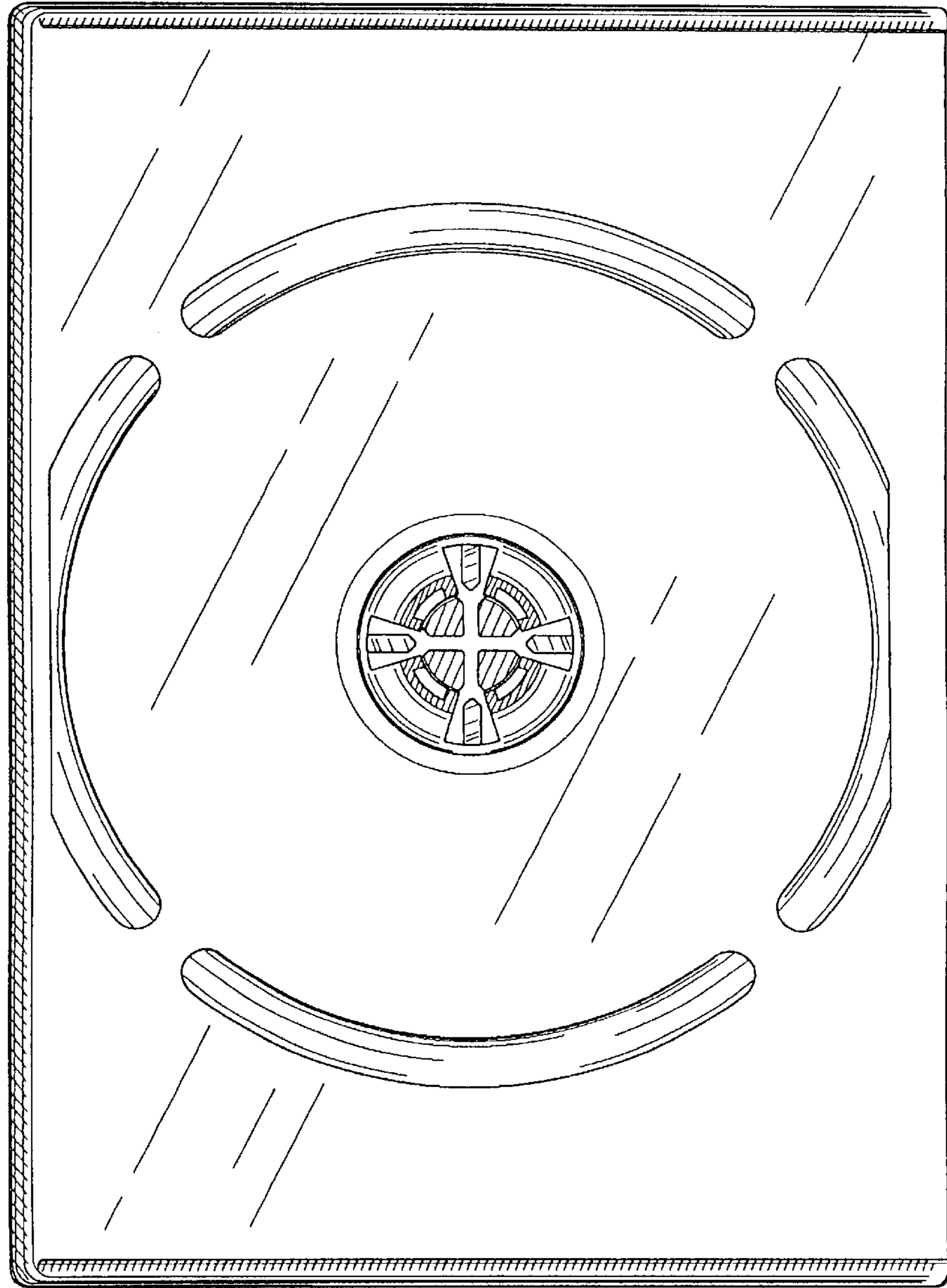

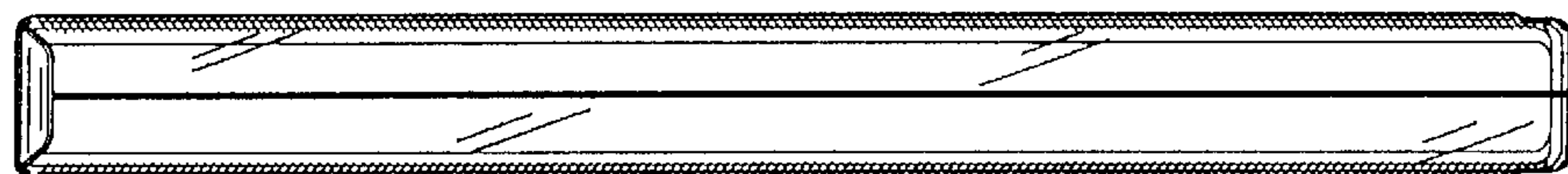

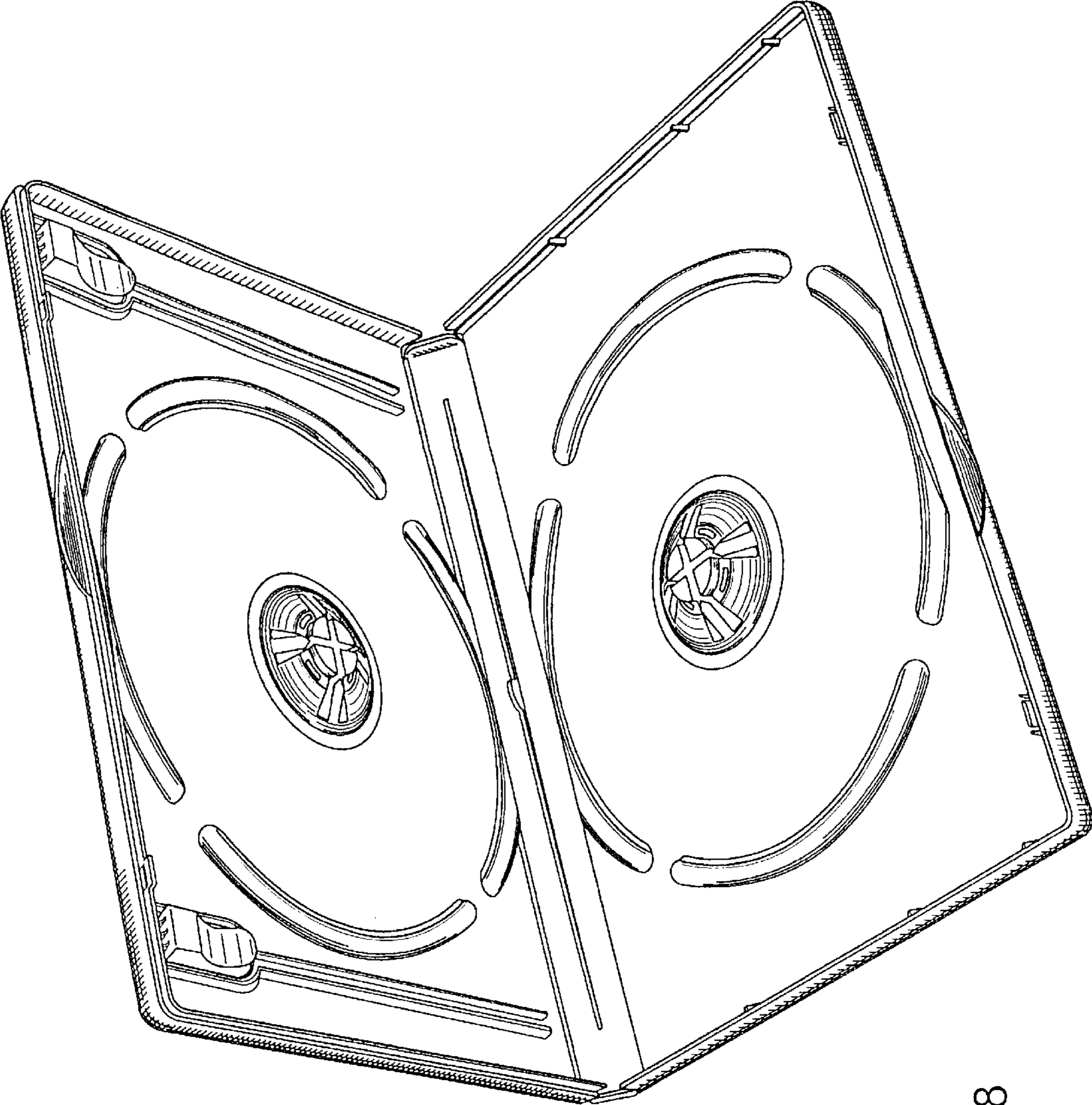
