(57) **CLAIM**

The ornamental design for a food serving utensil, as shown and described.

DESCRIPTION

FIG. 1 illustrates a perspective view of a bowl employing the ornamental design in accordance with the invention; FIG. 2 illustrates a side elevation view of the bowl of FIG. 1 (each side being the same as that shown); FIG. 3 illustrates a top view of the bowl of FIG. 1; and, FIG. 4 illustrates a bottom view of the bowl of FIG. 1.

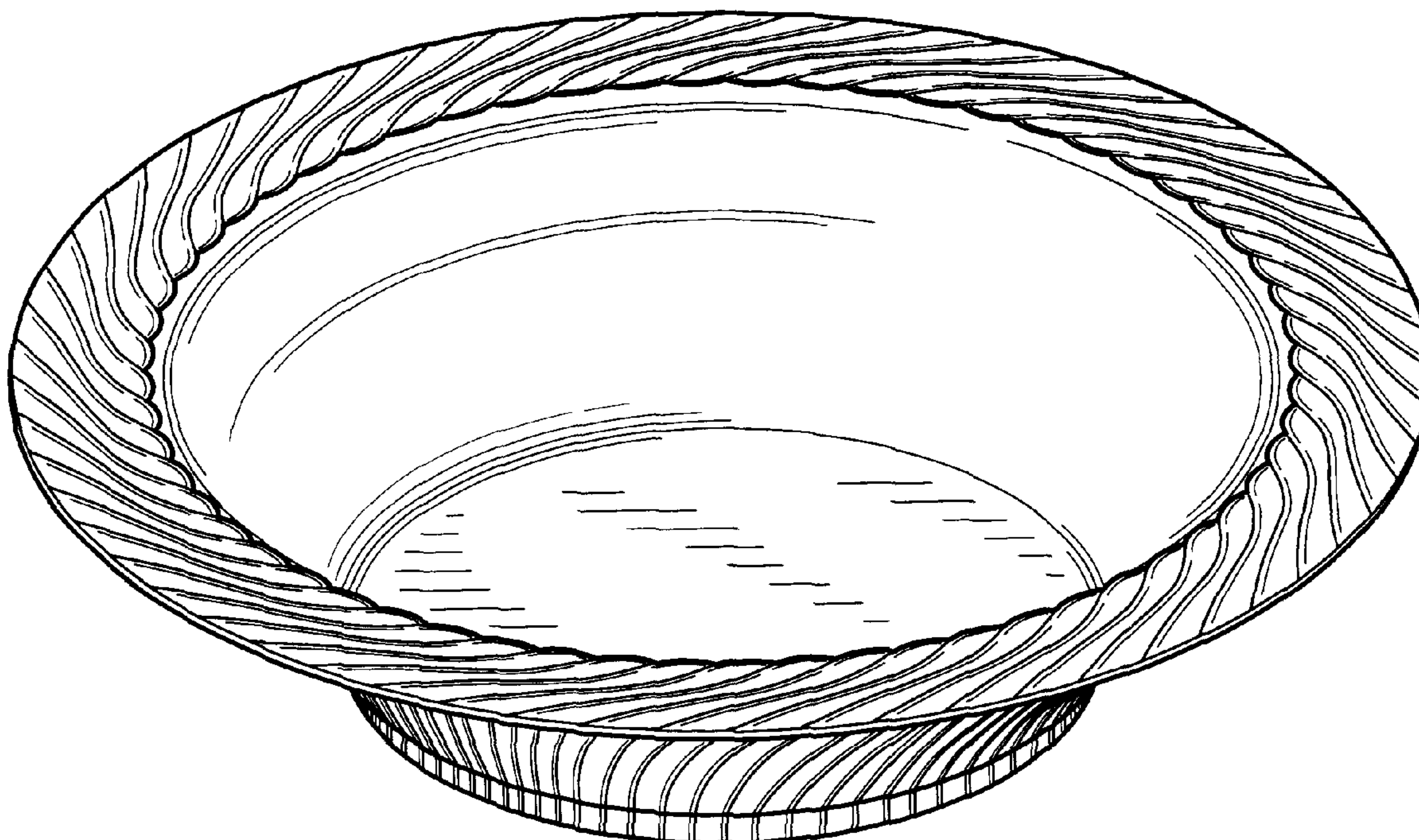

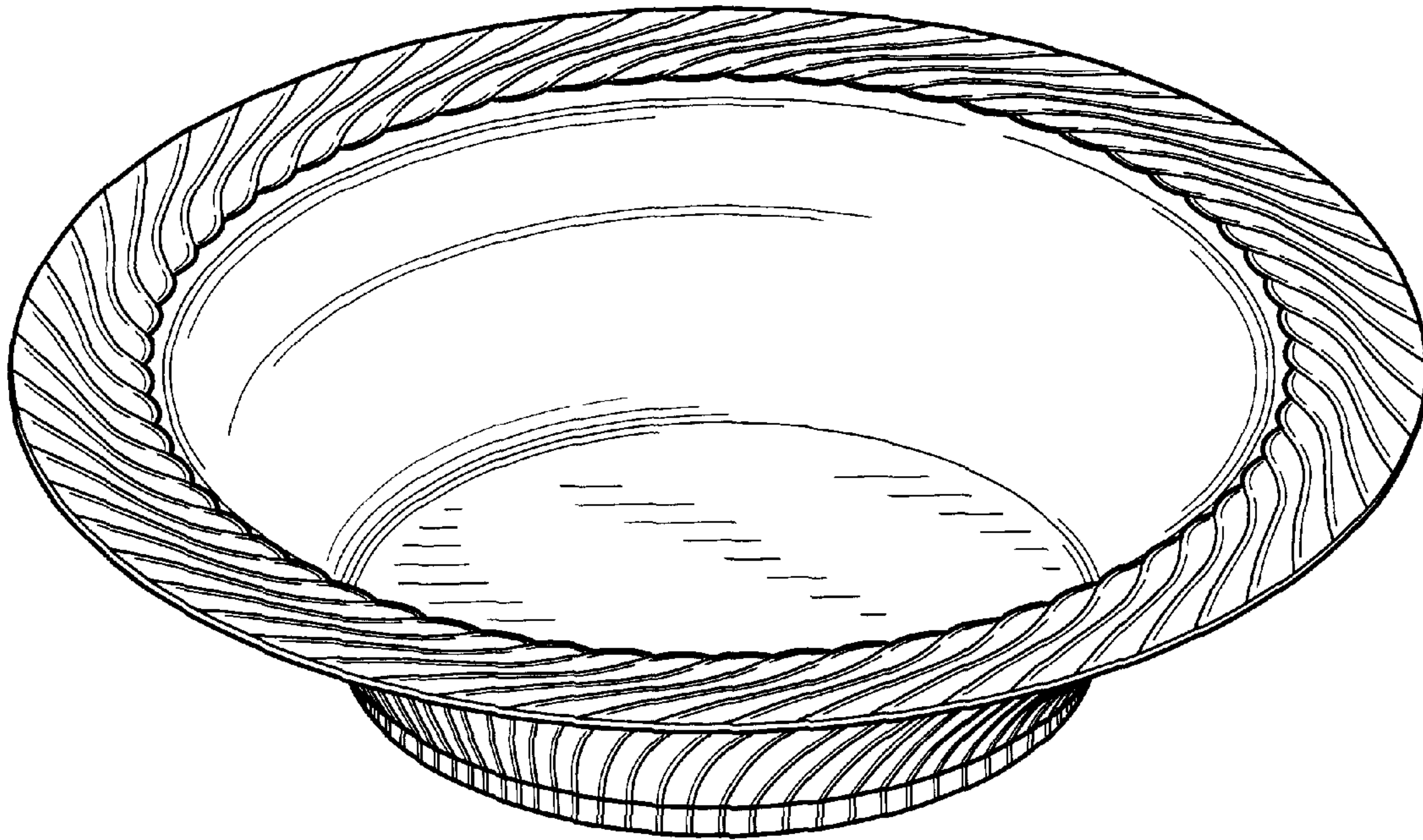
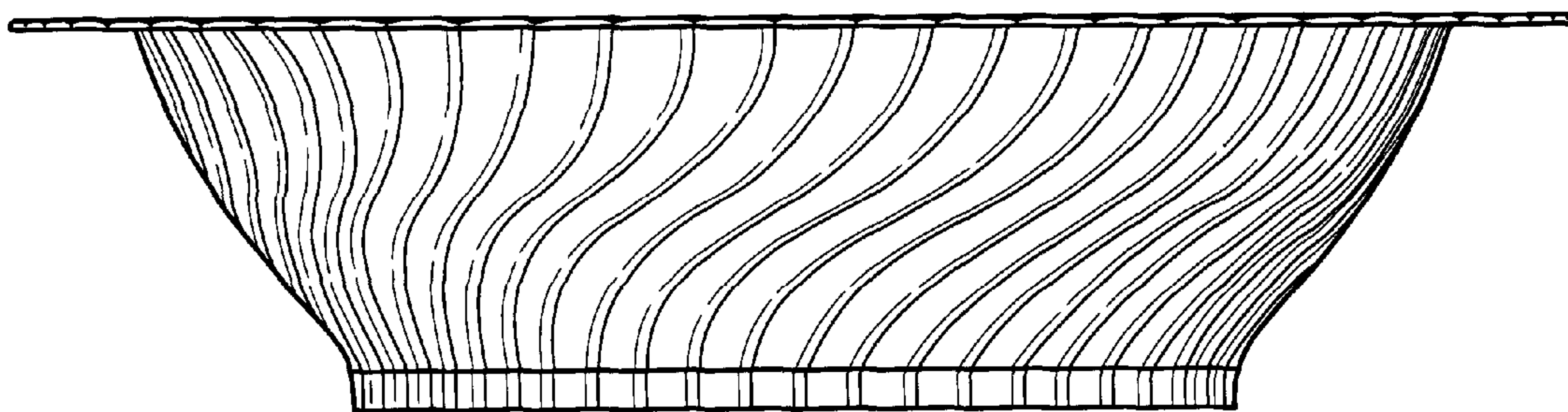

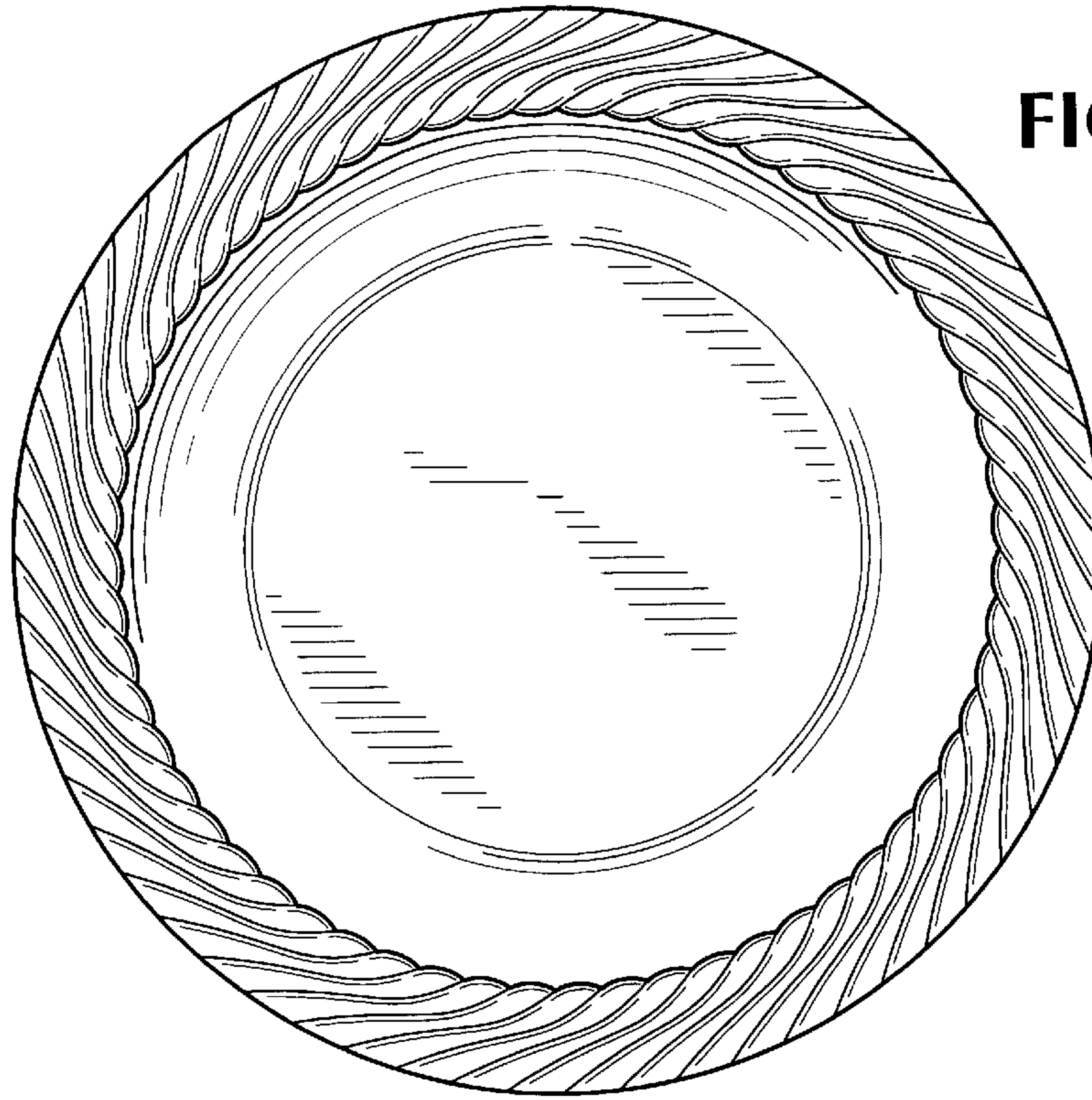
