(57) **CLAIM**

The ornamental design for a cosmetic applicator, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation of the cosmetic applicator of the invention depicted as affixed to a receptacle as illustrated in the portion of the figure depicted with broken lines, the receptacle not forming part of the invention.

FIG. 2 is a side view of the cosmetic applicator of the invention, depicted as affixed to a receptacle in the portion of the figure depicted with broken lines, the receptacle not forming part of the invention.

FIG. 3 is a top plan view of the applicator; and, FIG. 4 is a front perspective view of the cosmetic applicator depicted on a receptacle that is illustrated in the portion of the figure depicted with broken lines, the receptacle not forming part of the invention.

The broken lines in the drawings are for illustrative purposes only and do not form part of the claimed design.

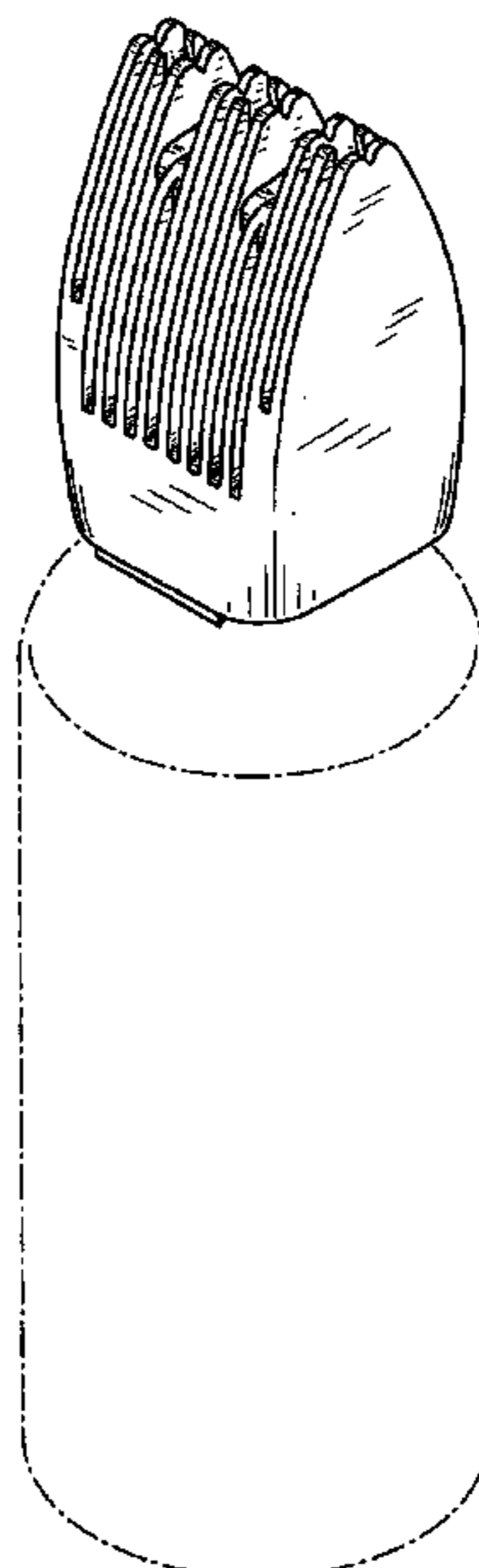

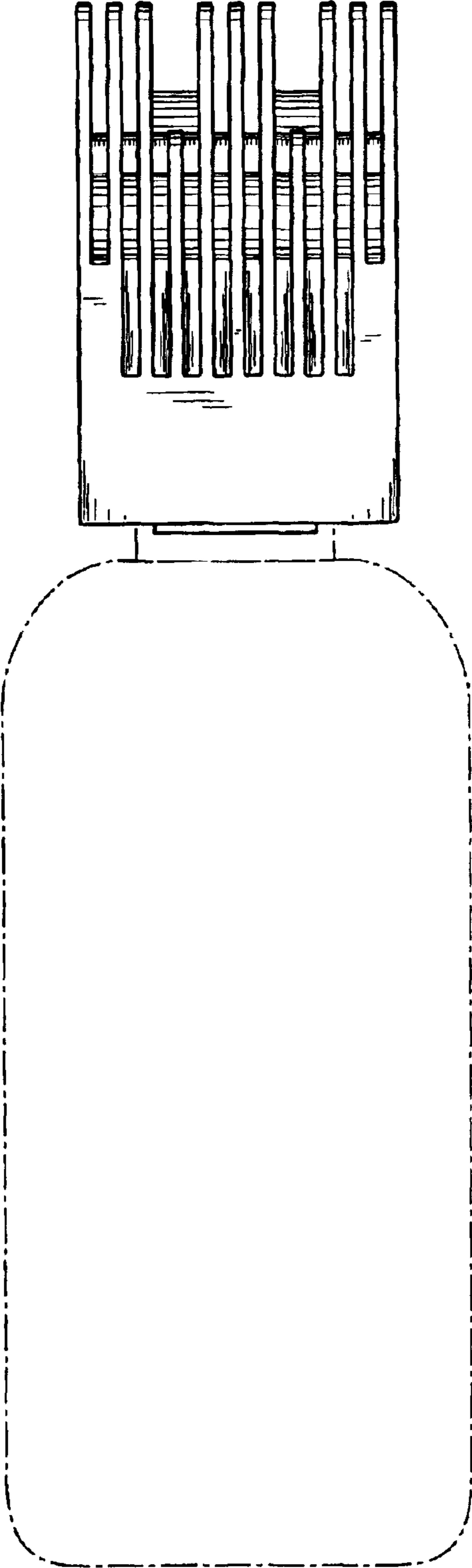

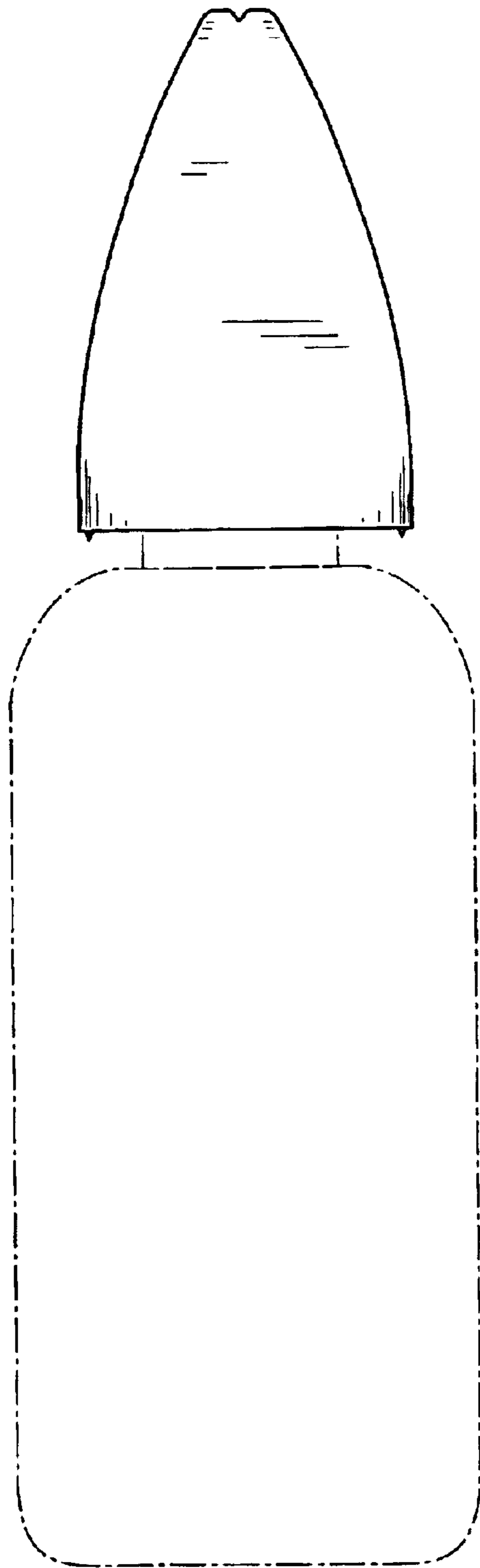

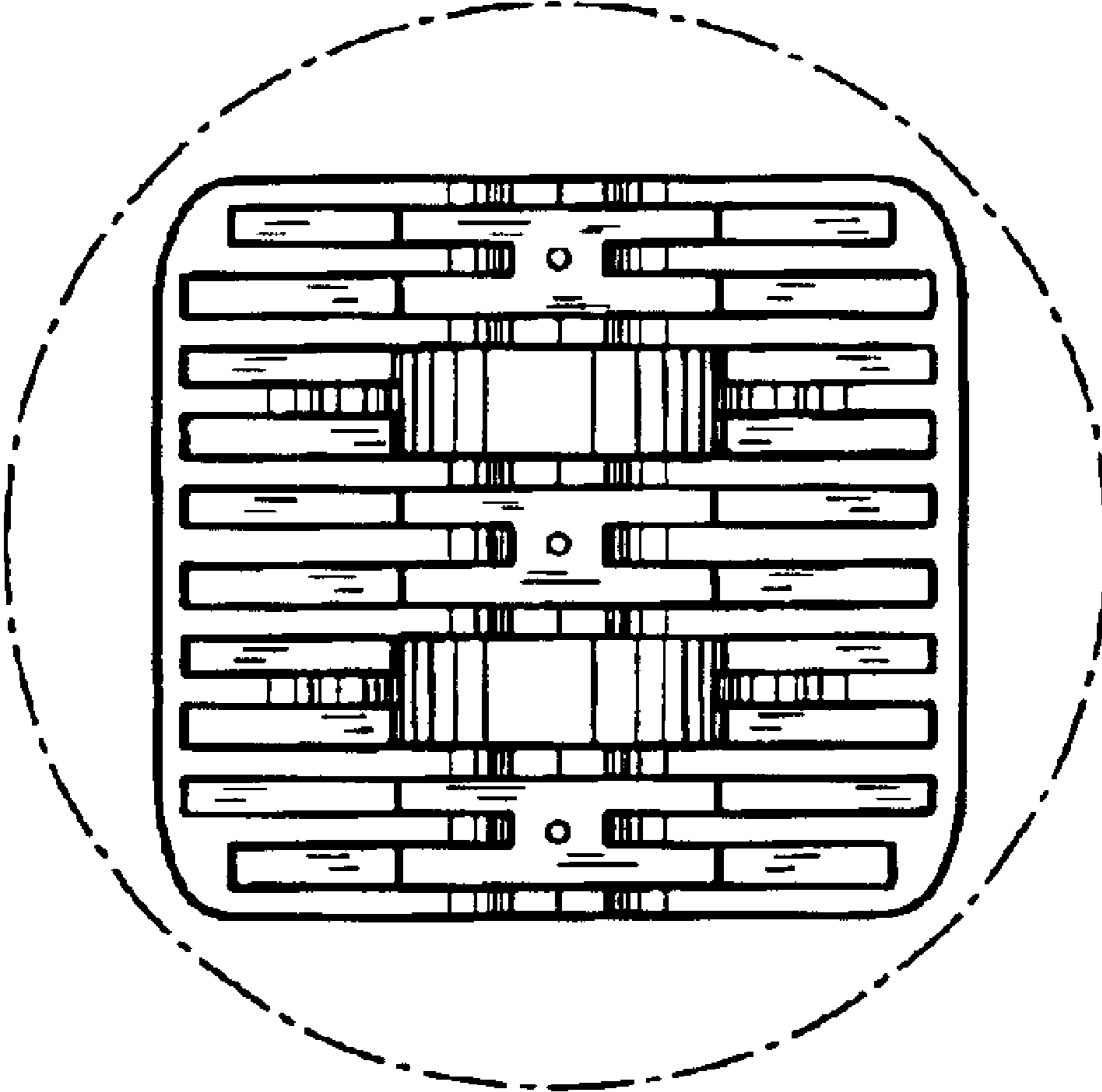
