(57) **CLAIM**

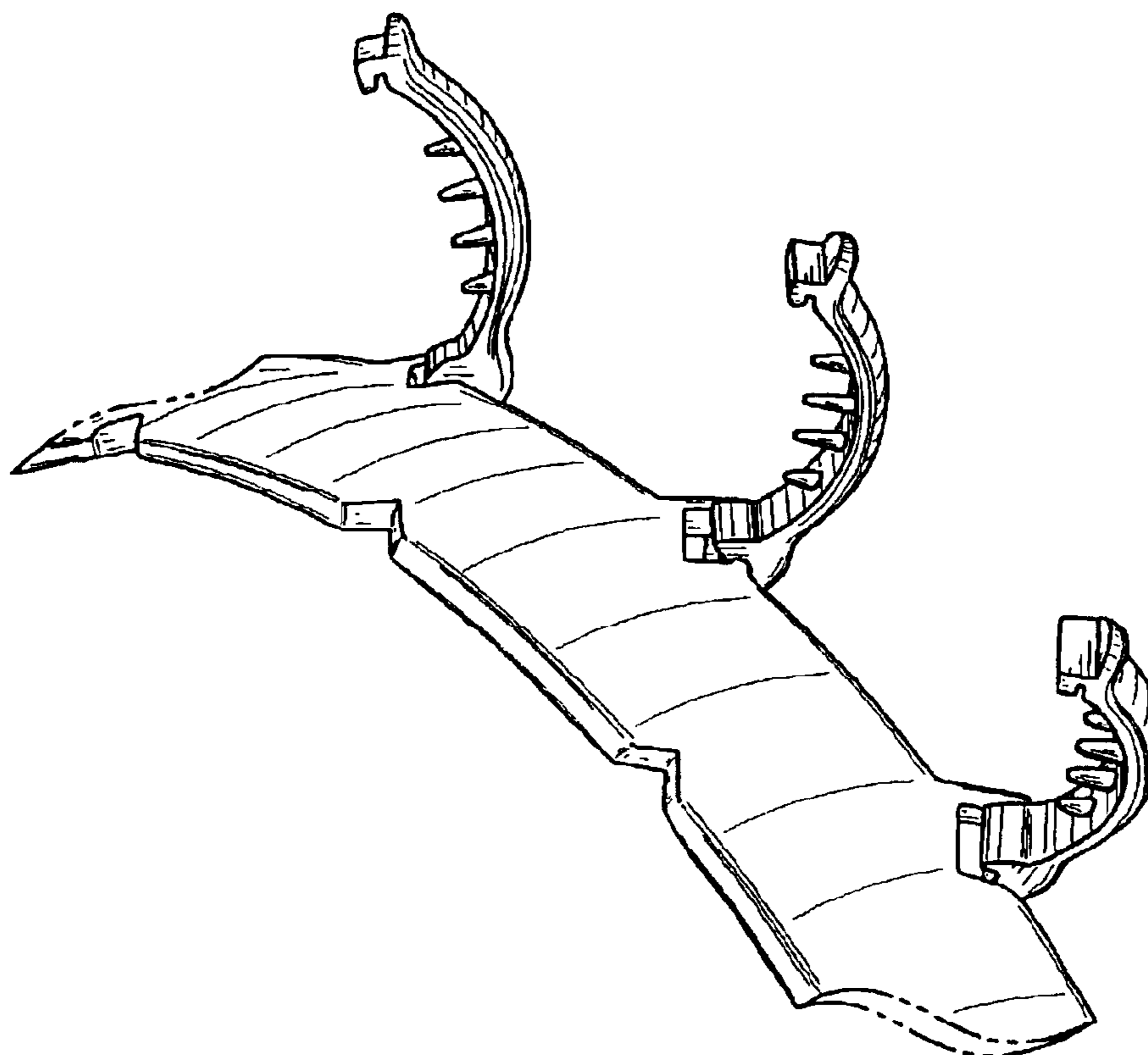
The ornamental design for a hair accessory with multiple clips, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a hair accessory with multiple clips showing my new design; FIG. 2 is a rear elevation view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a left side elevation view thereof; and, FIG. 7 is a perspective view of the hair accessory of FIG. 1 with the clips in an open position.

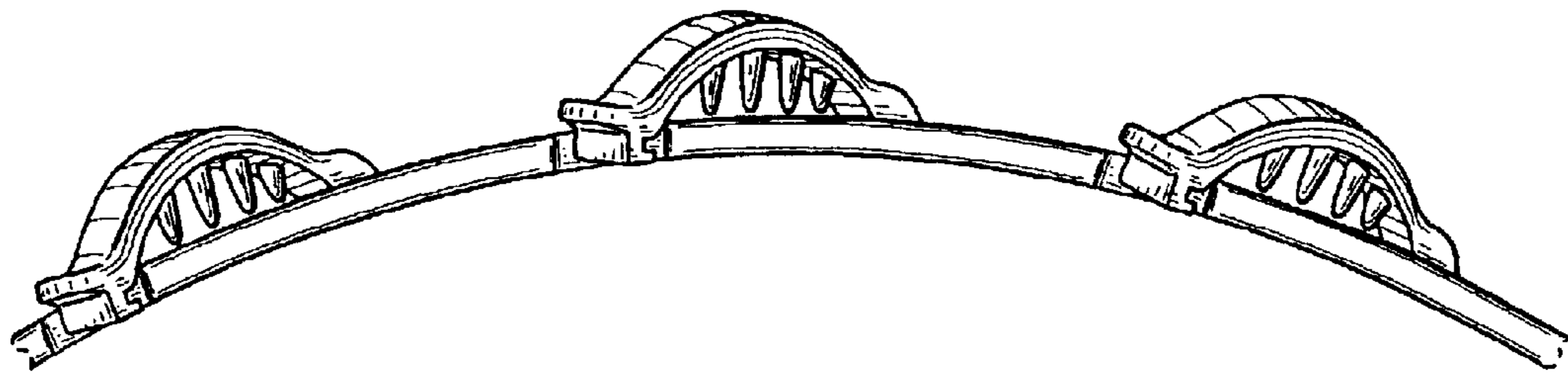

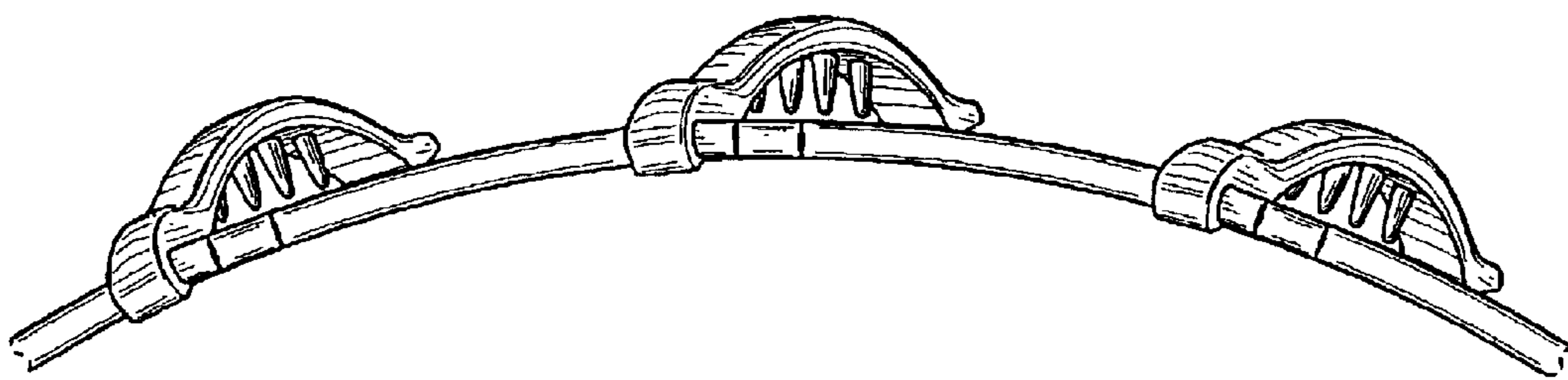

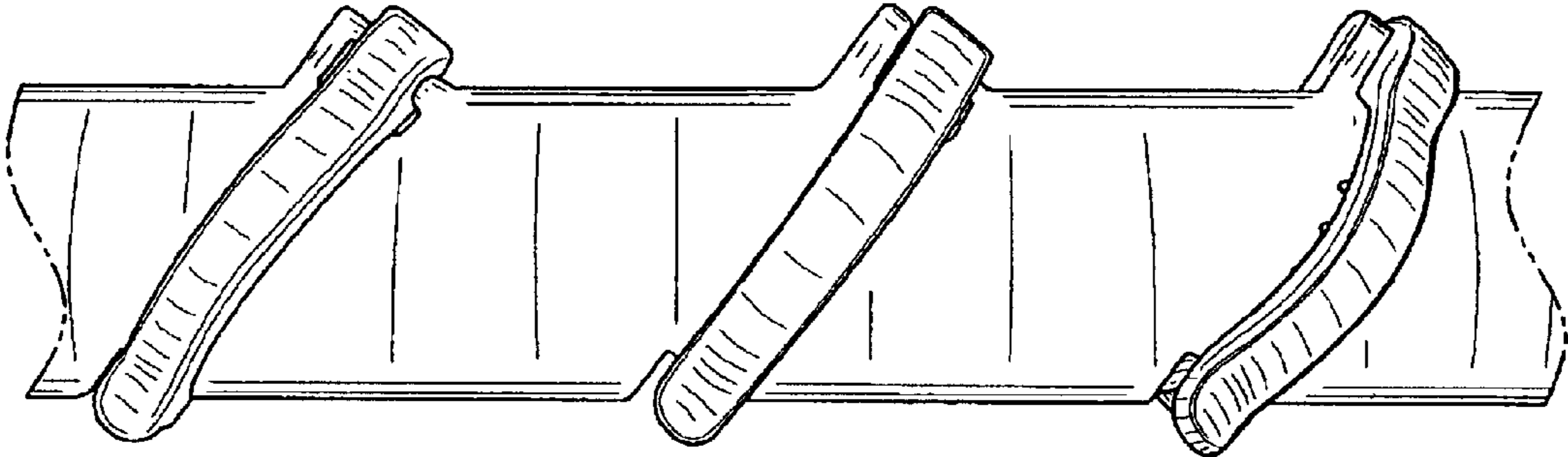

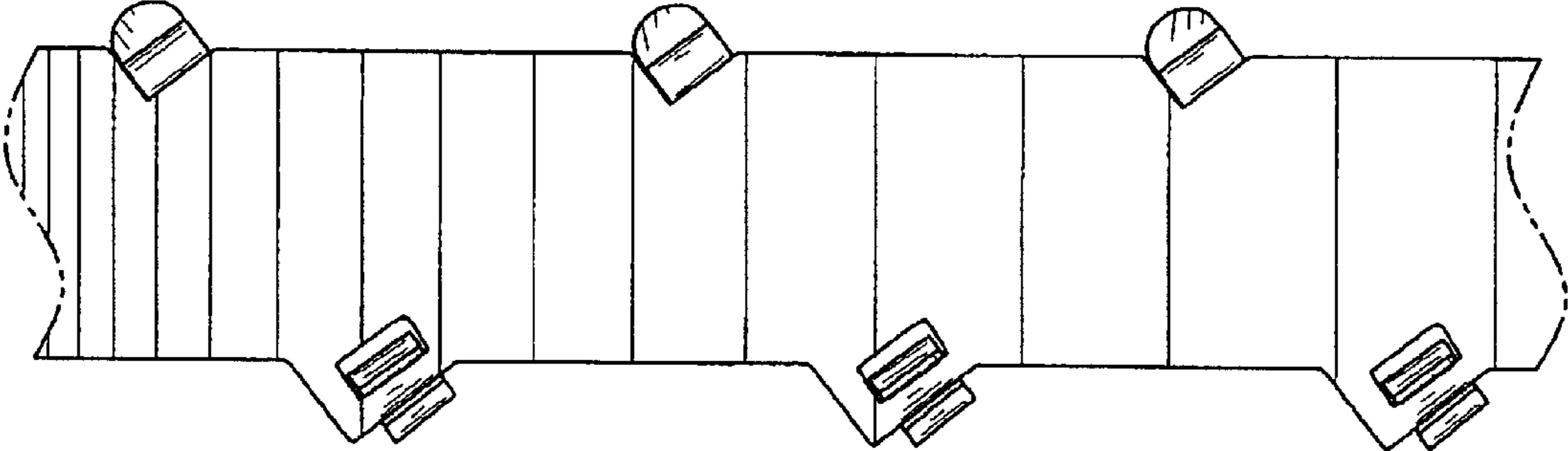

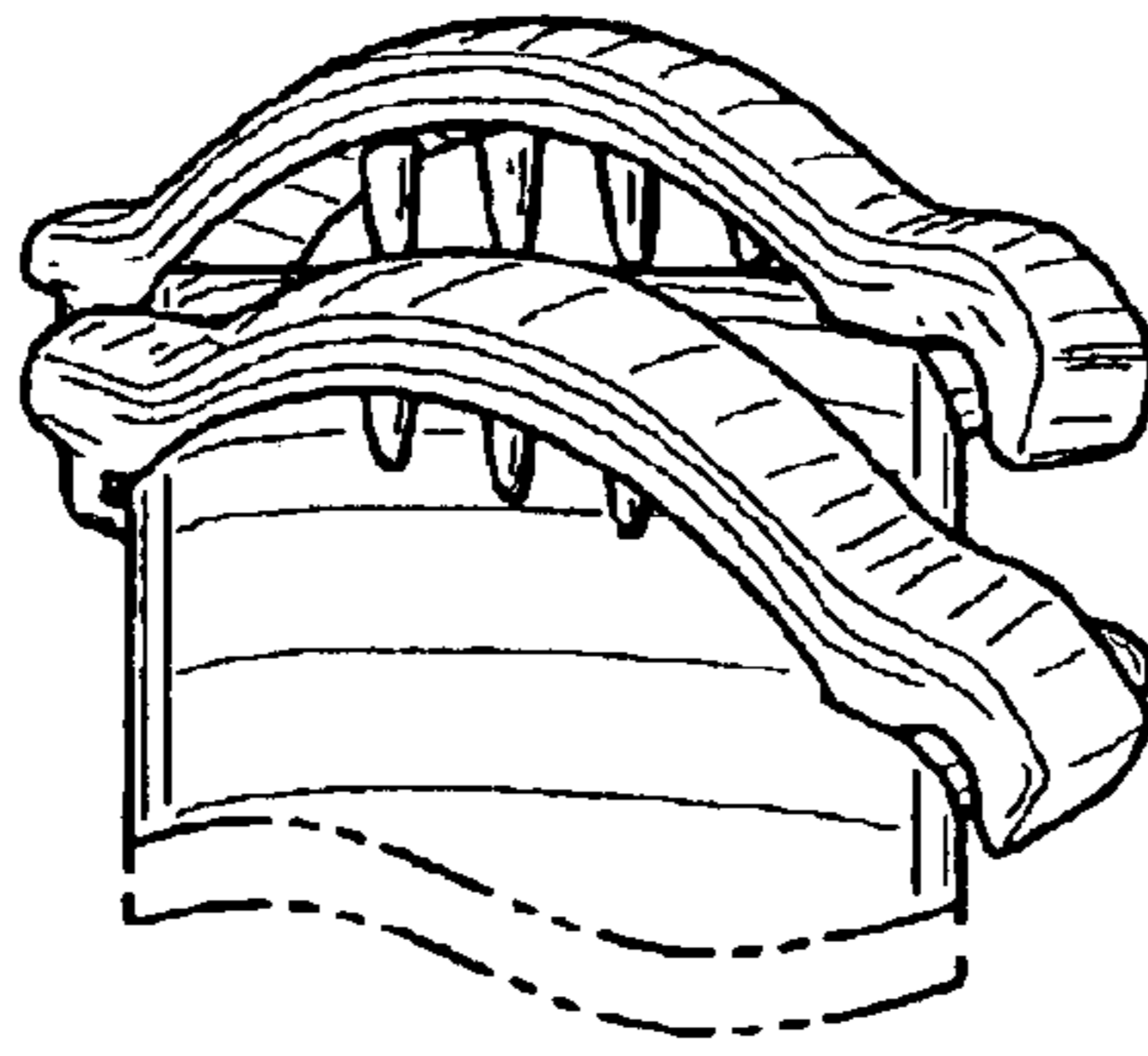

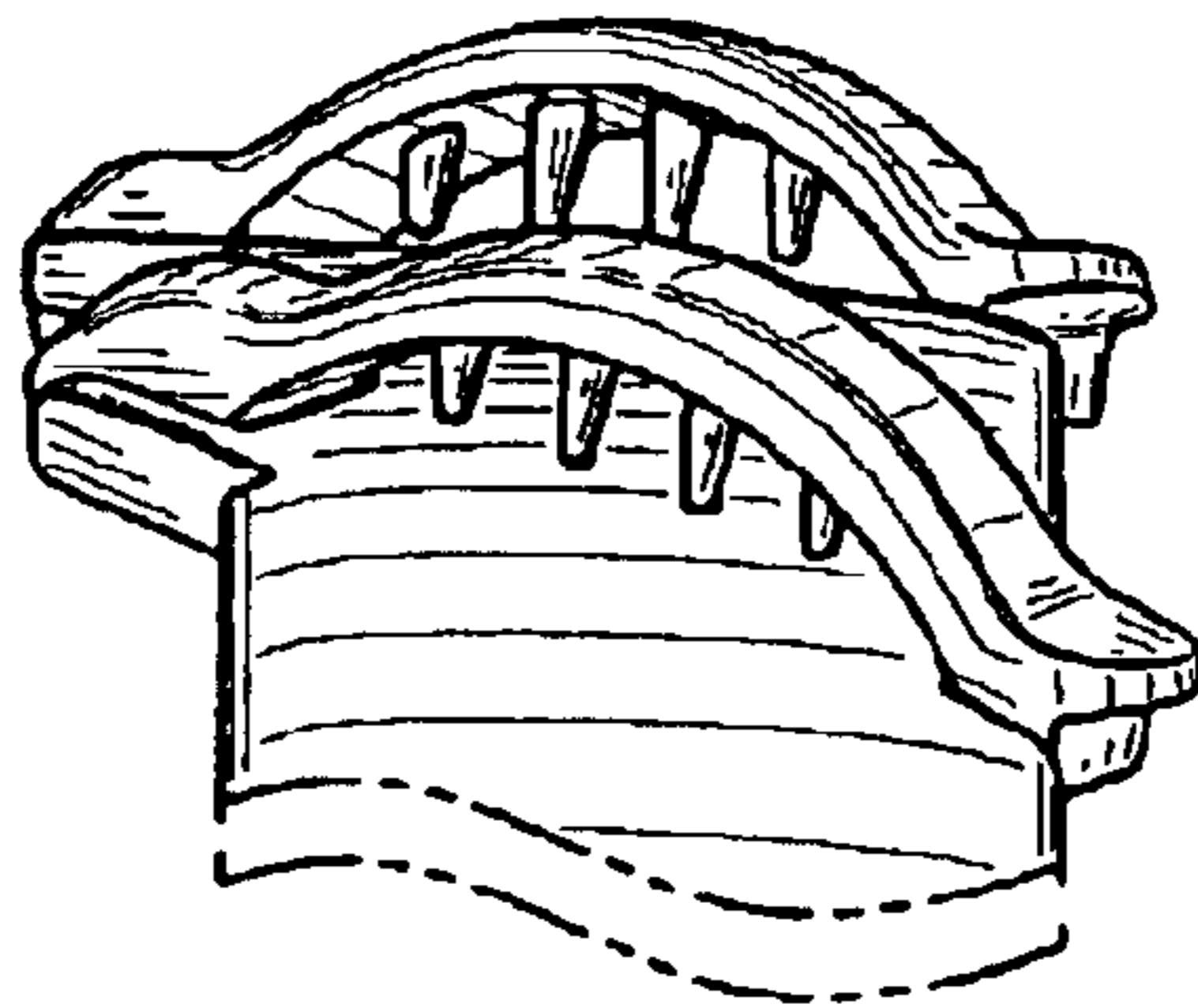

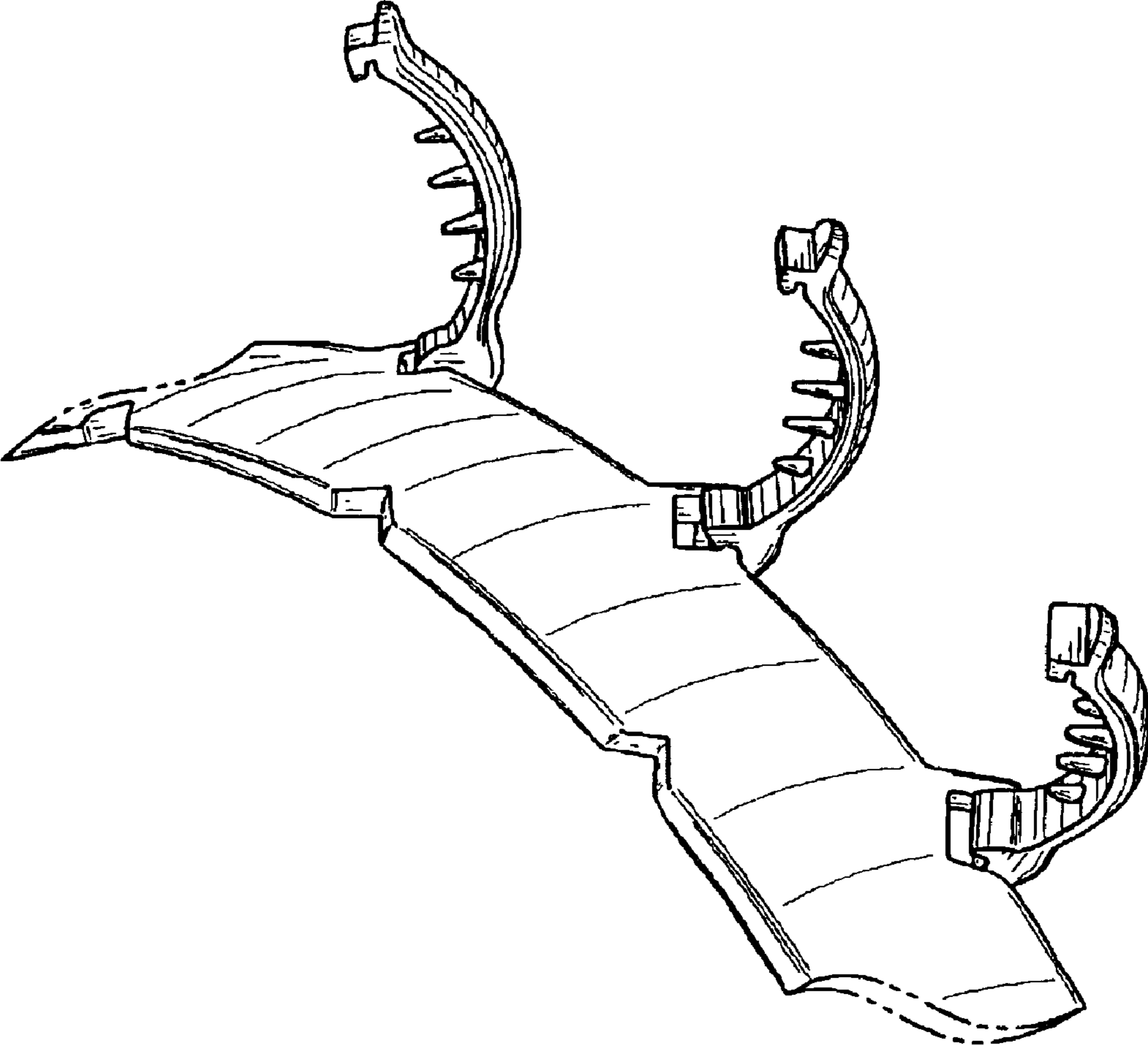
