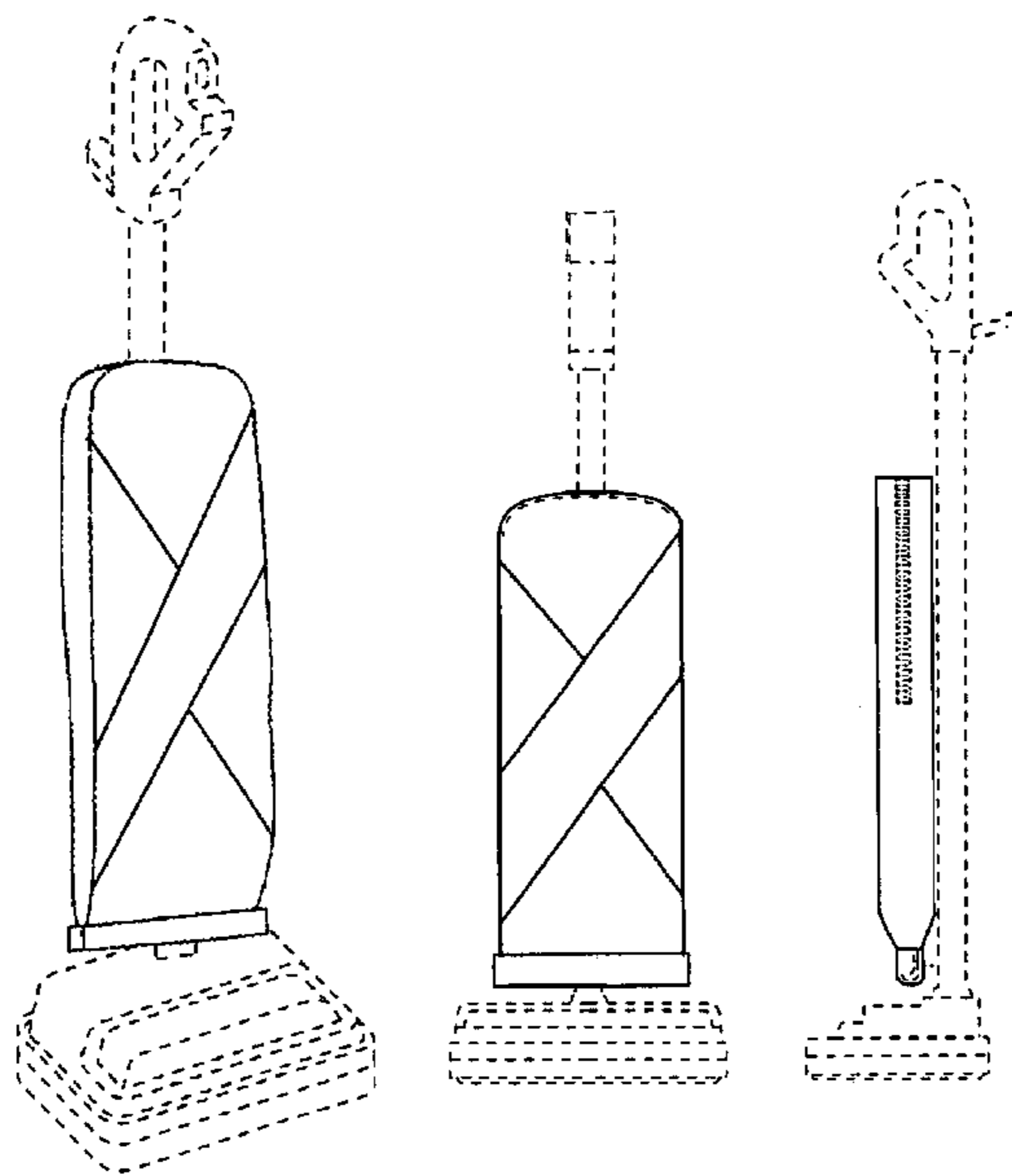
The ornamental design for a containment member for floor care apparatus, as shown and described.

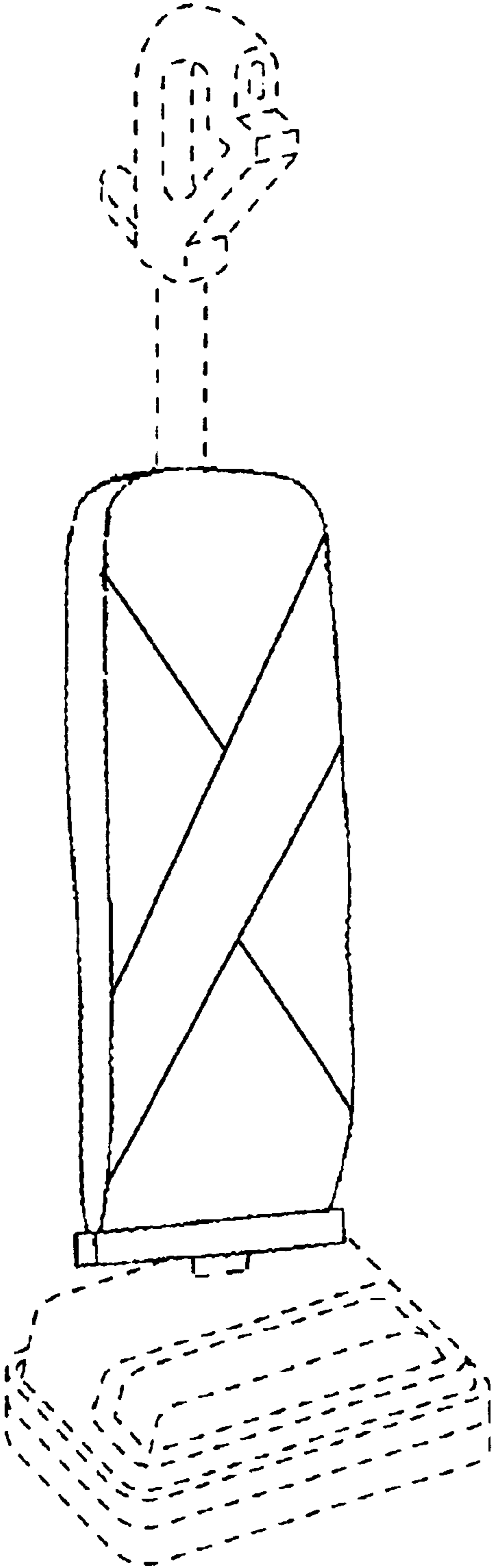

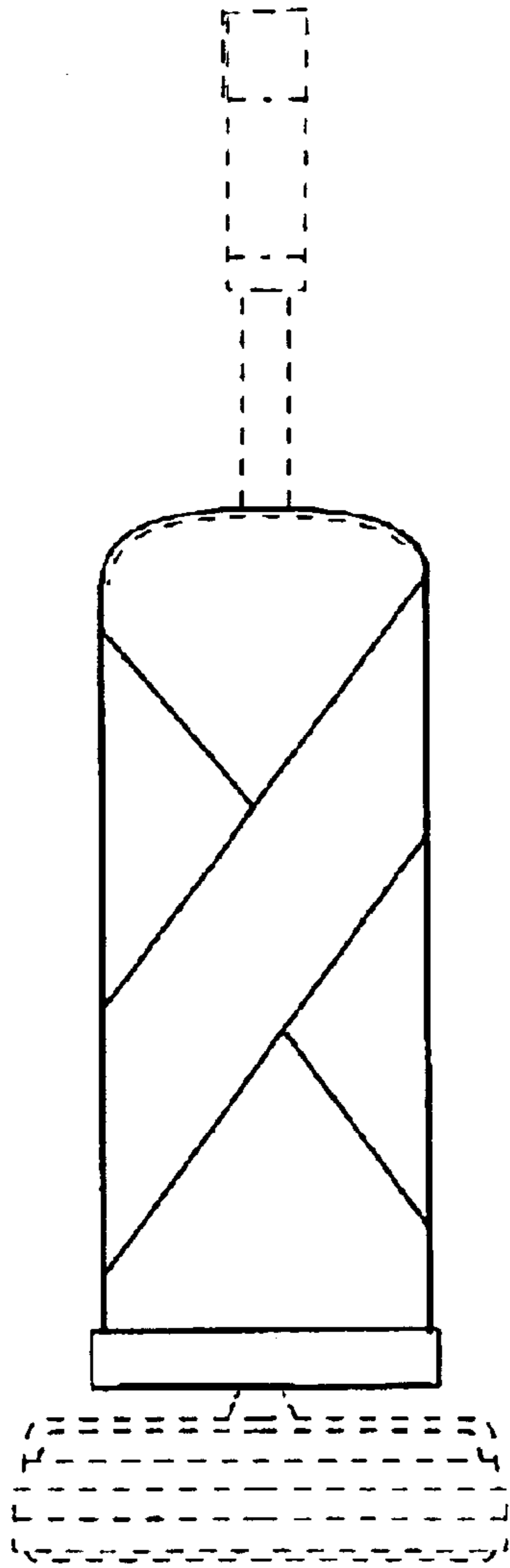

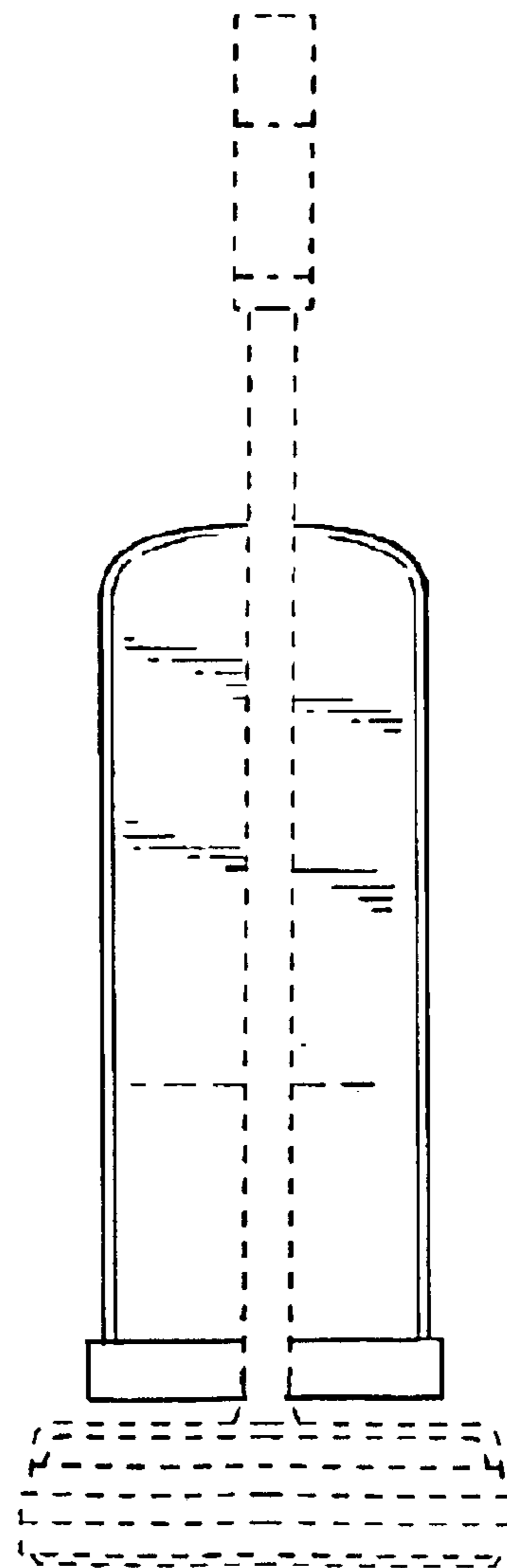

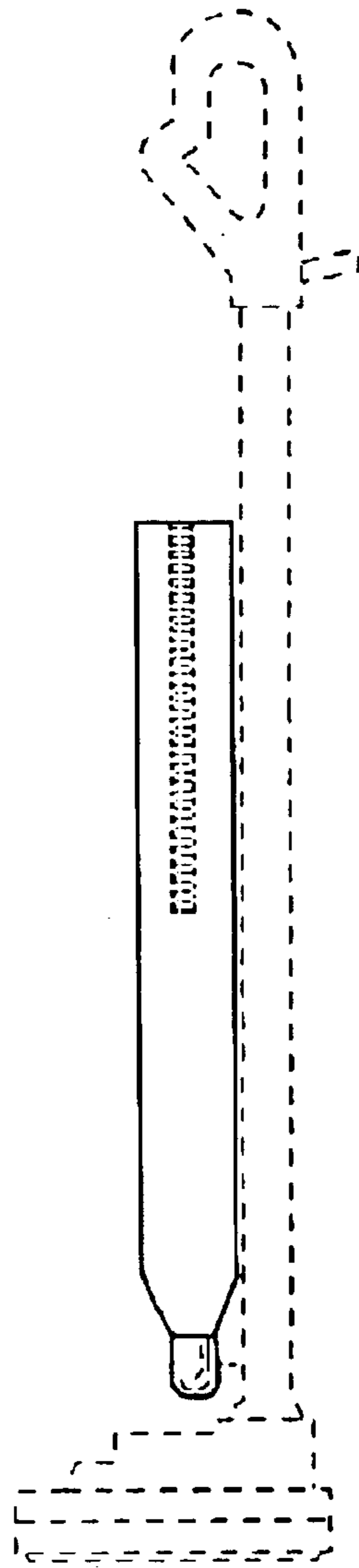

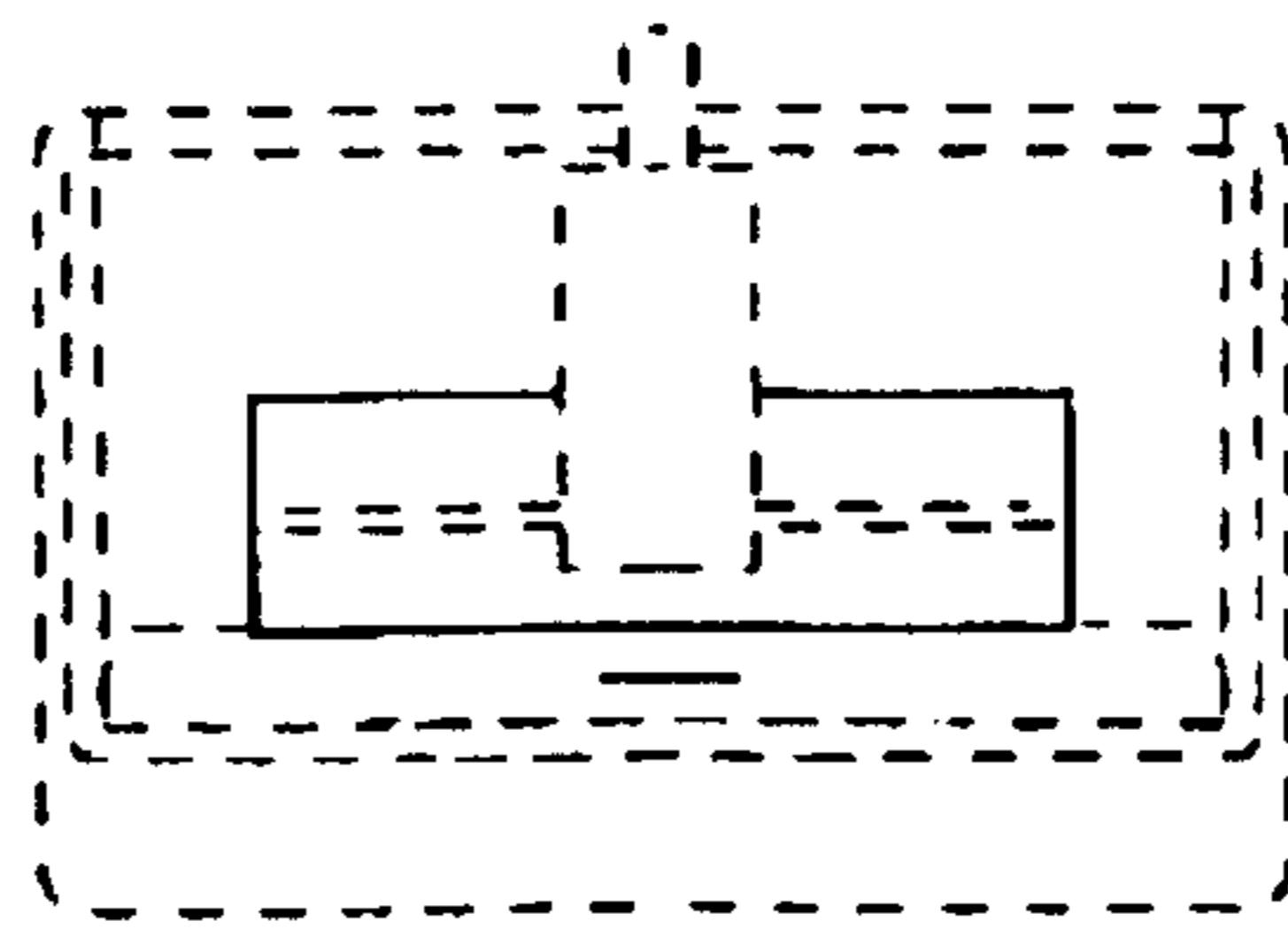
