(57) **CLAIM**

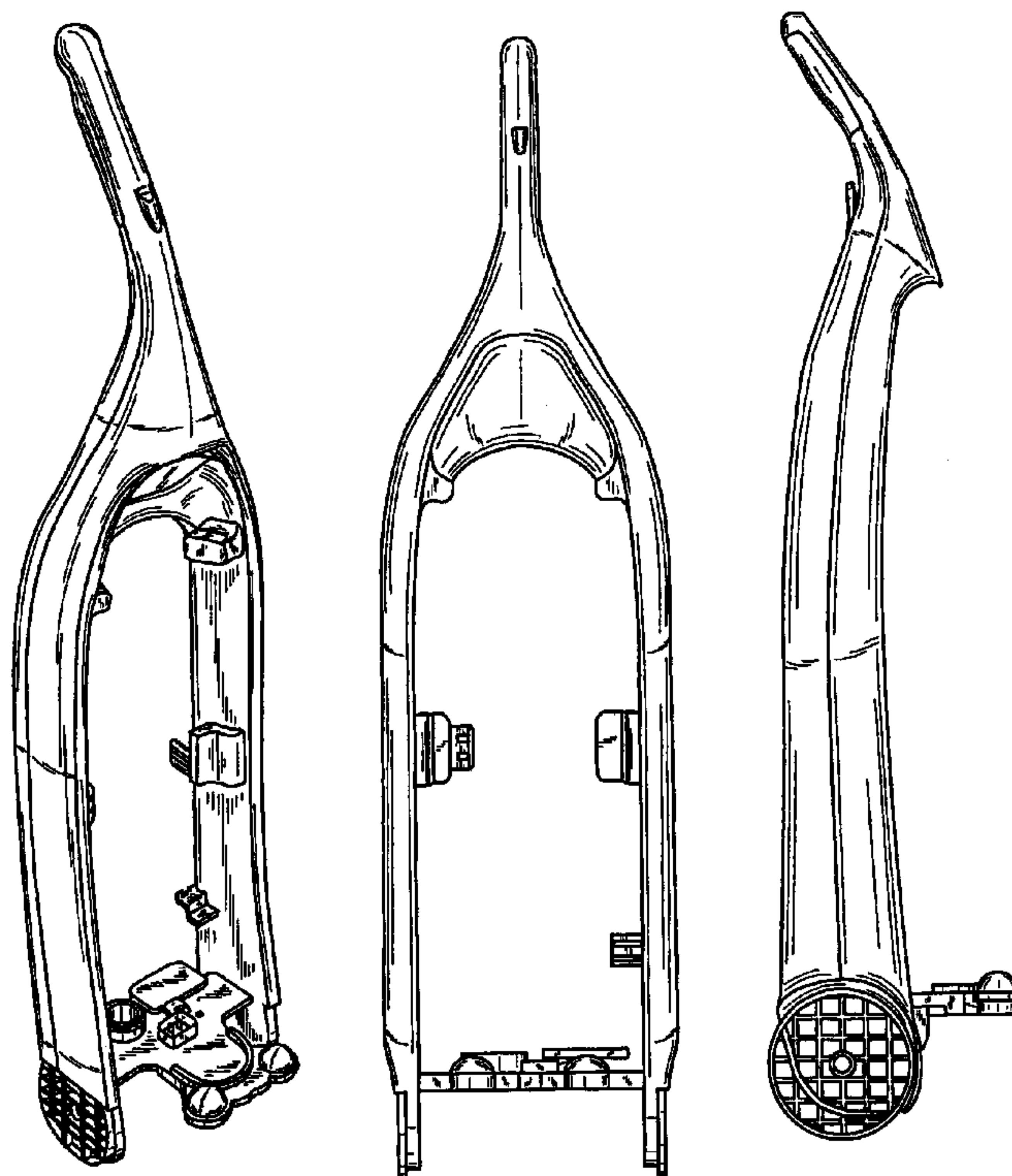
The ornamental design for a vacuum upright portion, as shown and described.

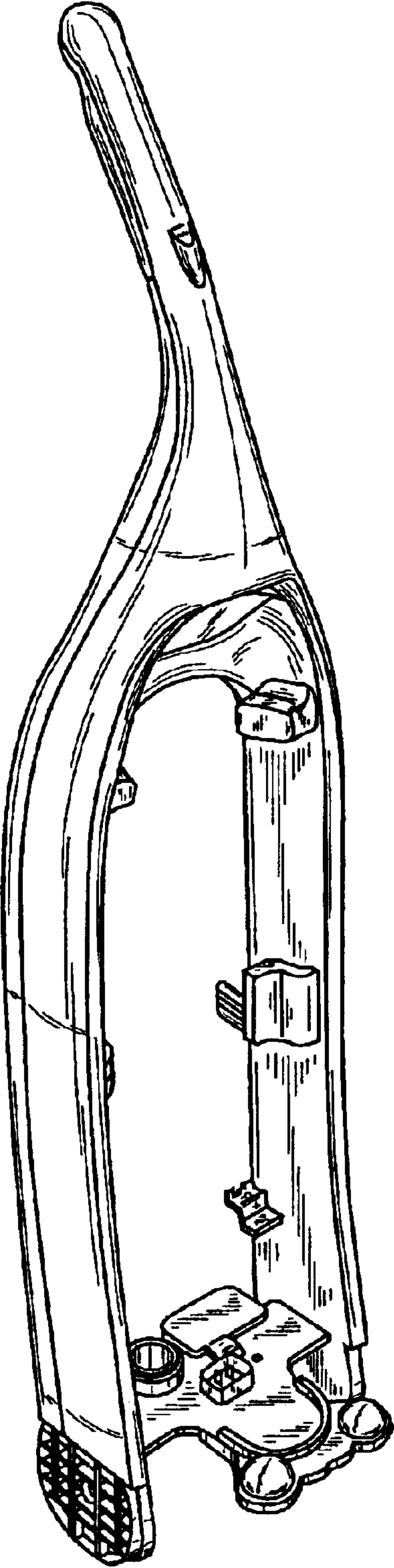
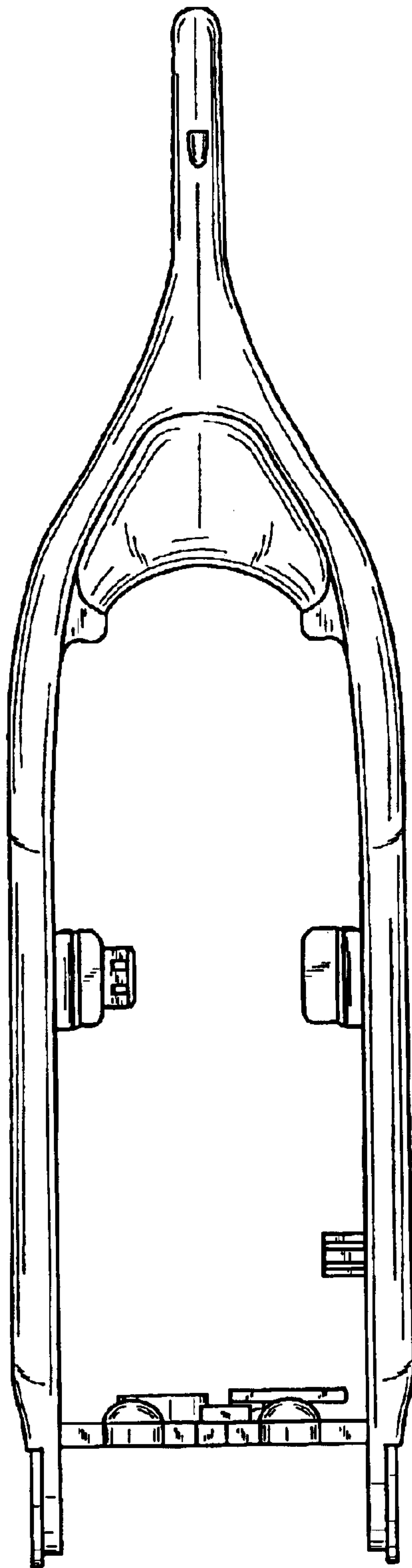

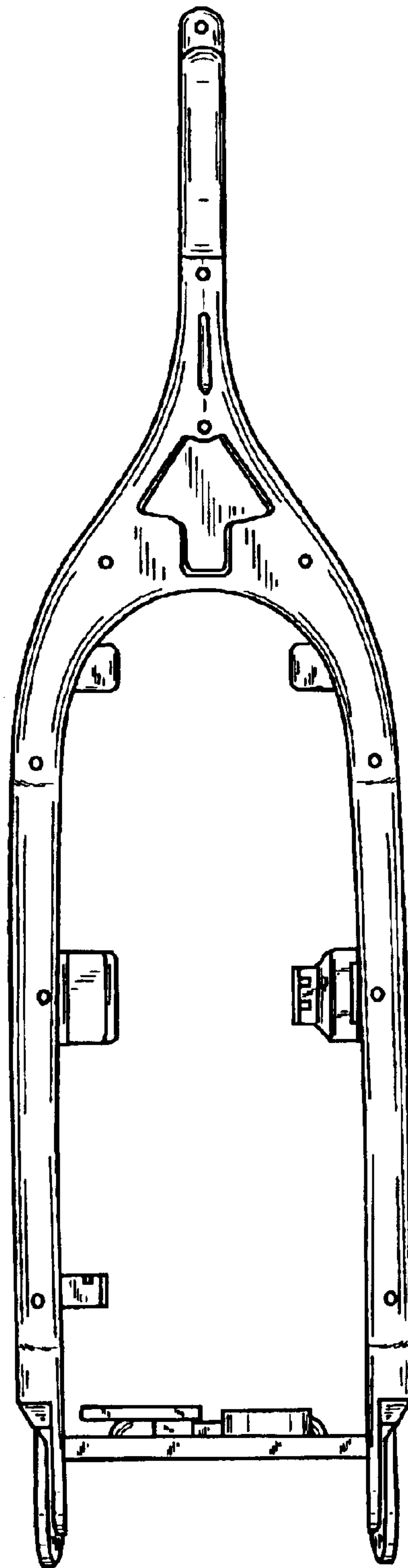

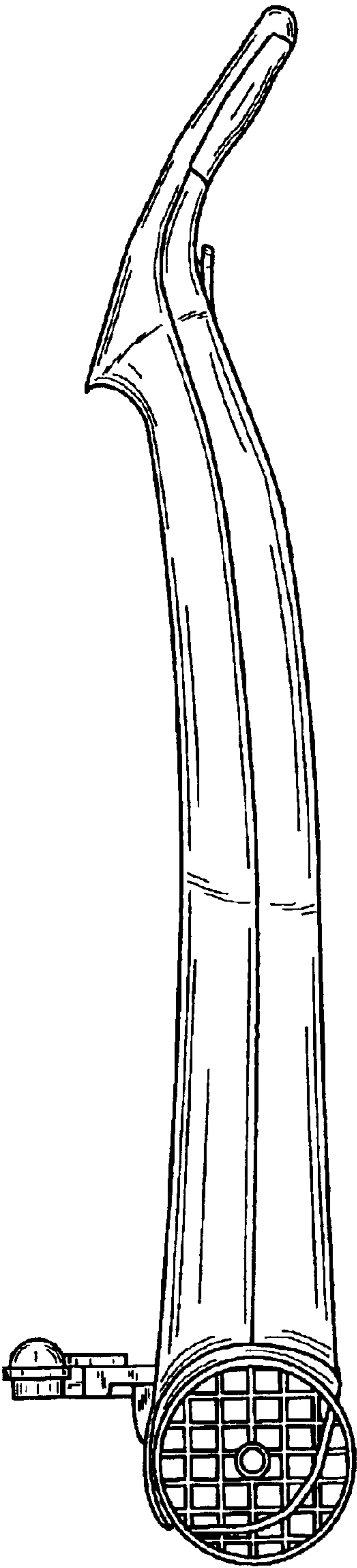

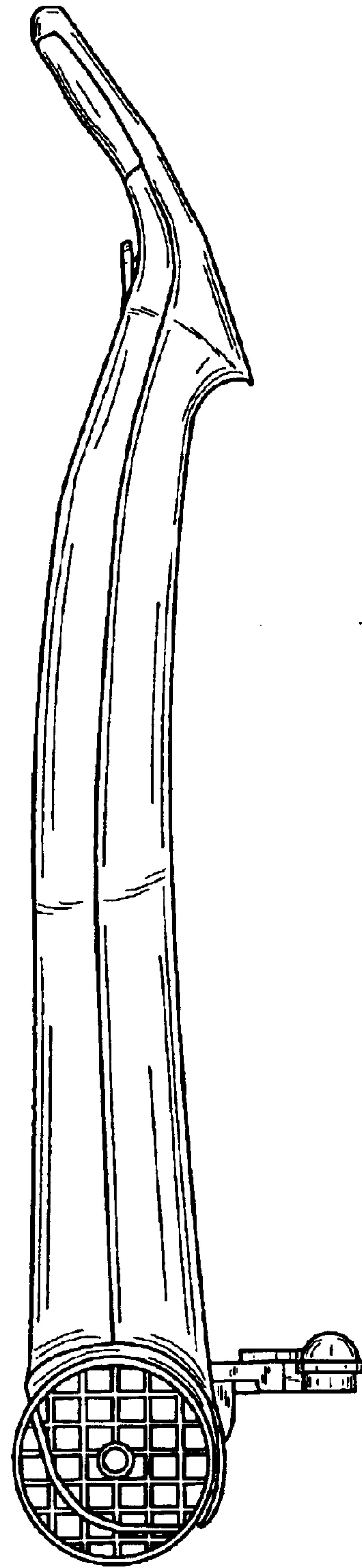
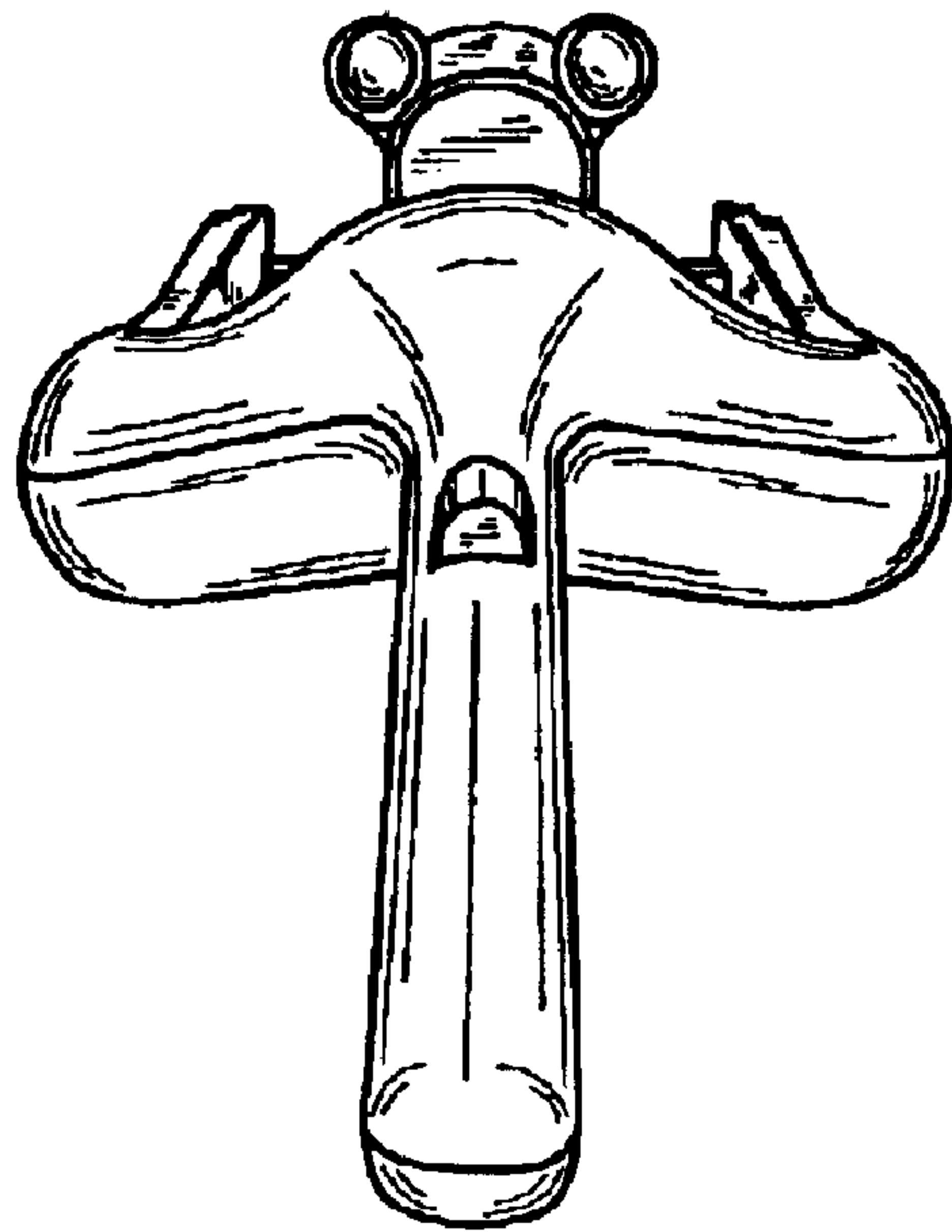
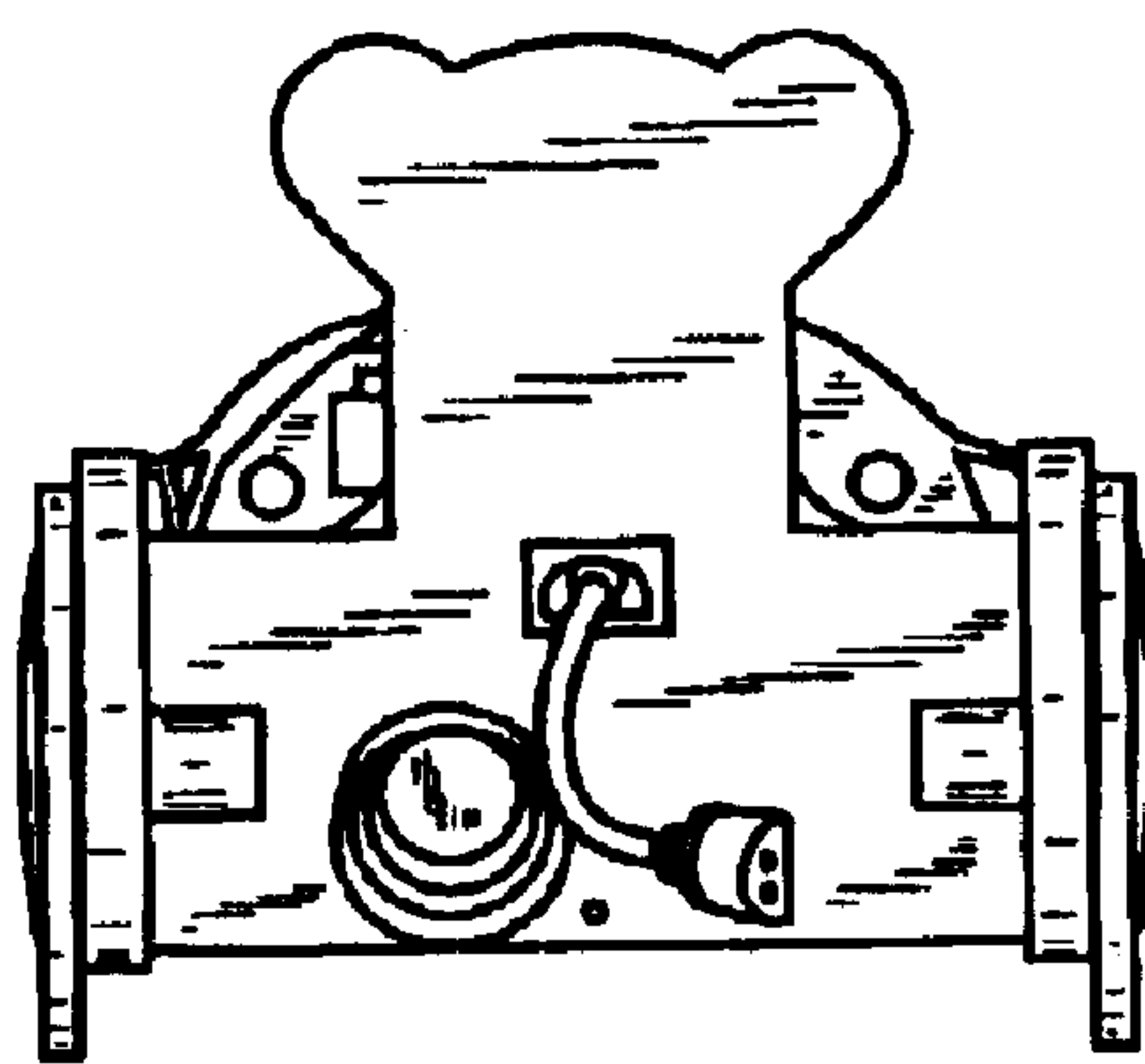
