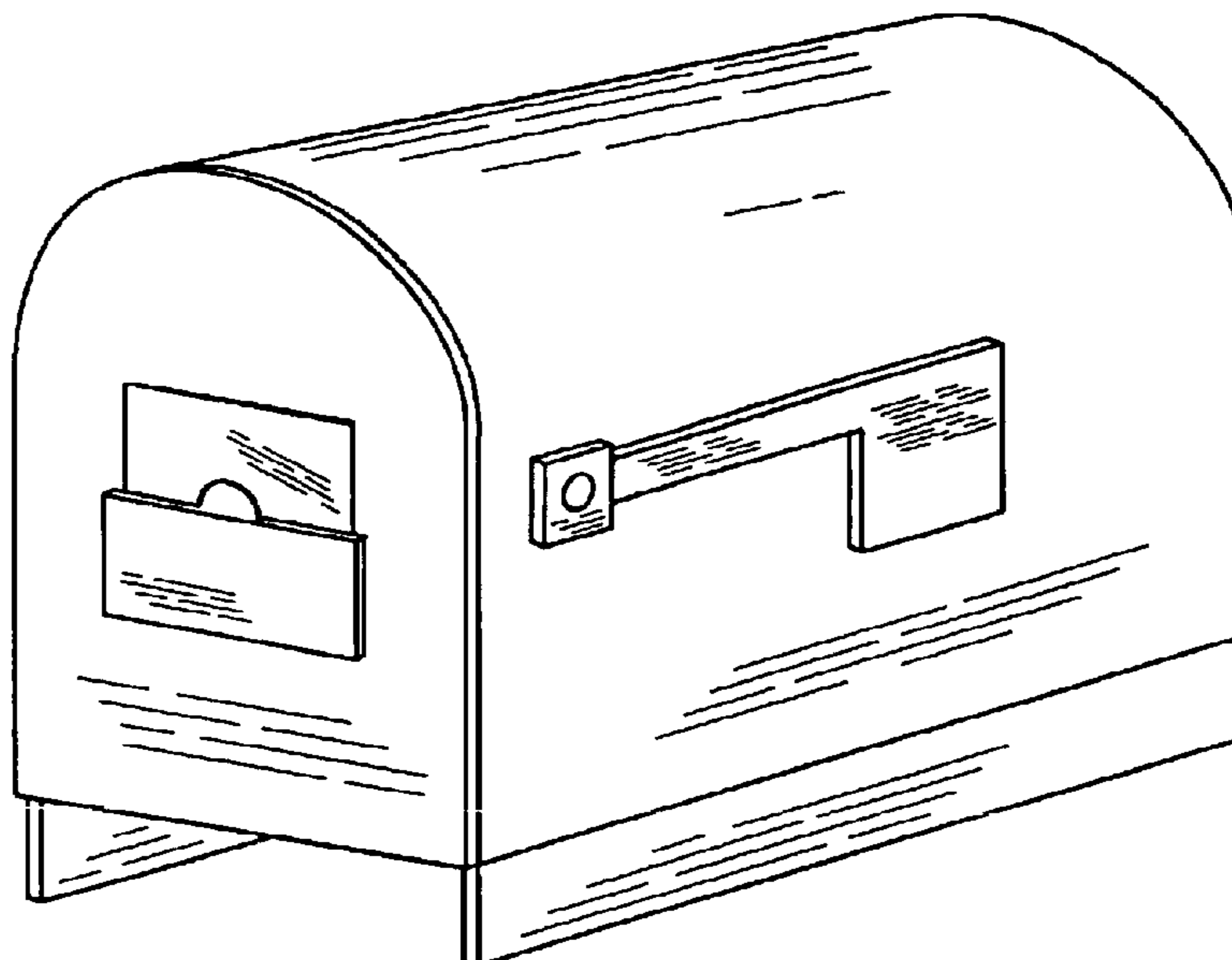

FIG. 7 is a left-side elevational view of the mailbox of FIG. 1;  
FIG. 8 is a is a top plan view of the mailbox of FIG. 1;  
FIG. 9 is a is a bottom plan view of the mailbox of FIG. 1;

FIG. 10 is a left side elevational view, the undisclosed front, rear, top, bottom, and opposite side are not part of the claimed design.

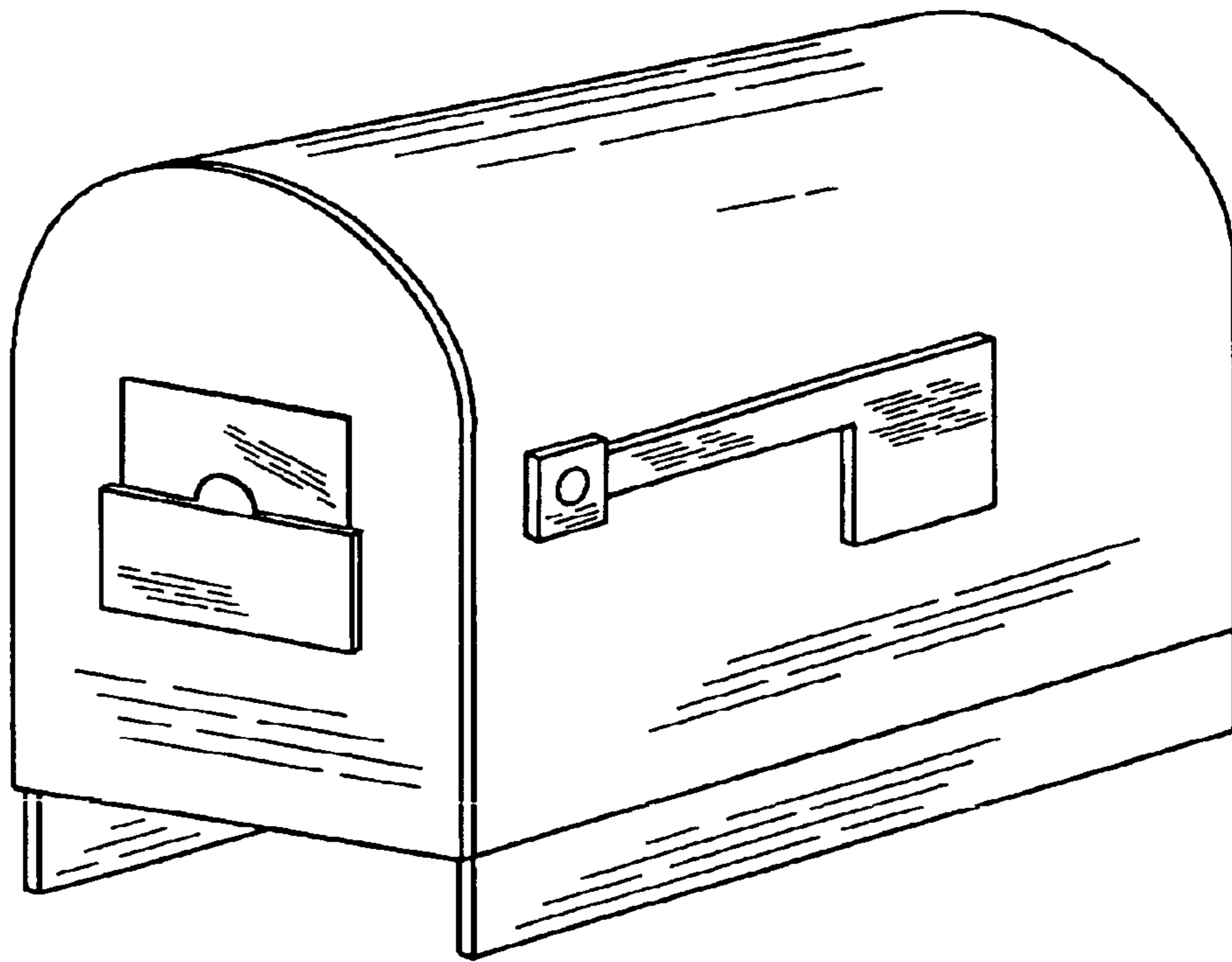

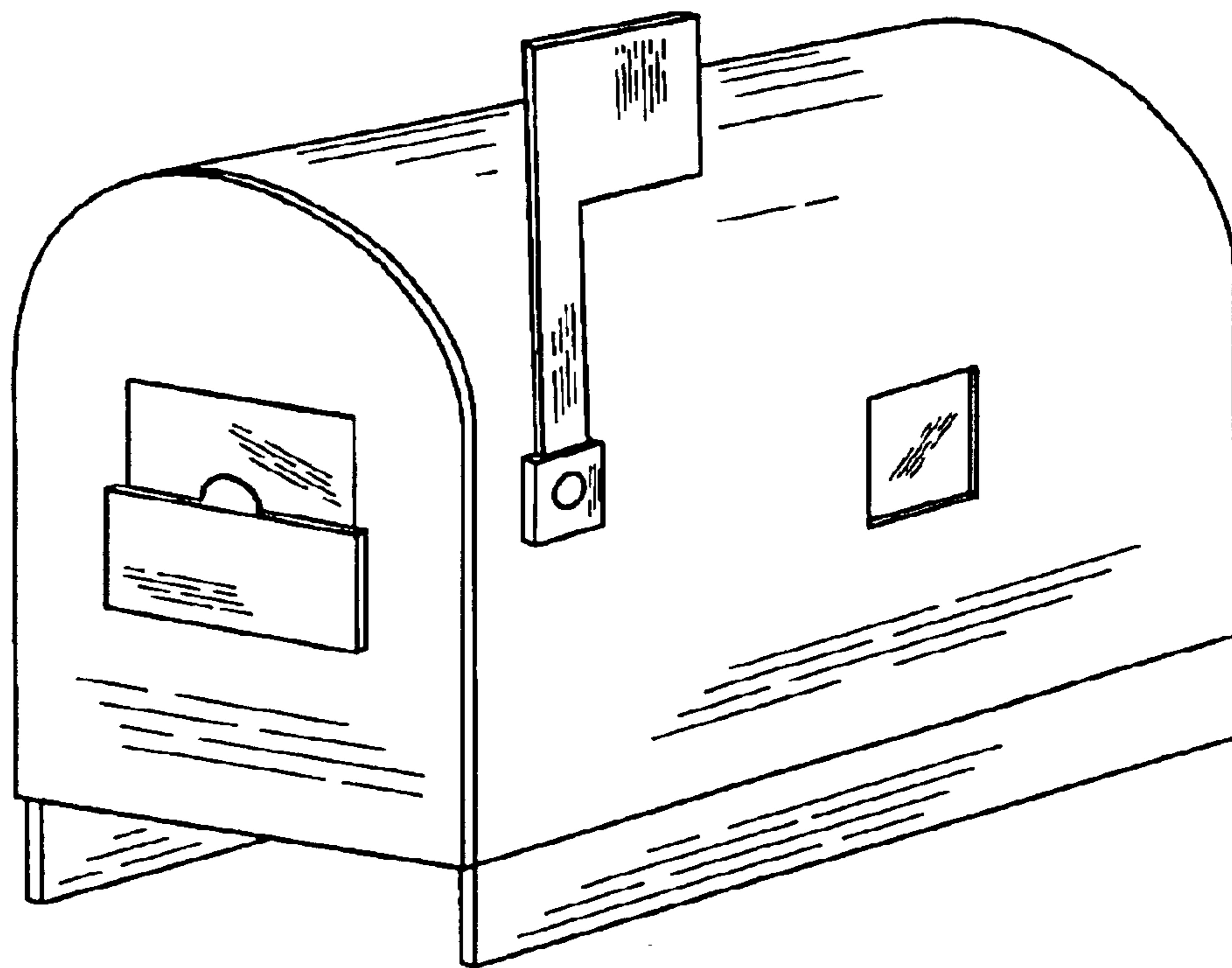

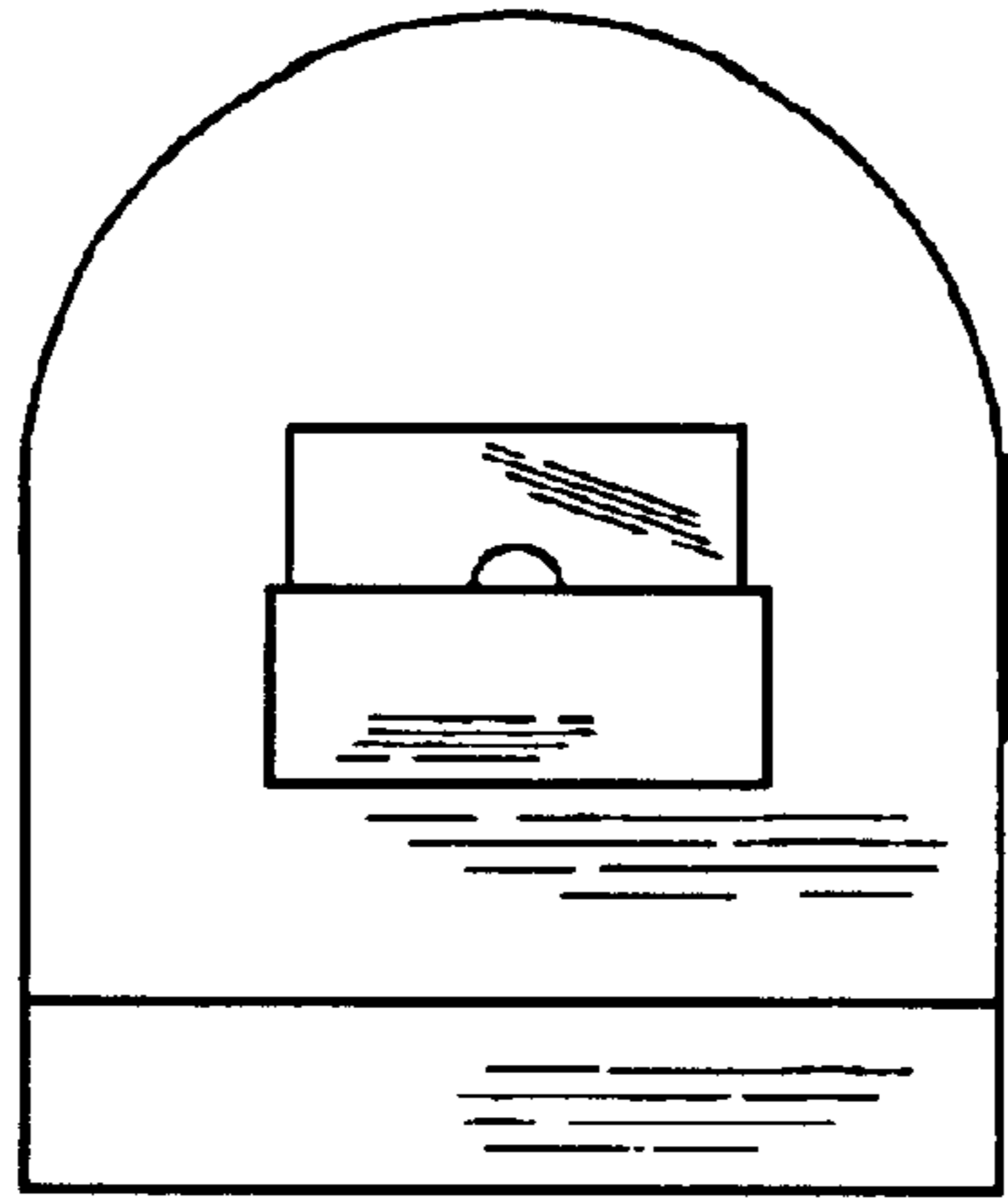

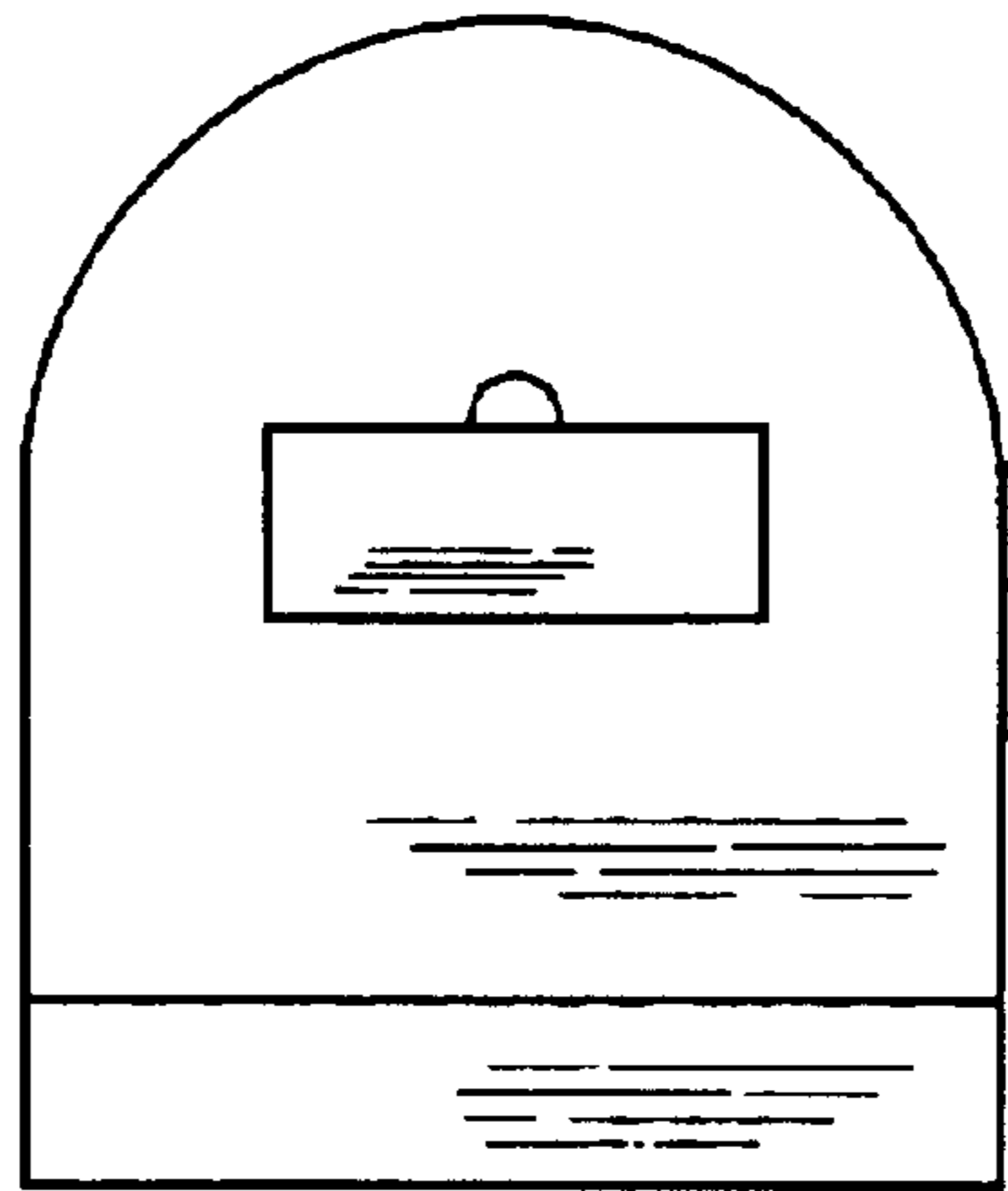

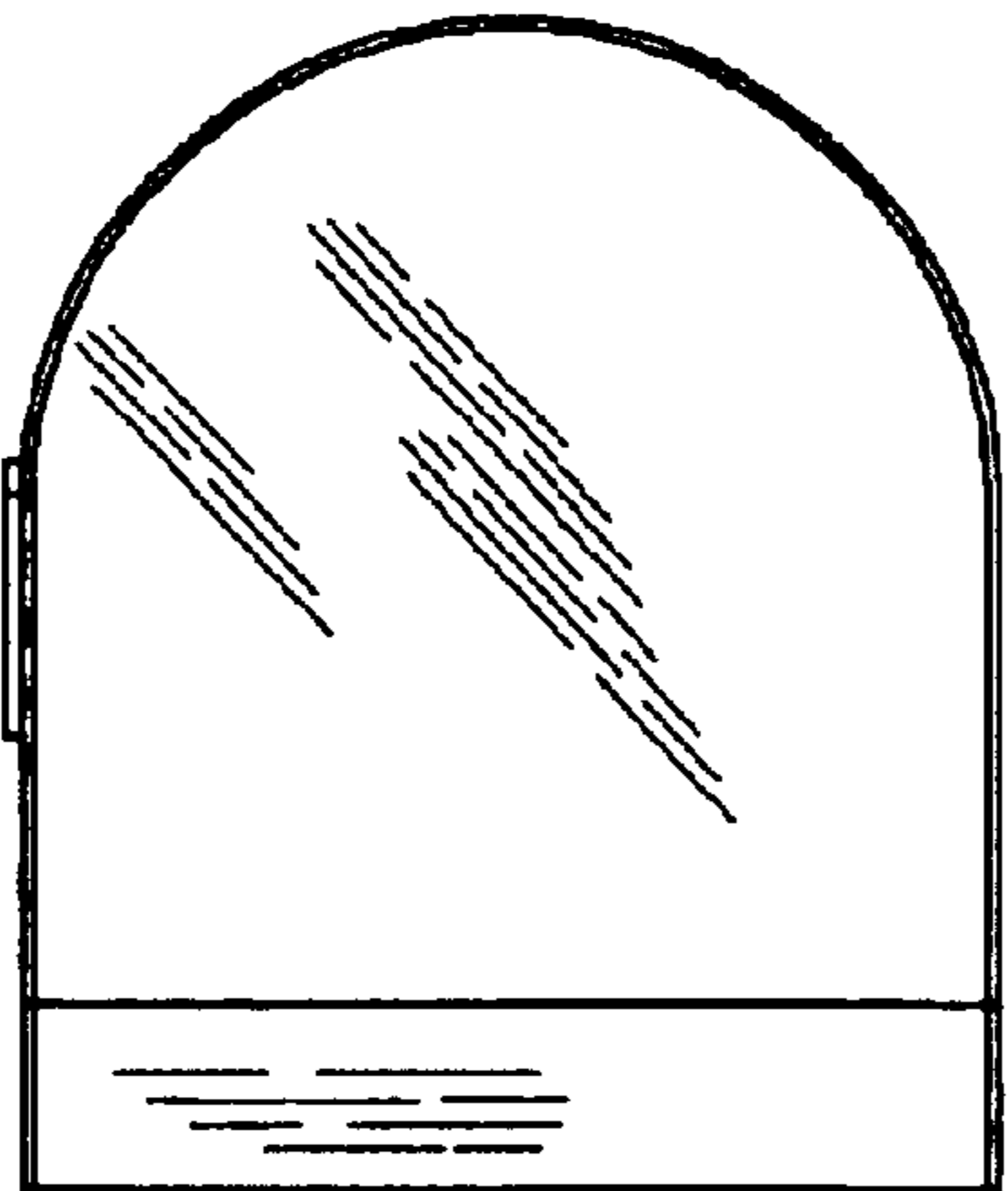

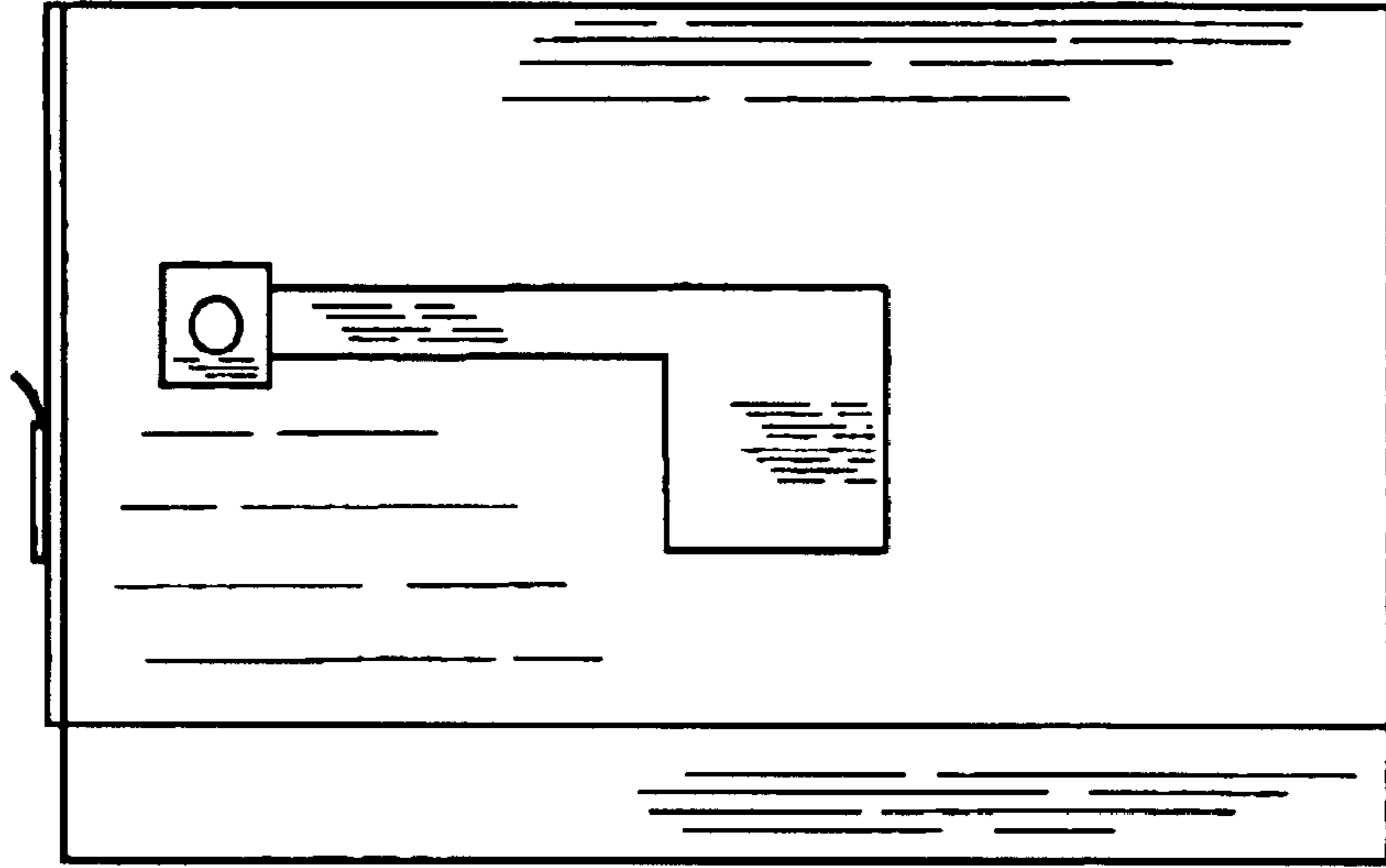

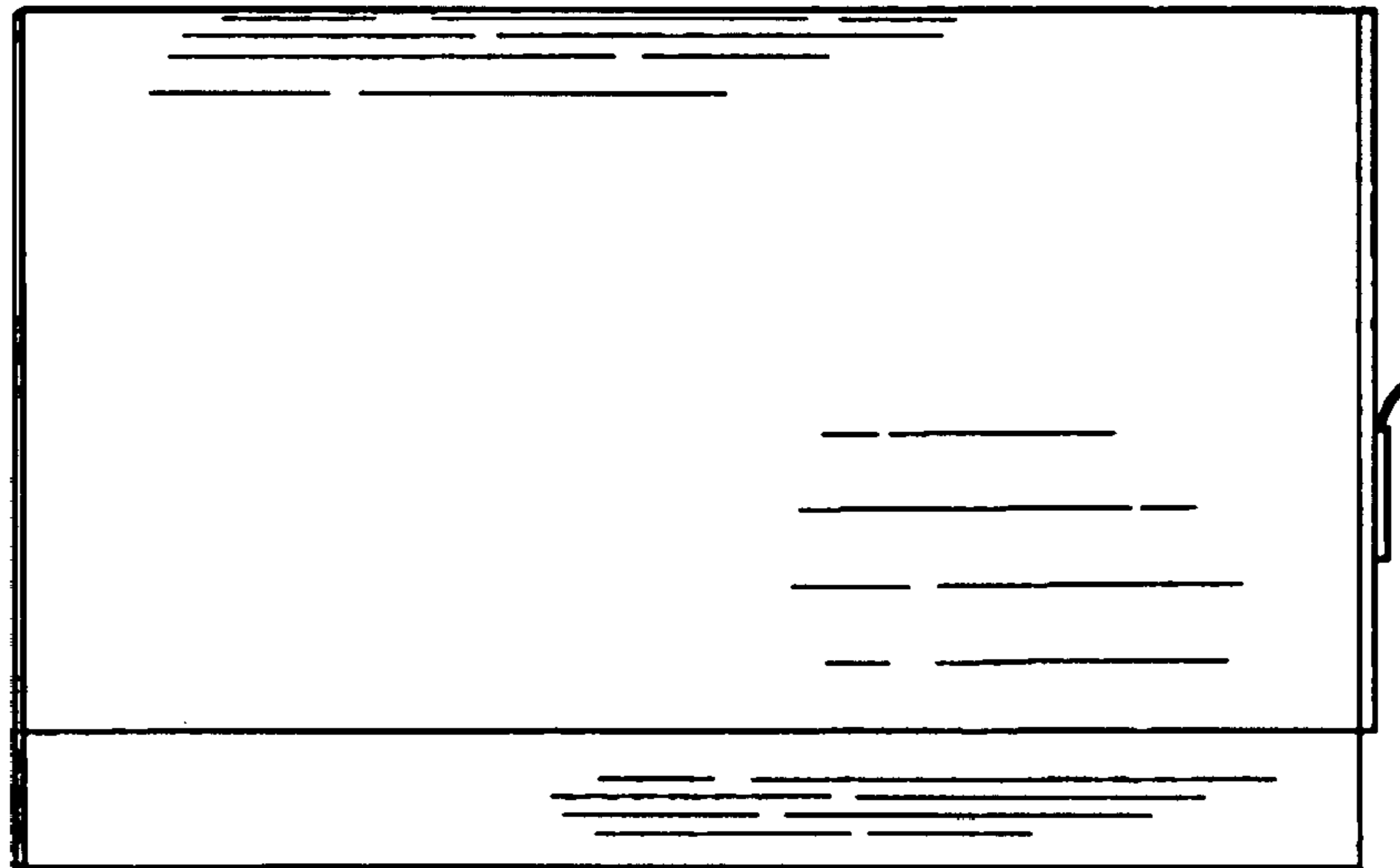

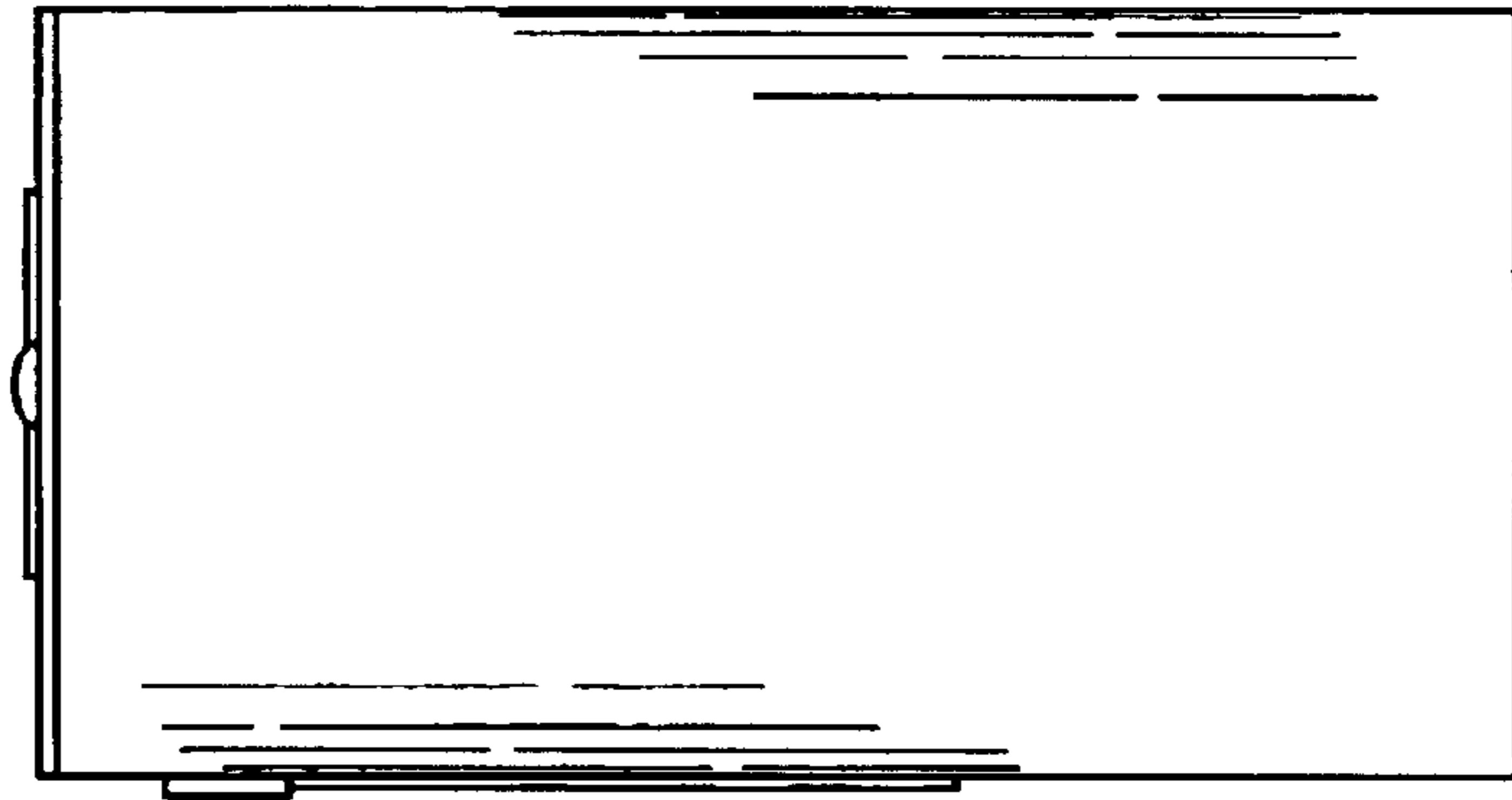

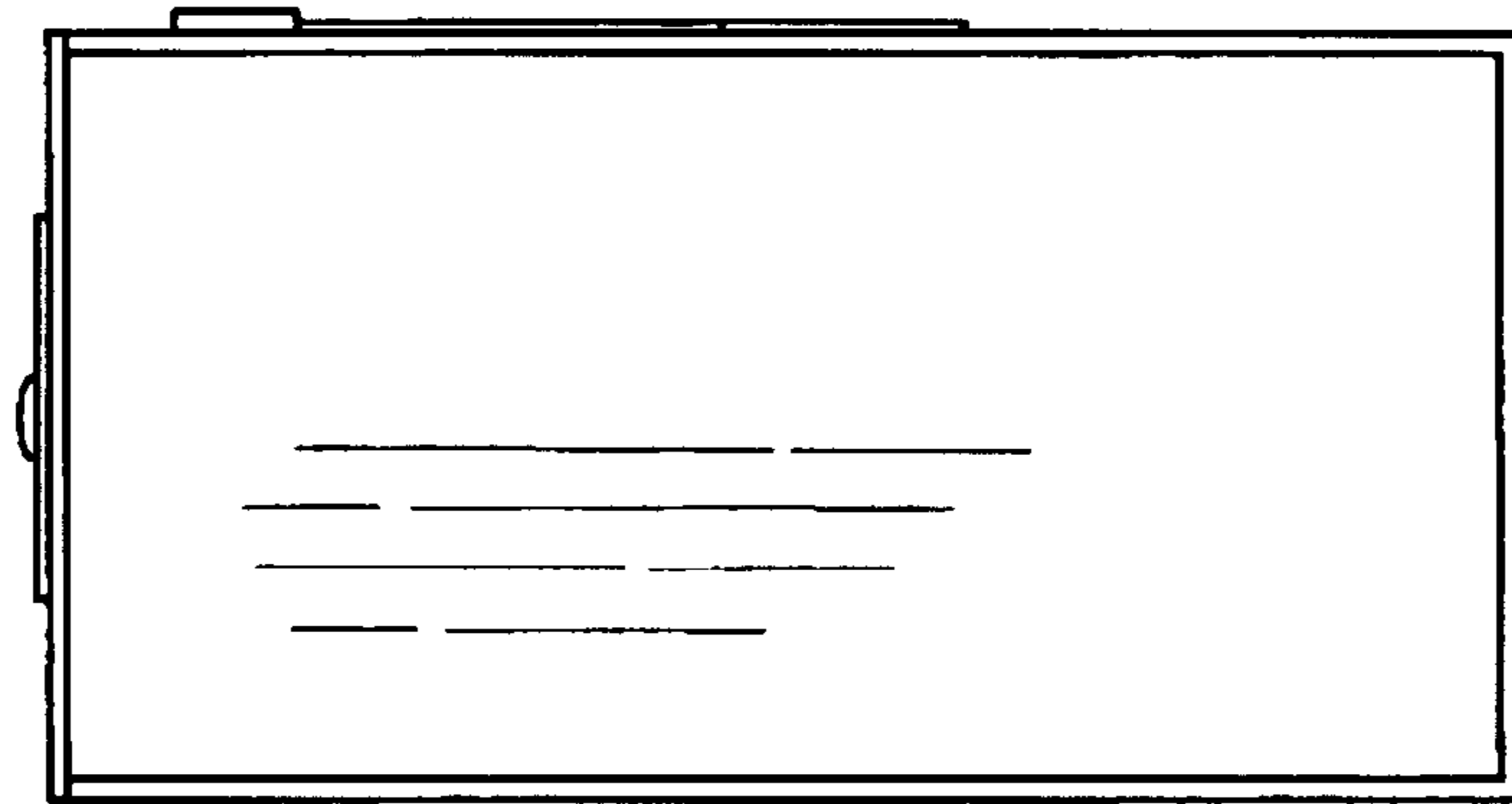

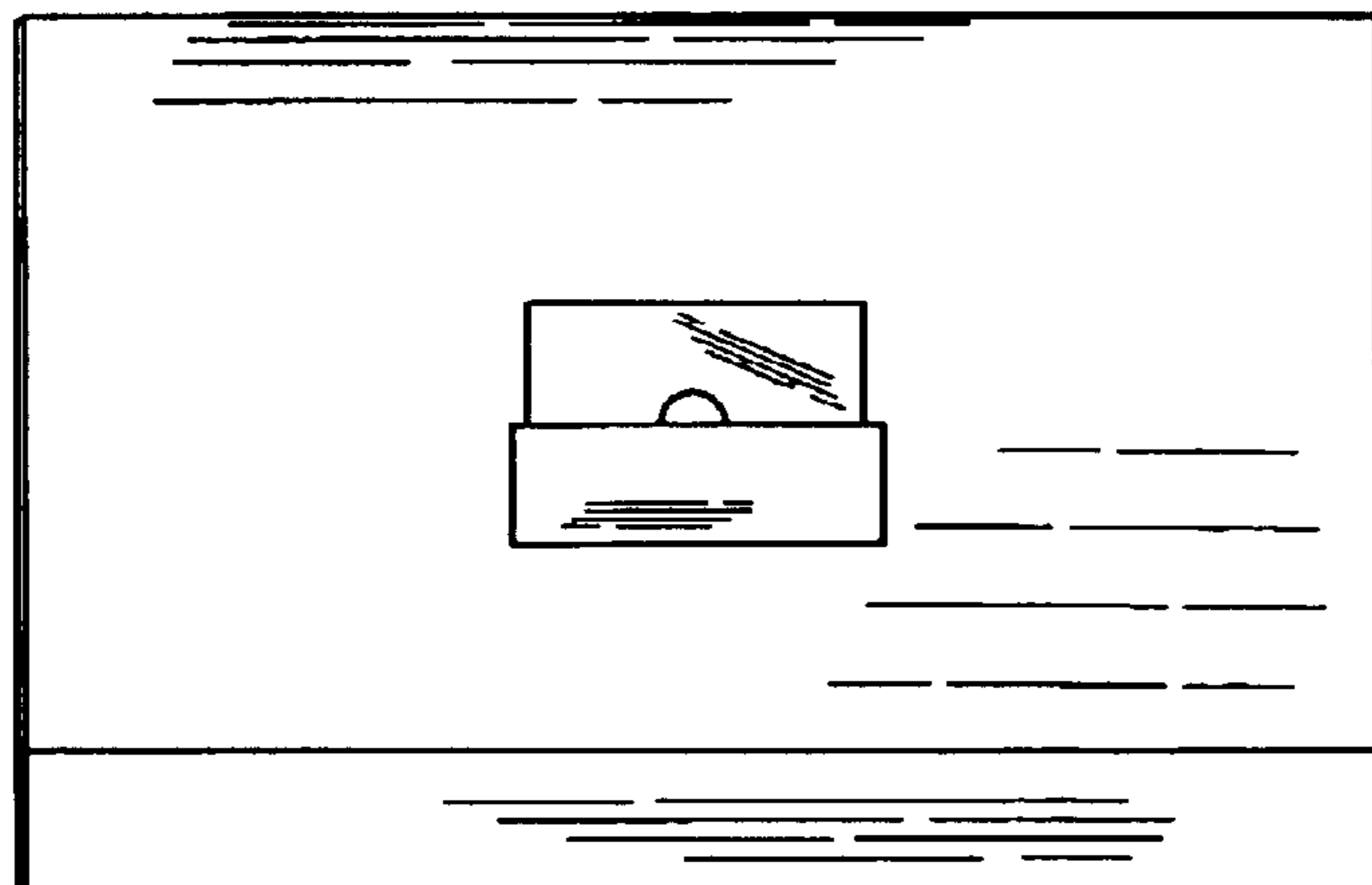
