FIG. 3 is a left-hand side elevational view of my new design;

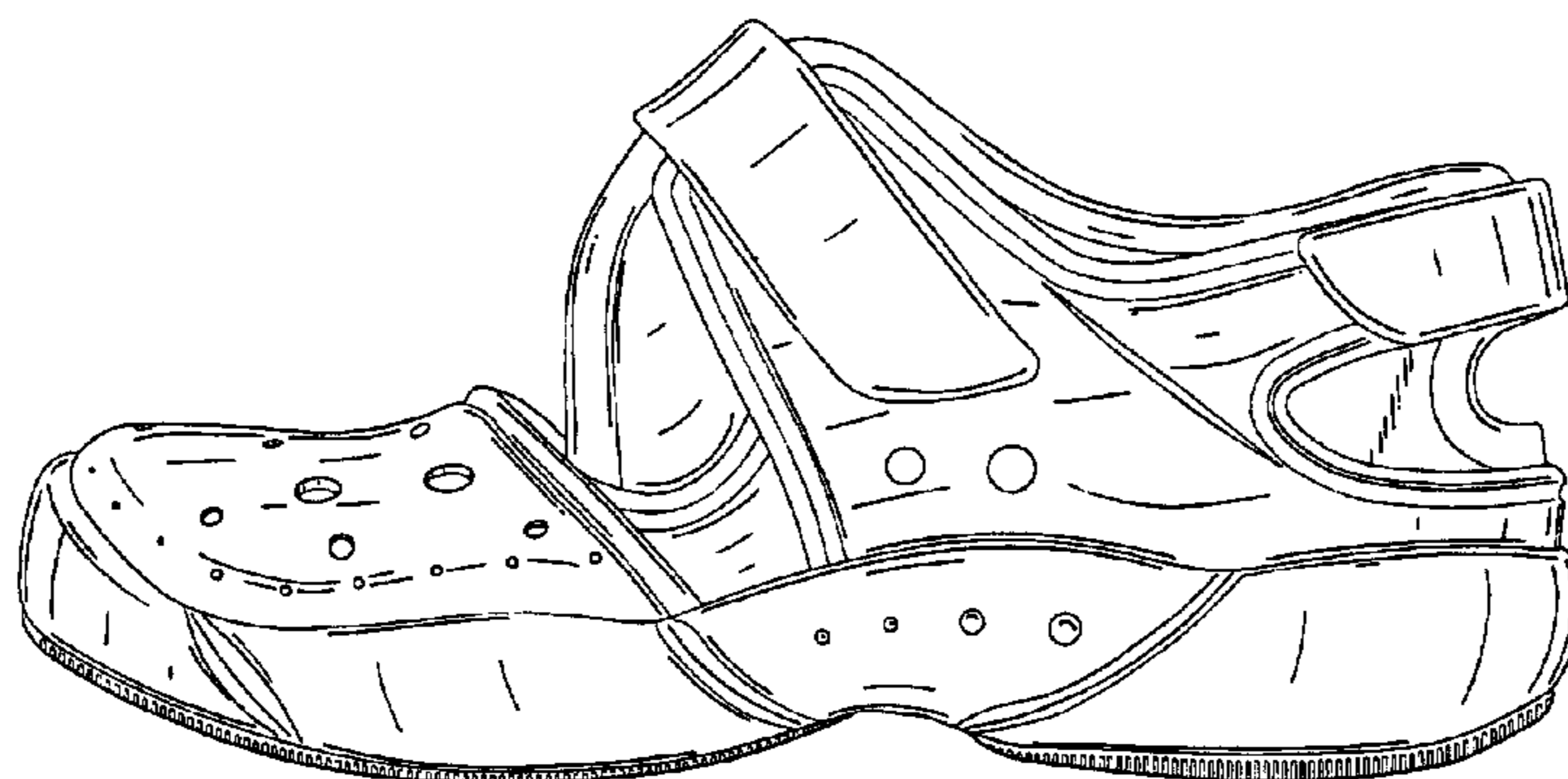
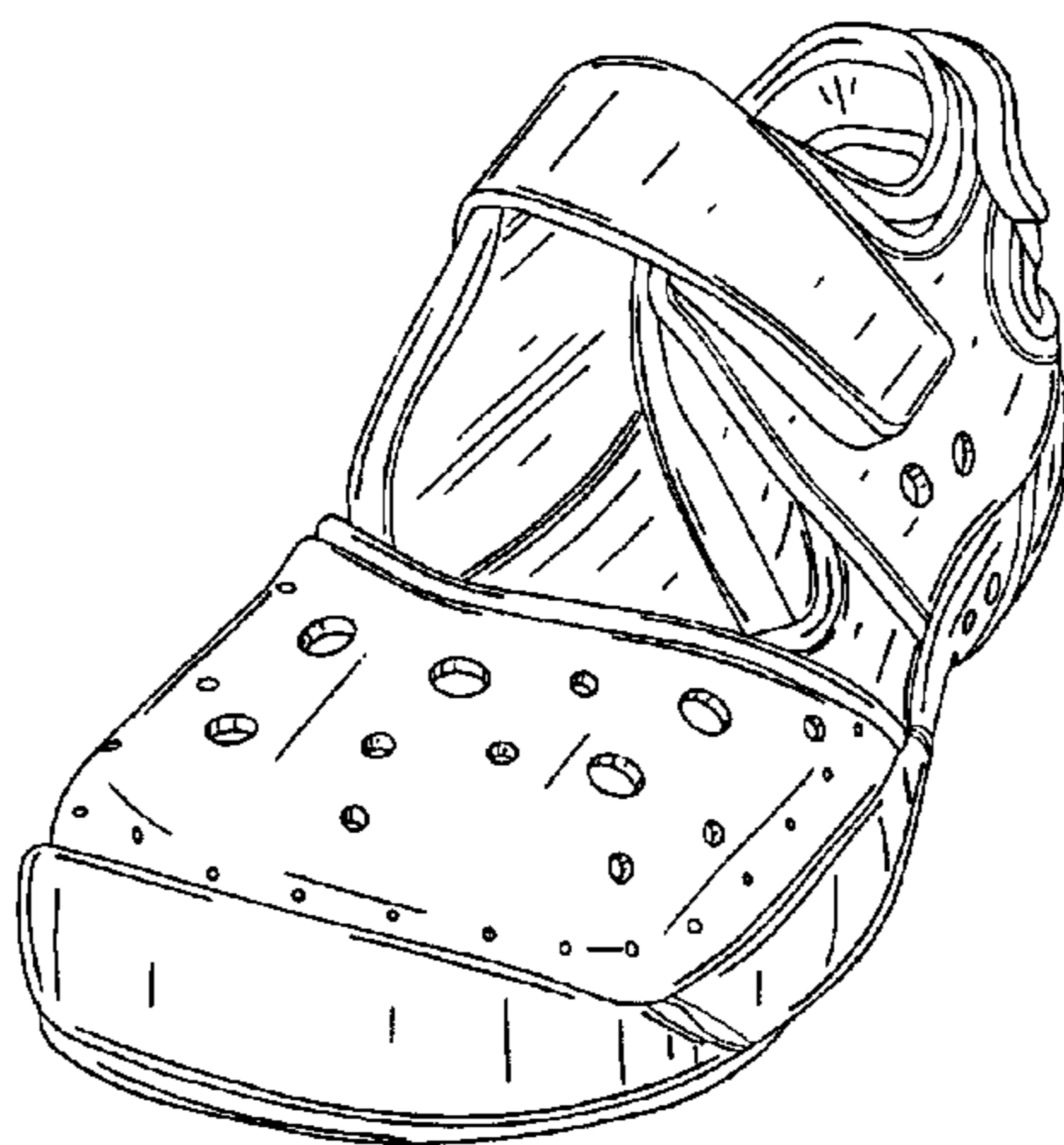
FIG. 4 is a top plan view of my new design;

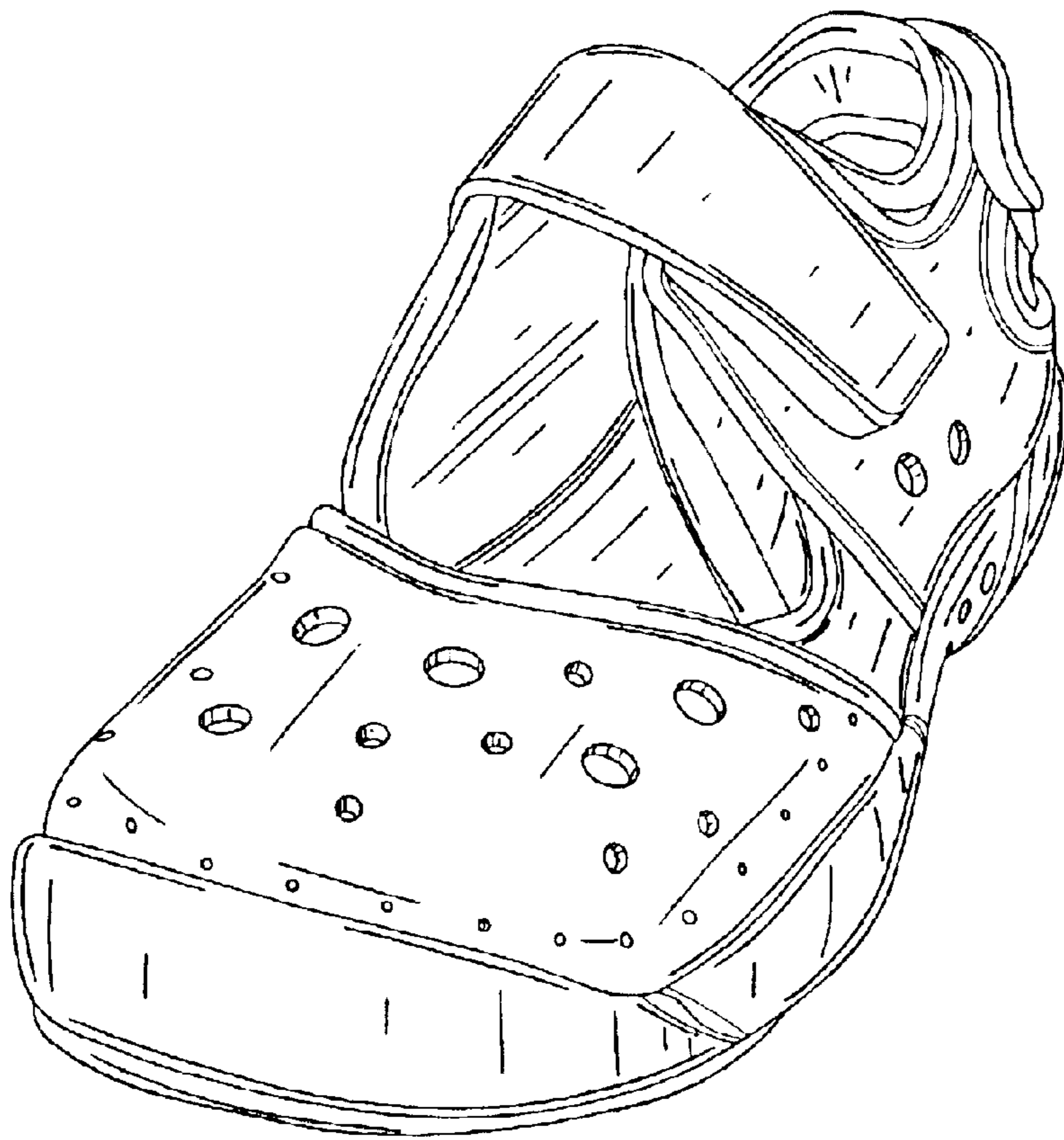

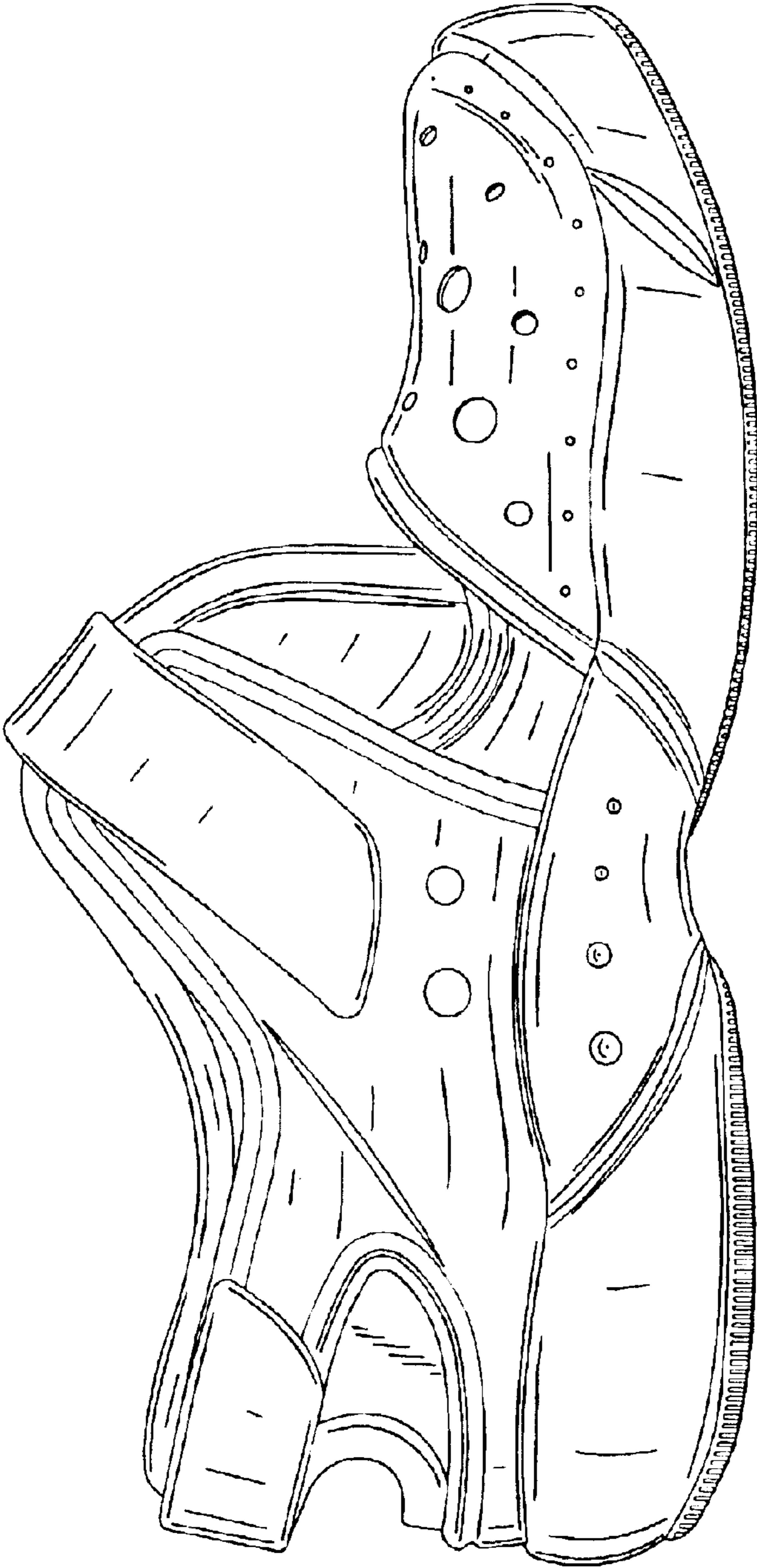

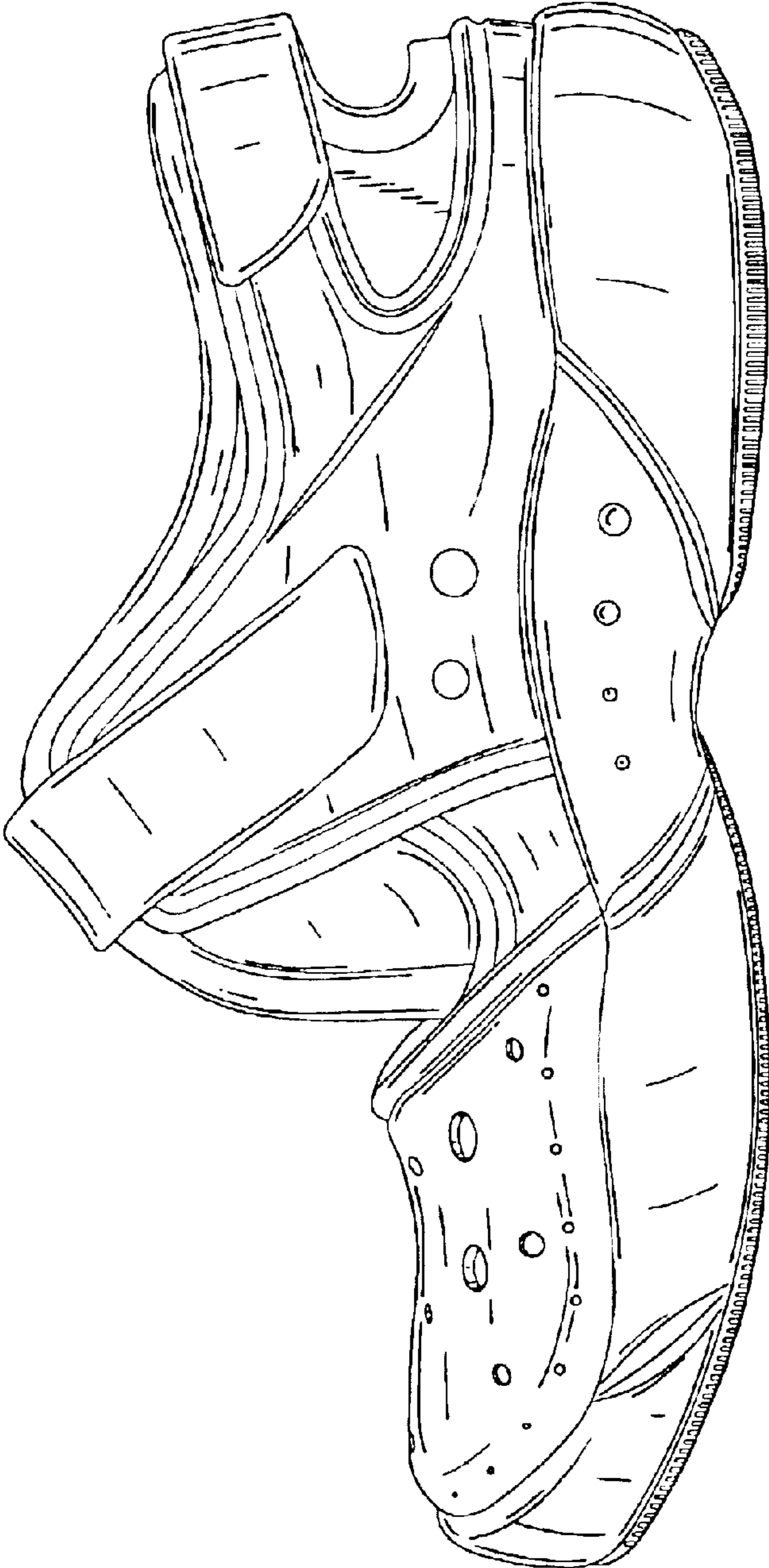

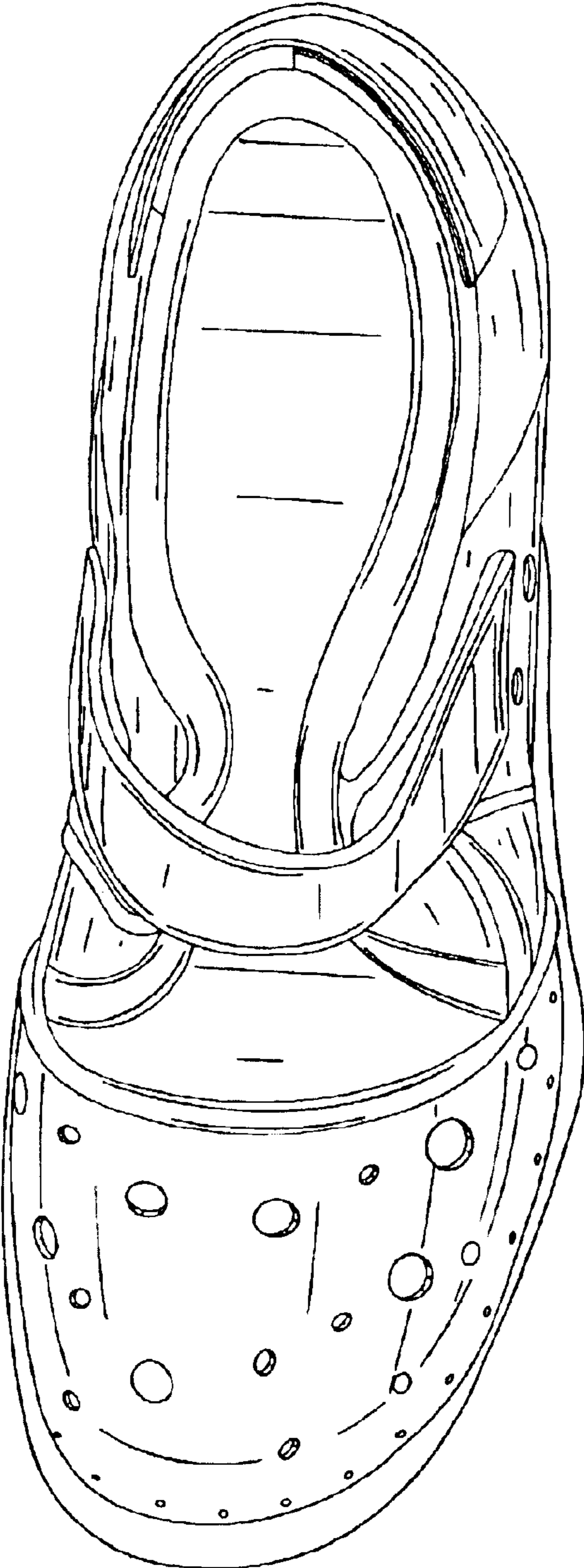

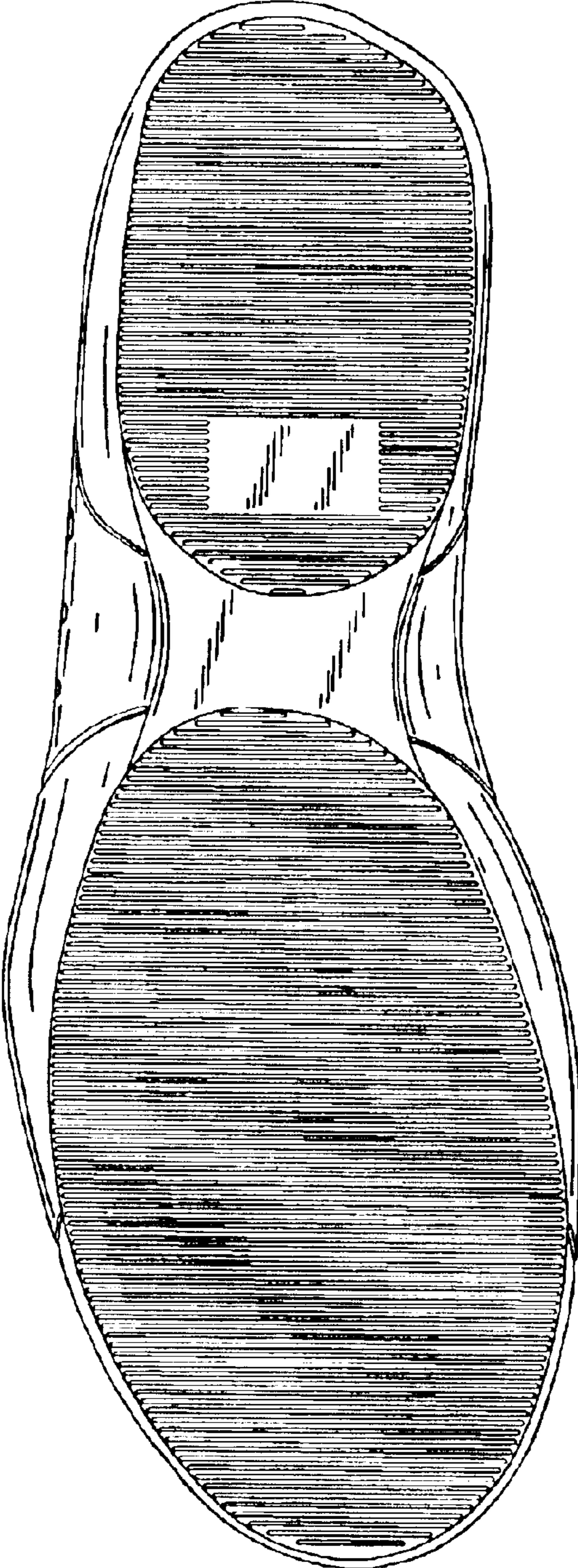

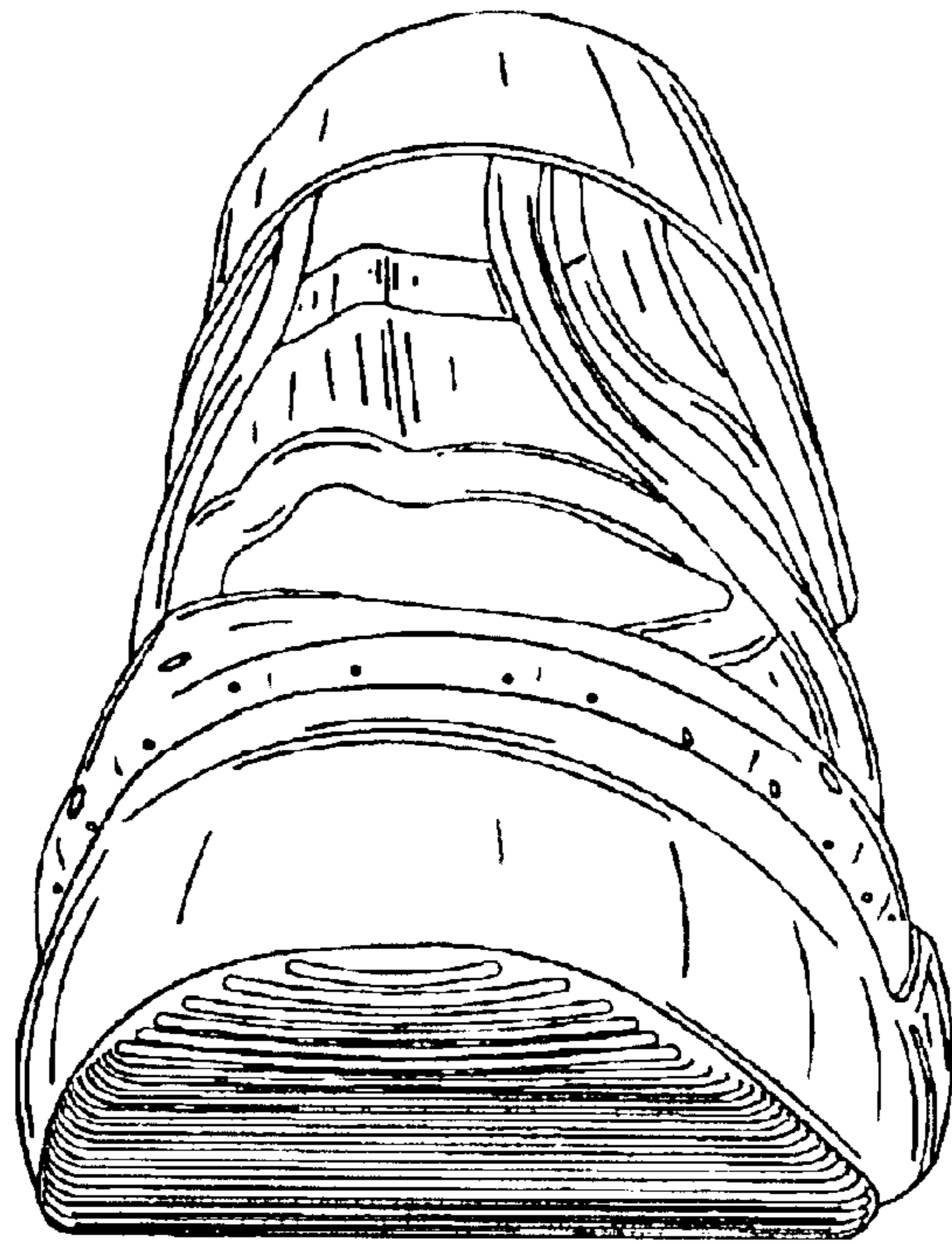

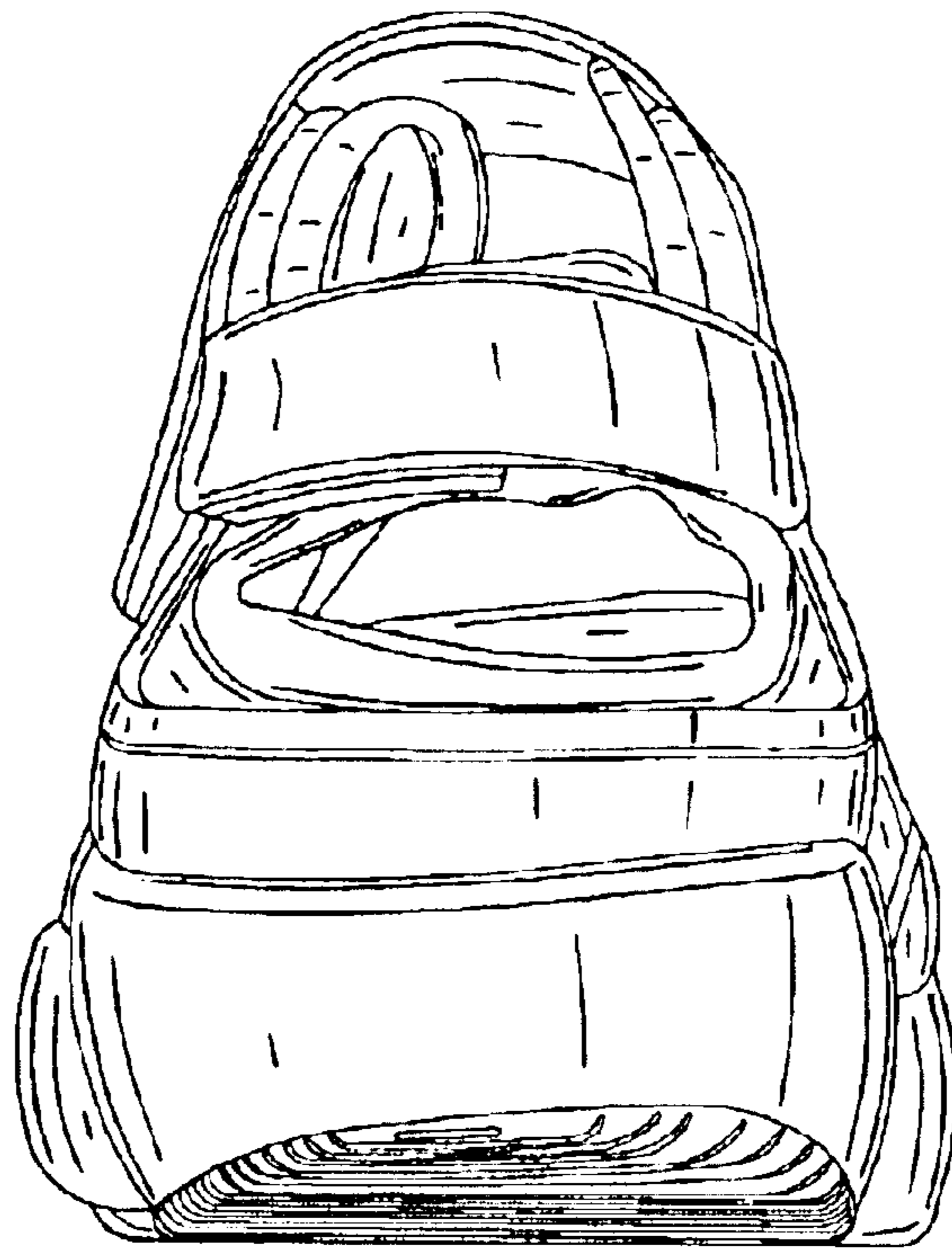
