(57) **CLAIM**

The ornamental design for “handle for article of cookware,”
as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of
my new design for a handle for article of cookware, with the
rear elevational view thereof being a mirror image of FIG.
1;

FIG. 2 is a right-side elevational view thereof;

FIG. 3 is a left-side elevational view thereof;

FIG. 4 is a top plan view thereof; and

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a front elevational view of a second embodiment
of my new design for a handle for article of cookware, with
the rear elevational view thereof being a mirror image of
FIG. 6;

FIG. 7 is a right-side elevational view thereof;

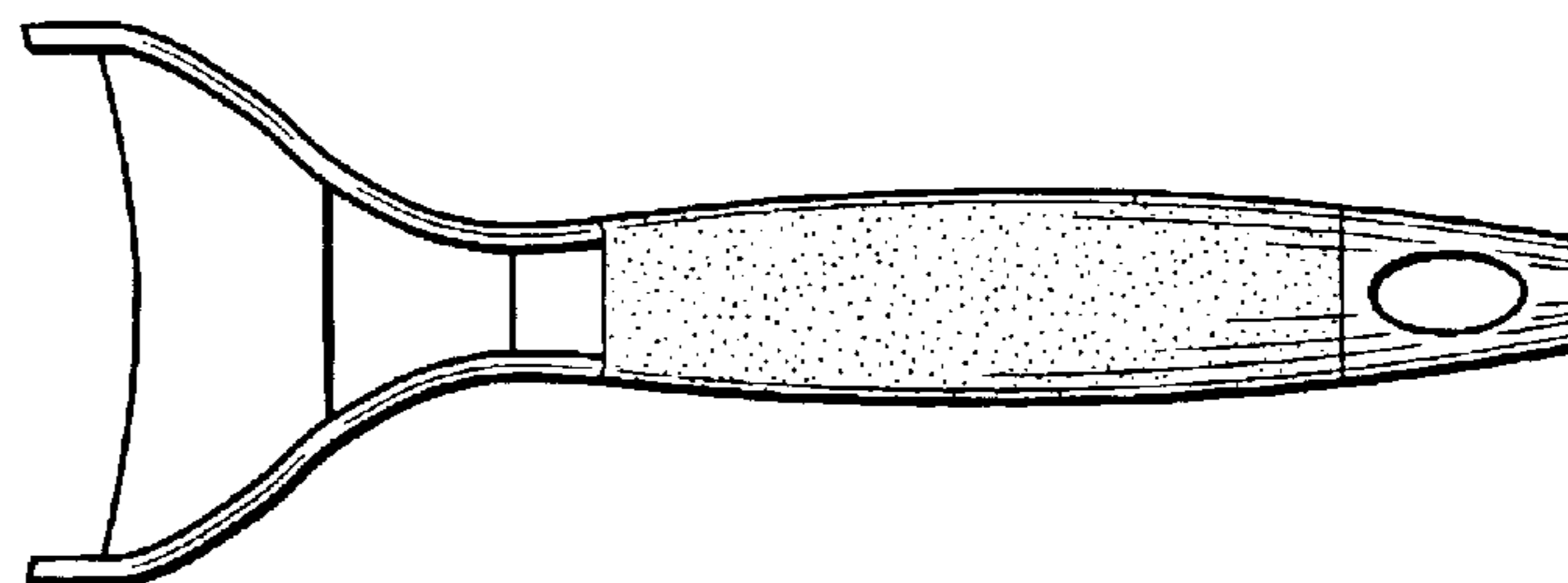
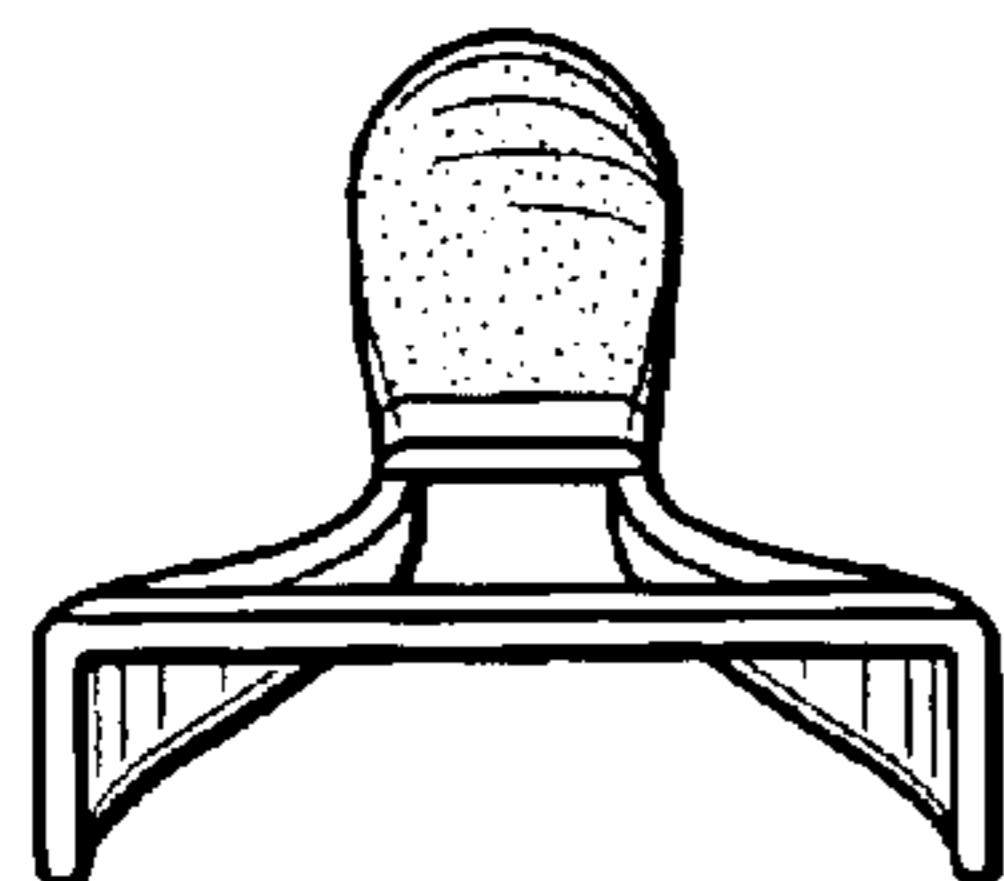
FIG. 8 is a left-side elevational view thereof;

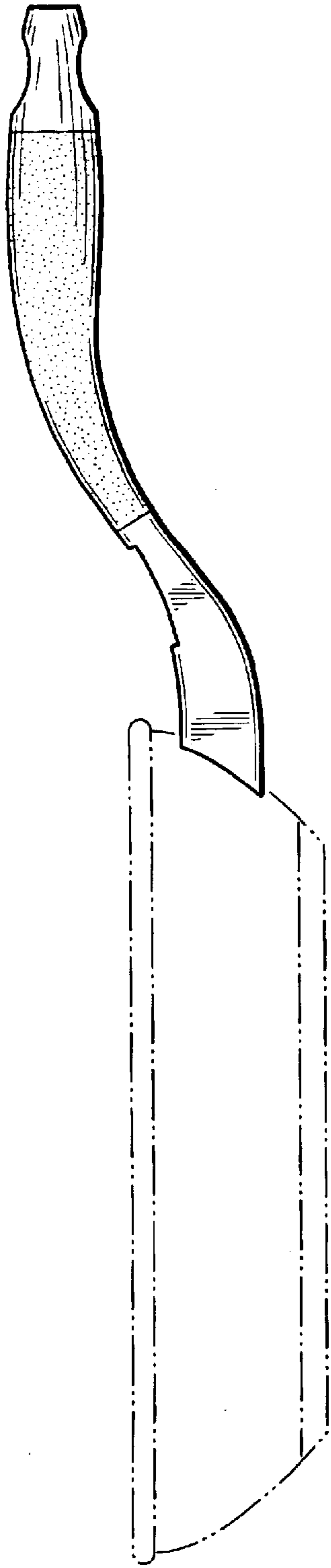

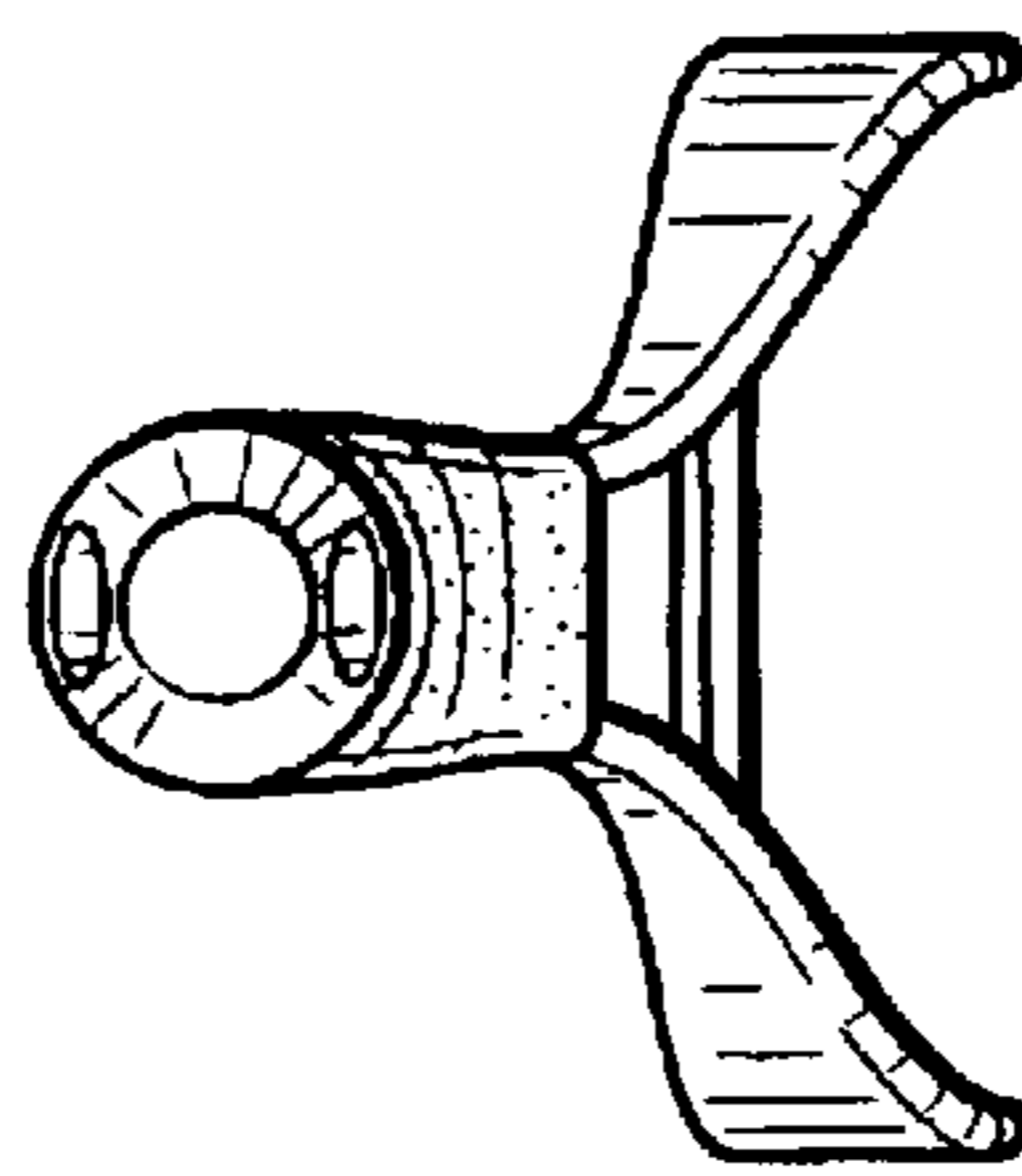

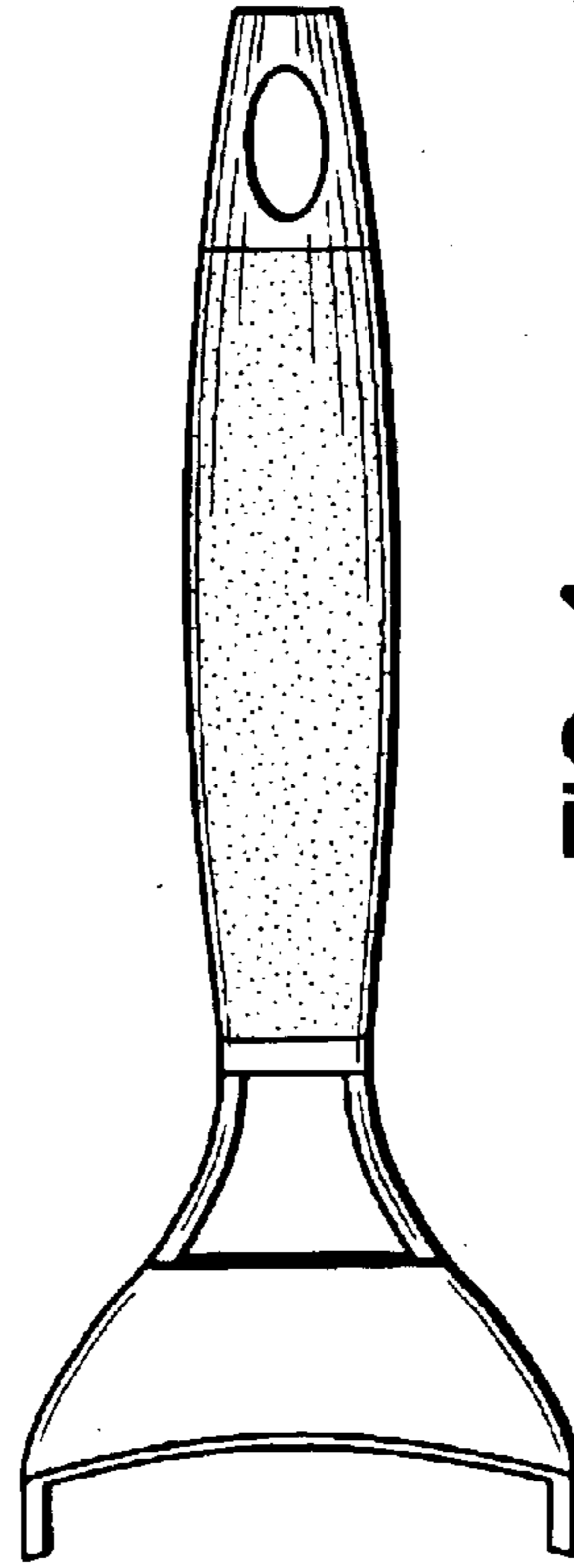

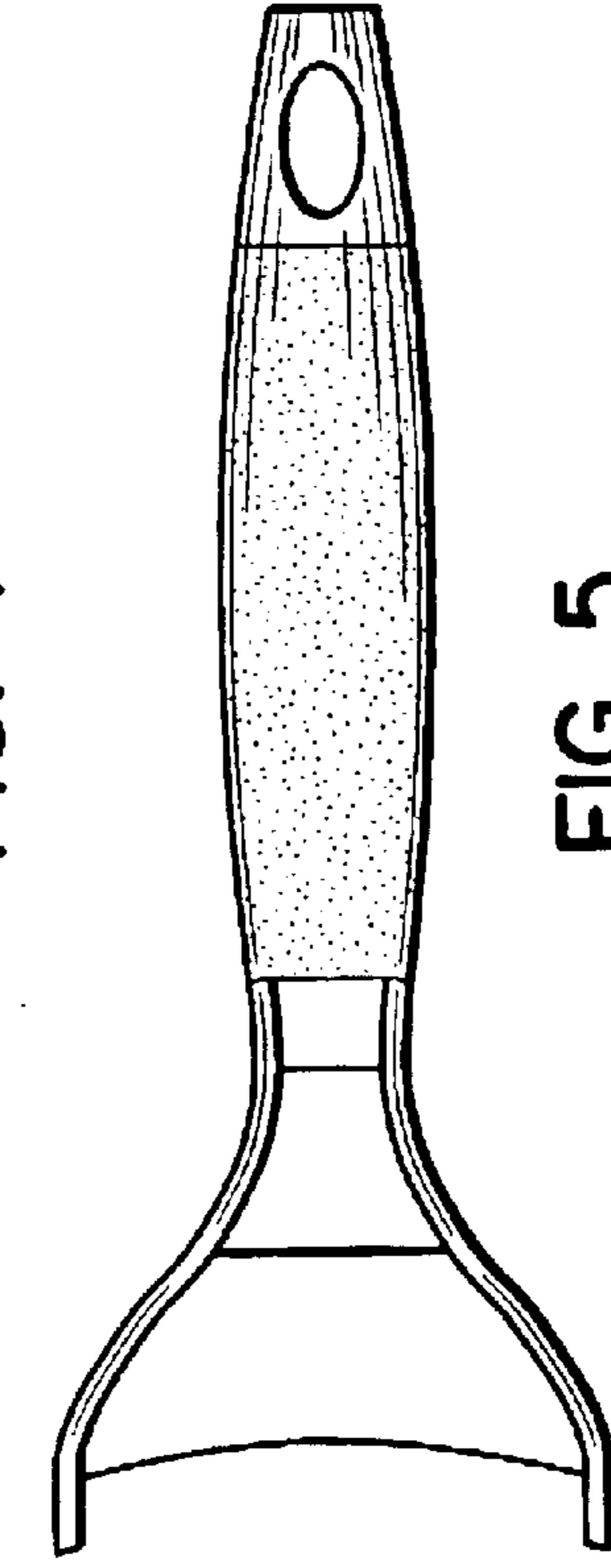

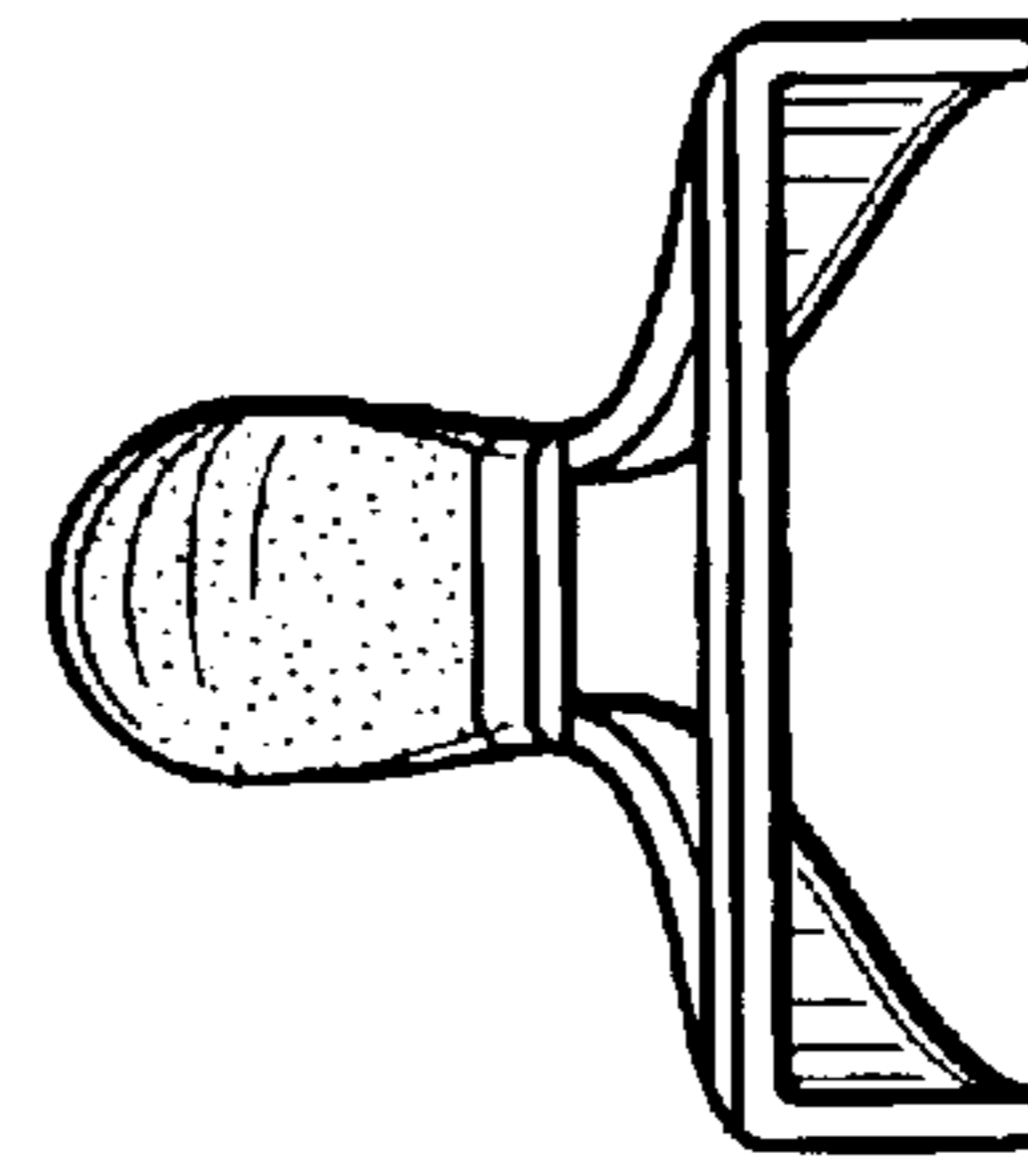

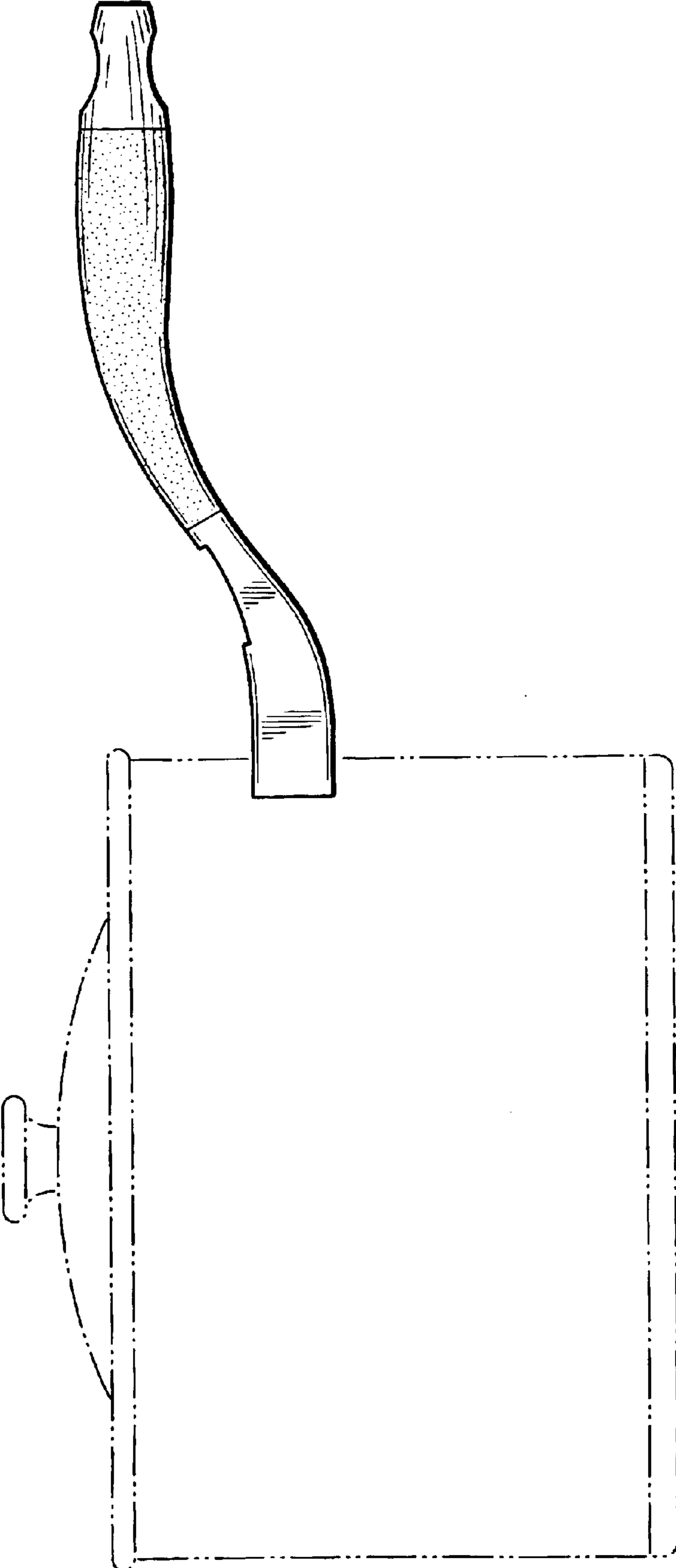

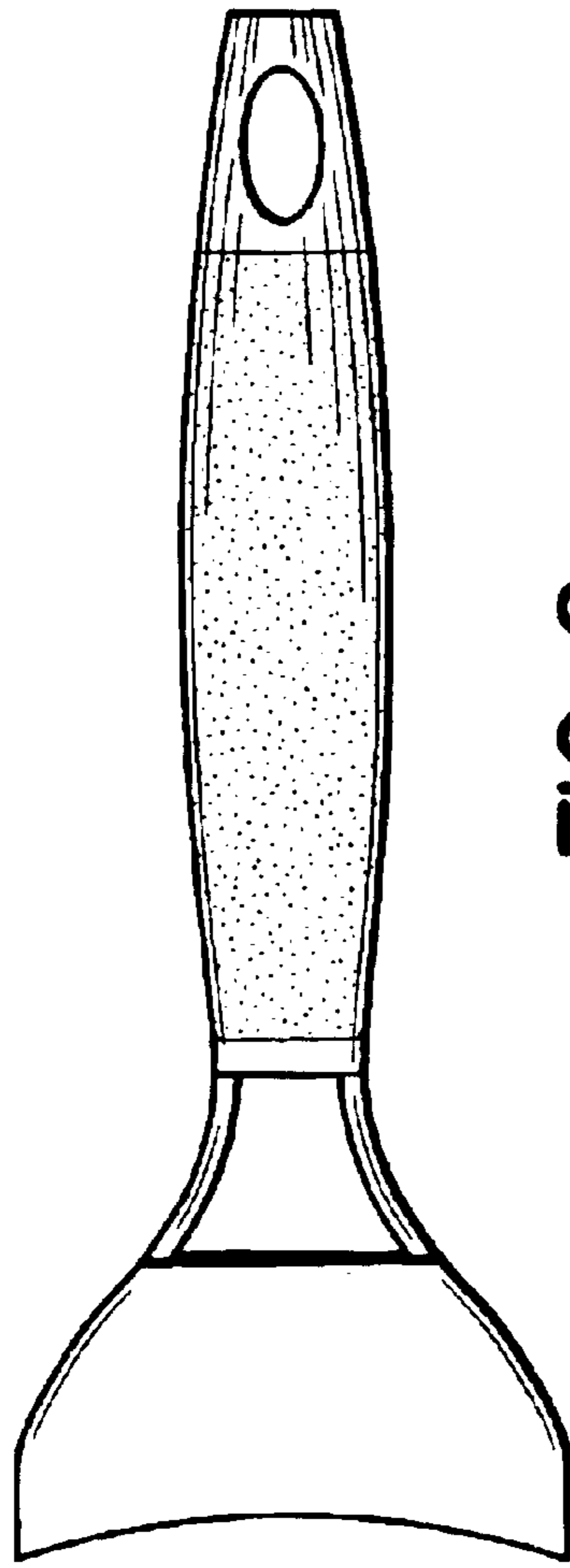

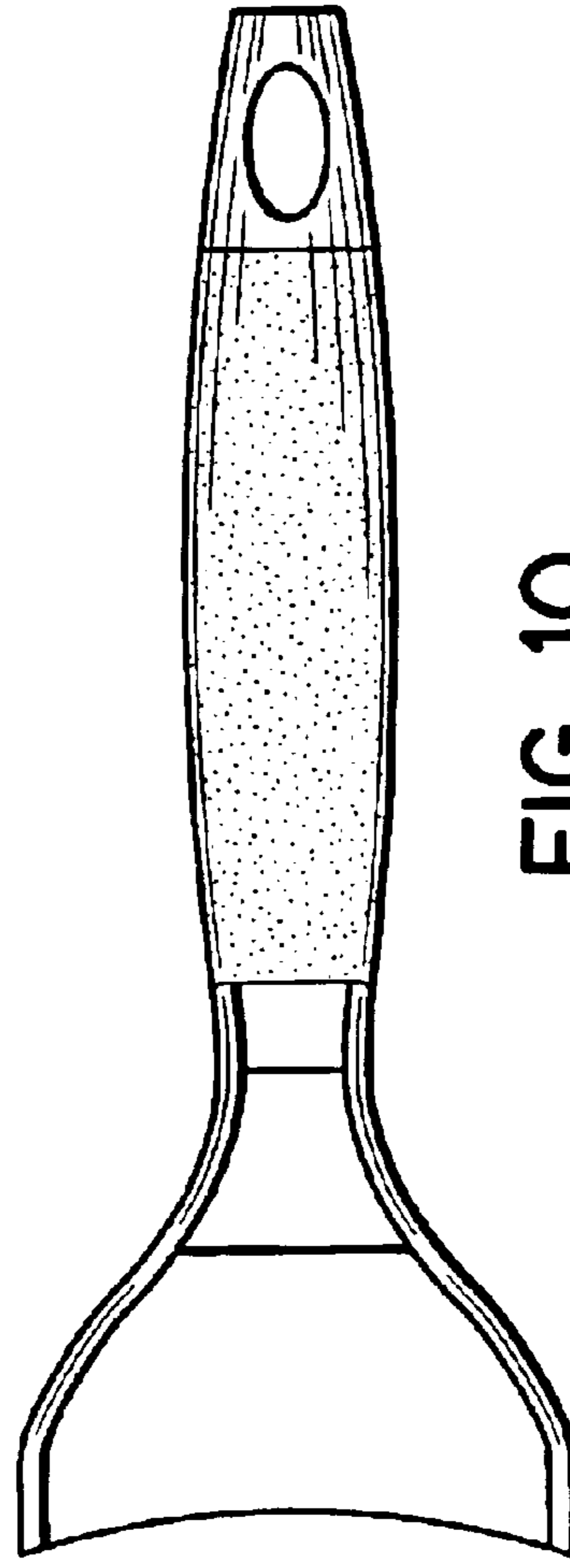

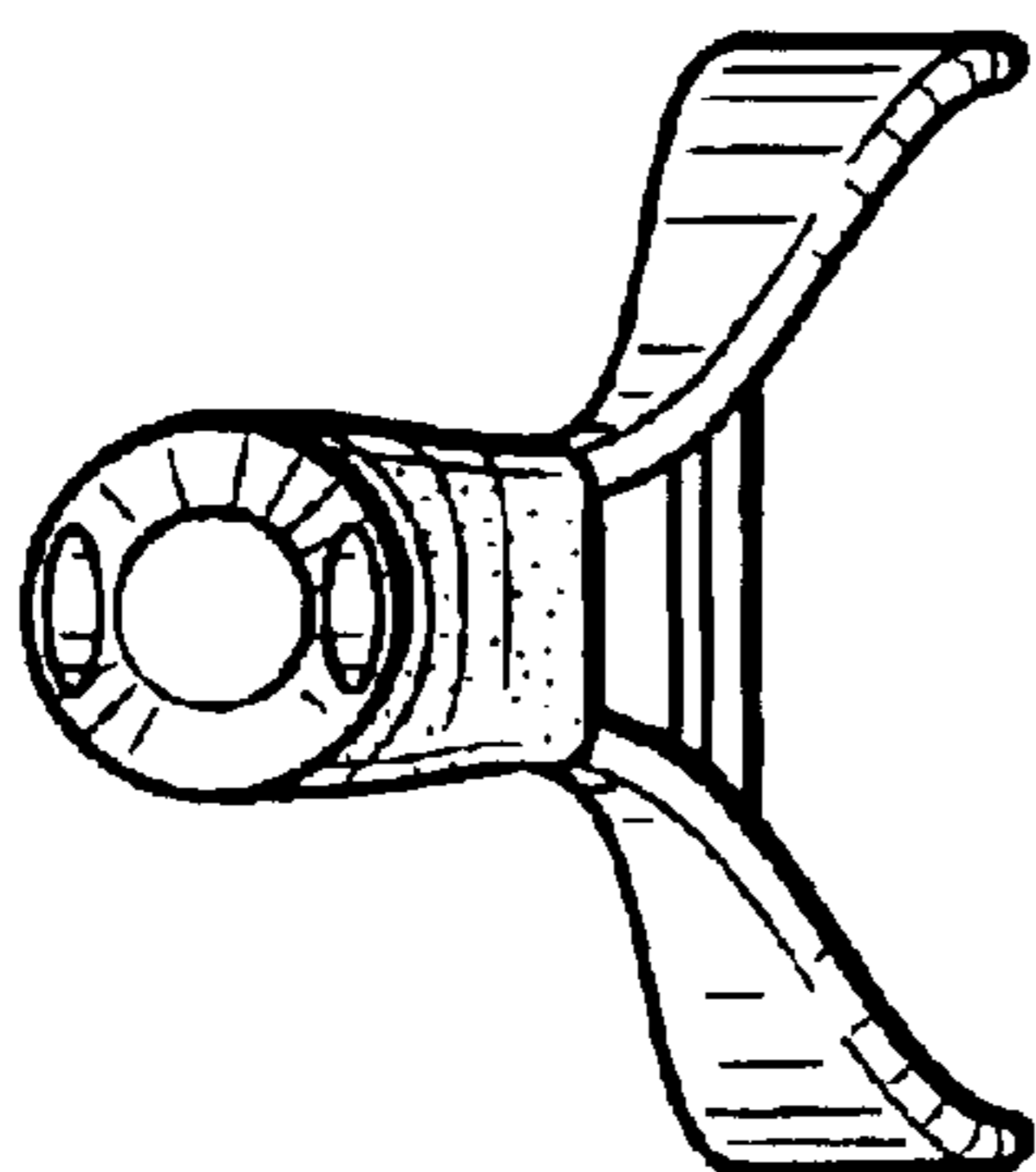

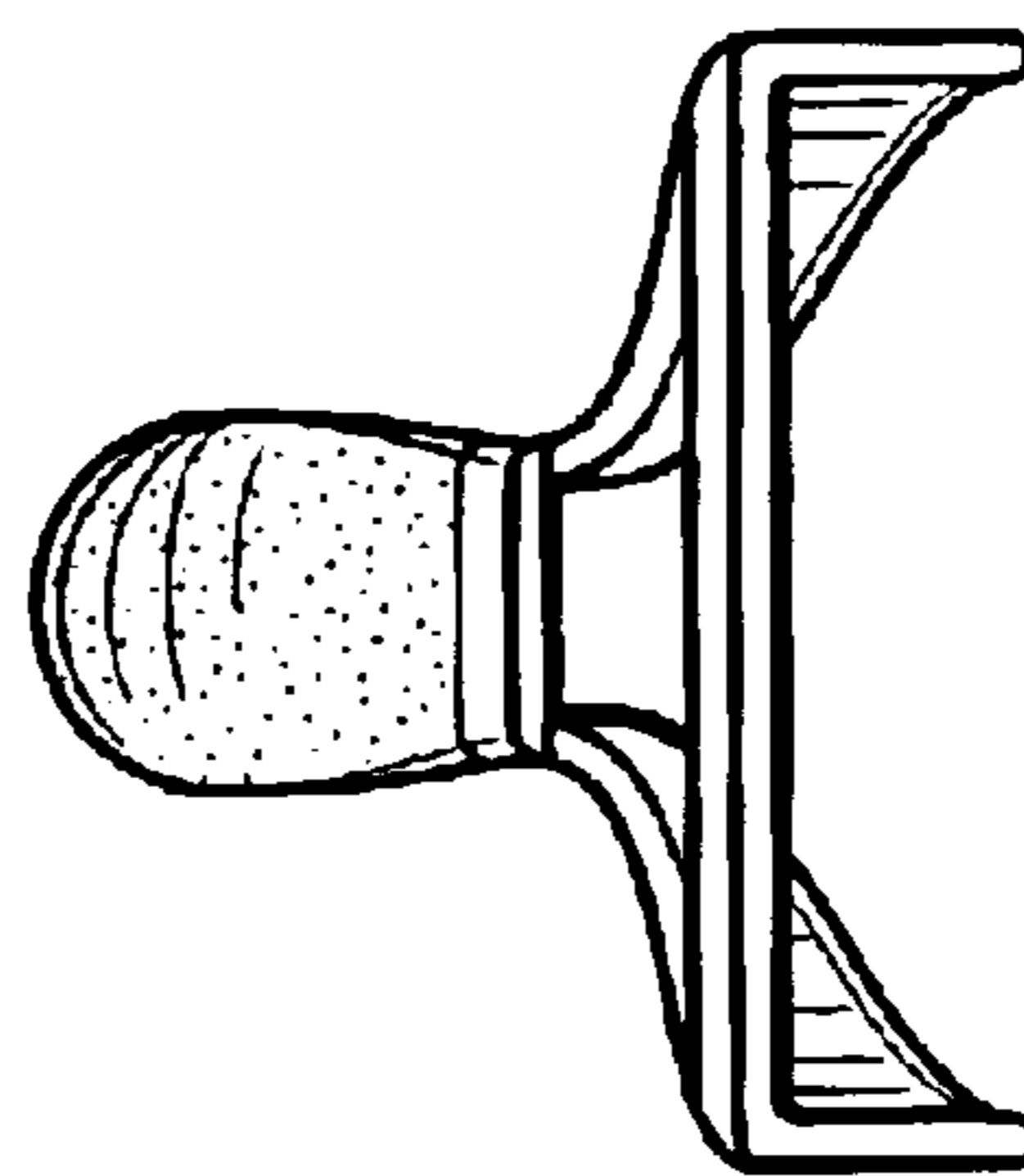
