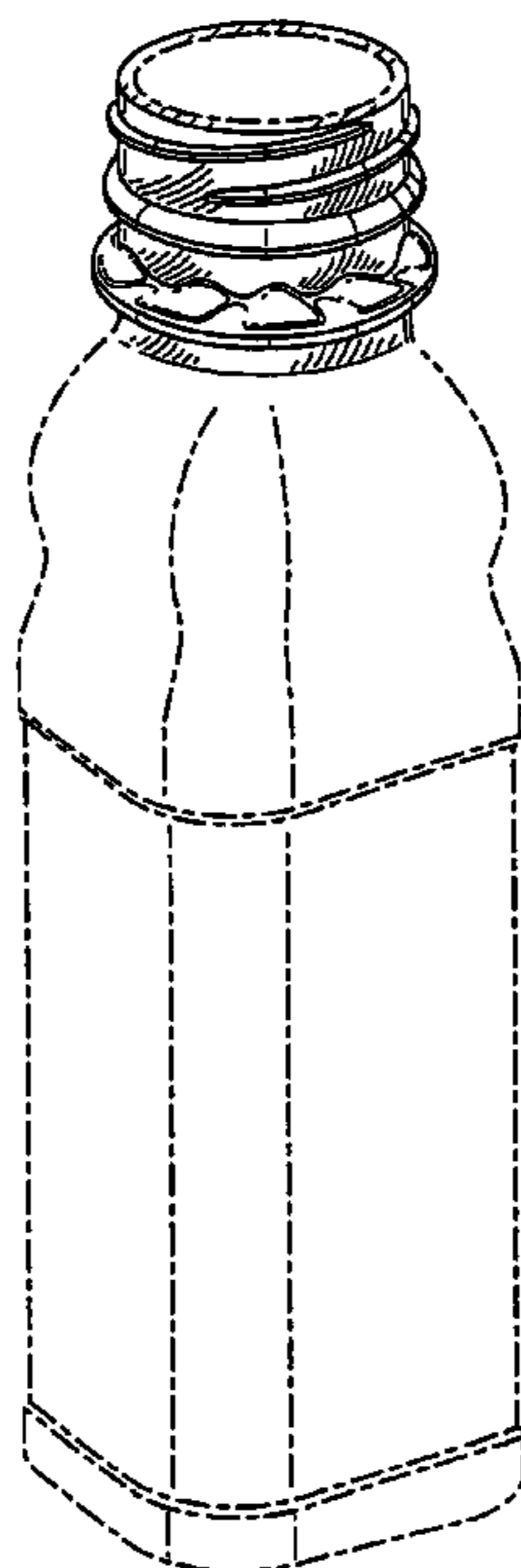

DESCRIPTION

FIG. 1 is a top, front, right perspective view of a plastic container beaded neck according to the present invention; FIG. 2 is a front view of the plastic container beaded neck; FIG. 3 is rear view of the plastic container beaded neck; FIG. 4 is a right side view of the plastic container beaded neck; FIG. 5 is a left side view of the plastic container beaded neck; and, FIG. 6 is a top view of the plastic container beaded neck. The broken lines shown in the drawings are for illustrative purposes only and form no part of the claimed design.

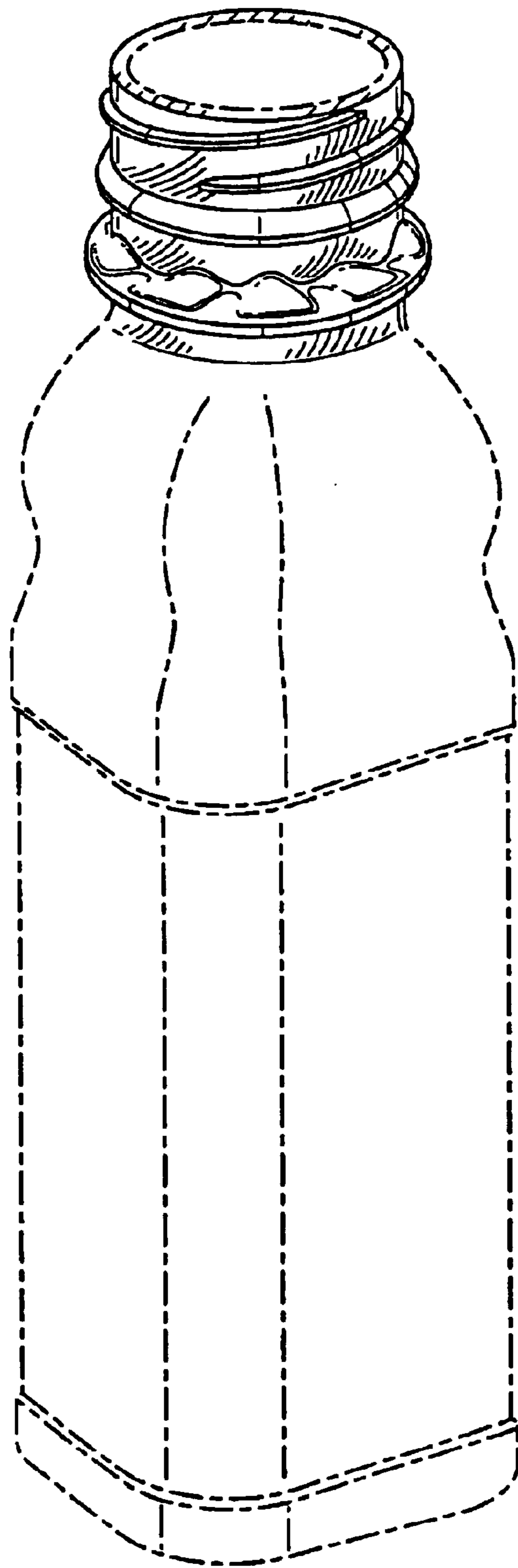

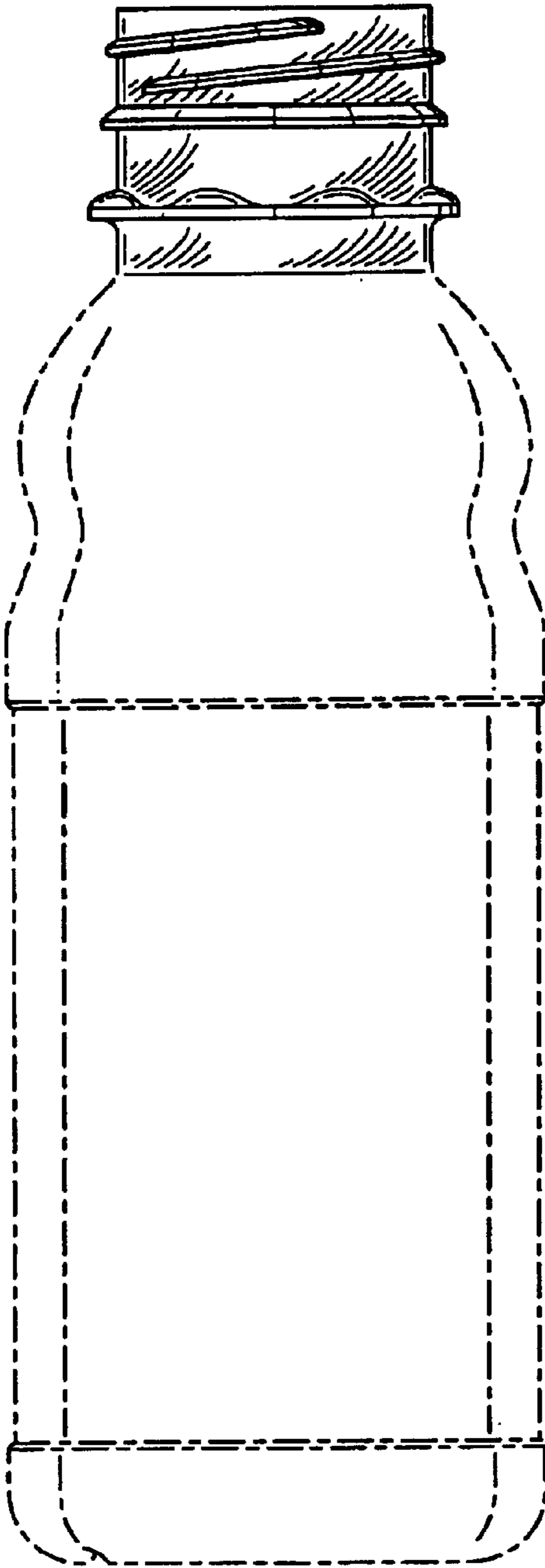

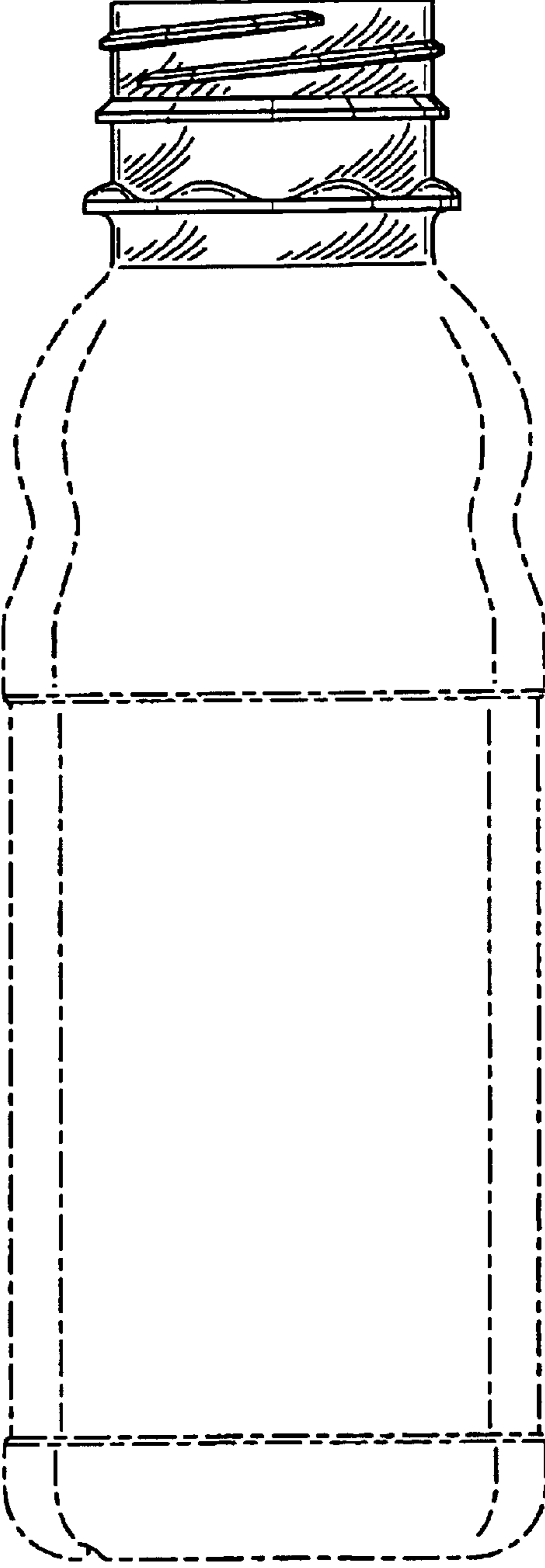

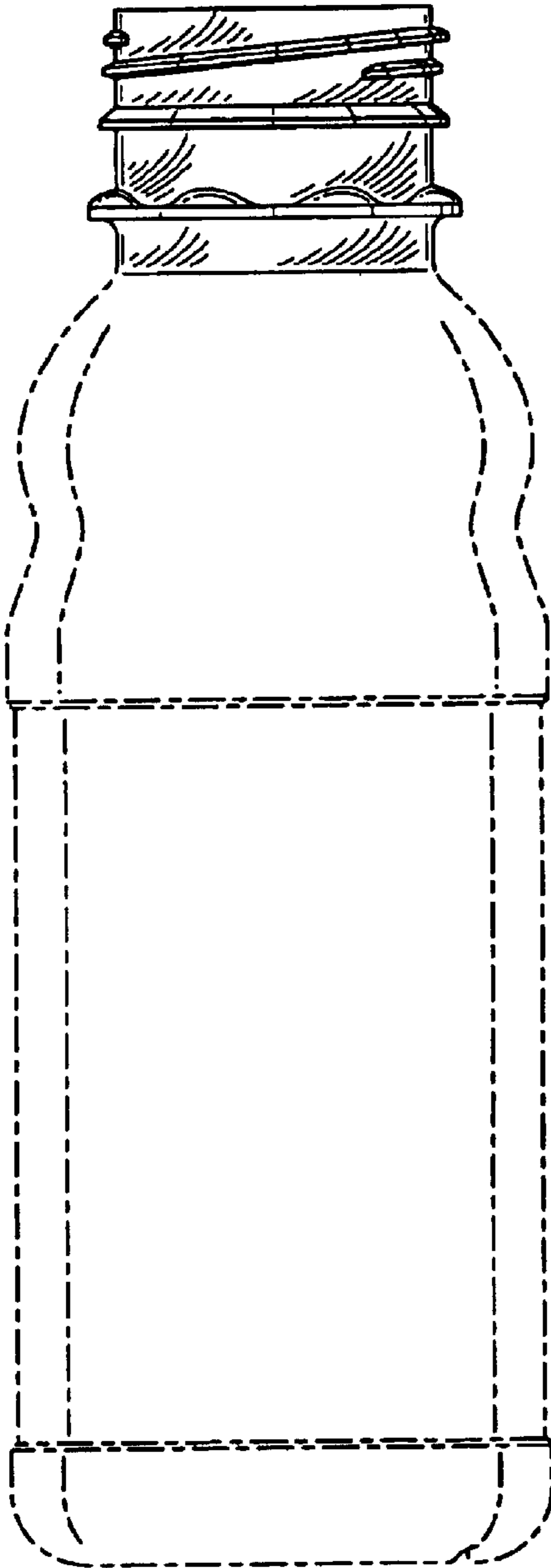

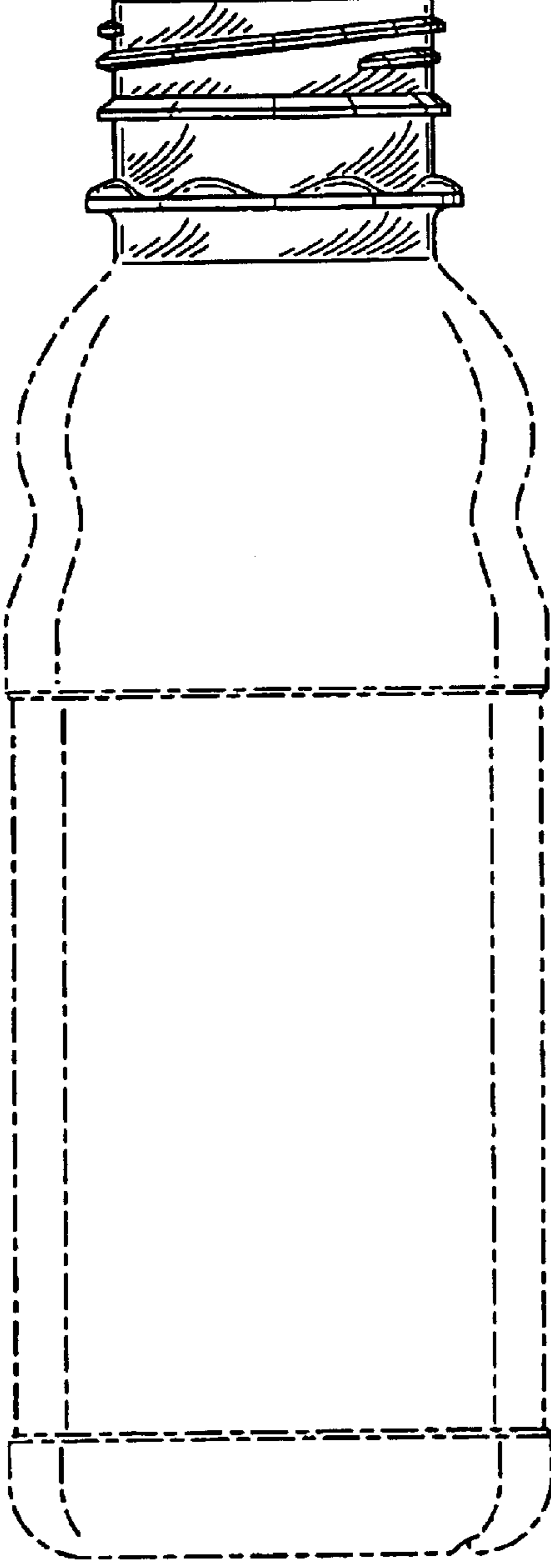

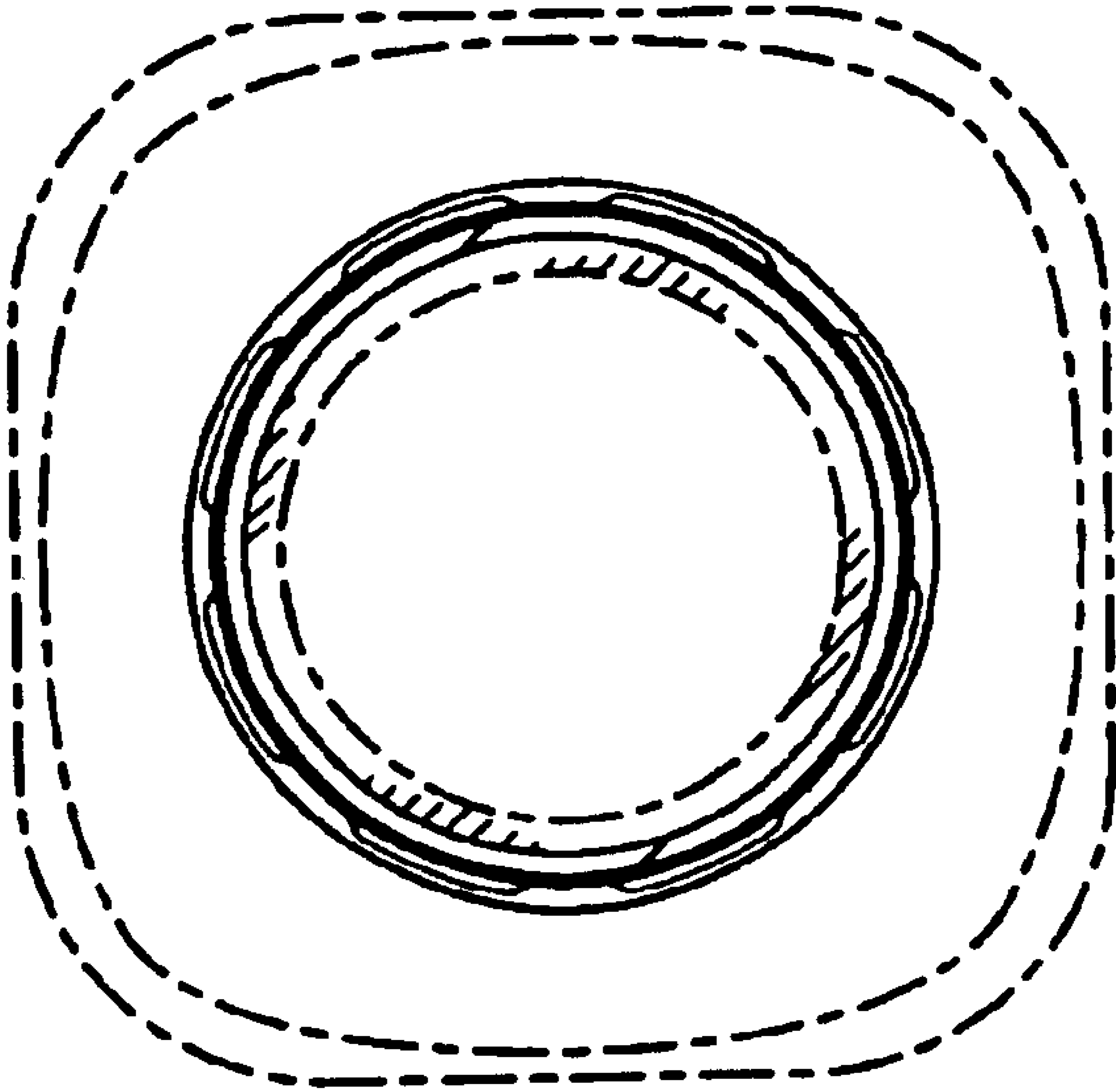
