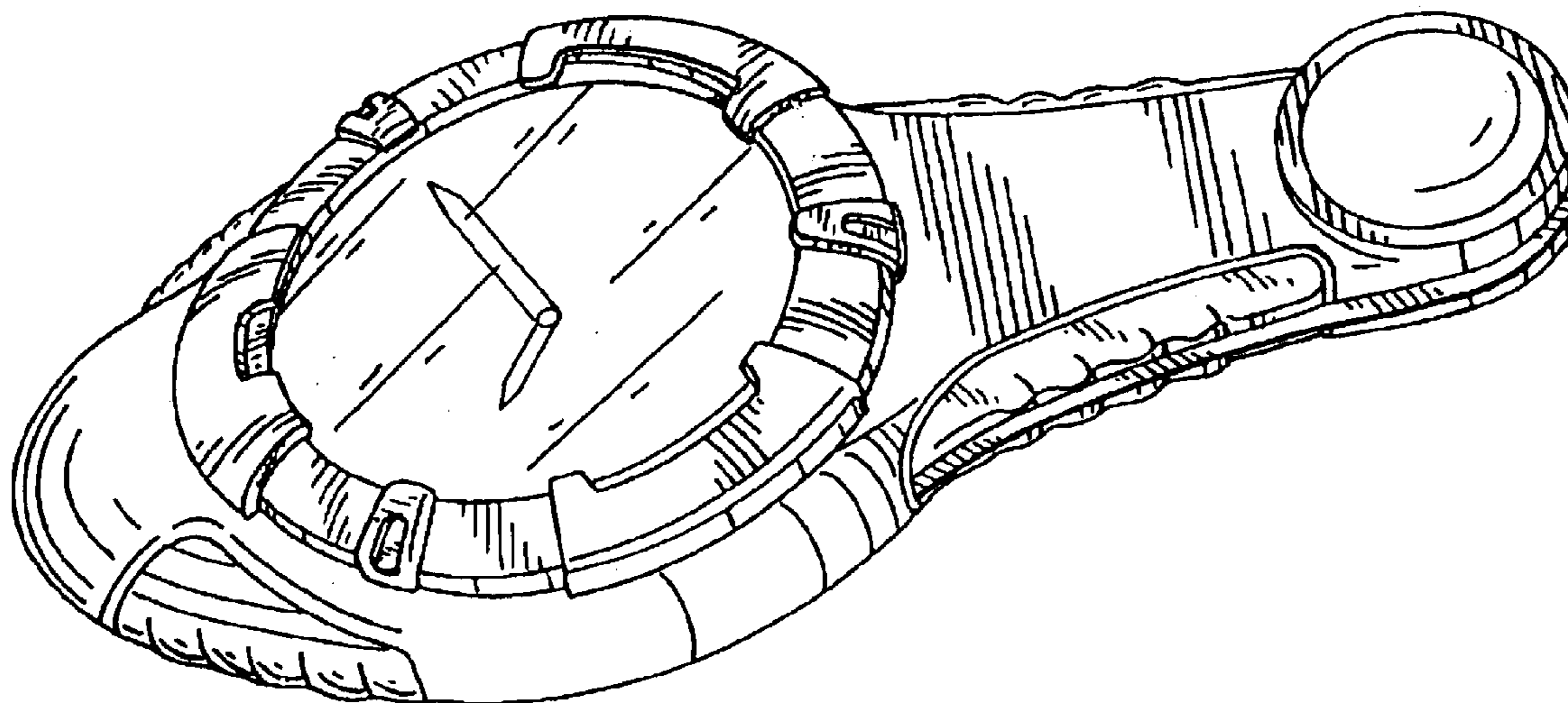
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an upper side perspective view of the timepiece; FIG. 2 is a top plan view thereof; FIG. 3 is a side elevational view thereof, the opposite side being identical; FIG. 4 is a bottom view thereof; FIG. 5 is a left hand end view thereof; and, FIG. 6 is a right hand end view thereof.

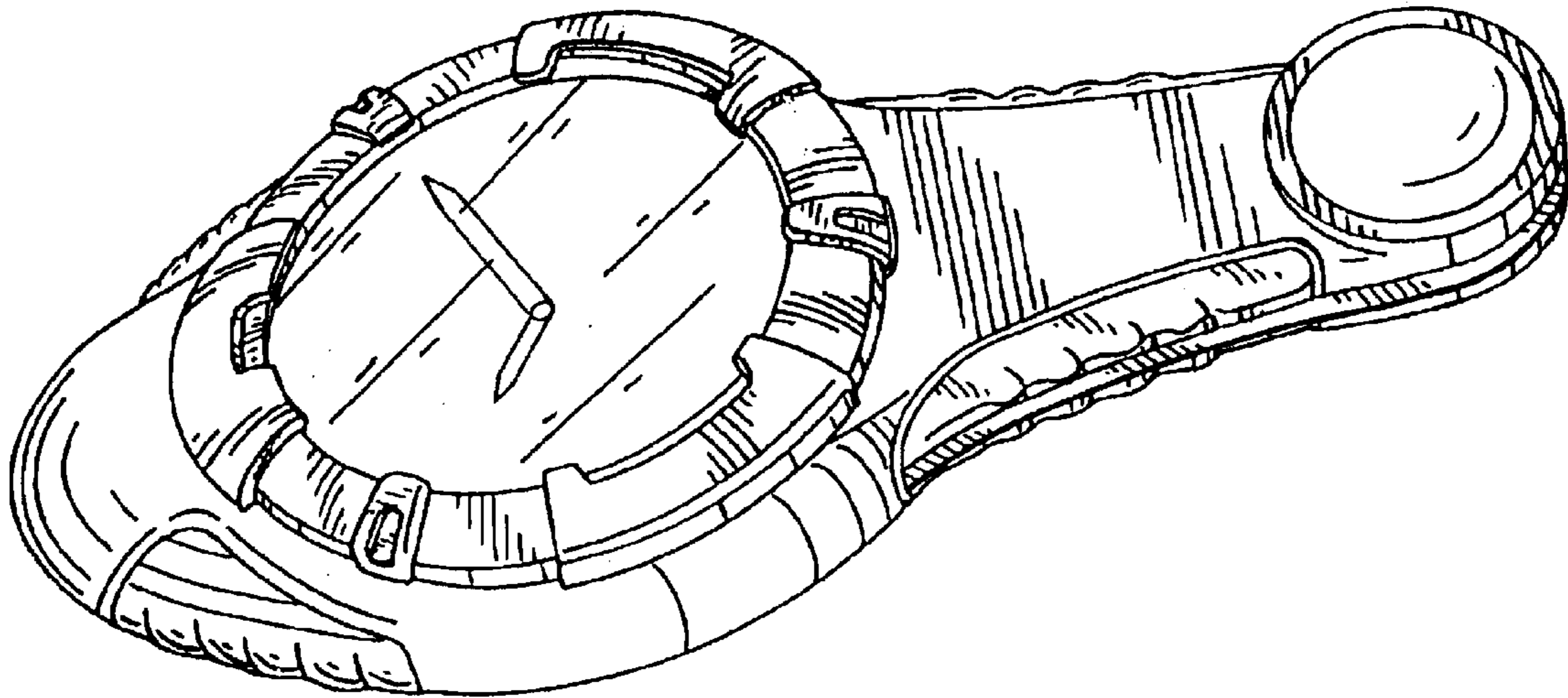

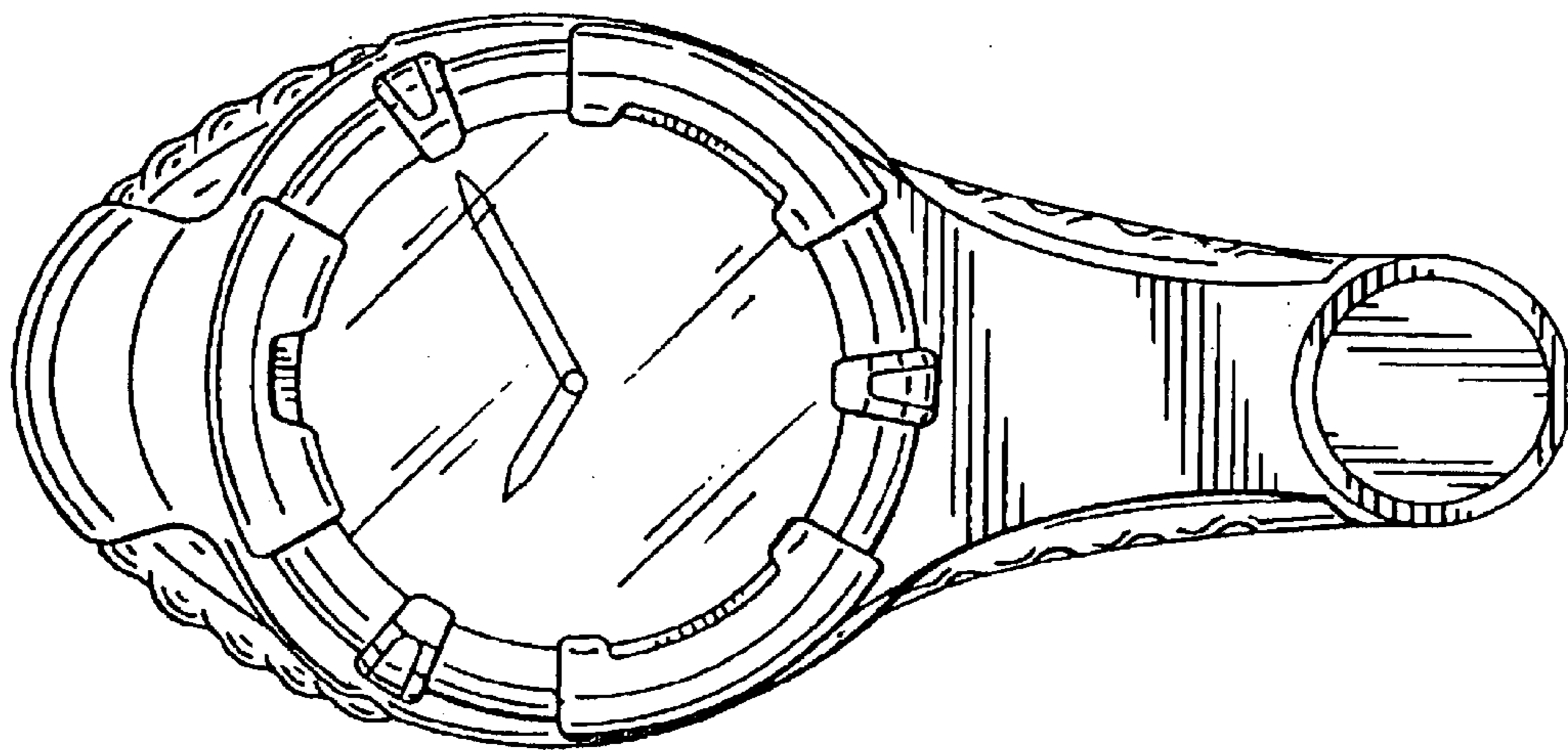

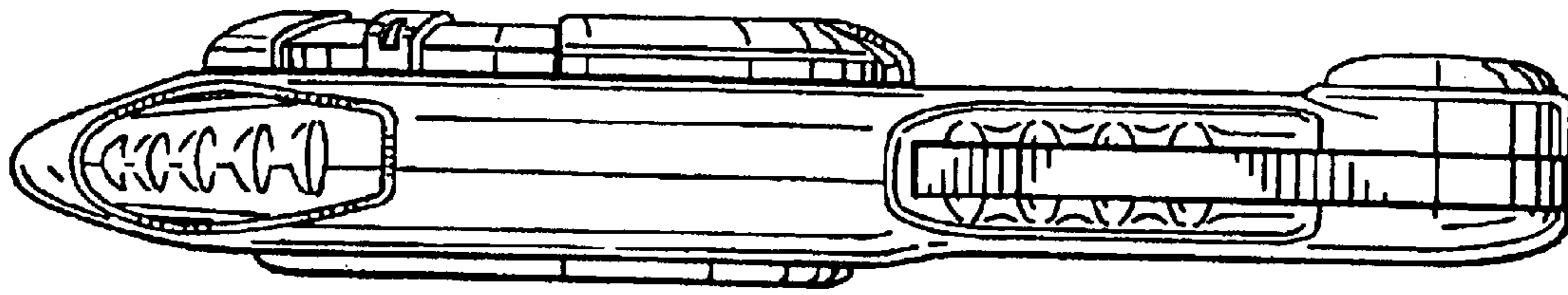

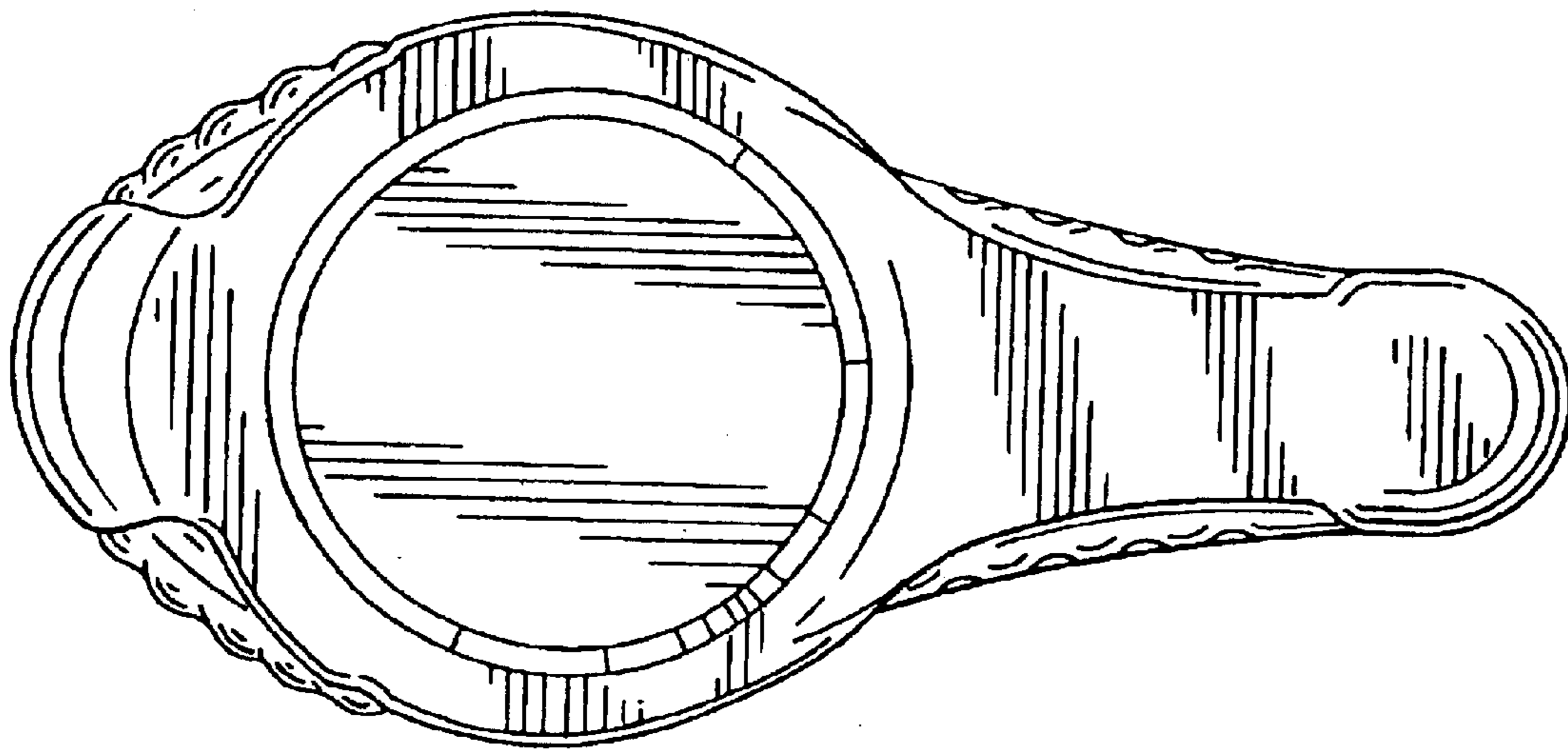

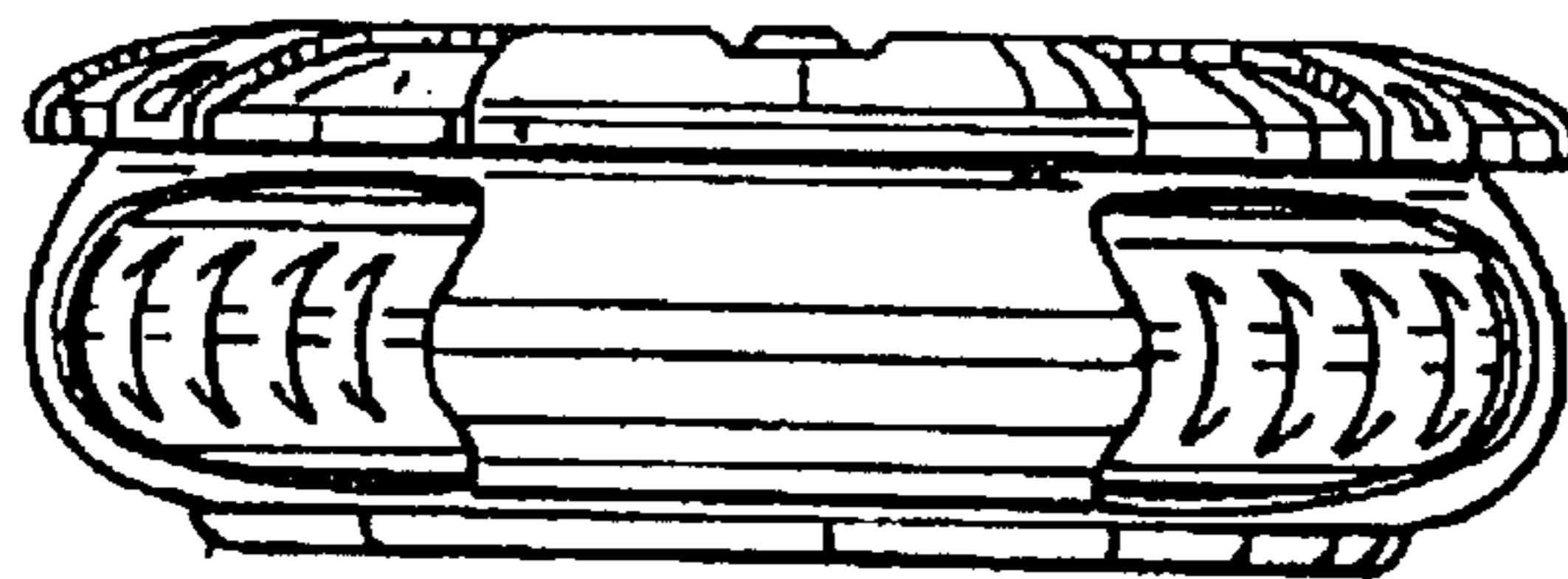

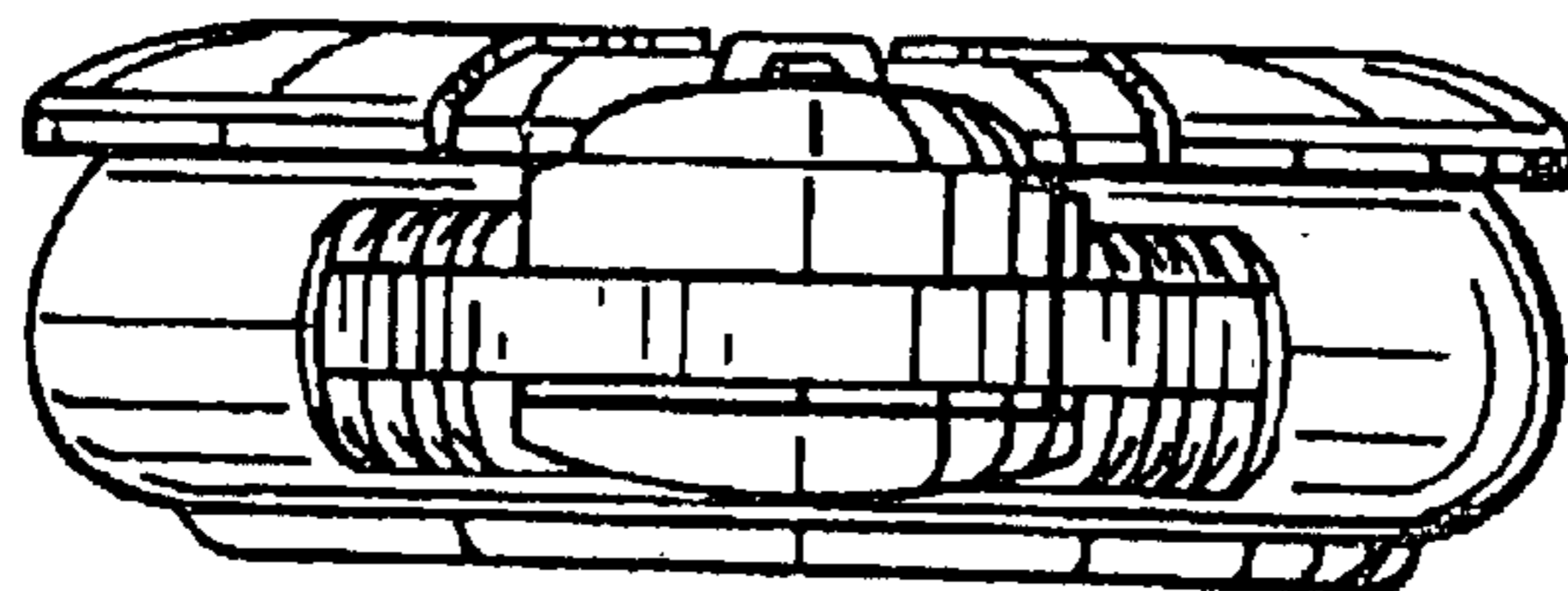
