The ornamental design for an indicator for water quality measuring instrument, as shown.

DESCRIPTION

FIG. 1 is a perspective view of the top, front and left side of an indicator for water quality measuring instrument showing our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a right side elevational view thereof; and,

FIG. 7 is a bottom plan view thereof.

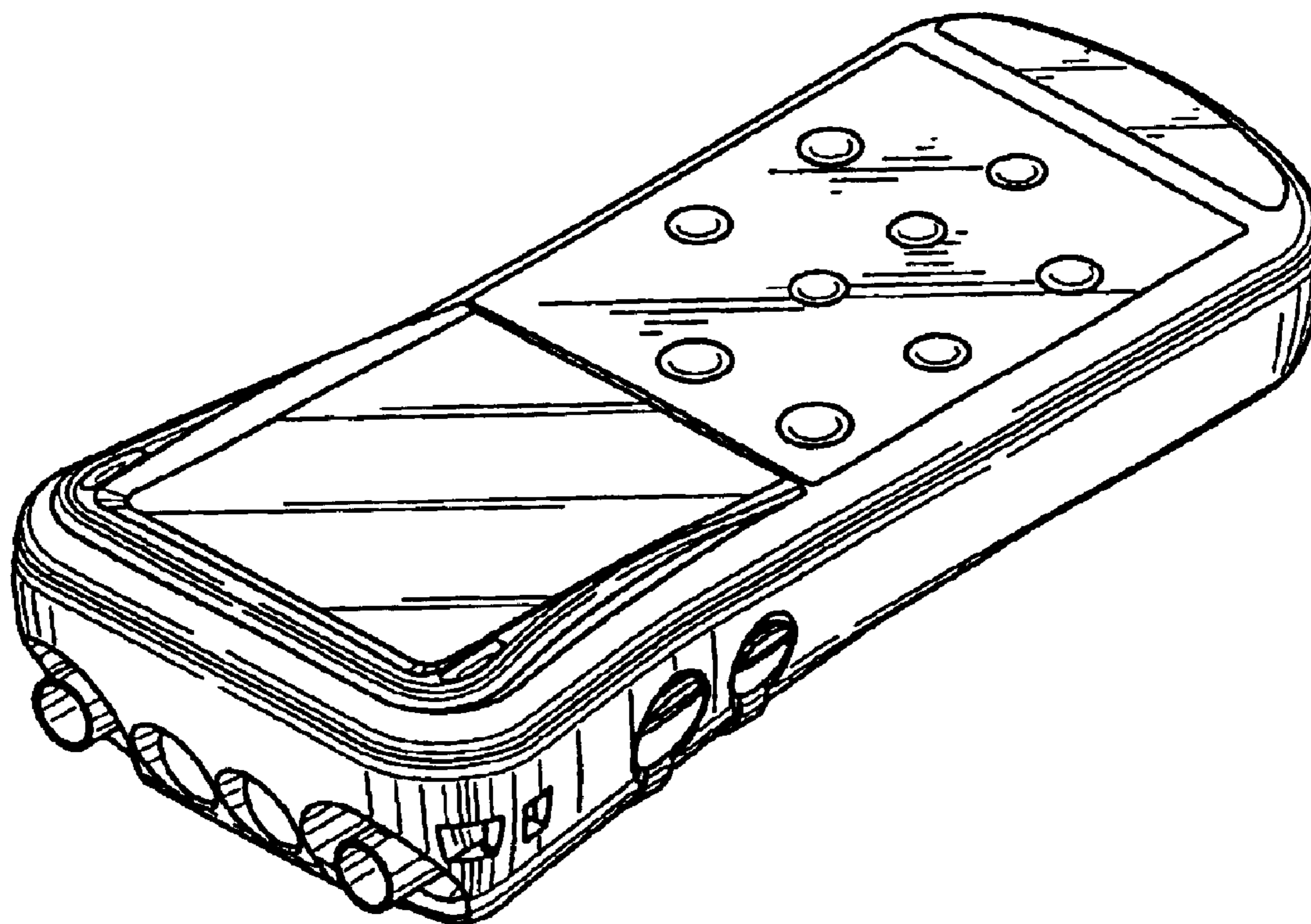

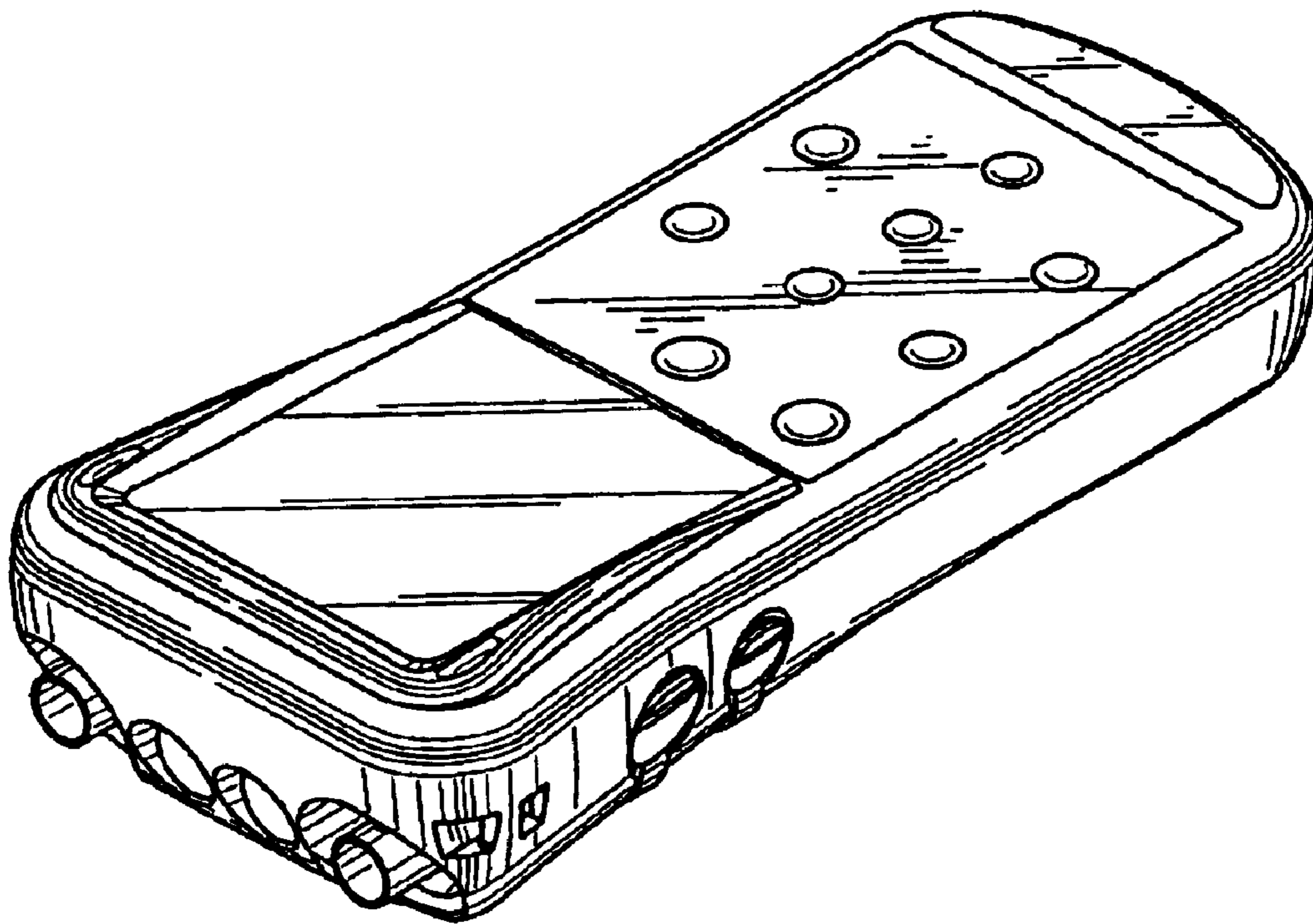

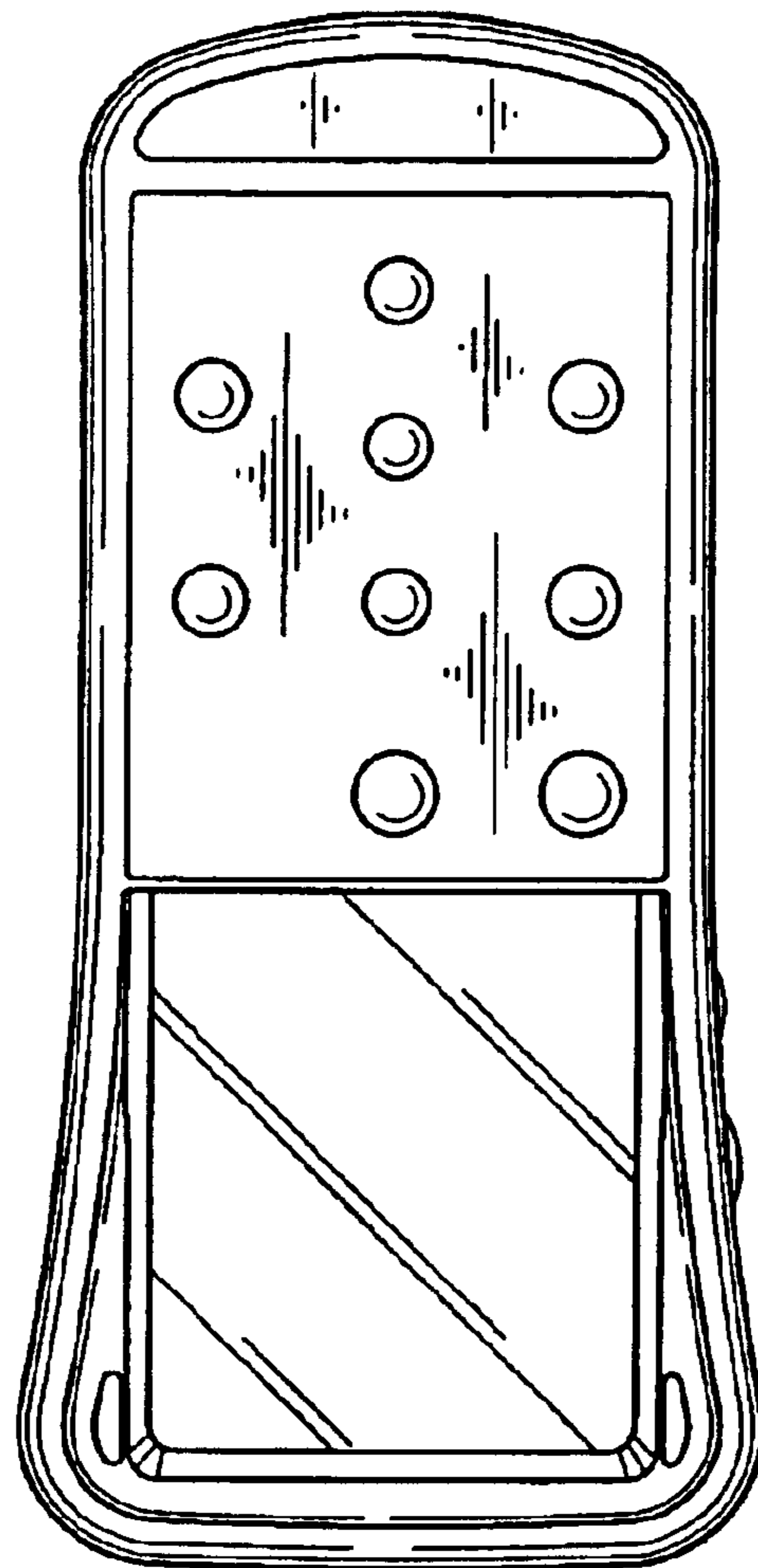

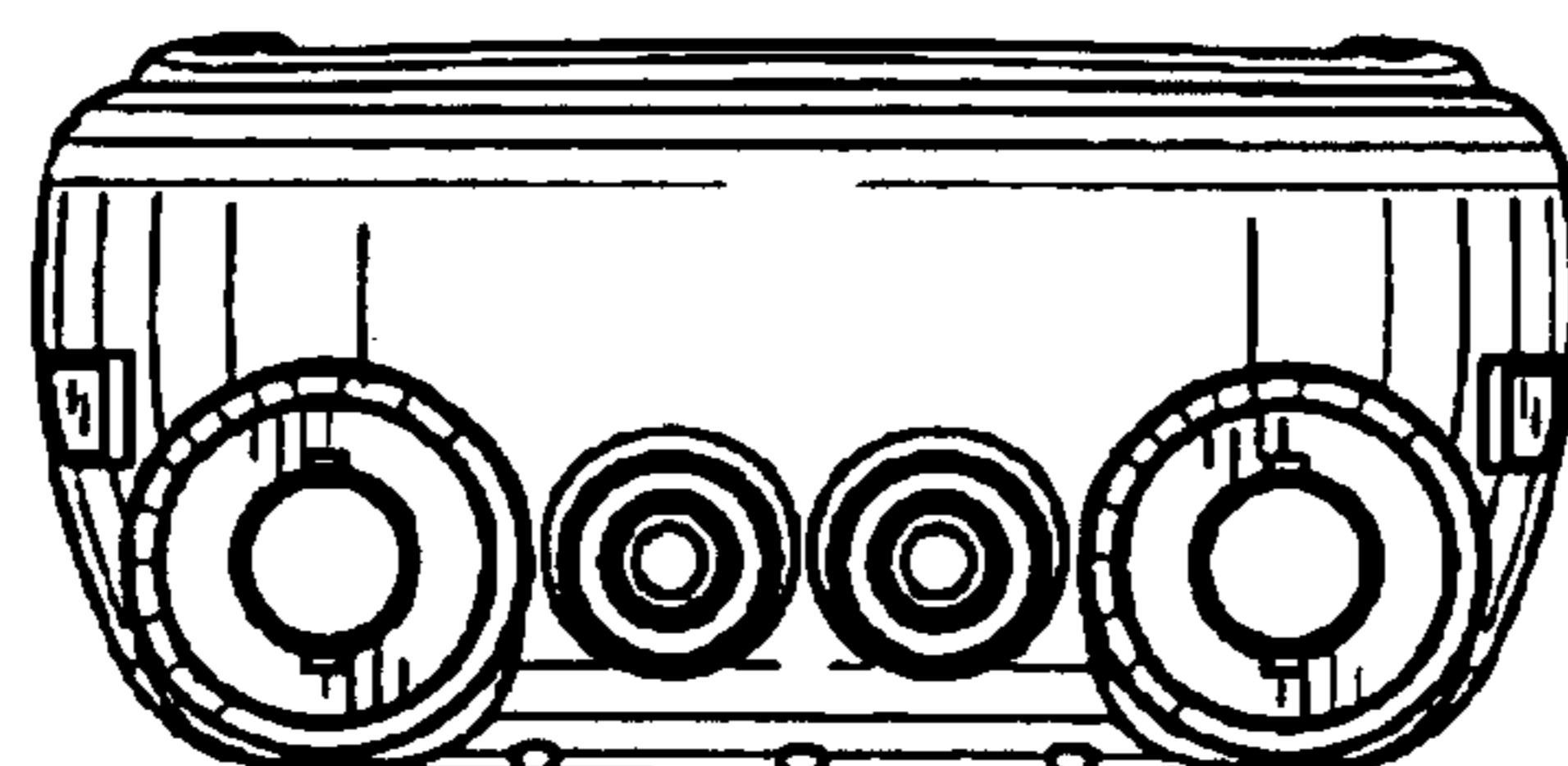

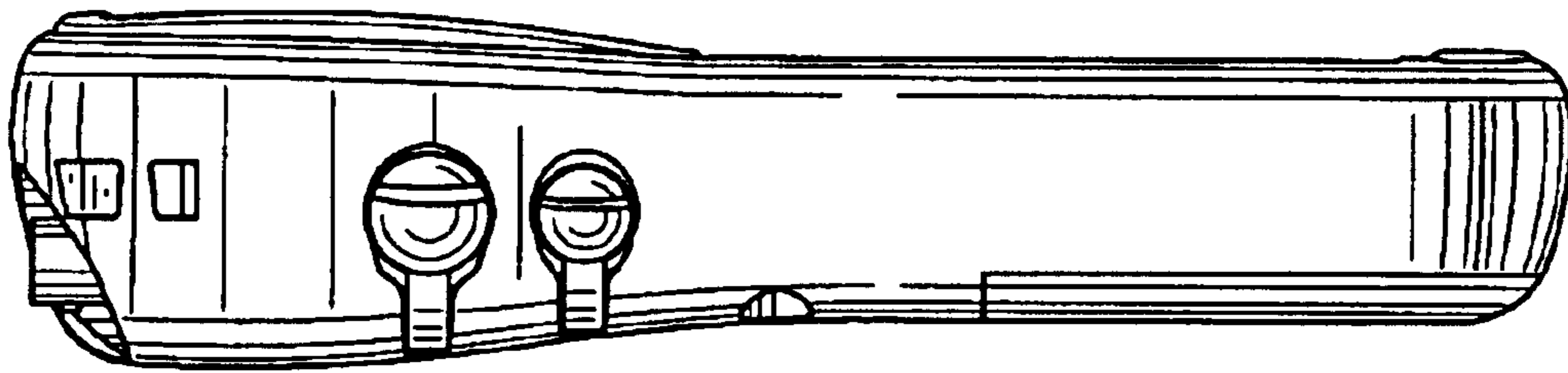

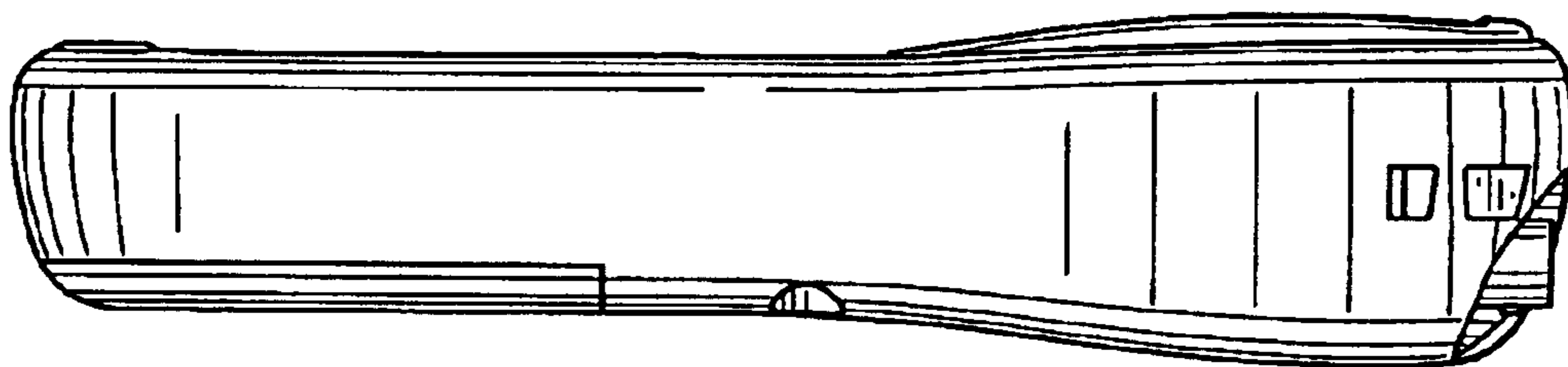

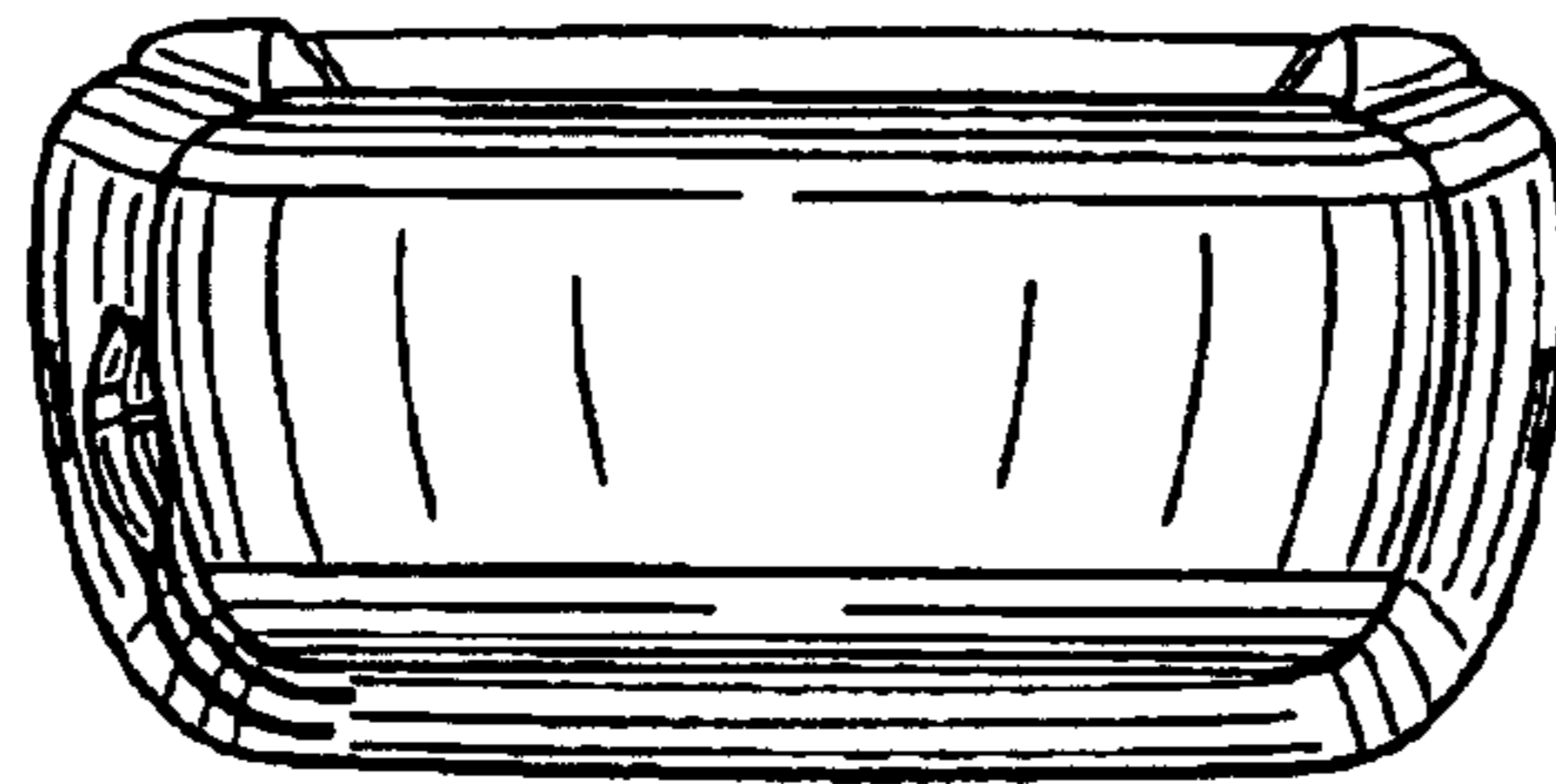
