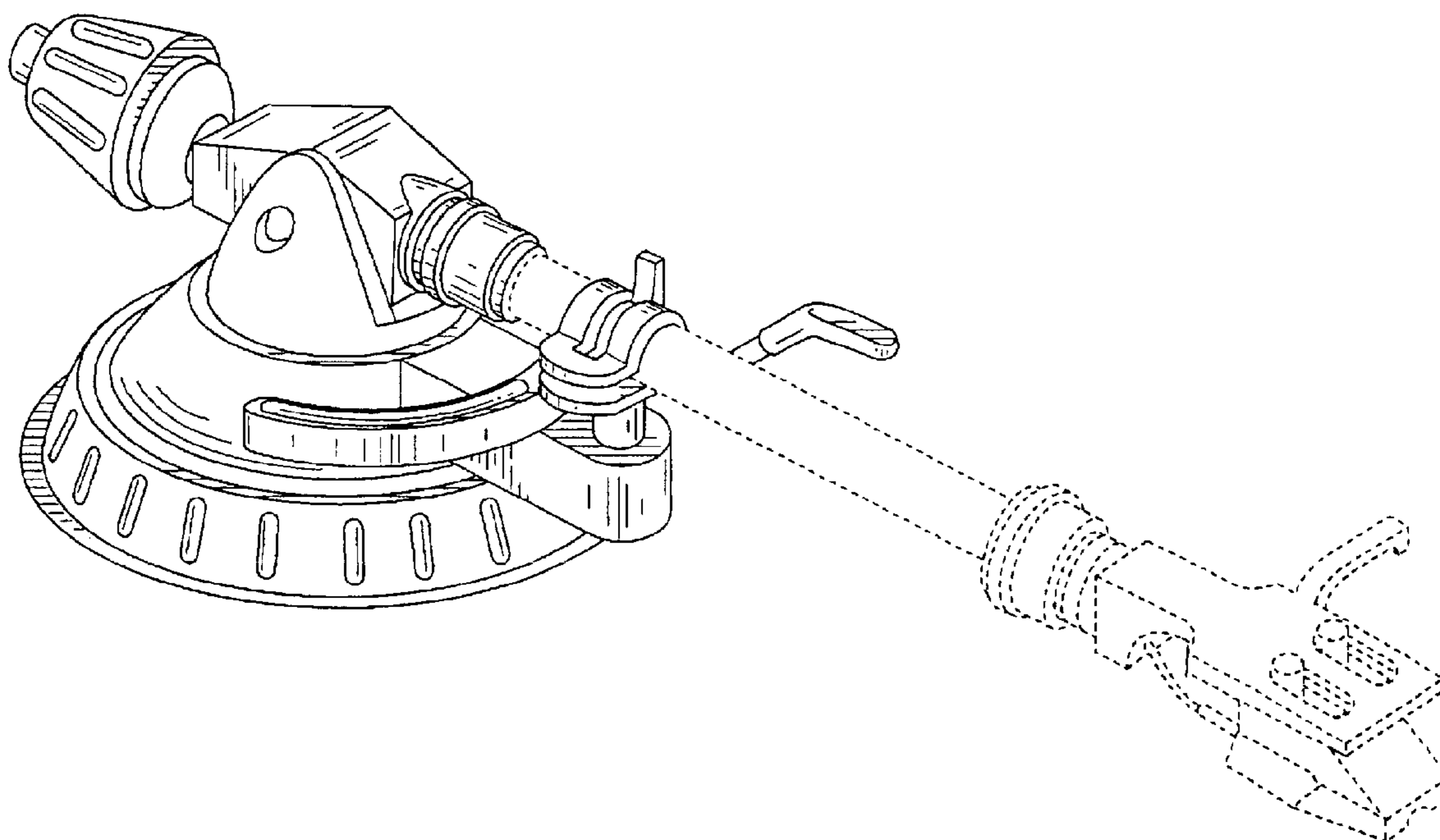
(57) **CLAIM**

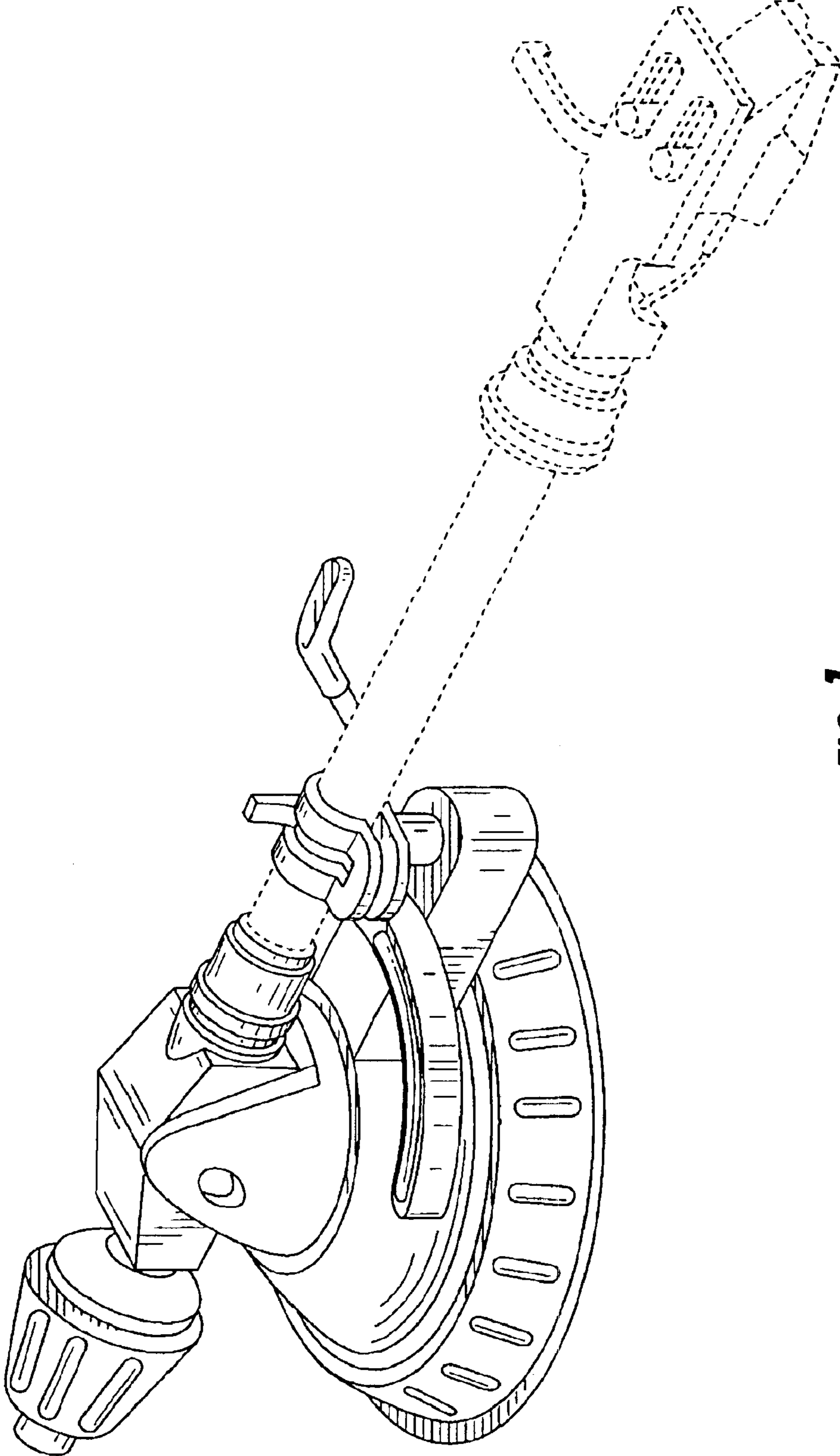
The ornamental design for a tone arm assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a tone arm assembly showing my new design;  
FIG. 2 is a top view thereof;  
FIG. 3 is a bottom view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a rear elevational view thereof;  
FIG. 6 is a left elevational view thereof; and,  
FIG. 7 is a right elevational view thereof.

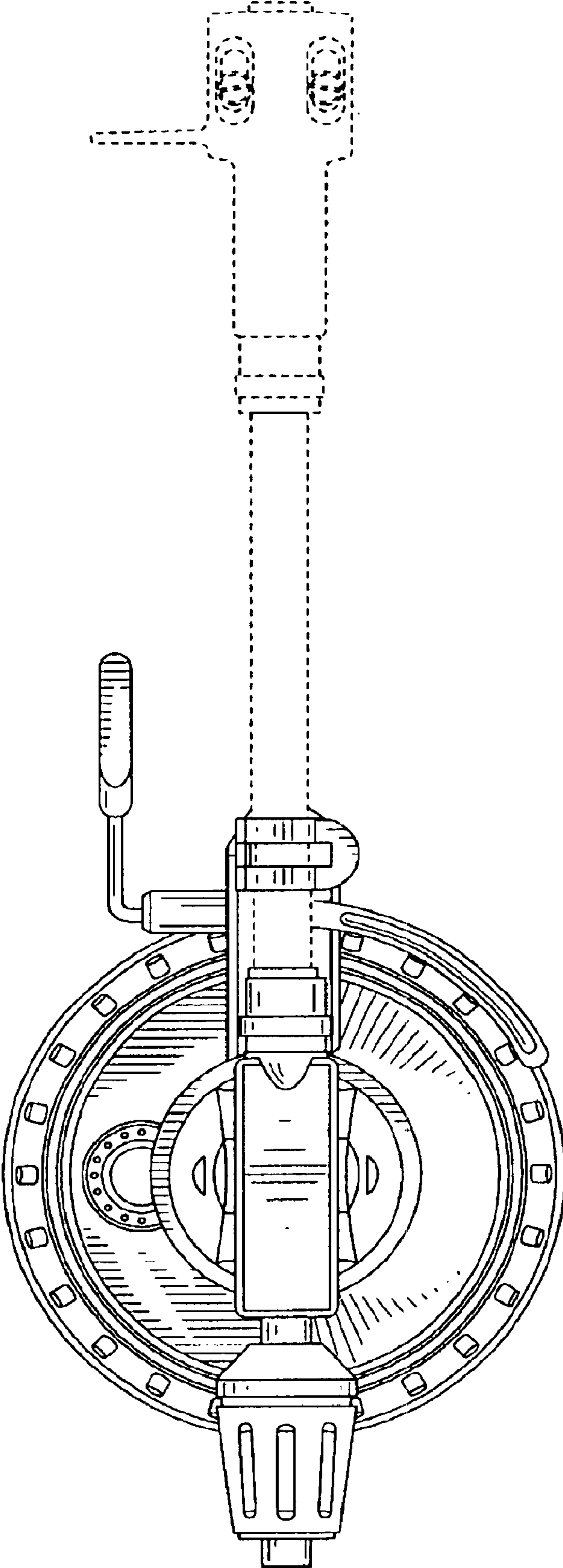
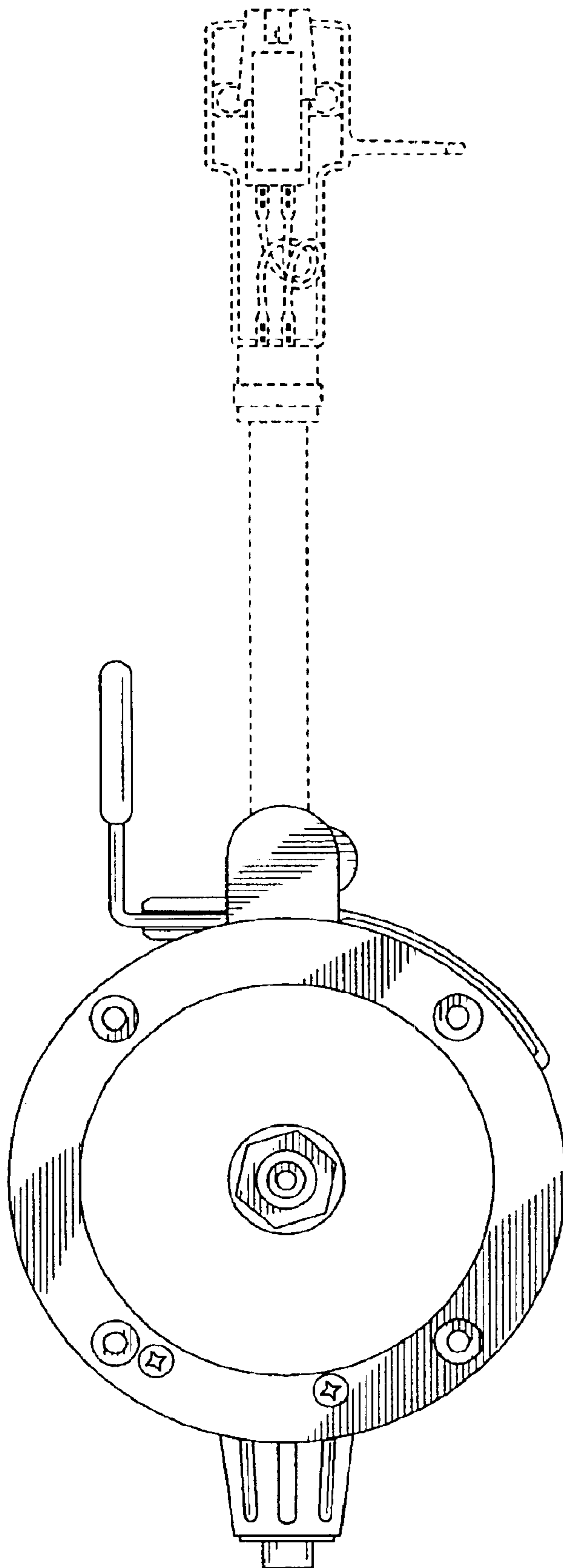
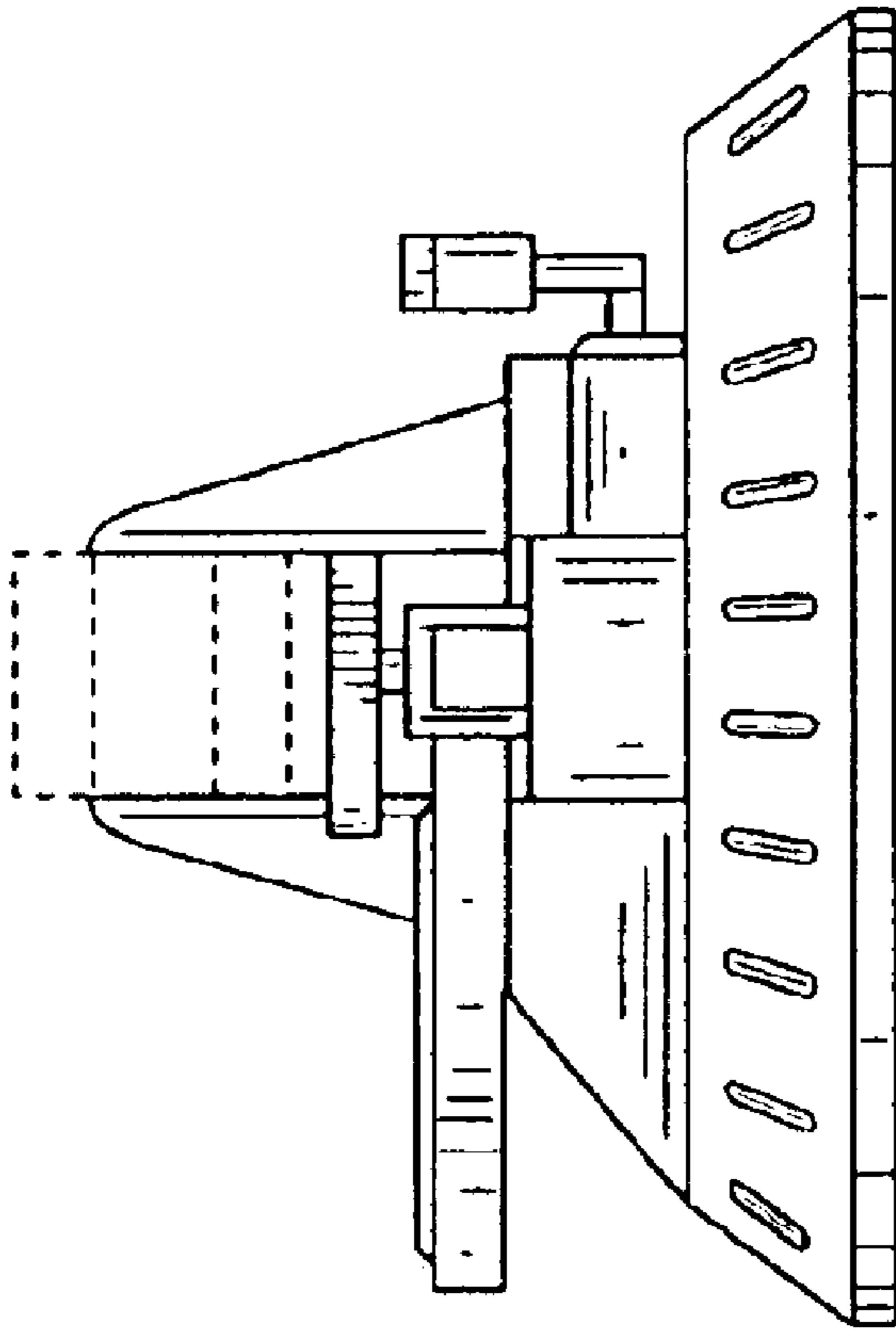


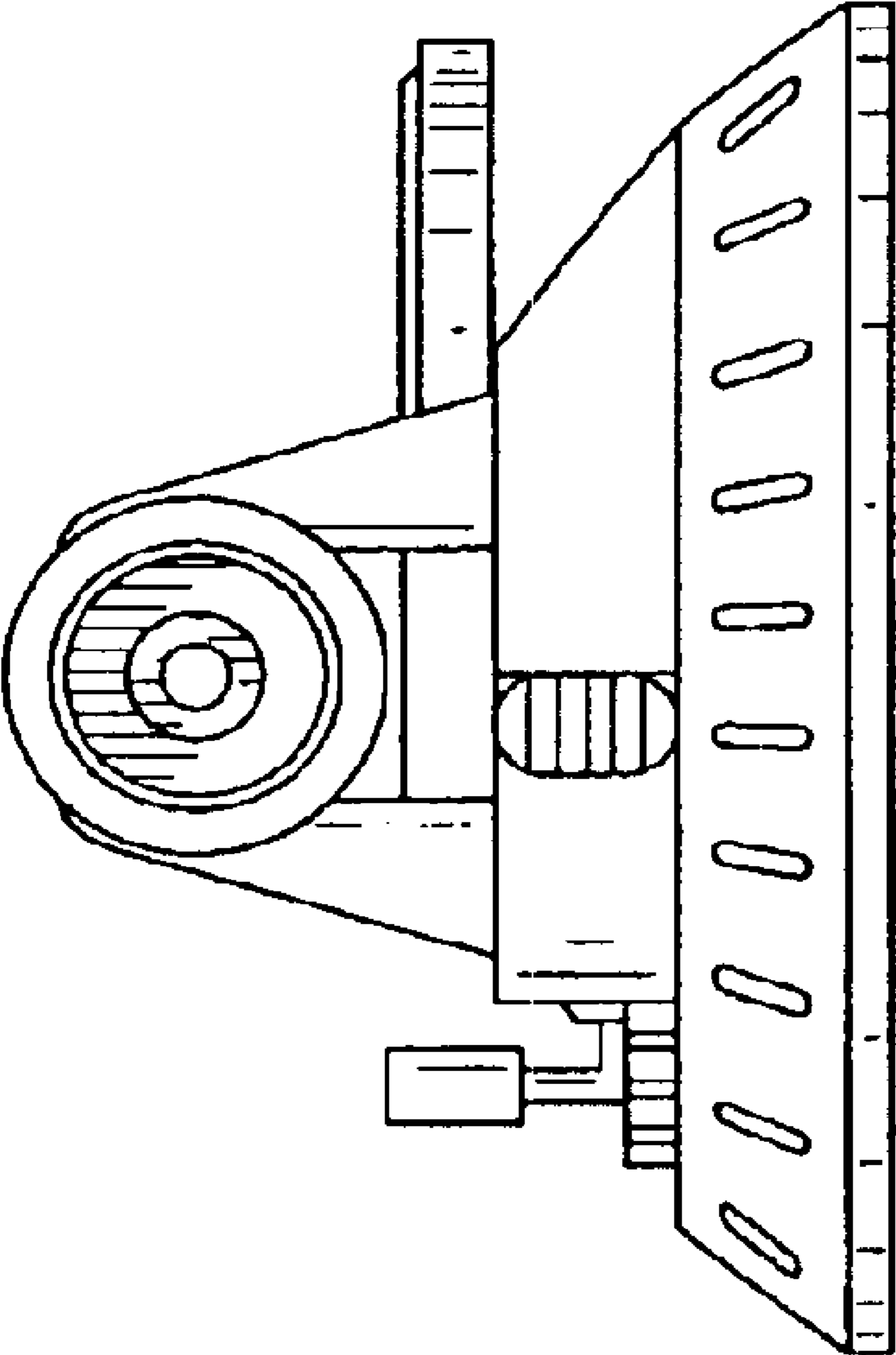

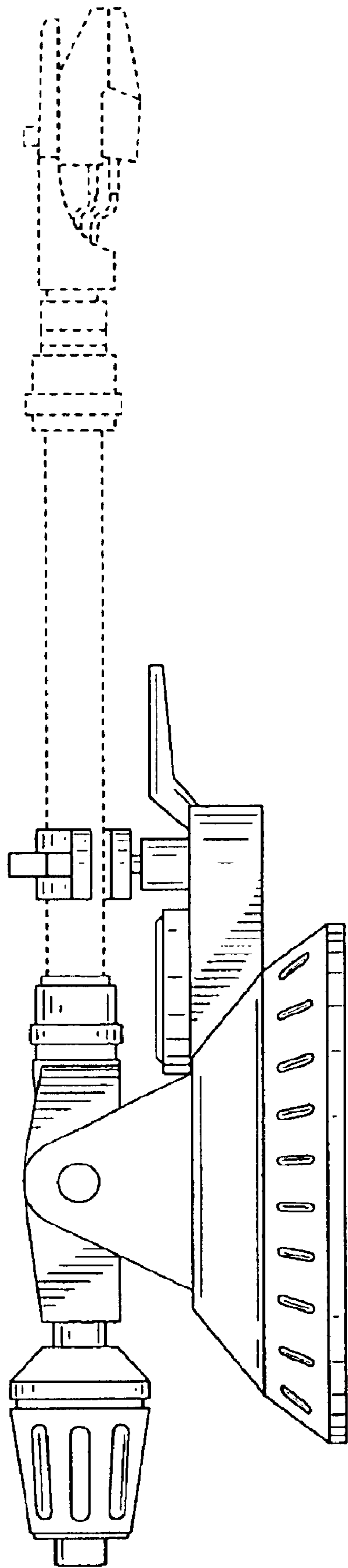

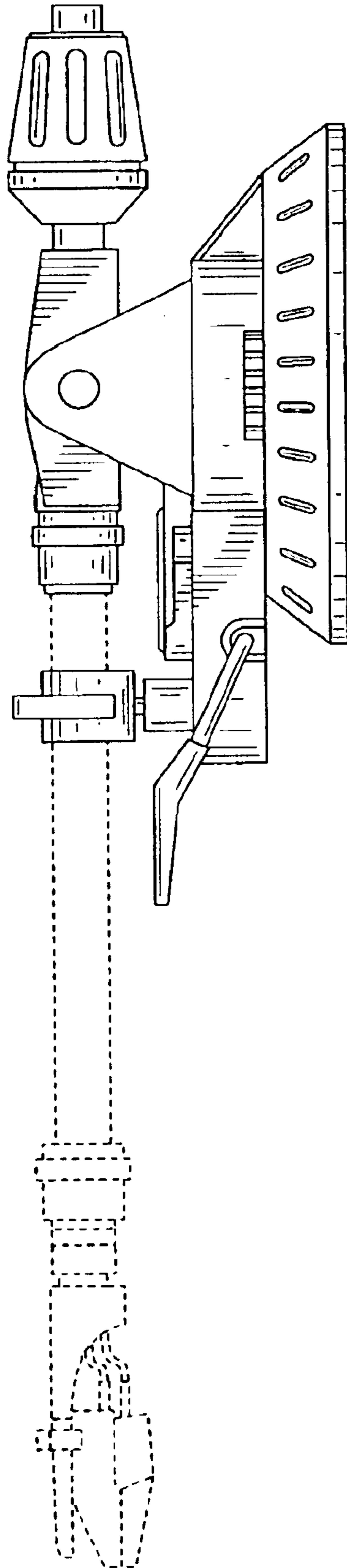
