The ornamental design for a putter head, as shown.

DESCRIPTION

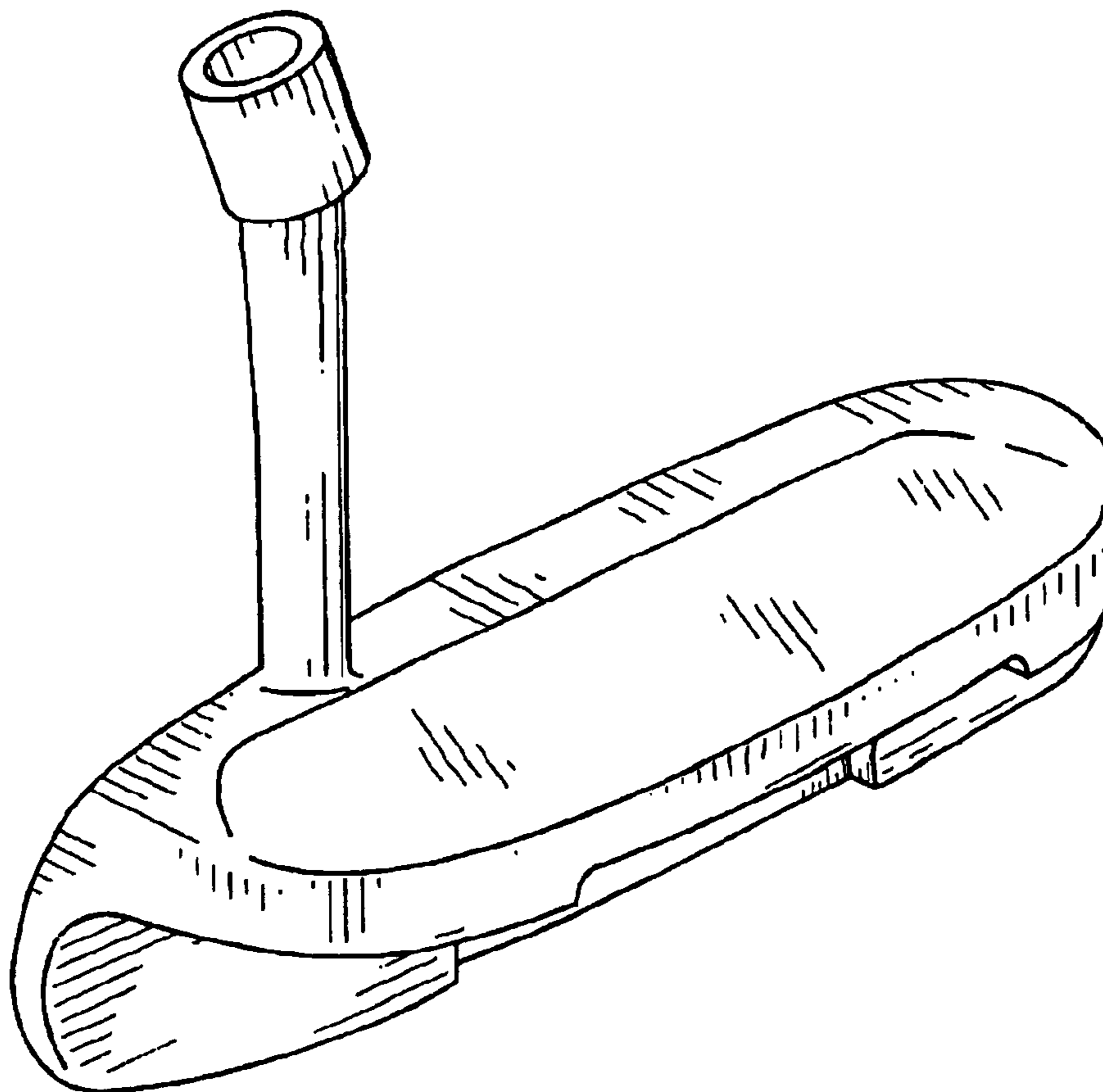
FIG. 1 is a declined perspective view of the putter head.
FIG. 2 is a right side view of the putter head.
FIG. 3 is a left side view of the putter head.
FIG. 4 is a front elevation view of the putter head.
FIG. 5 is a rear elevation view of the putter head.
FIG. 6 is a top view of the putter head; and,
FIG. 7 is a bottom view of the putter head.
An undisclosed second embodiment, in the form of a left-handed putter head would be a mirror (or reverse) image of the putter head shown in FIGS. 1-7.

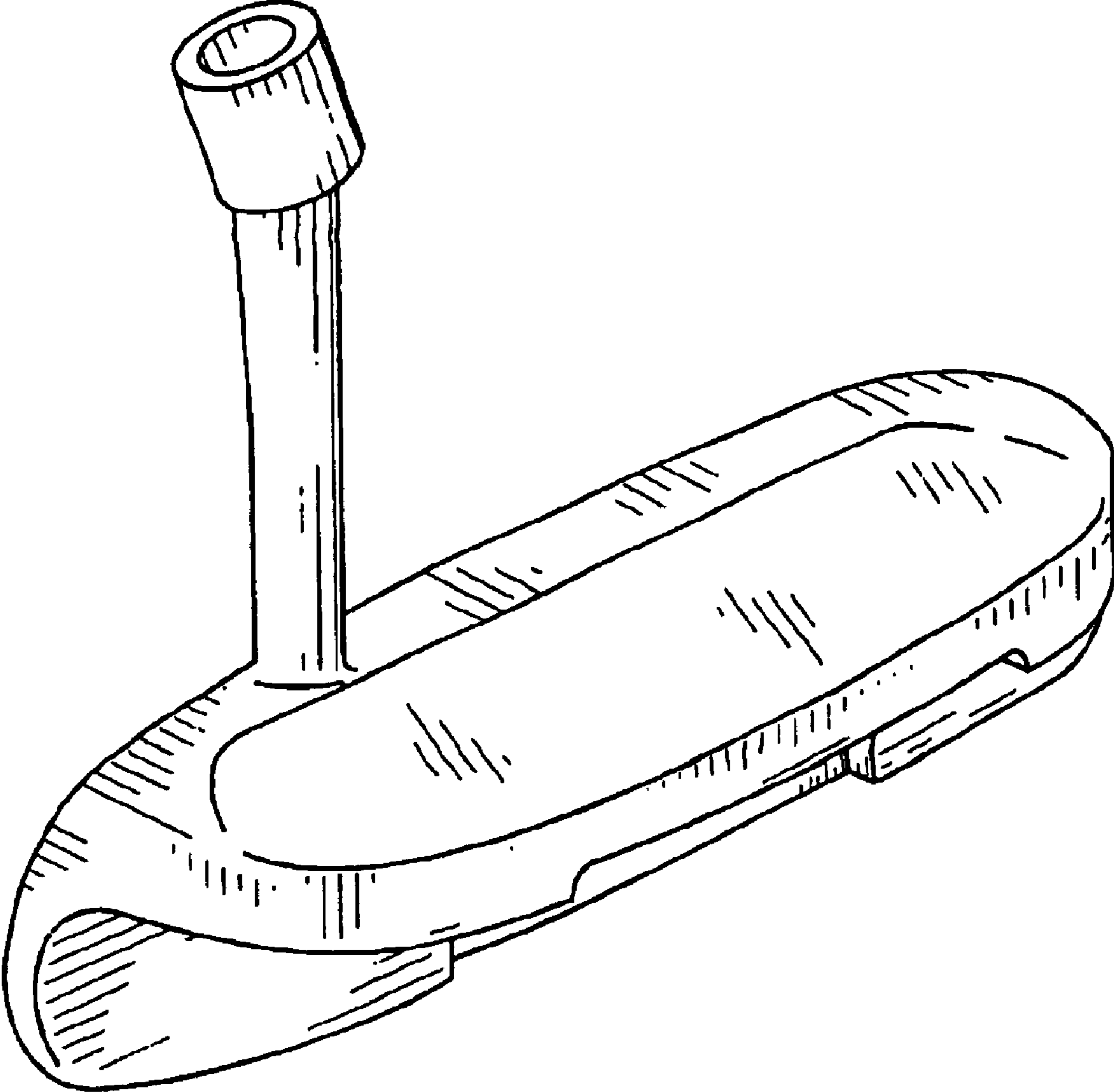

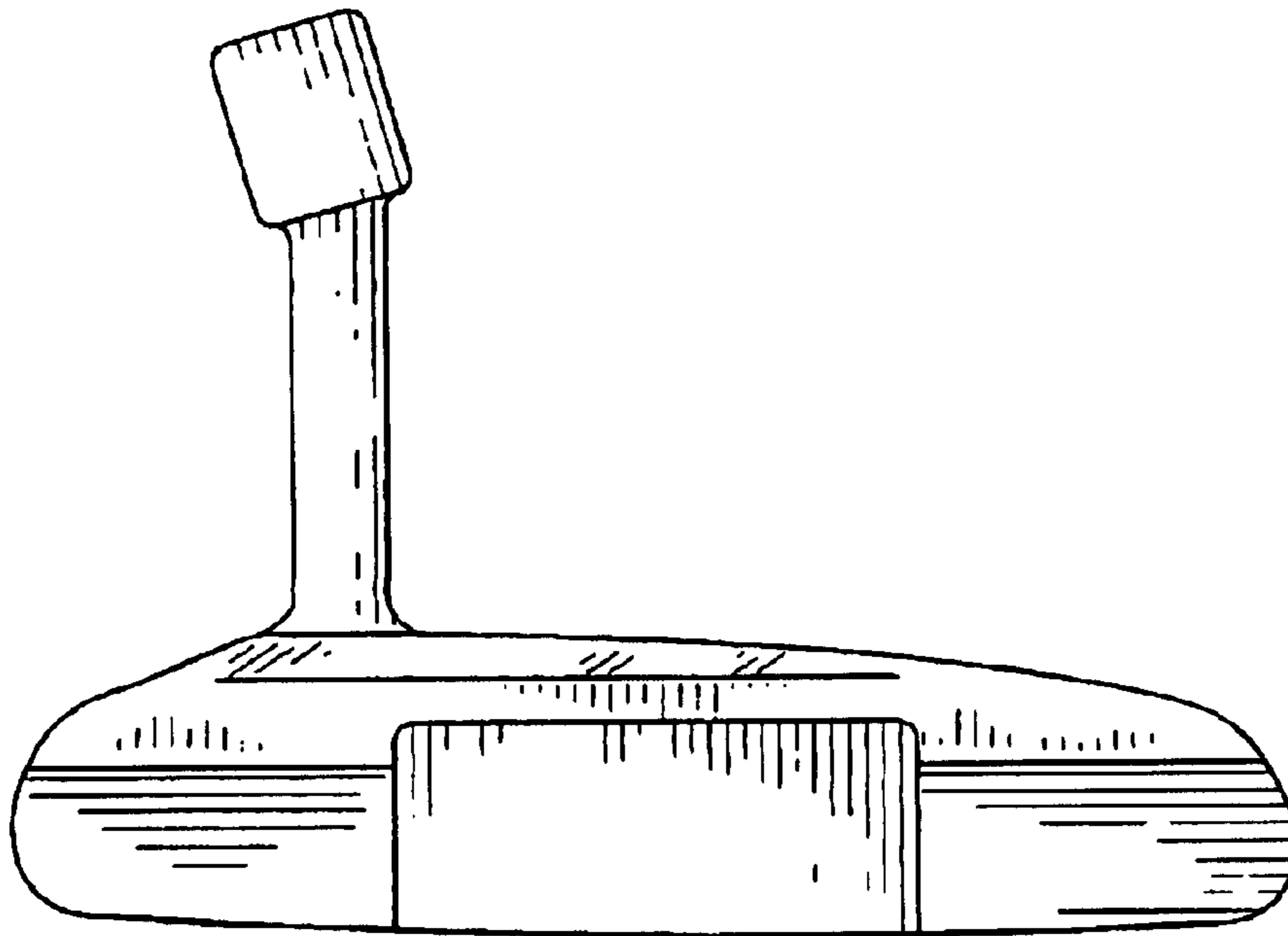

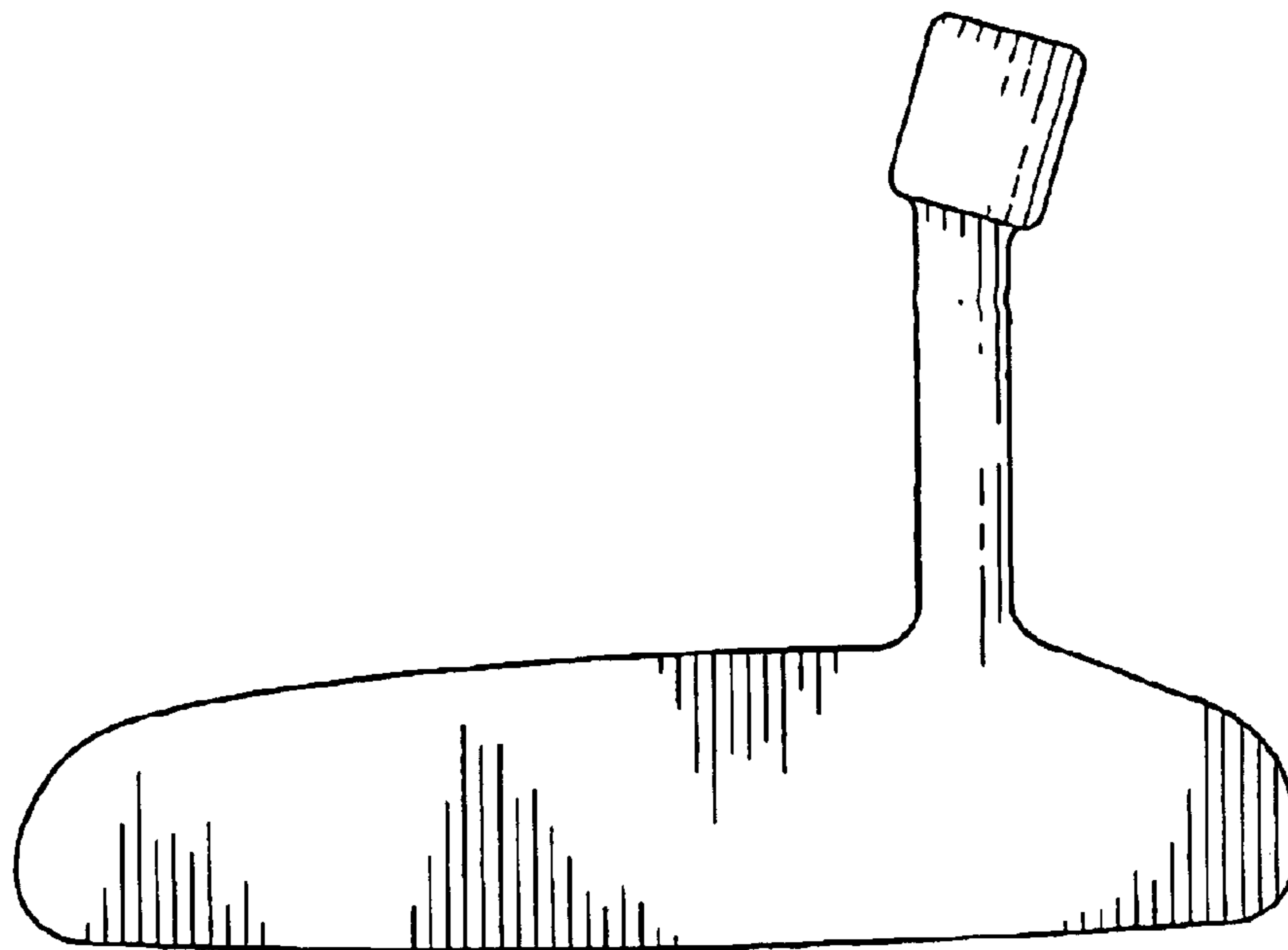

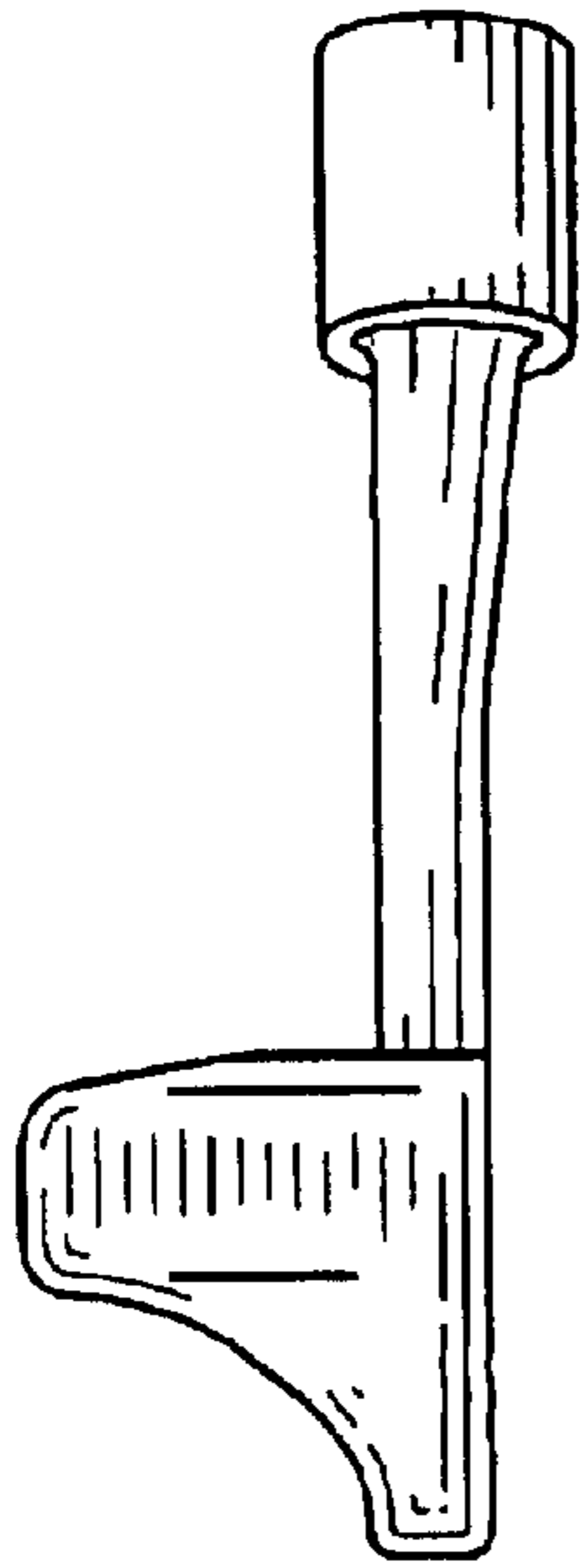

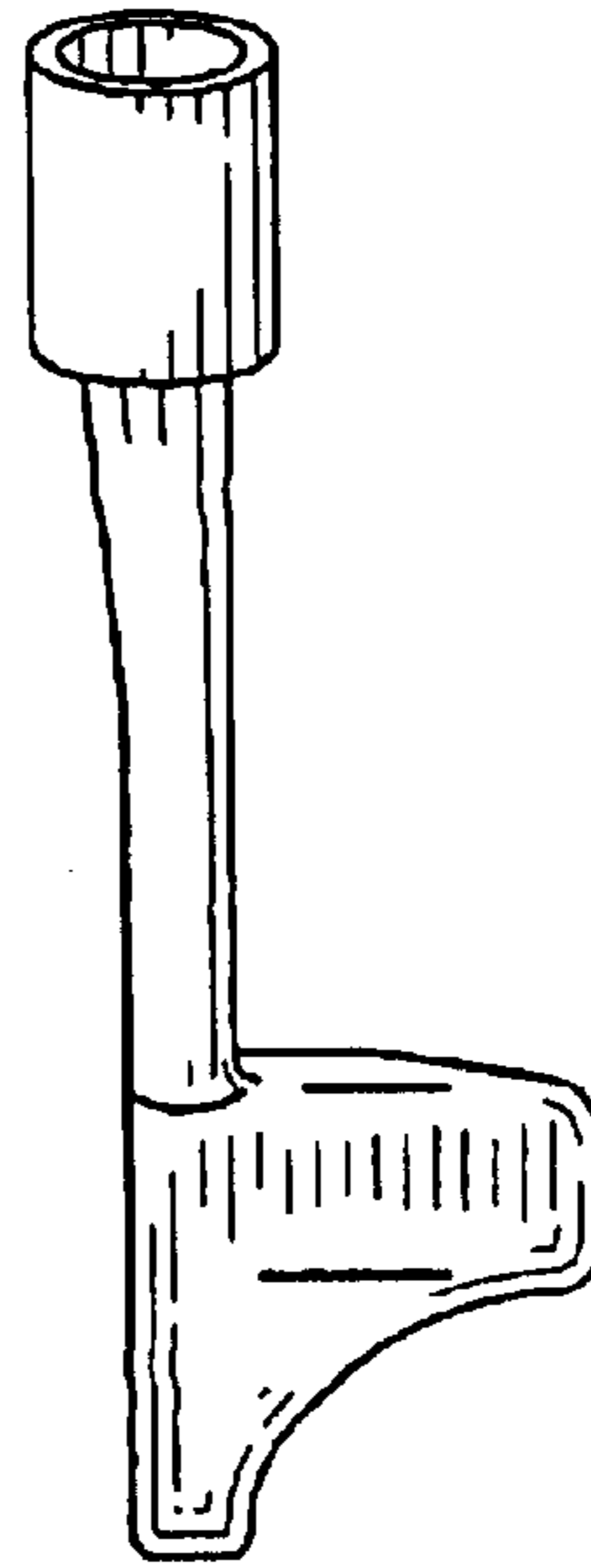

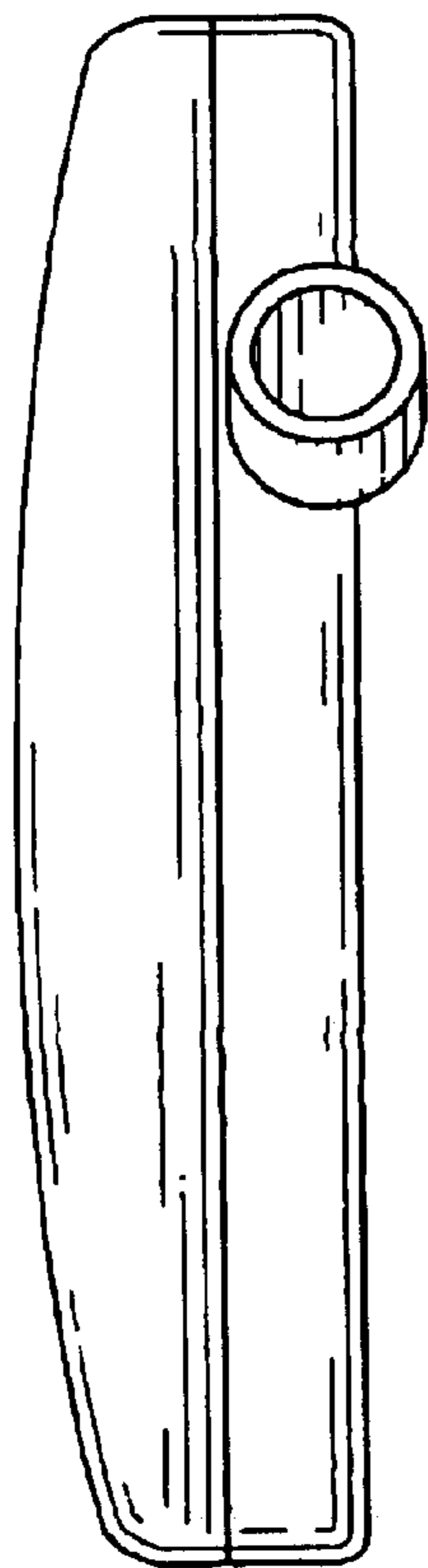

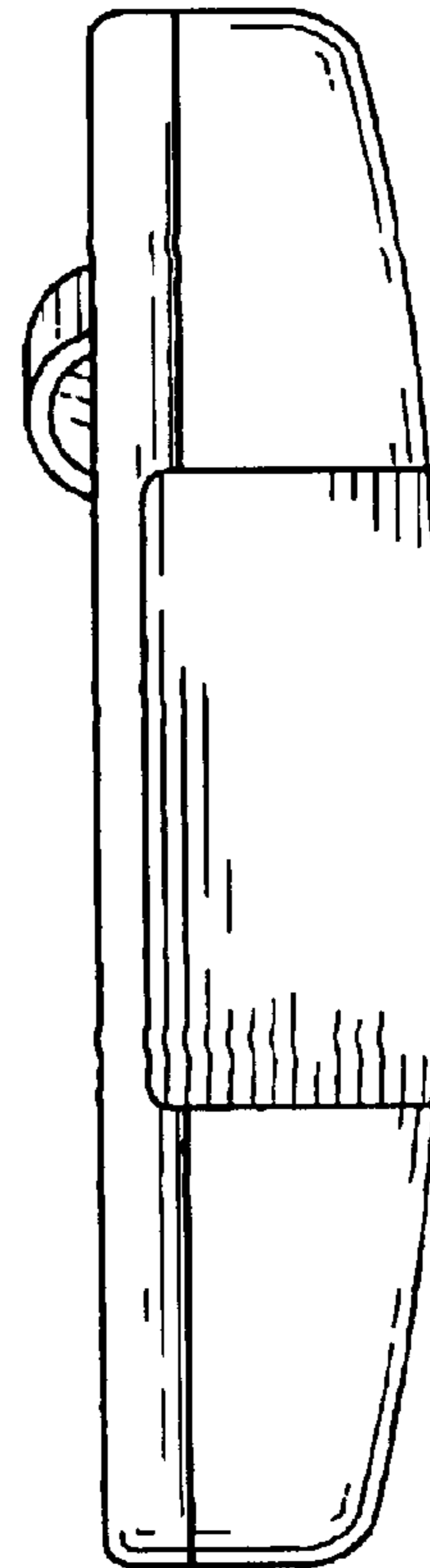
