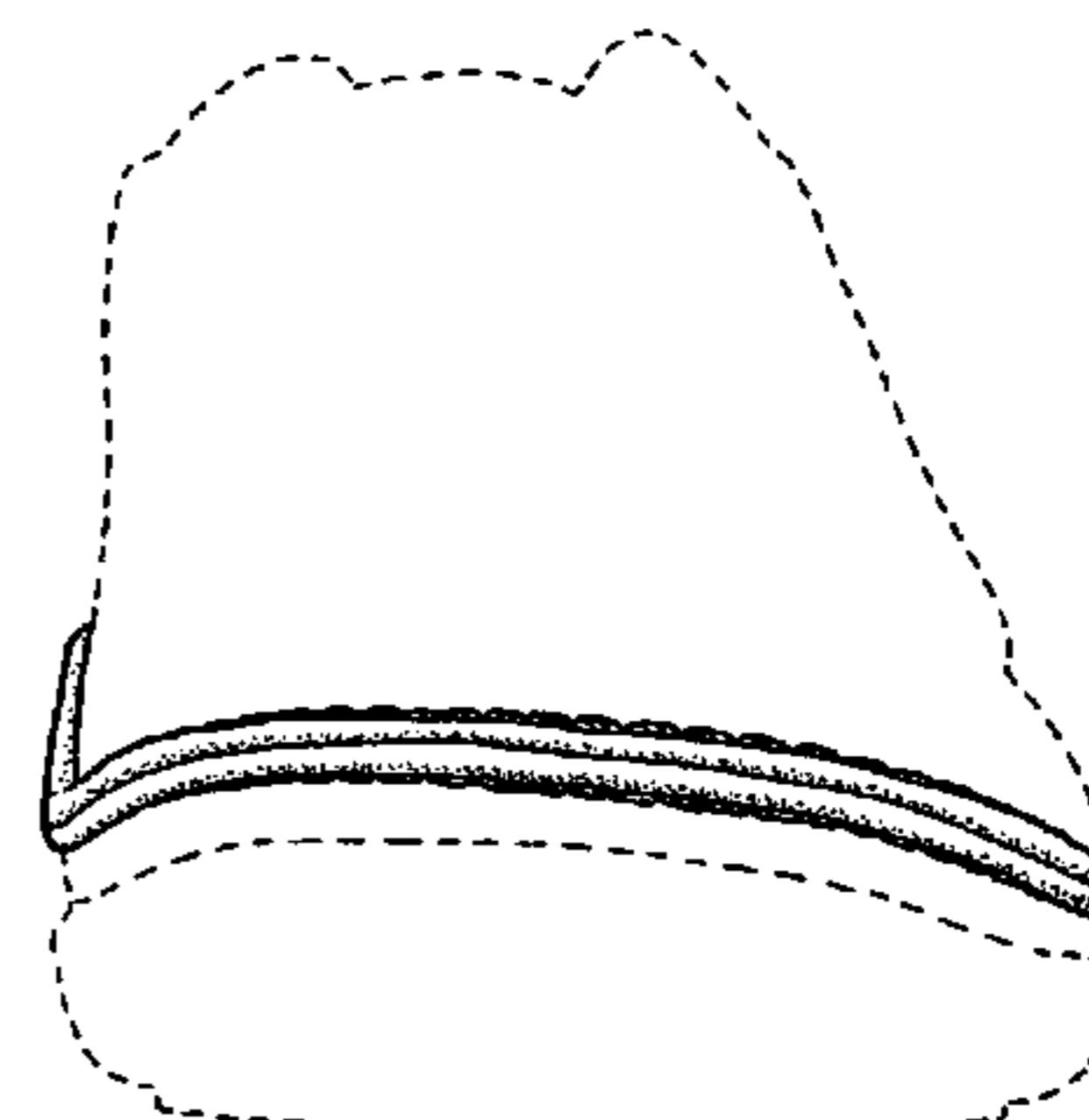
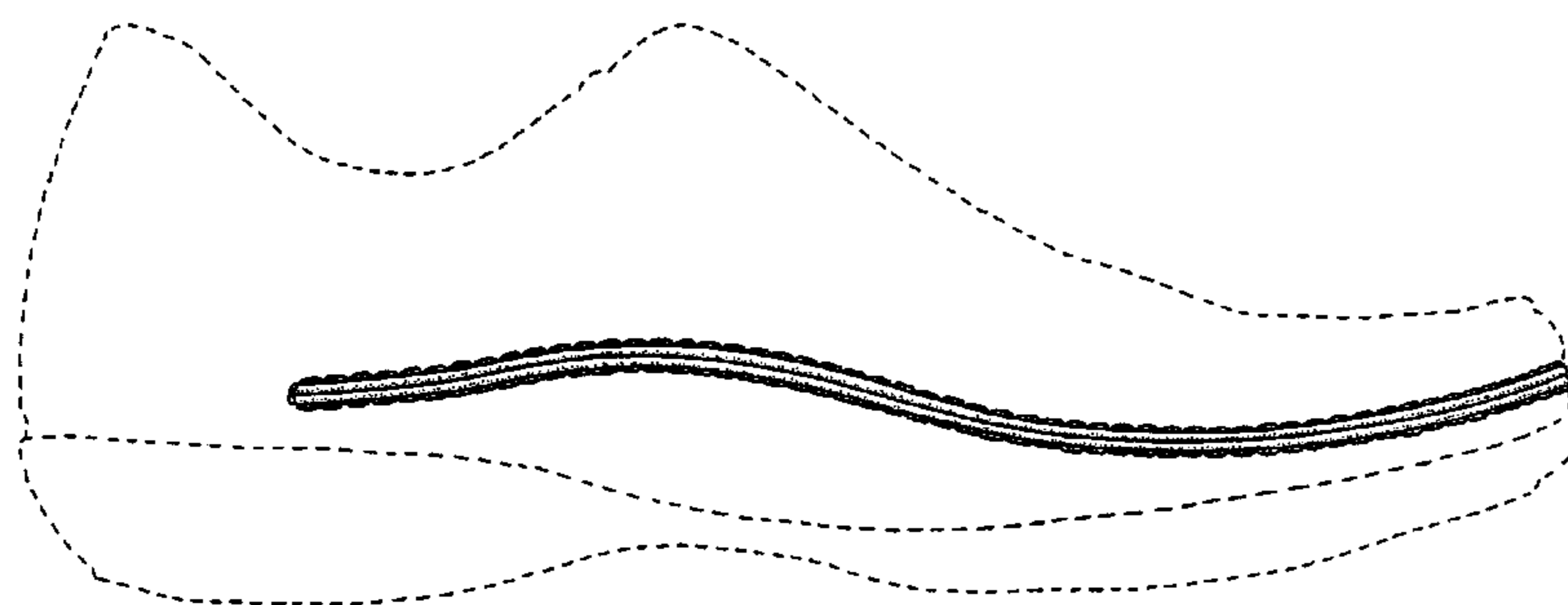
(57) **CLAIM**

The ornamental design for an element of a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of an element of a shoe showing a new design;
FIG. 2 is a right side elevational view thereof; and,
FIG. 3 is a front elevational view thereof.
The broken line showing of a shoe in the figures is environmental and forms no part of the claimed design.

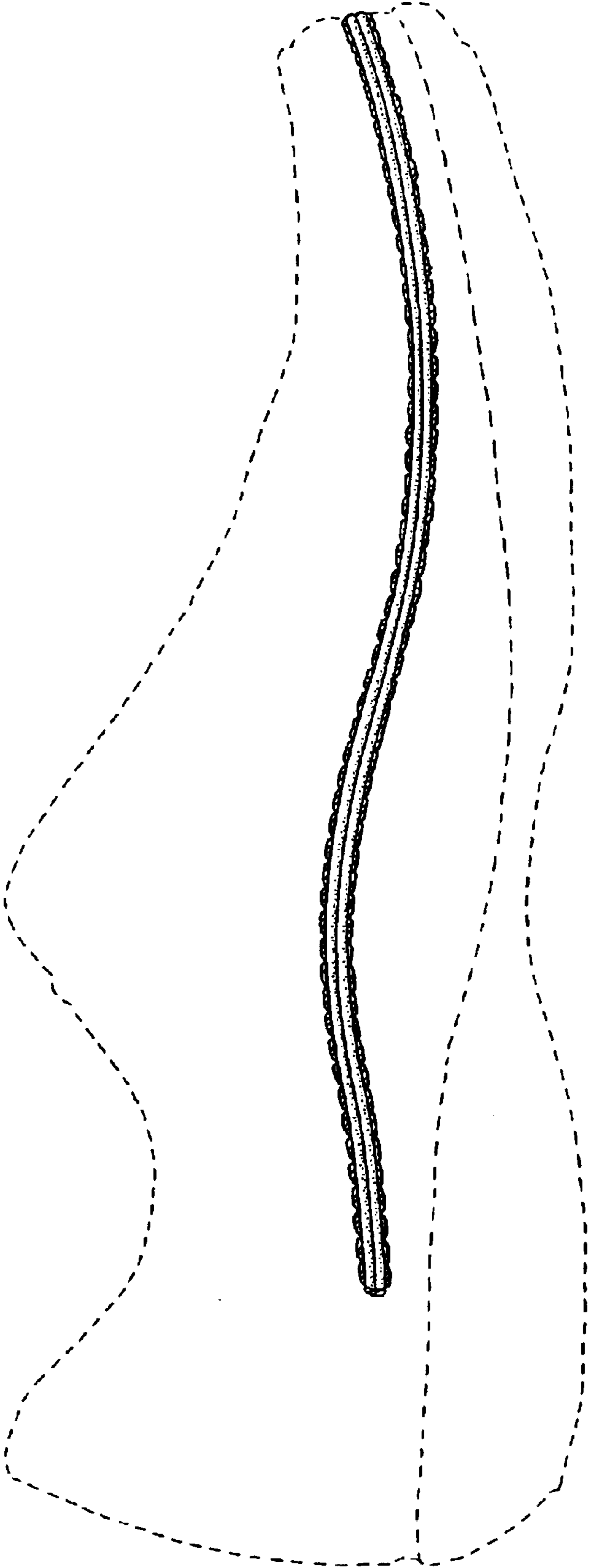

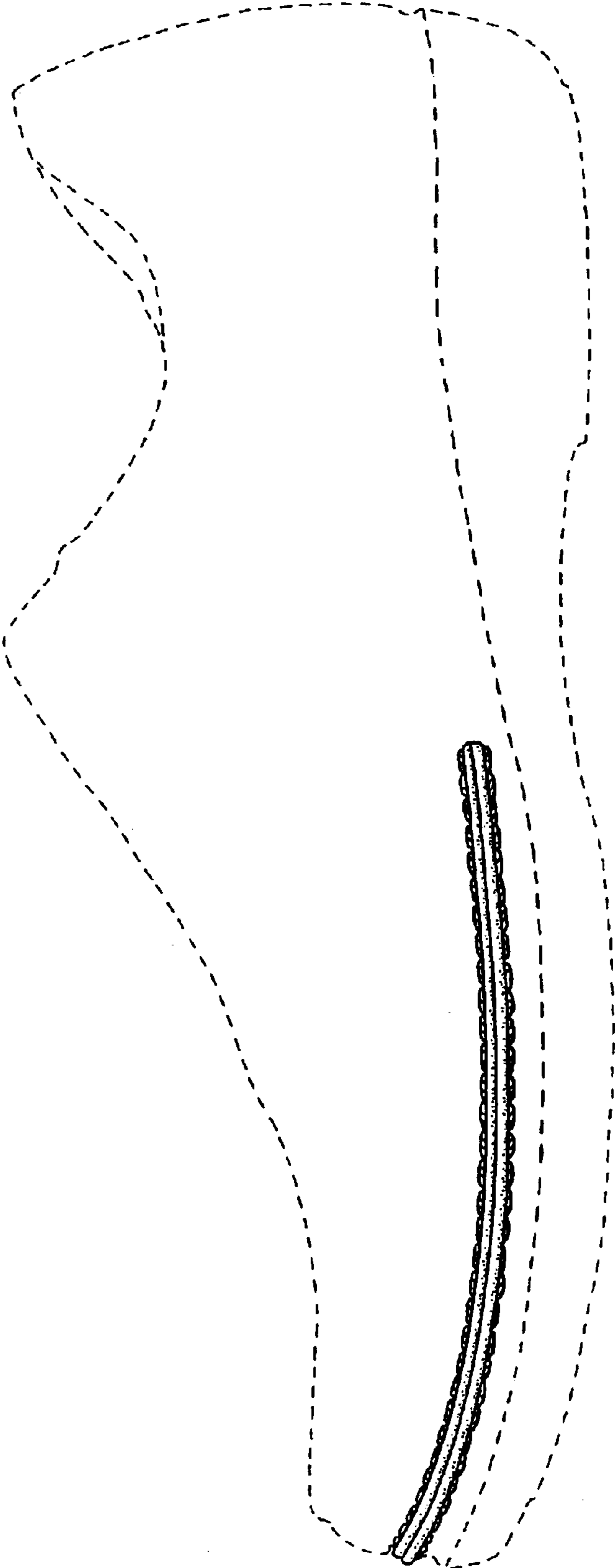

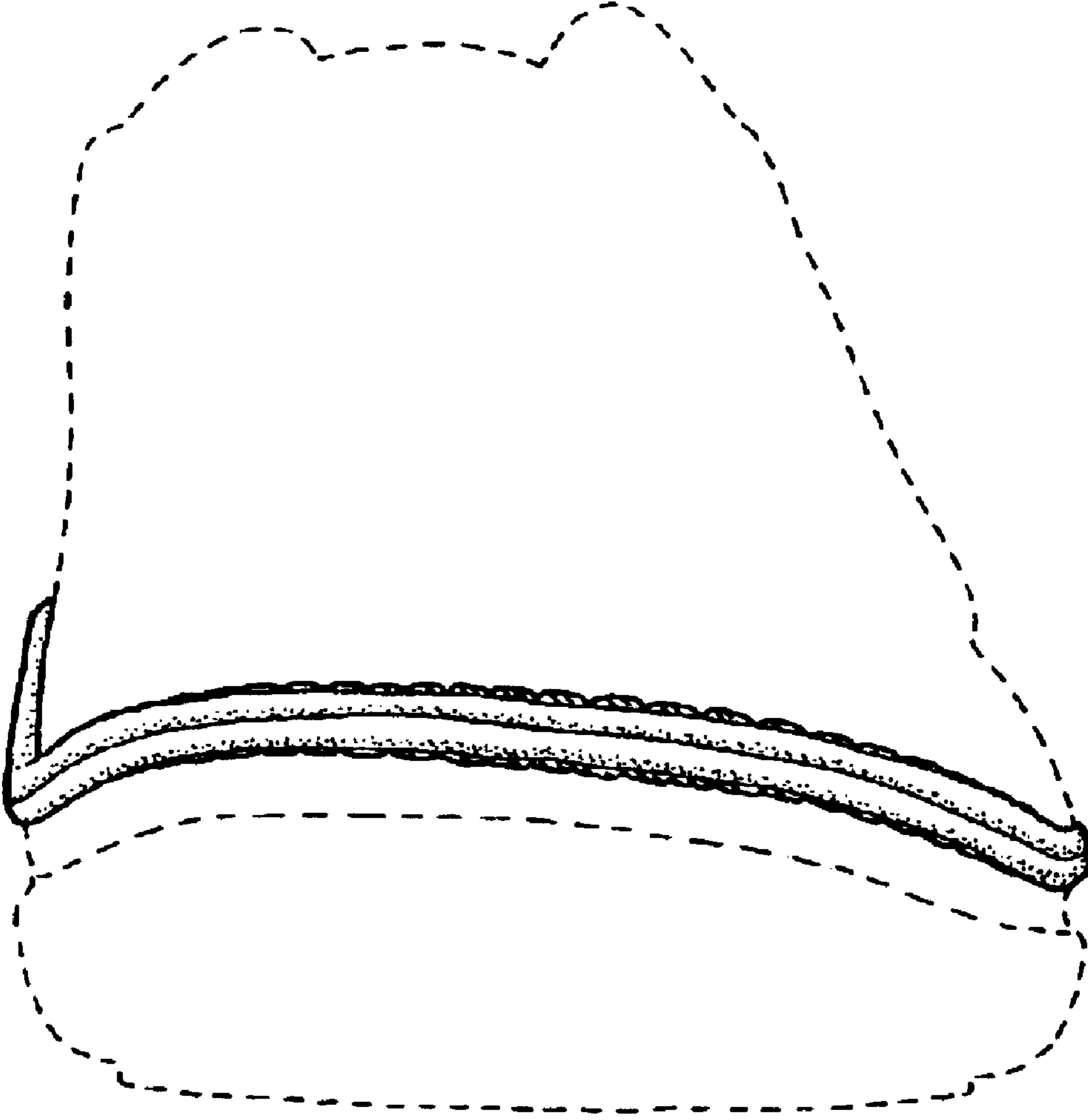
