(57) **CLAIM**

The ornamental design for a travel golf bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from the front and one side of a first embodiment of the travel golf bag;

FIG. 2 is a perspective view from the front and the other side of the first embodiment of the travel golf bag, with the cover open;

FIG. 3 is a front view of the first embodiment of the travel golf bag;

FIG. 4 is a back view of the first embodiment of the travel golf bag;

FIG. 5 is a left side view of the first embodiment of the travel golf bag;

FIG. 6 is a right side view of the first embodiment of the travel golf bag;

FIG. 7 is an underneath view of the first embodiment of the travel golf bag;

FIG. 8 is a perspective view from the front and one side of a second embodiment of the travel golf bag;

FIG. 9 is a perspective view from the front and the other side of the second embodiment of the travel golf bag, the cover having been separated;

FIG. 10 is a perspective view from the front and the other side of the second embodiment of the travel golf bag, the cover being in a carry position;

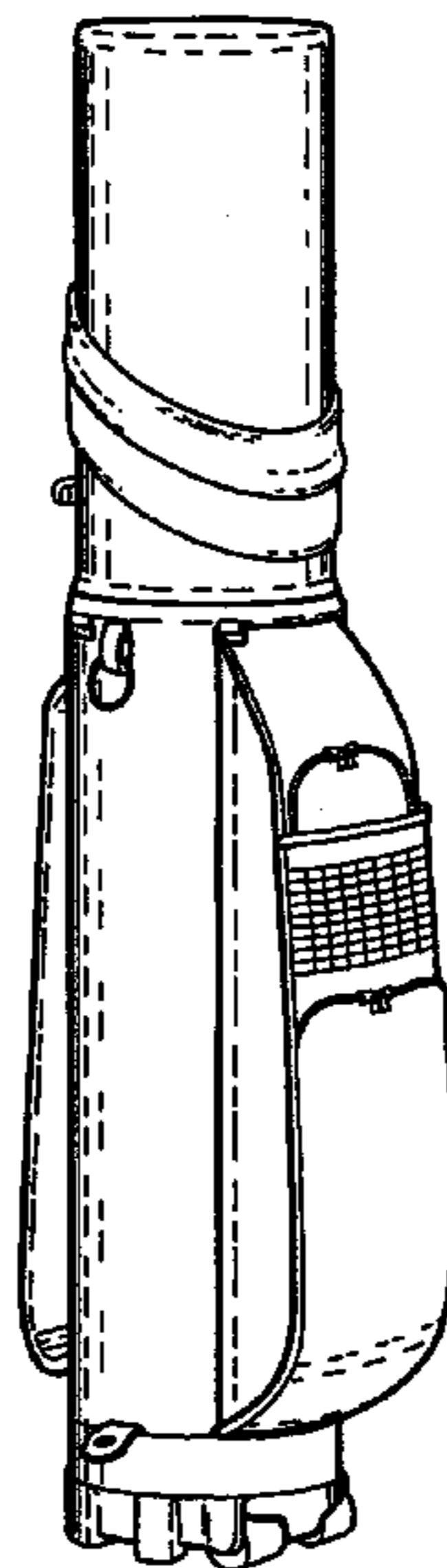
FIG. 11 is a front view of the second embodiment of the travel golf bag;

FIG. 13 is a left side view of the second embodiment of the travel golf bag; and,

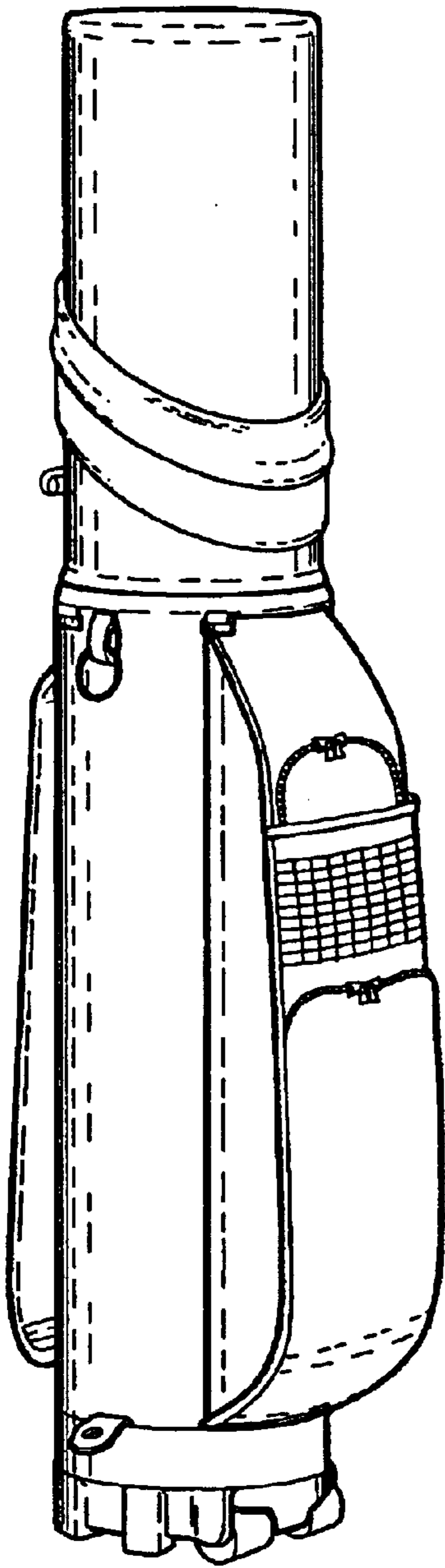

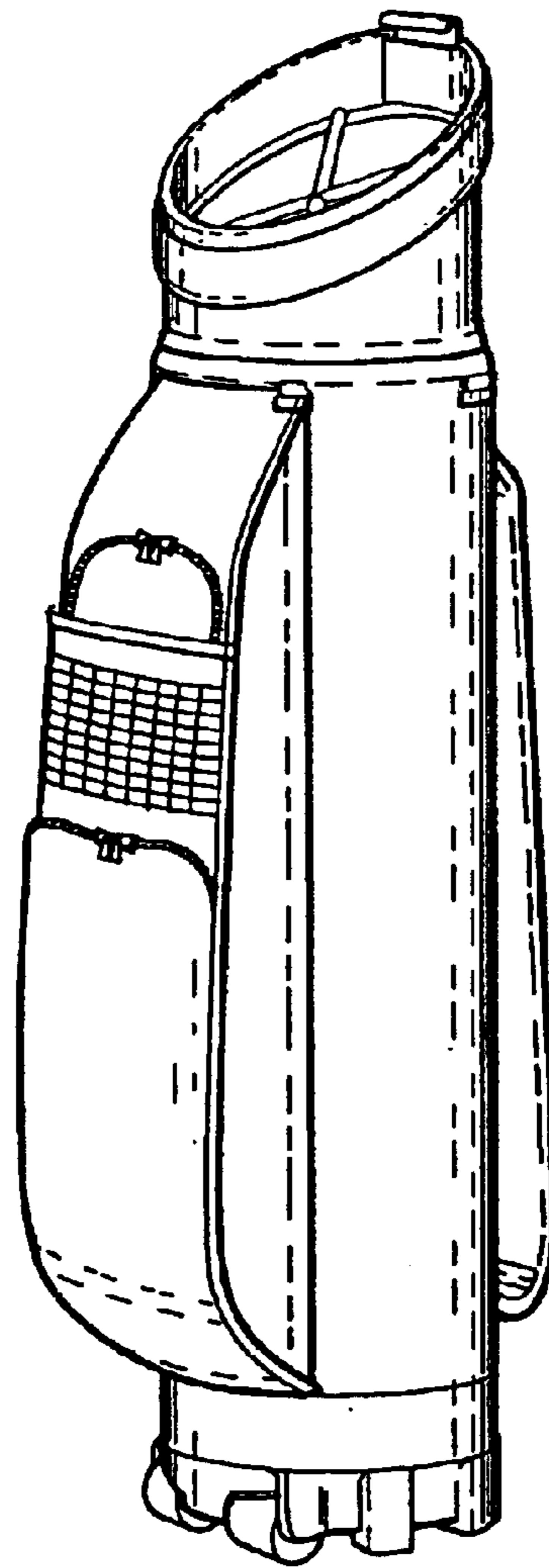
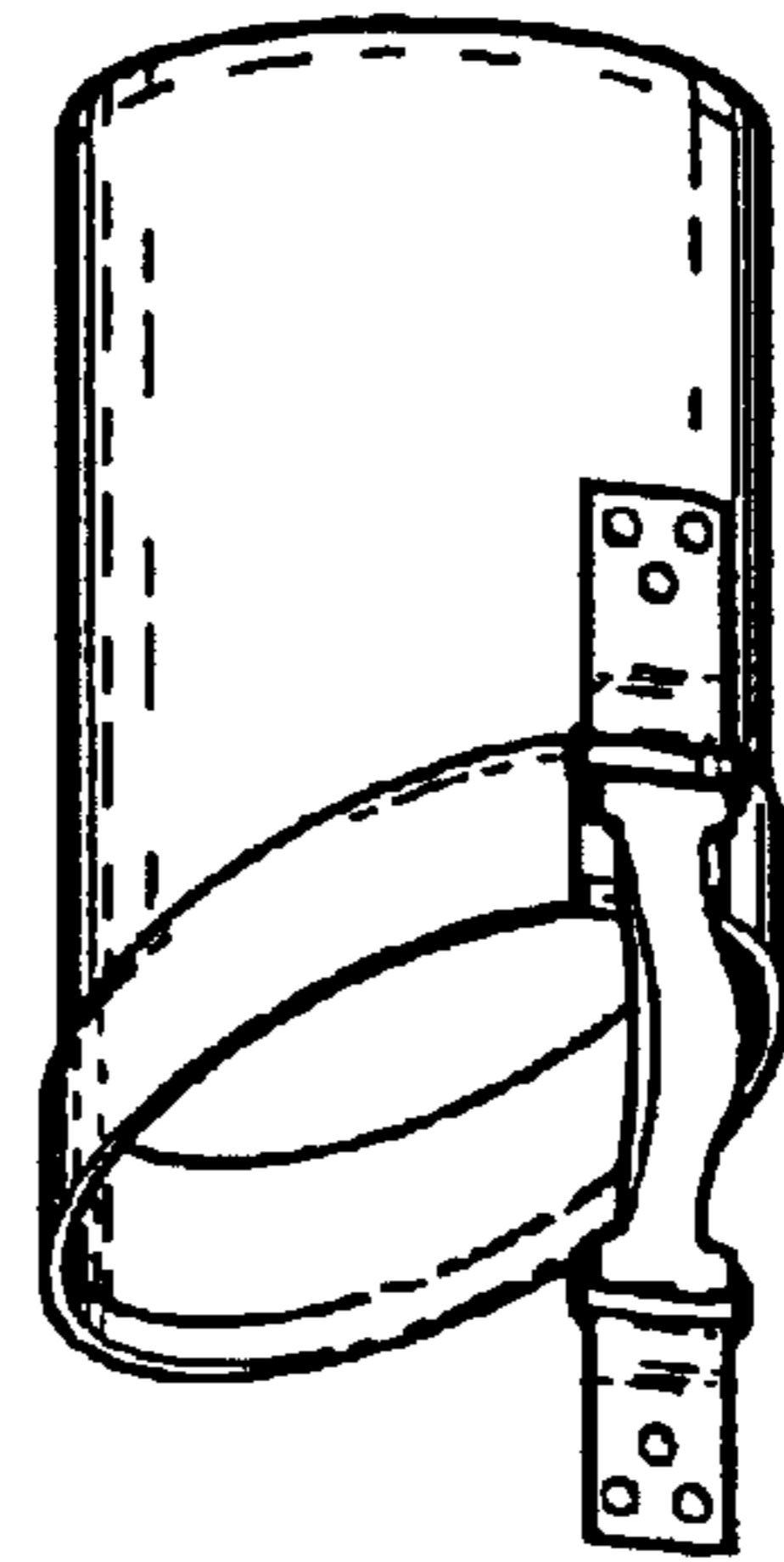

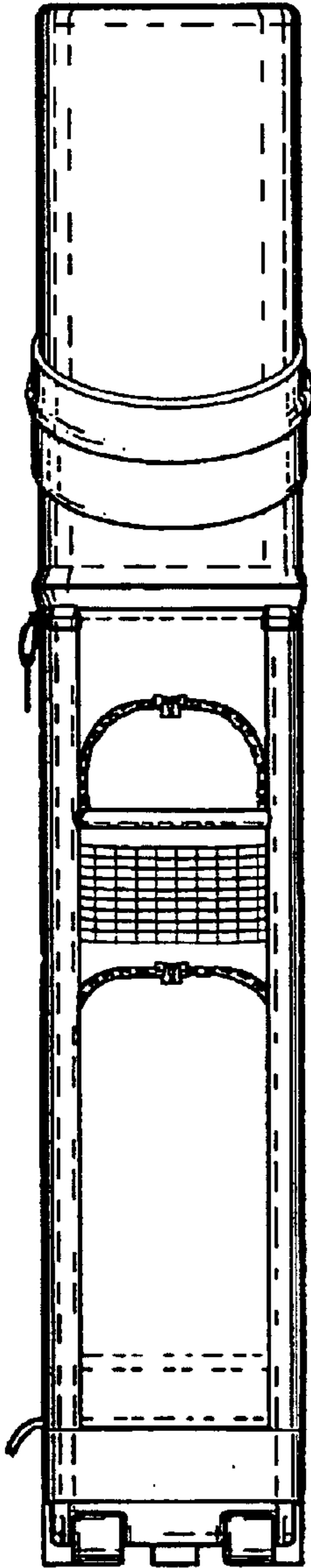

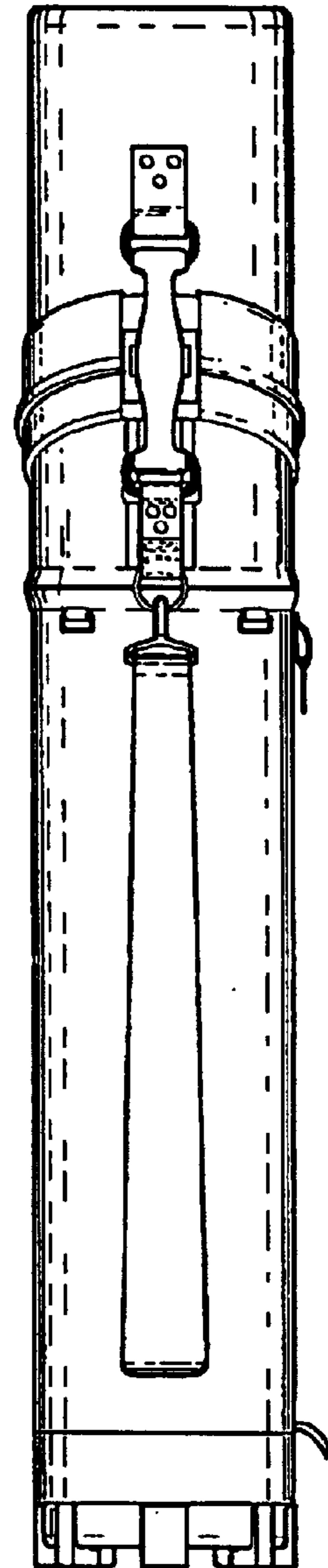

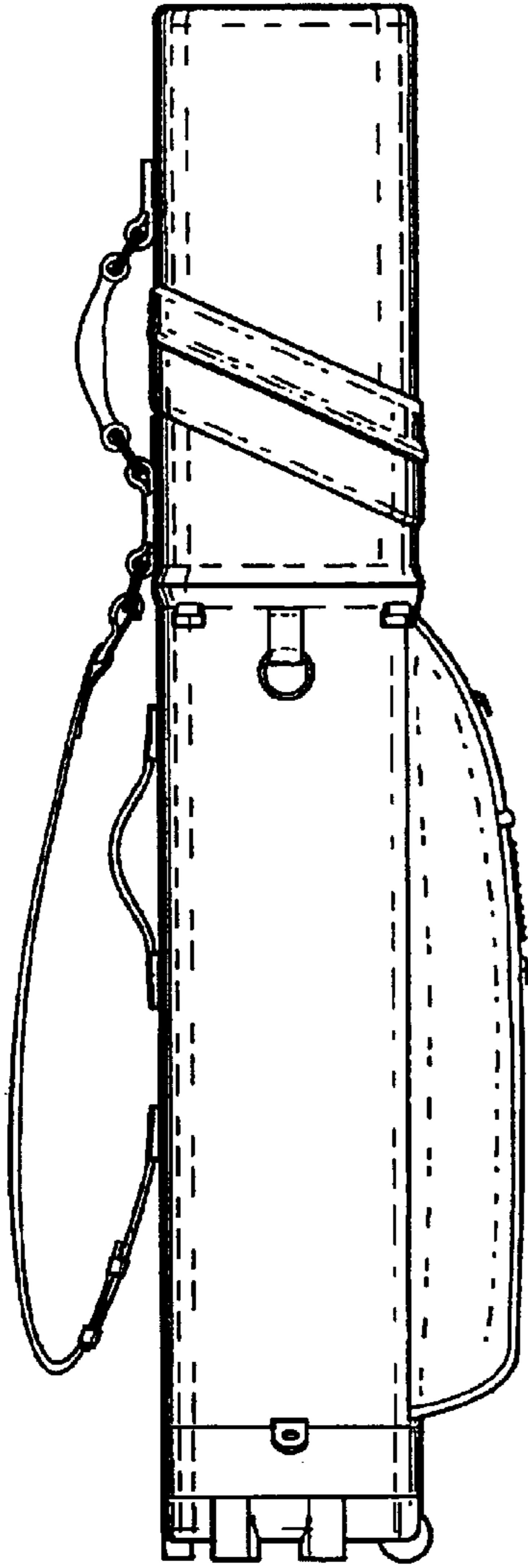

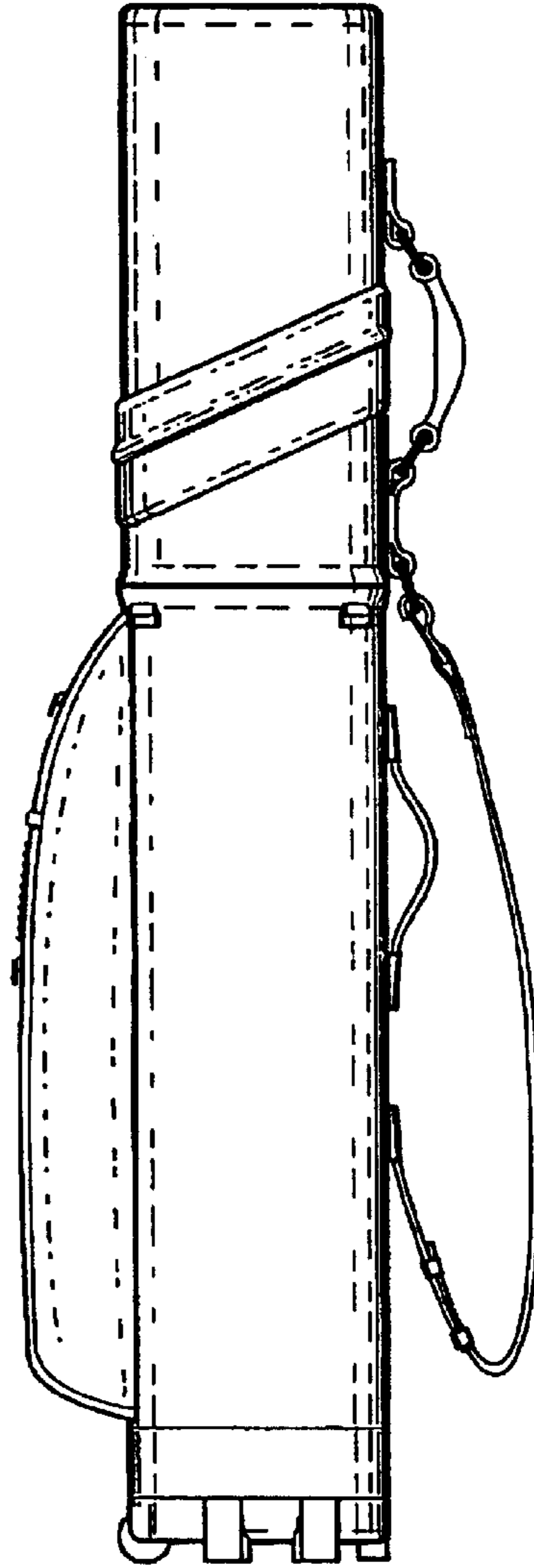

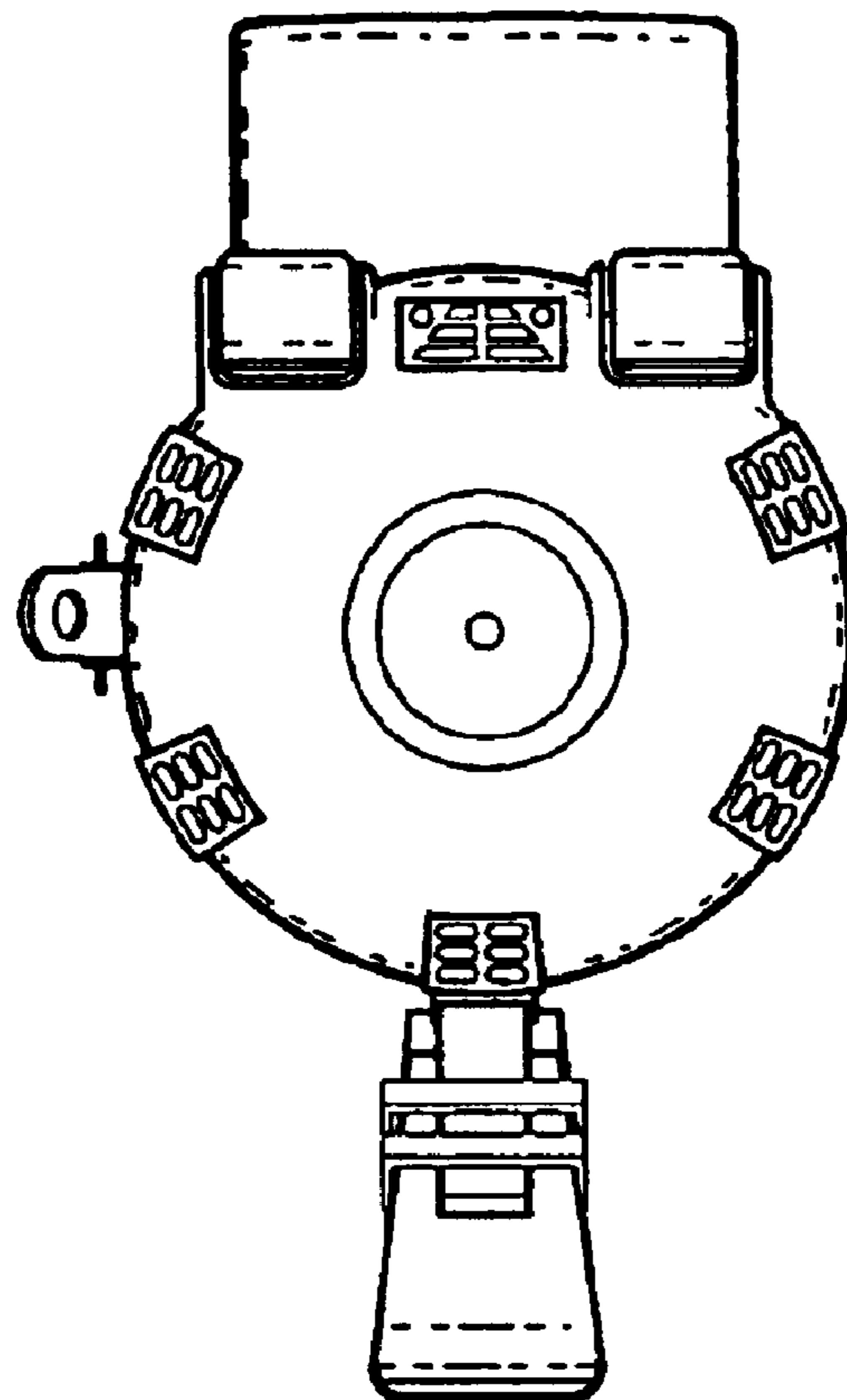

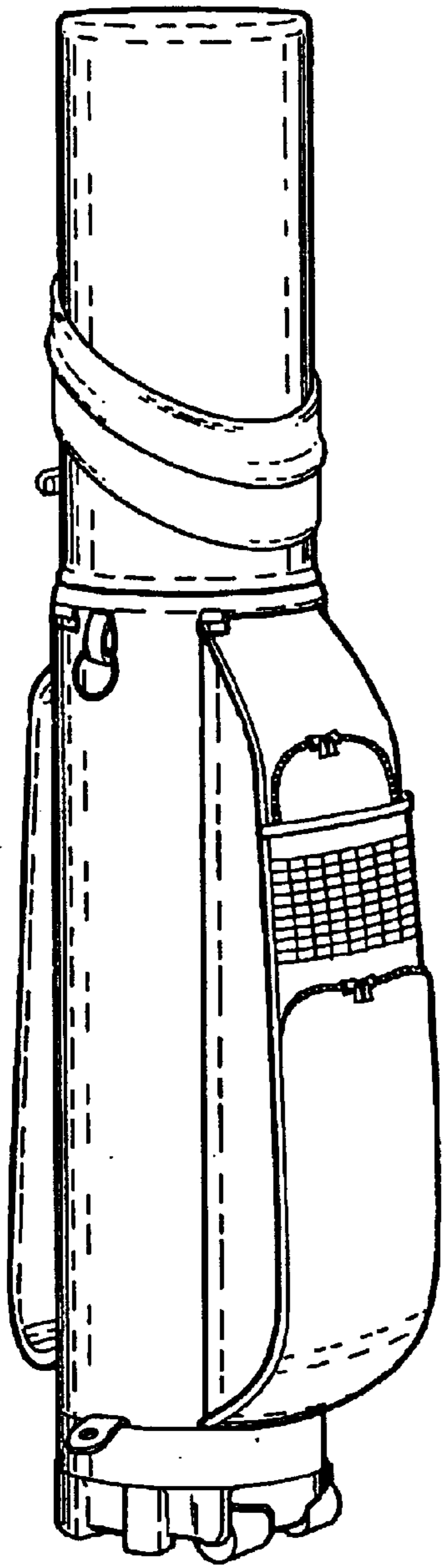

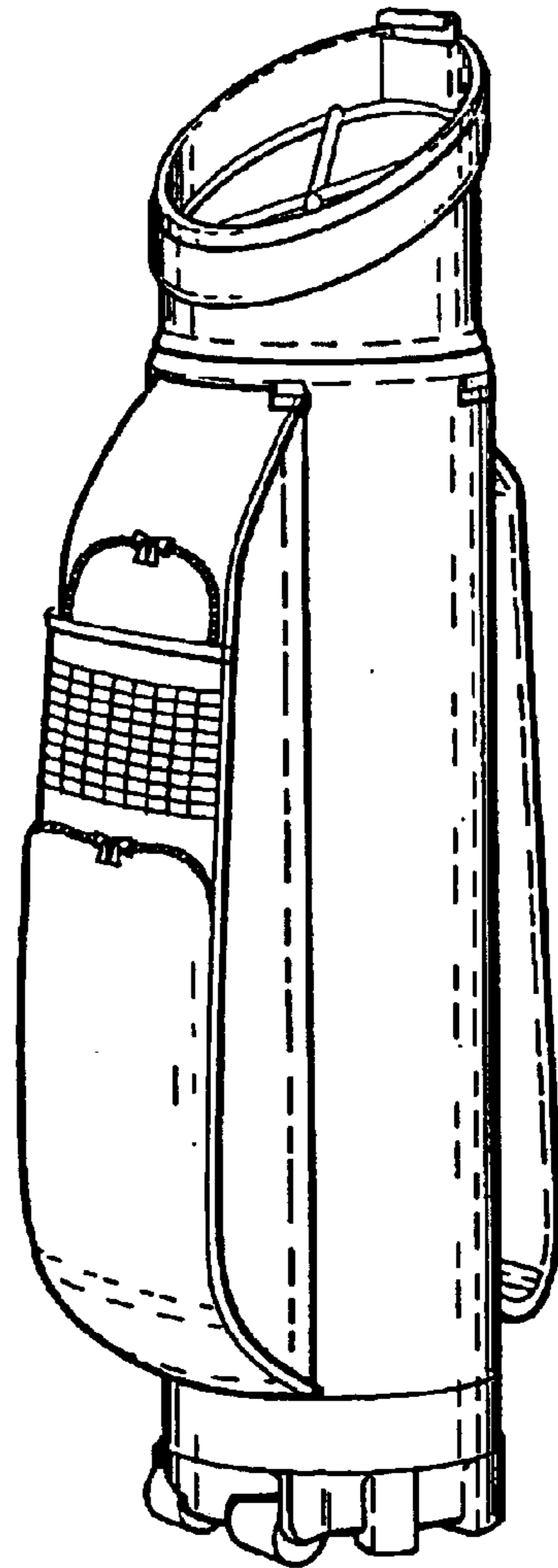
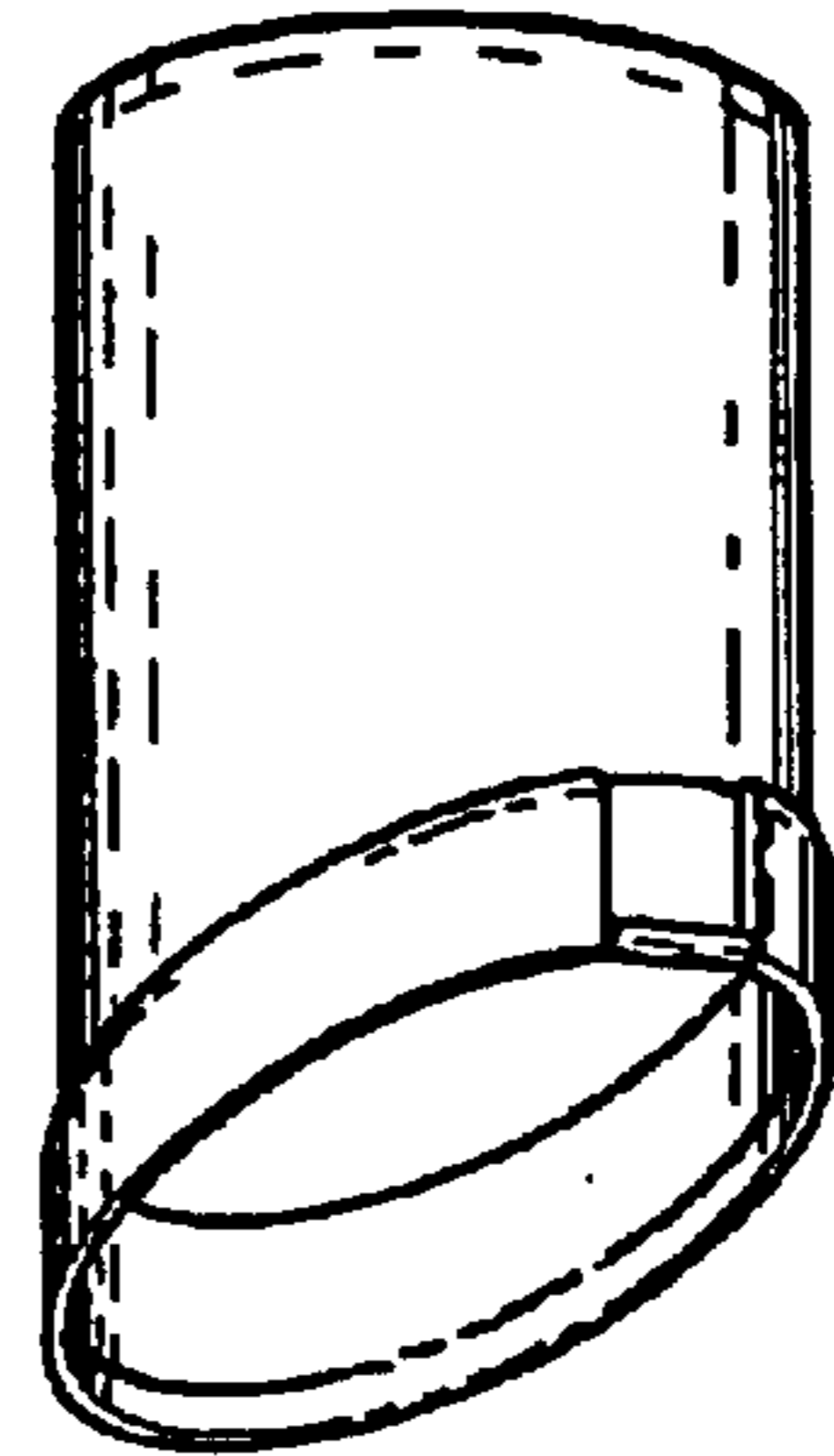

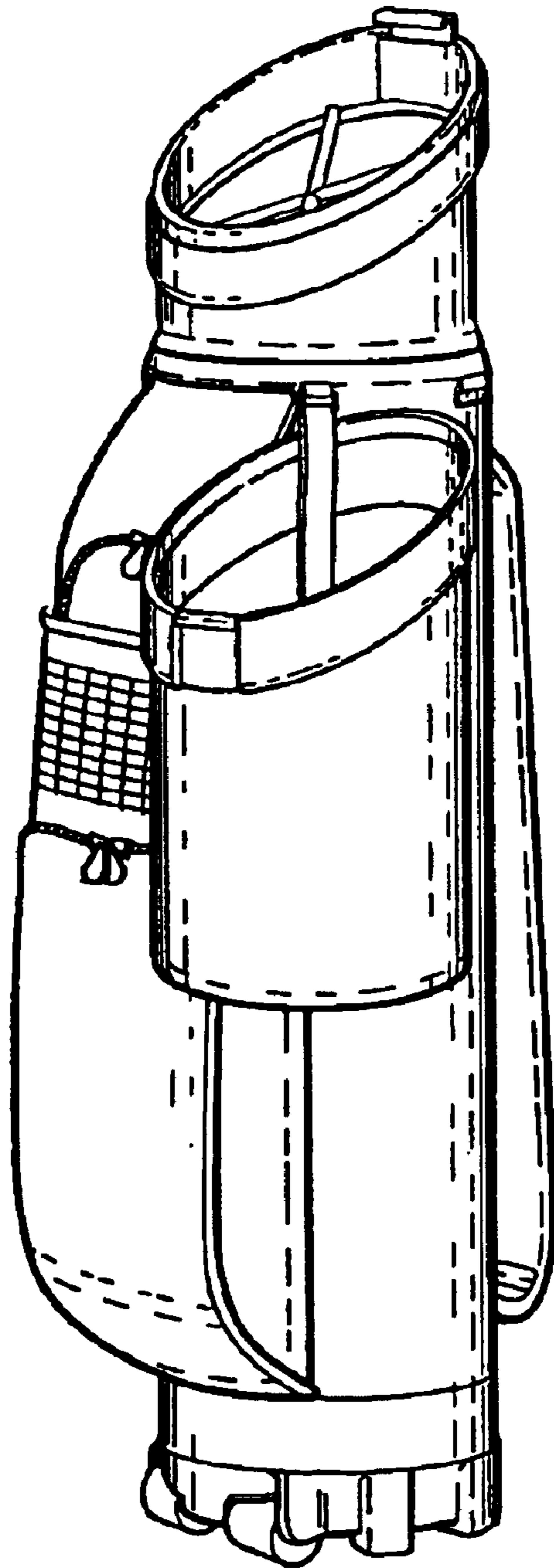

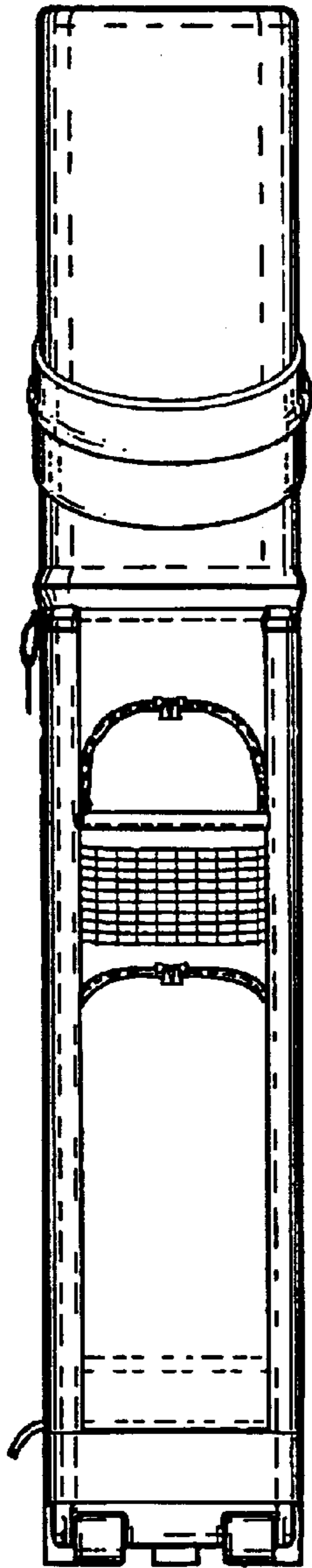

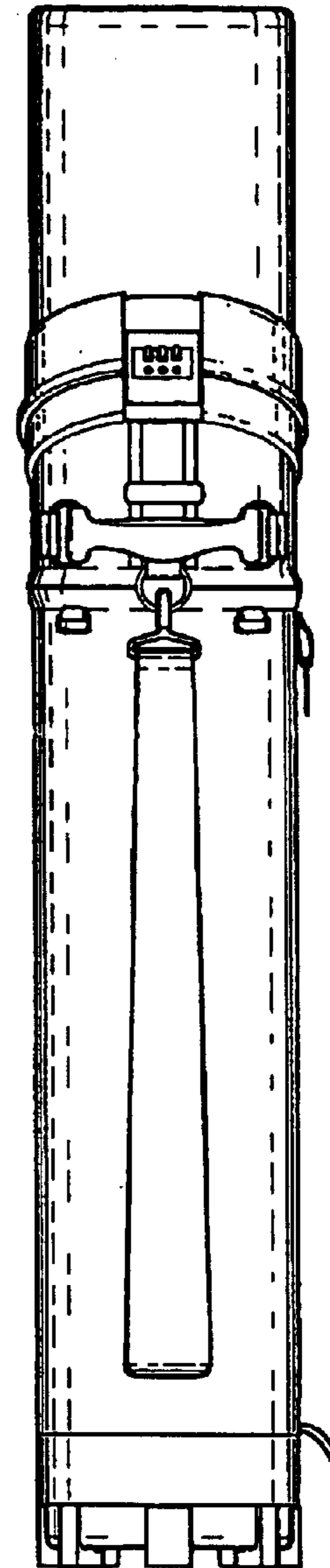

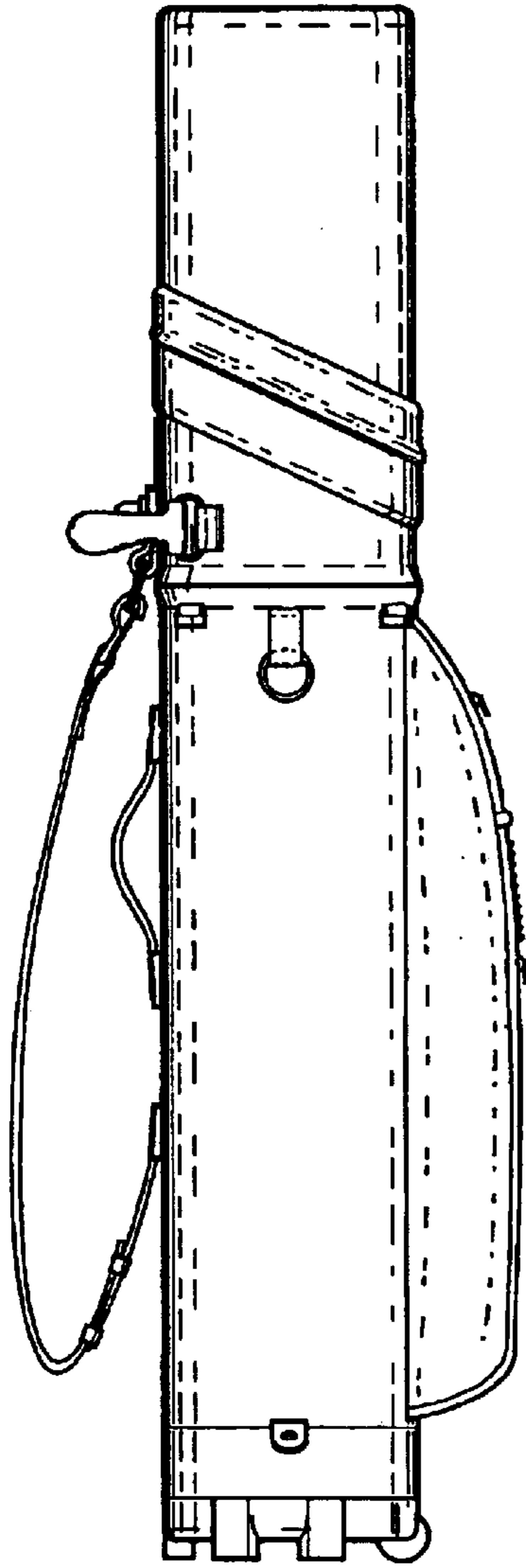

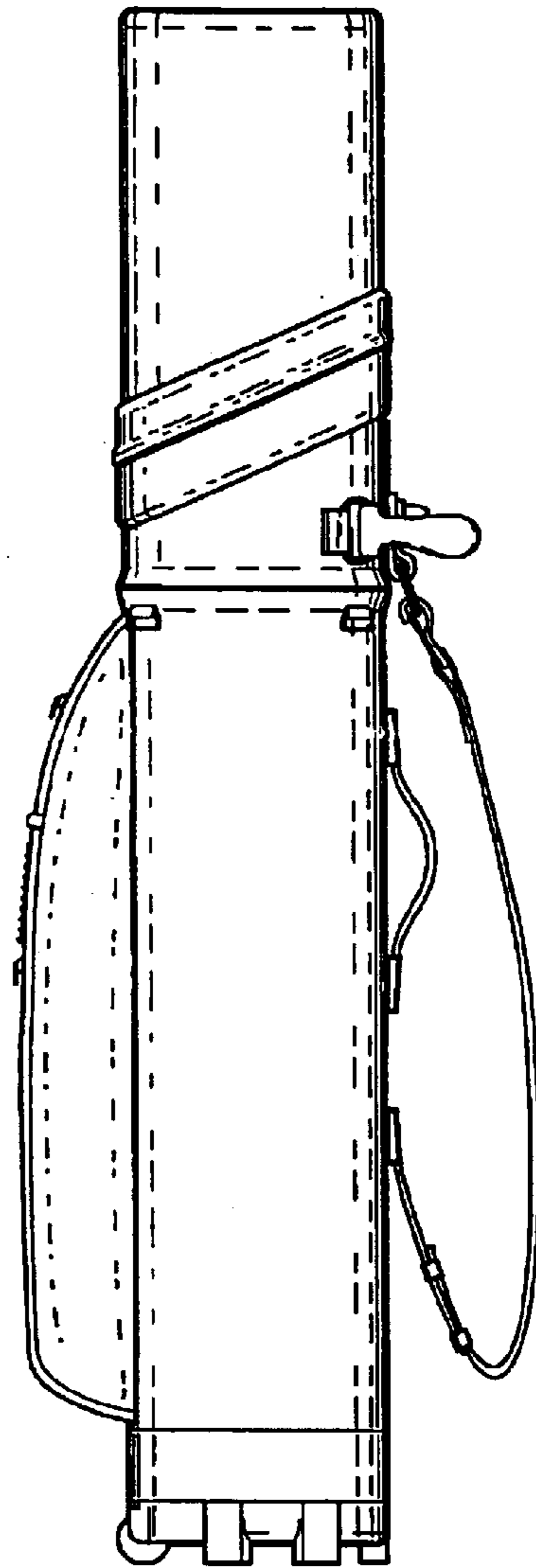
