(57) **CLAIM**

The ornamental design for a seat, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a seat in the form of a chair;

FIG. 20 is a left hand side elevational view thereof, the right hand side being a mirror image thereof;

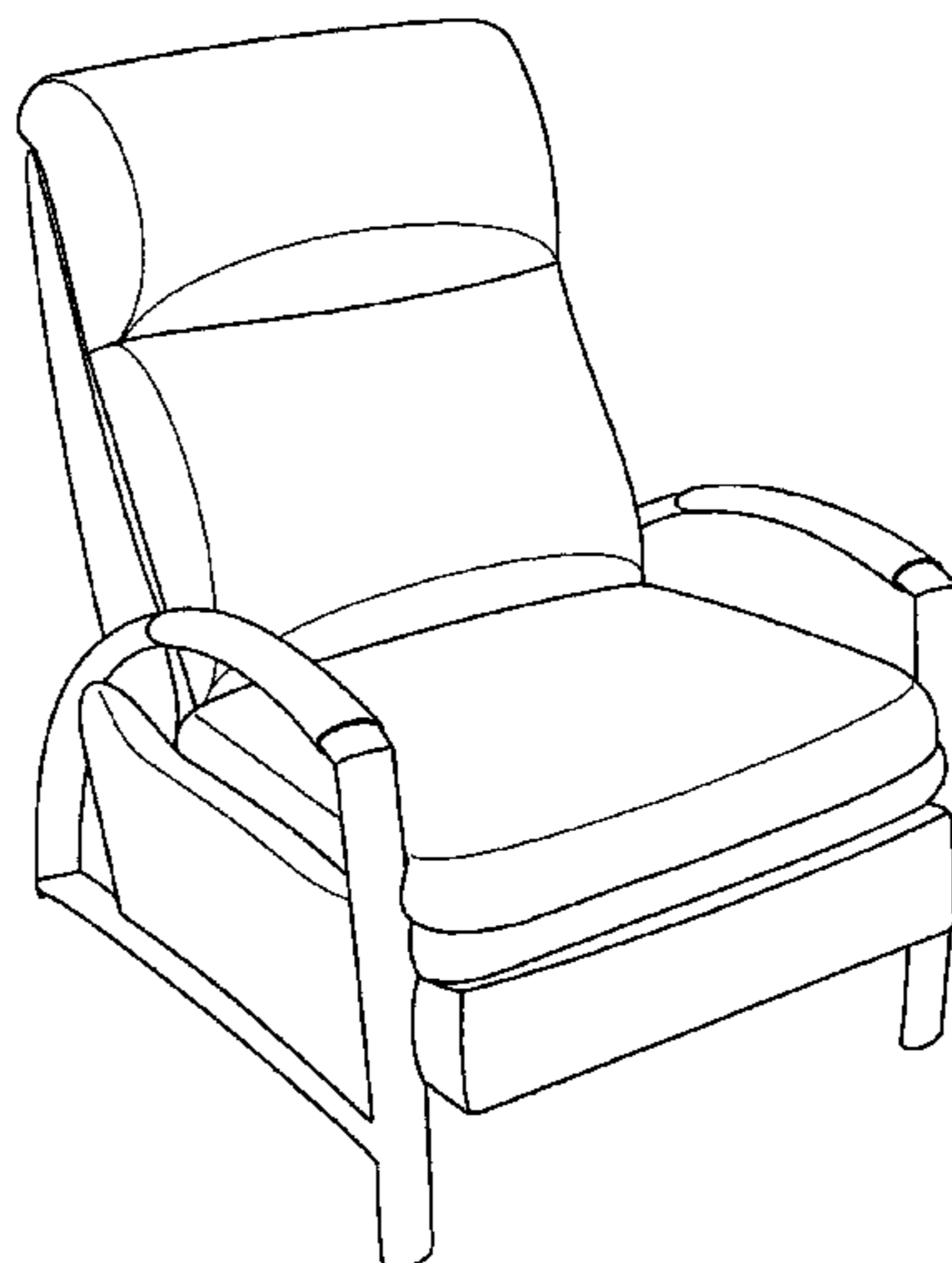
FIG. 21 is a perspective view of a sixth embodiment of a seat in the form of a three seater sofa;

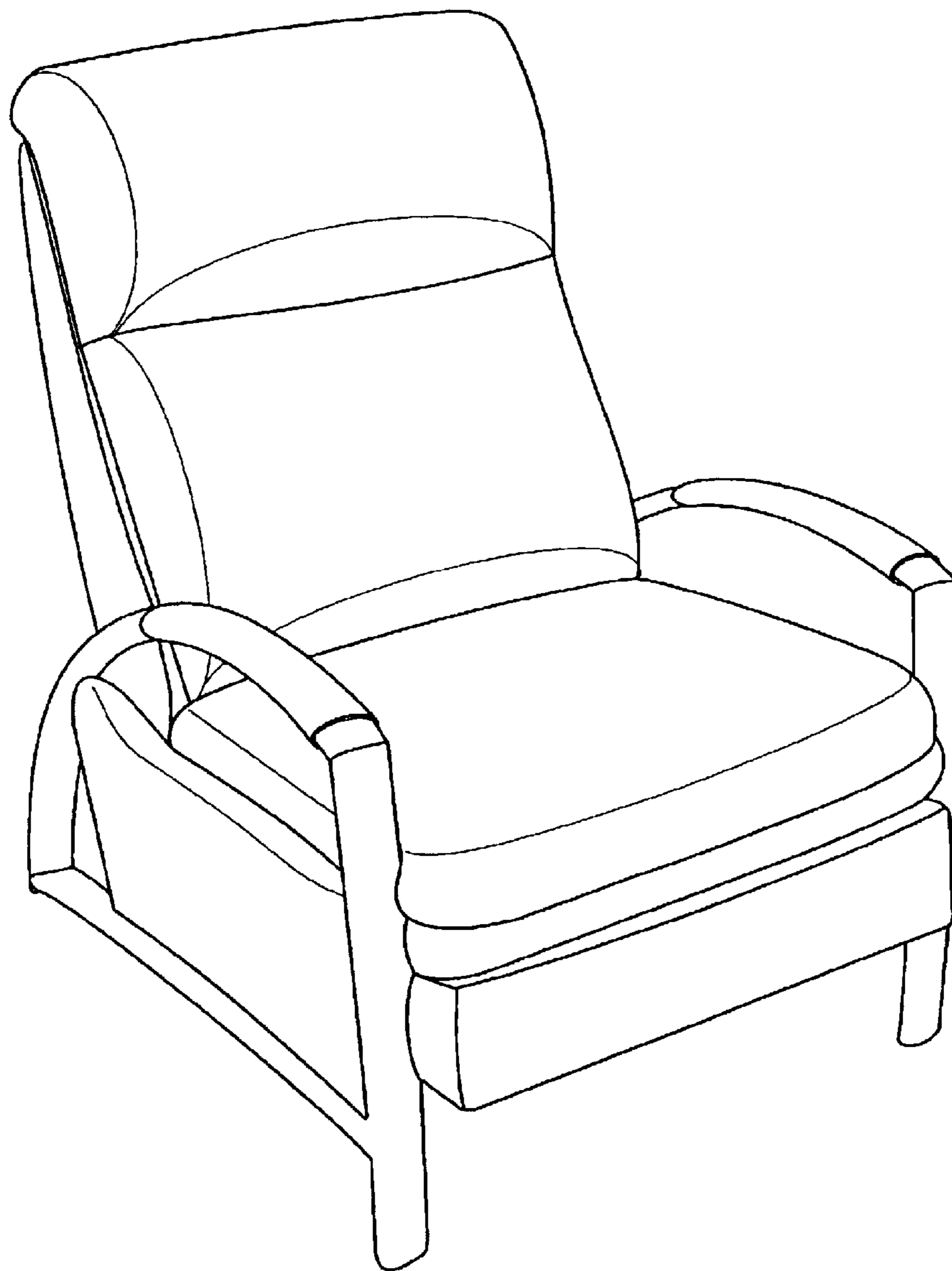
FIG. 22 is a front view thereof;

FIG. 24 is a left hand side elevational view thereof, the right hand side being a mirror image thereof.

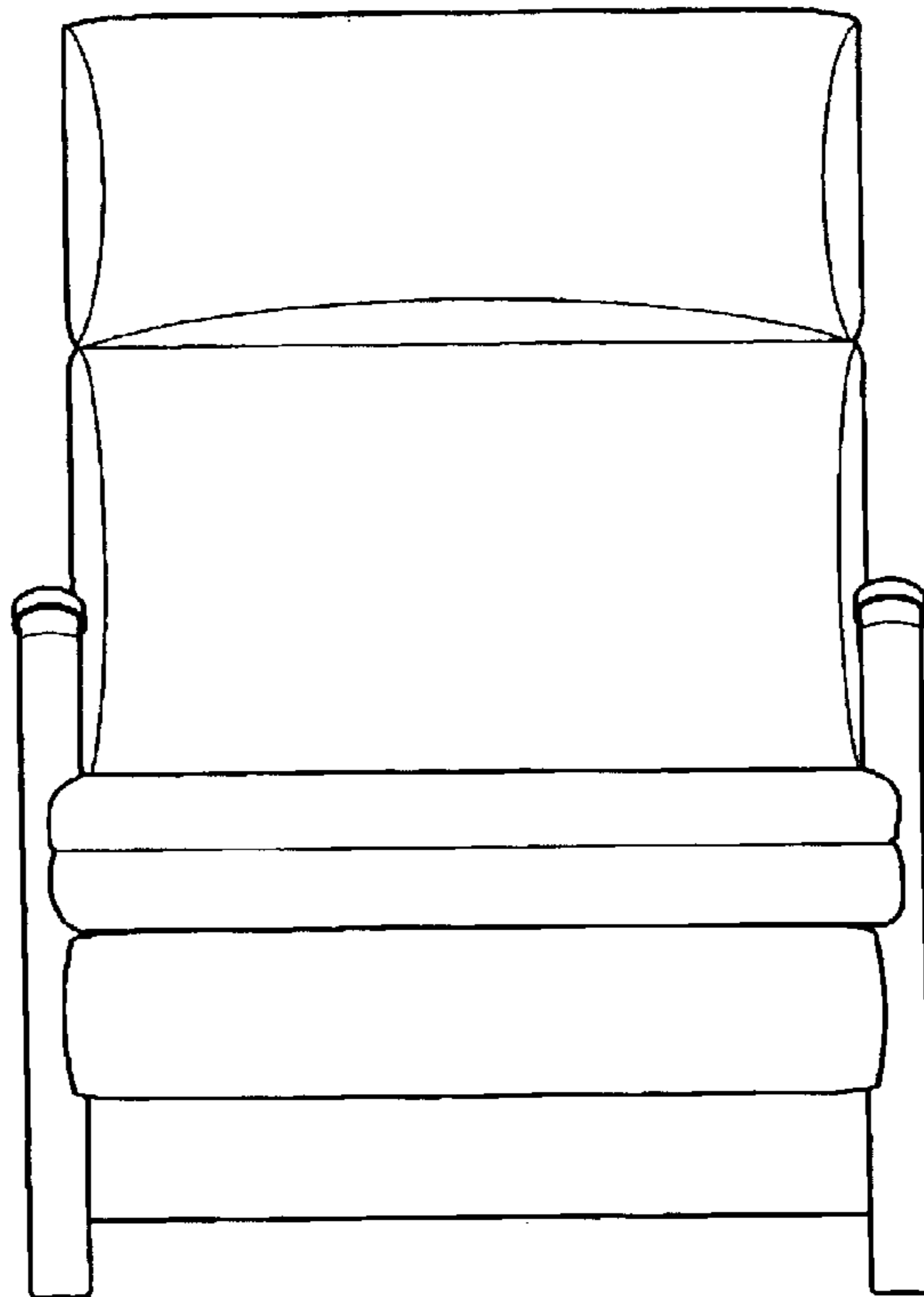

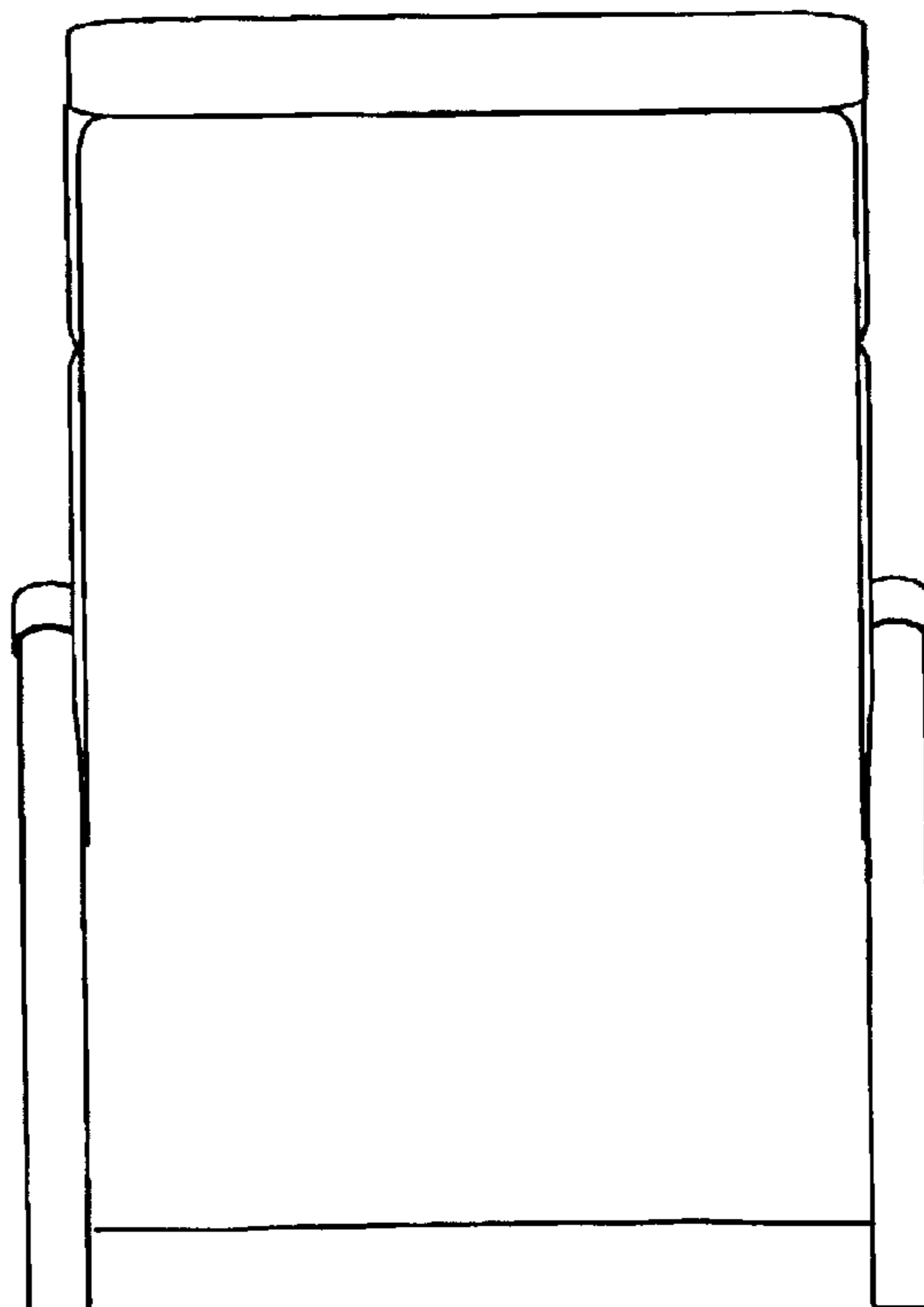


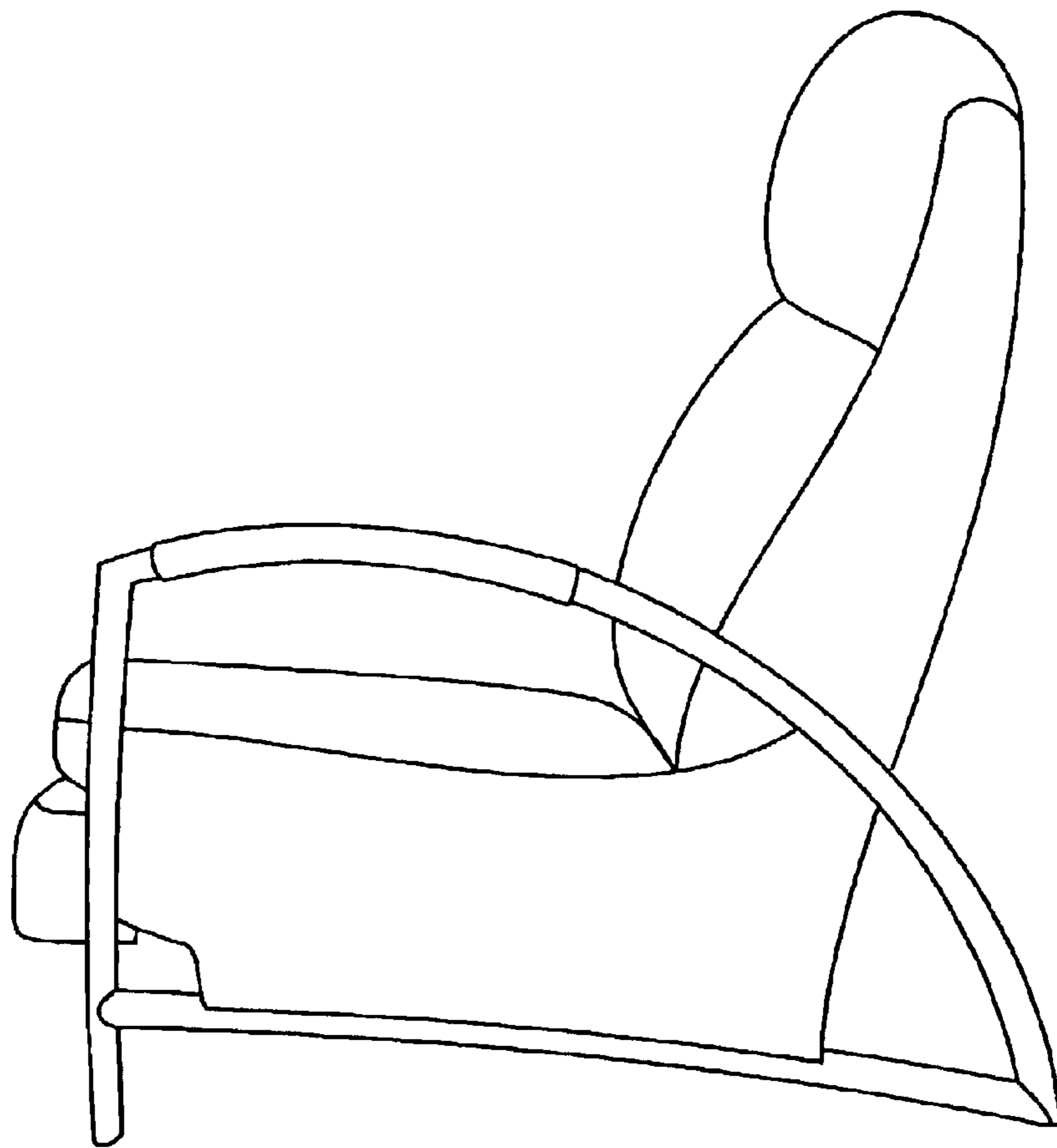

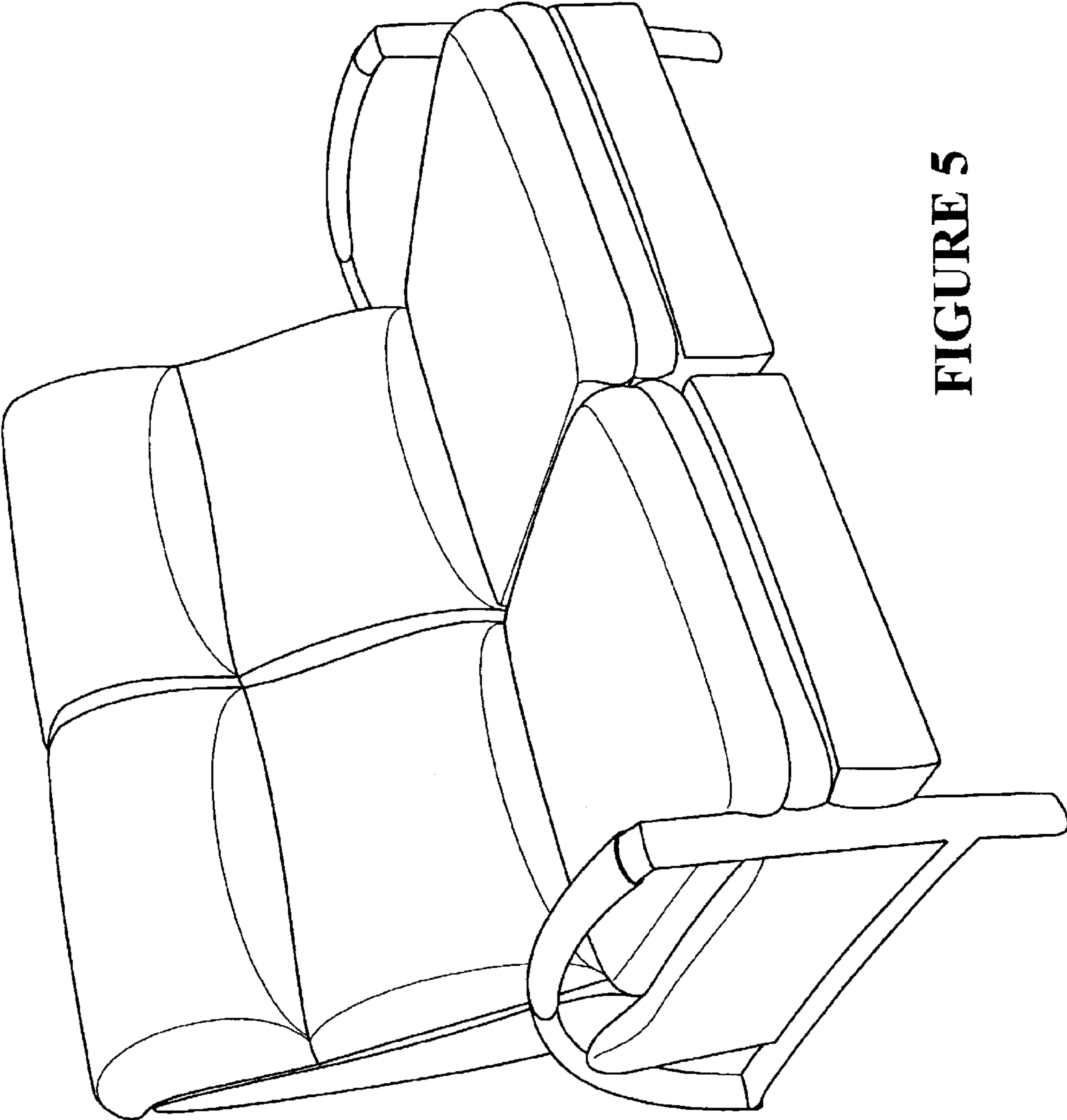
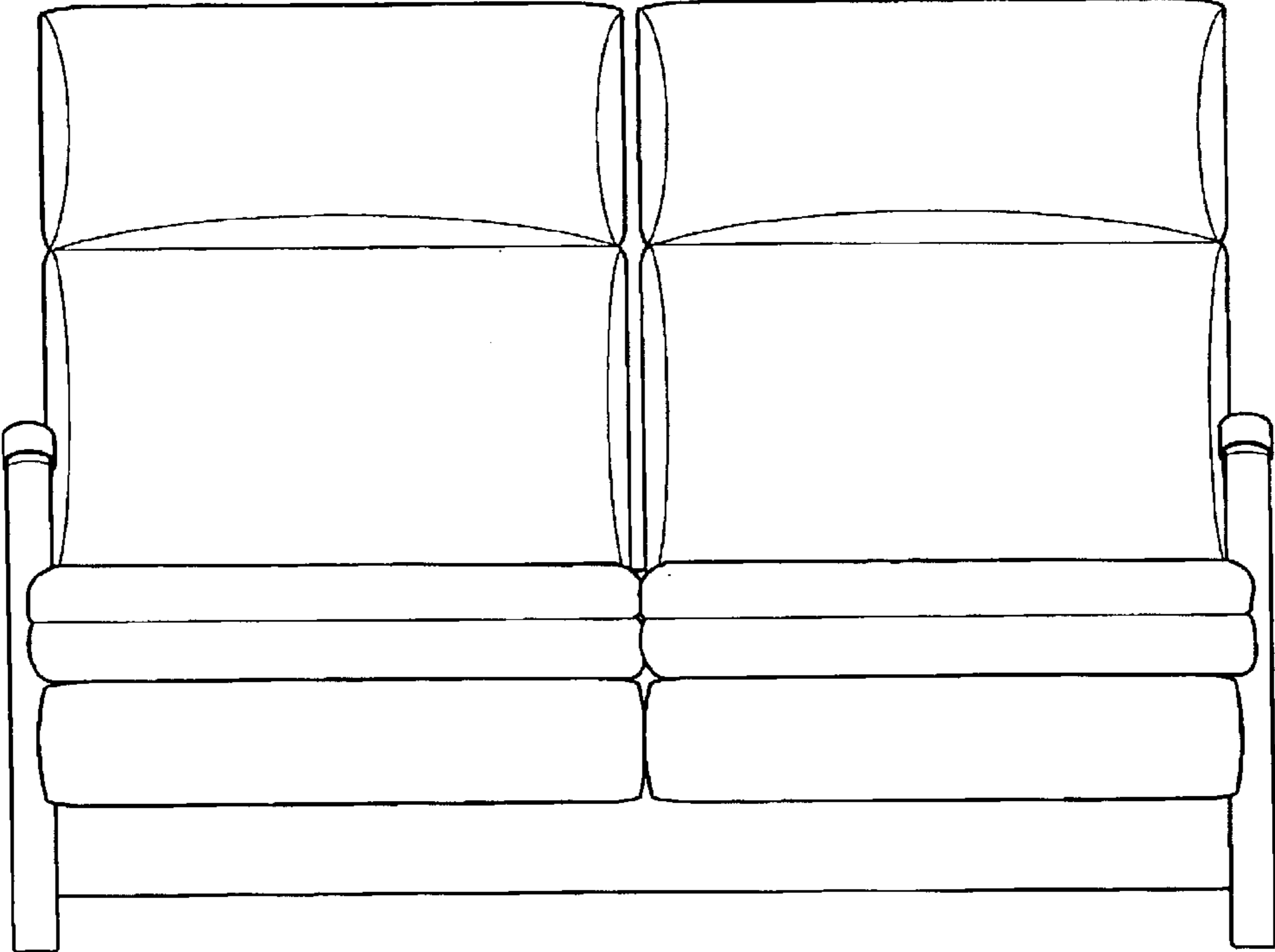
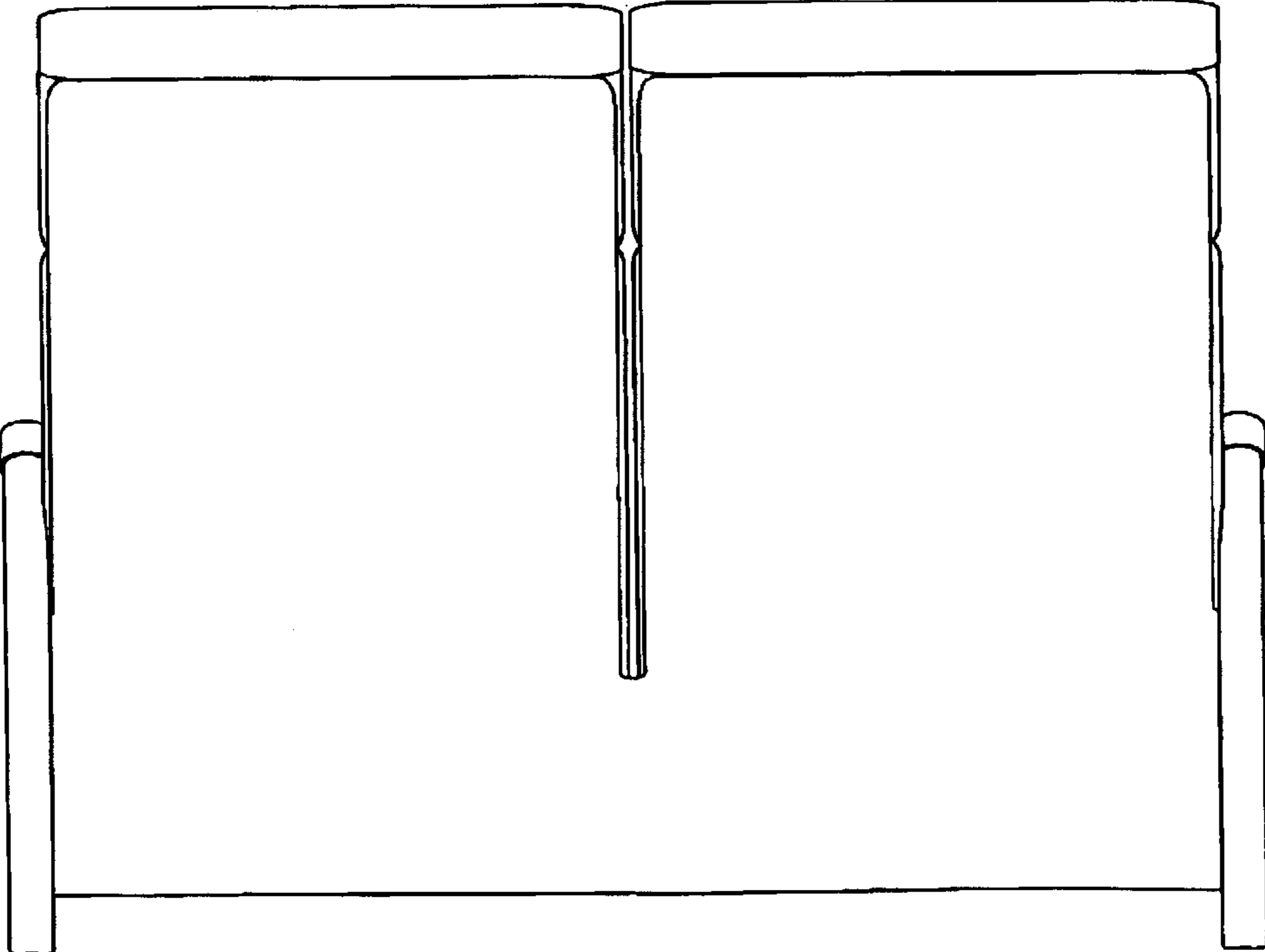


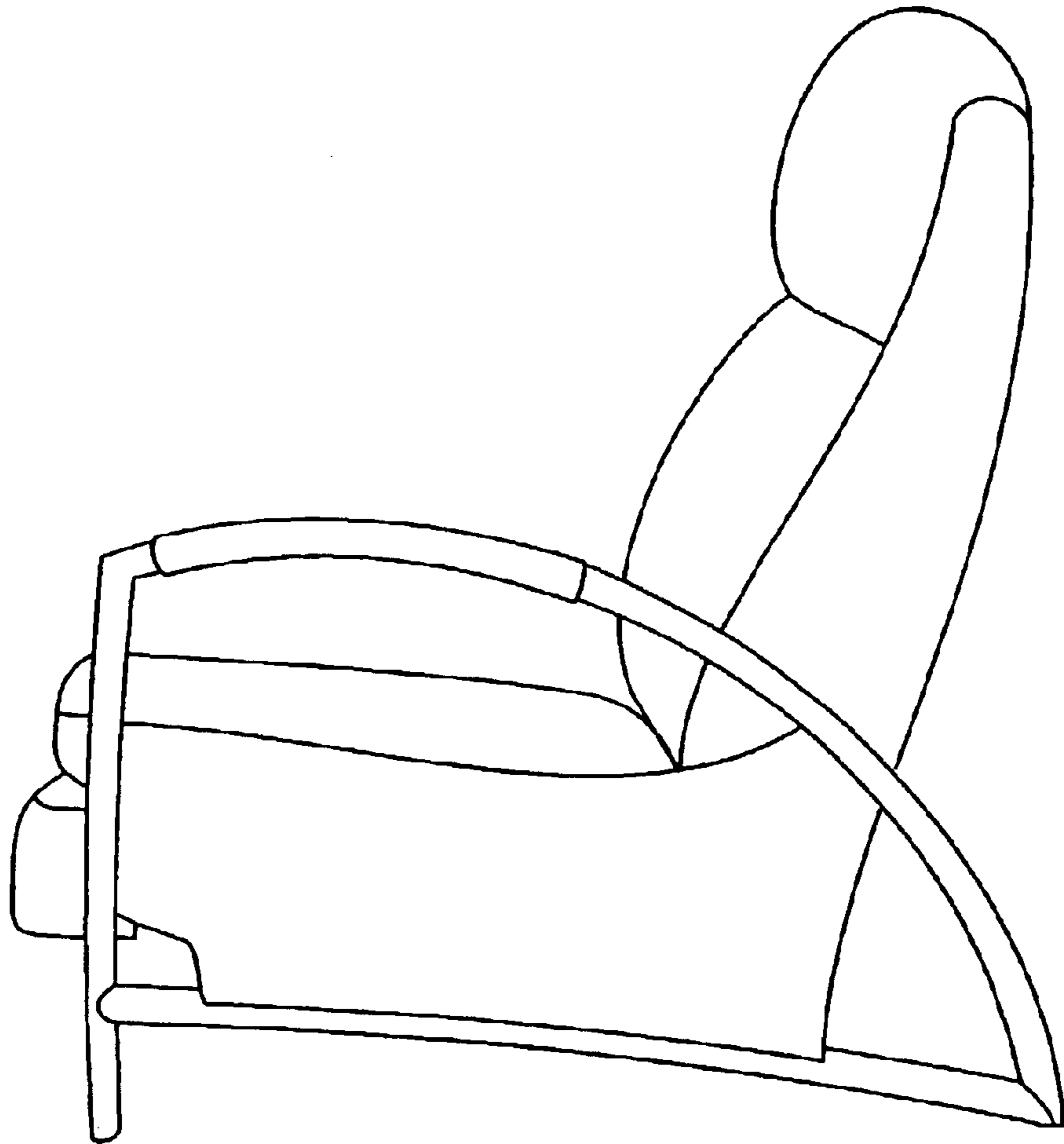

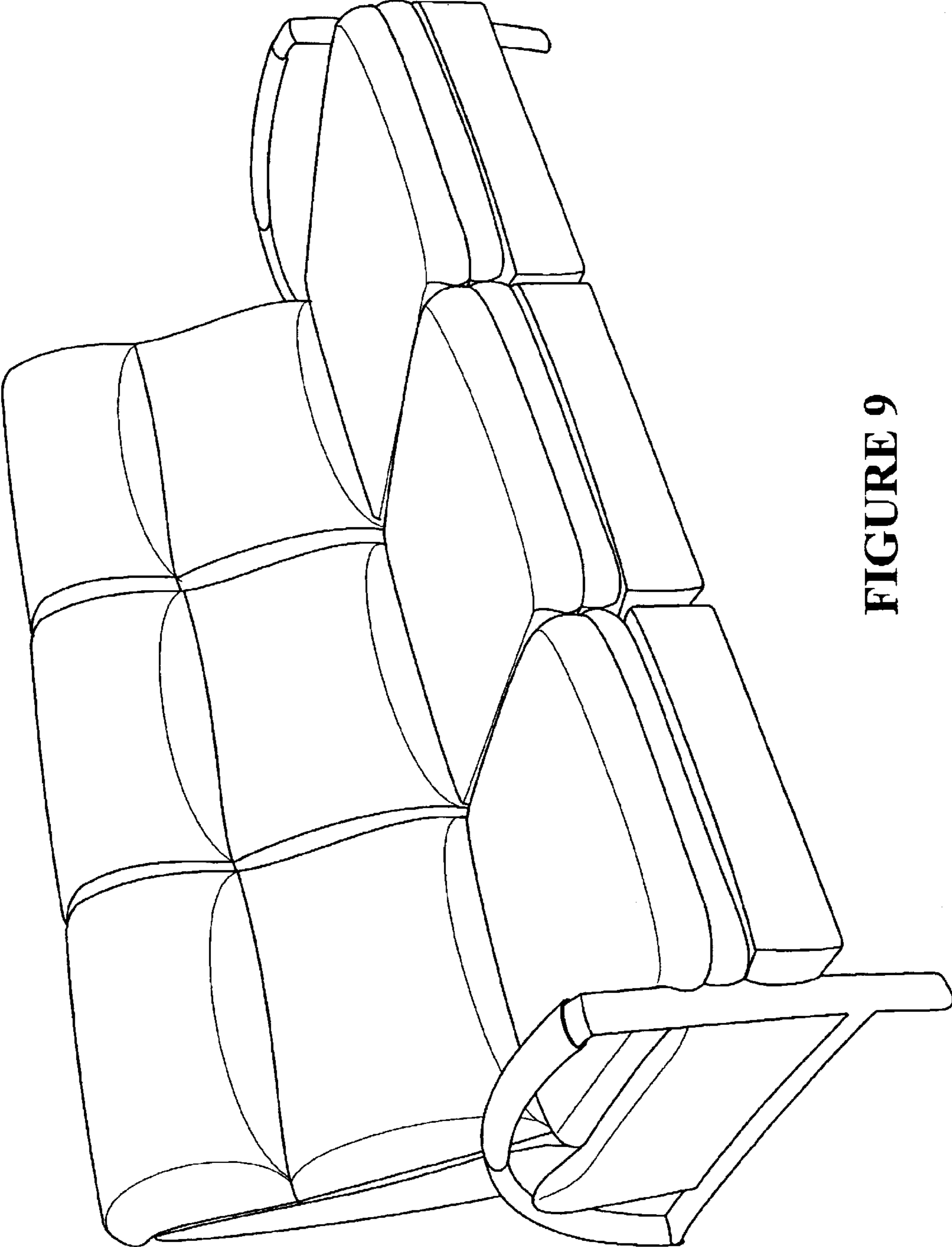

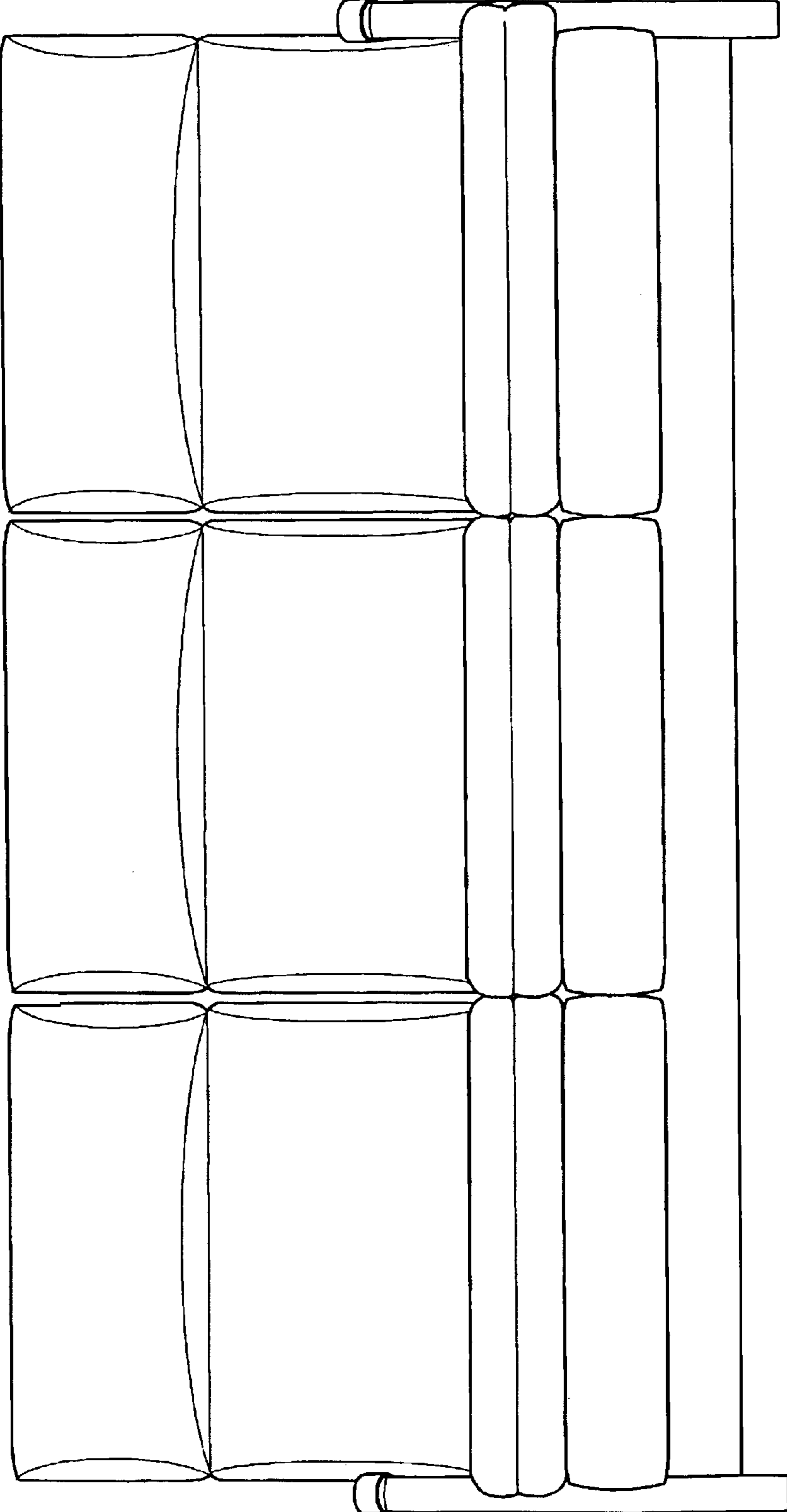

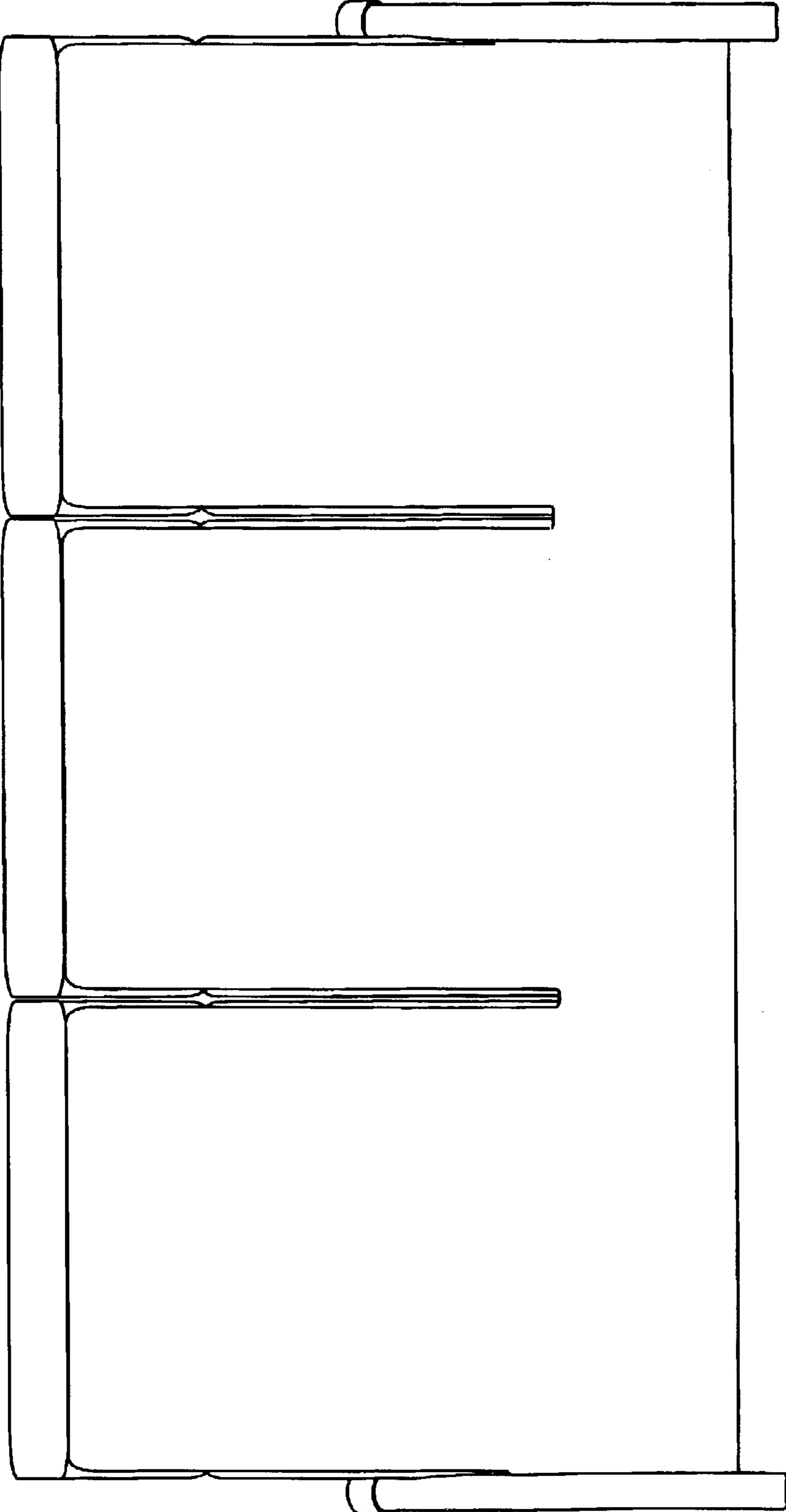
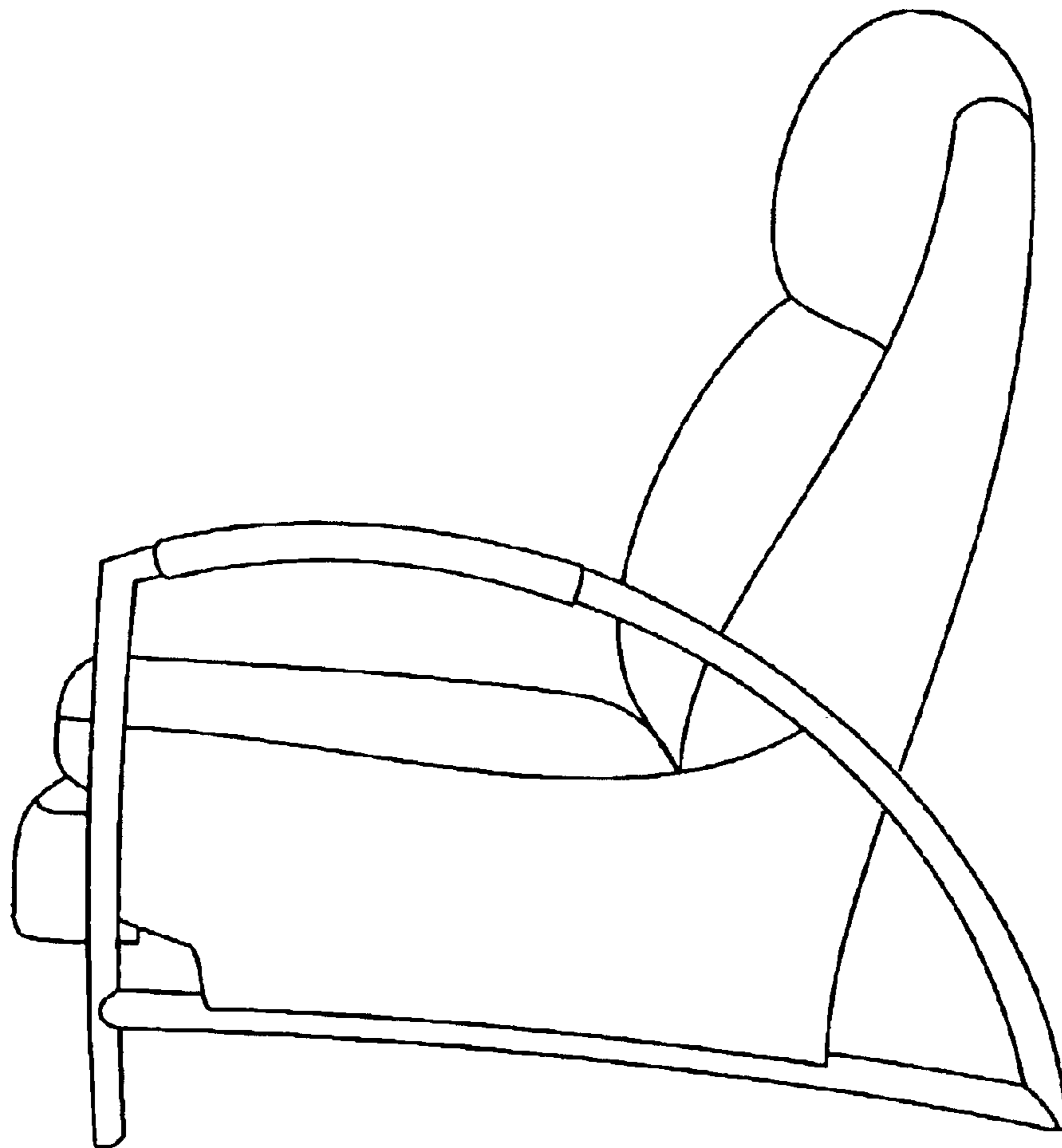
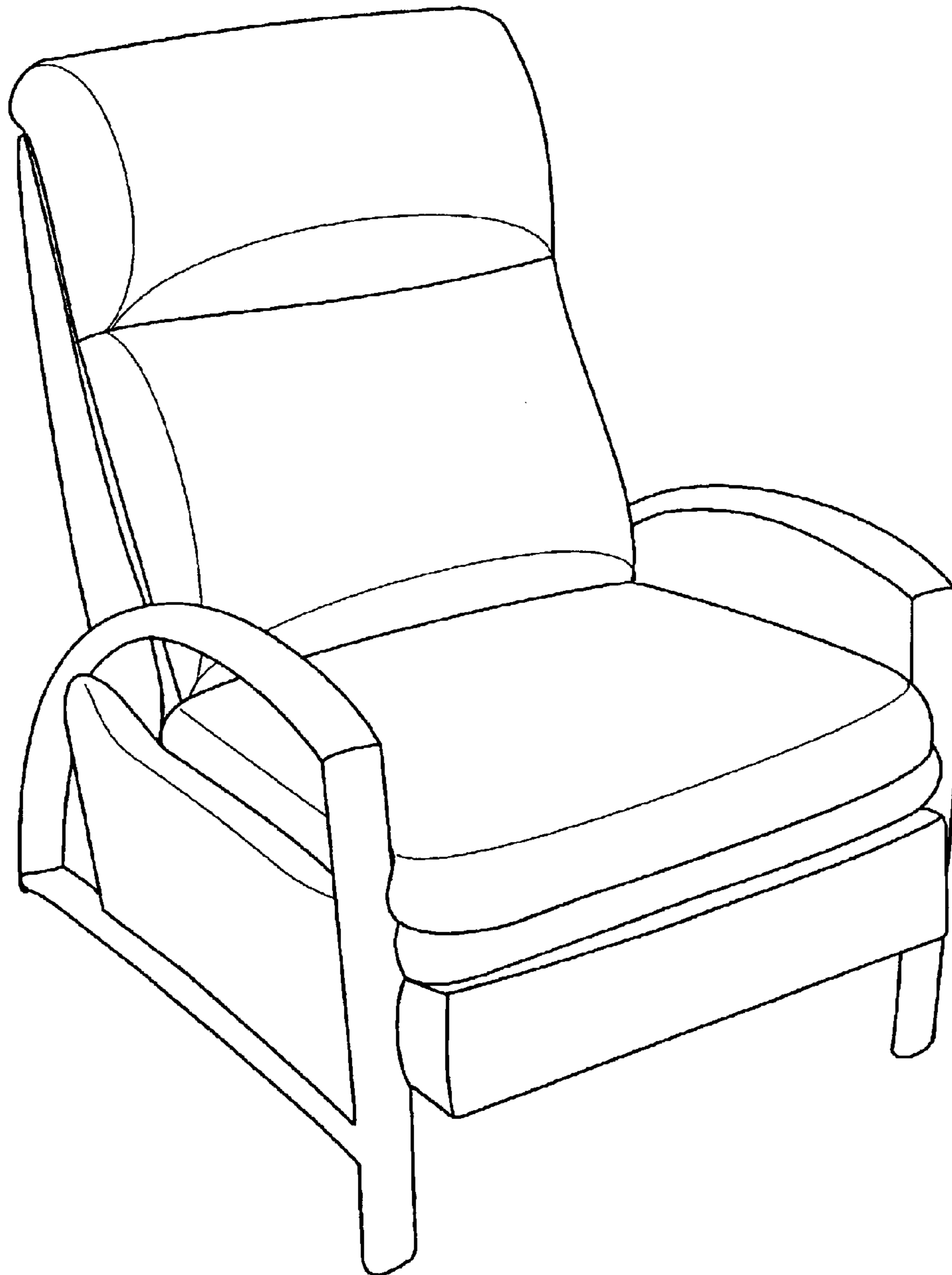

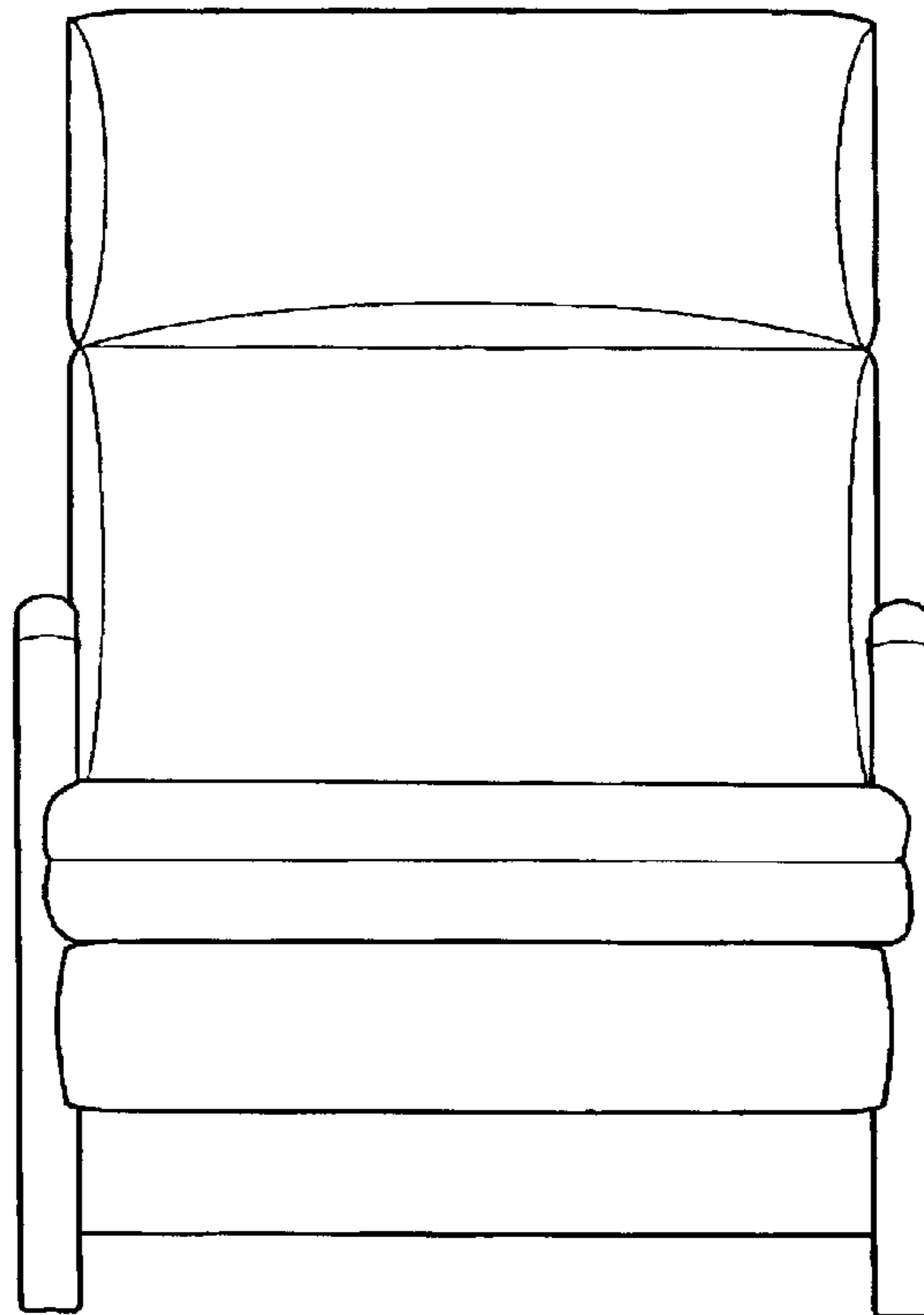


**FIGURE 12**

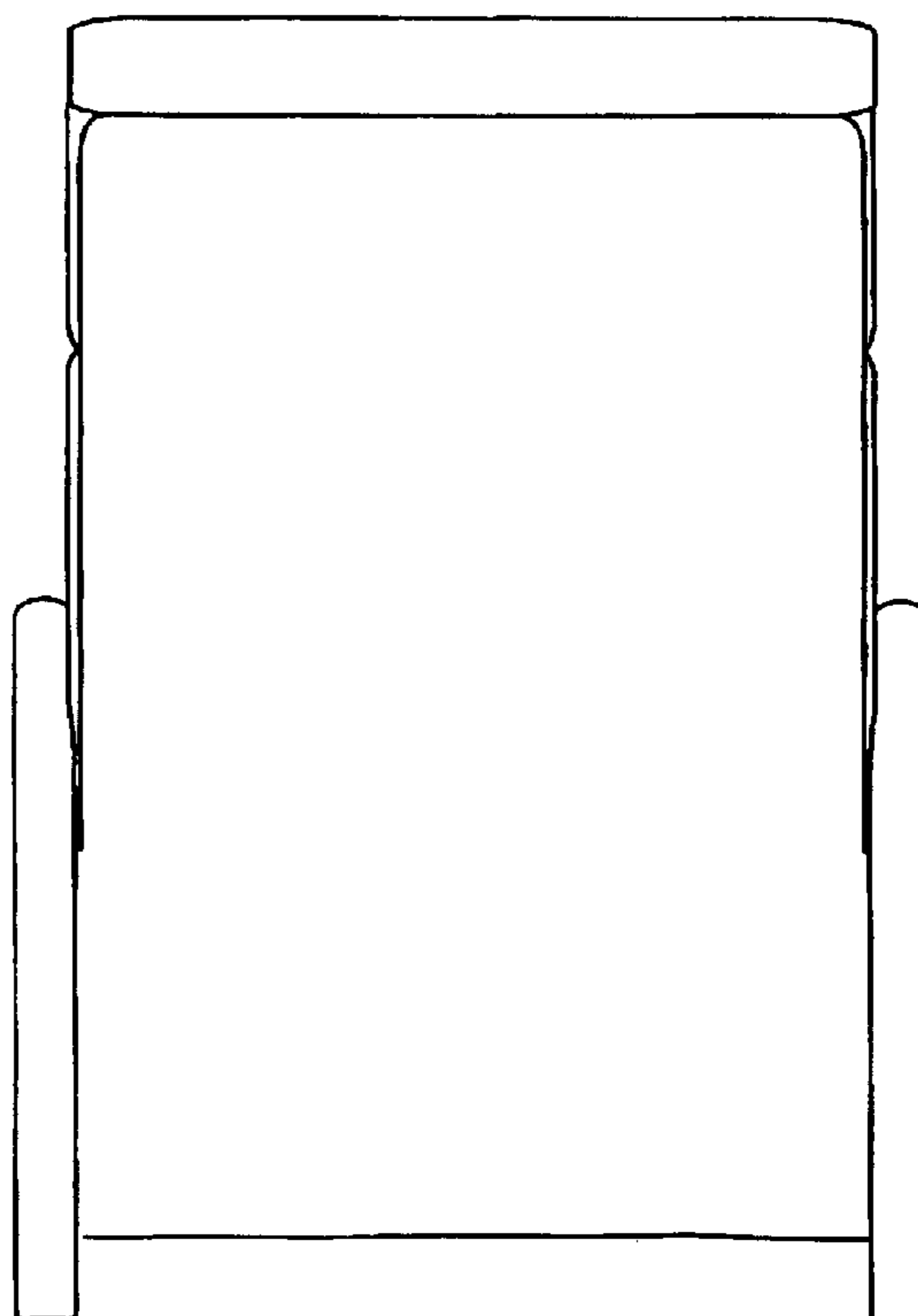


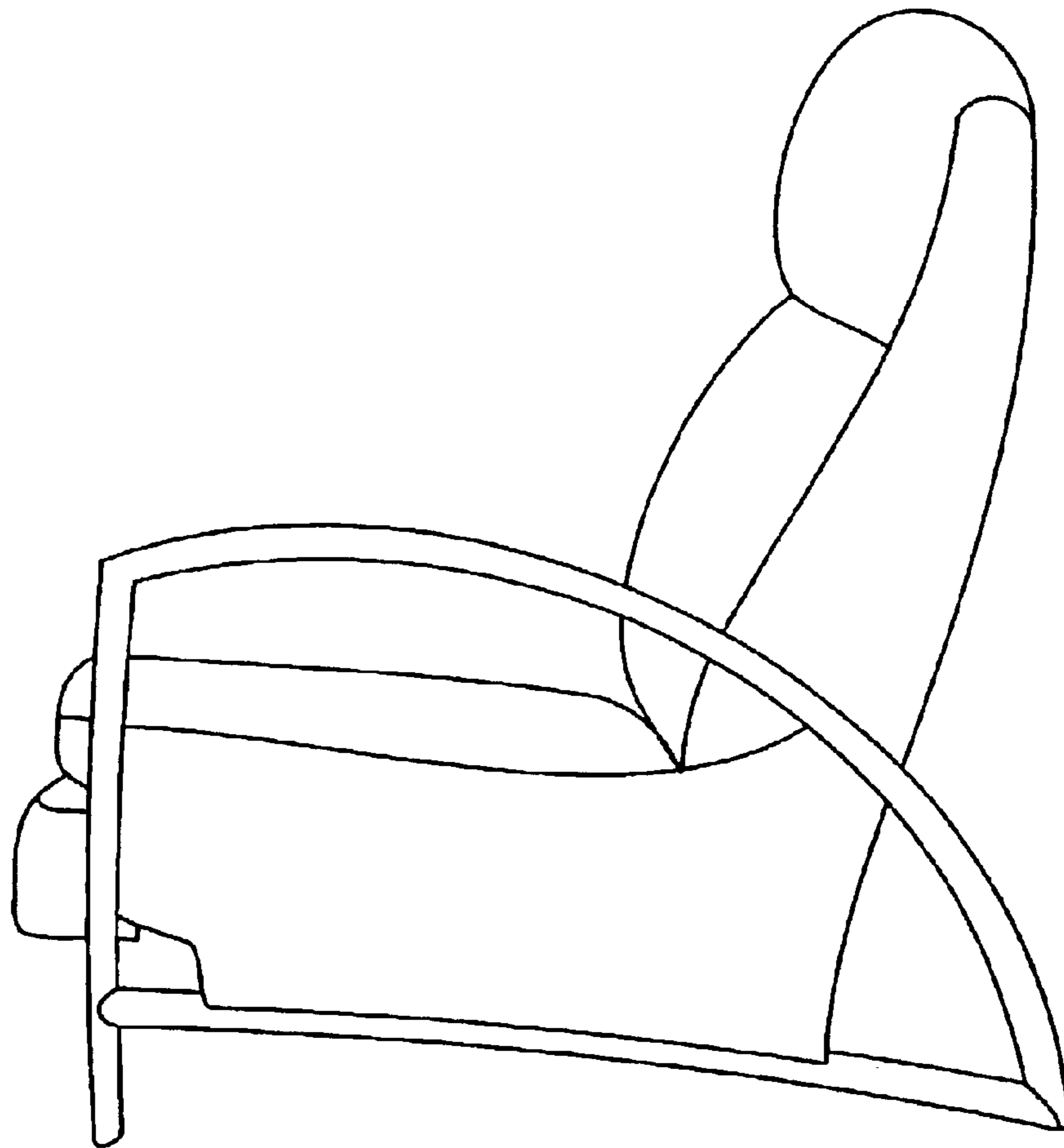
**FIGURE 13**

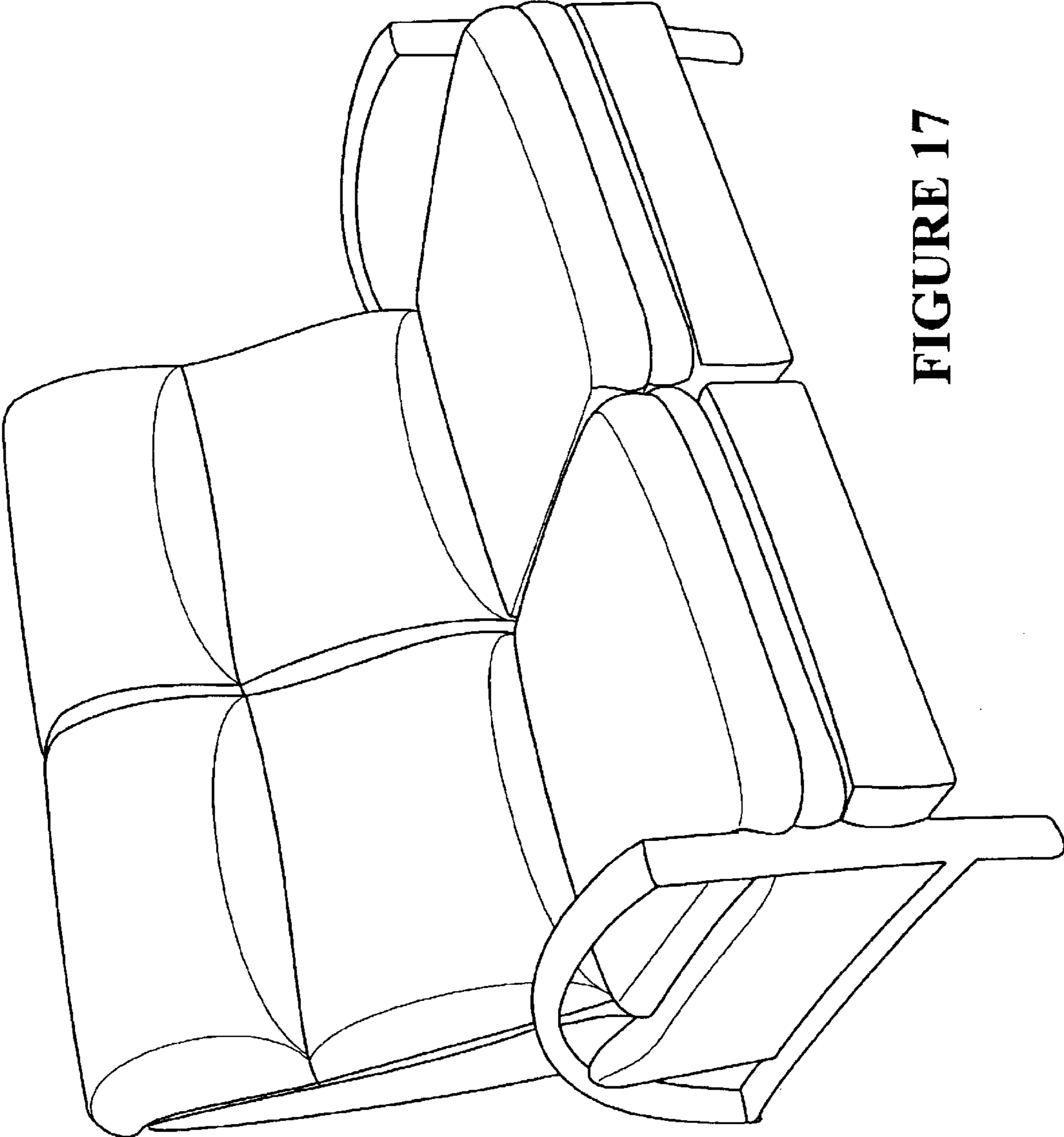
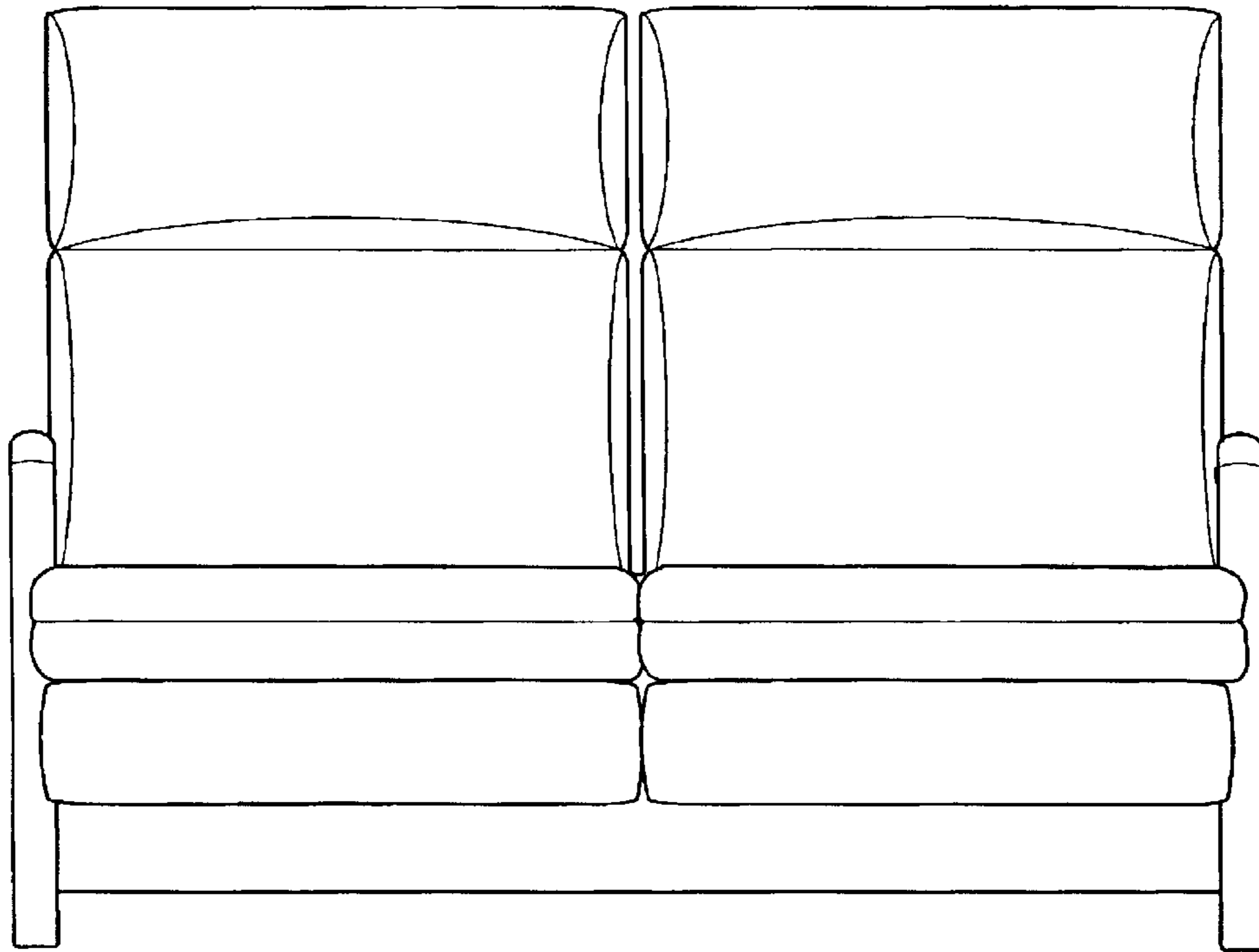
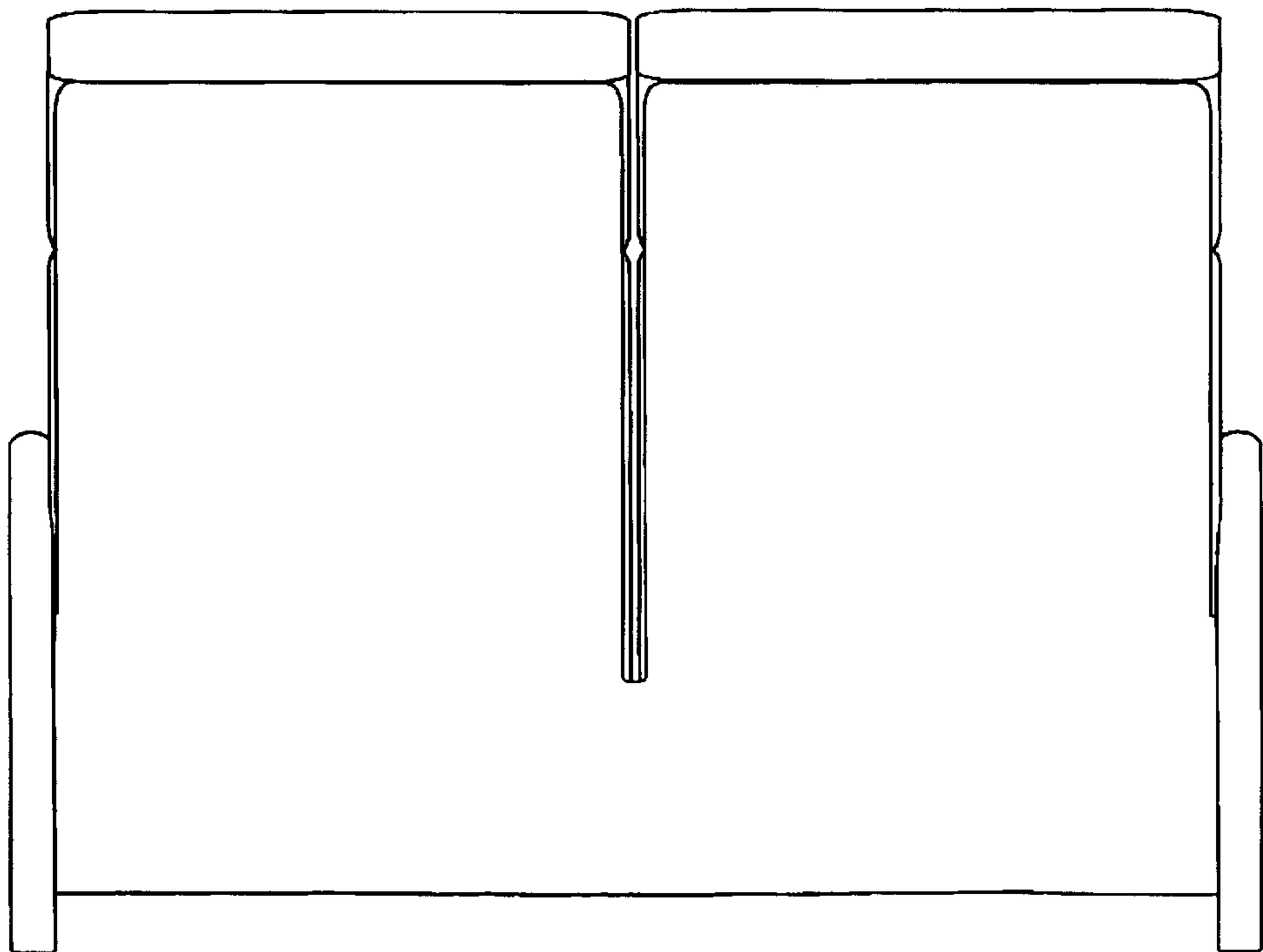

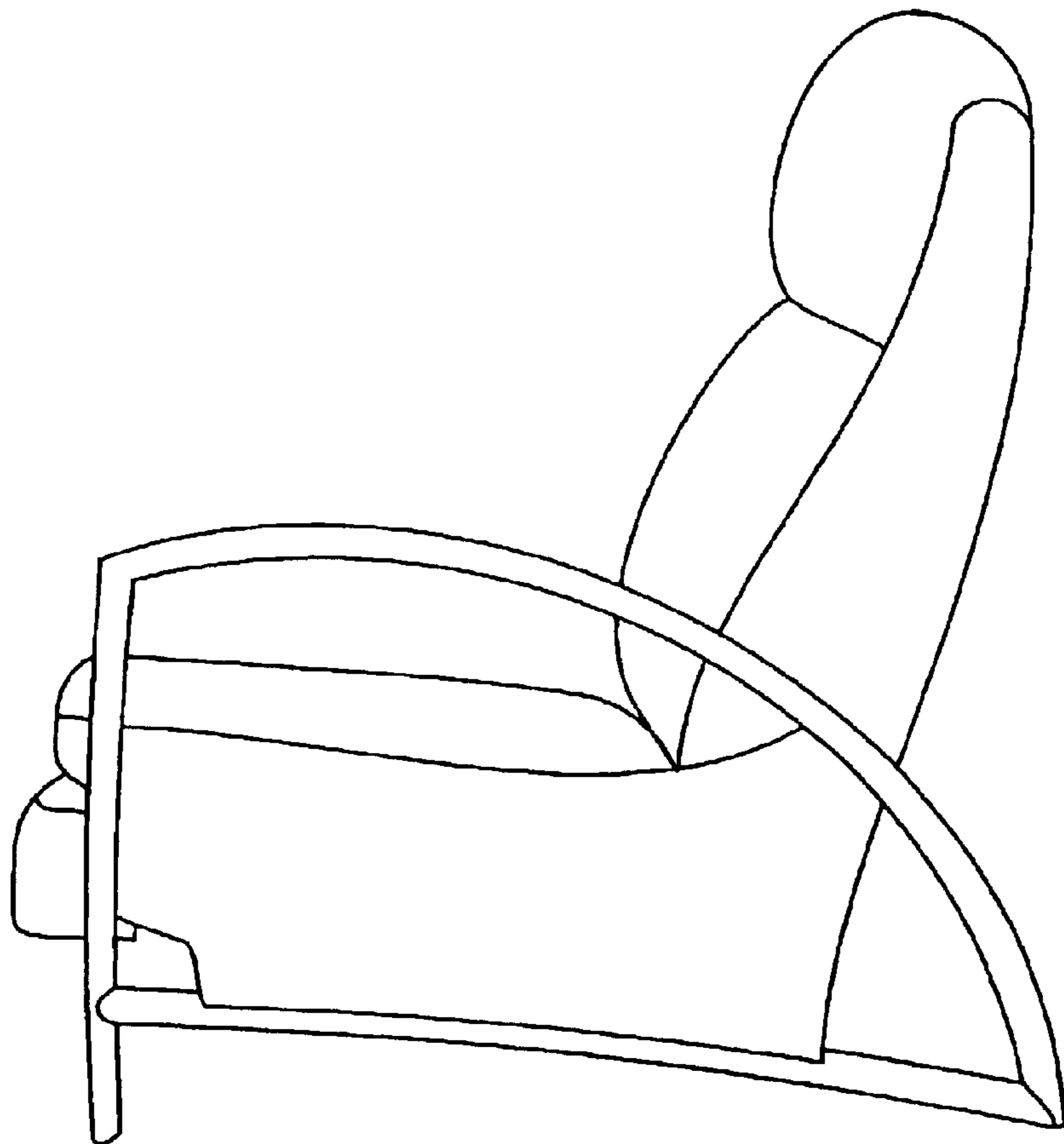




**FIGURE 18**

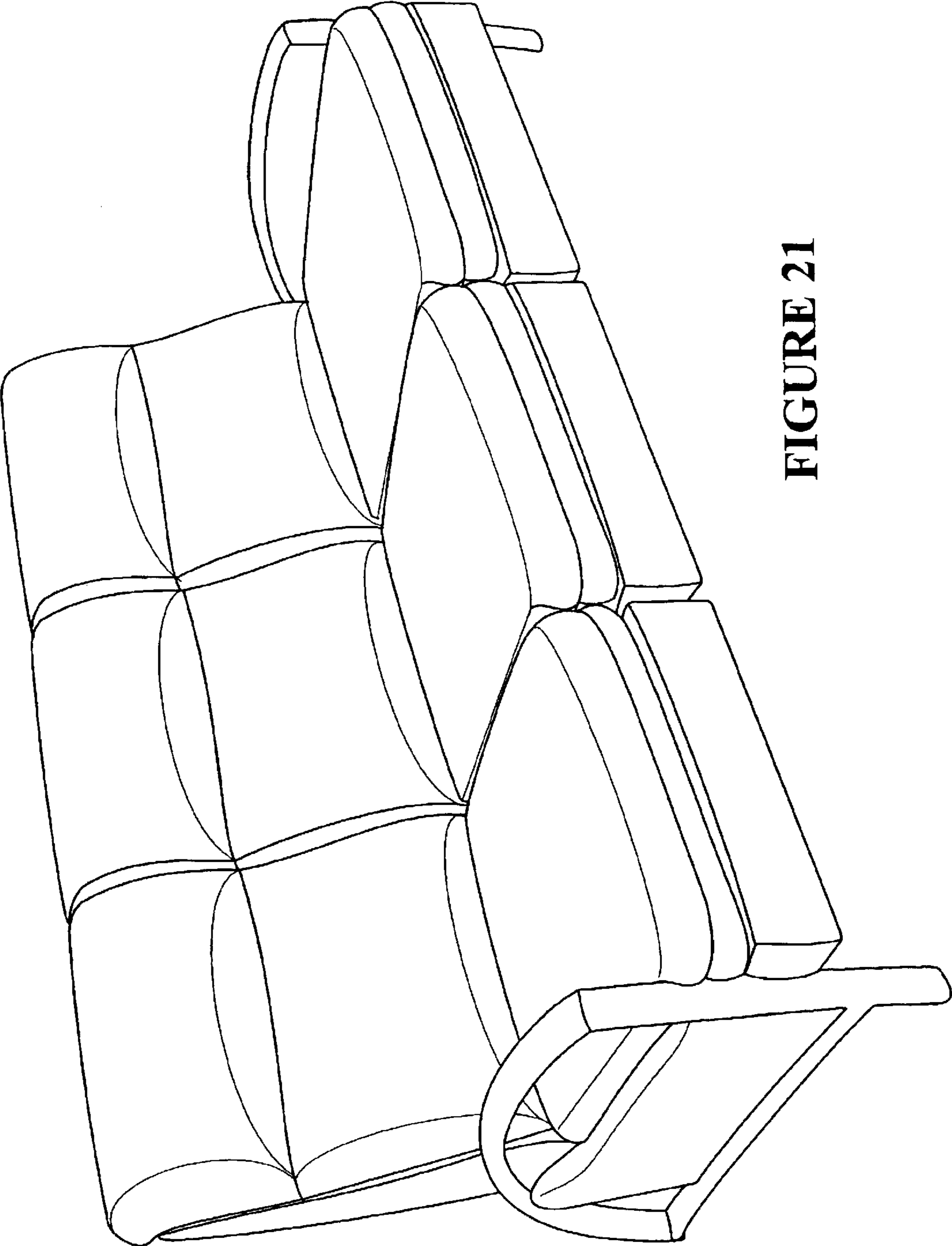

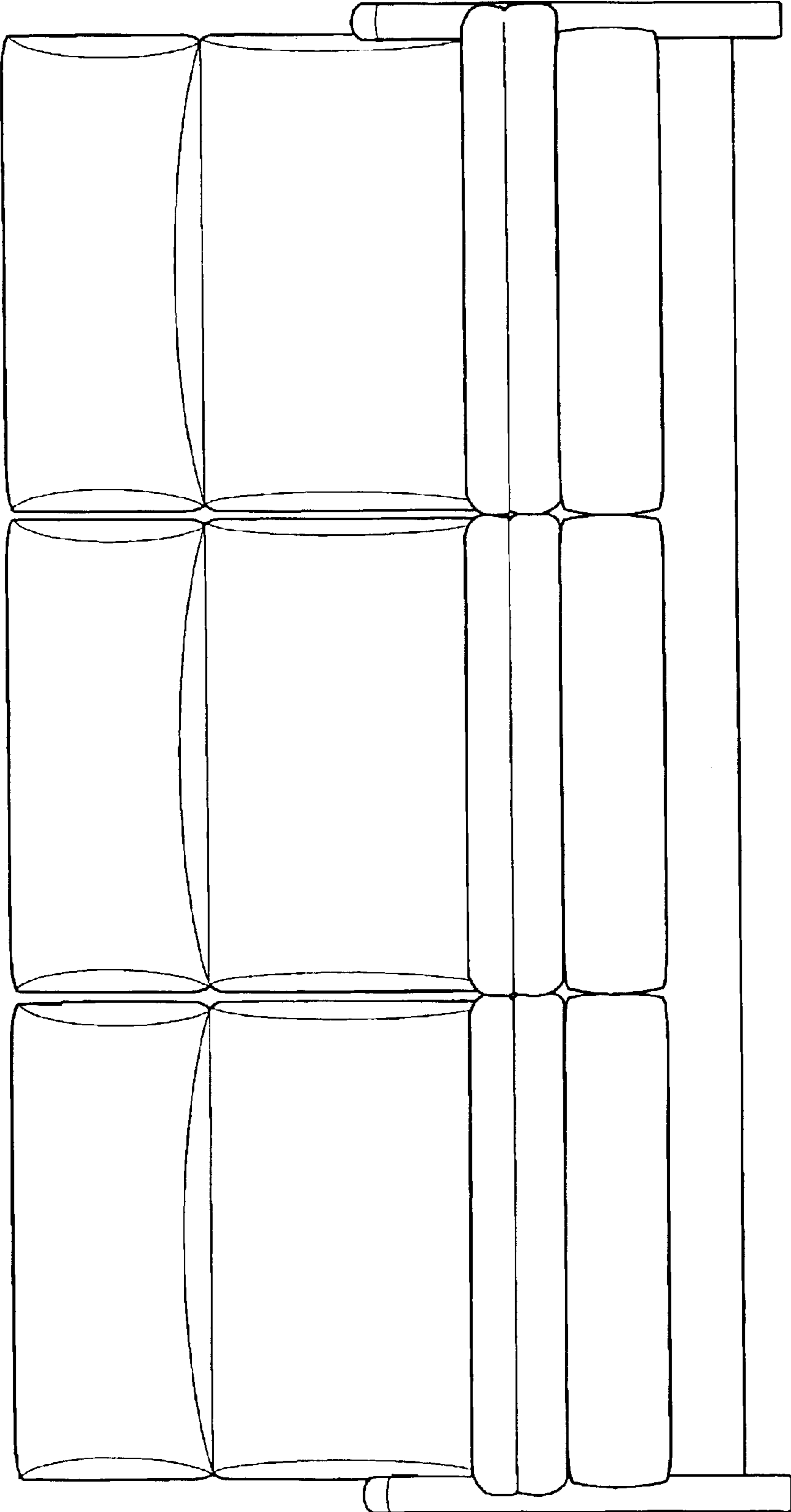

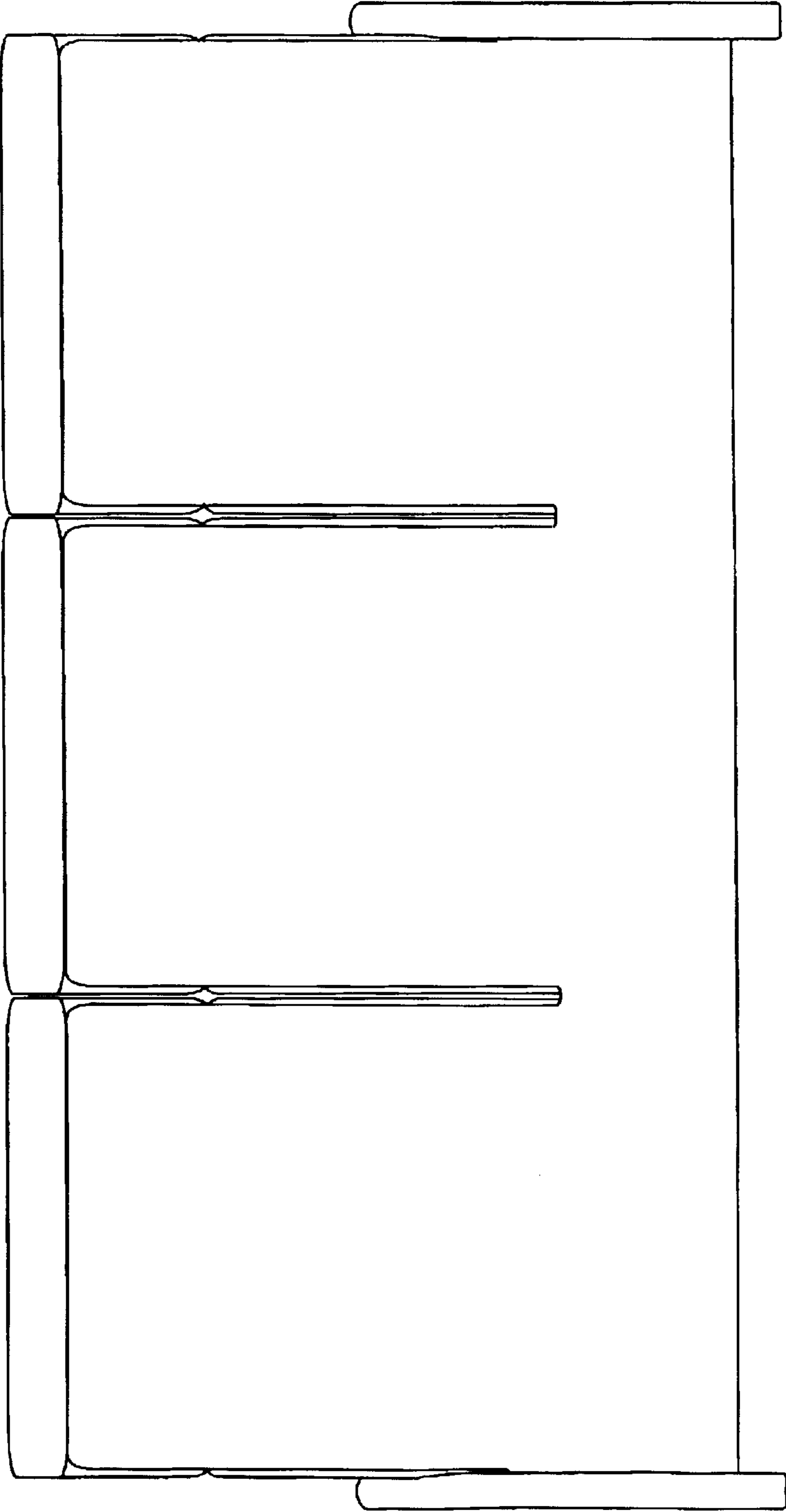
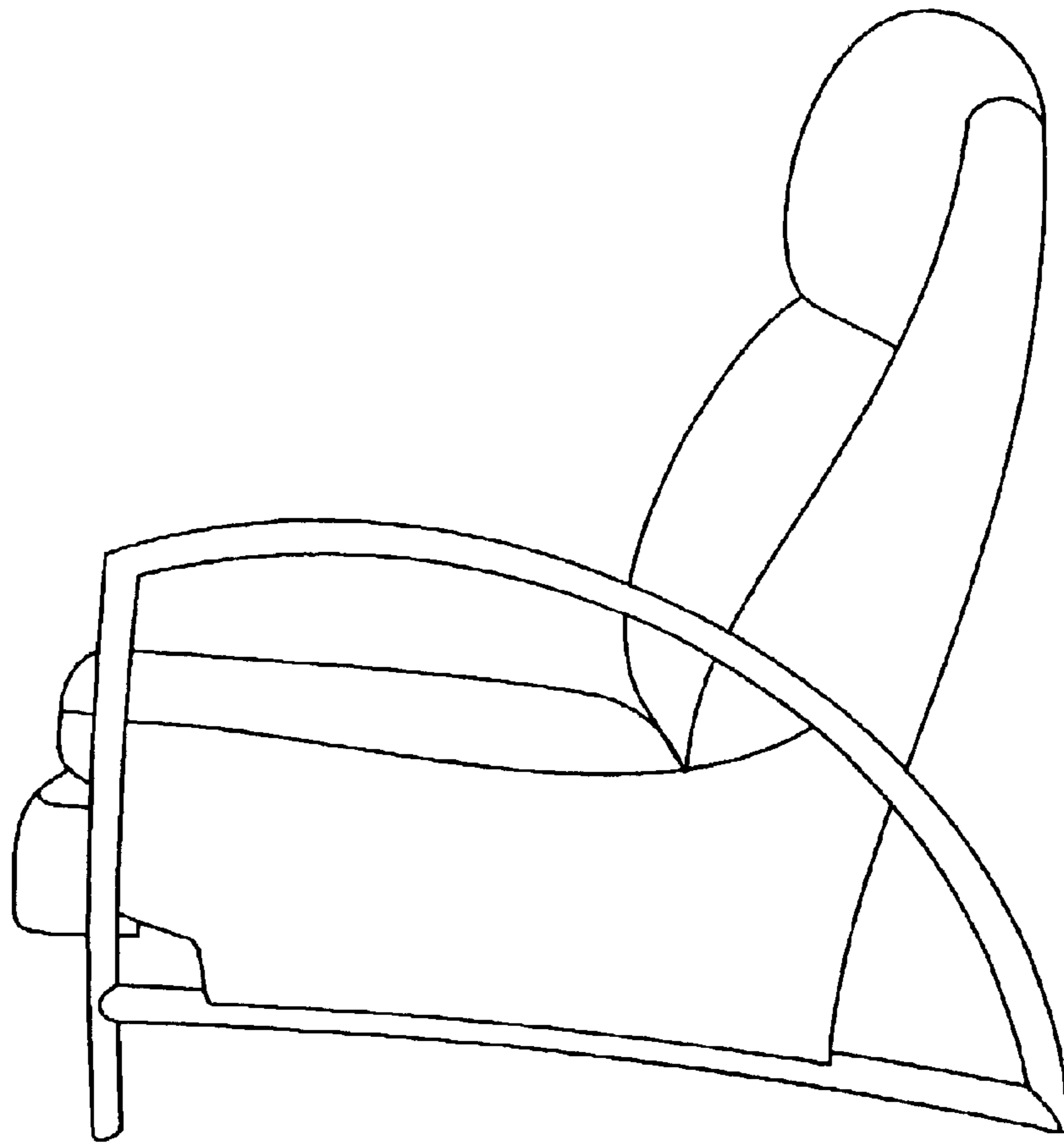
