FIG. 10 is a front view thereof.

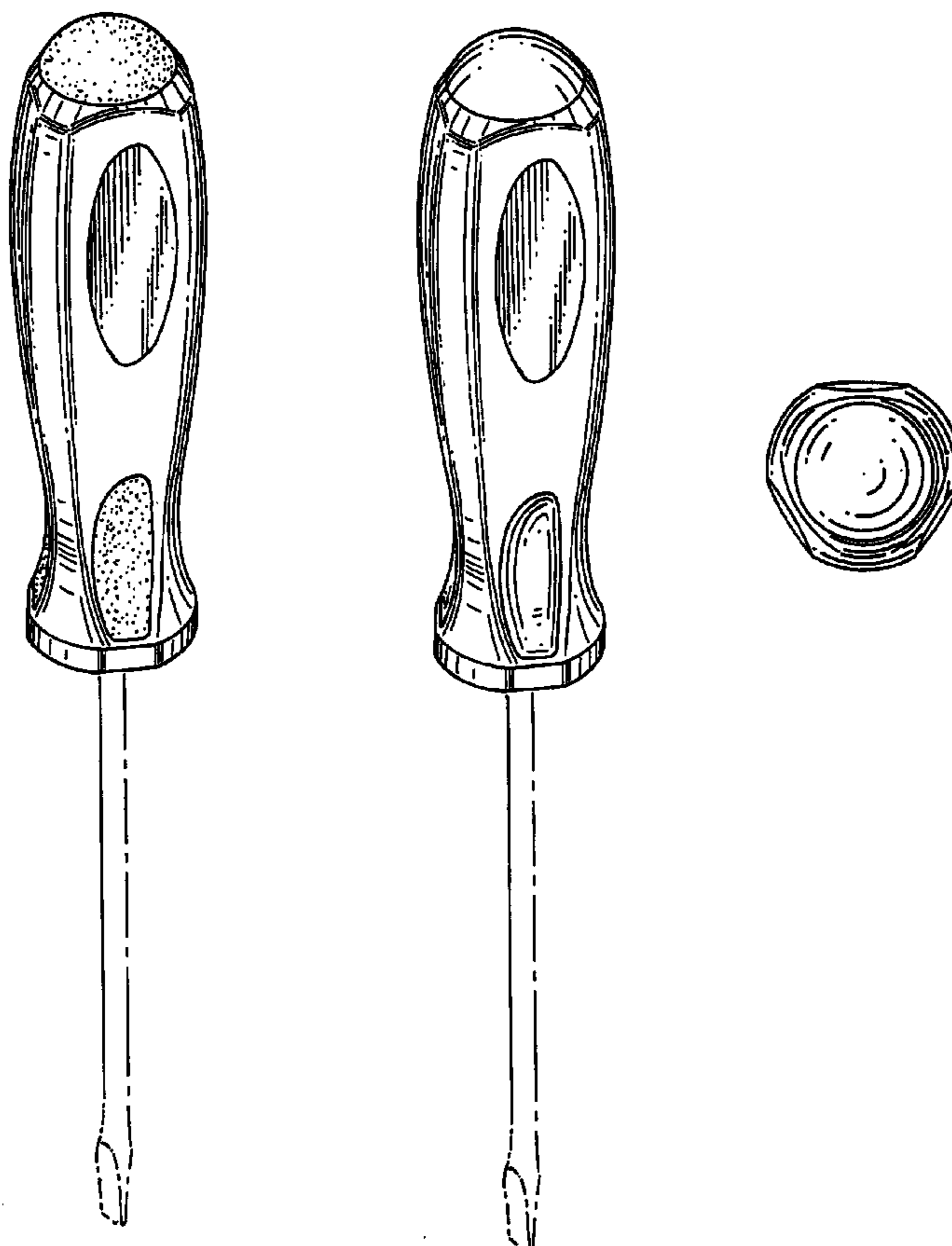

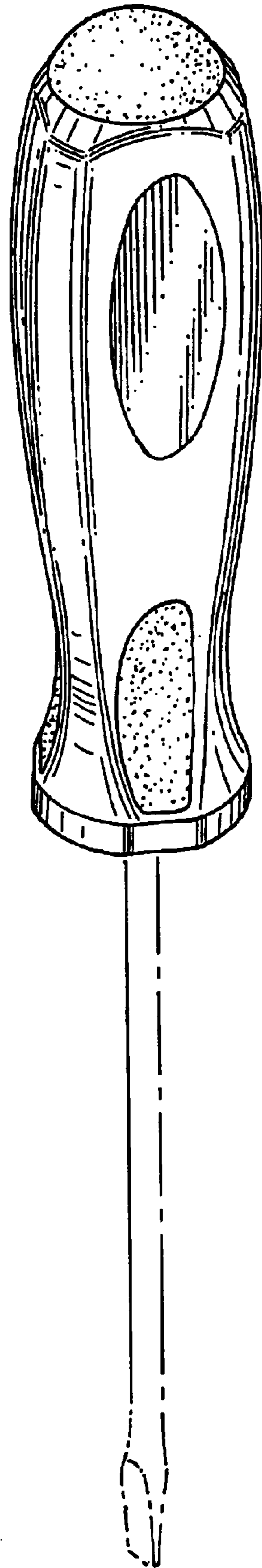

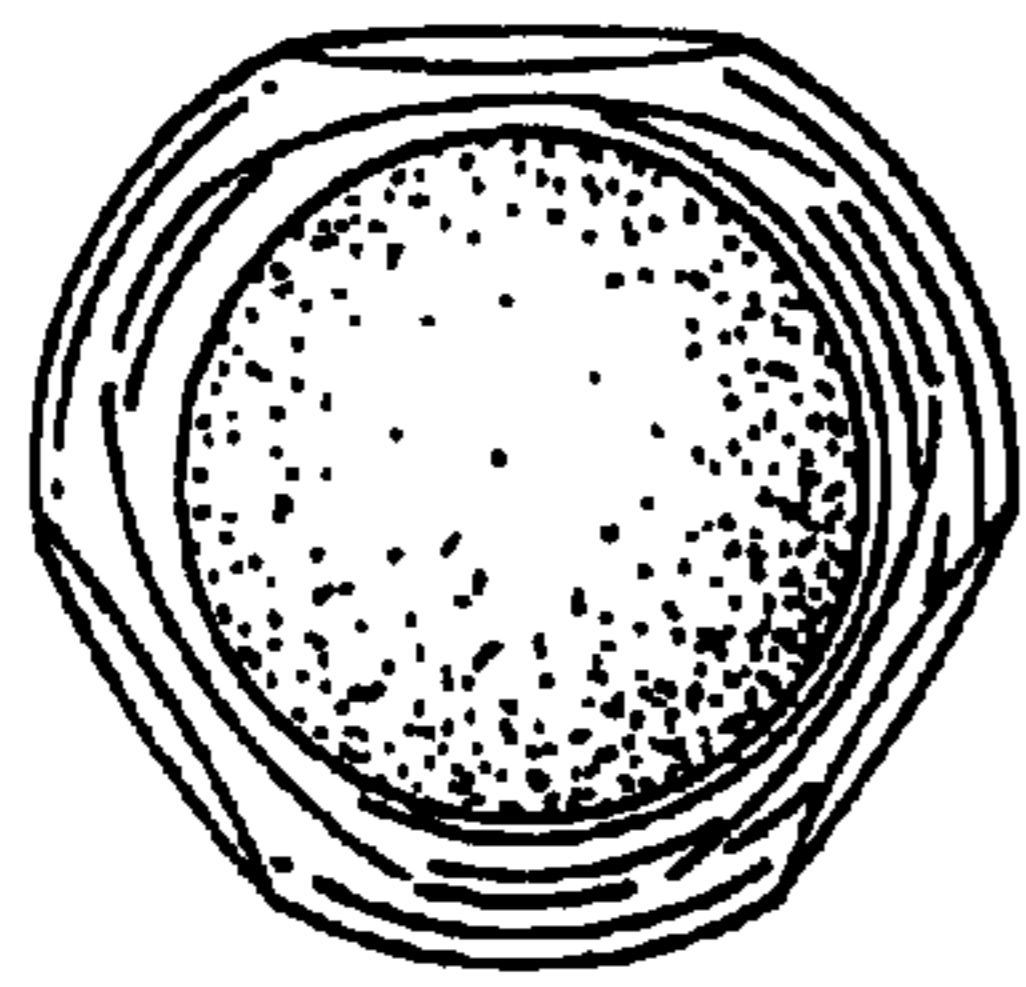

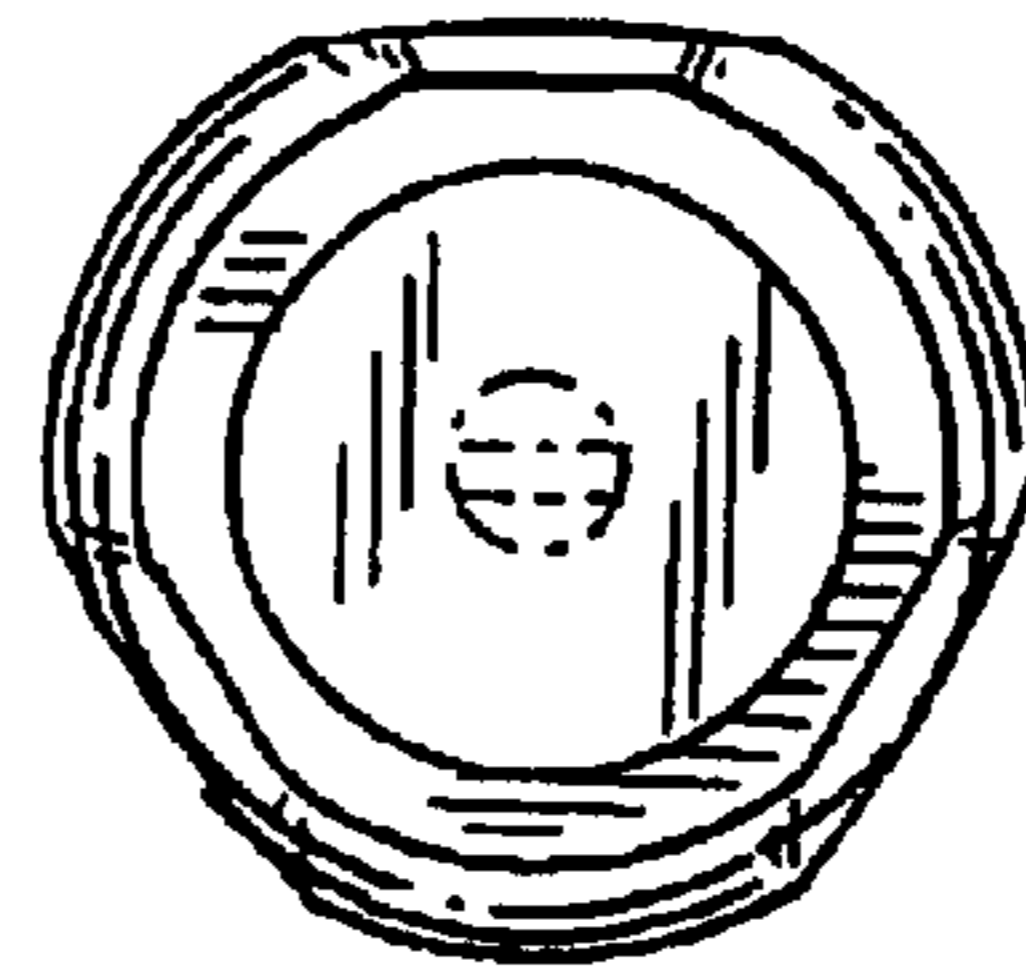

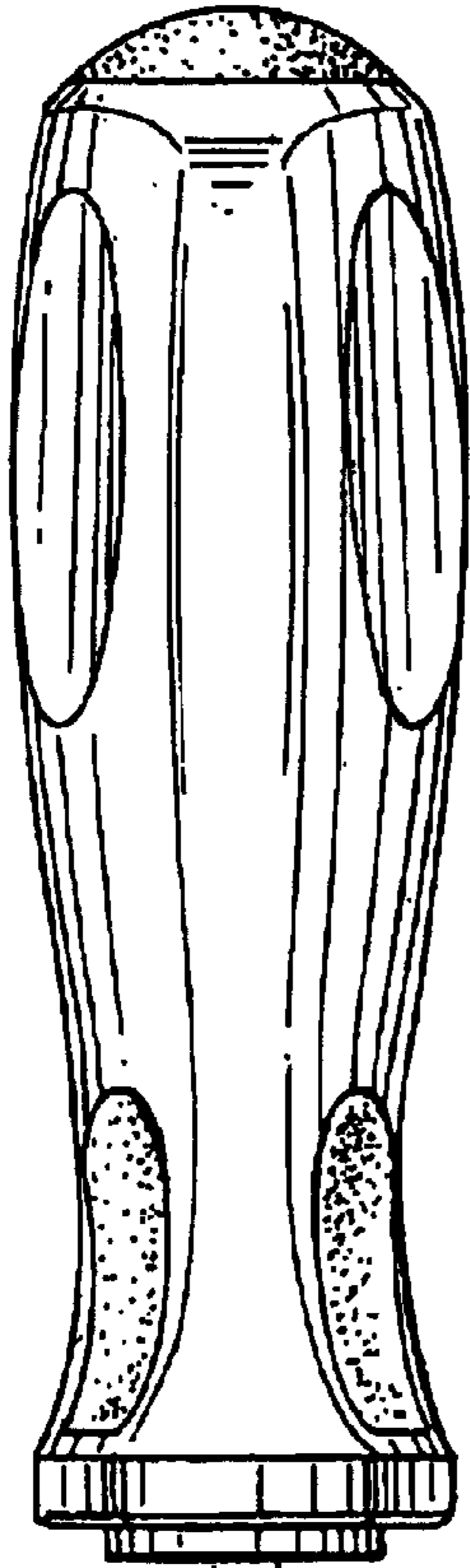

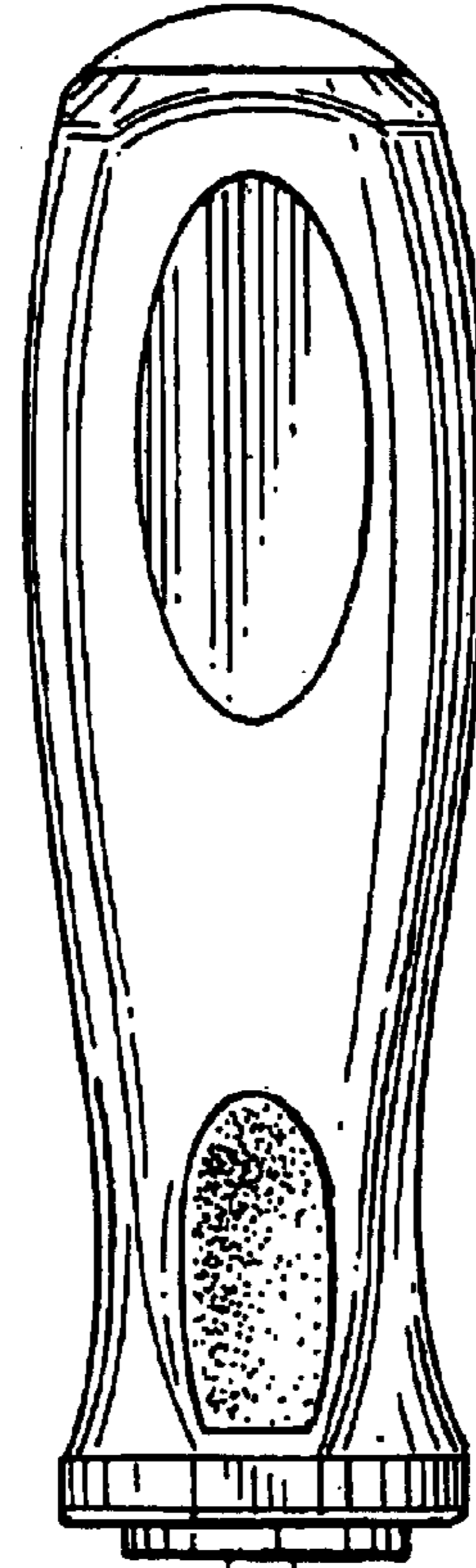
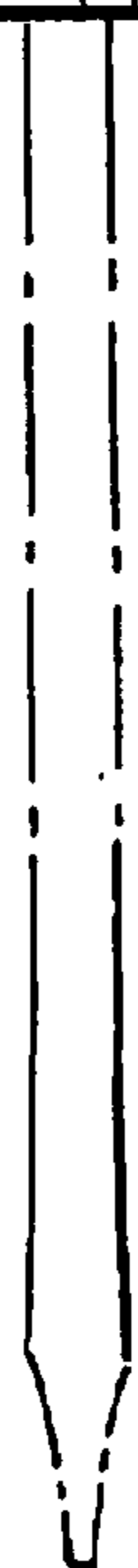

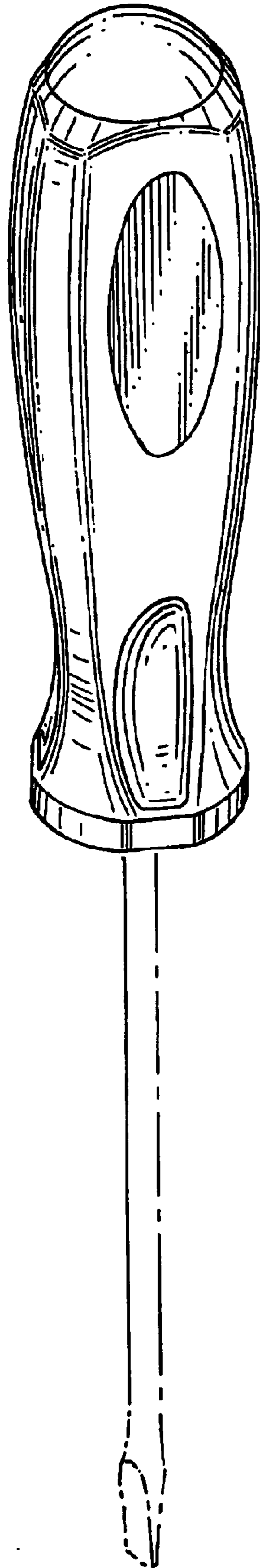

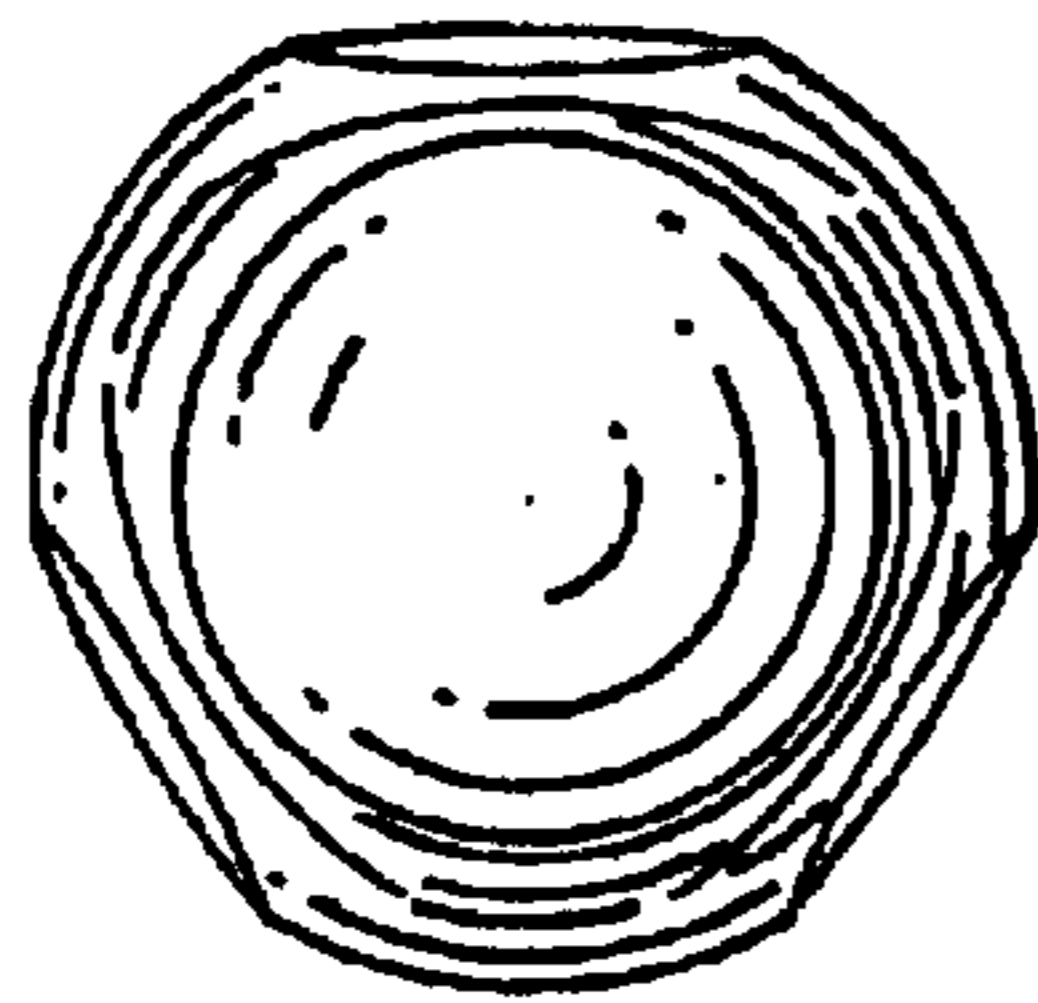

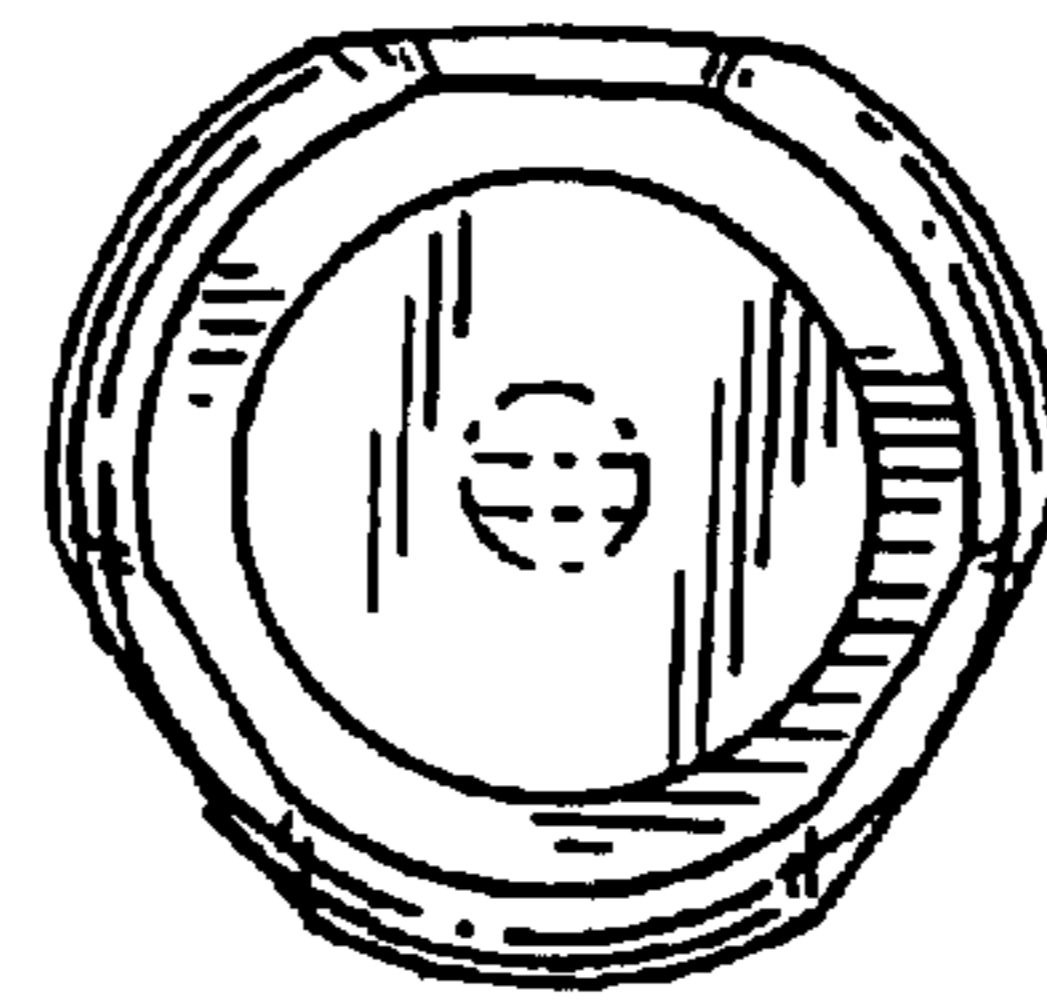

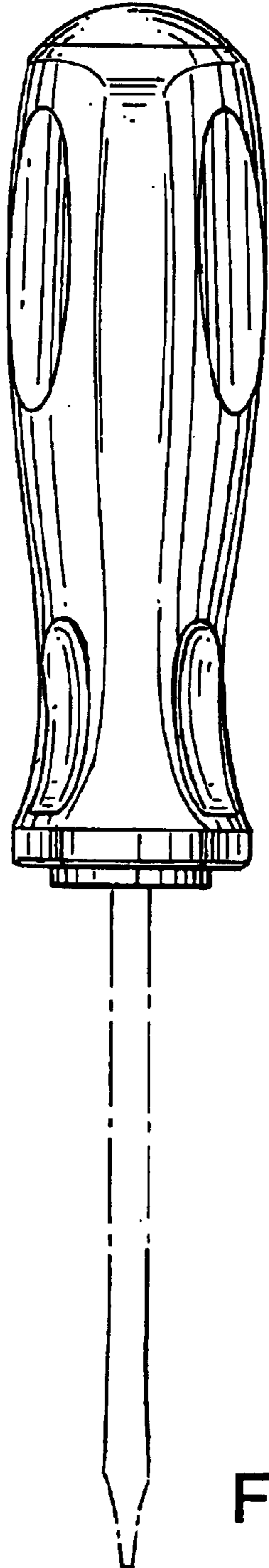

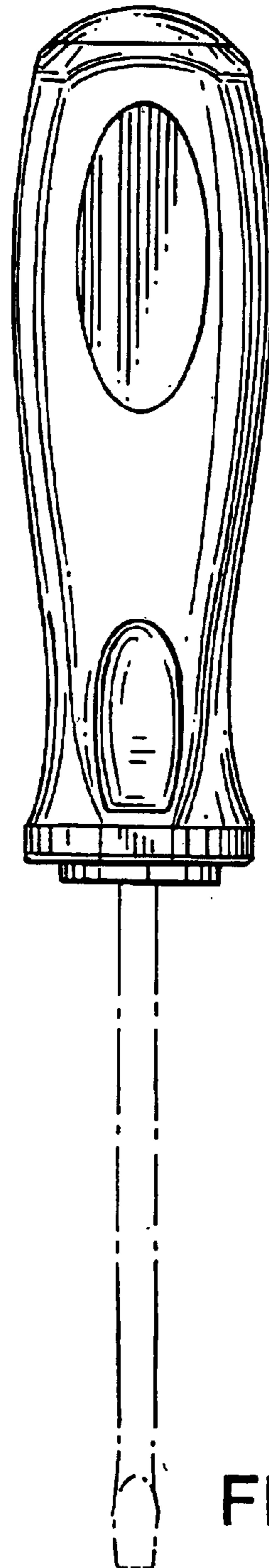
